DESCRIPTION

FIG. 1 is a perspective view of a rotary tool showing our new design;

FIG. 2 is a left side elevational view of the rotary tool of FIG. 1;

FIG. 4 is a front side elevational view of the rotary tool of FIG. 1;

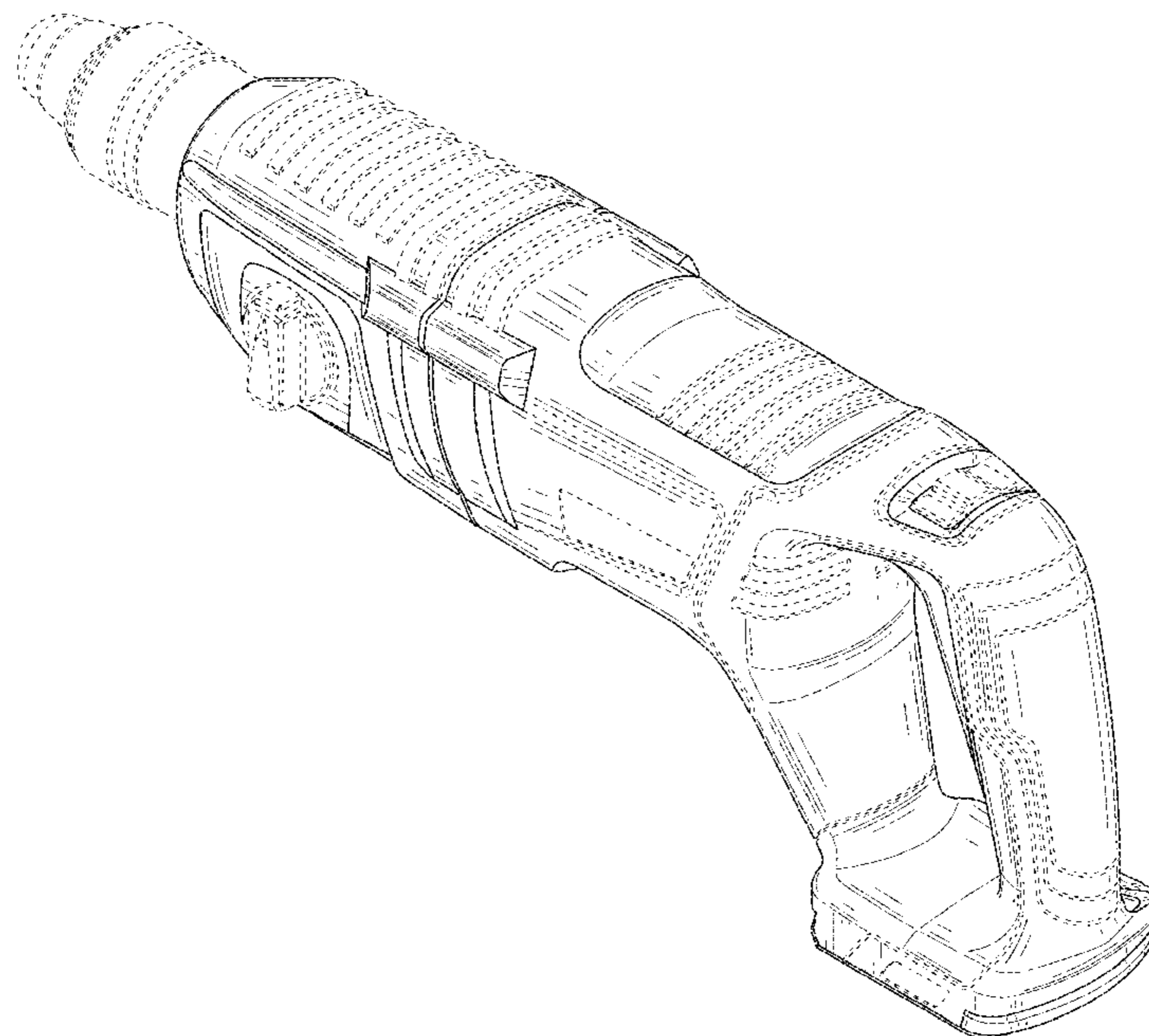
FIG. 5 is a rear side elevational view of the rotary tool of FIG. 1;

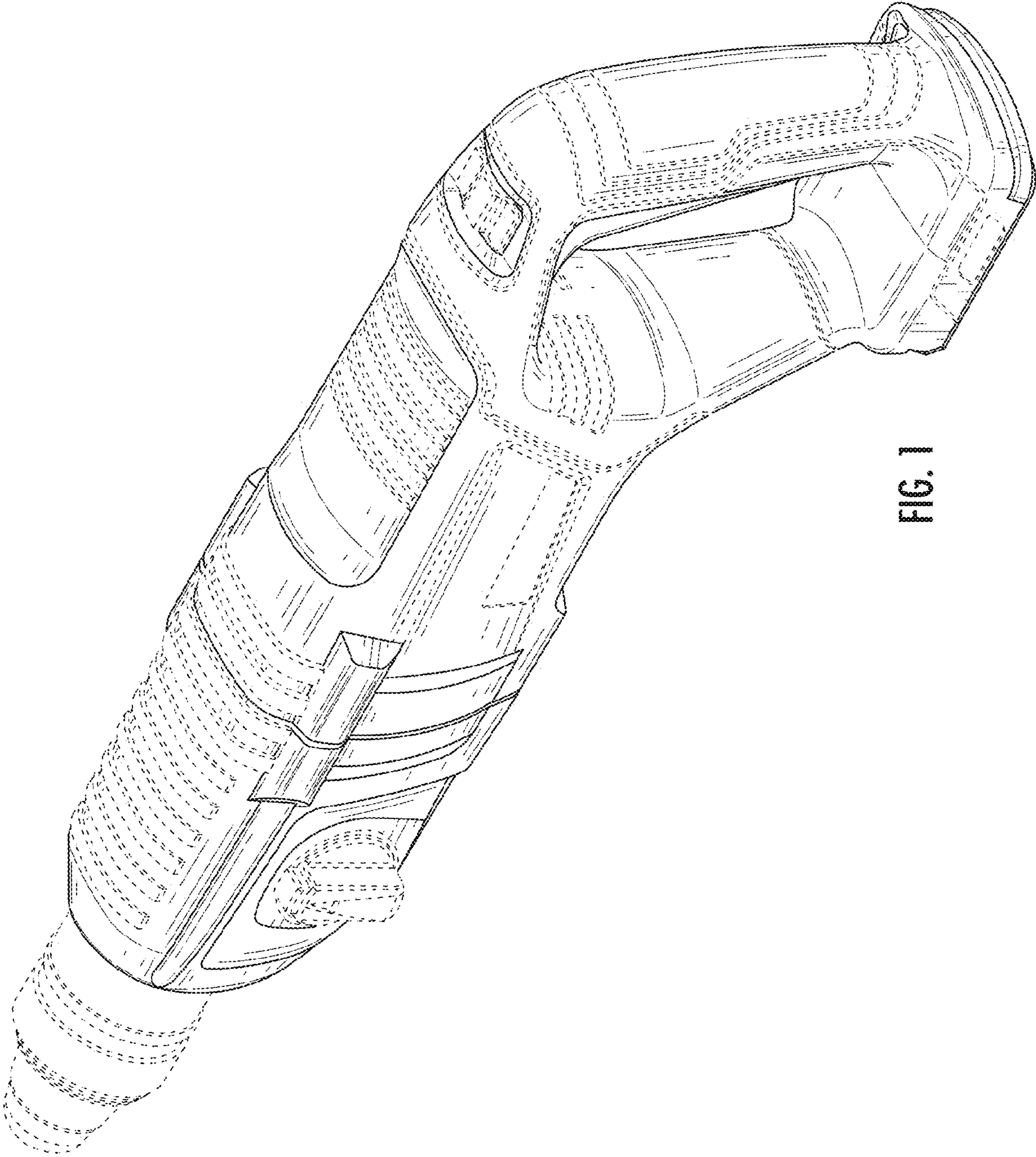

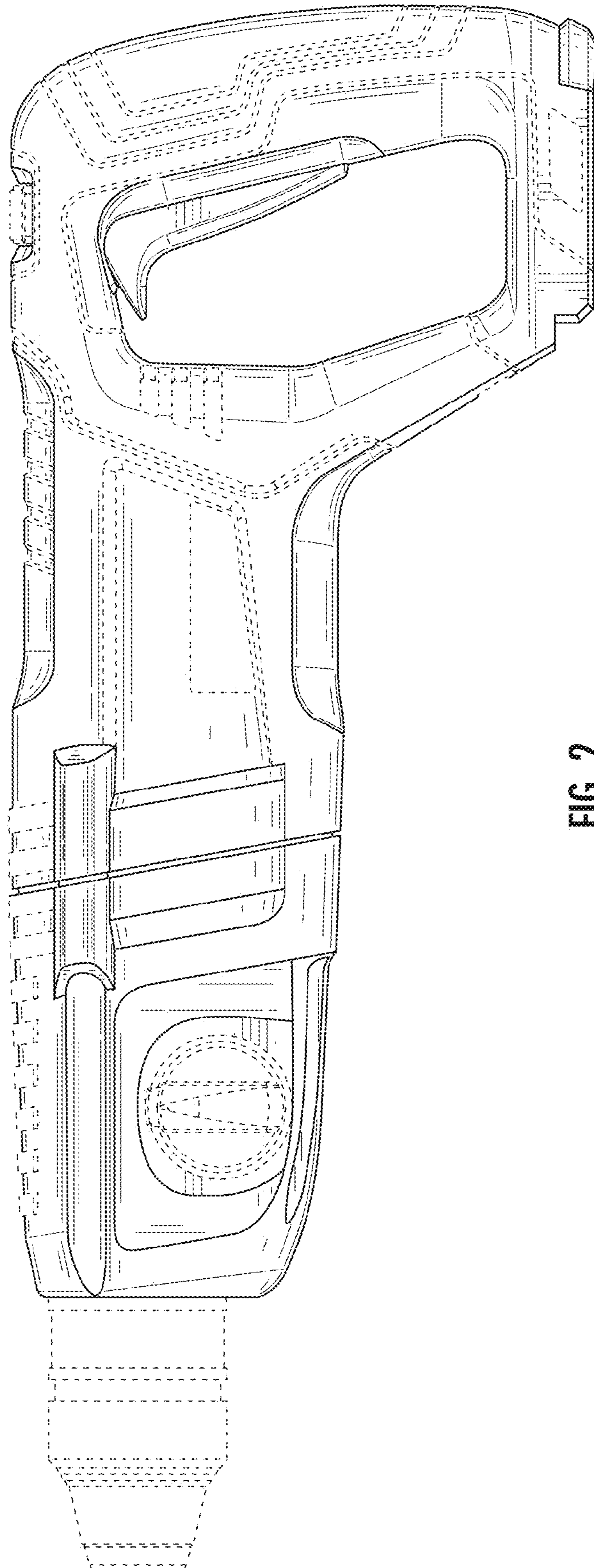

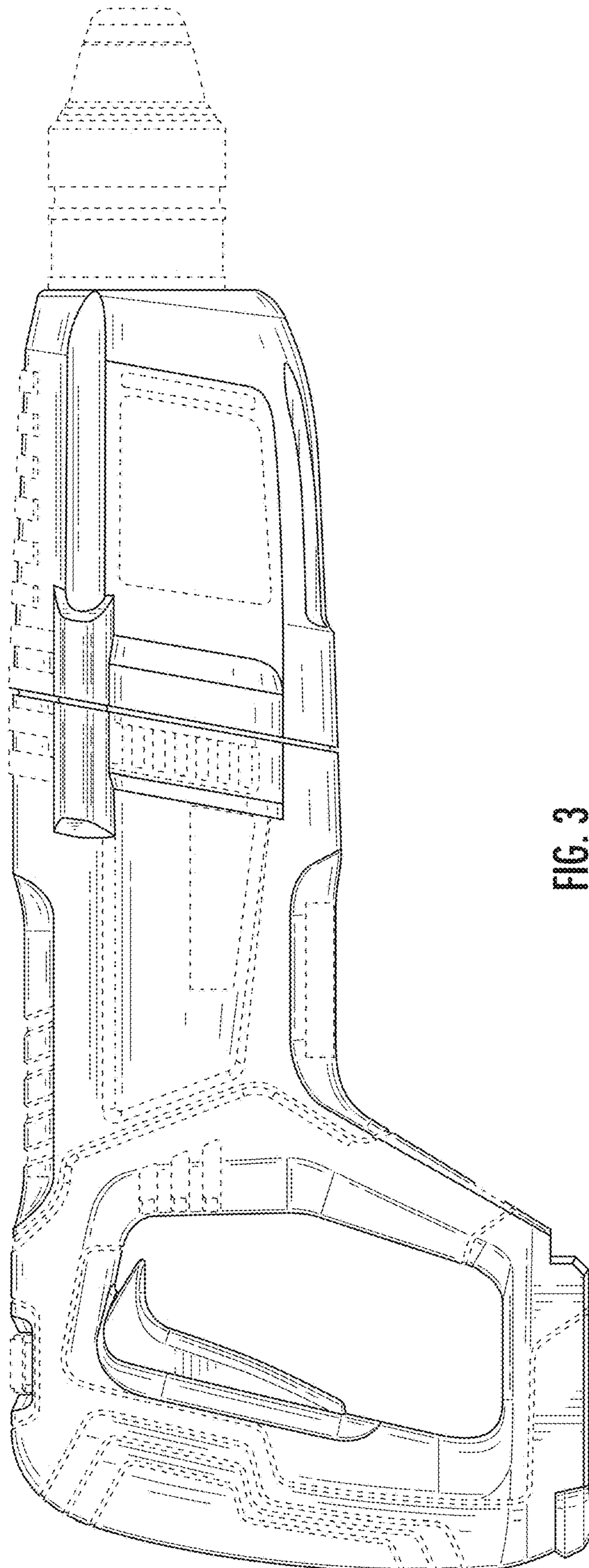

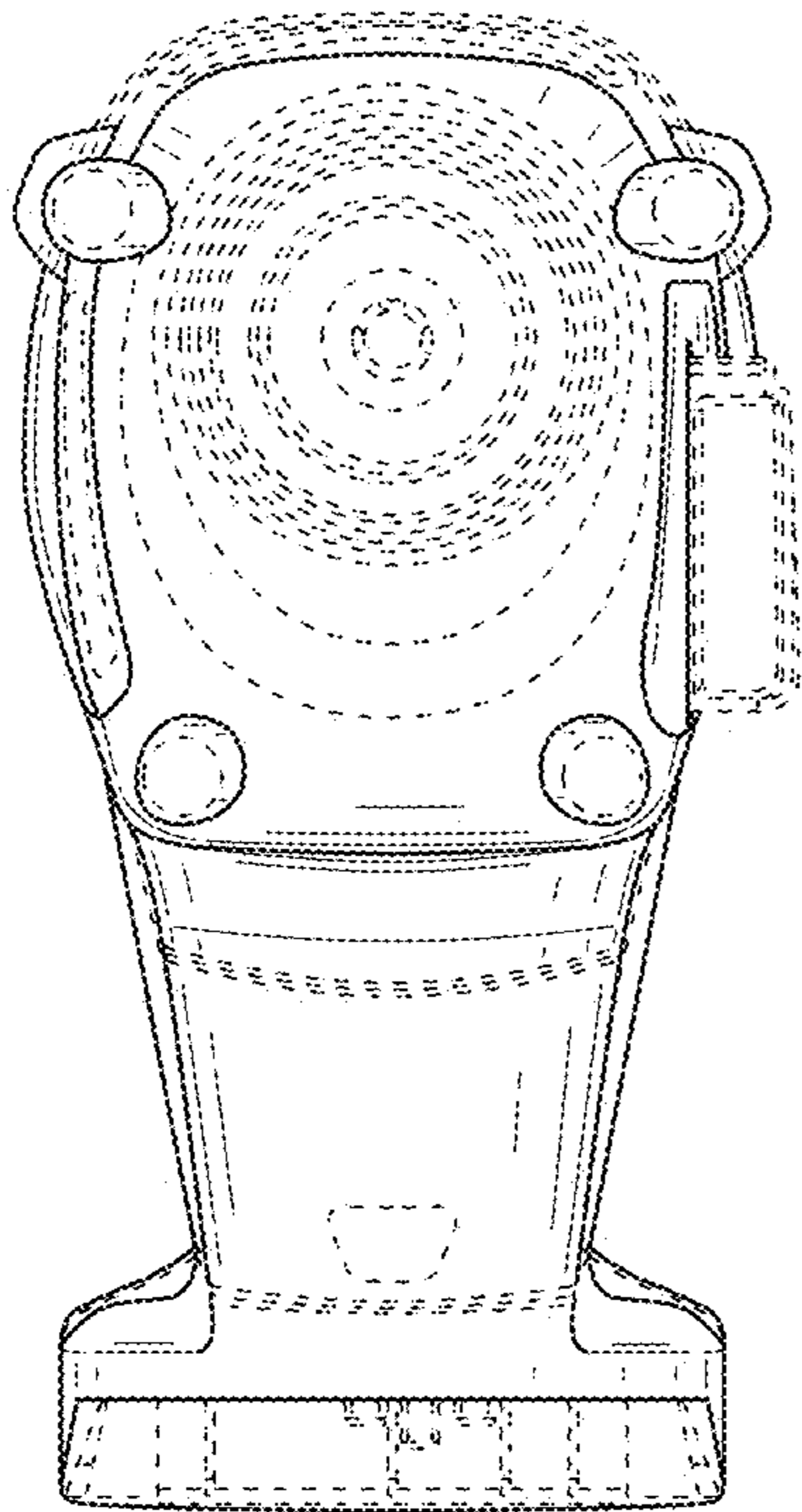

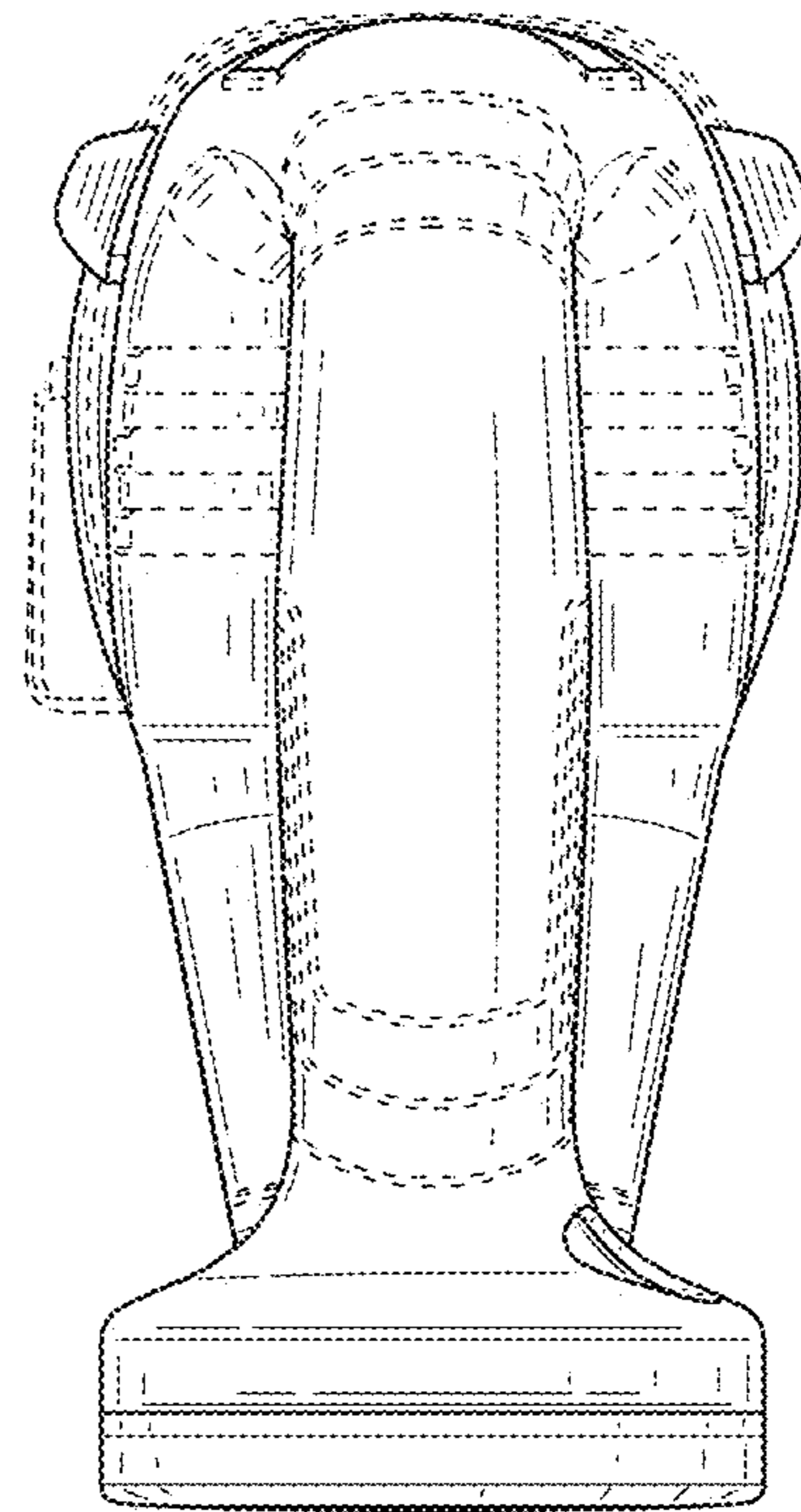

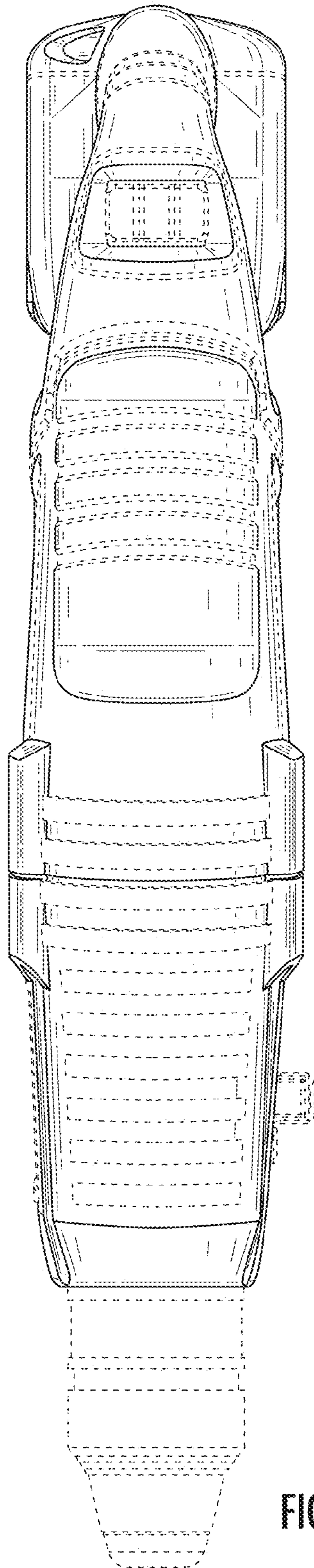

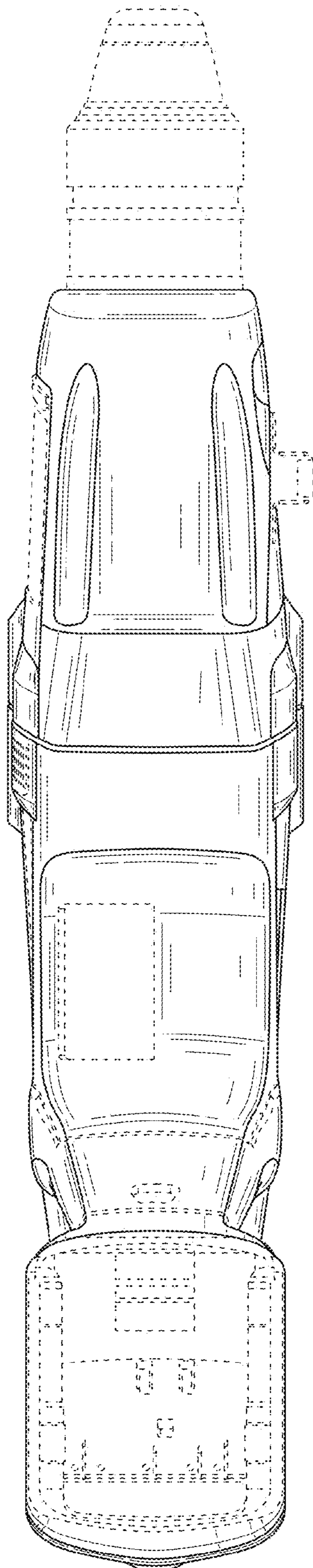
