FIG. 3 is a rear view of the topper for bubble solution container of FIG. 1.

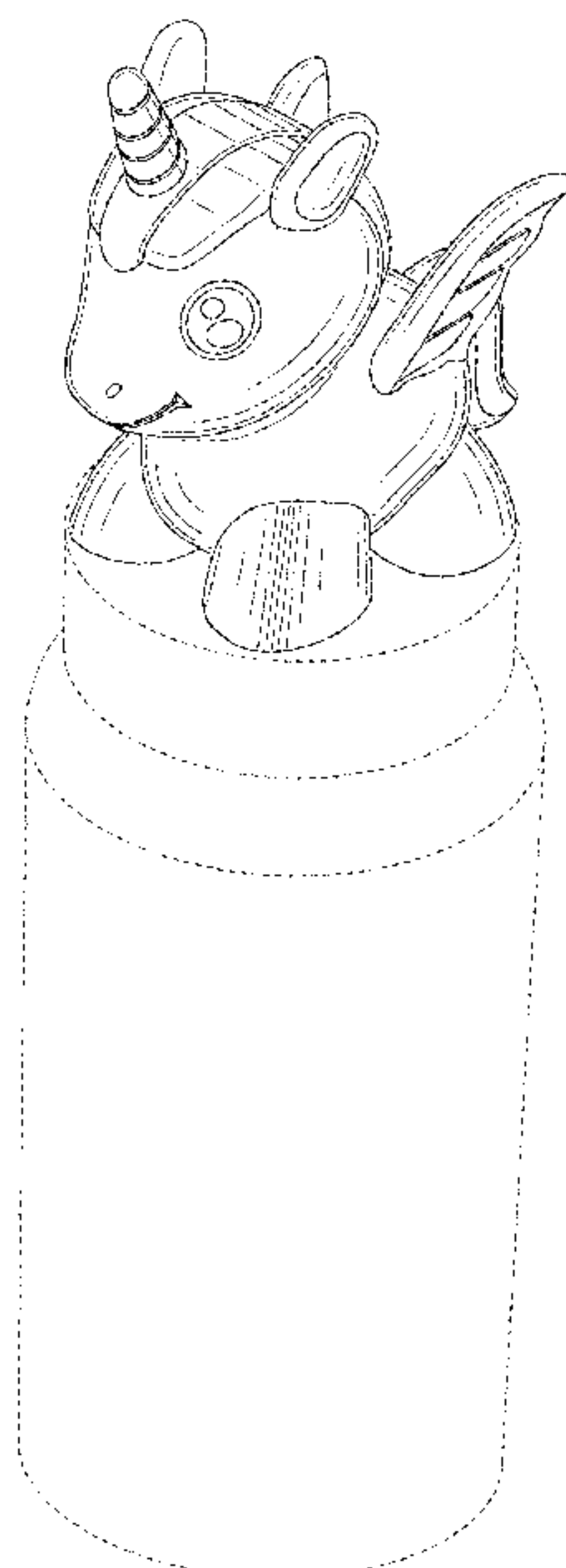
FIG. 4 is a left view of the topper for bubble solution container of FIG. 1.

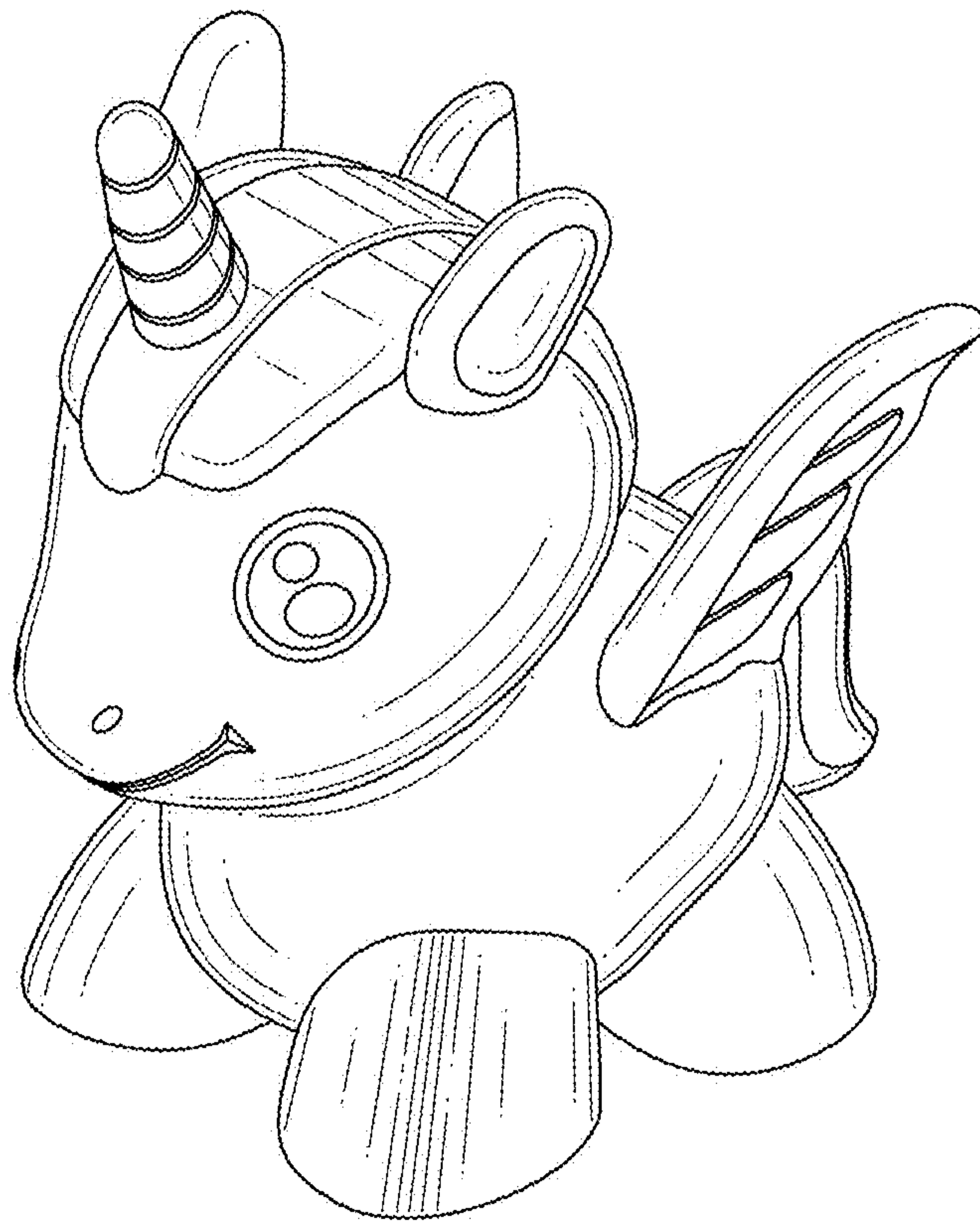

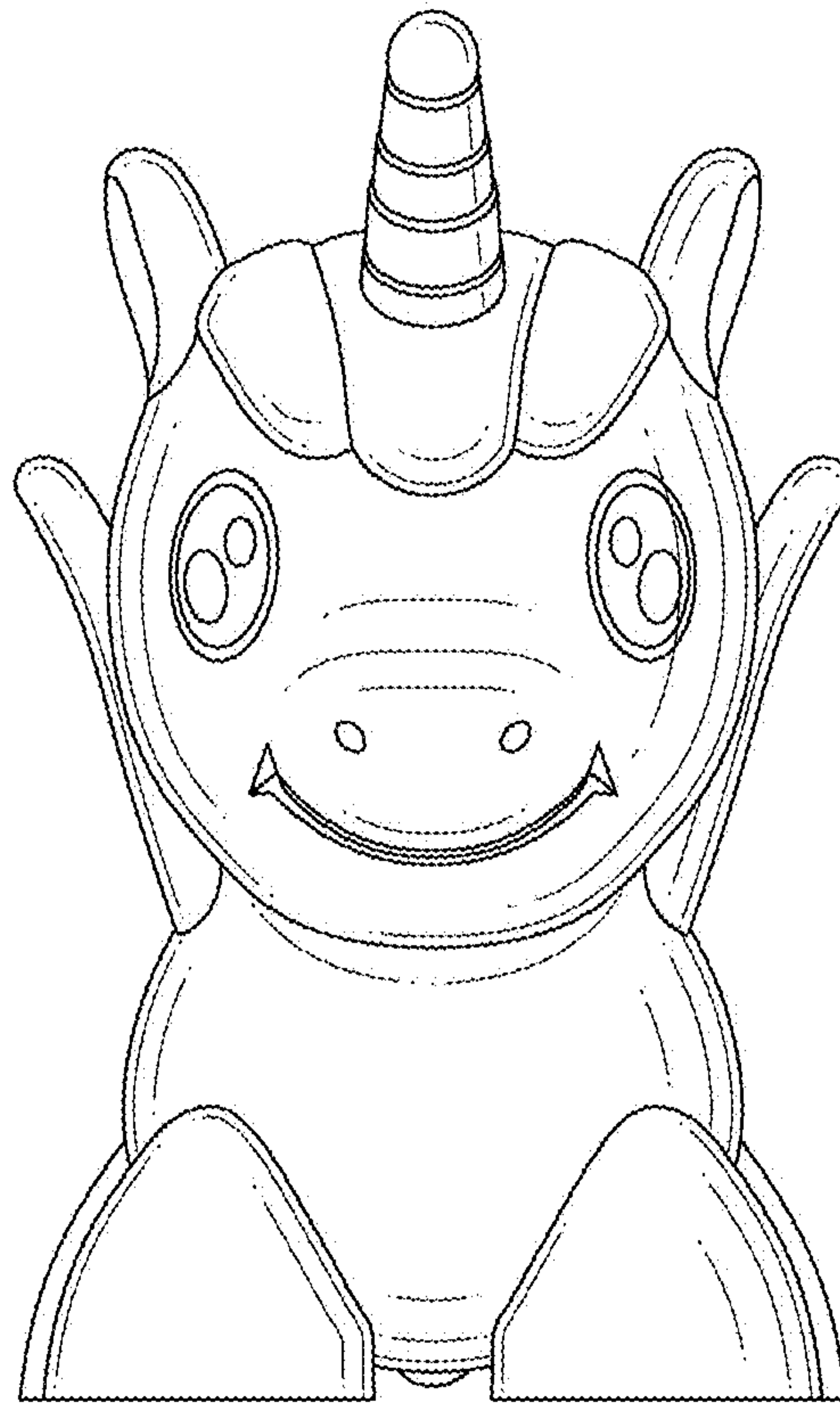

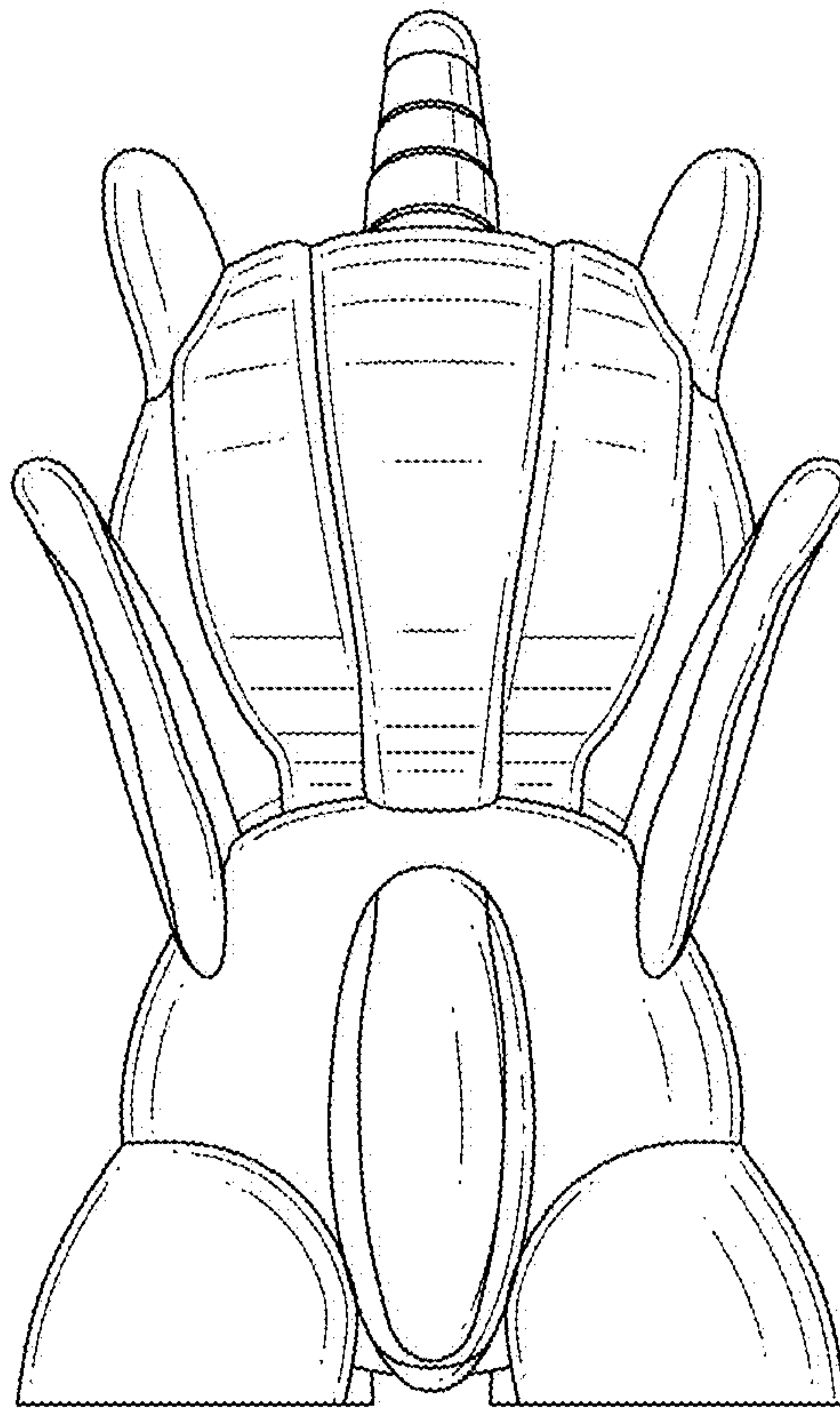

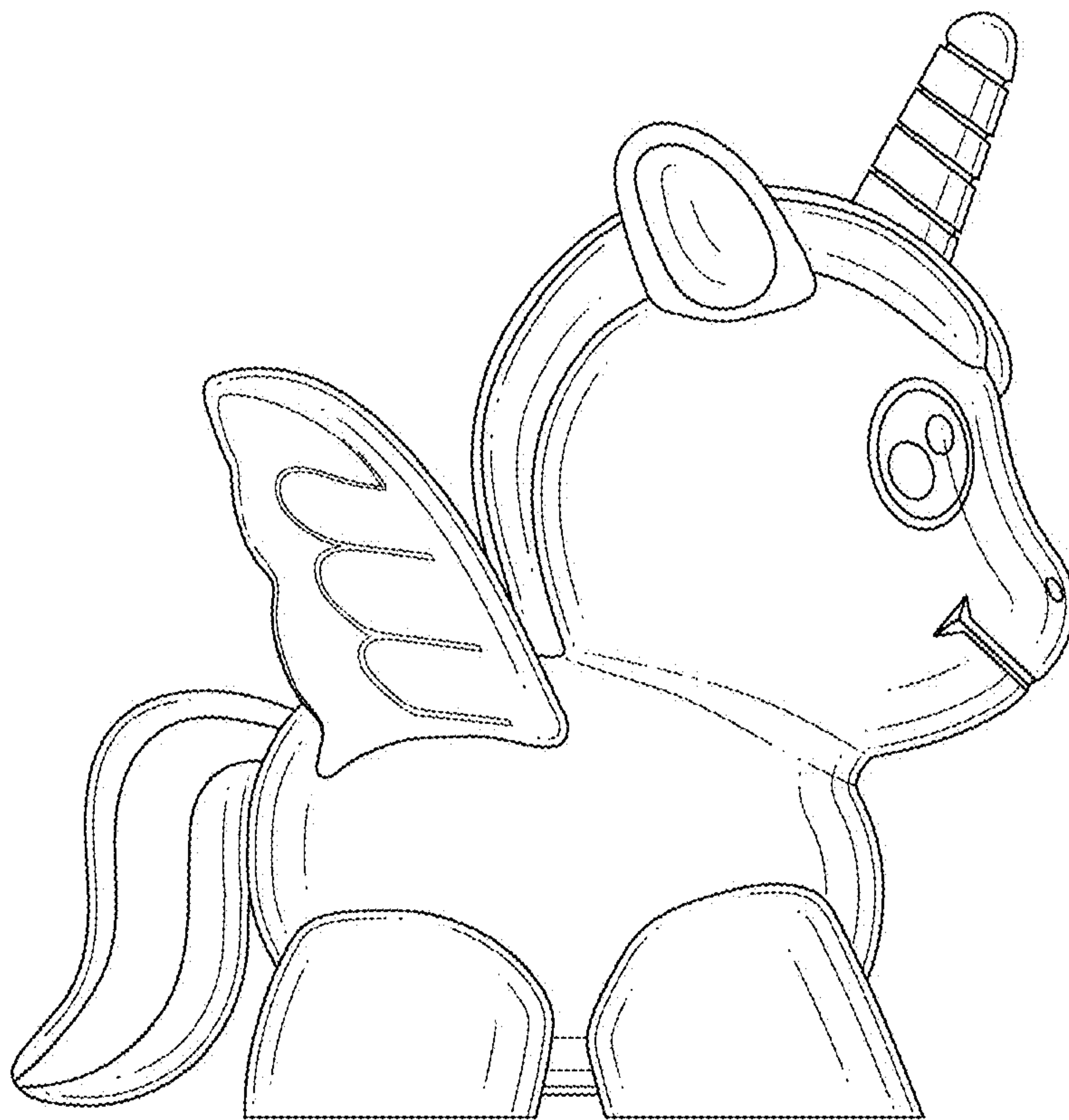

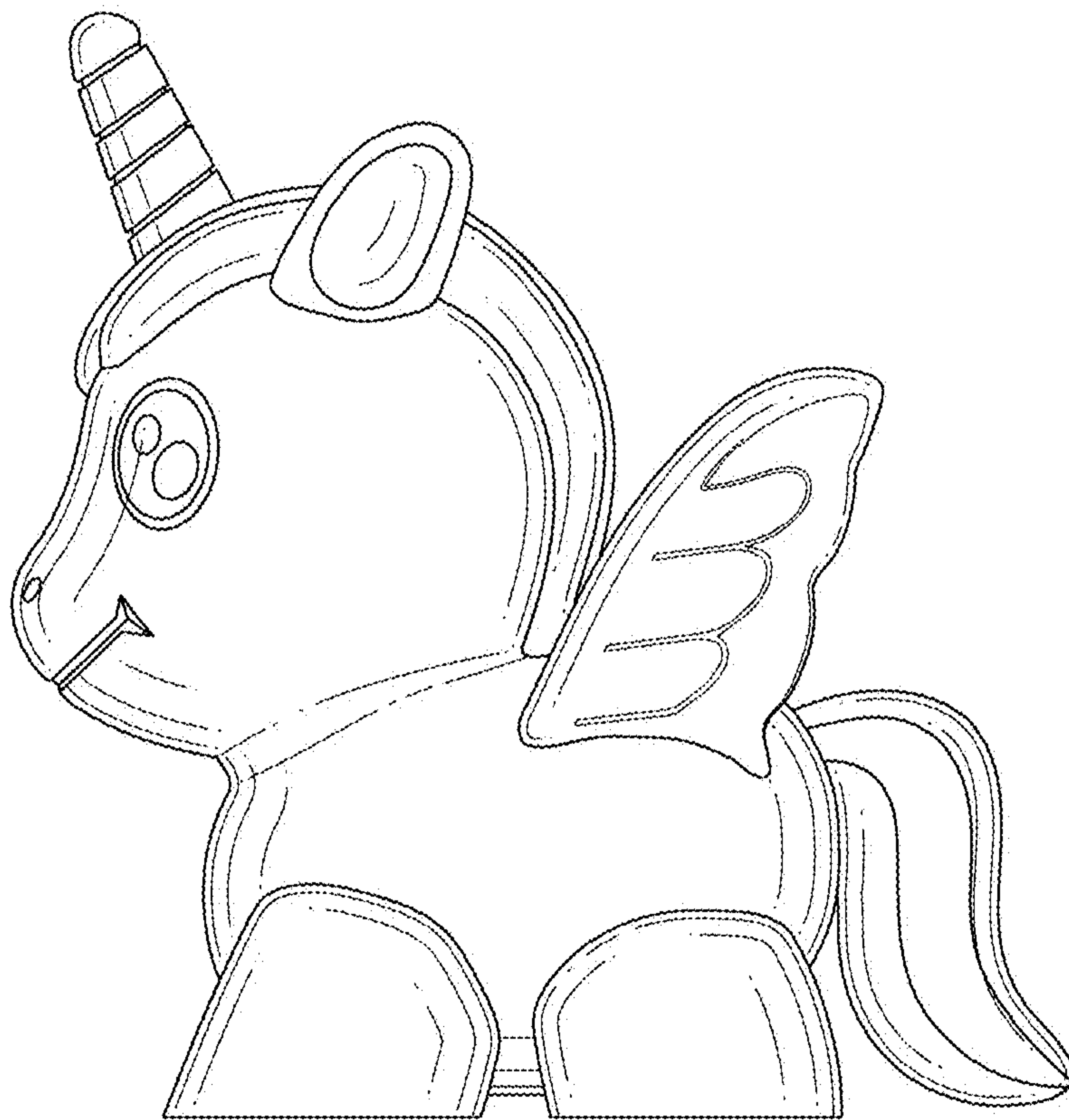

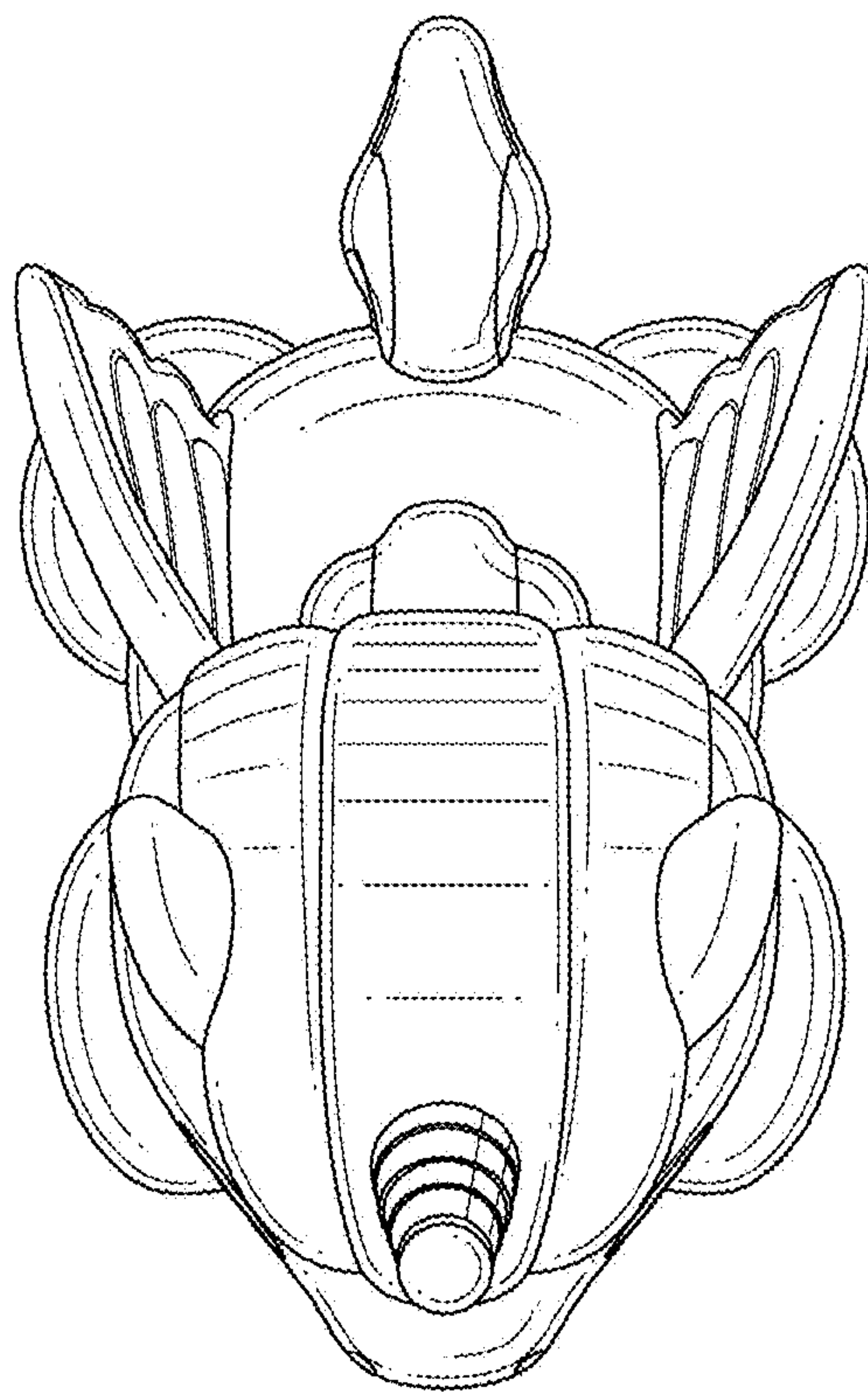

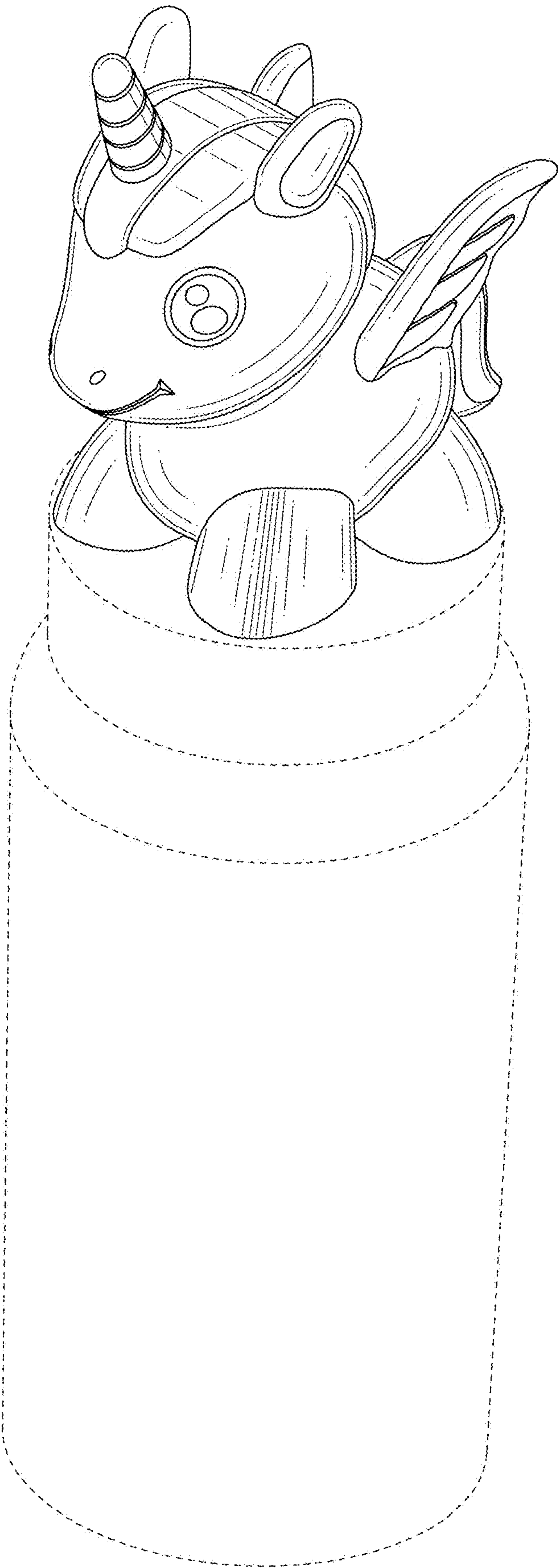
