DESCRIPTION

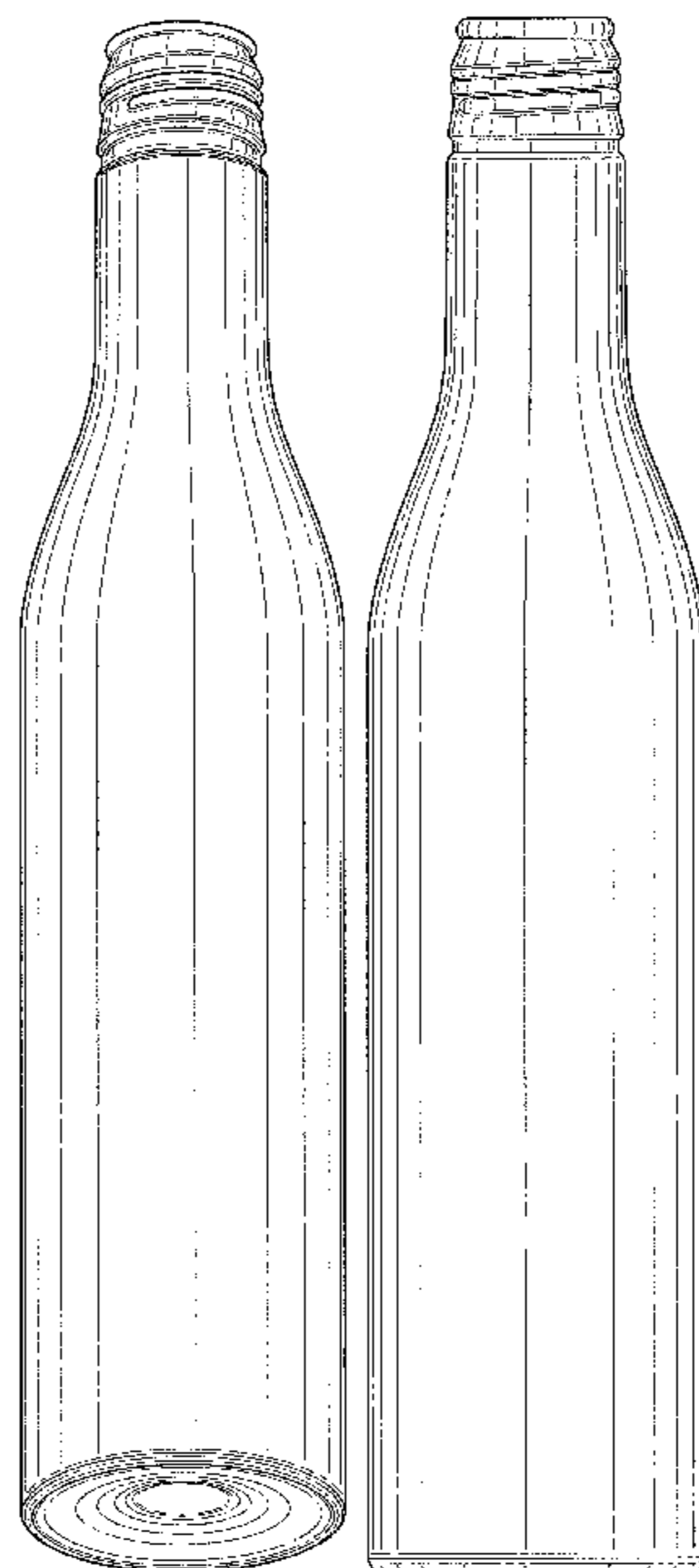
FIG. 1 is a top perspective view of the bottle of the present design;

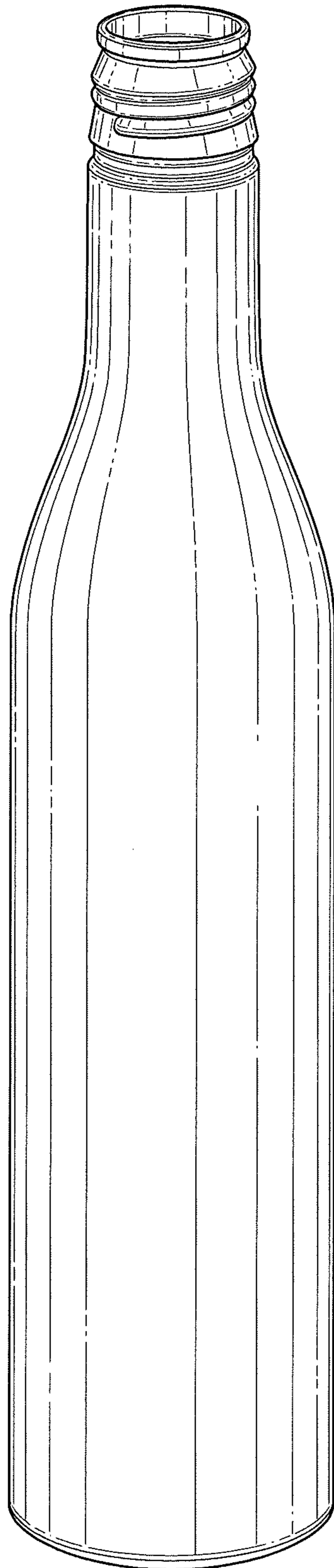

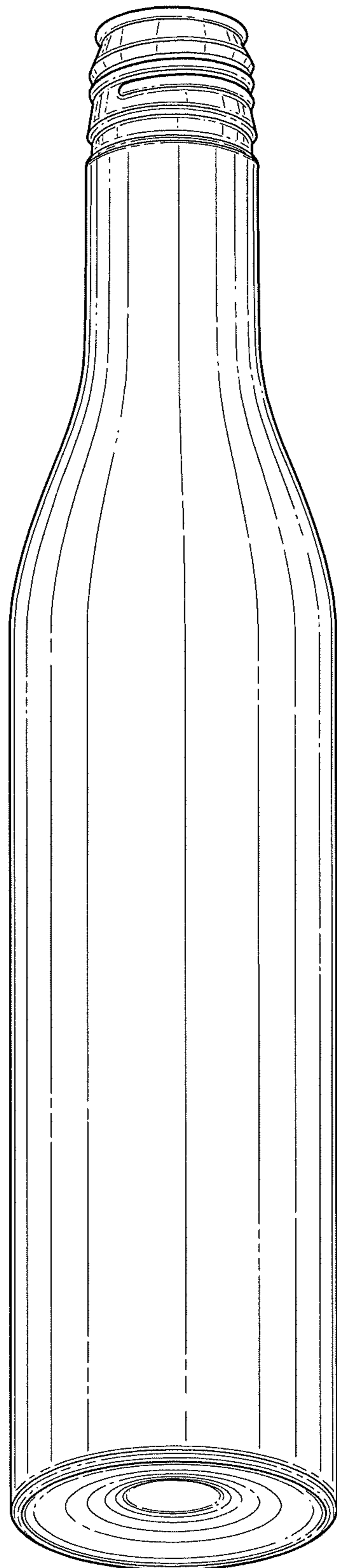

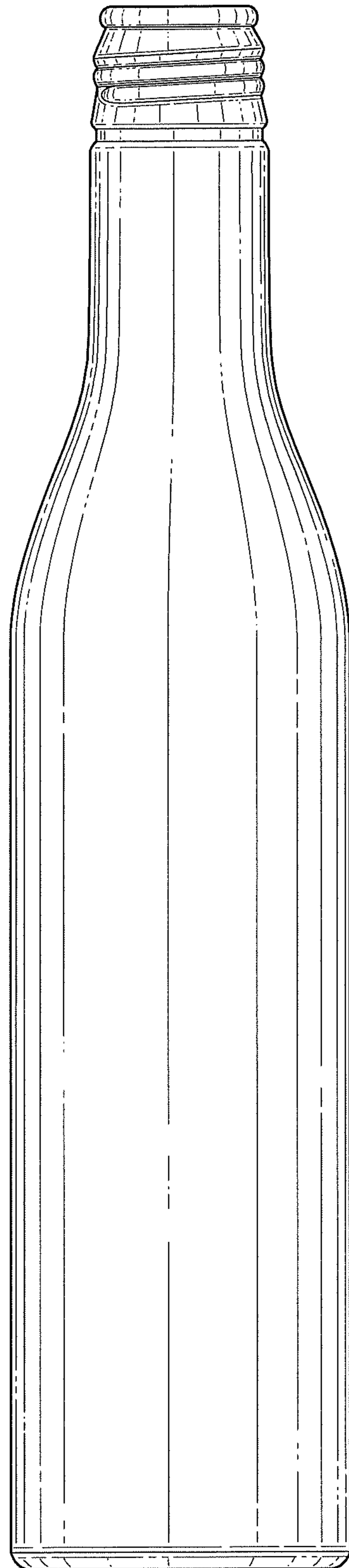

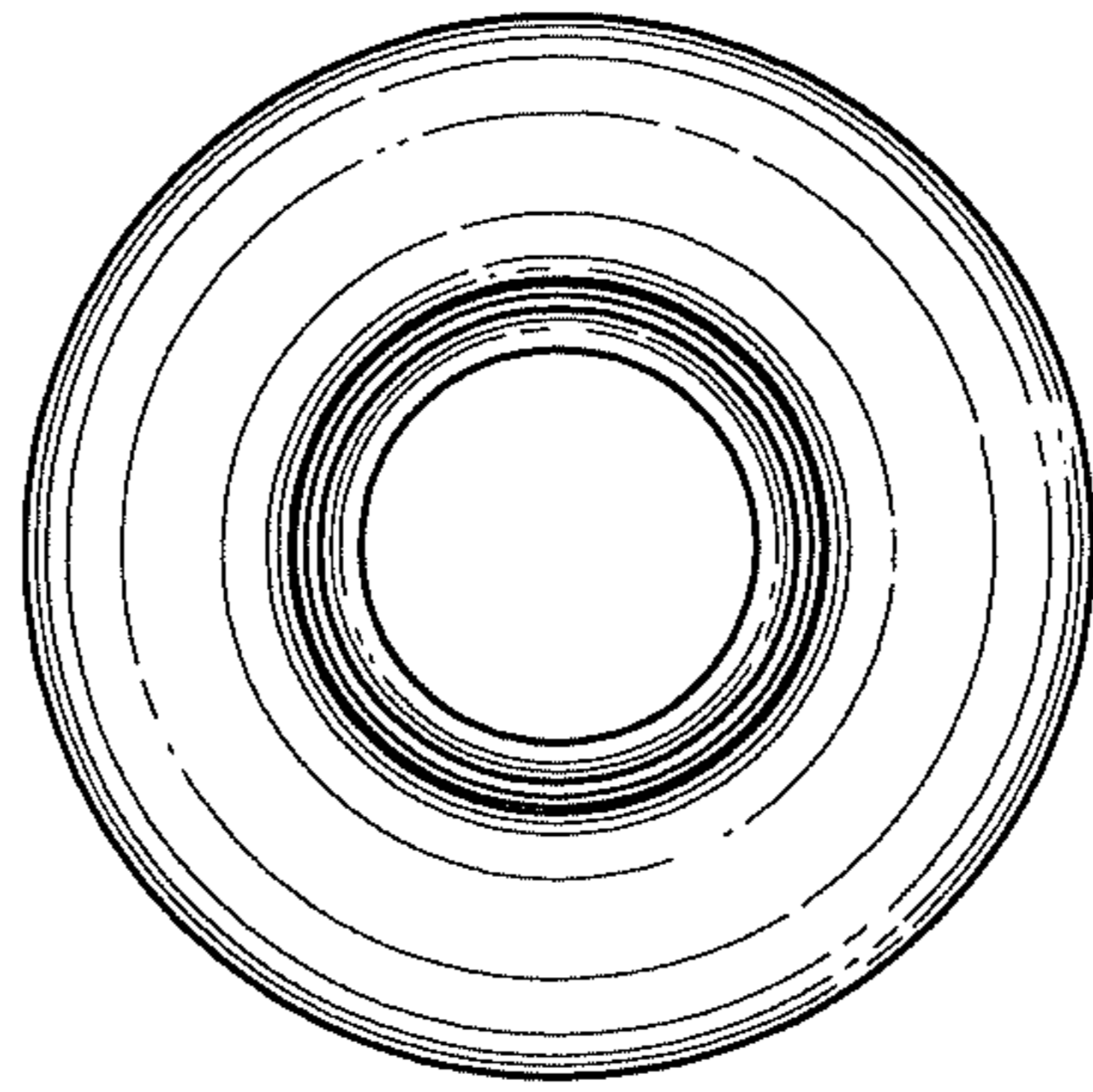

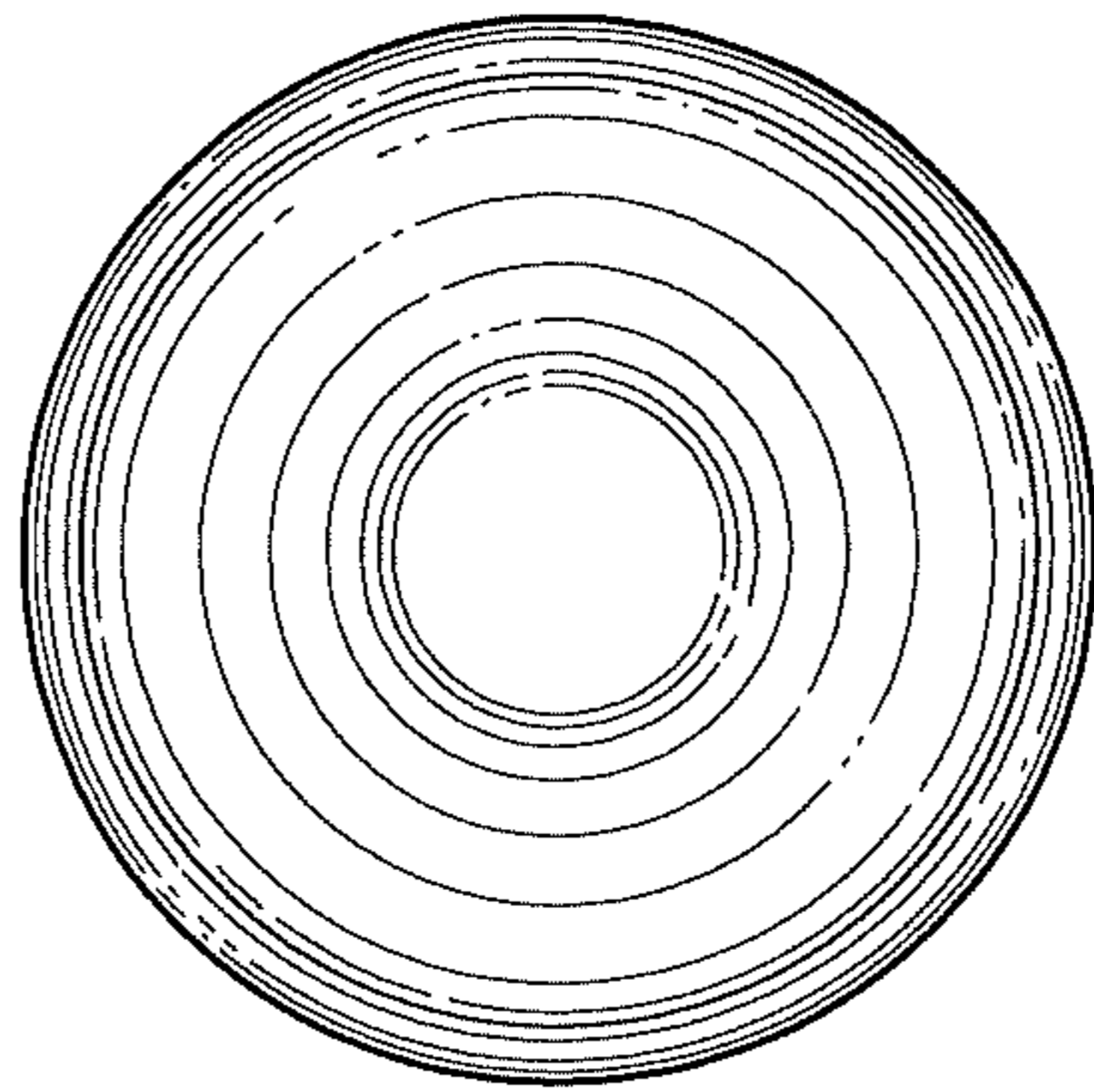
