FIG. 7 is a bottom view of the bottle of FIG. 1.

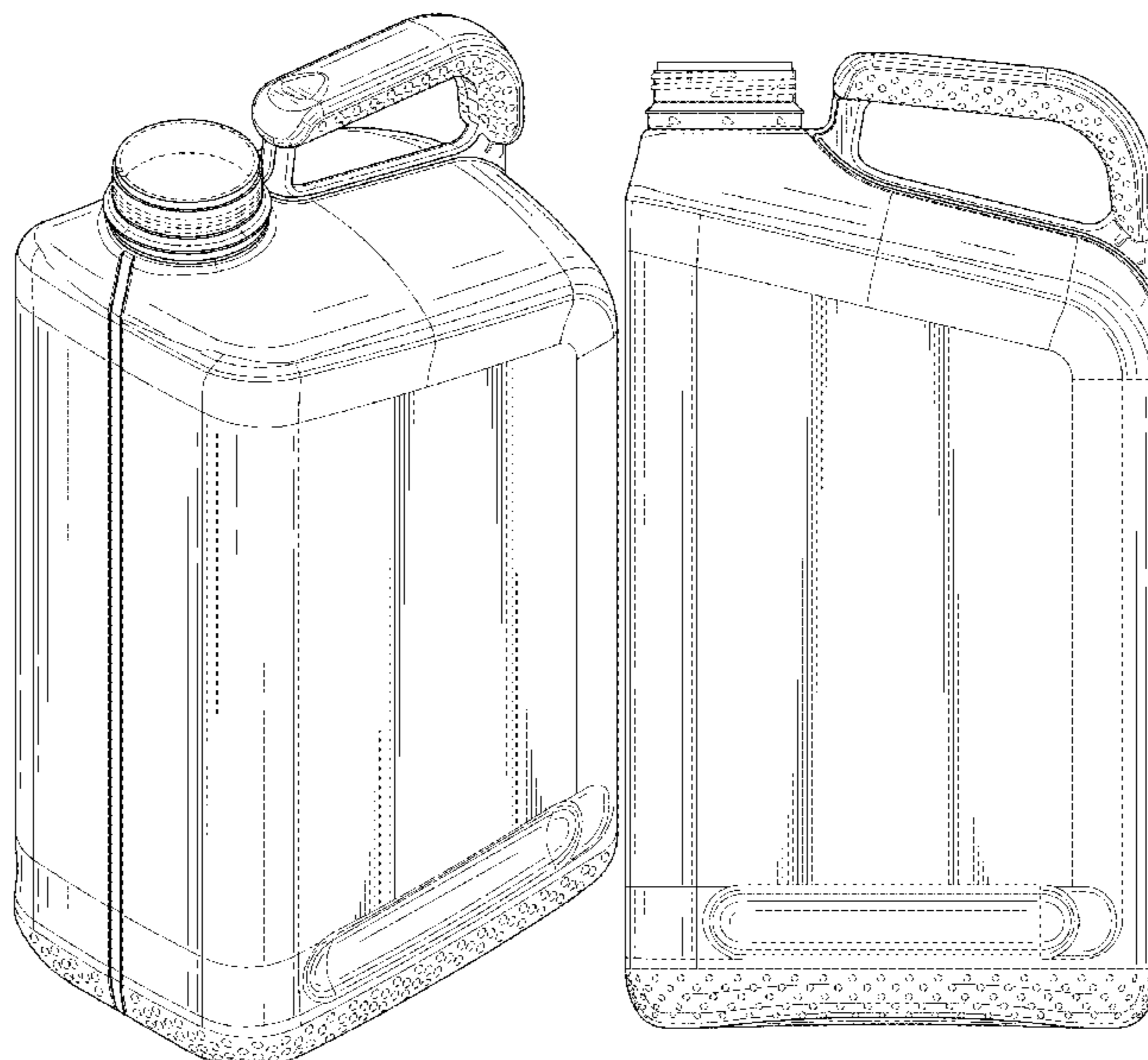
The broken lines in the drawings including the repeating circular details on the bottle handle and around the base of the bottle illustrate the portions of the bottle that form no part of the claimed design.

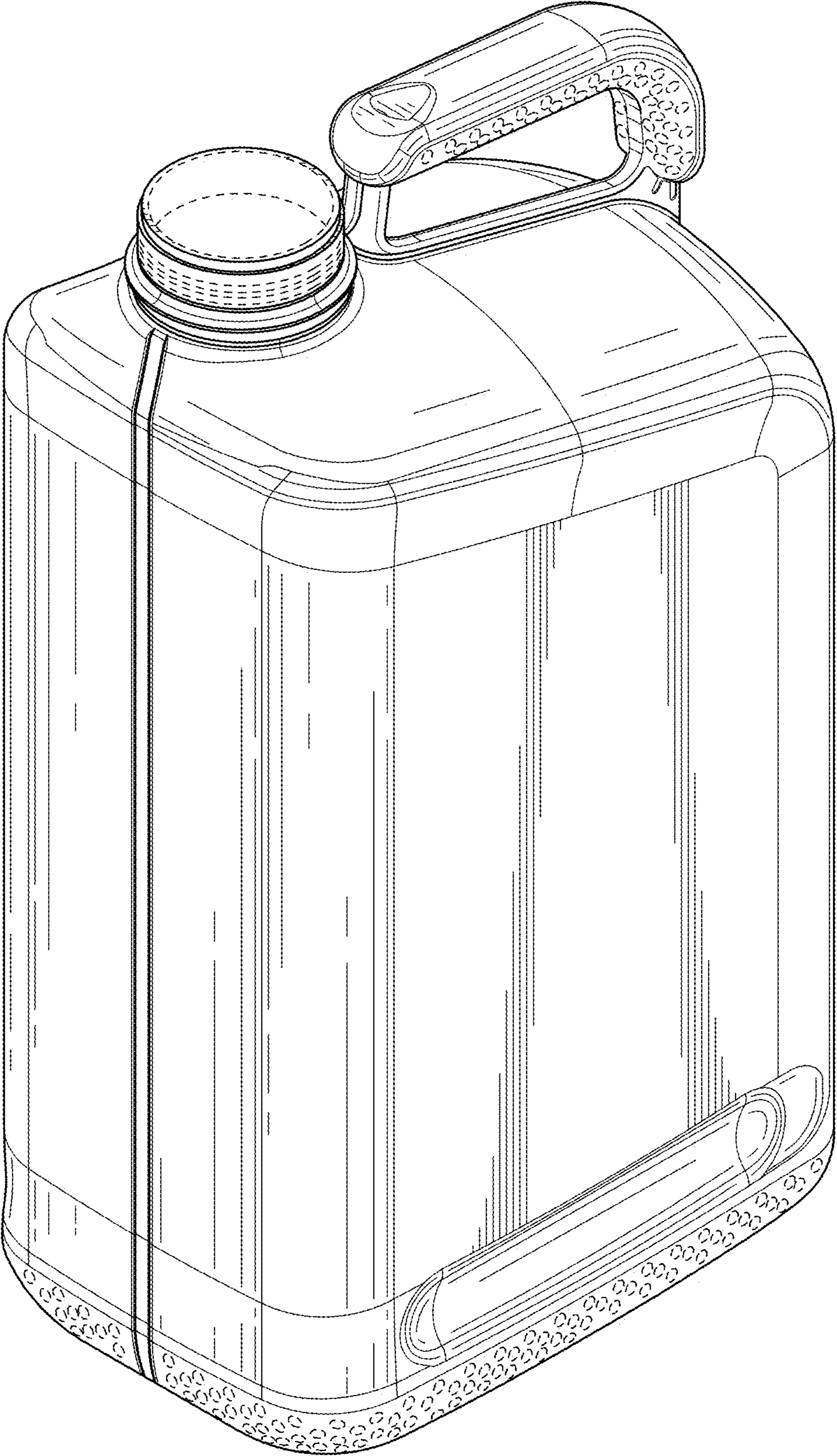

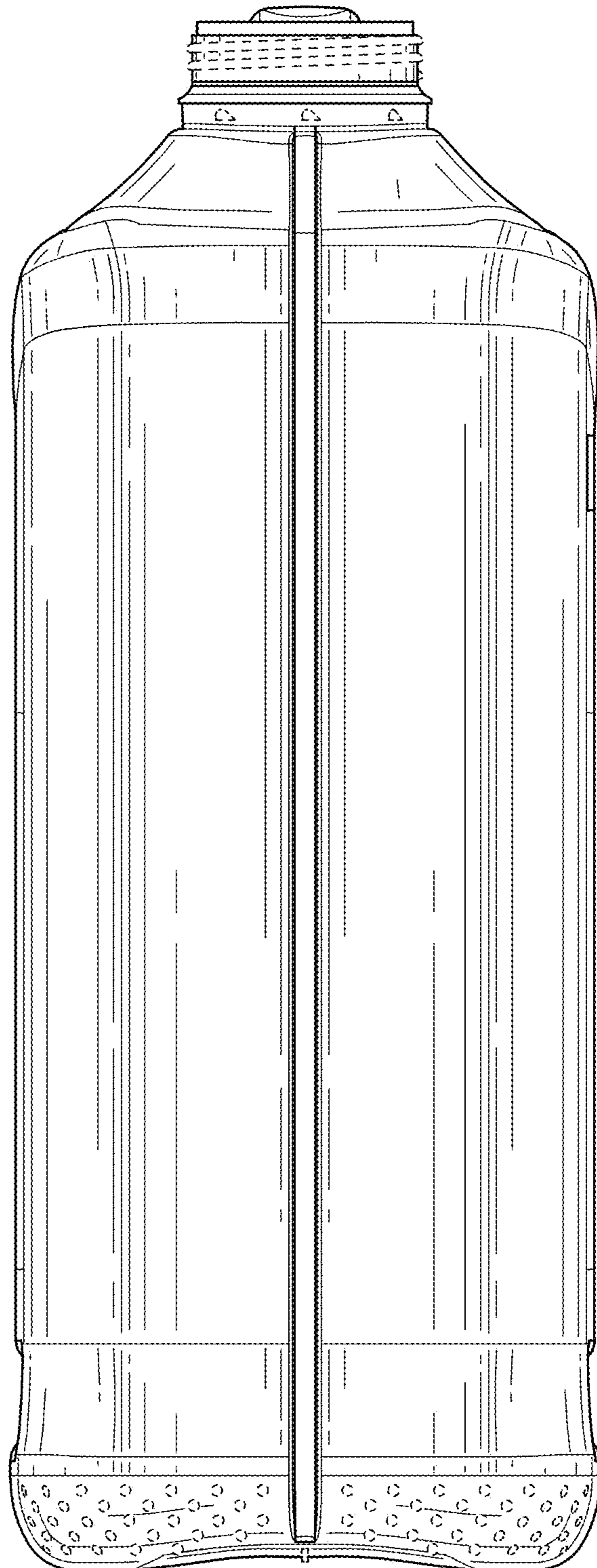

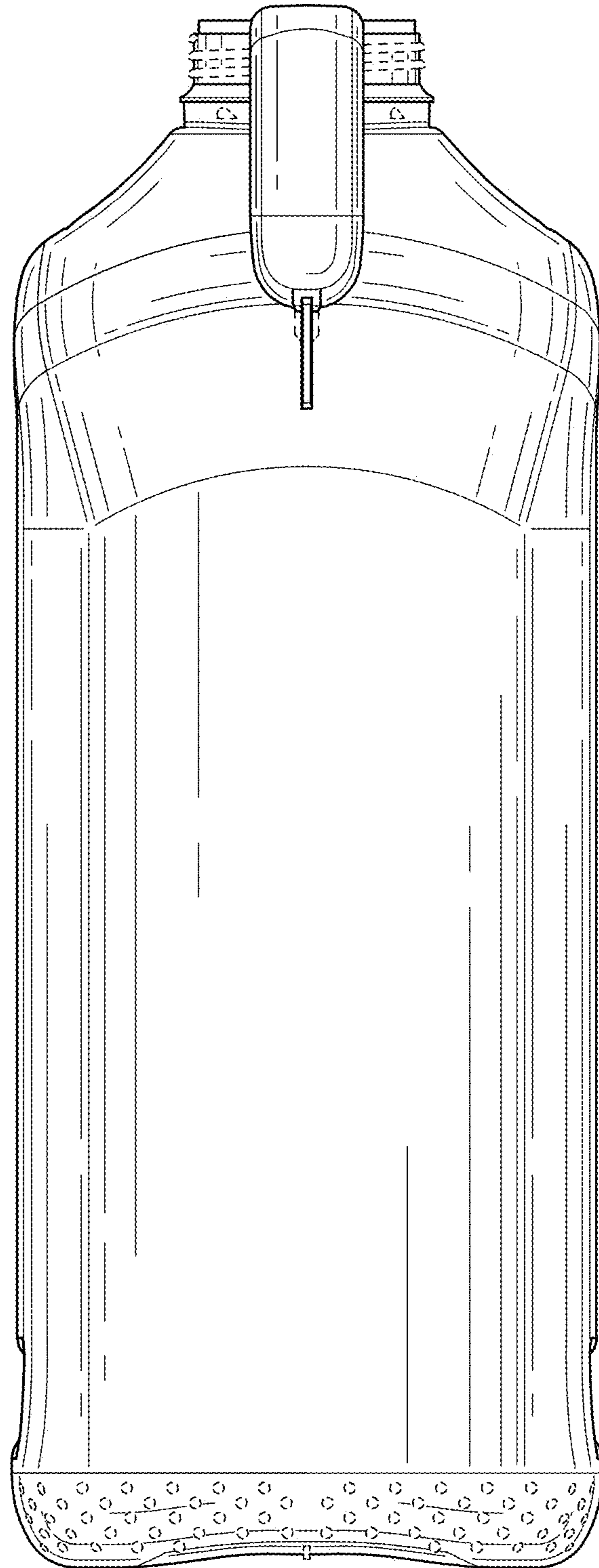

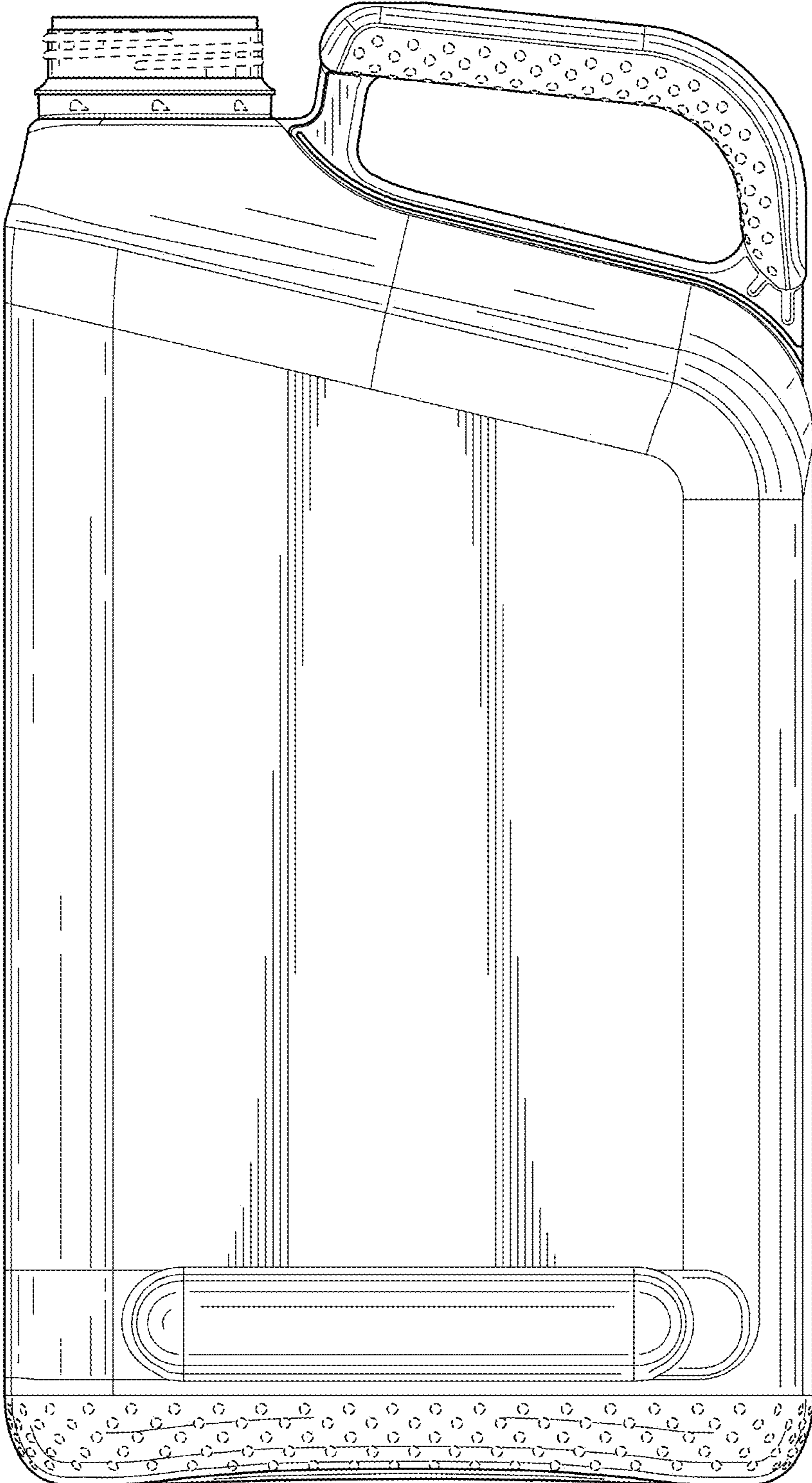

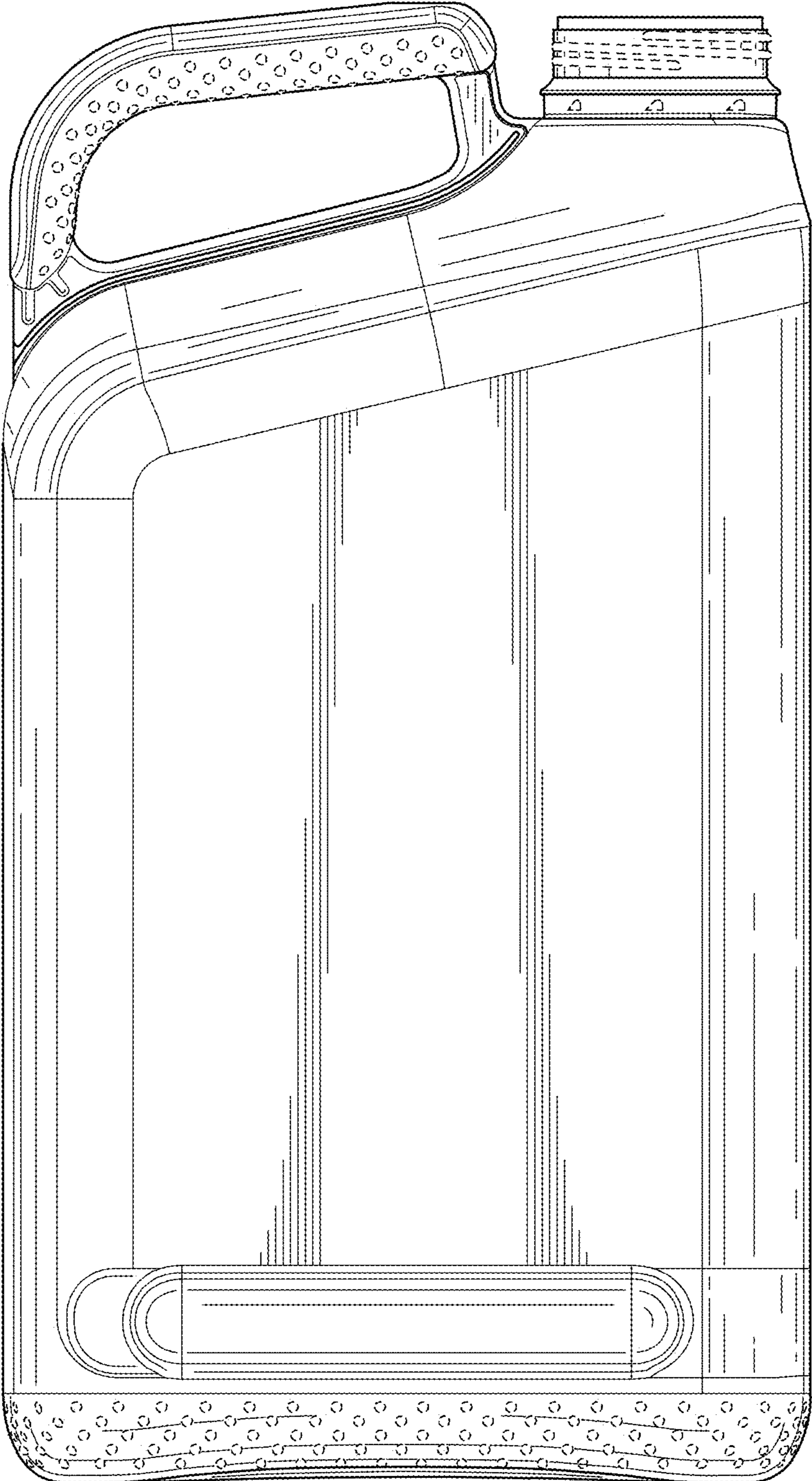

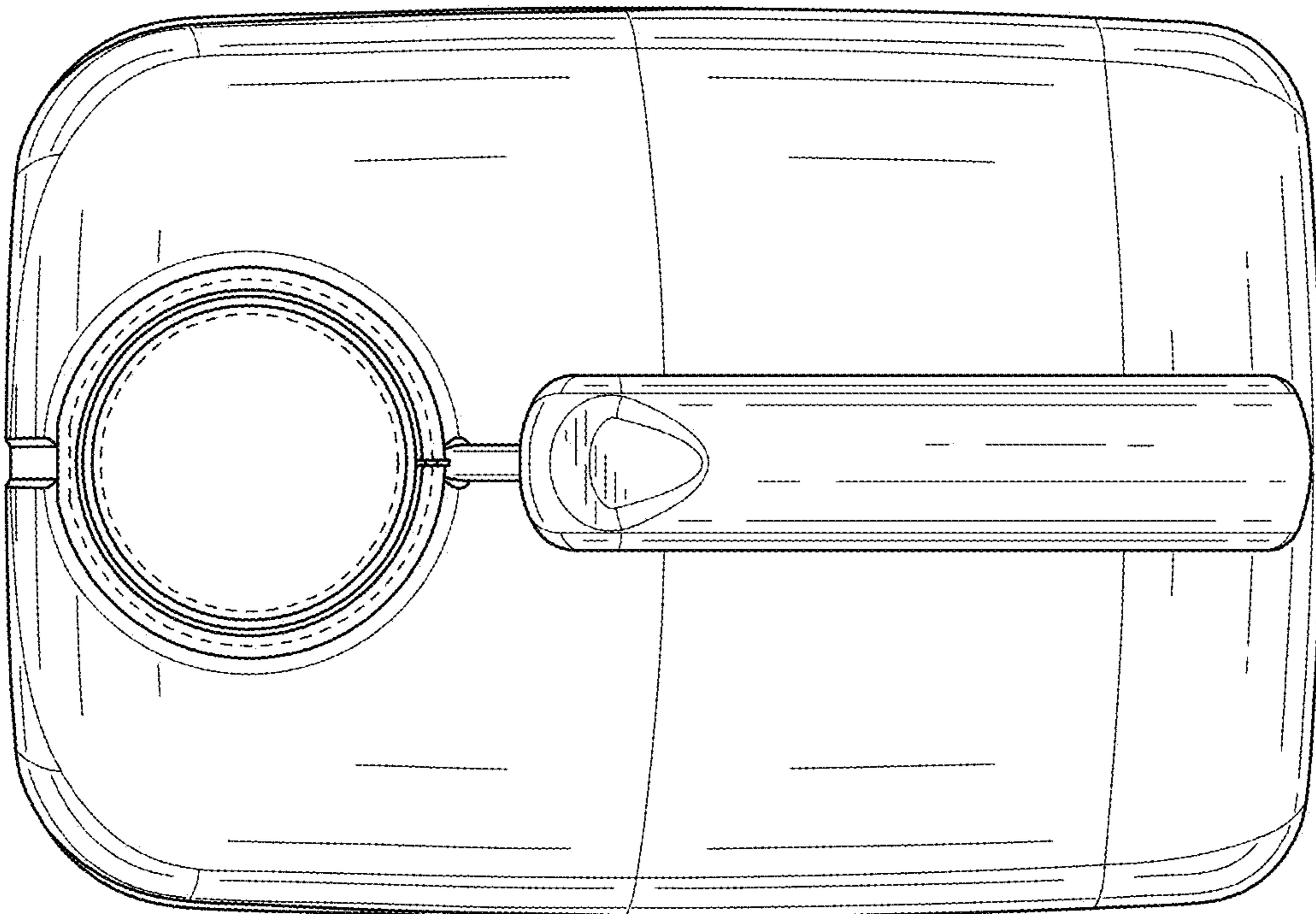
