installation of FIG. 1.

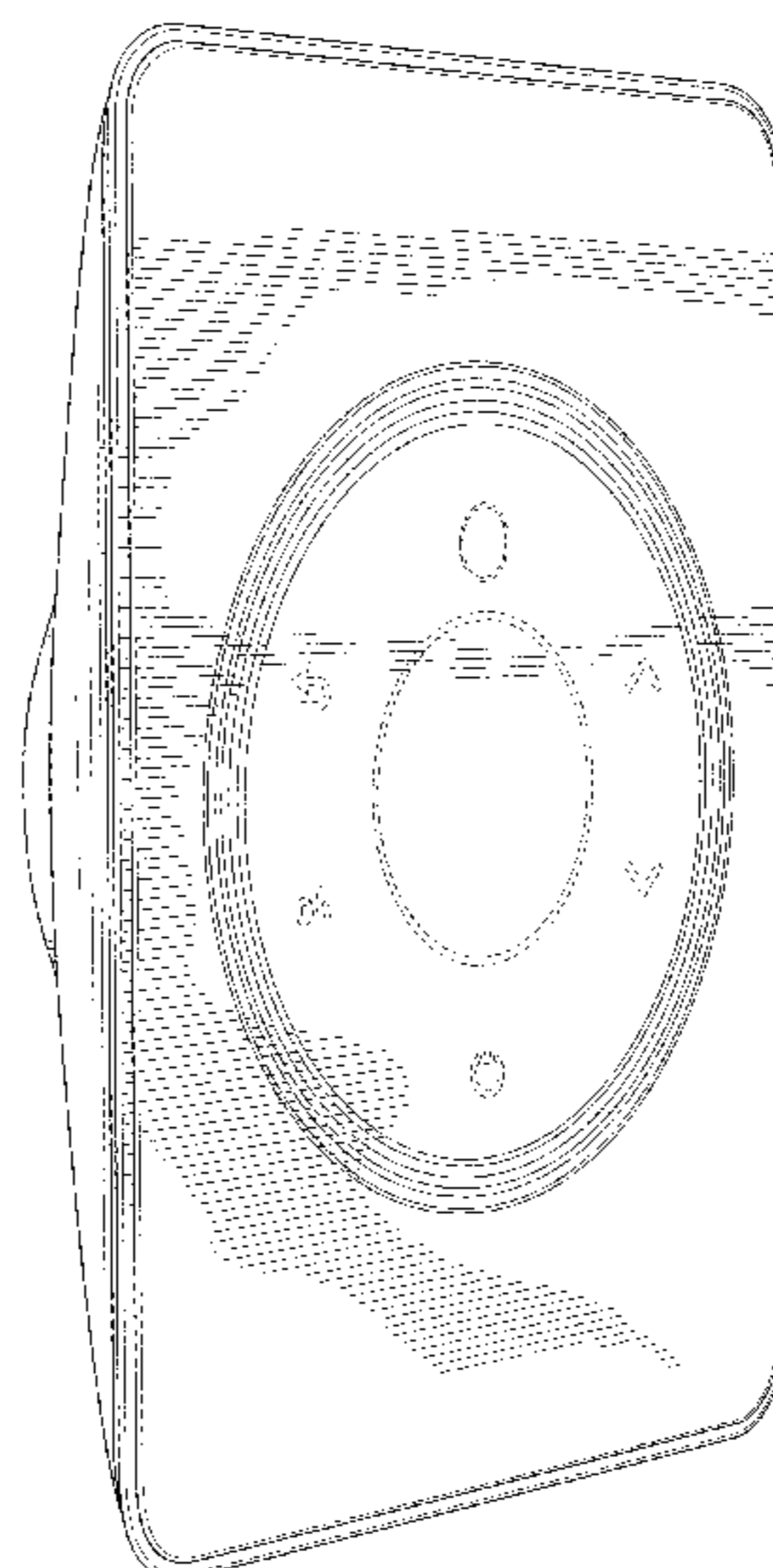
The broken lines shown in the drawings illustrate portions of

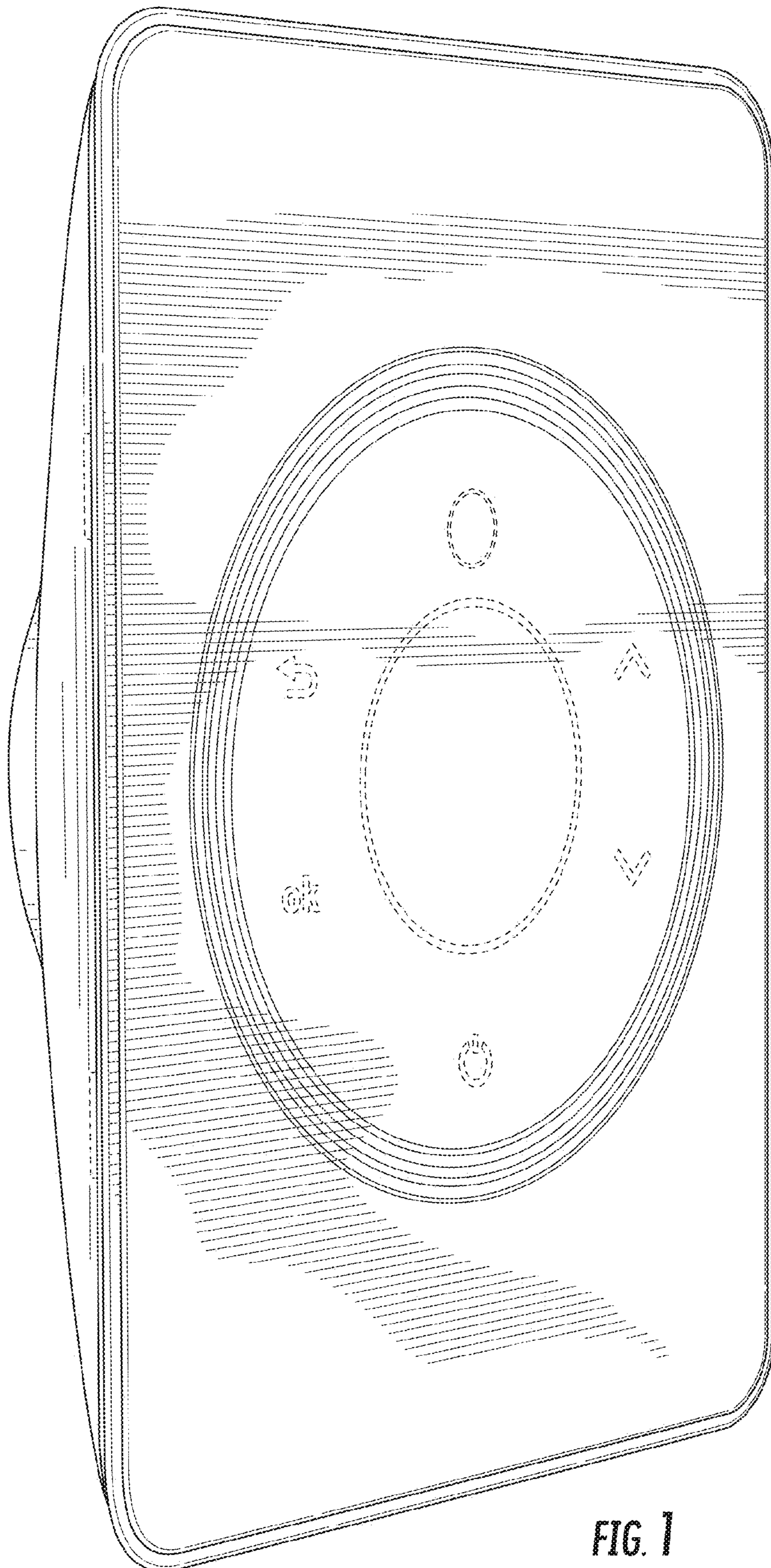

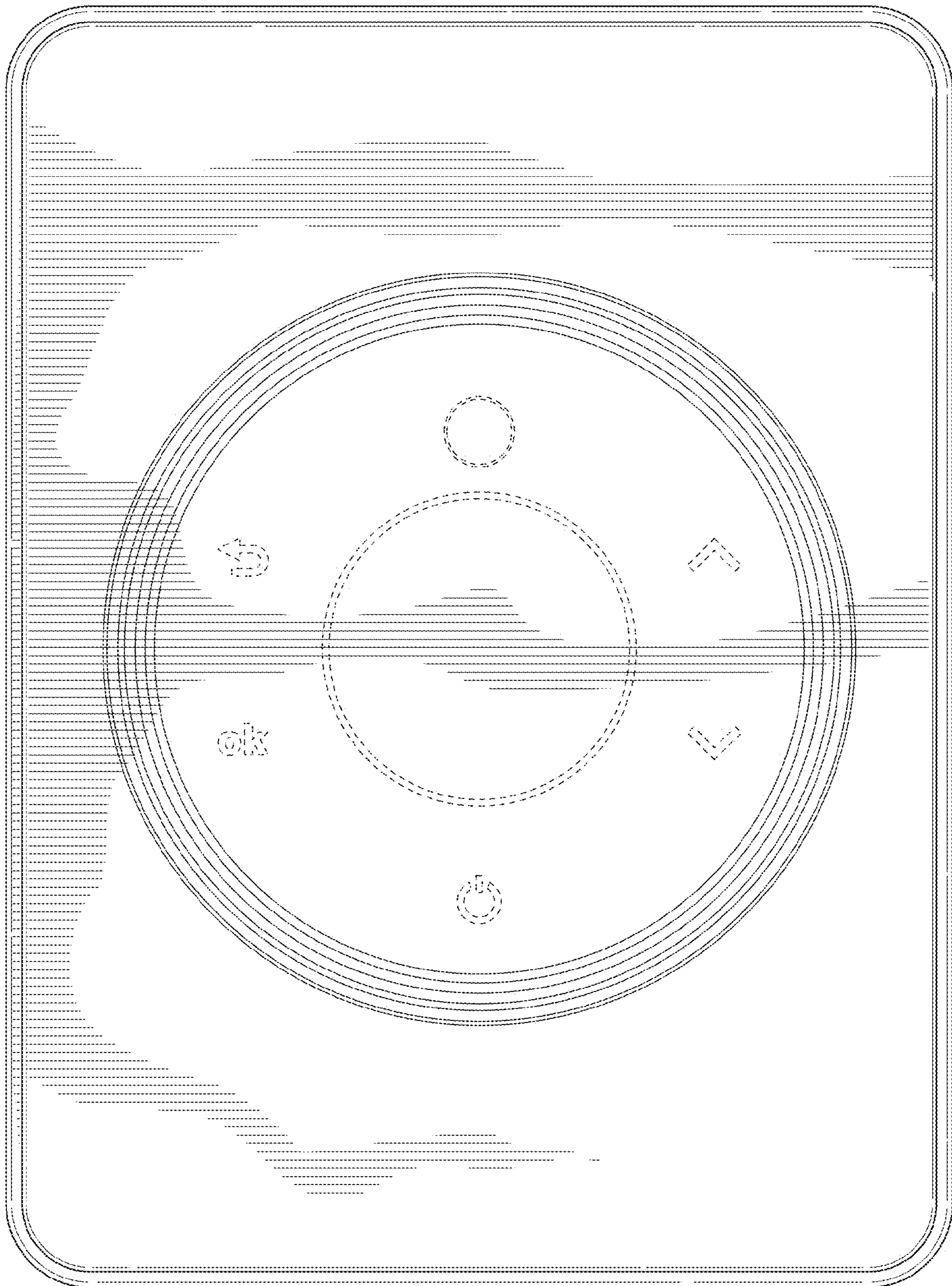

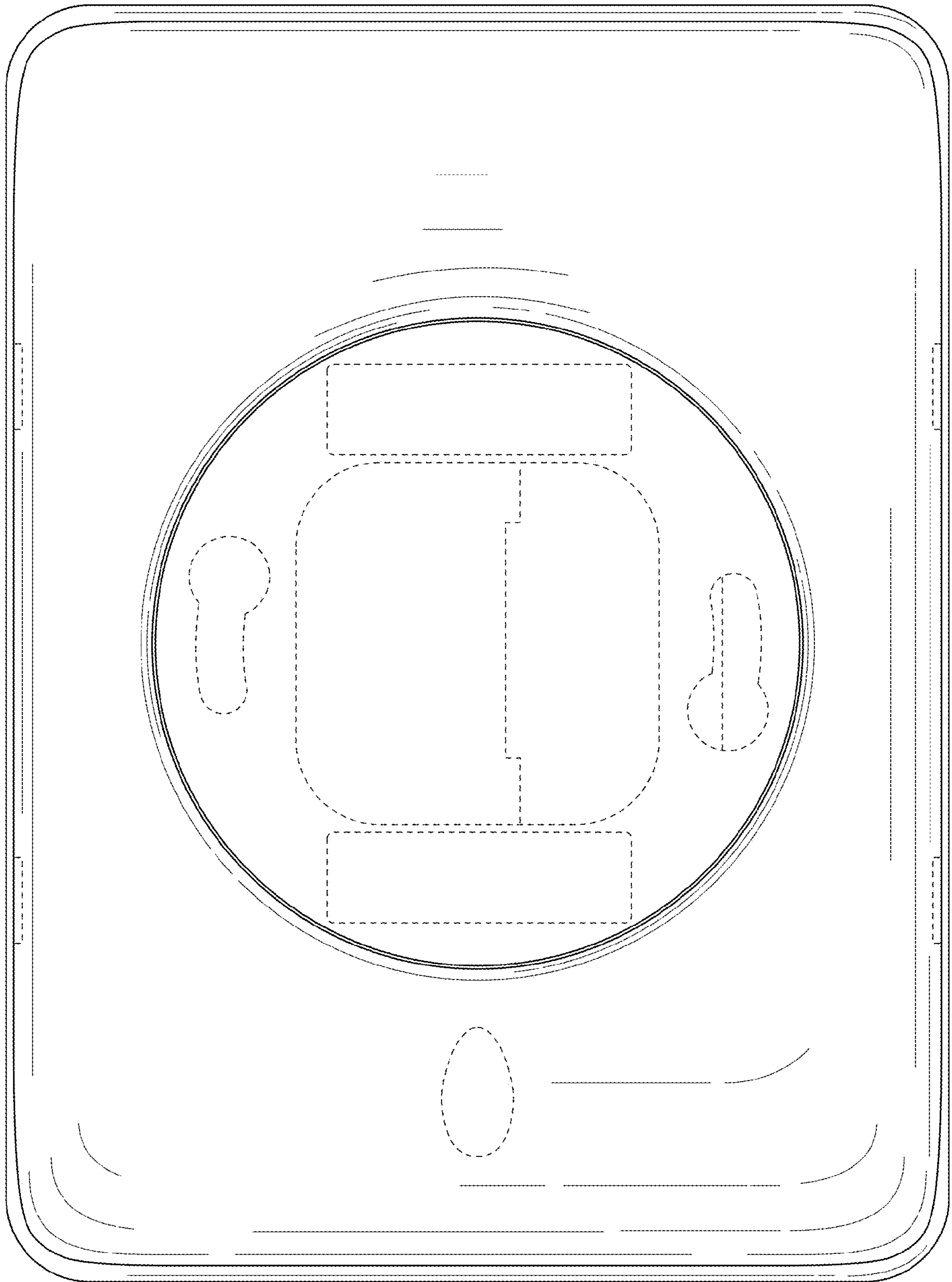
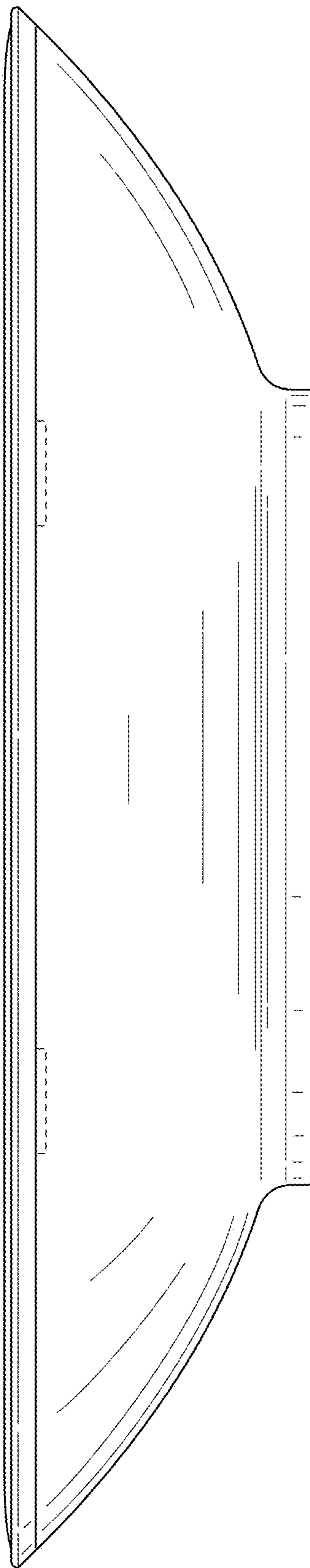
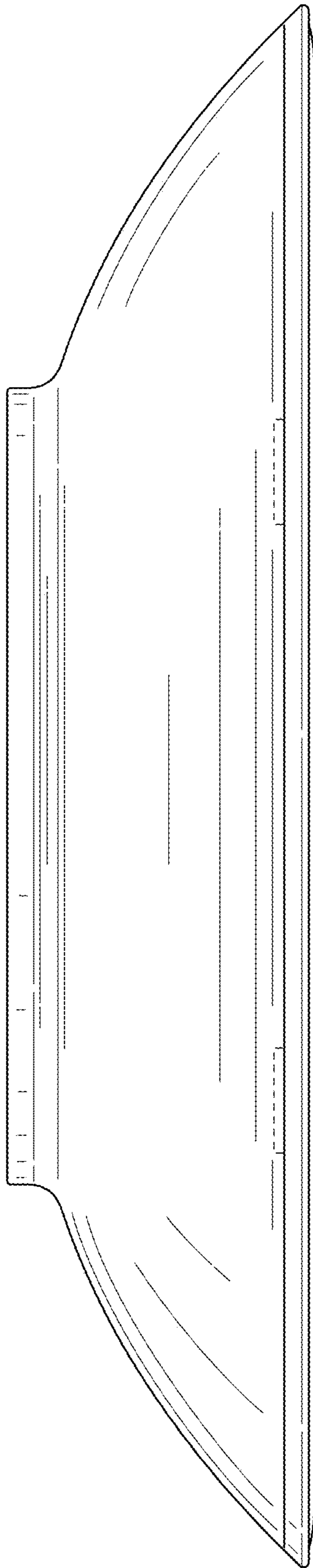


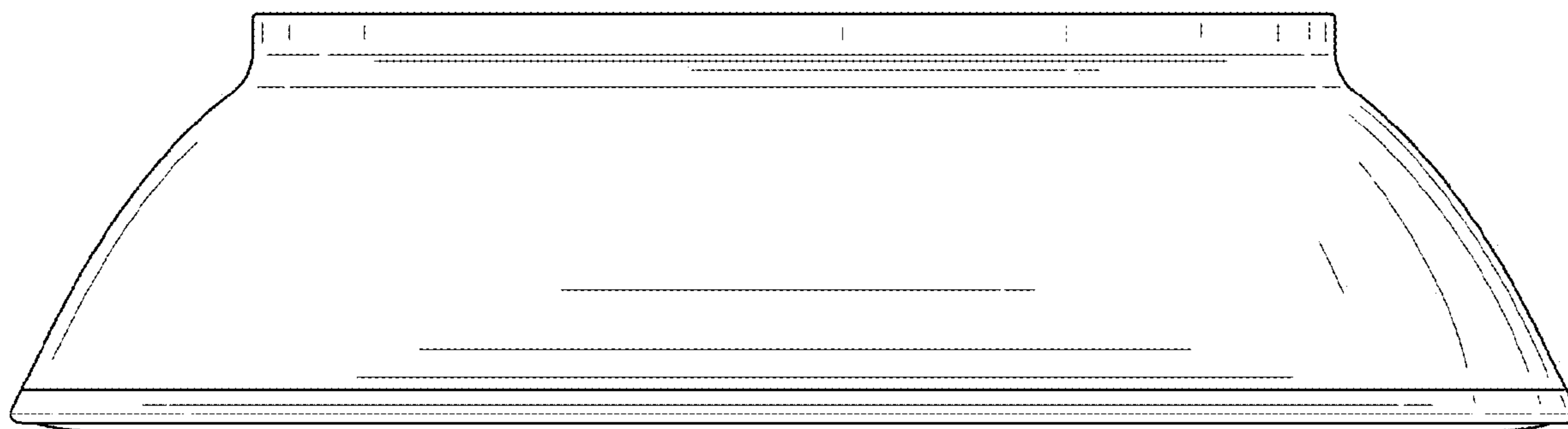

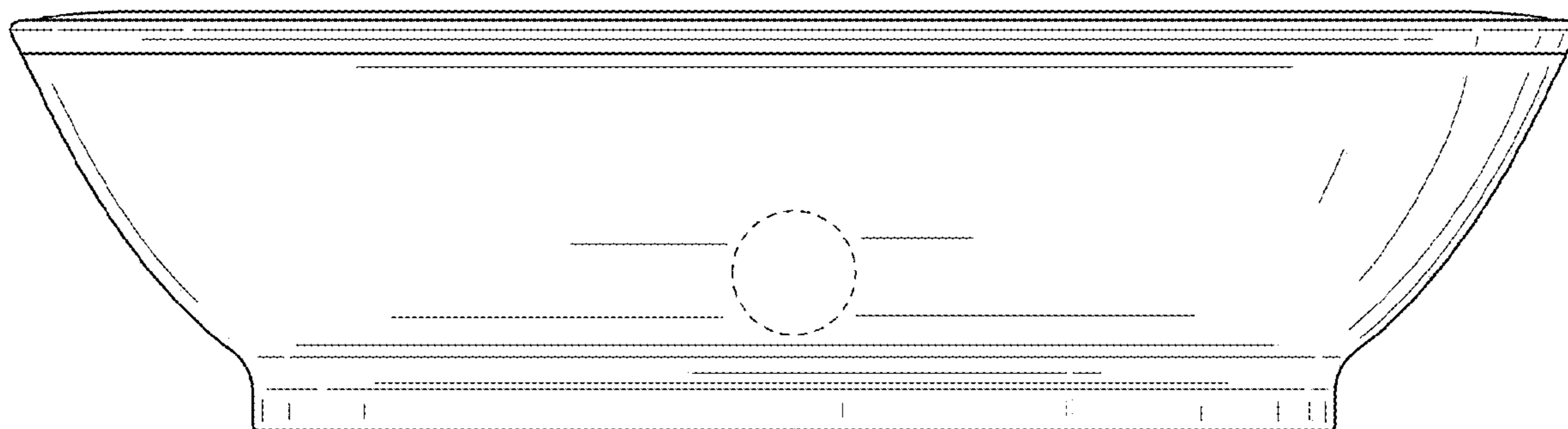
