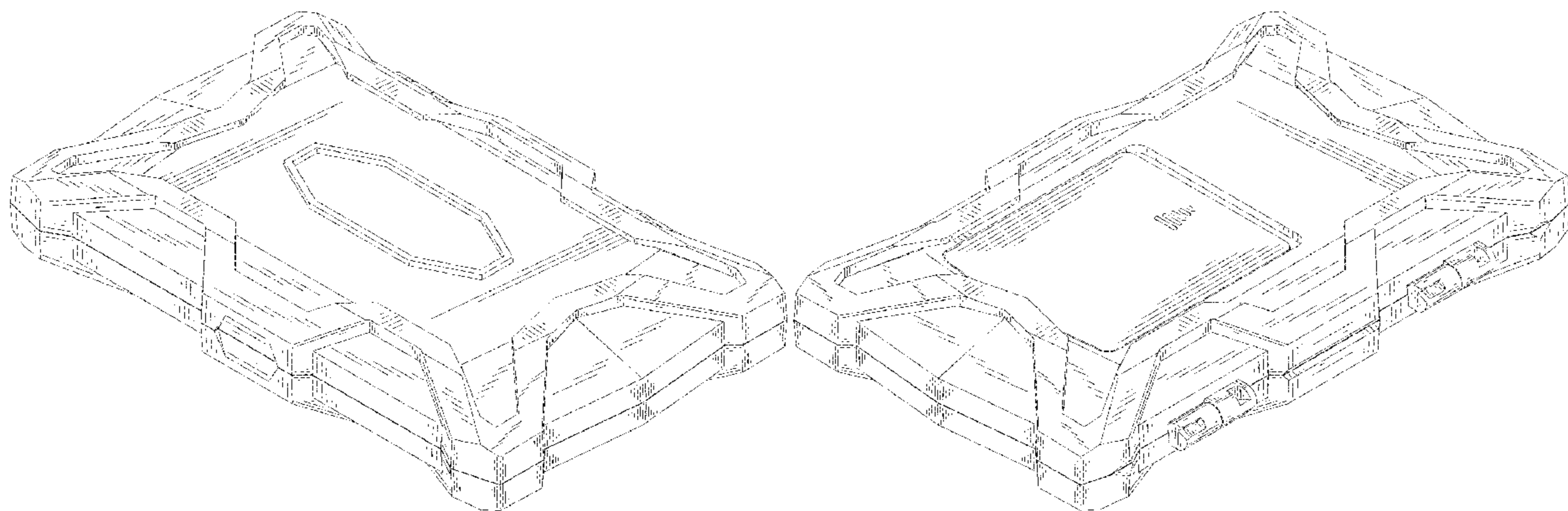
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, bottom and left side perspective view of an electronic scale showing my new design;
FIG. 2 is a rear, top and right side perspective view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a left side plan view thereof;
FIG. 6 is a right plan view thereof;
FIG. 7 is a front elevation view thereof;

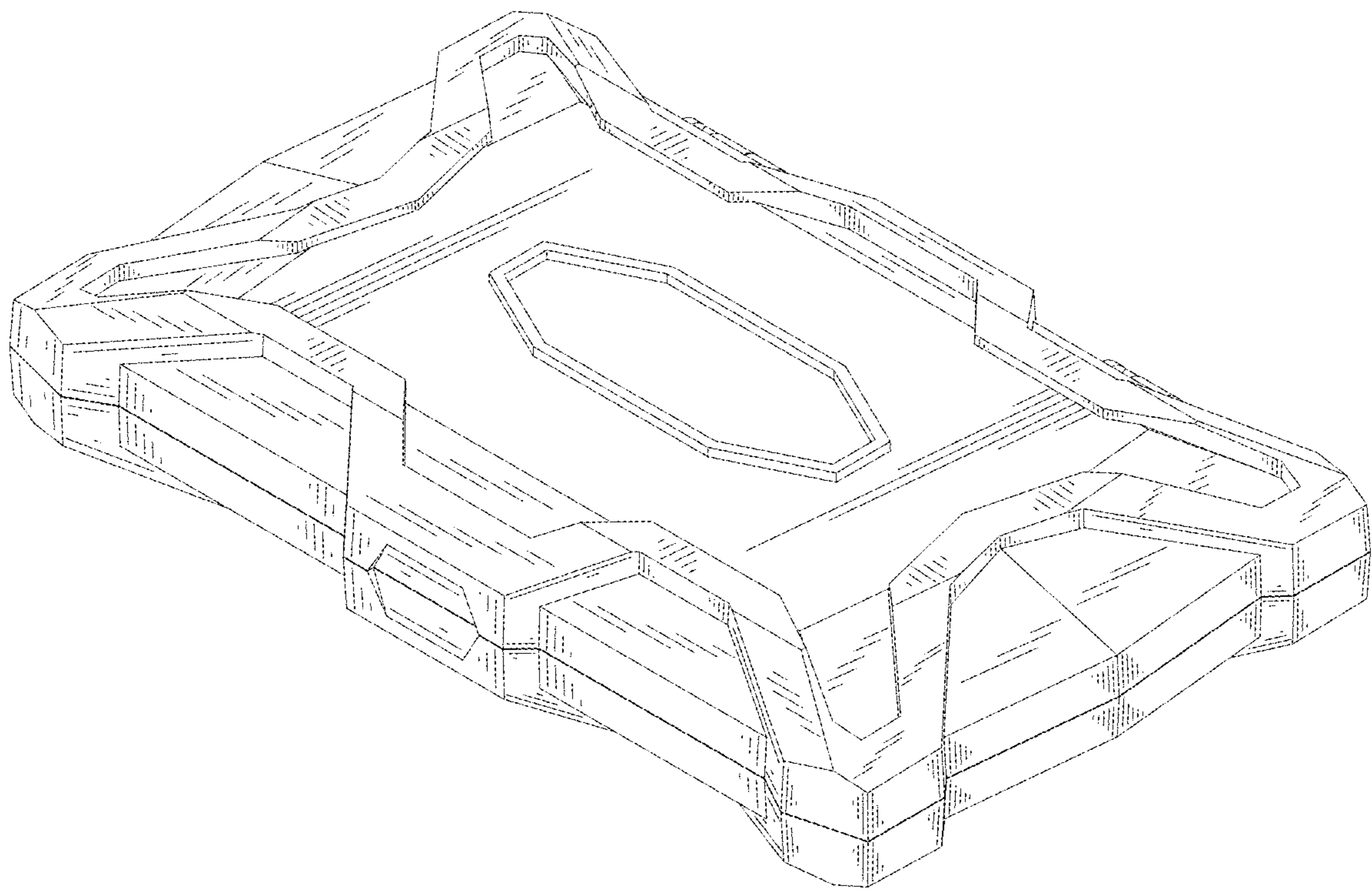

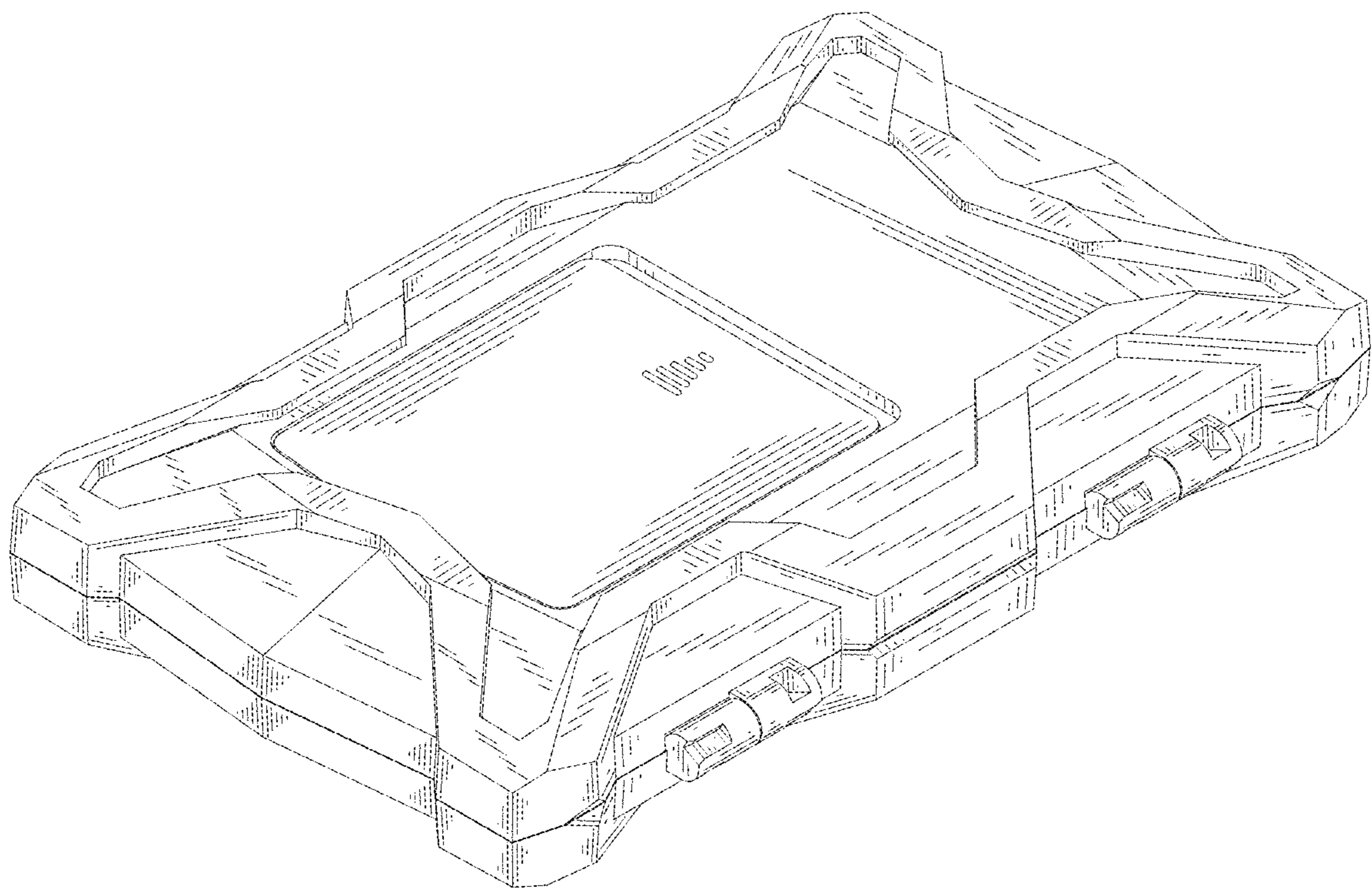

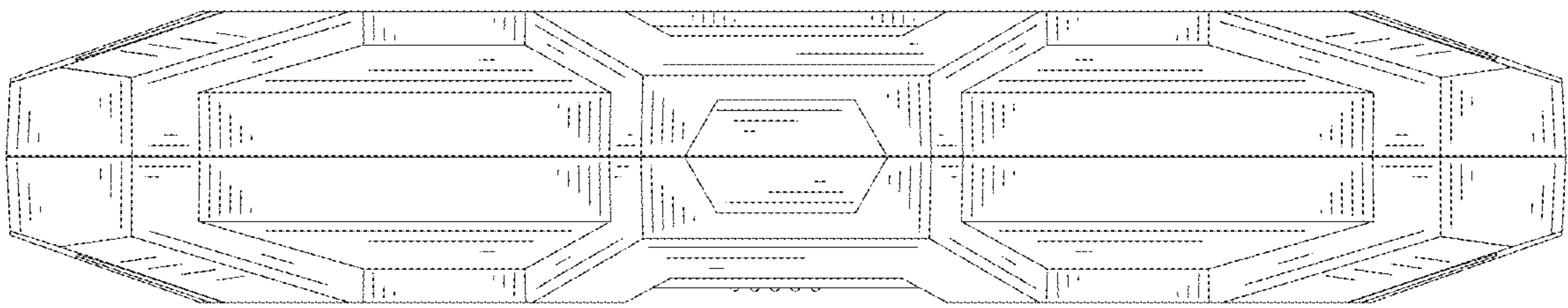

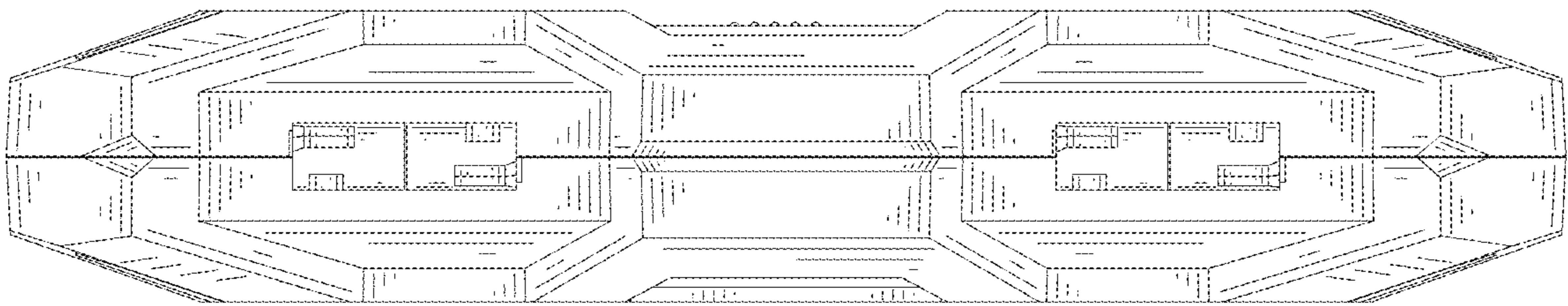

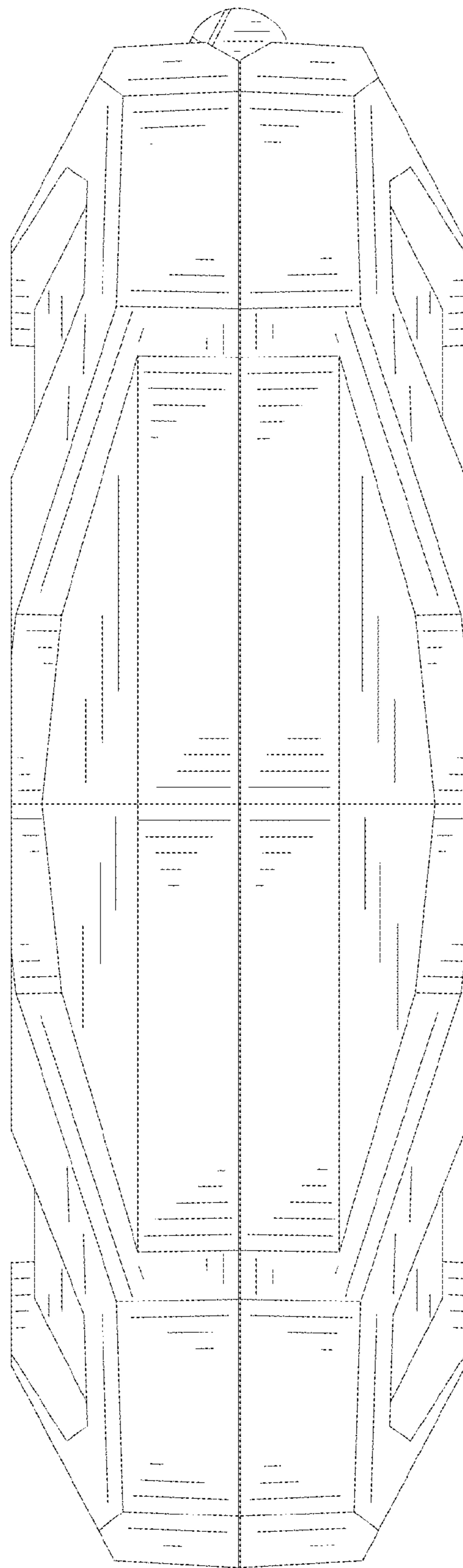

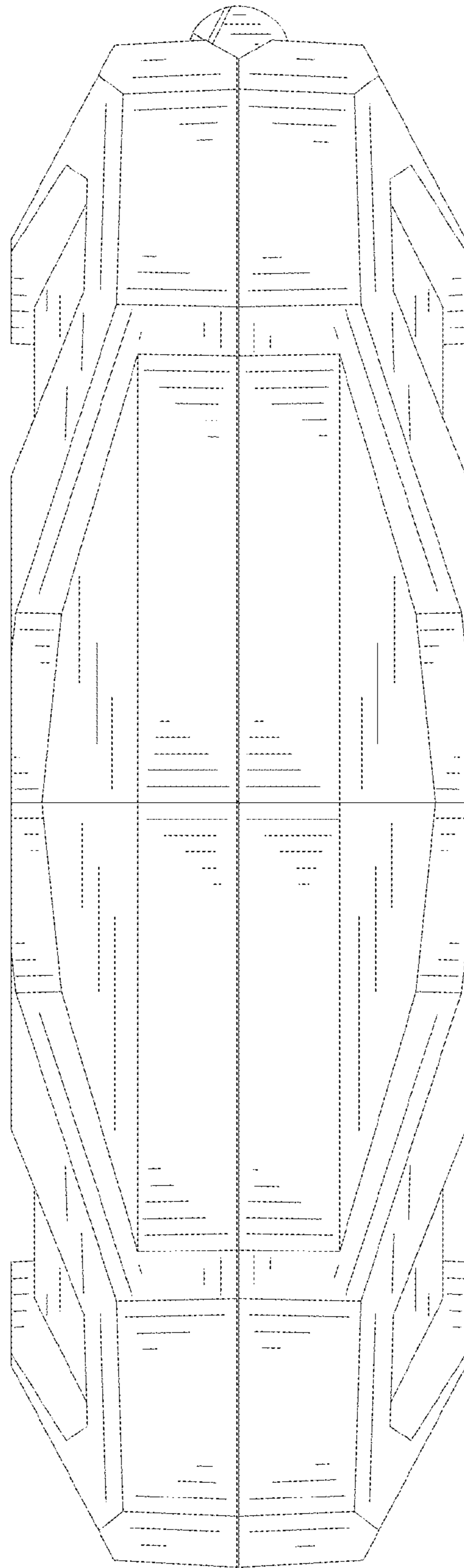

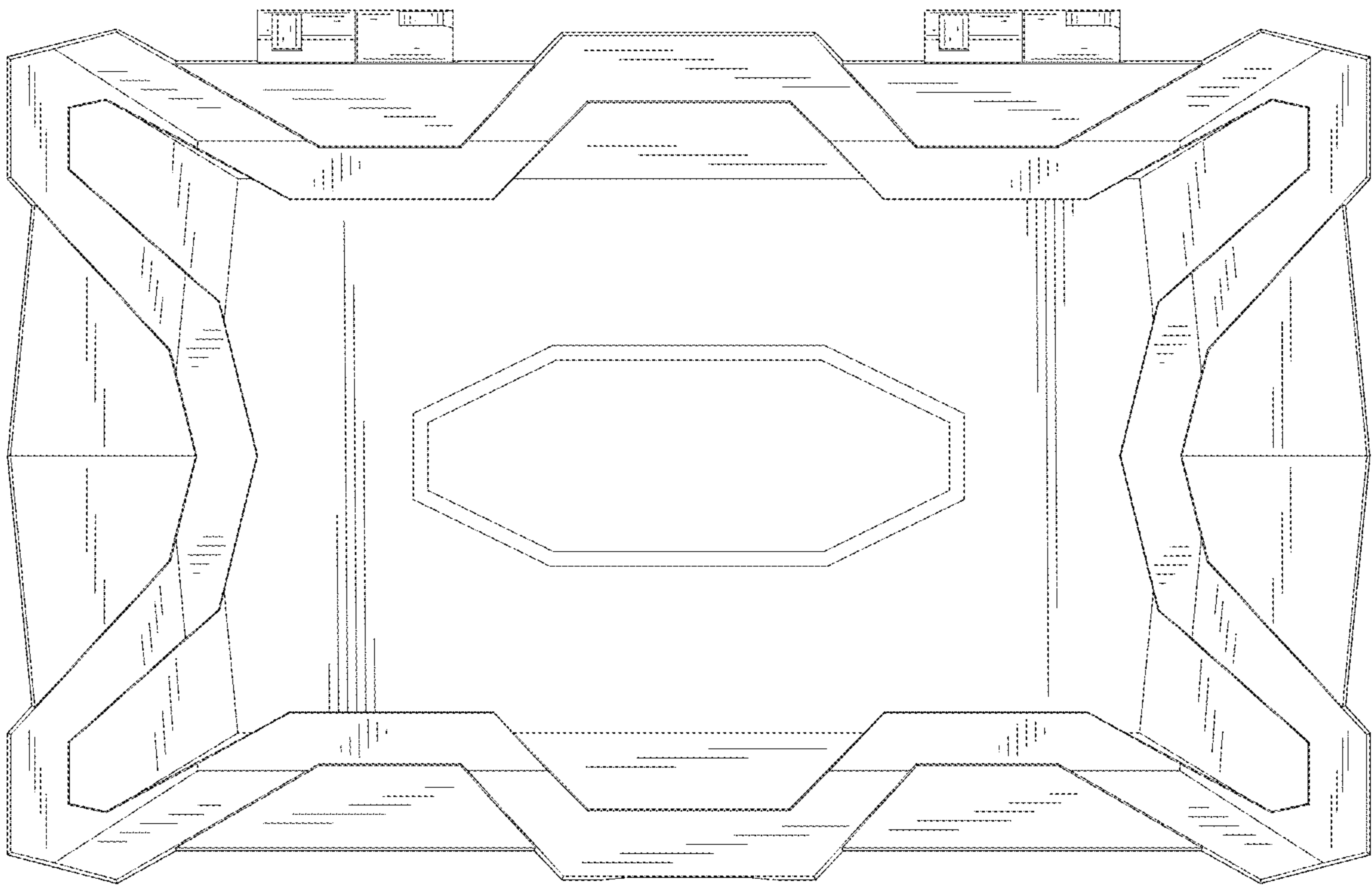

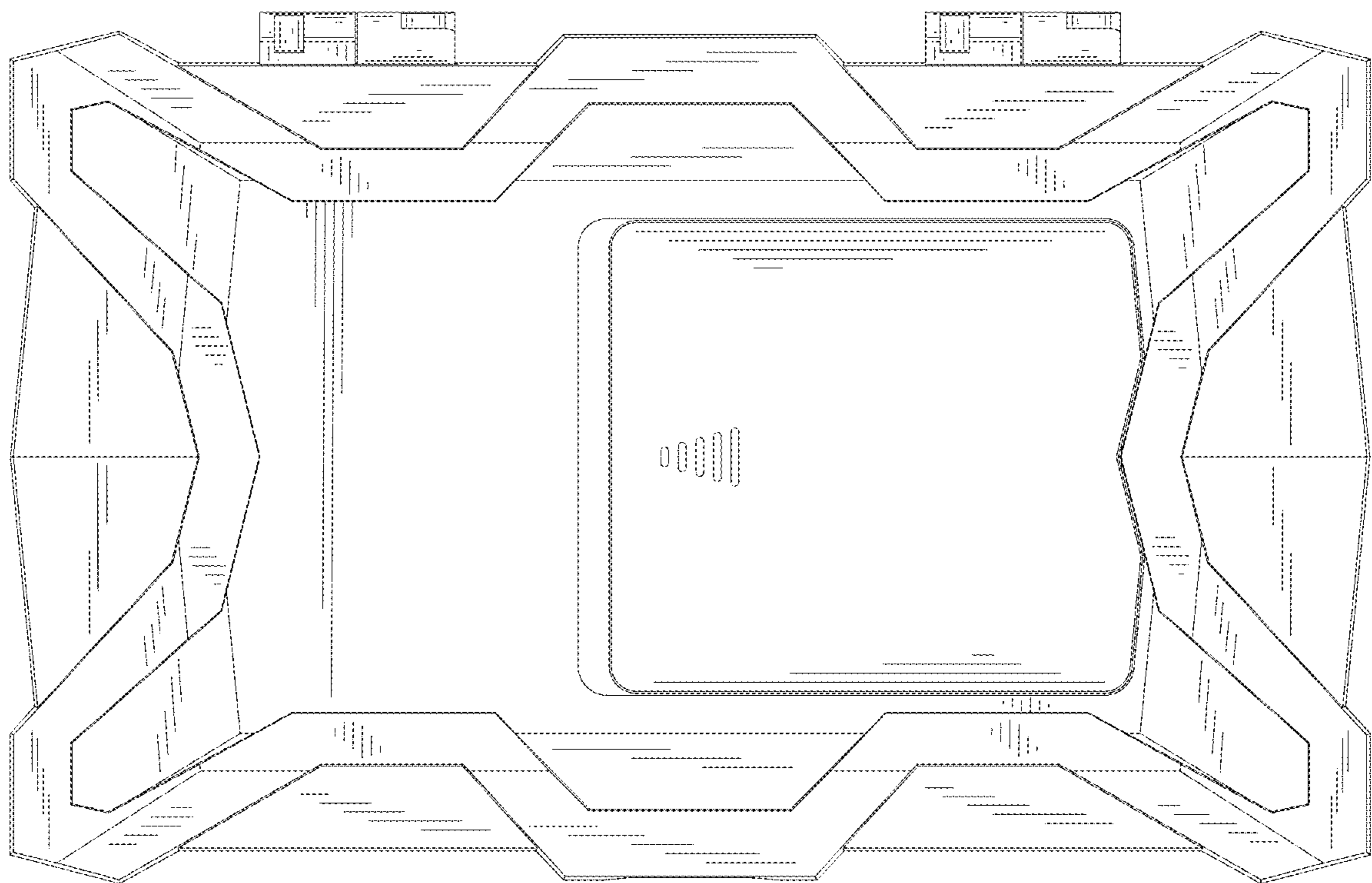
