(57) **CLAIM**

The ornamental design for a sump pump power adapter, as shown as described.

**DESCRIPTION**

FIG. 1 is a front, top, right, isometric view of an ornamental design for a sump pump power adapter;

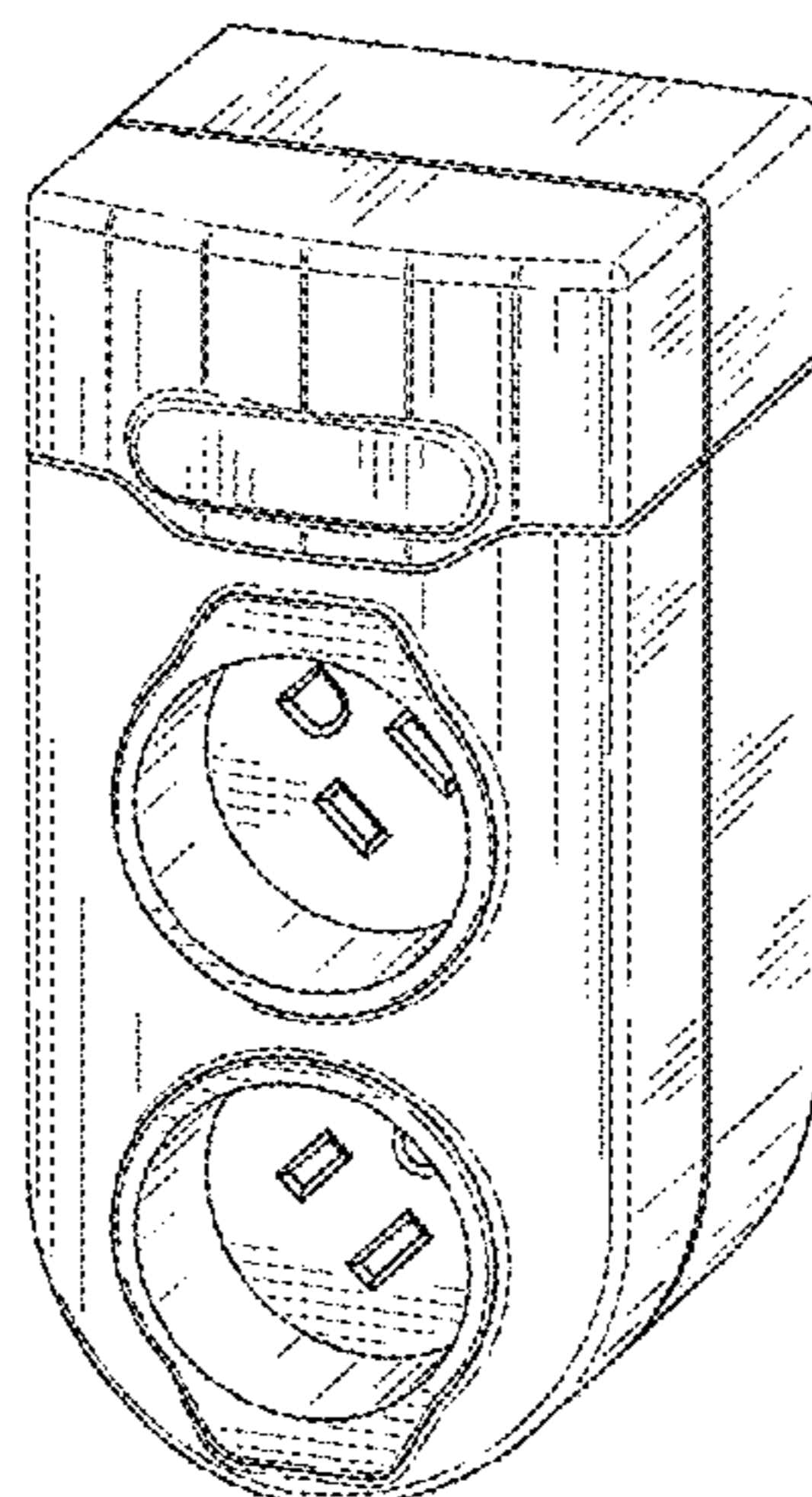


FIG. 24 is a rear elevational view of the sump pump power adapter of FIG. 22;

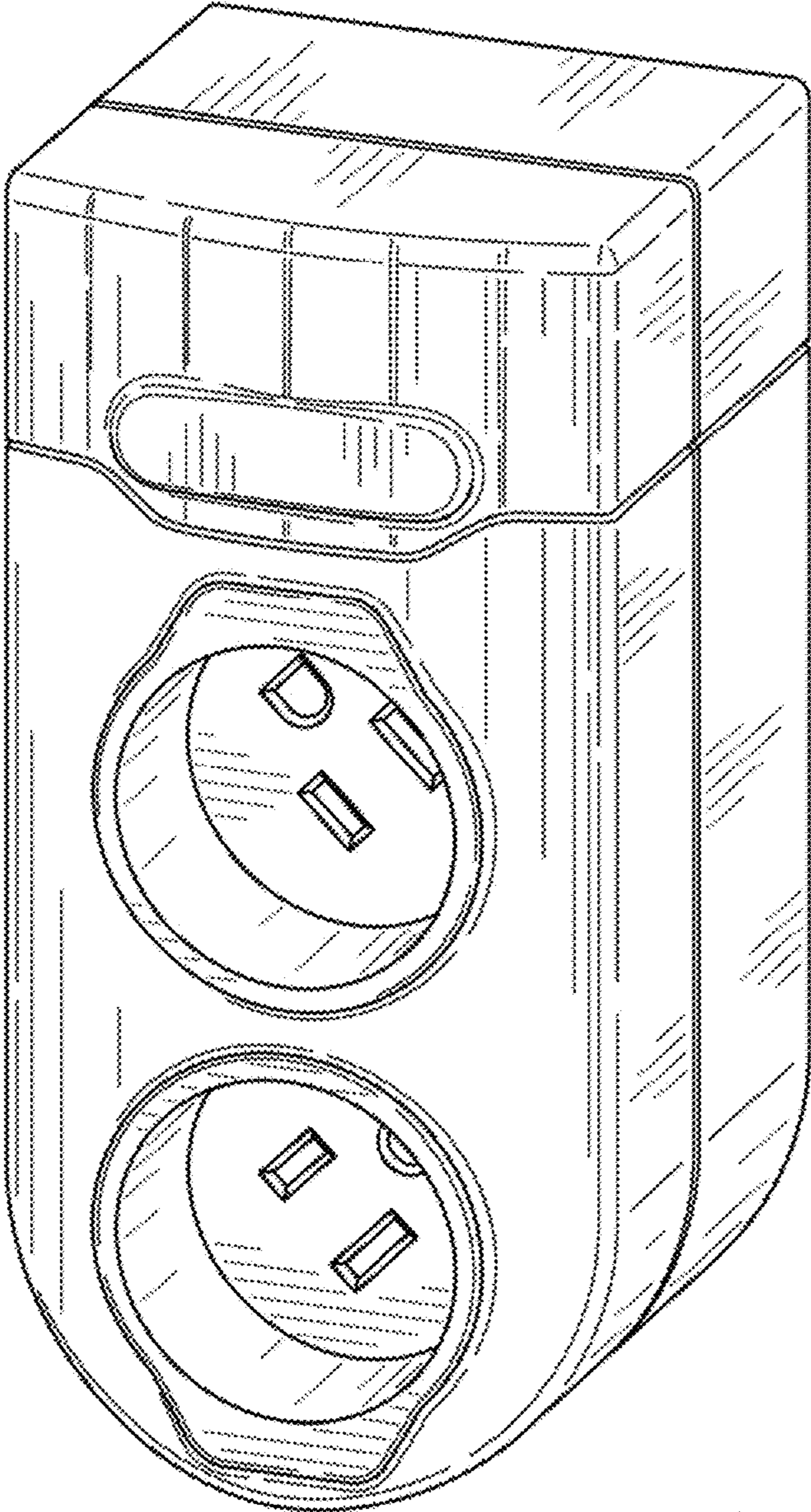

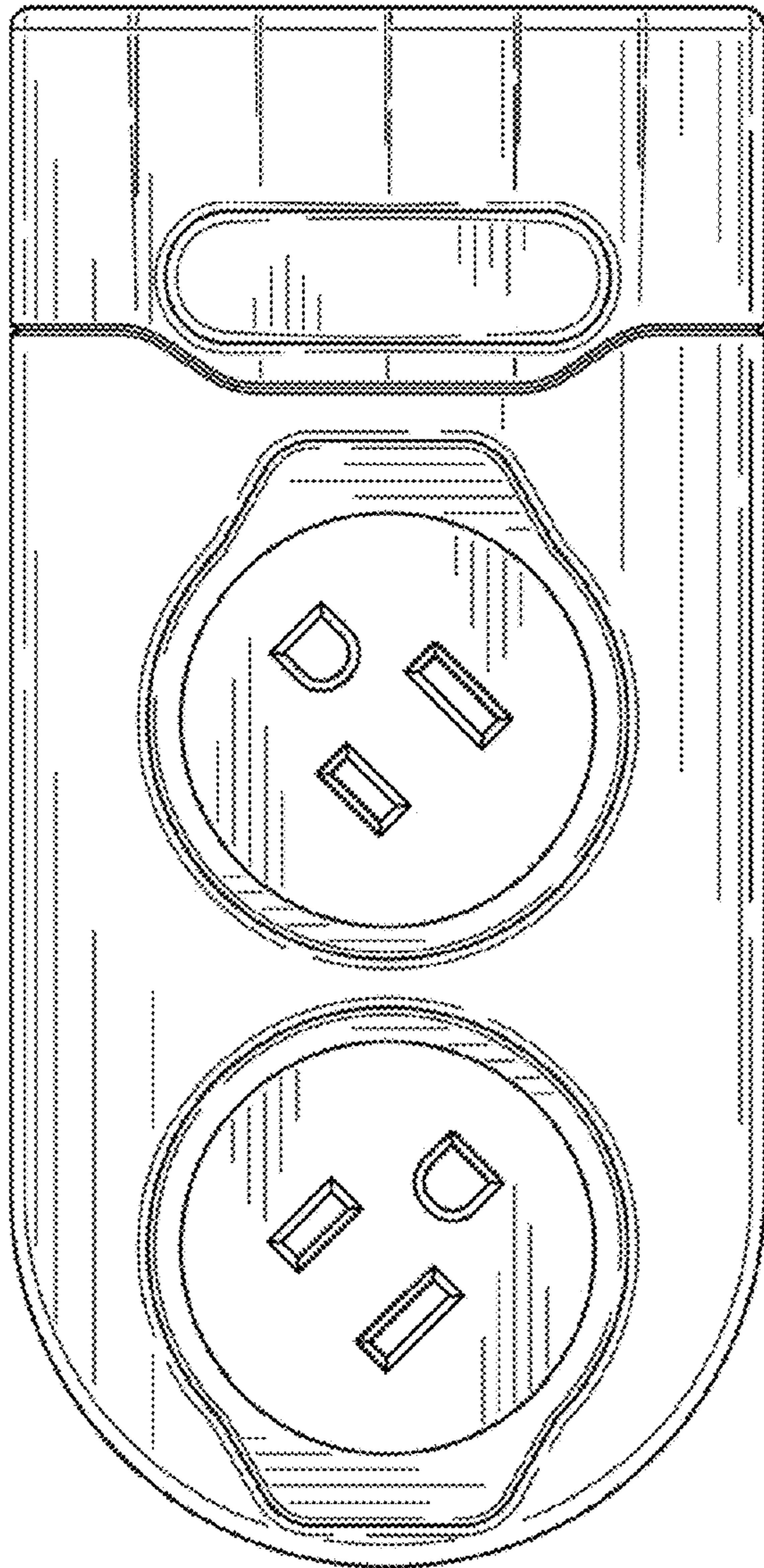

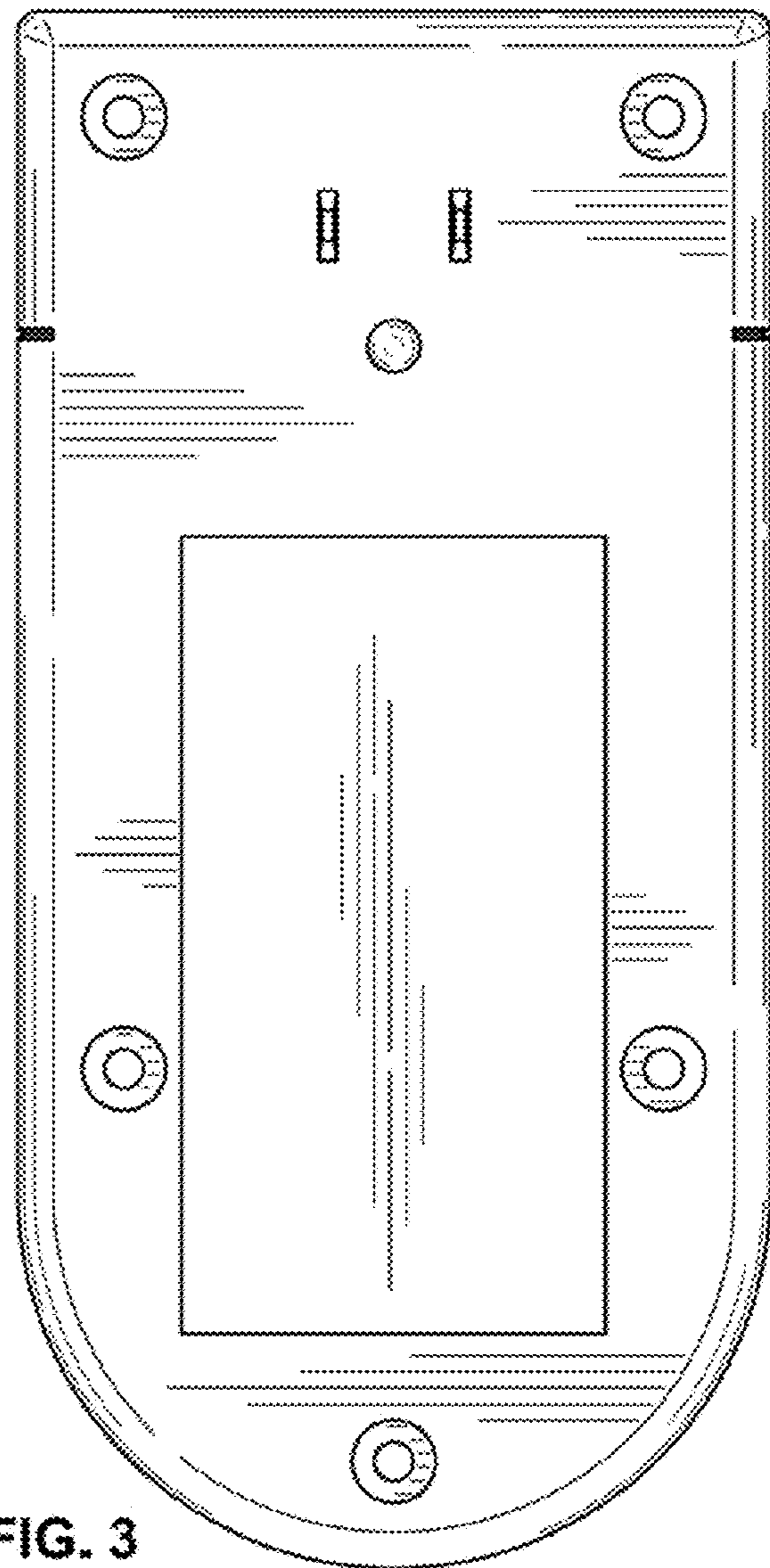

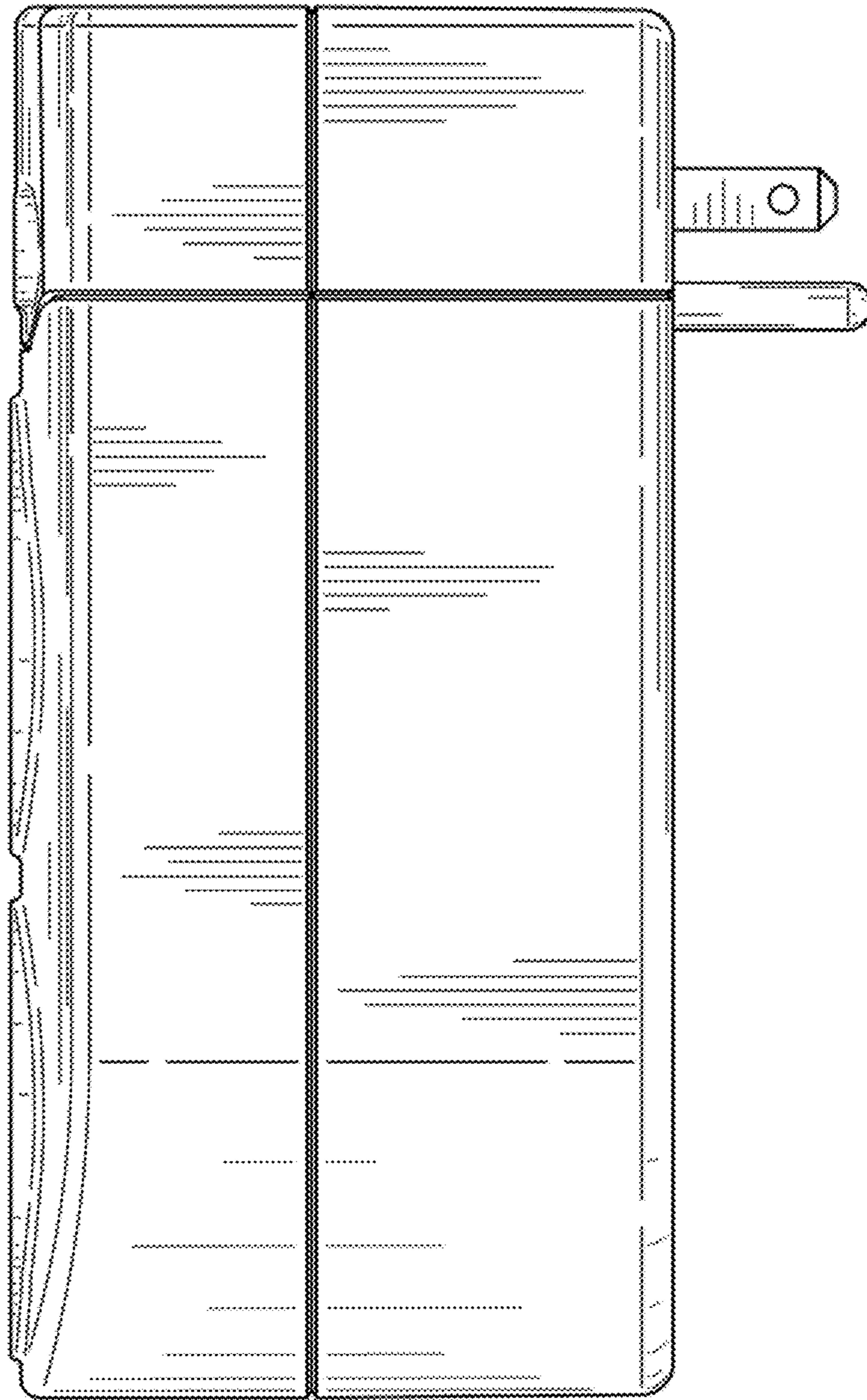

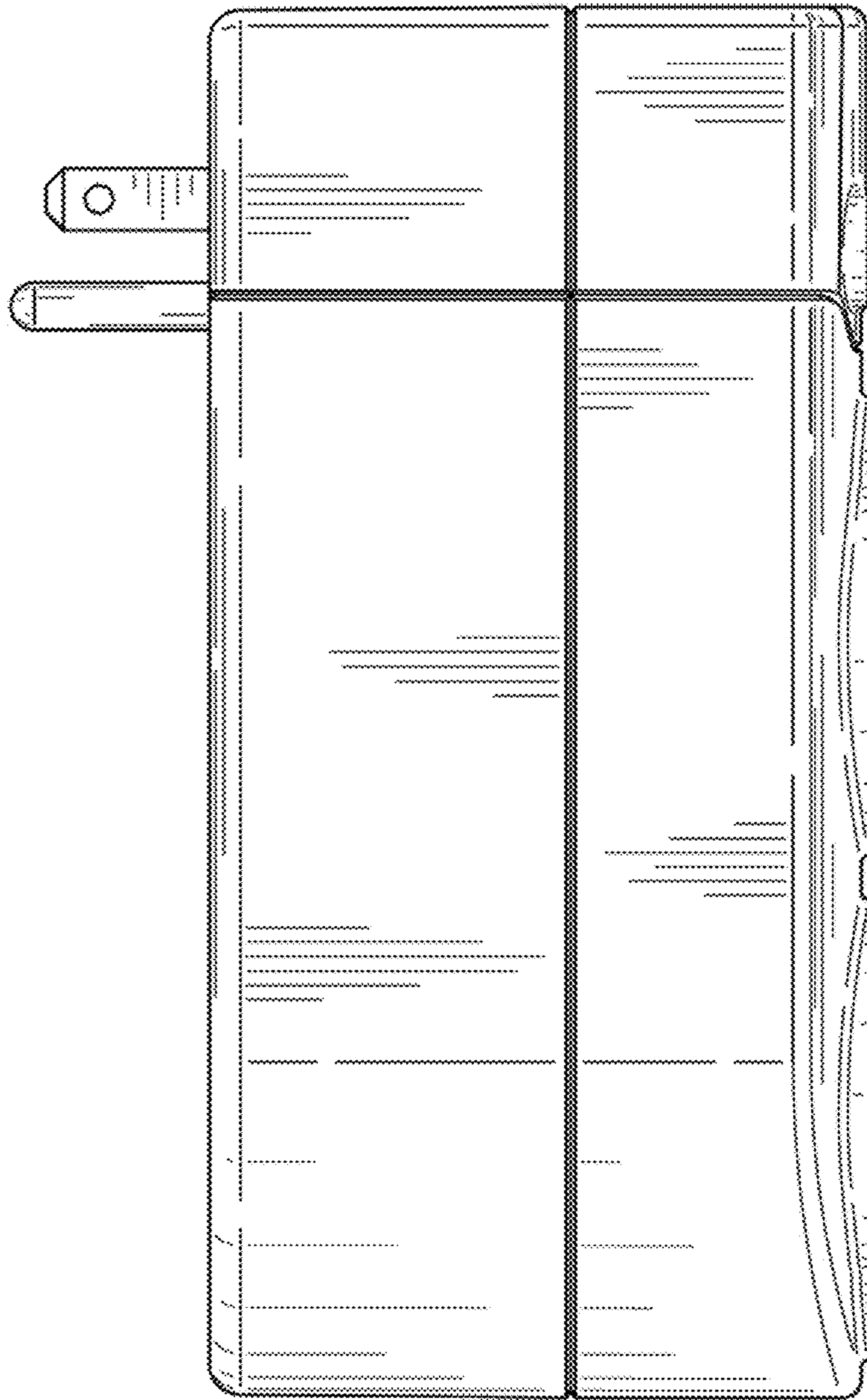

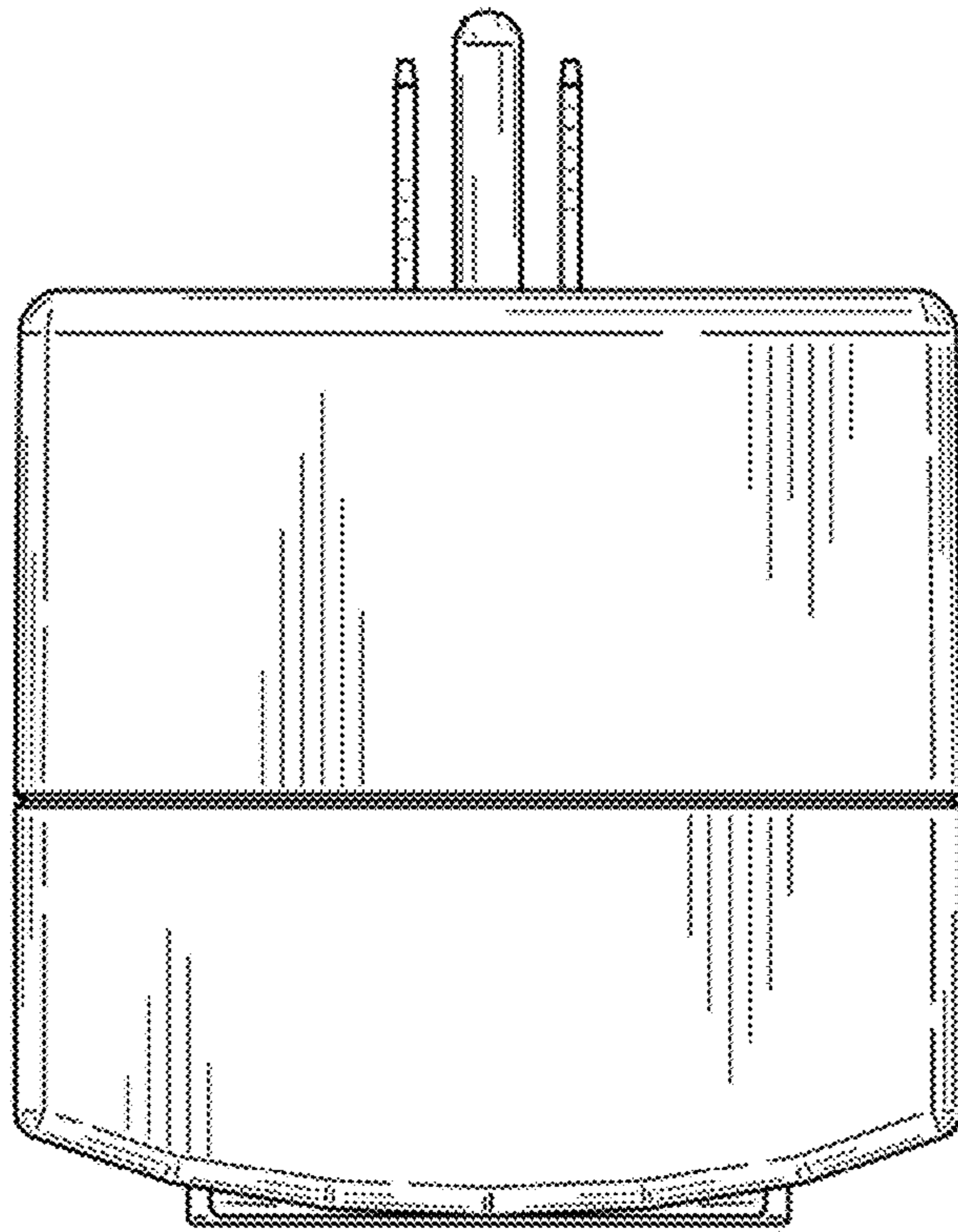

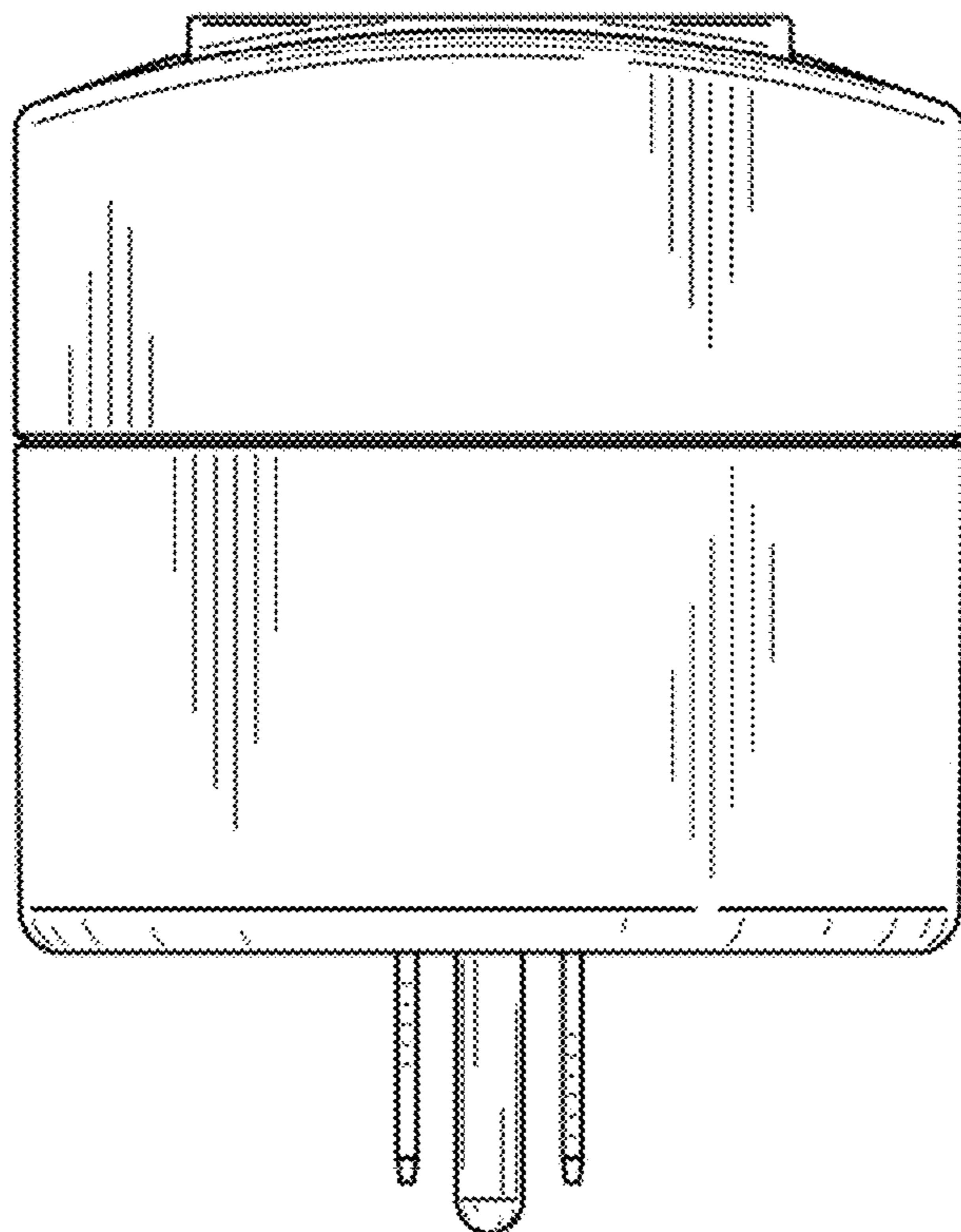

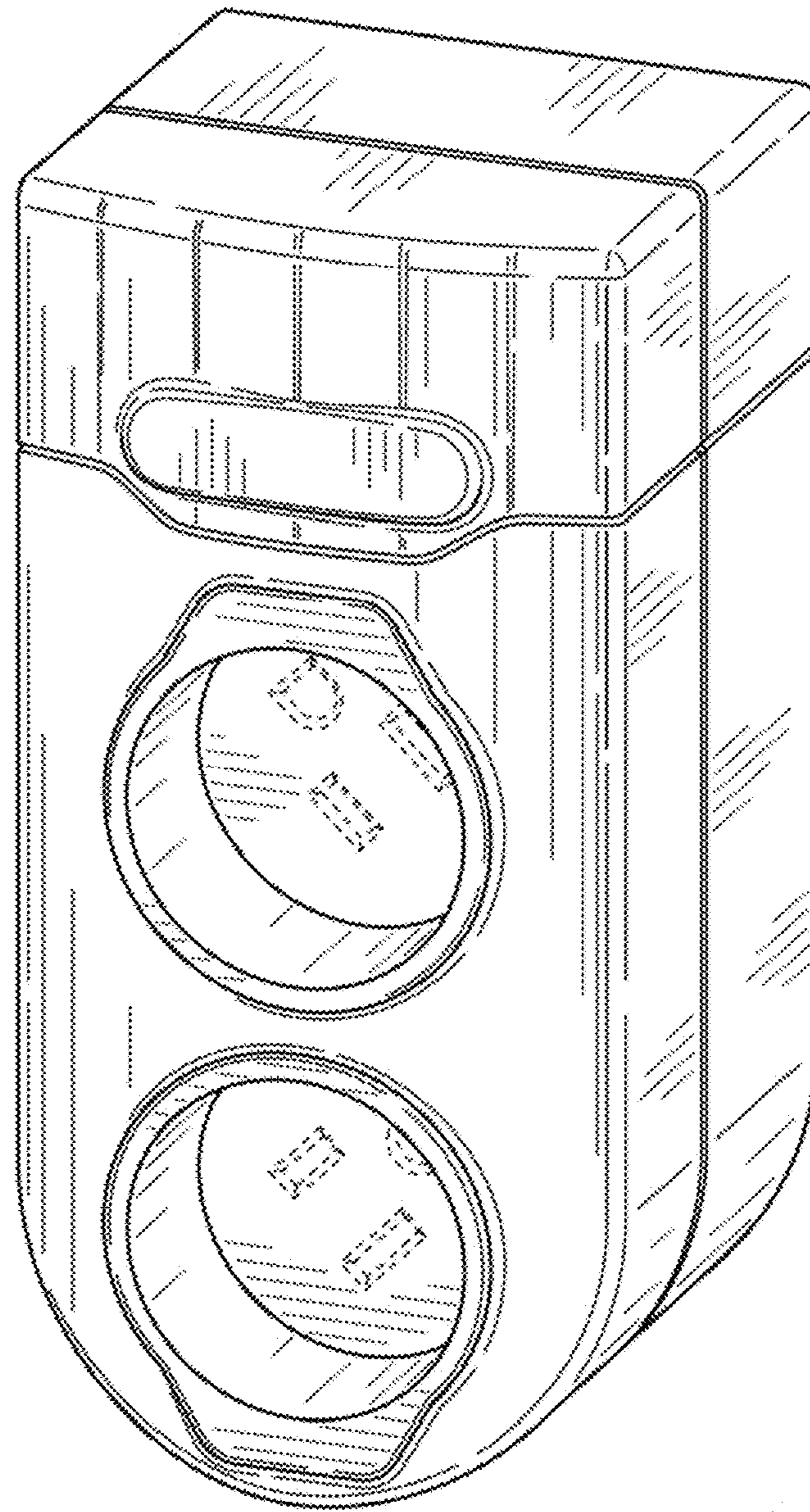

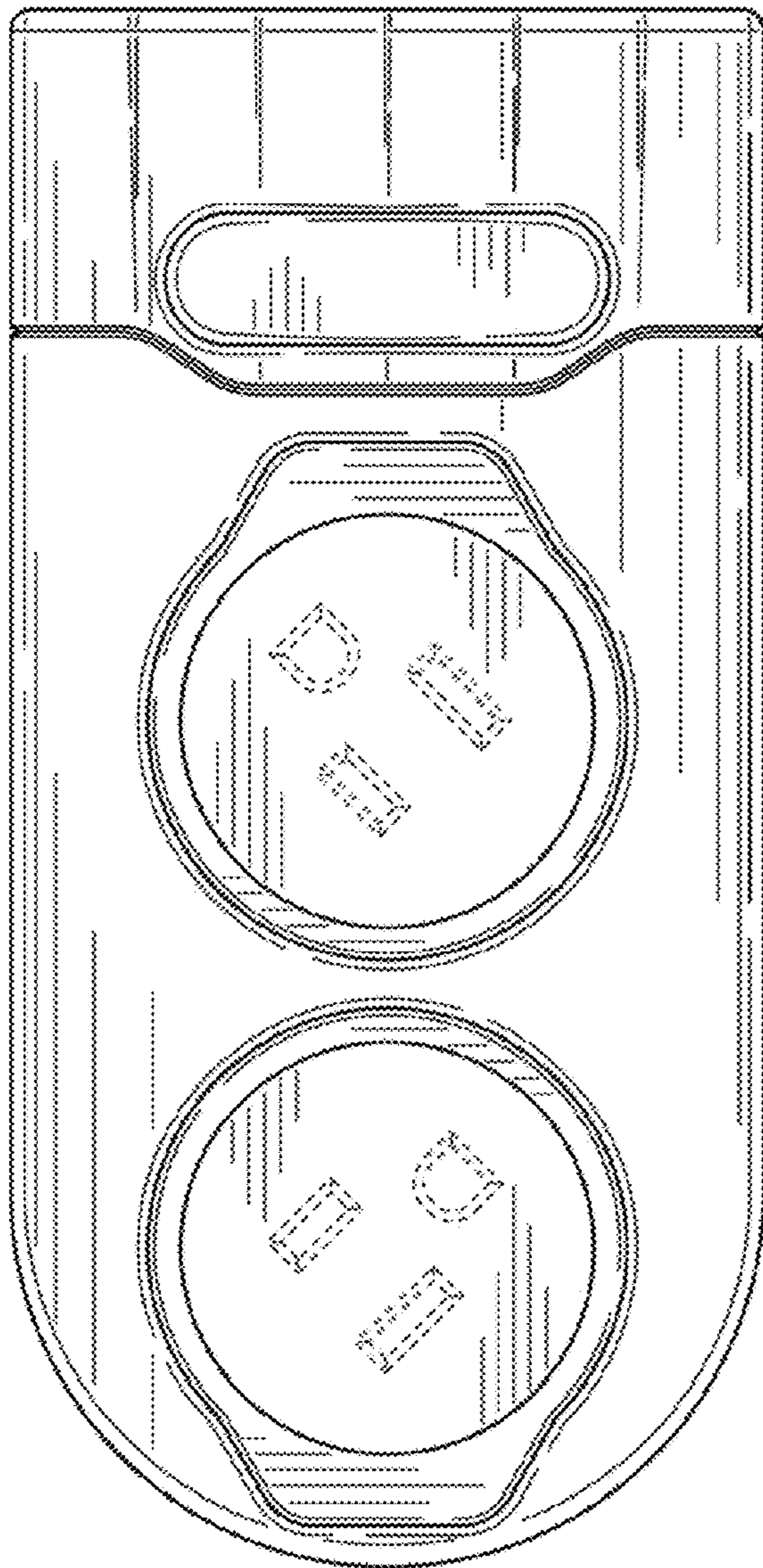

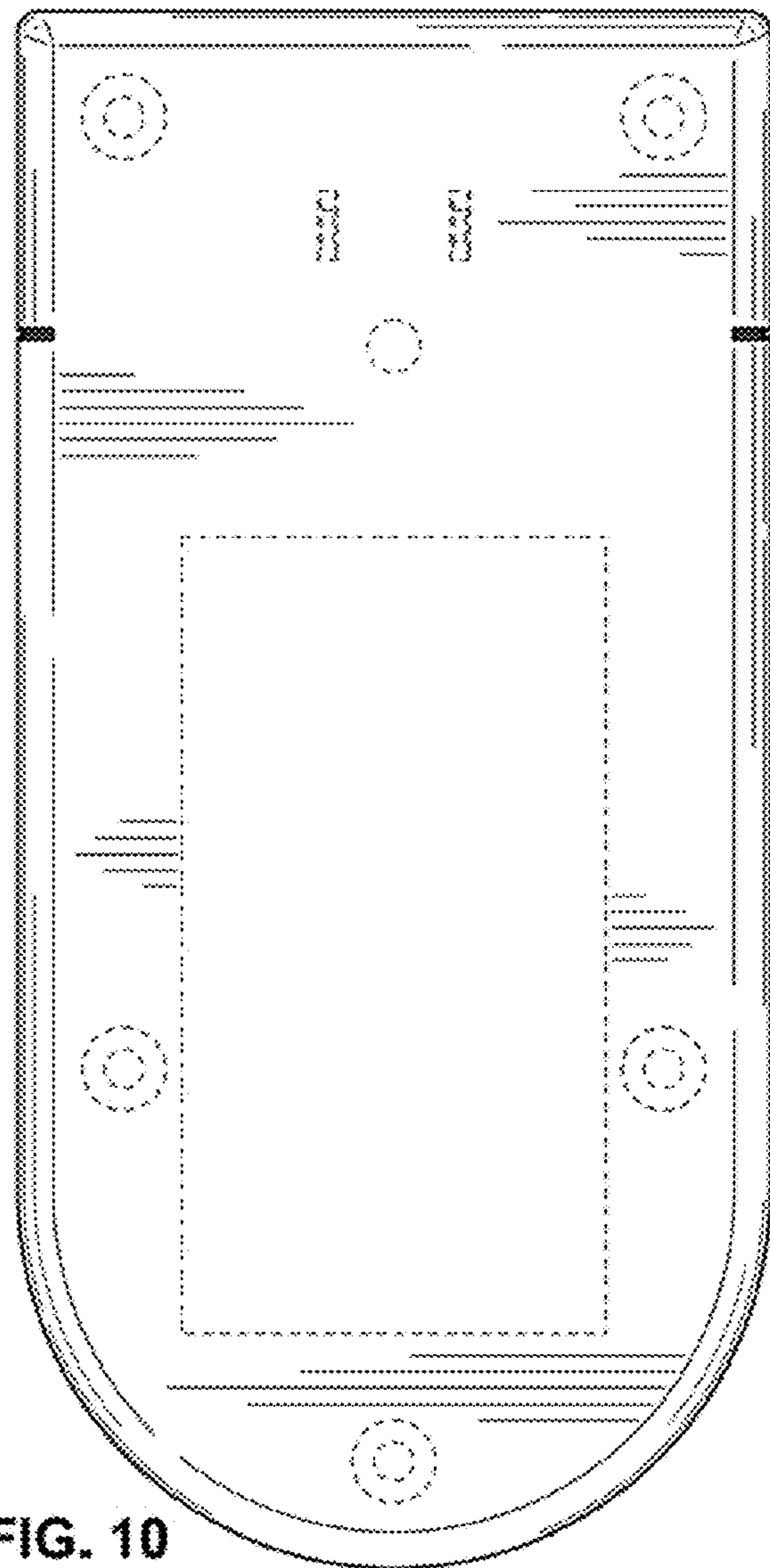

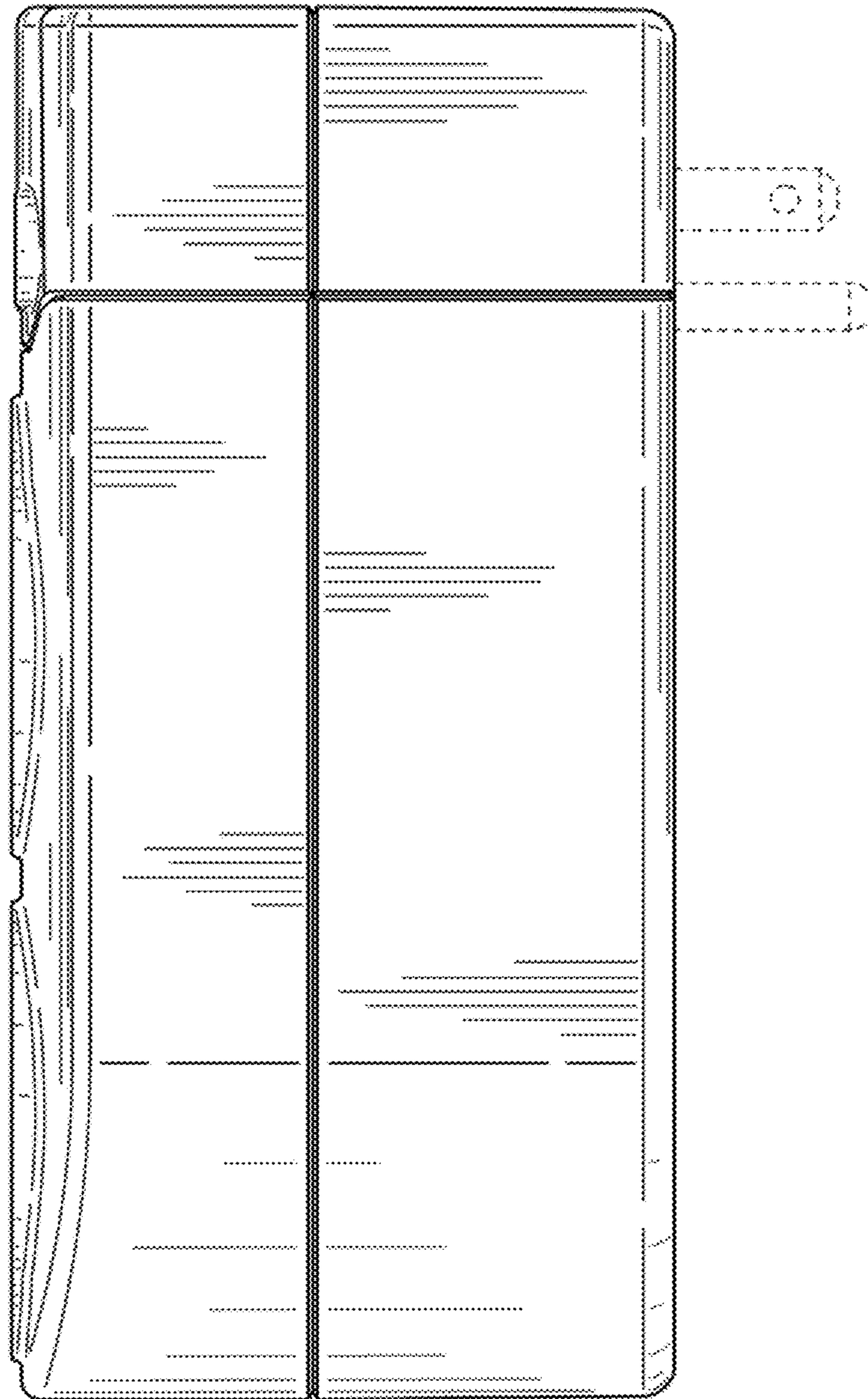

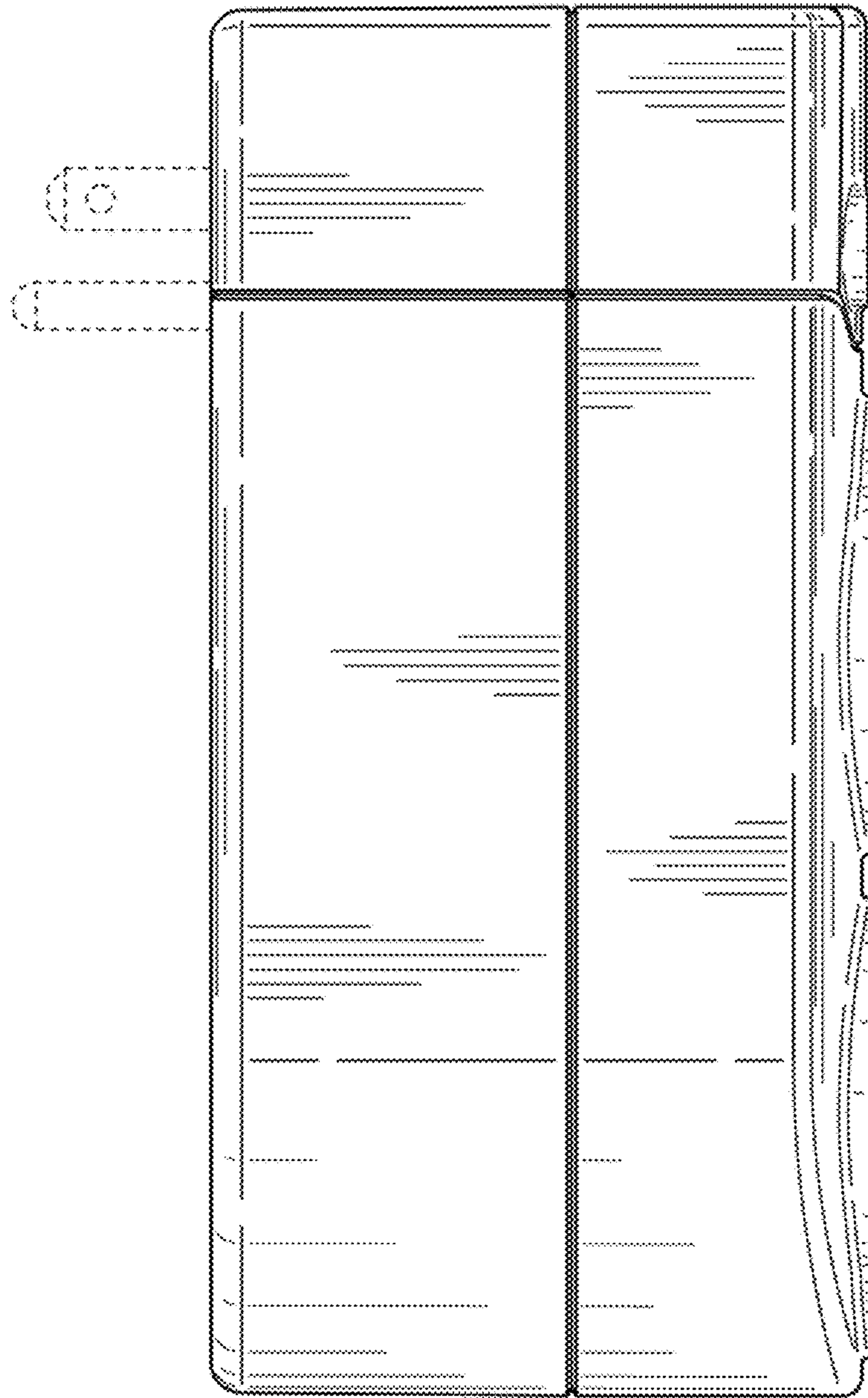

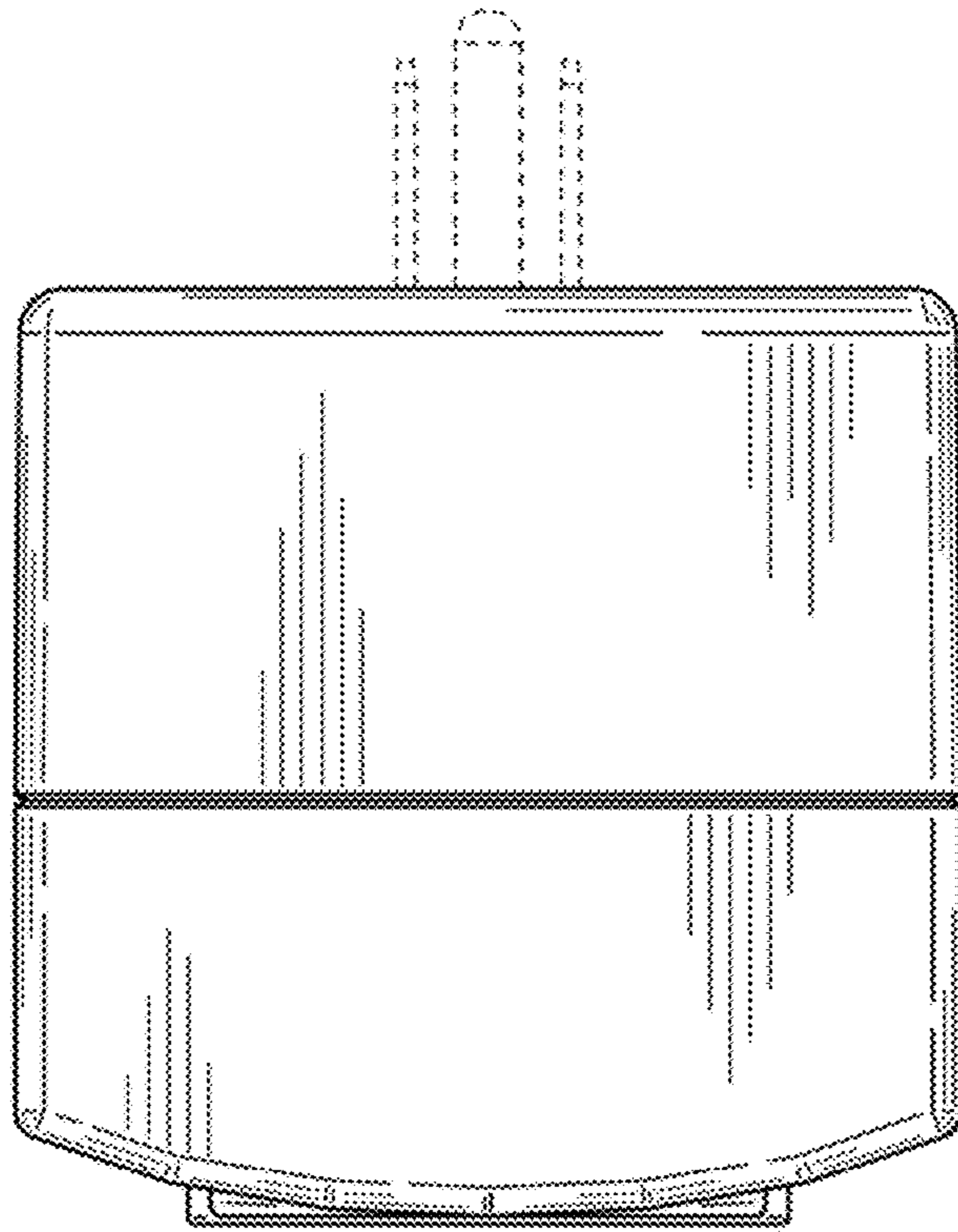

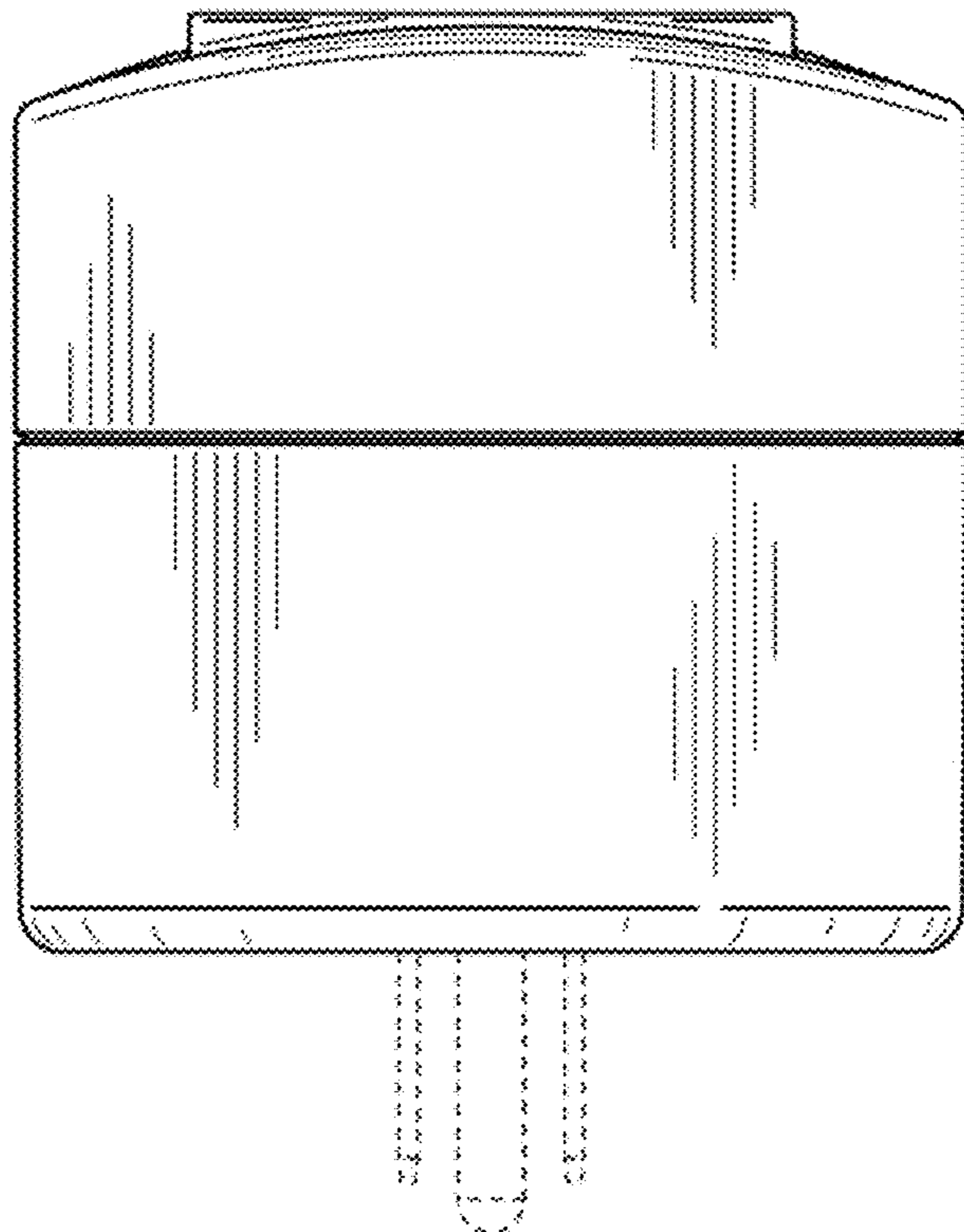

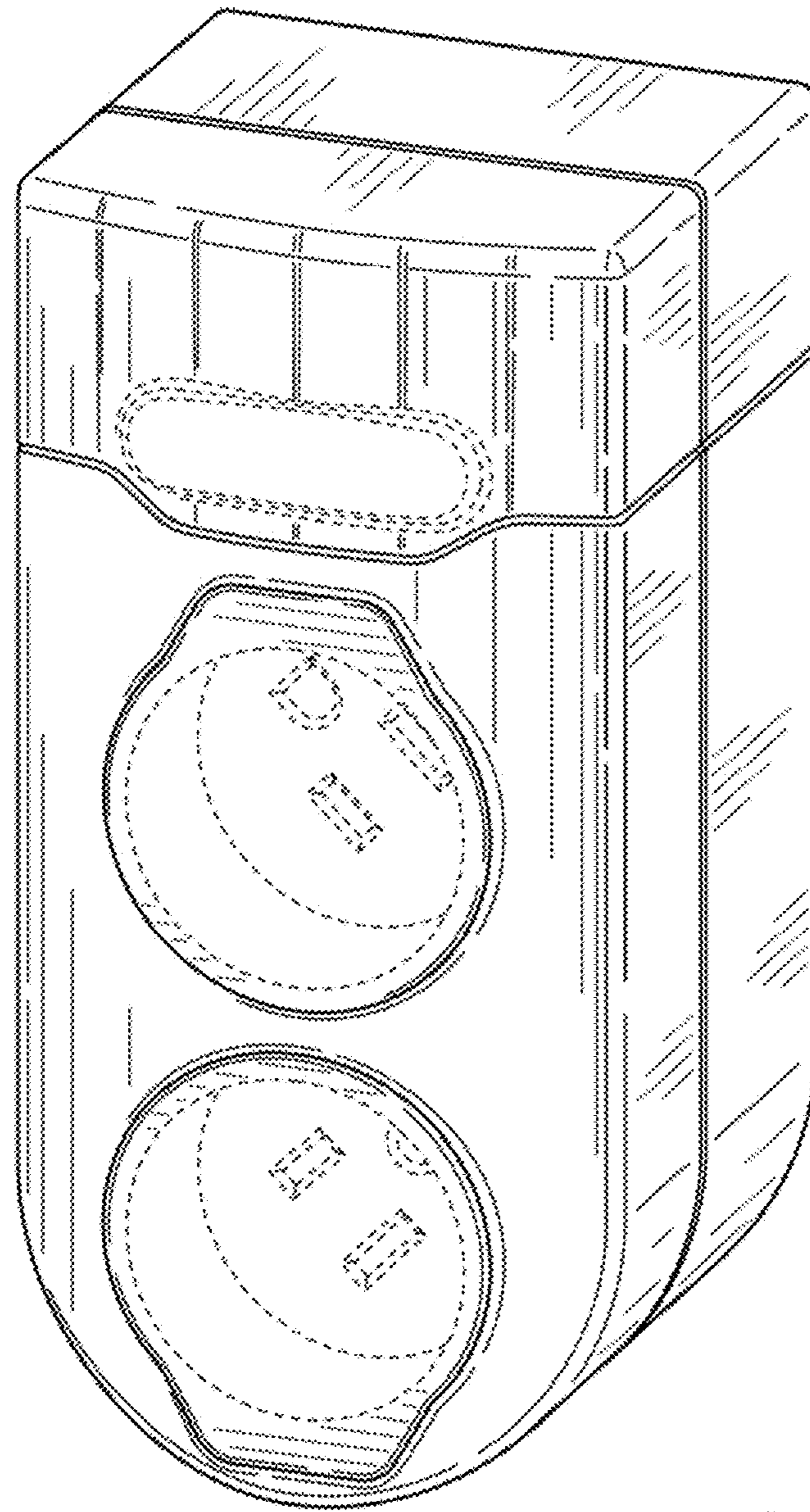

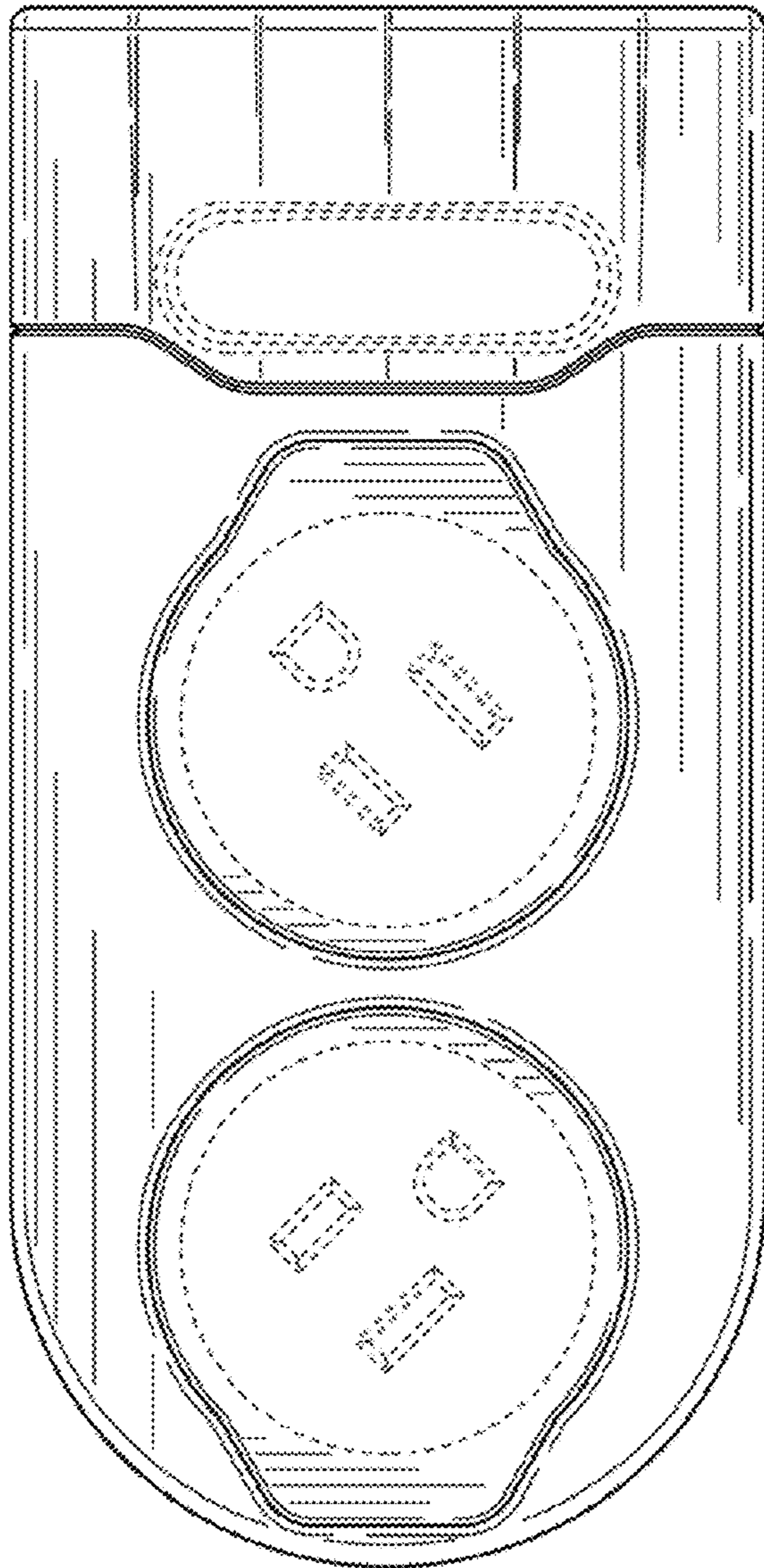

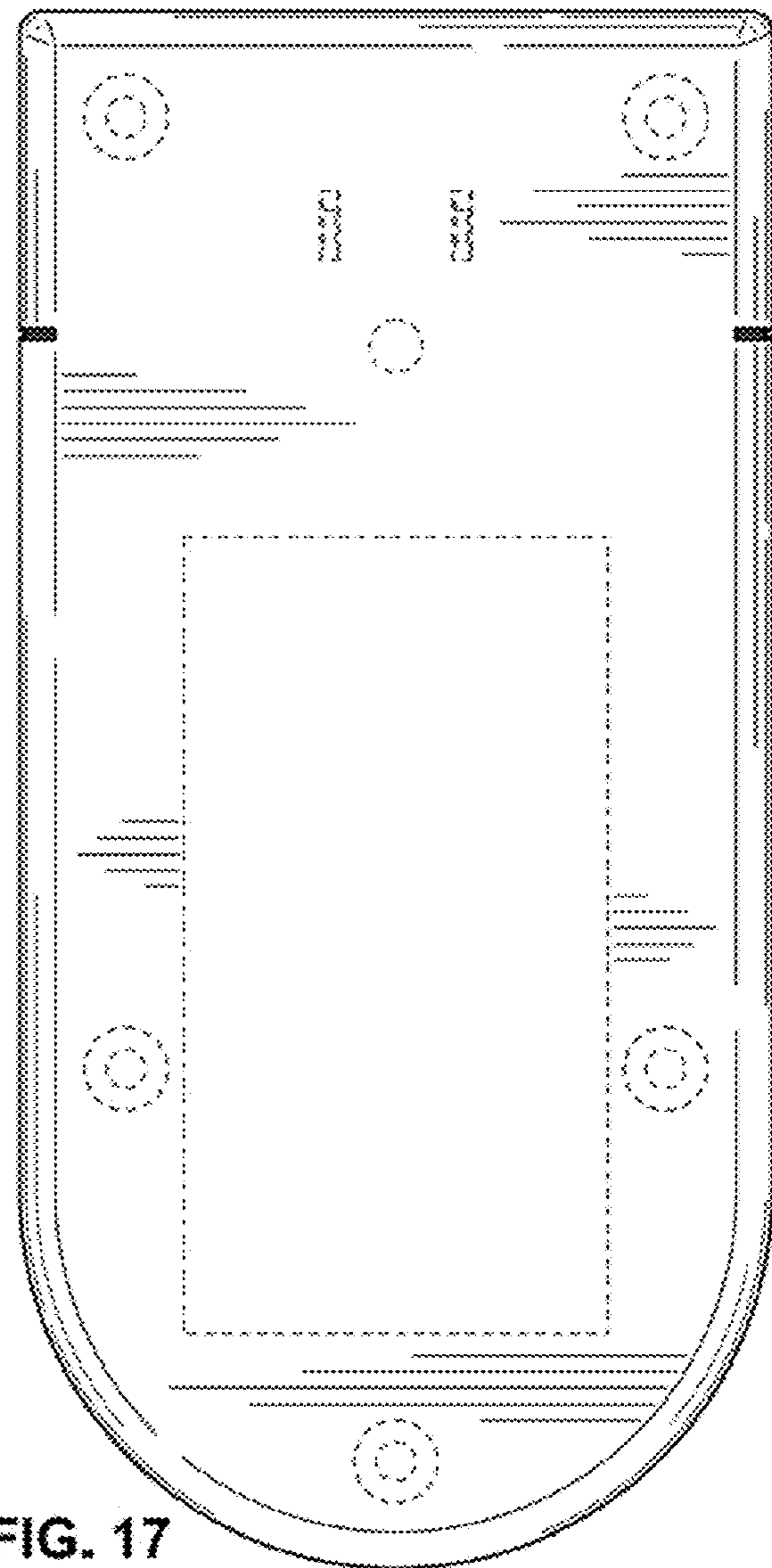

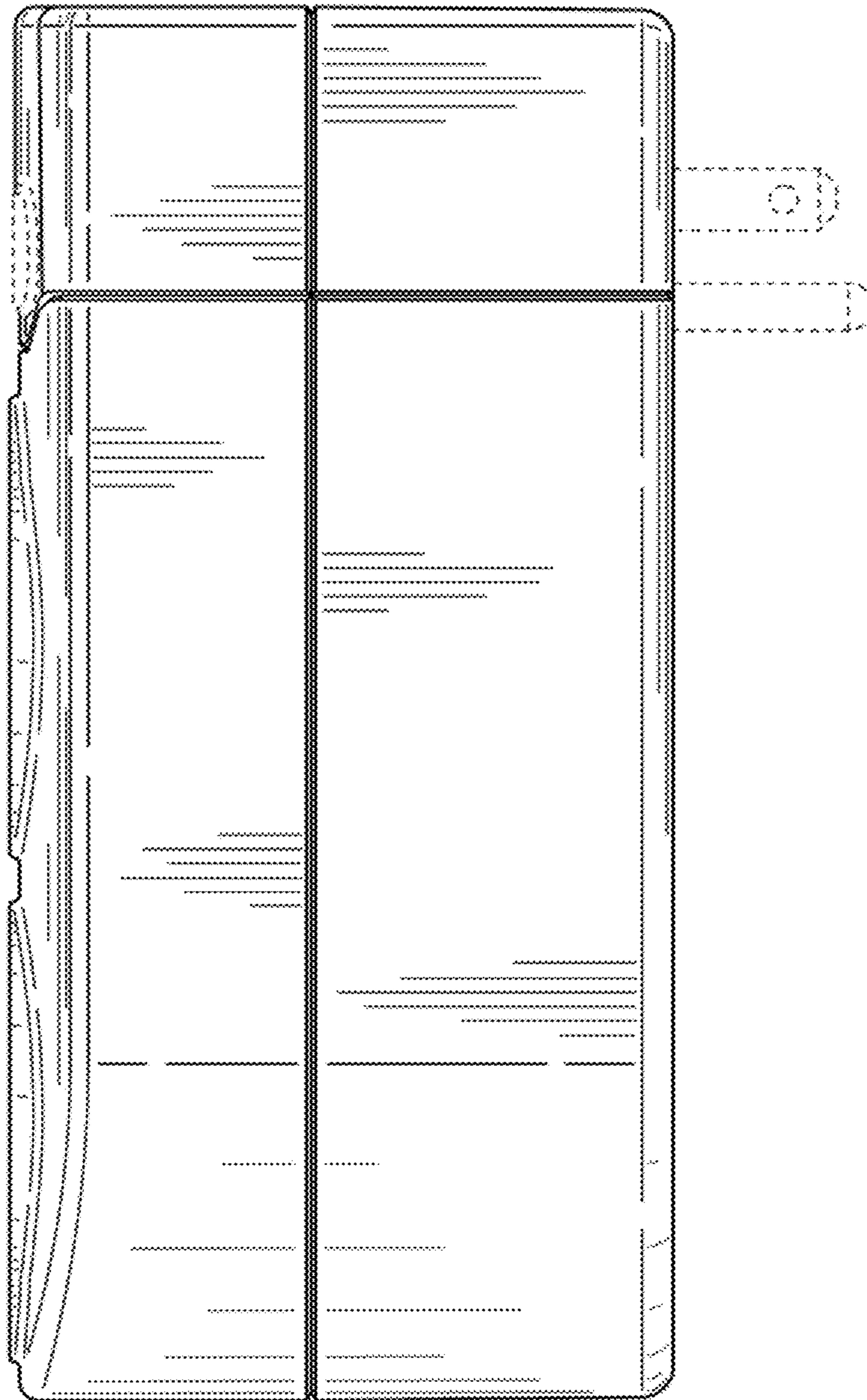

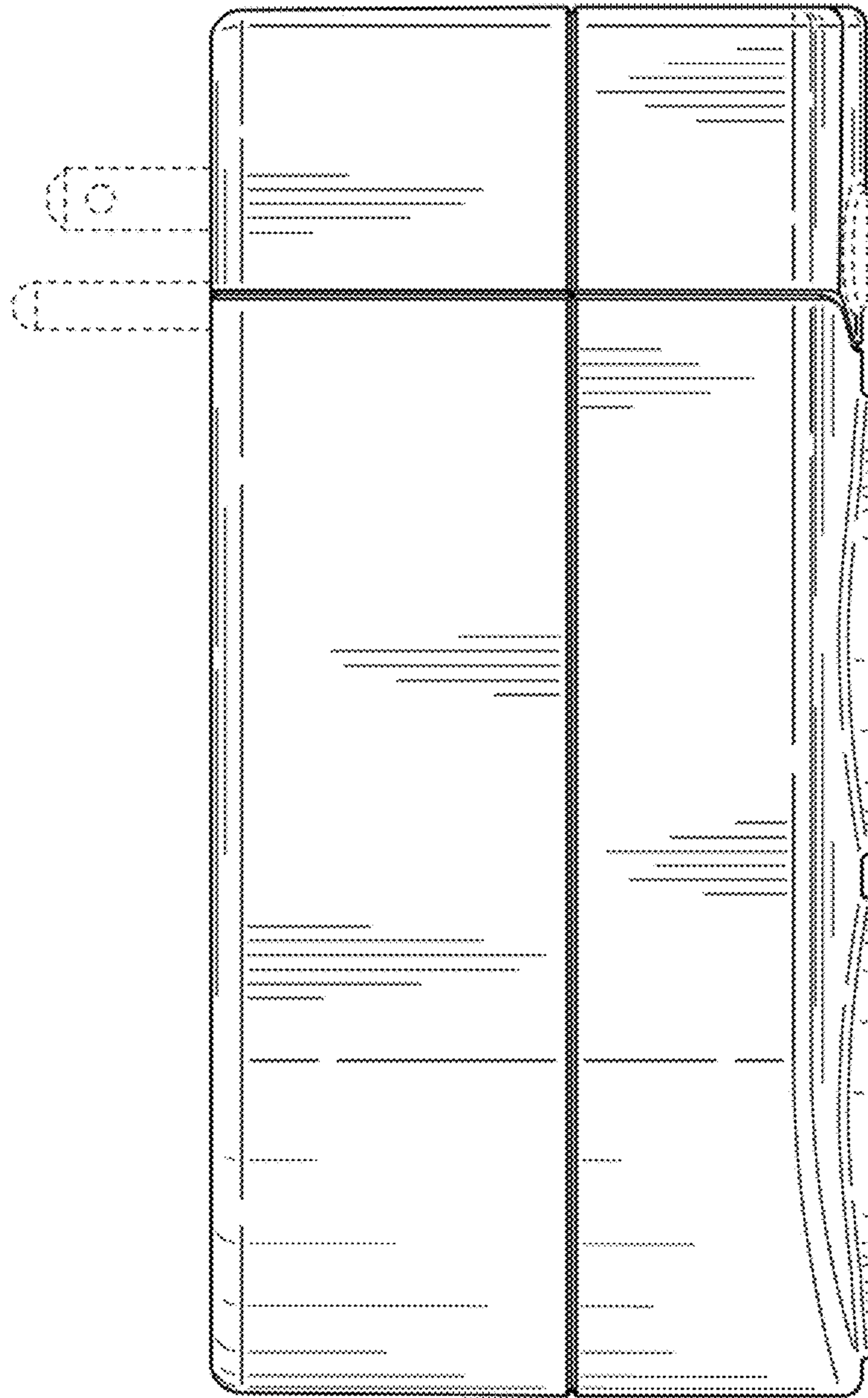

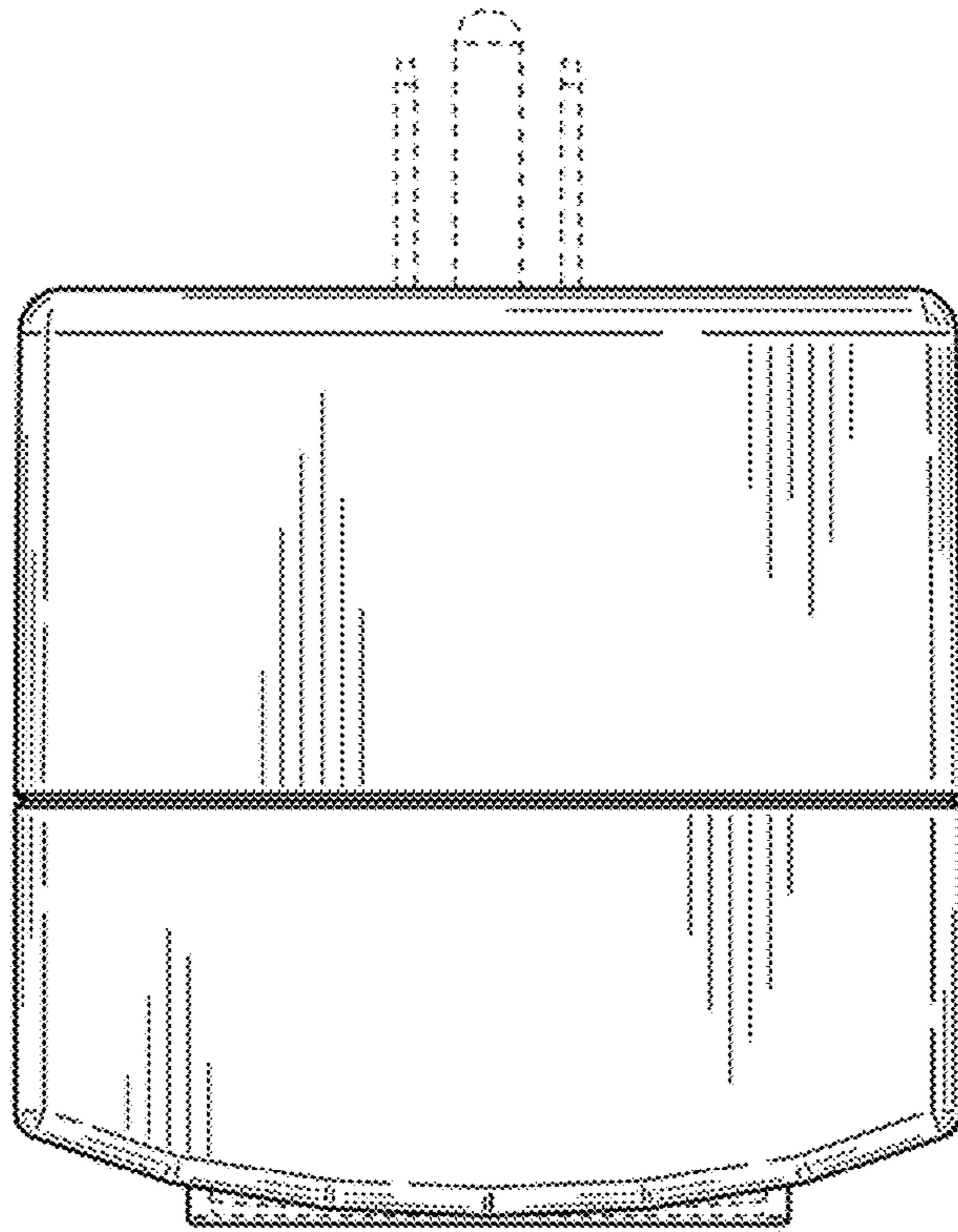

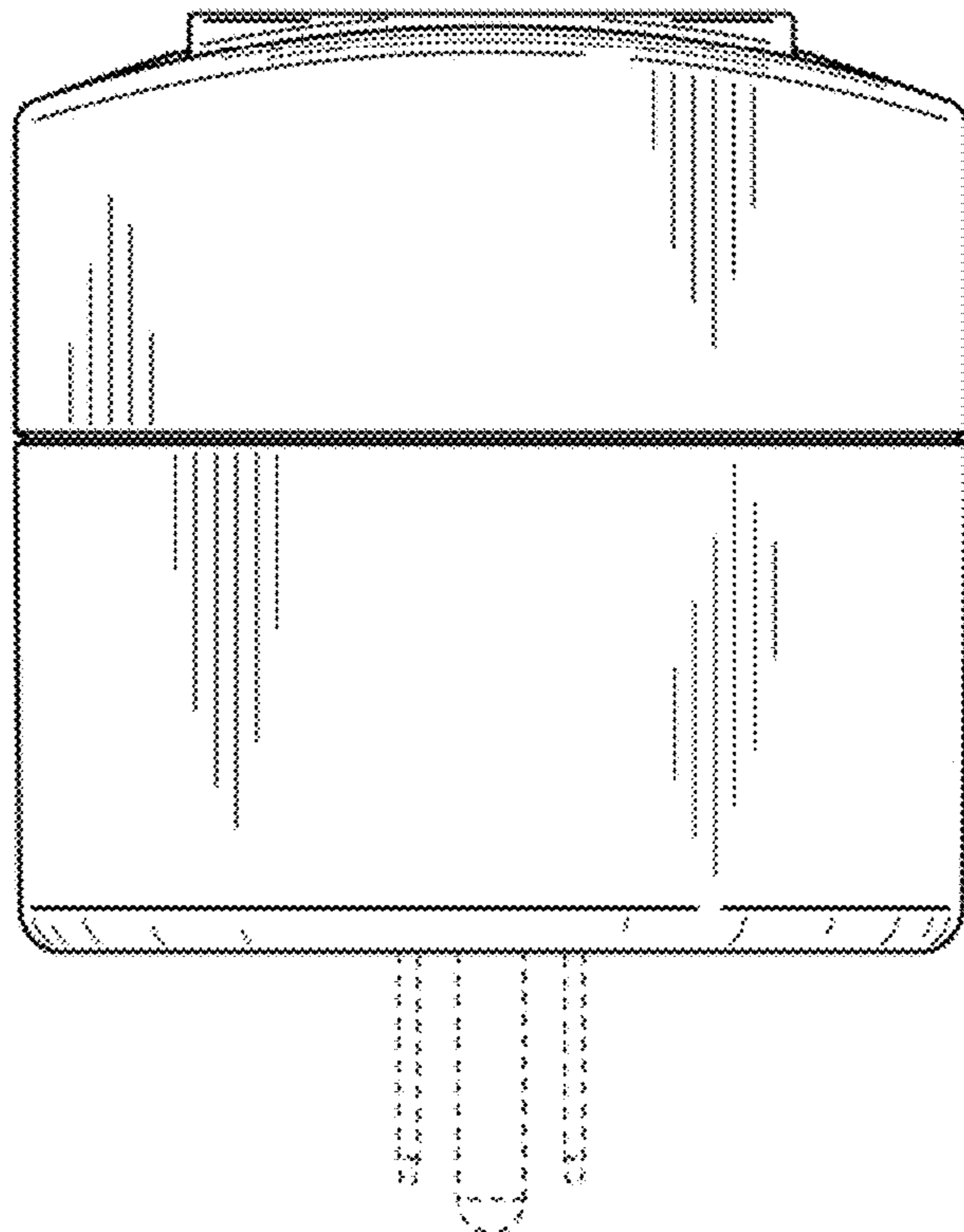

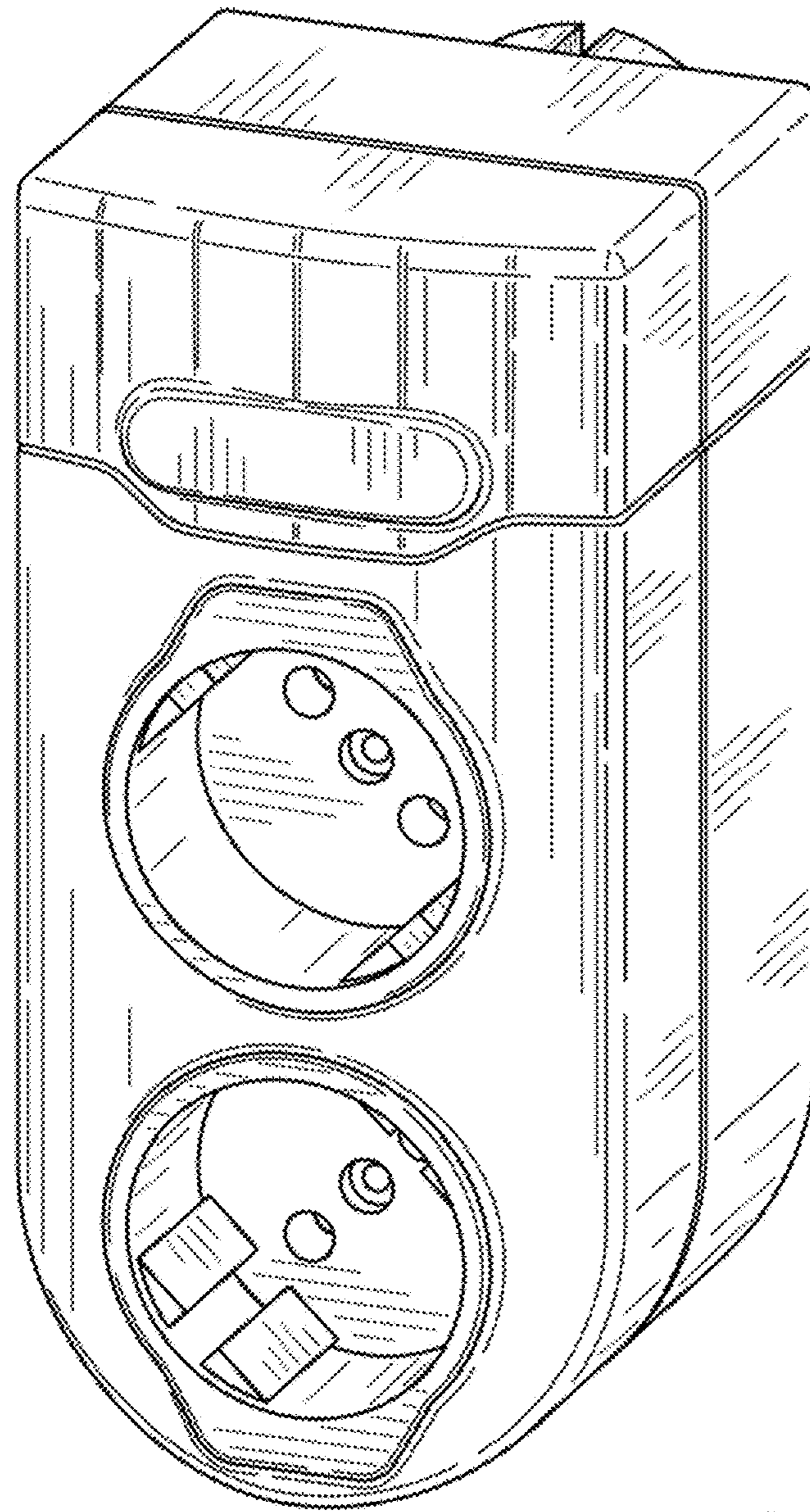

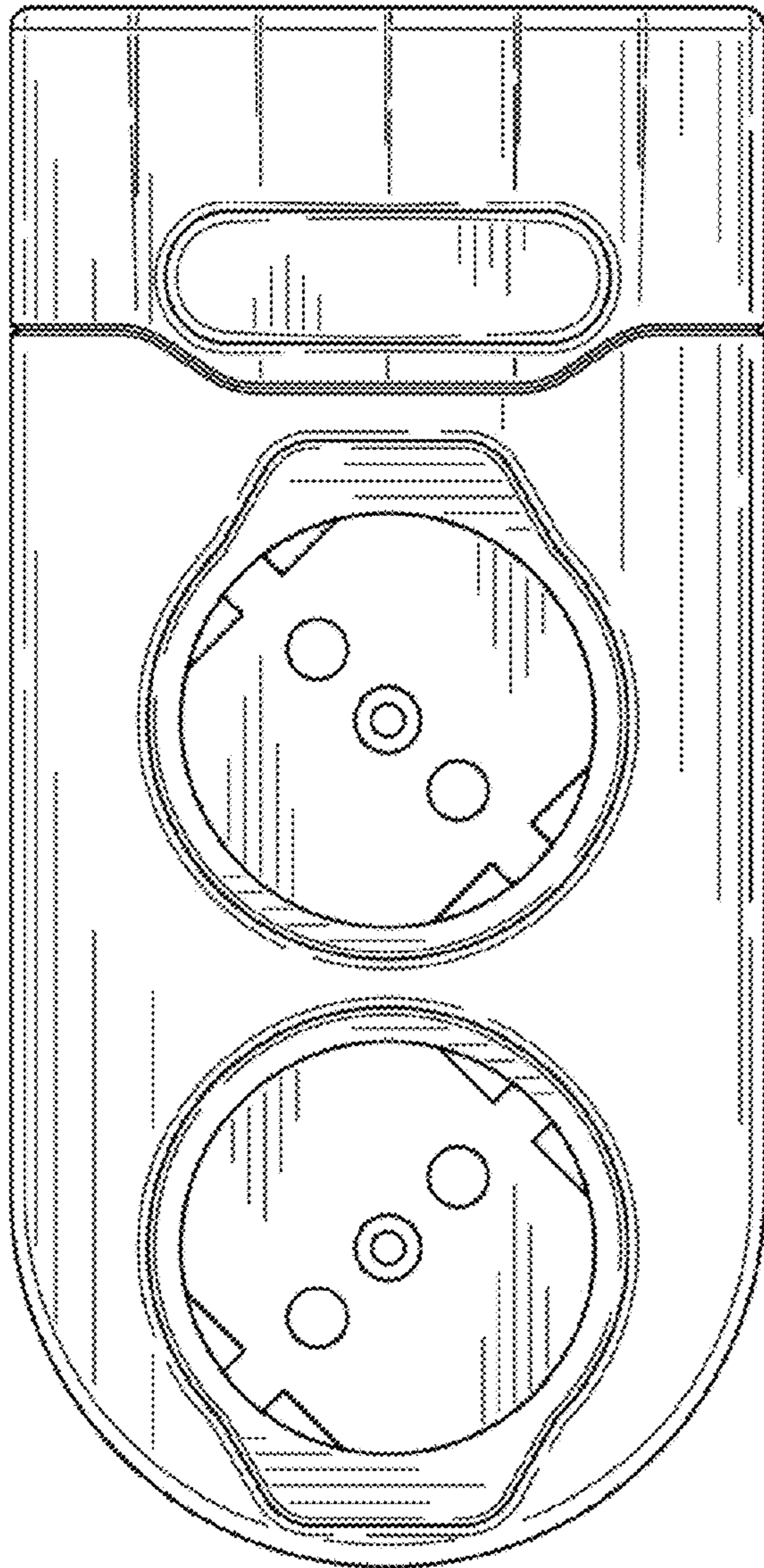

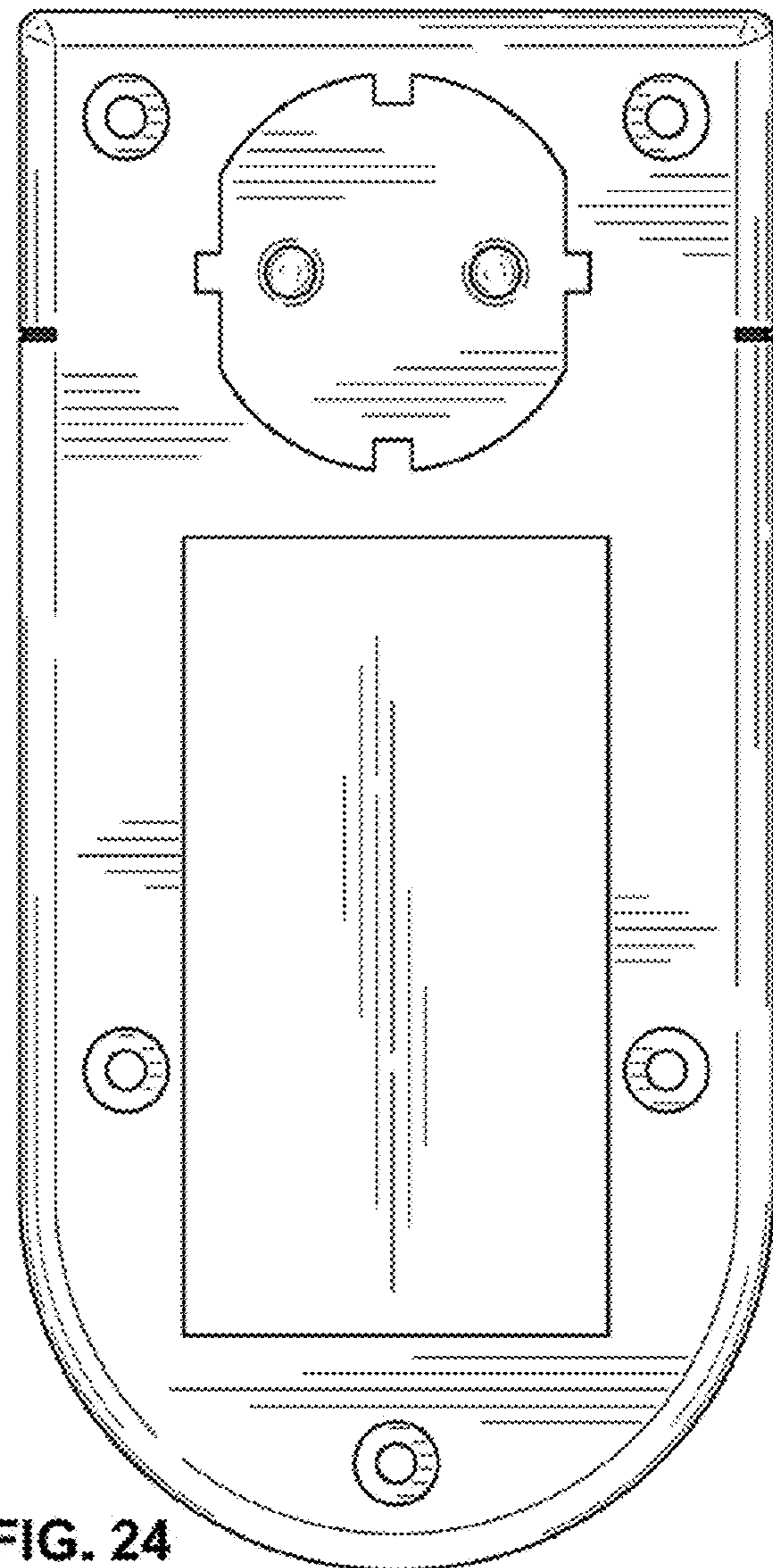

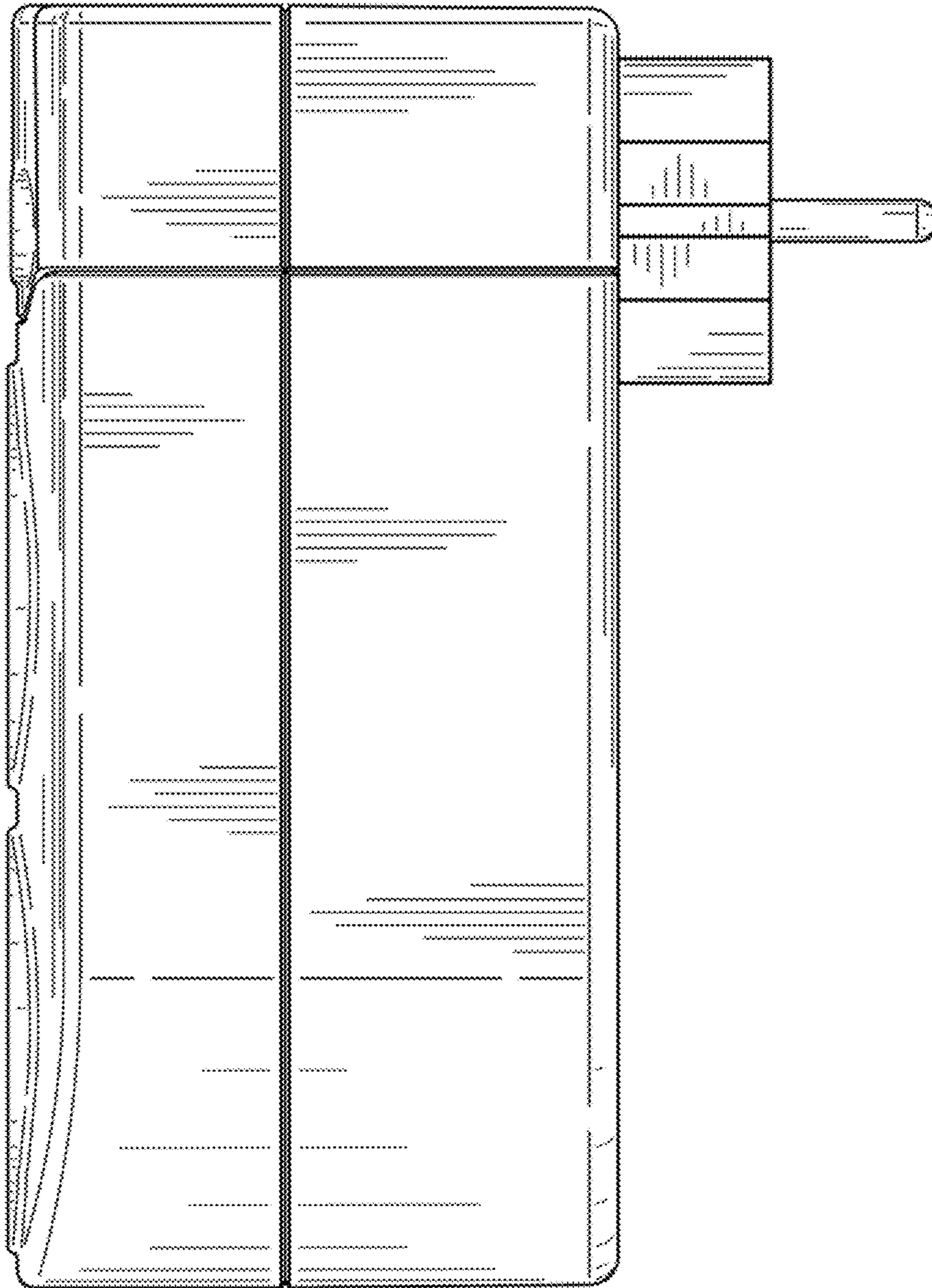

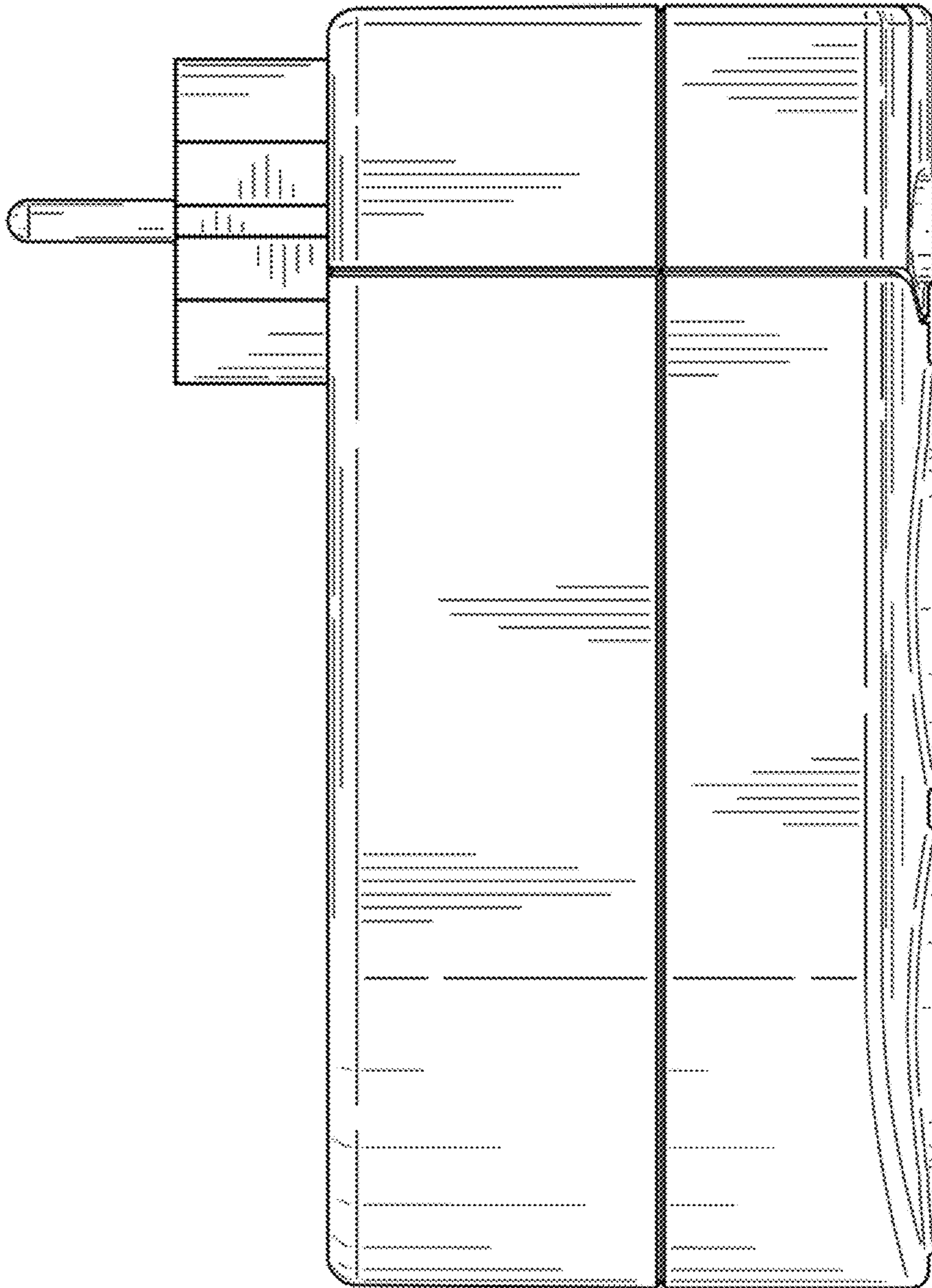

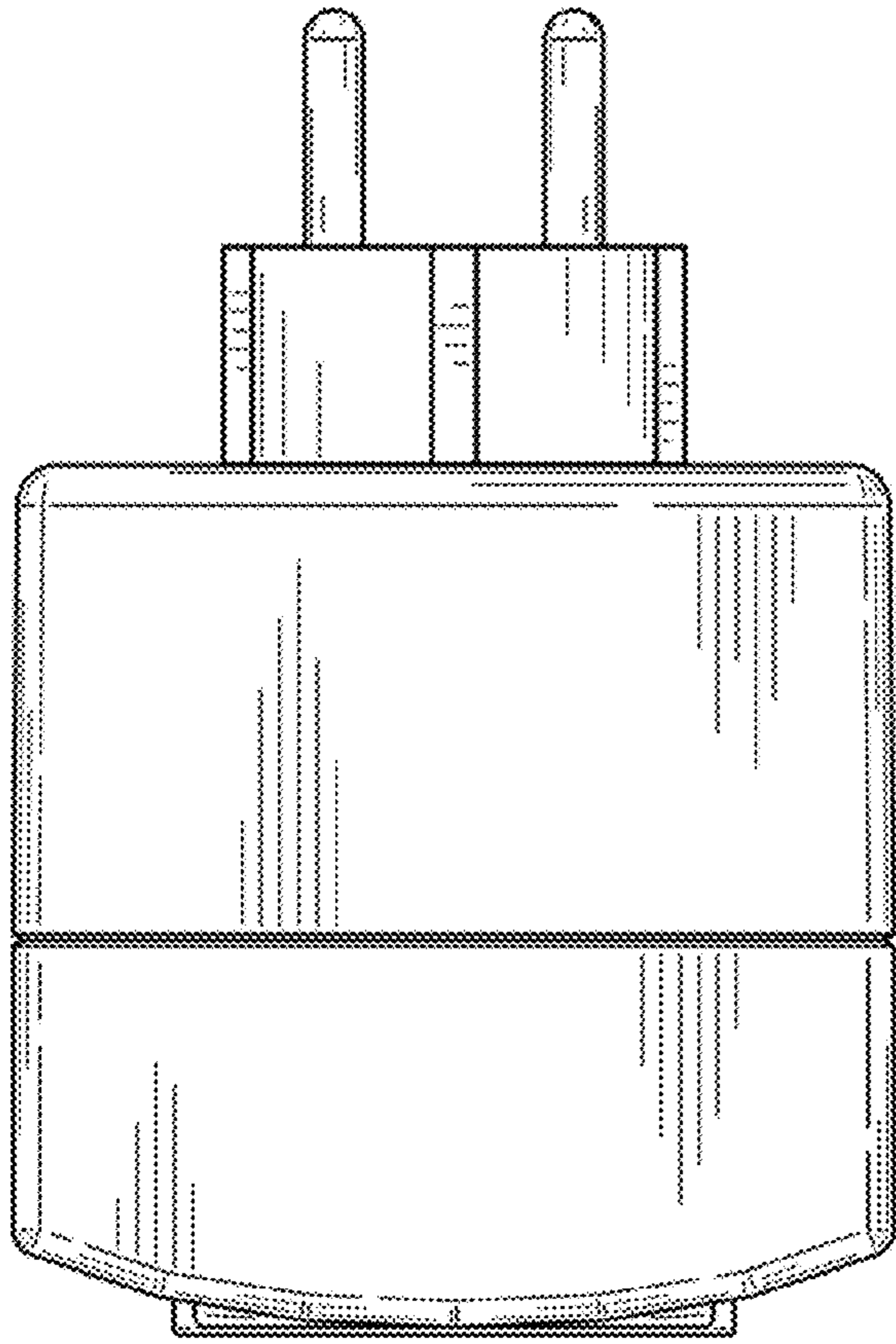

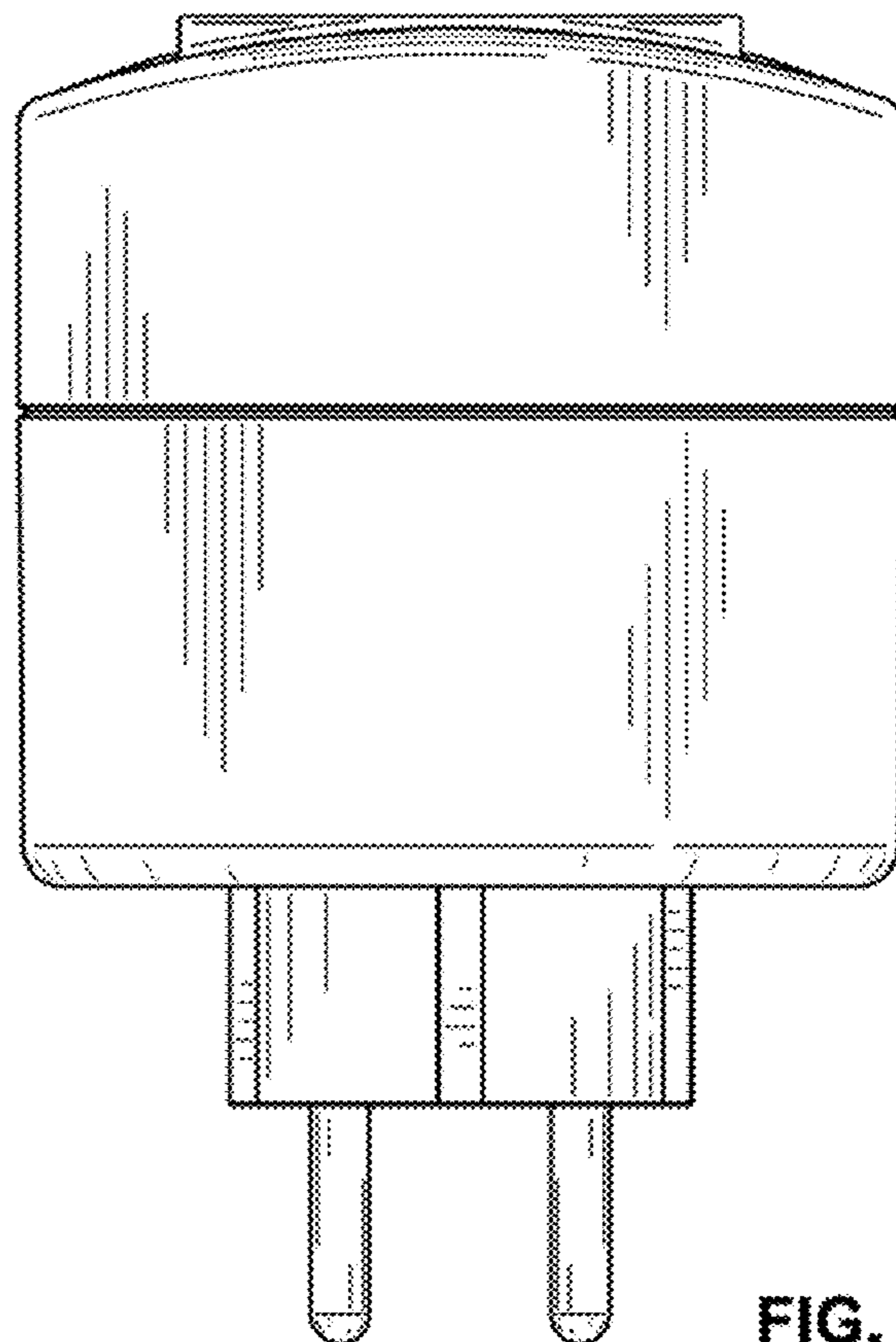
