DESCRIPTION

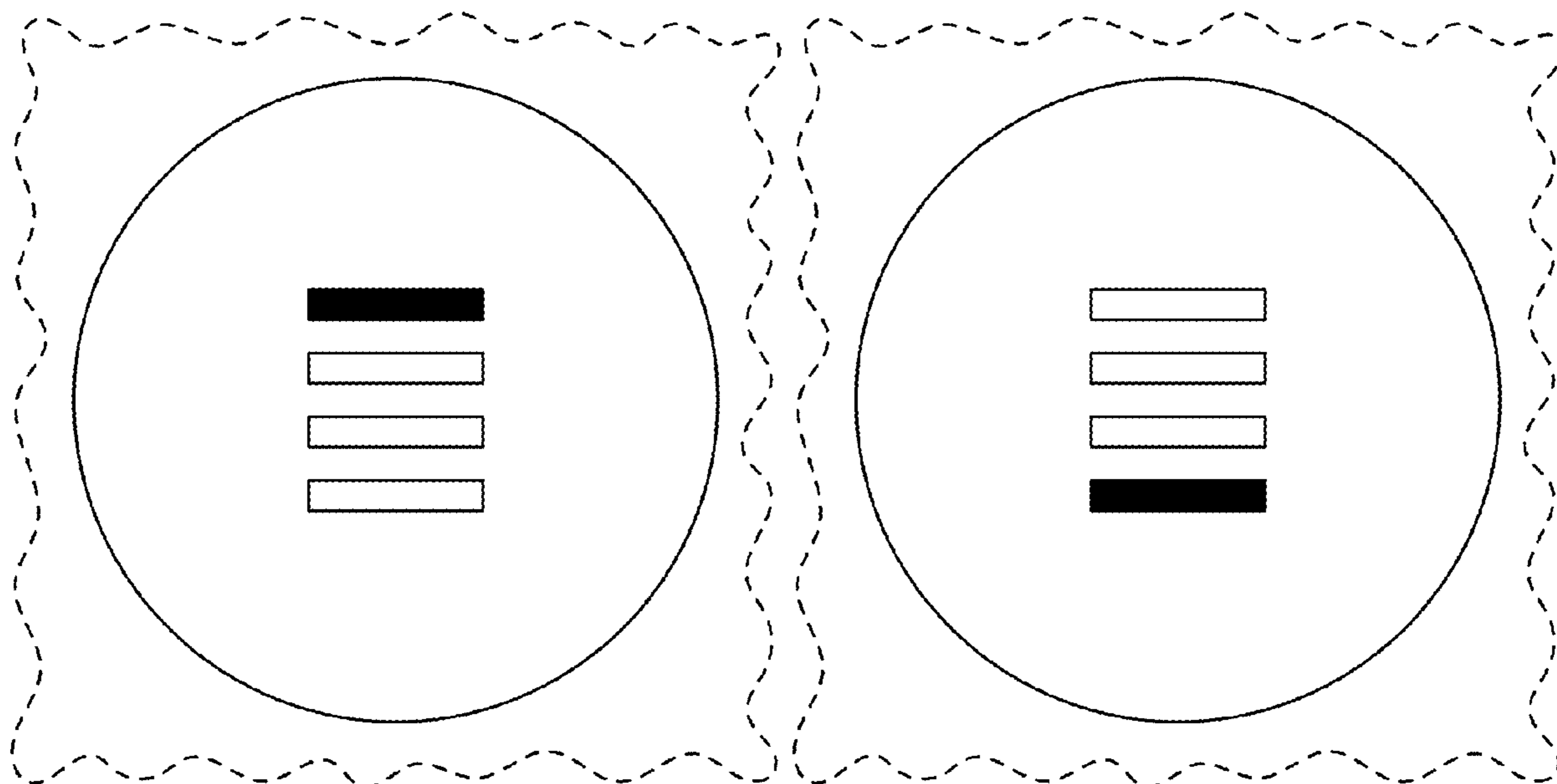
FIG. 1 is the first image in a sequence for a display screen with animated graphical user interface showing my new design;

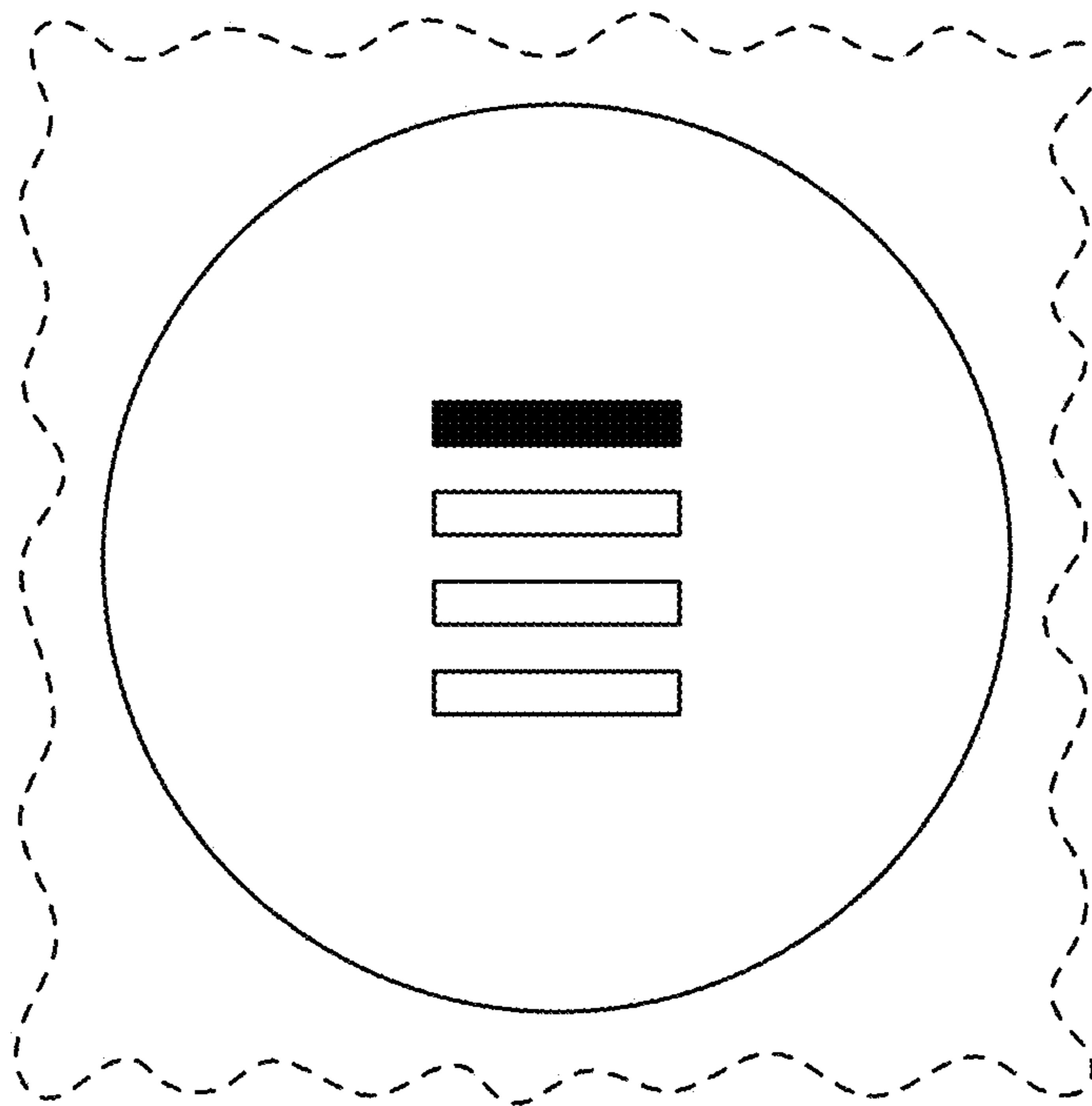

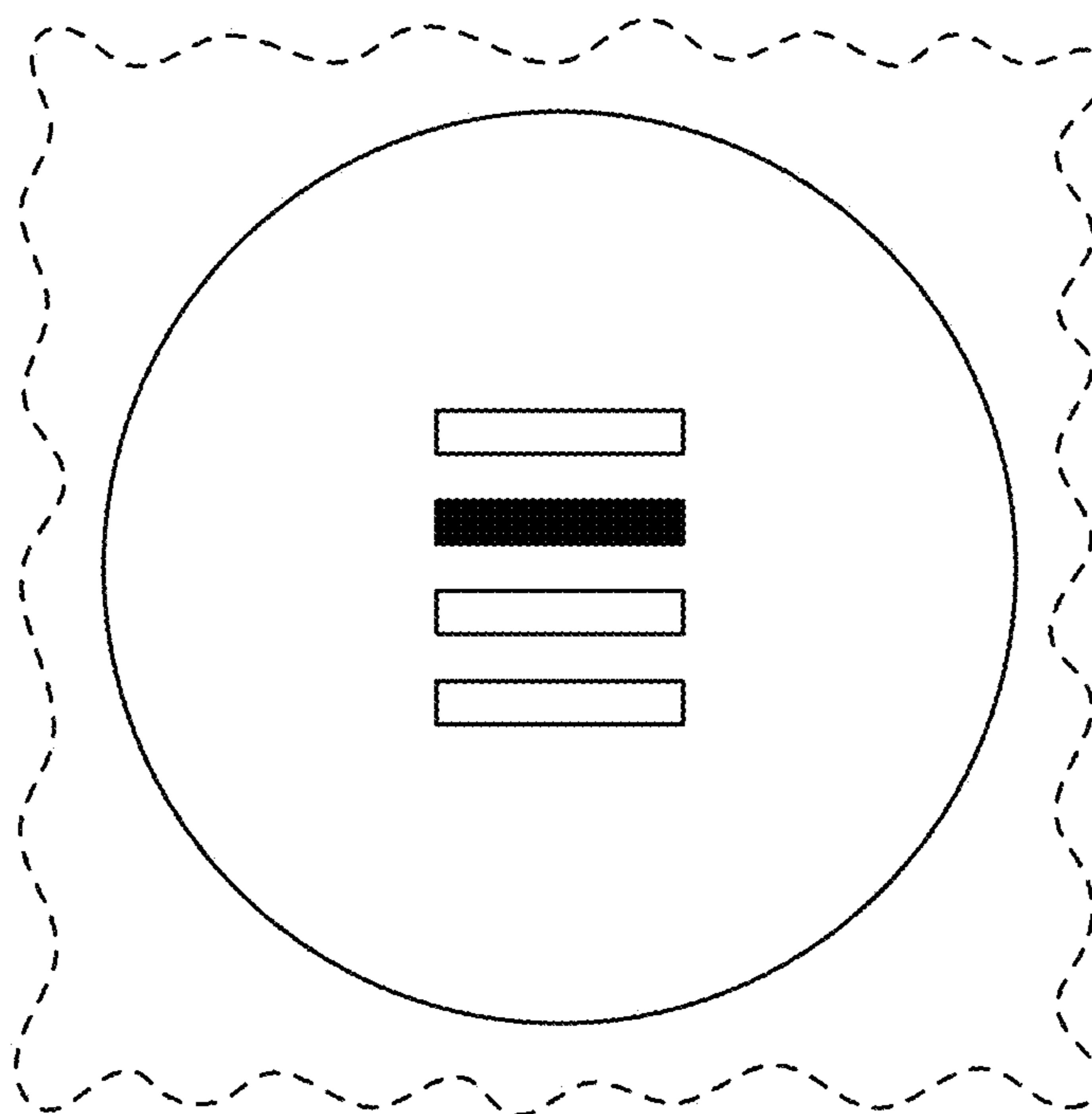

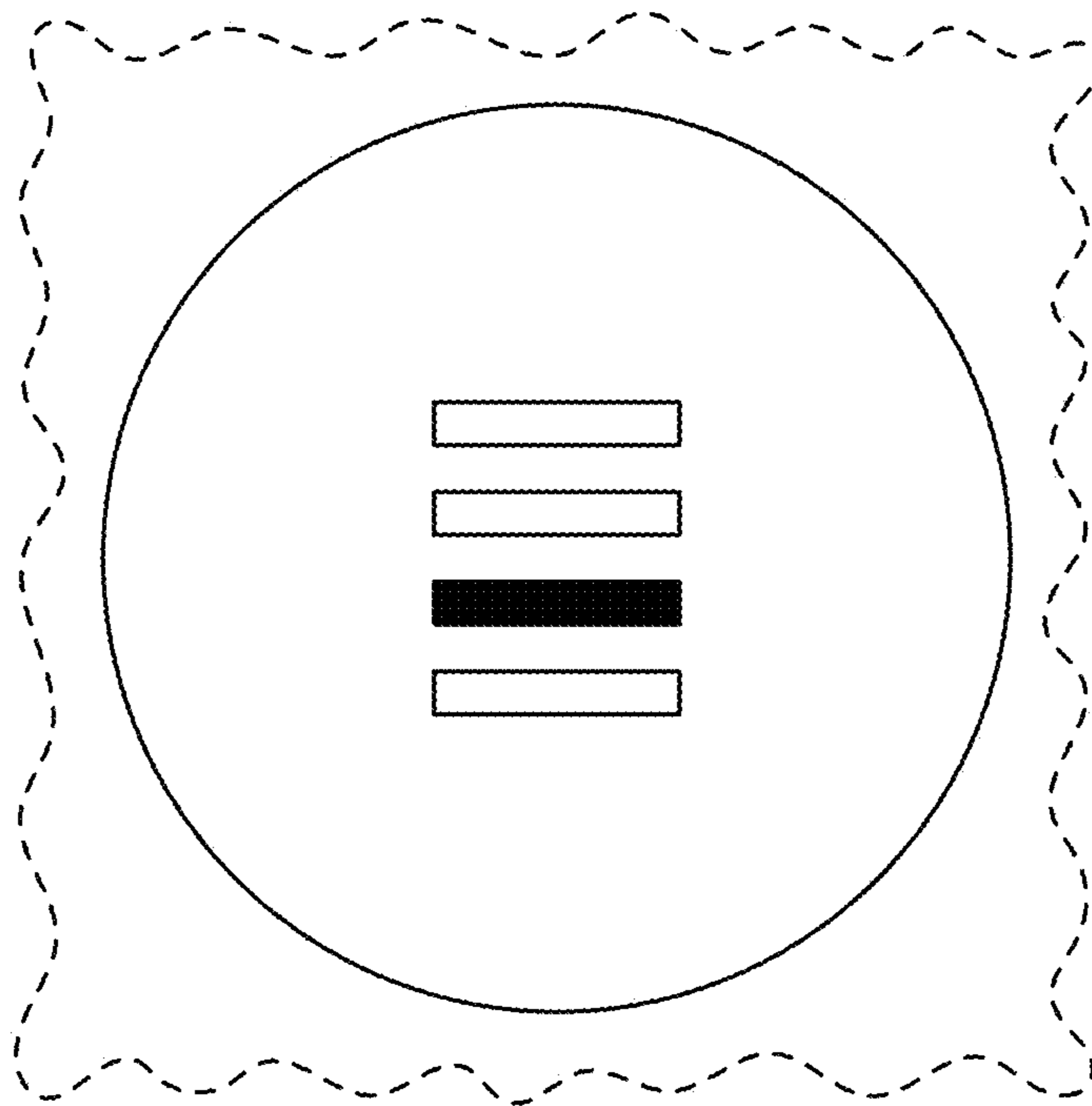

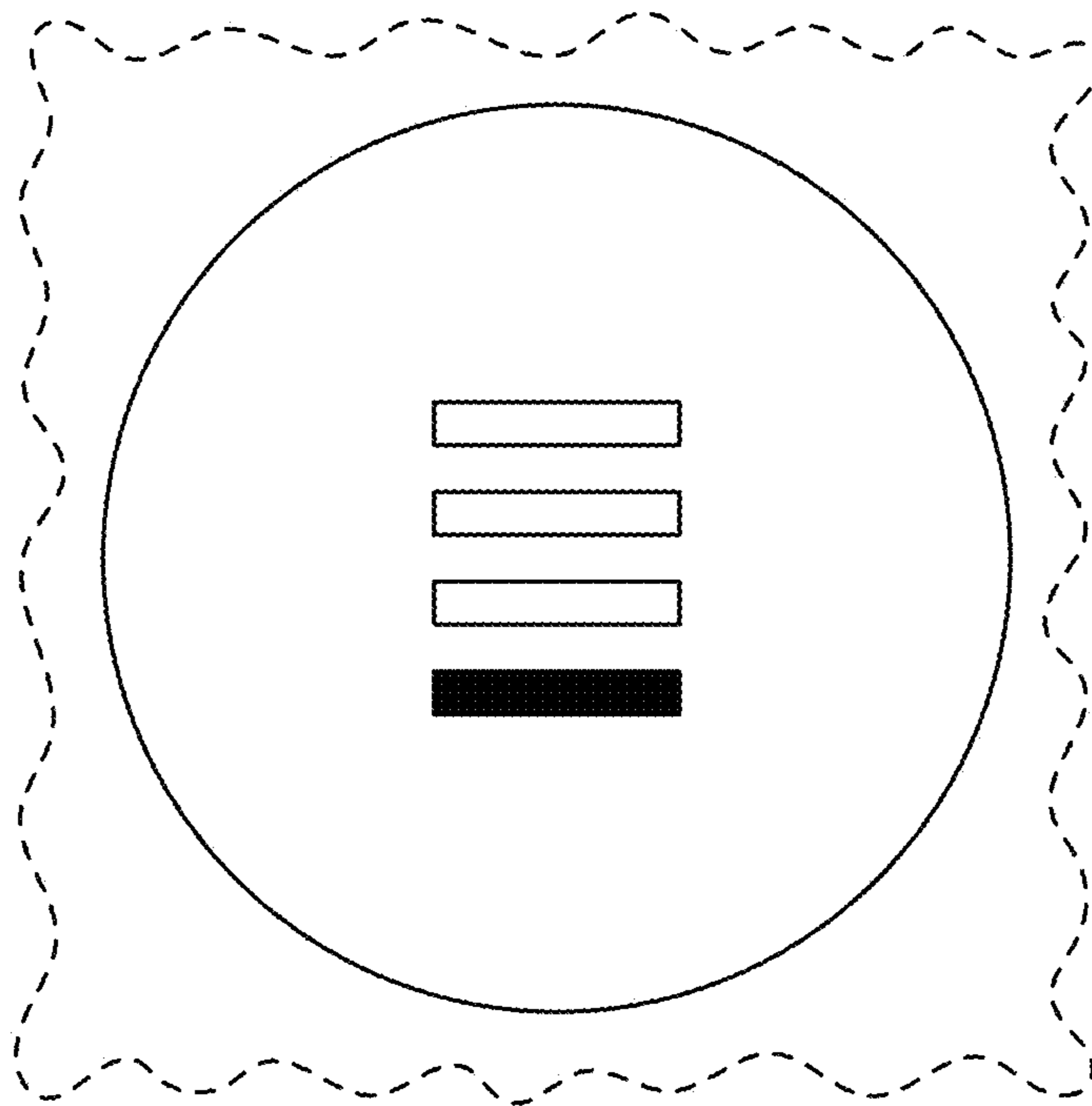

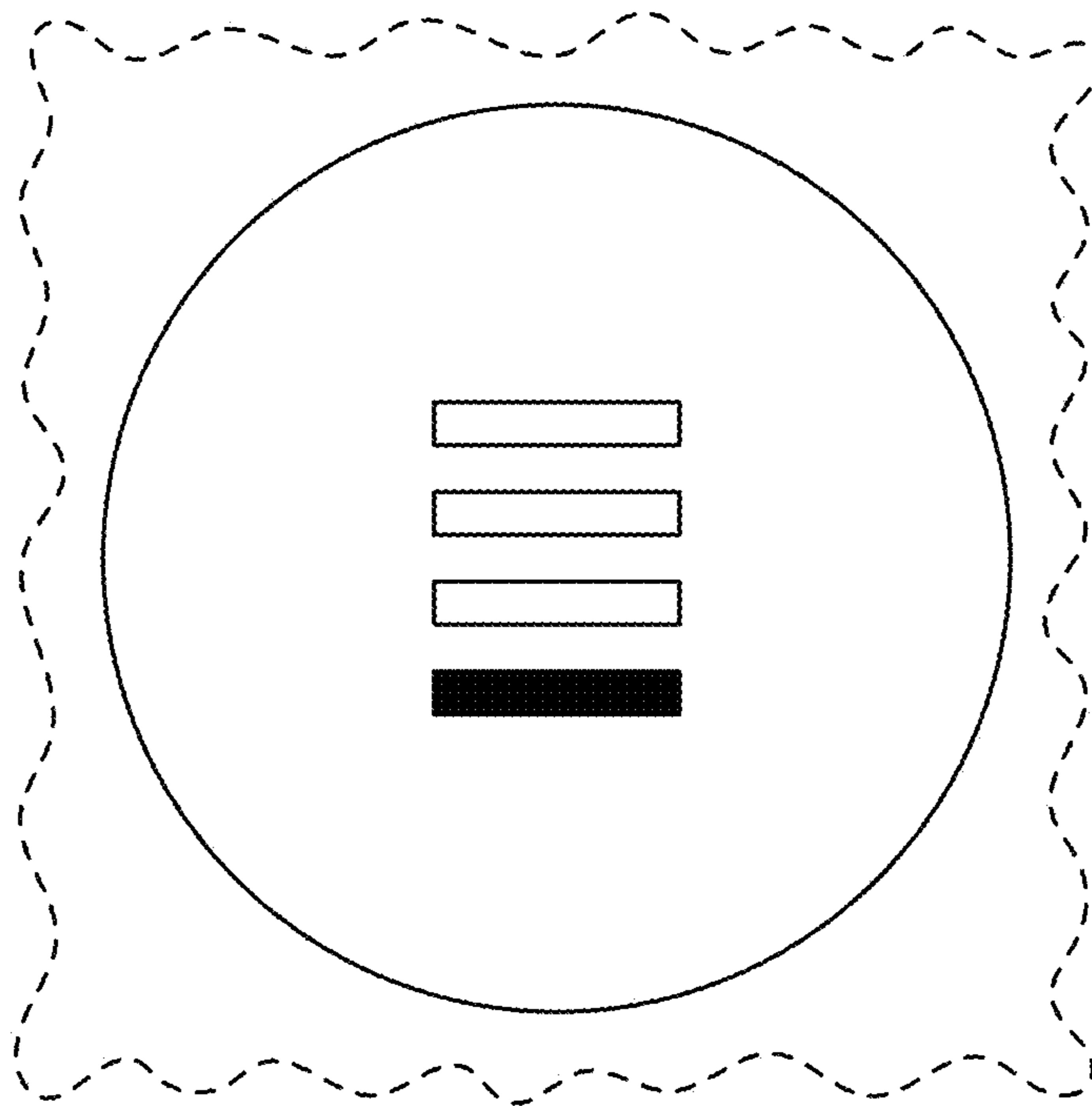

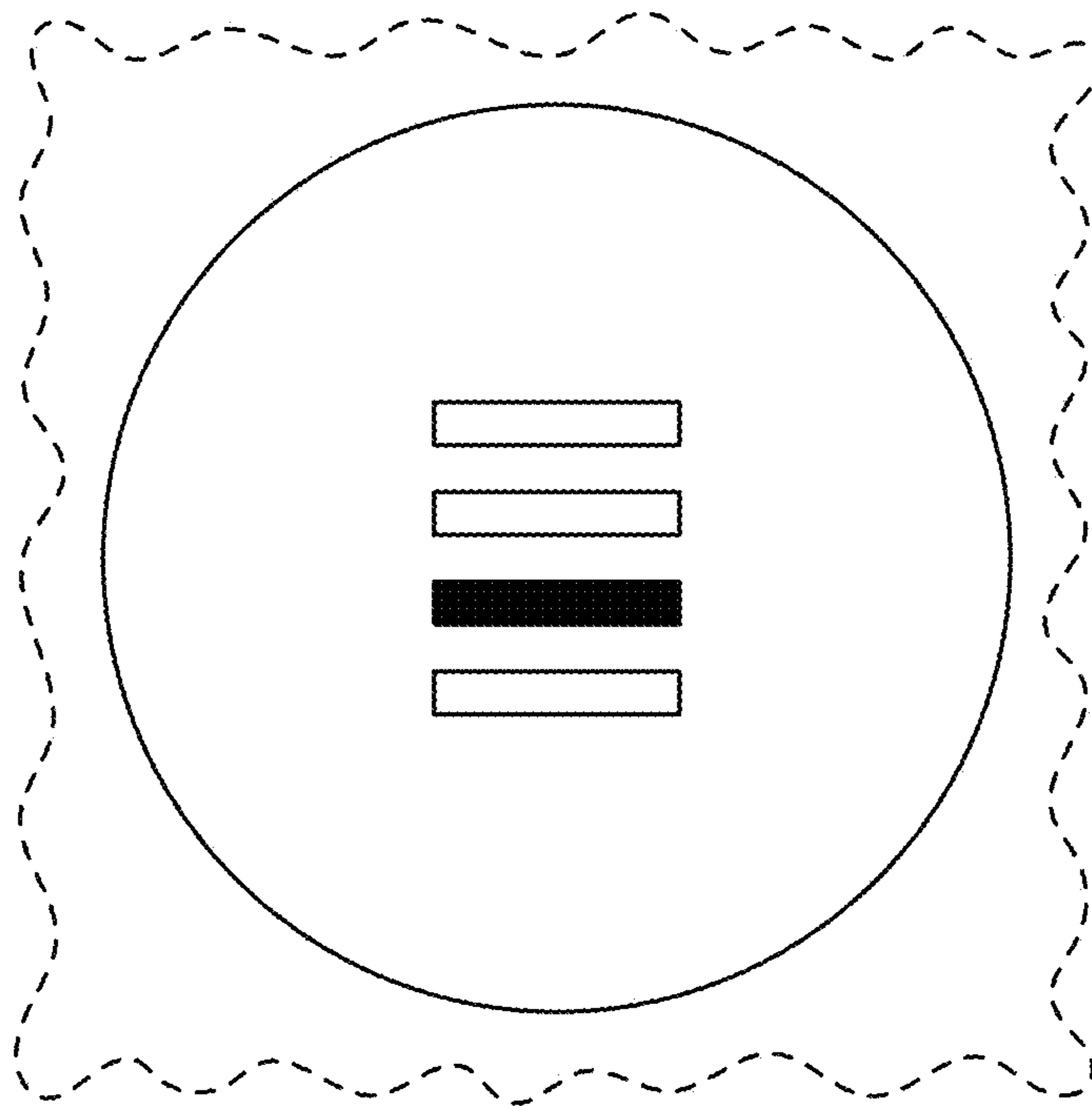

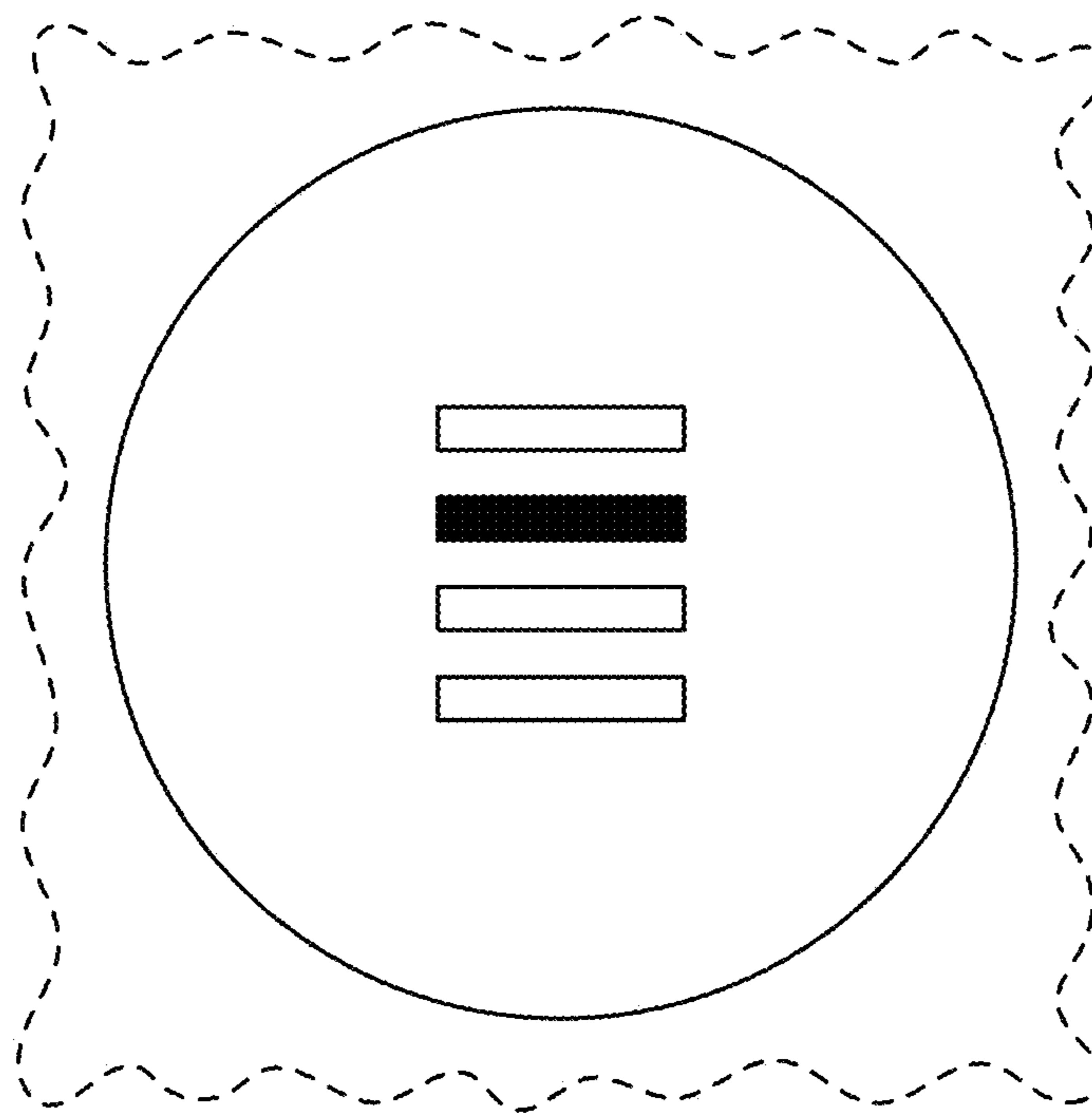

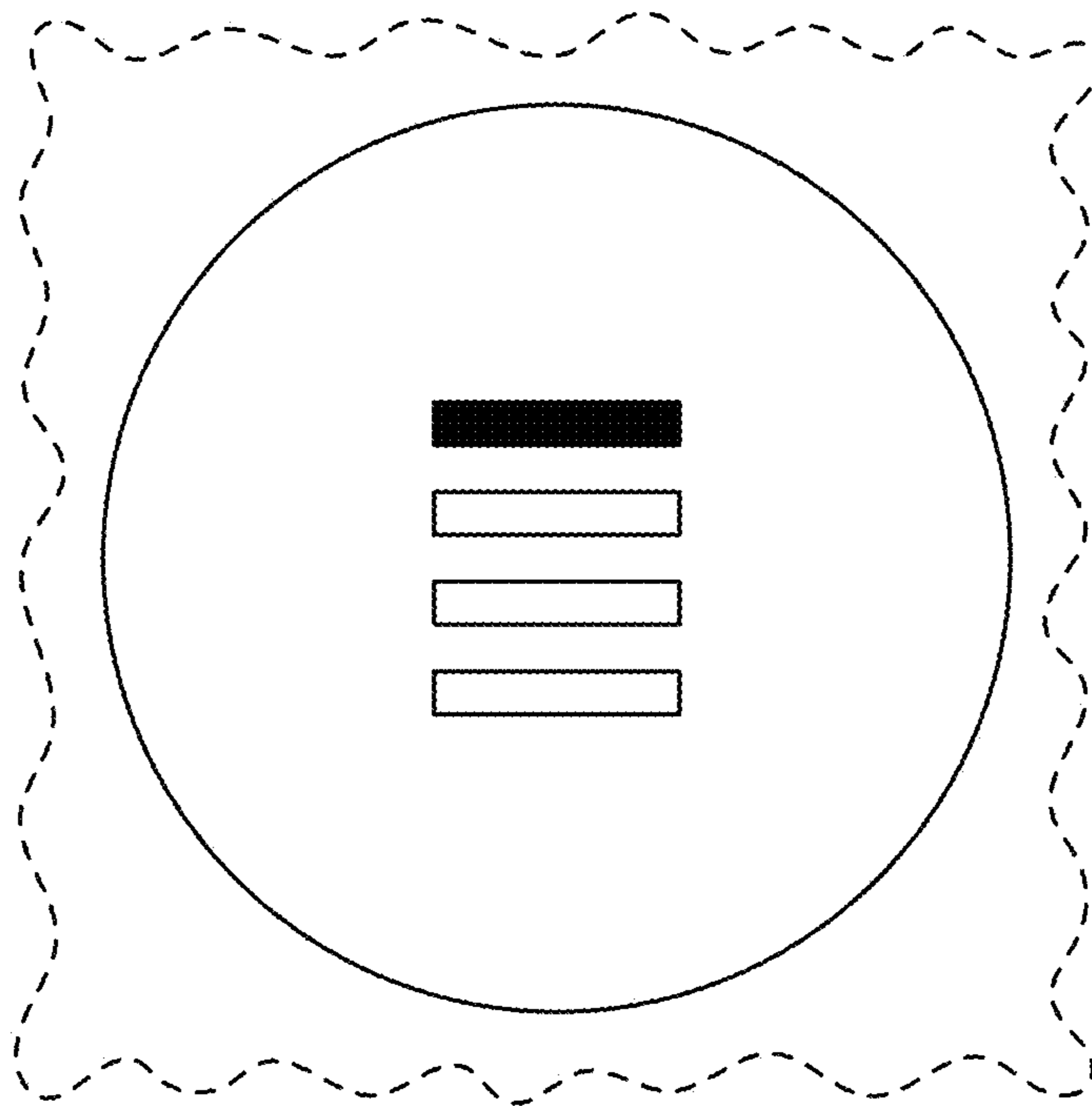
