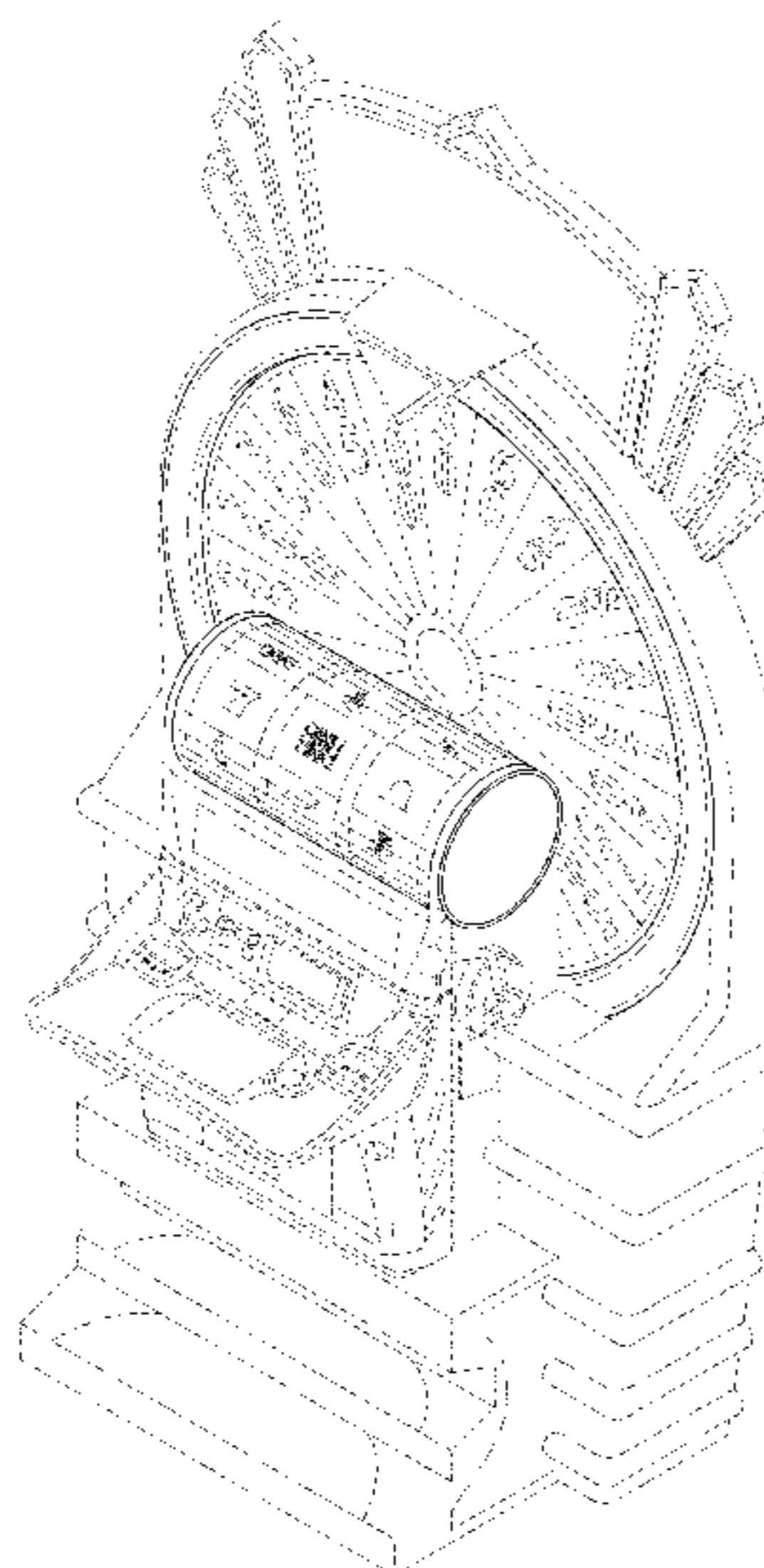
(57) **CLAIM**

The ornamental design for a gaming apparatus having a cylindrical display, as shown and described herein.

DESCRIPTION

FIG. 1 is a front perspective view of a gaming apparatus having a cylindrical display of our new design.
FIG. 2 is a front view of the gaming apparatus having a cylindrical display of FIG. 1.
FIG. 3 is a rear view of the gaming apparatus having a cylindrical display of FIG. 1.
FIG. 4 is a right side view of the gaming apparatus having a cylindrical display of FIG. 1.
FIG. 5 is a left side view of the gaming apparatus having a cylindrical display of FIG. 1; and,
FIG. 6 is a top view of the gaming apparatus having a cylindrical display of FIG. 1.

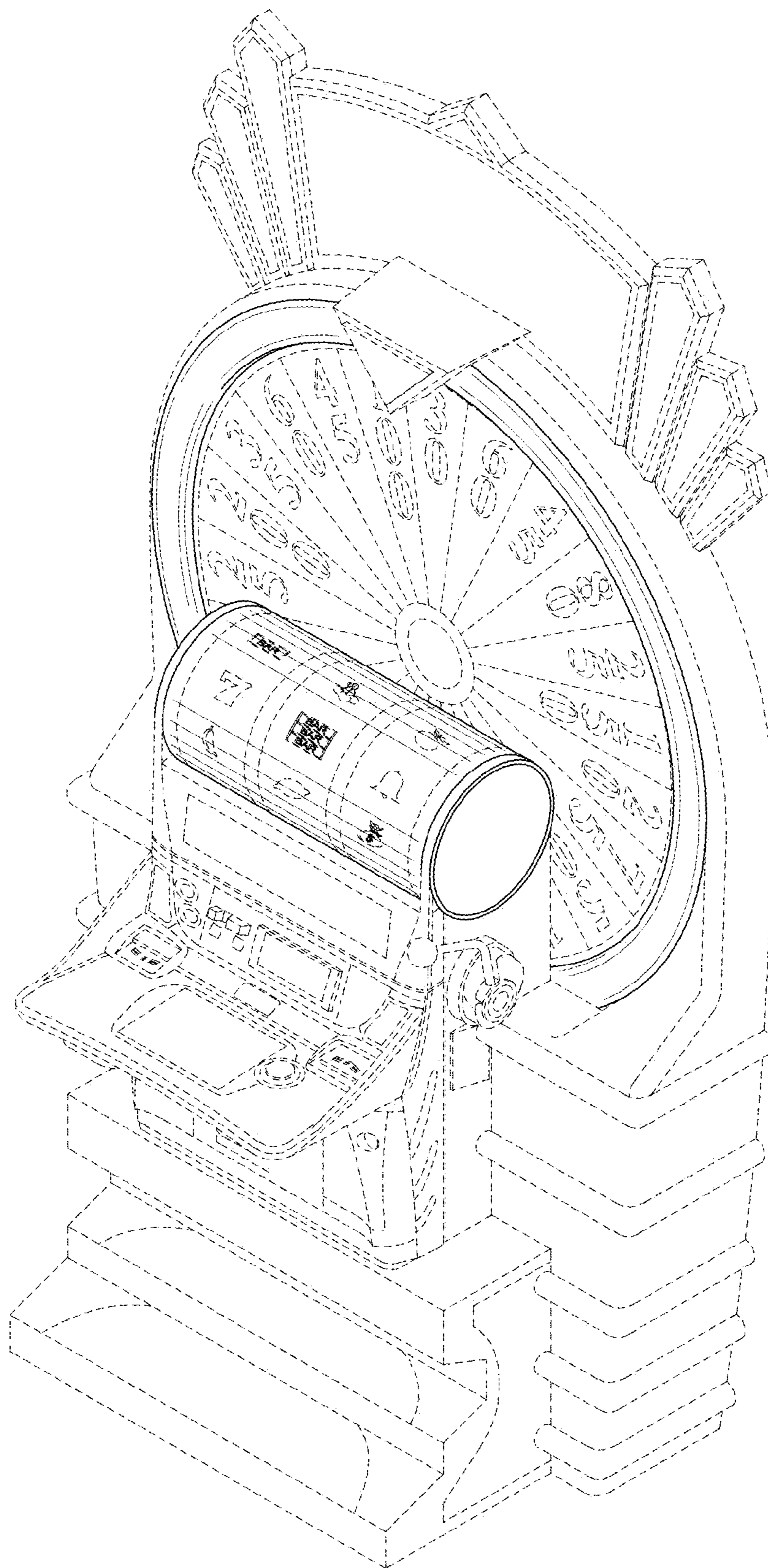

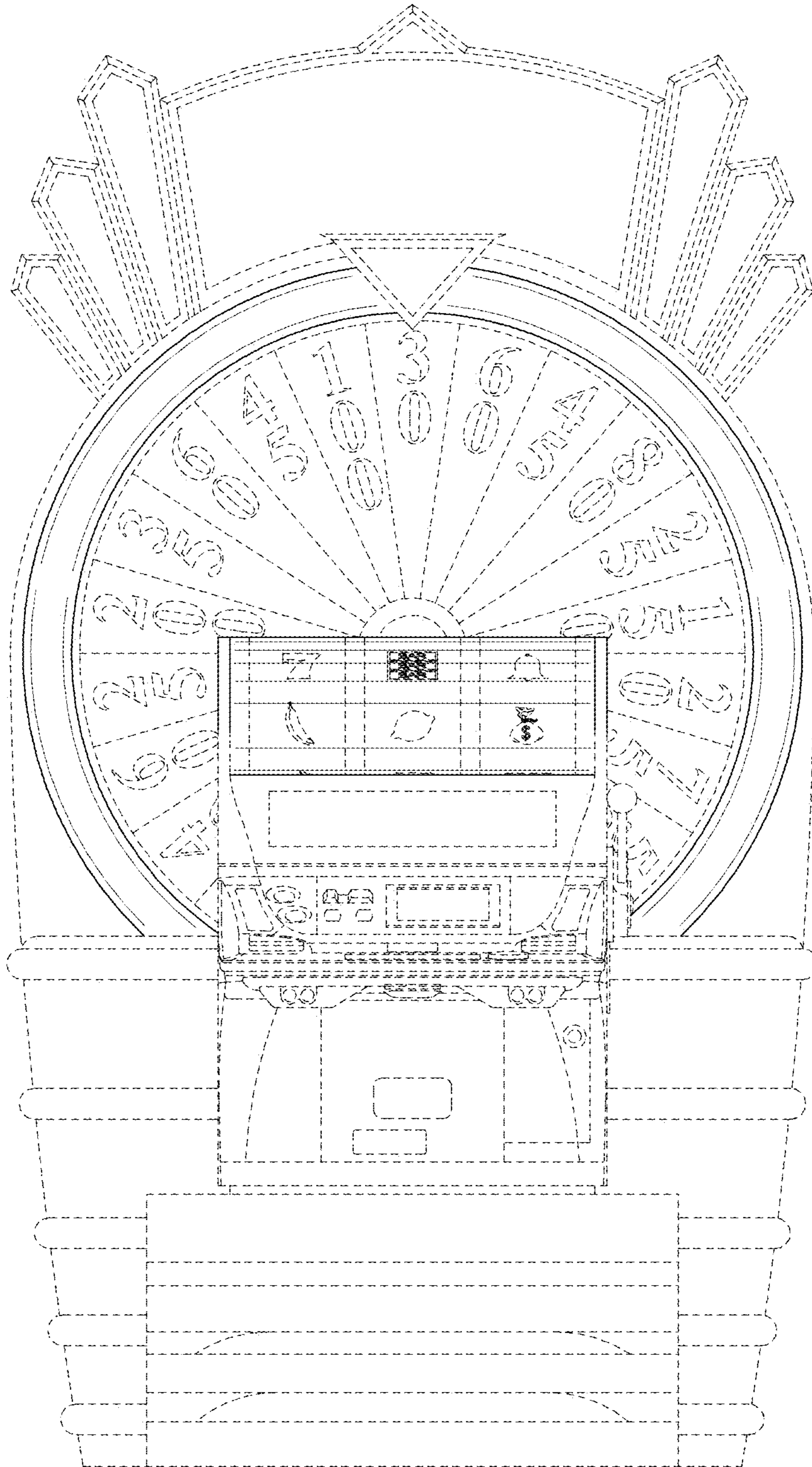

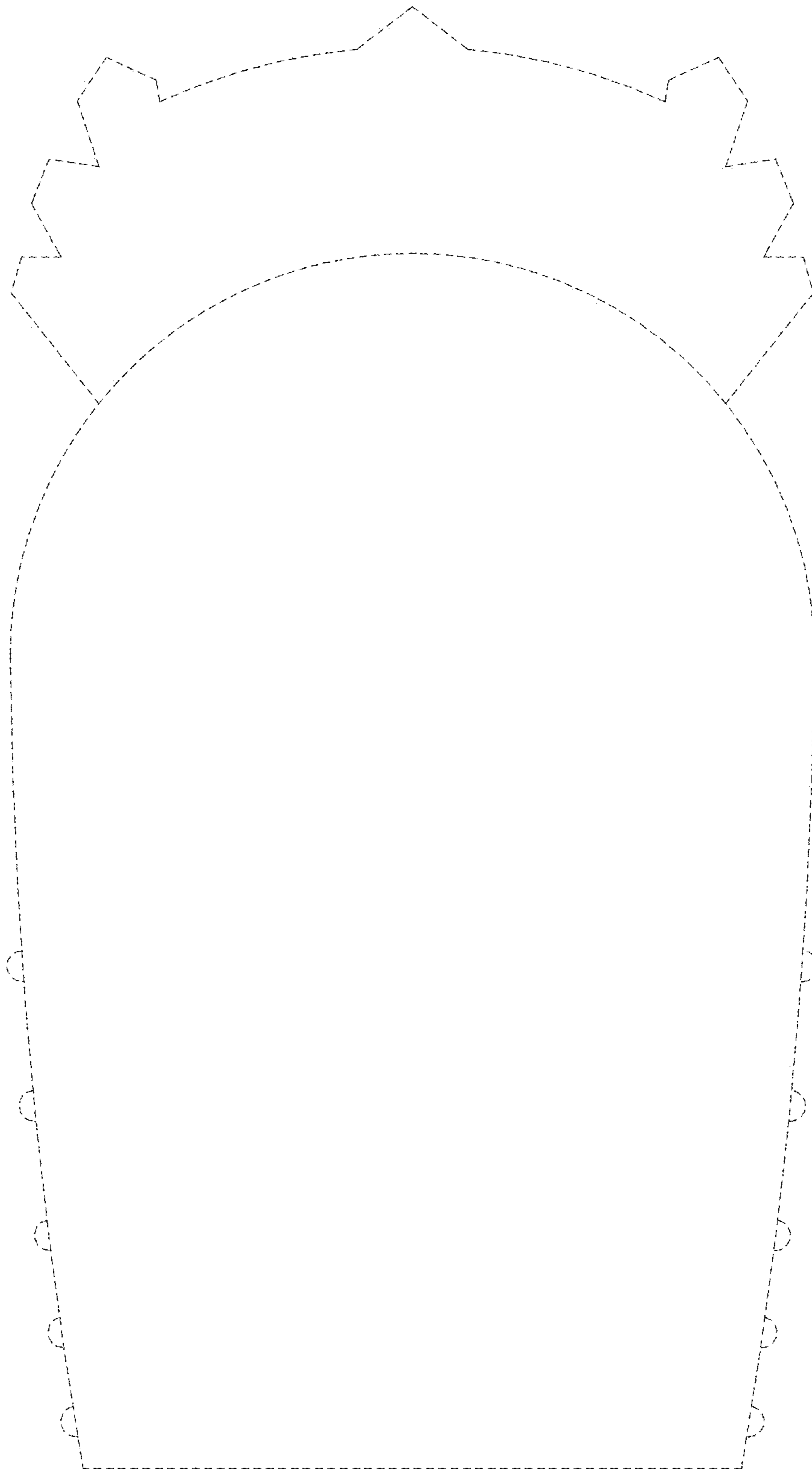

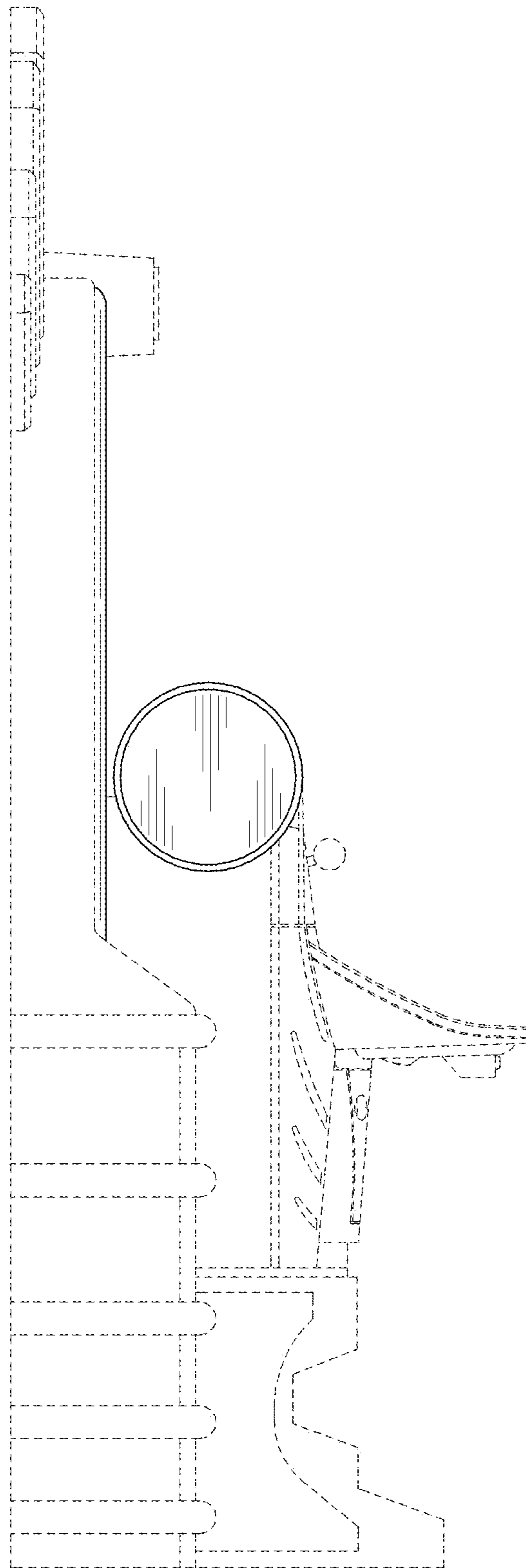

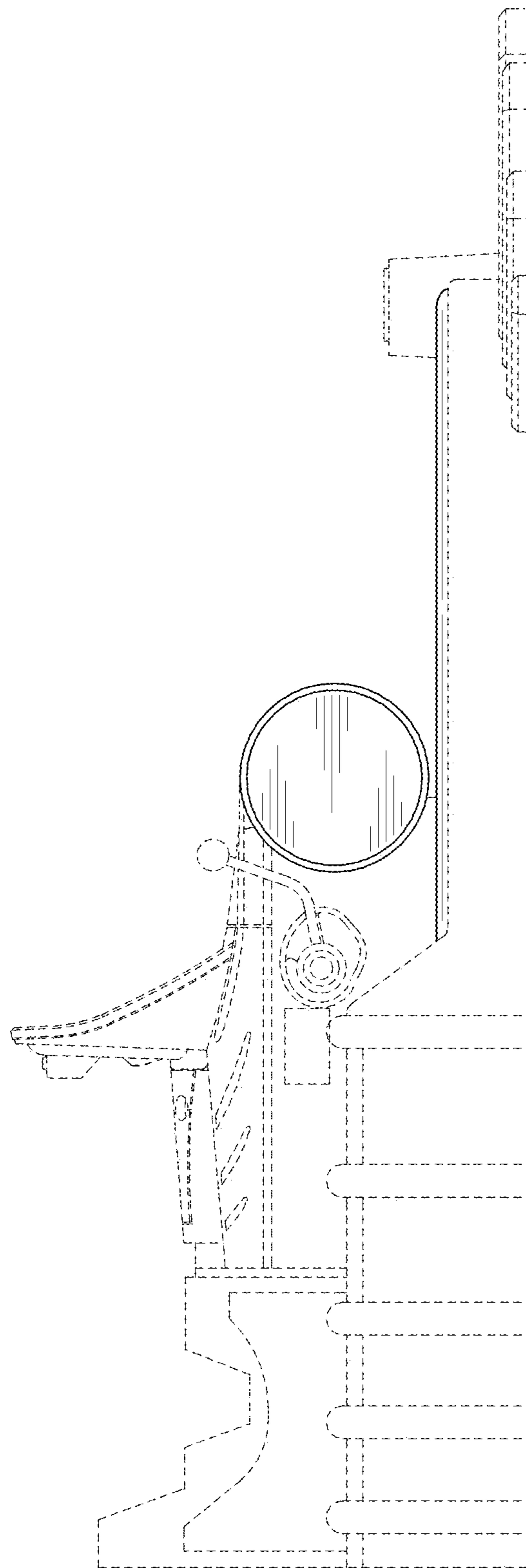

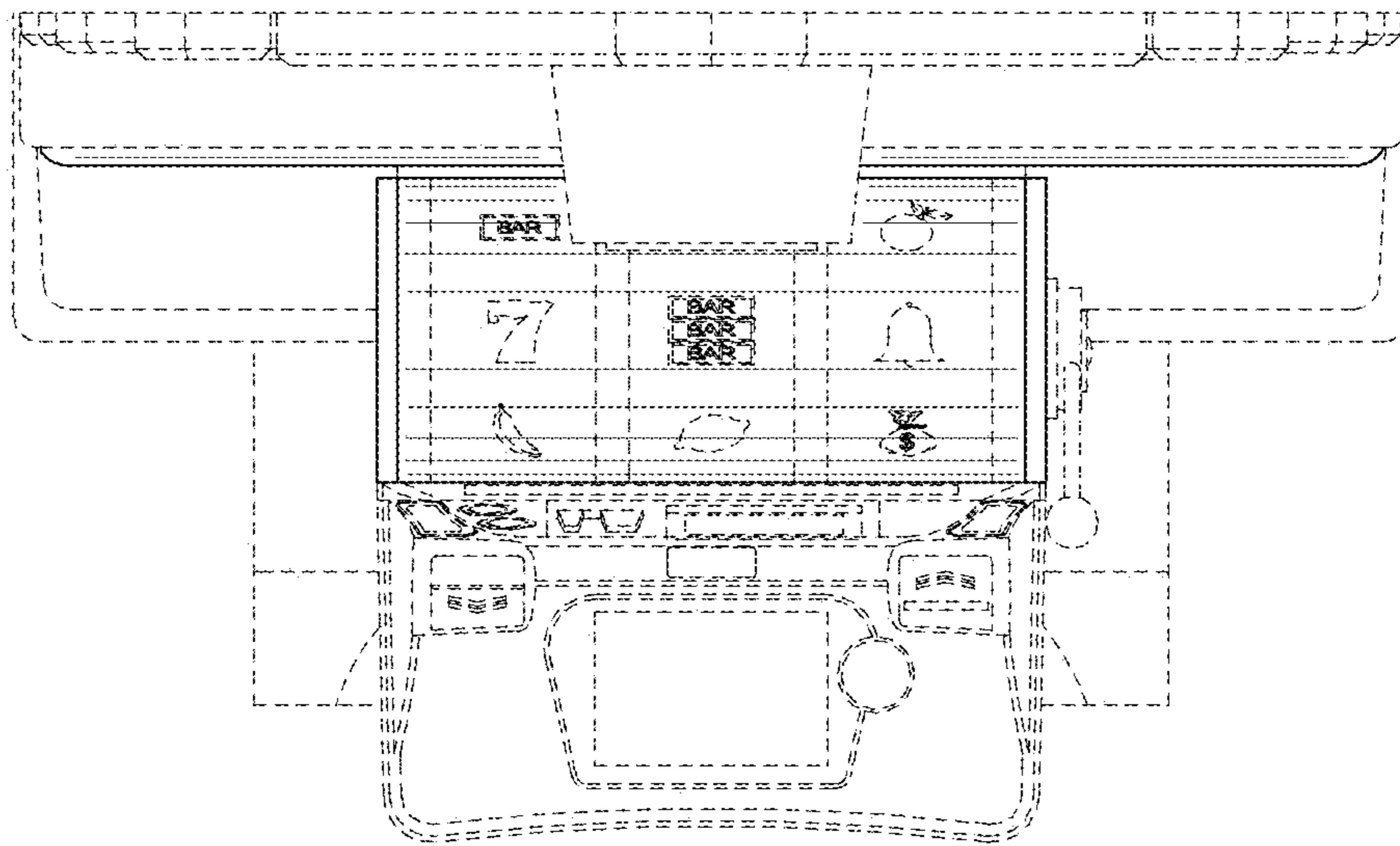
