The ornamental design for an shower enclosure, as shown and described.

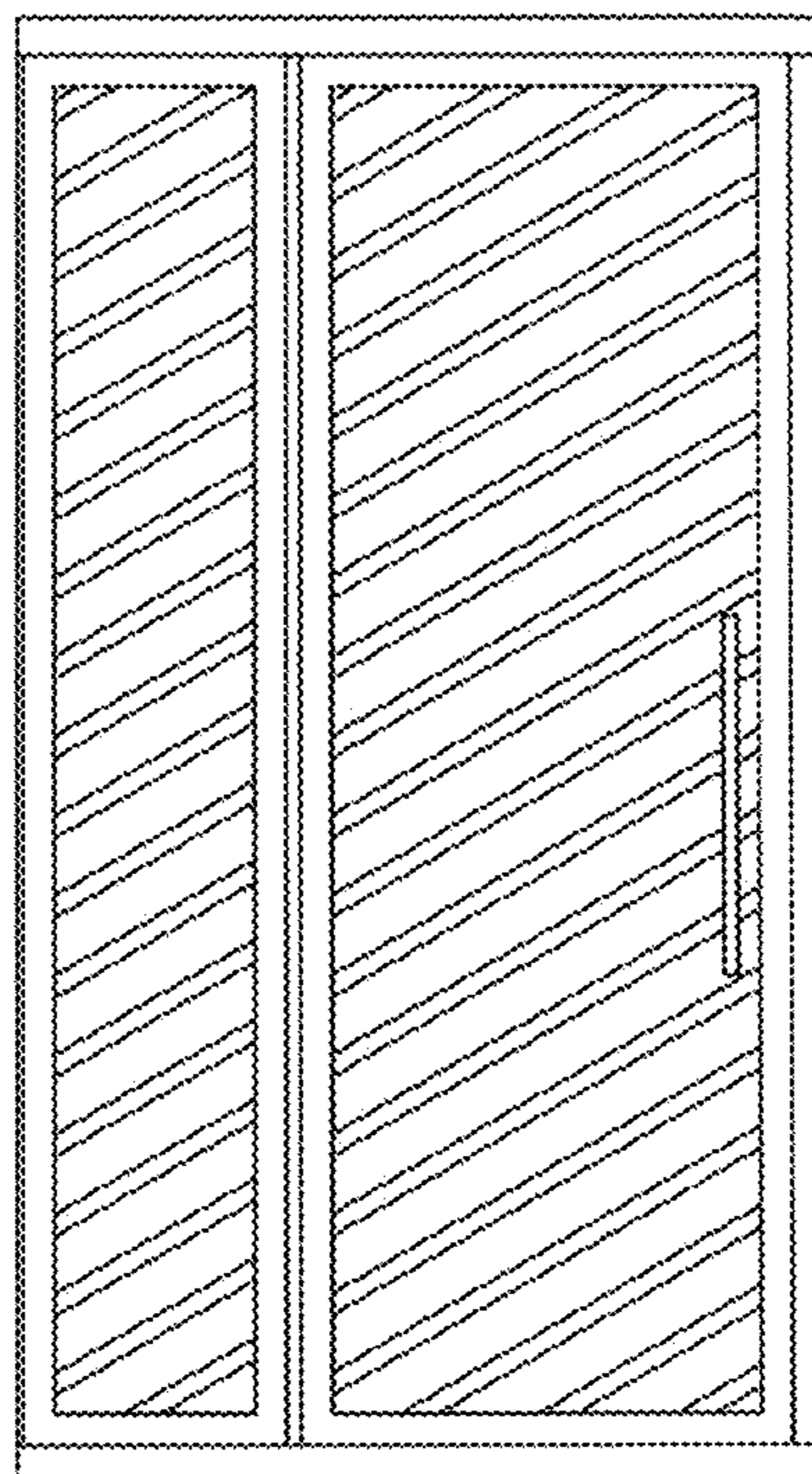
DESCRIPTION

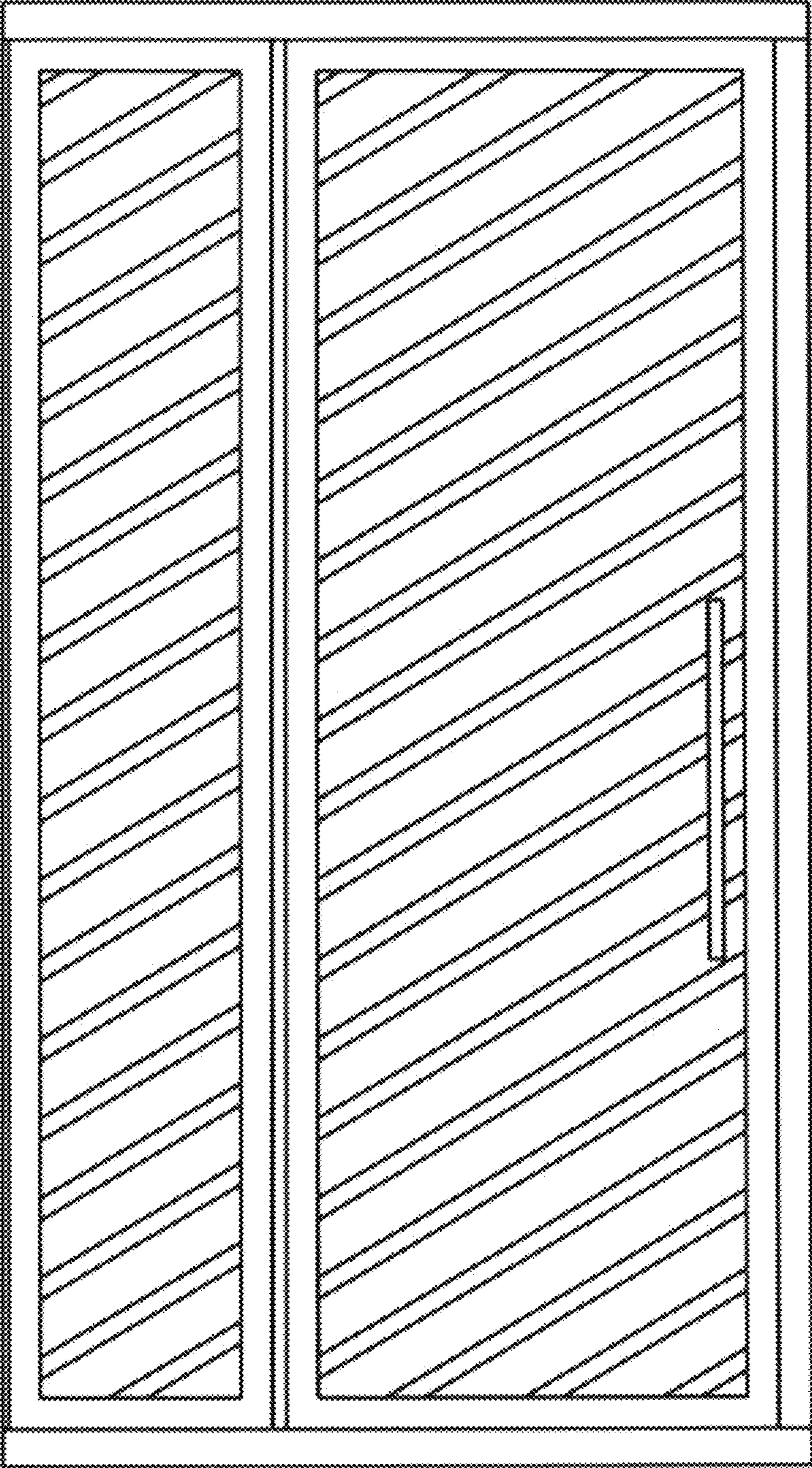

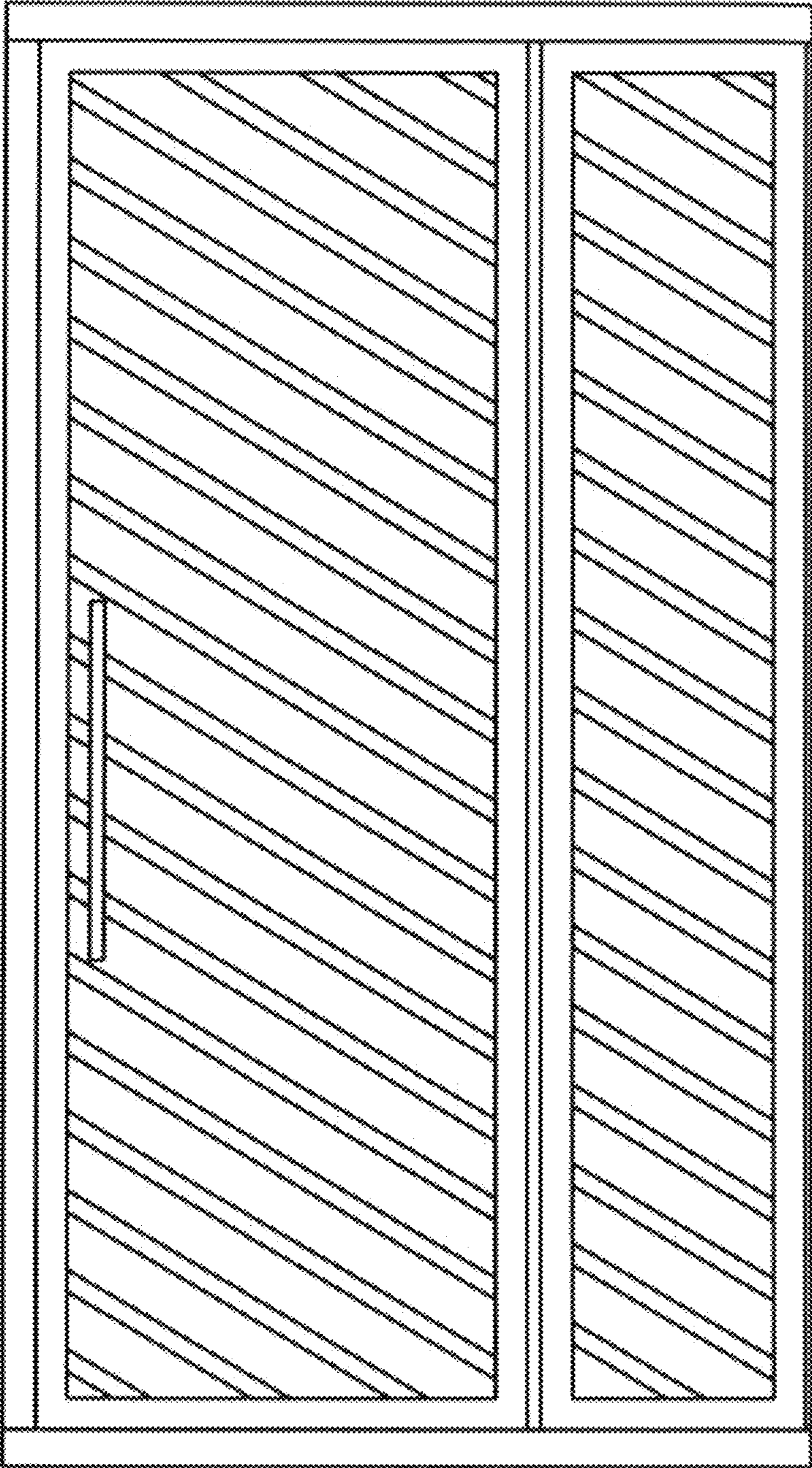

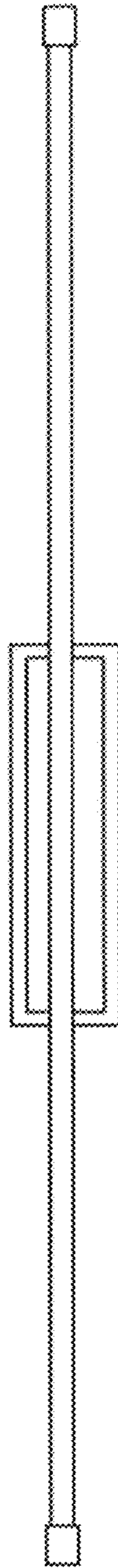

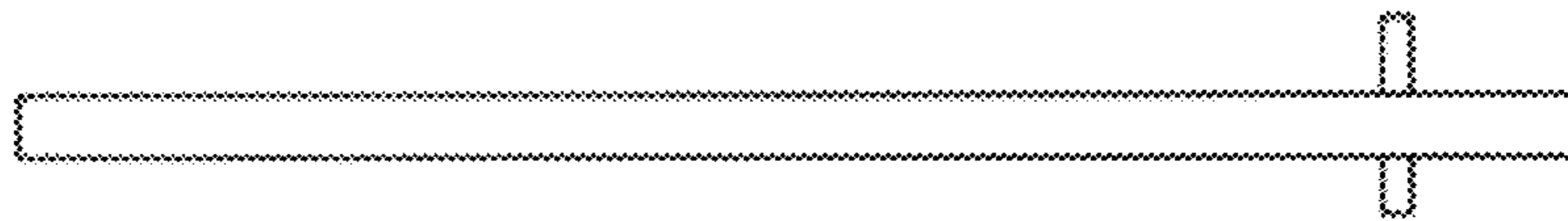
