(57) **CLAIM**

The ornamental design for an air conditioner, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an air conditioner, showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left-side view thereof;

FIG. 5 is a right-side view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is another front perspective view thereof, showing only the claimed portion in FIG. 1;

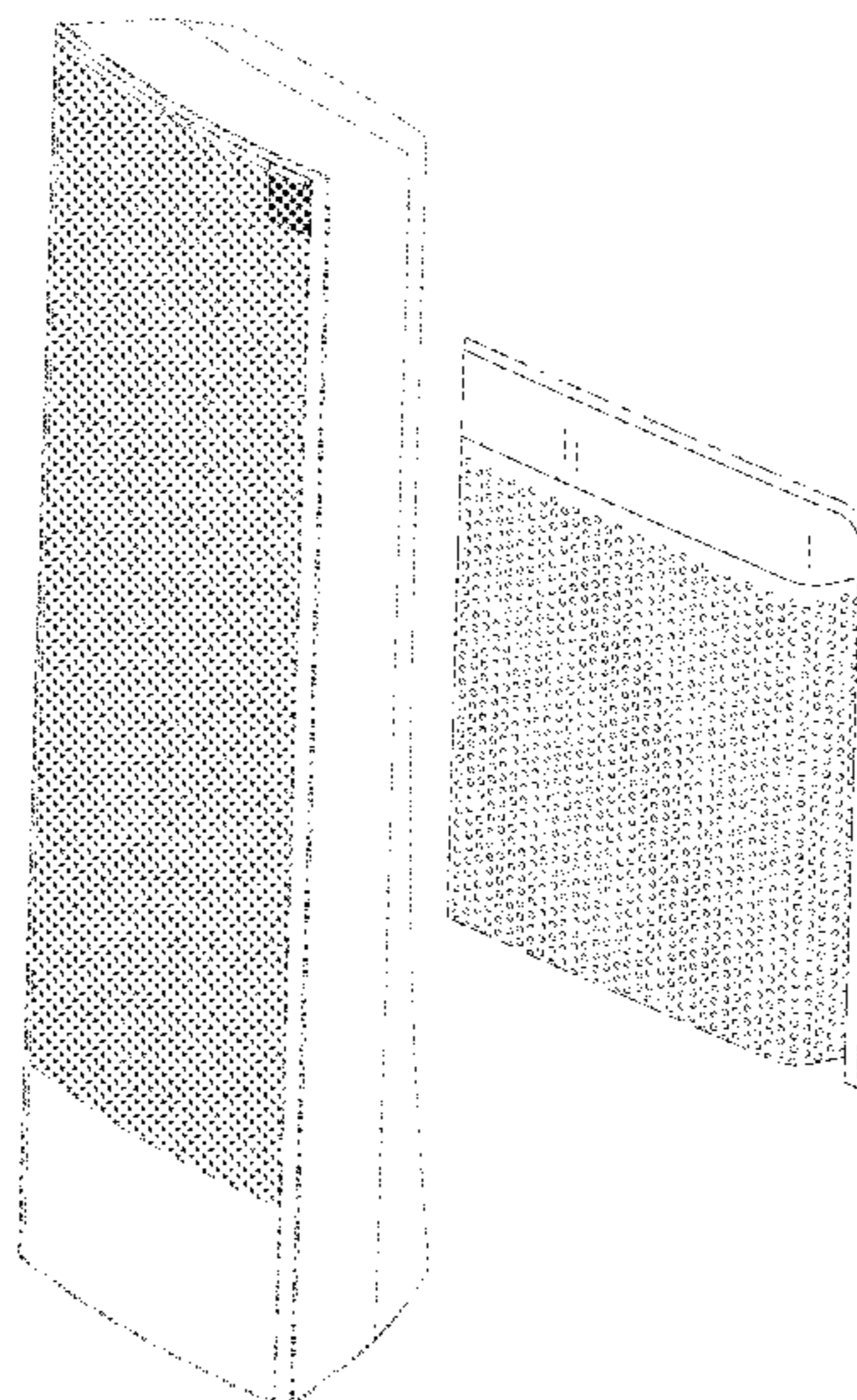
FIG. 9 is an enlarged view of the portion 9 in FIG. 6; and,

FIG. 10 is a cross-sectional view thereof, taken along line 10-10 in FIG. 9.

The even-dash broken lines illustrating portions of the air conditioner form no part of the claimed design. The dot-dash broken lines in the figures represent a boundary line and form no part of the claimed design. The dot-dot-dash broken lines encircling enlargement portions of the claimed design form no part of the claimed design.

The thousands of tiny features of front portion are ‘micro air holes’, not the pattern.

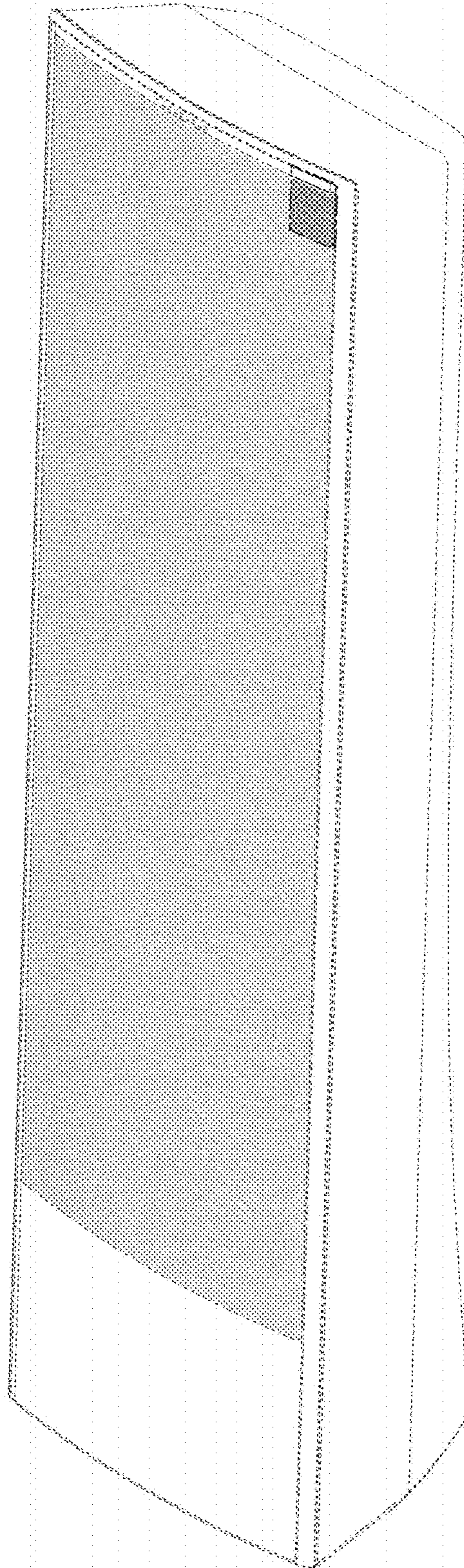

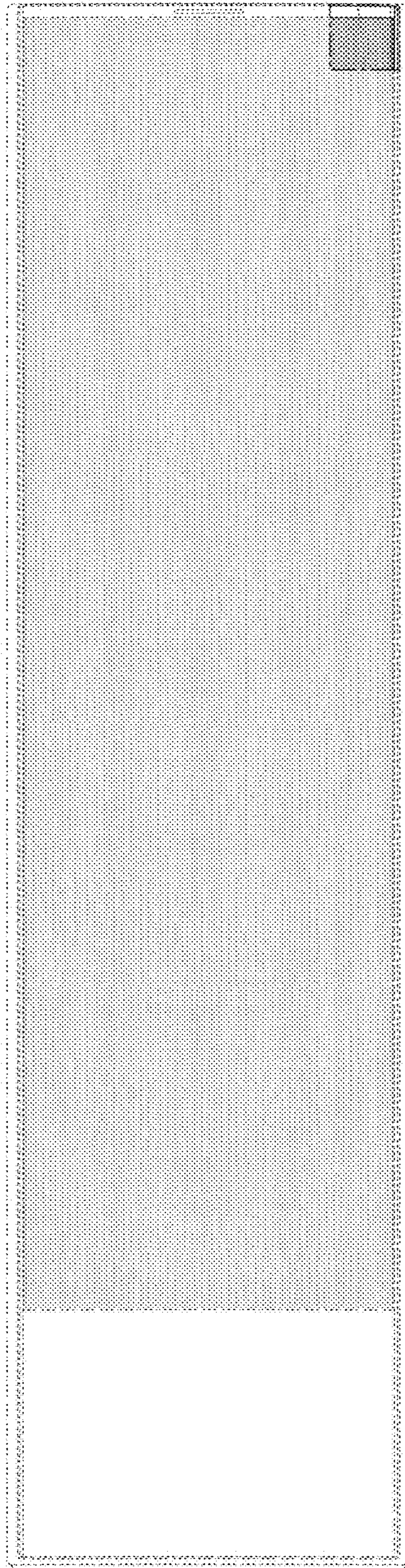

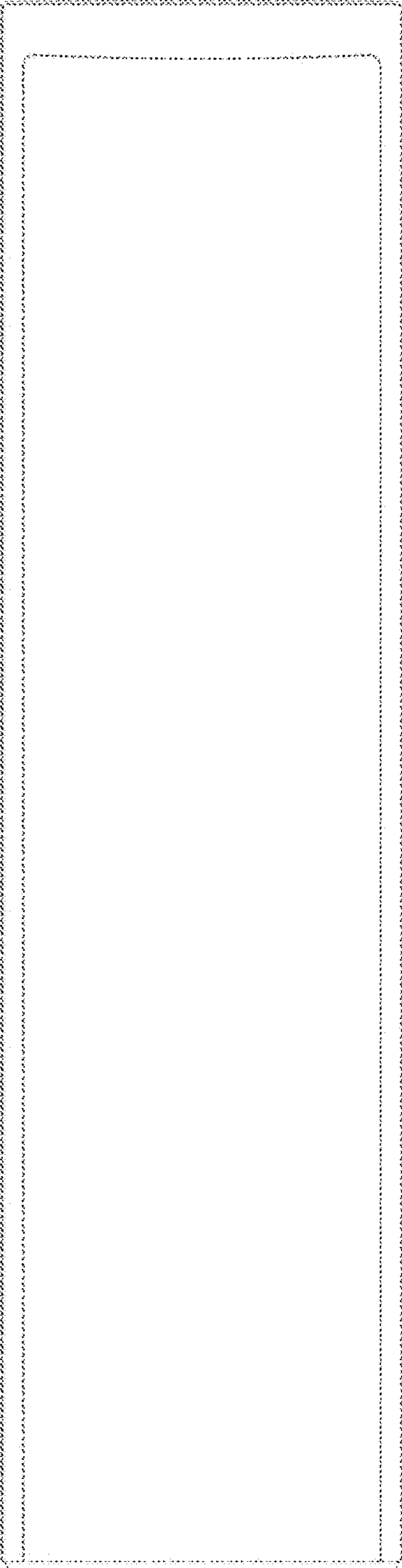

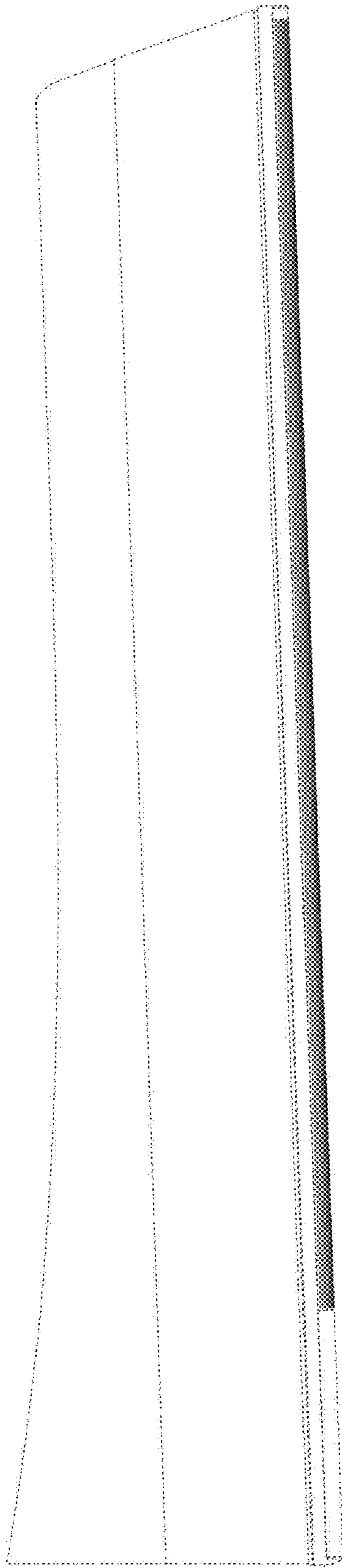

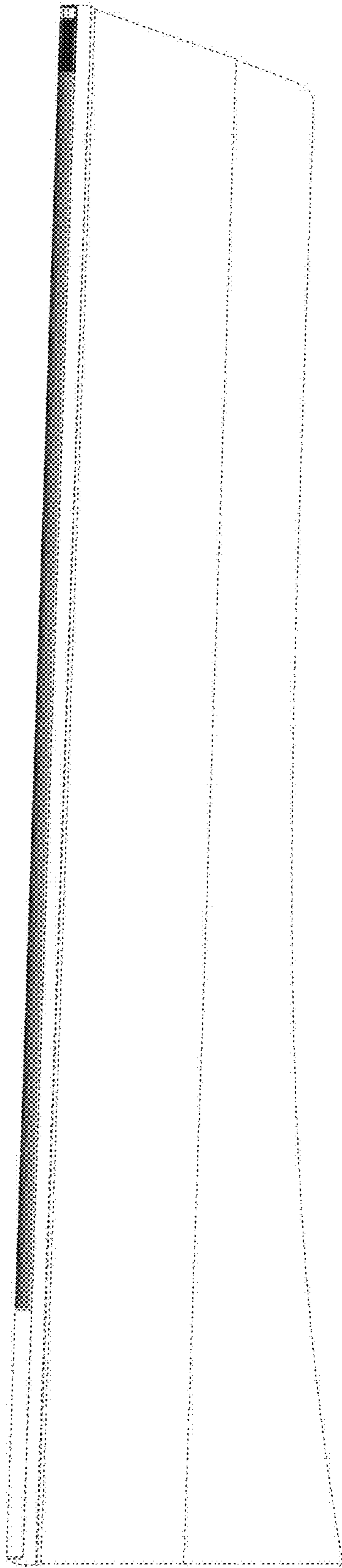

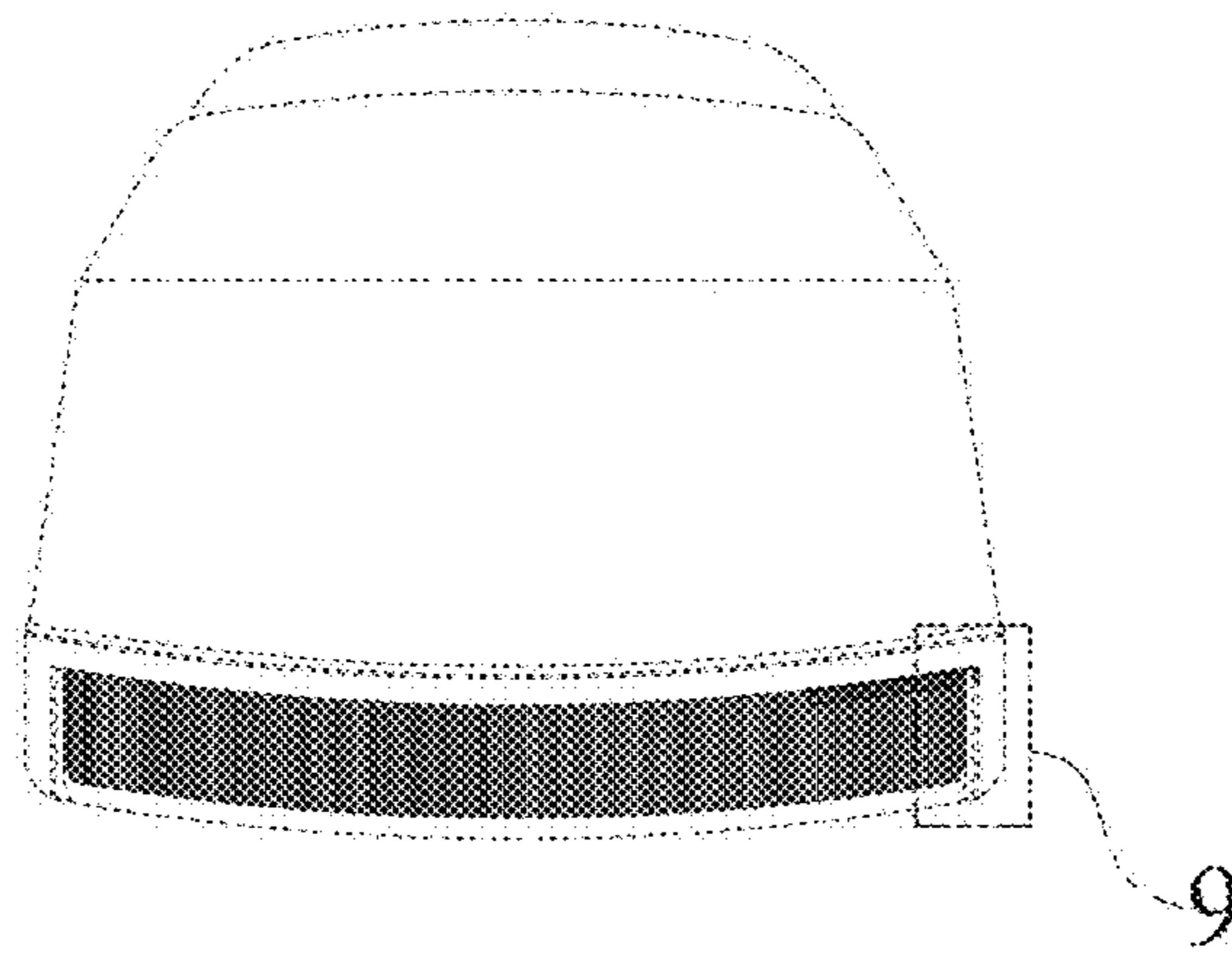

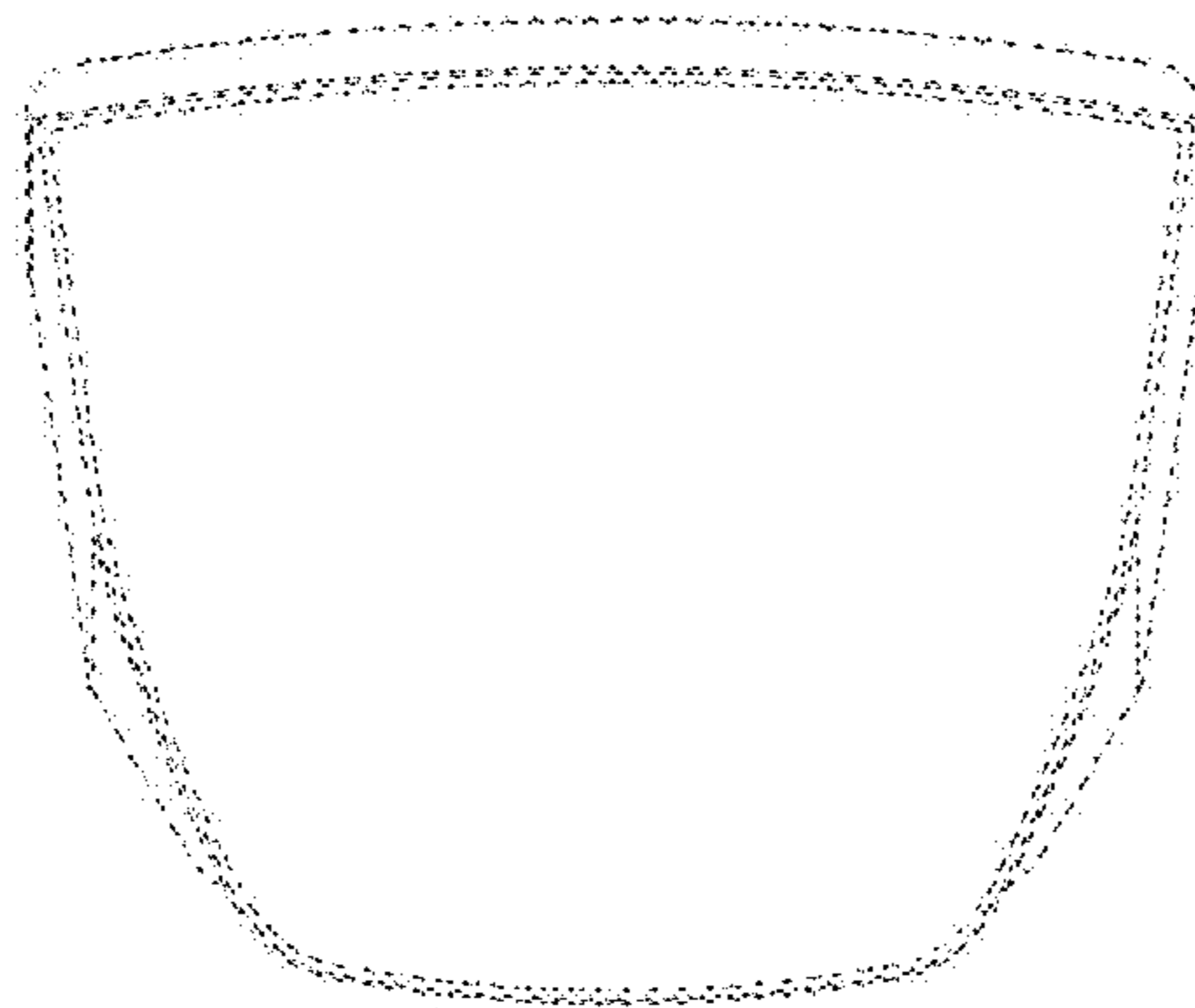

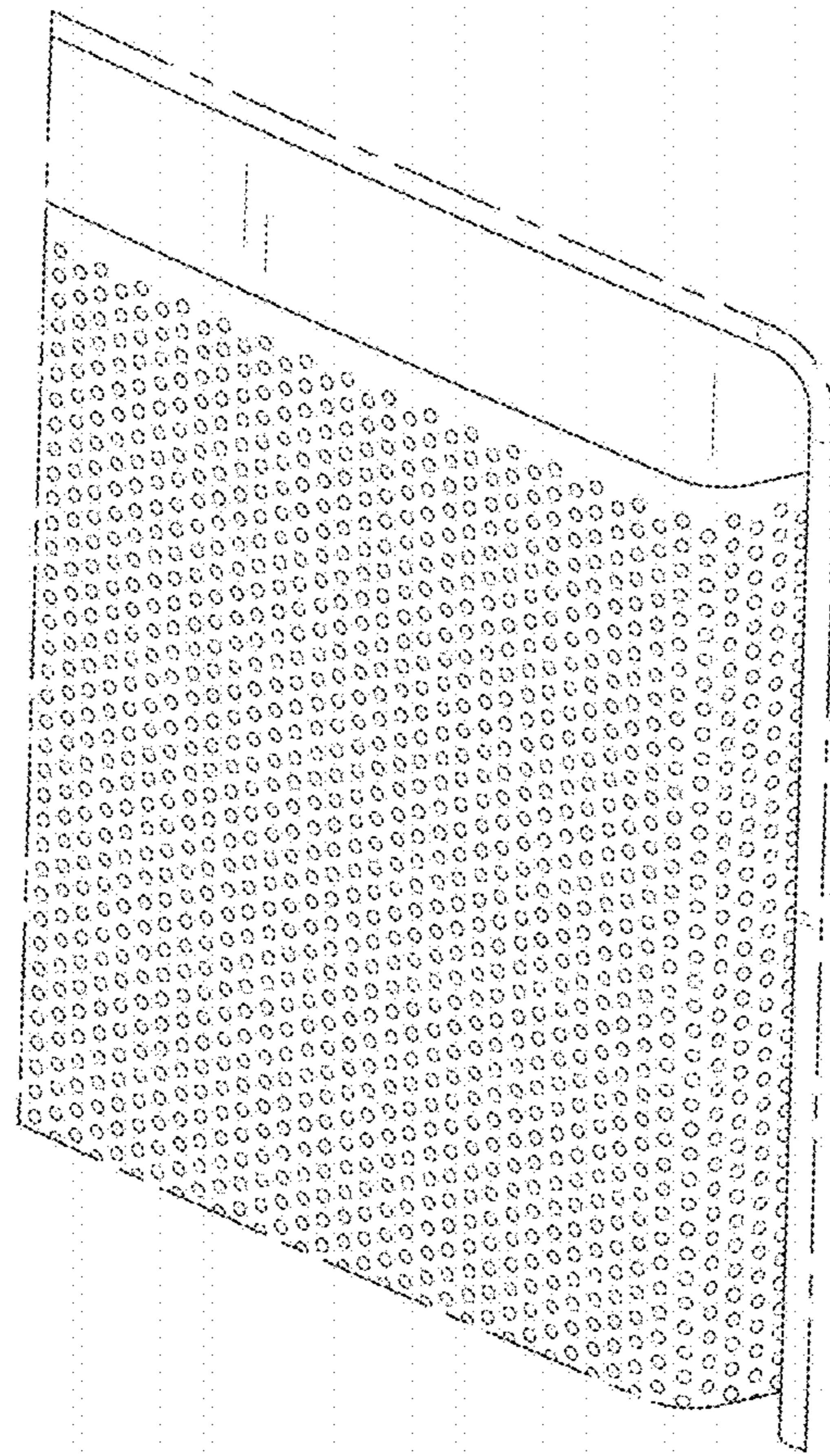

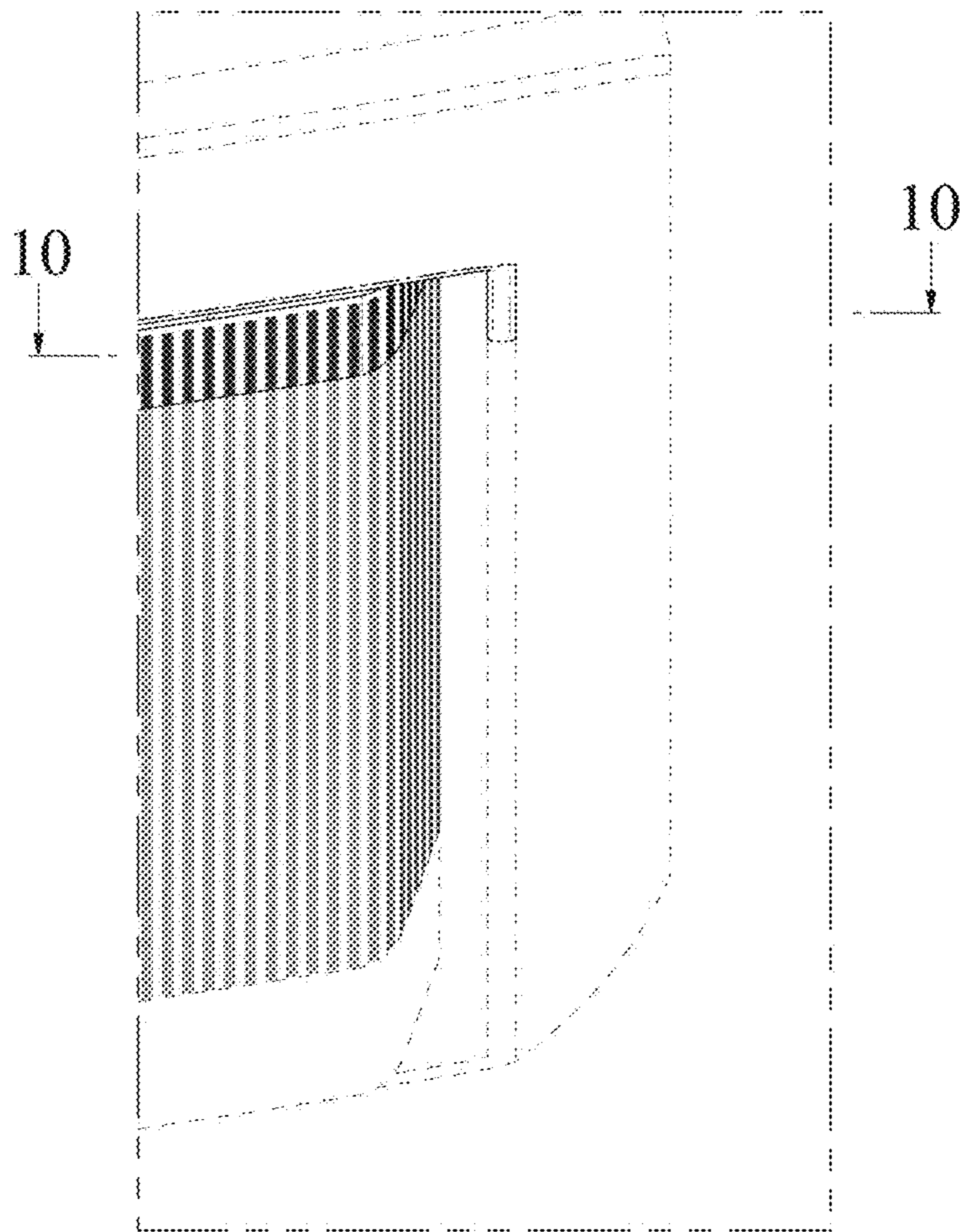
