FIG. 1.5 is a left side elevational view of the chandelier shown in FIG. 1.1;

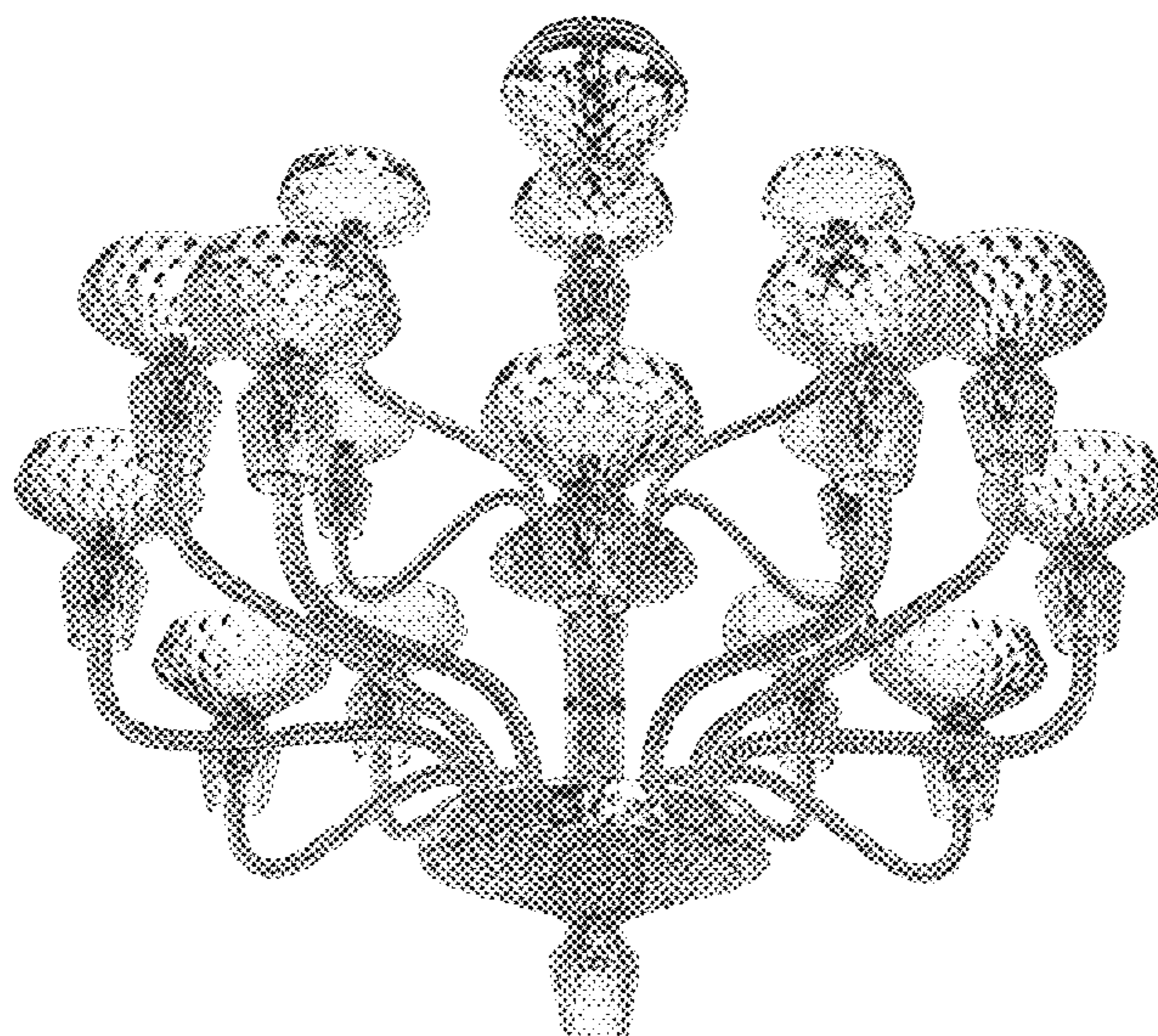
FIG. 1.6 is a bottom plan view of the chandelier shown in FIG. 1.1;

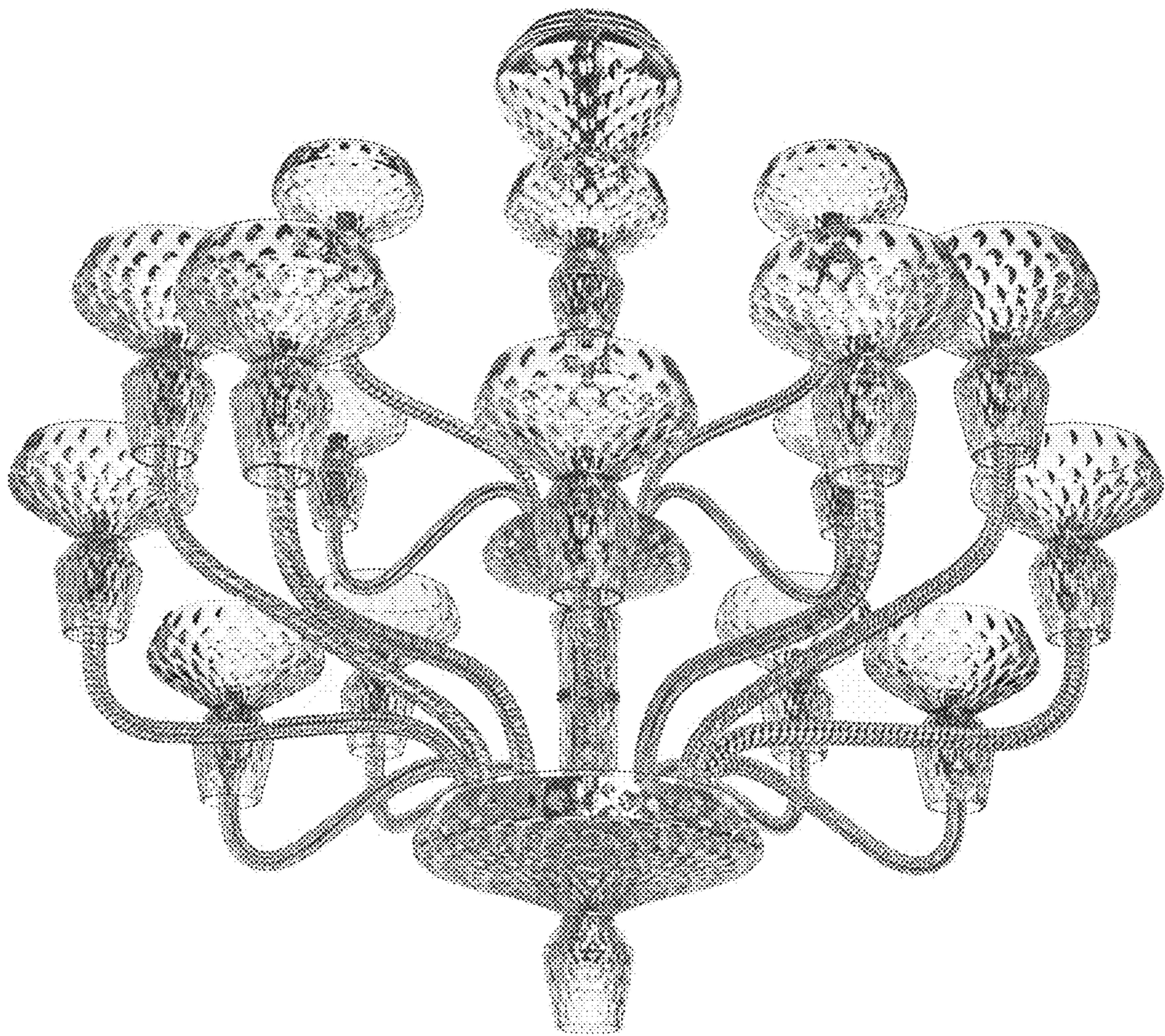

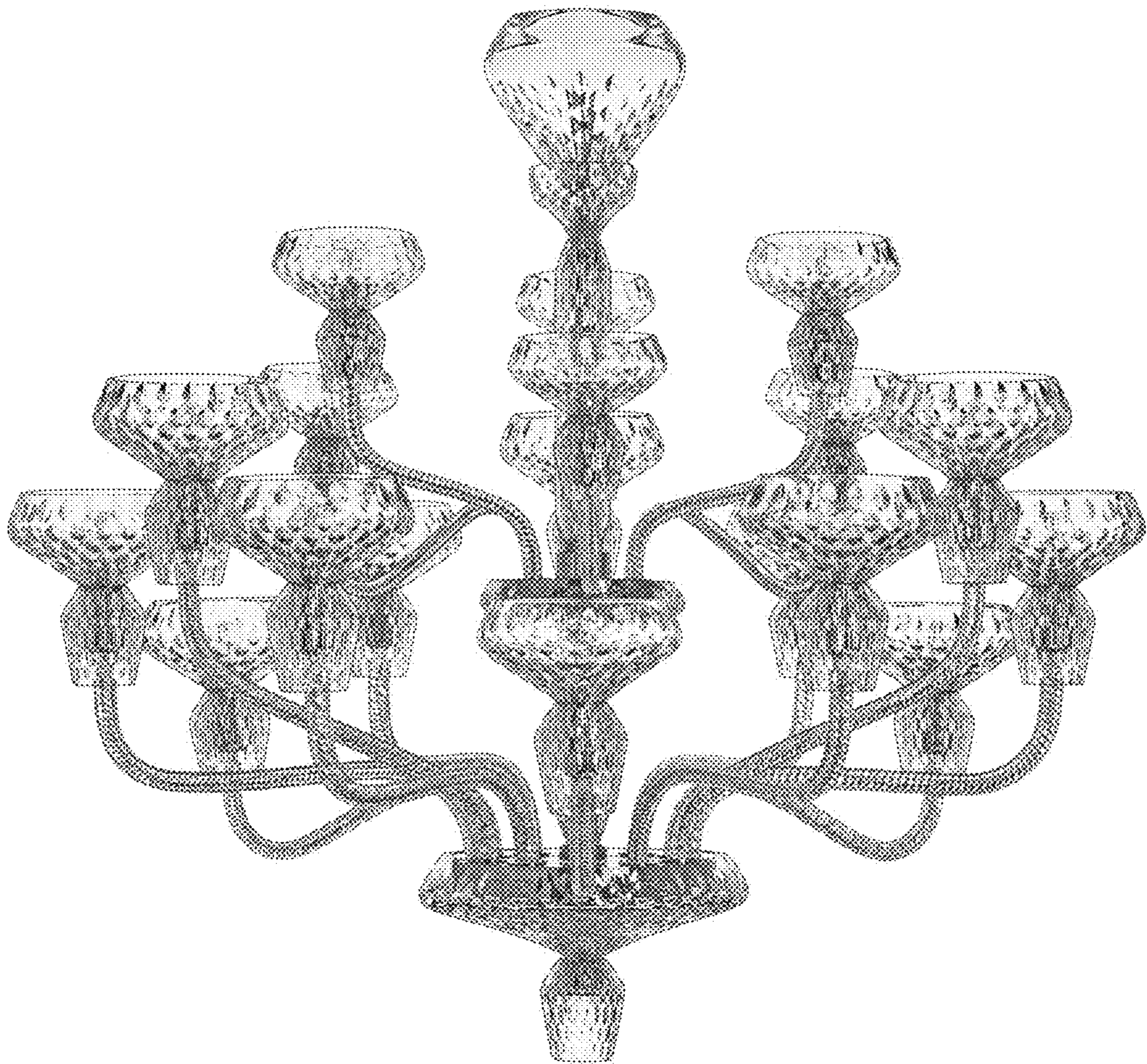

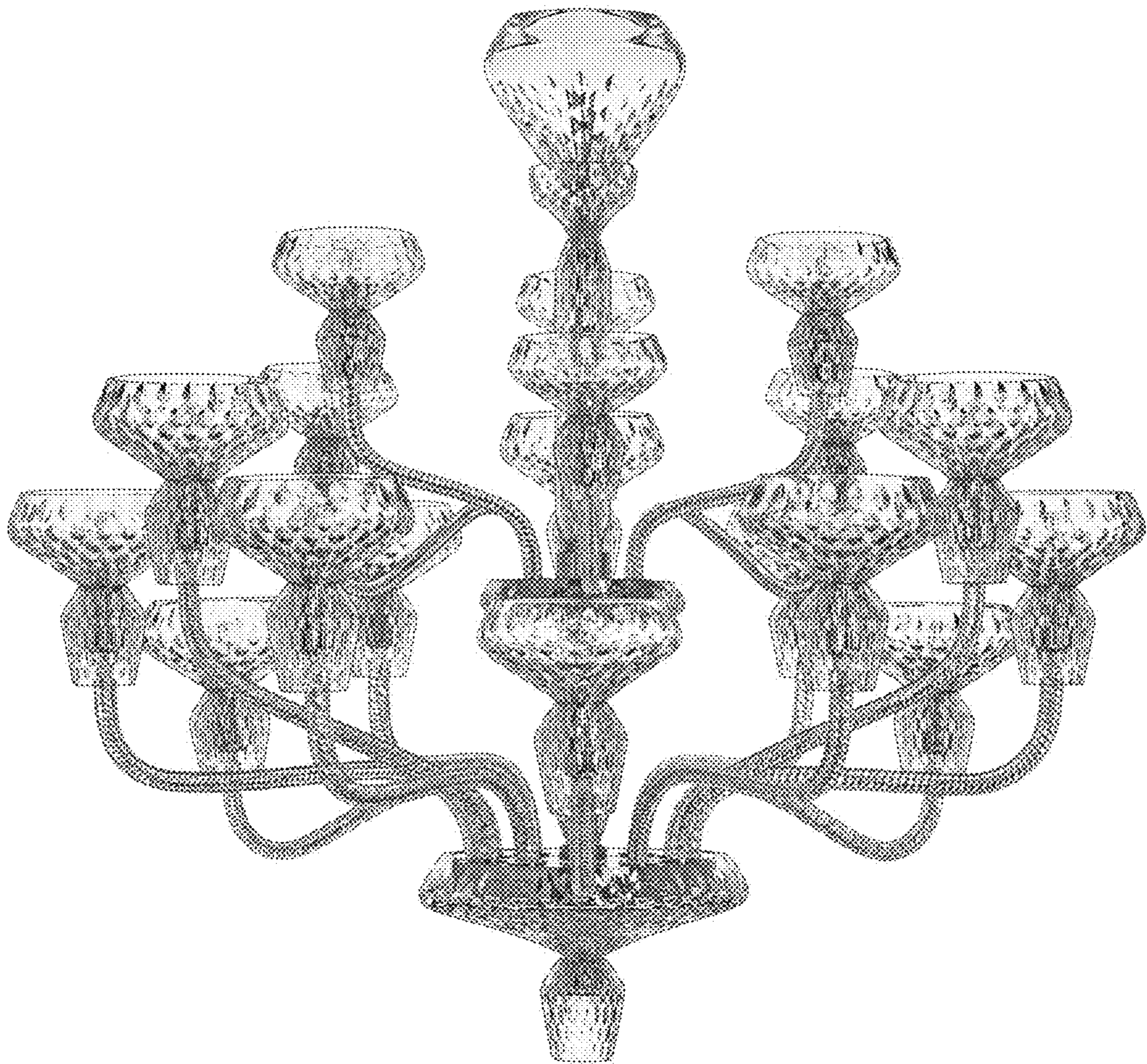

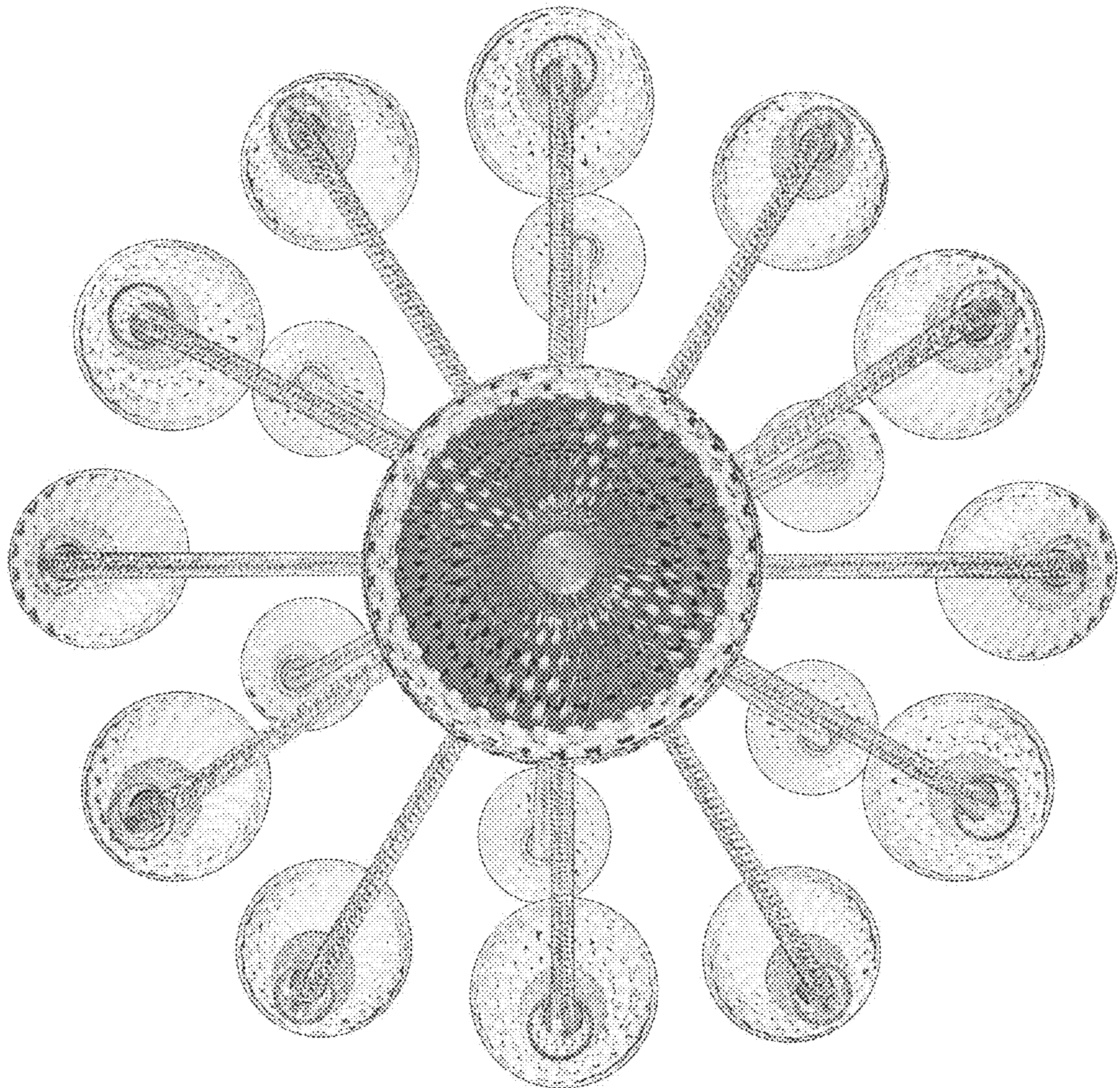
