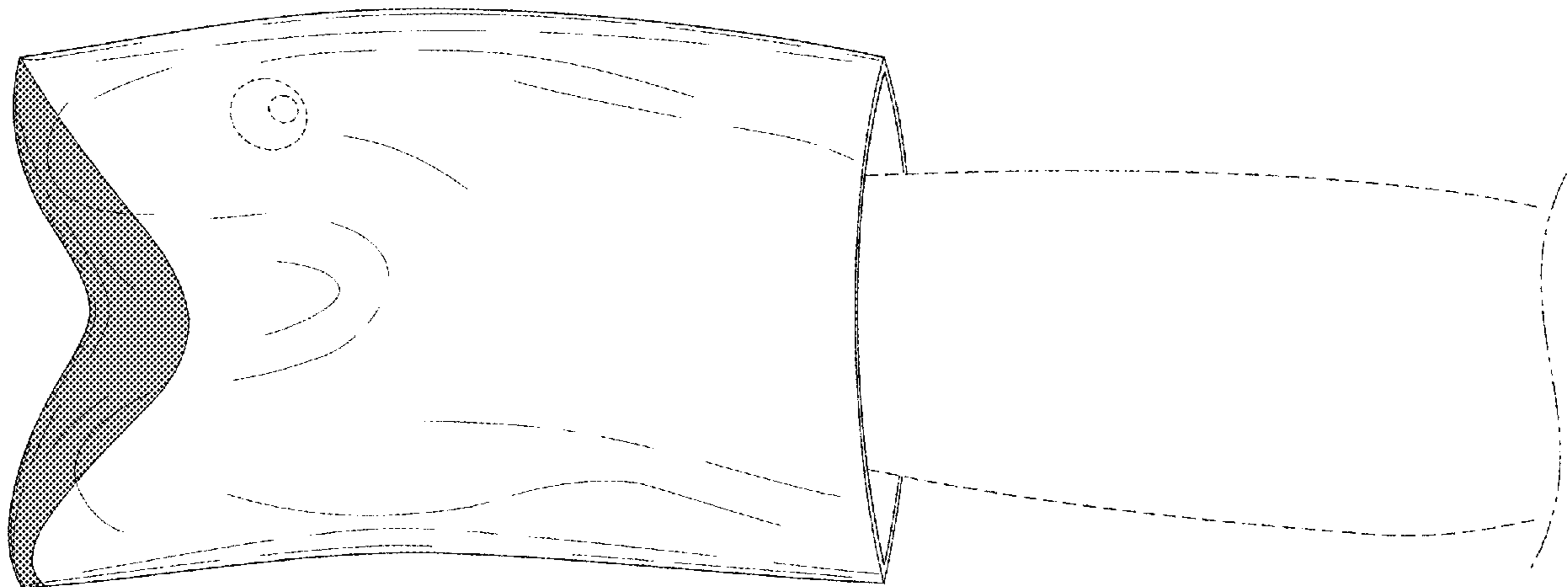

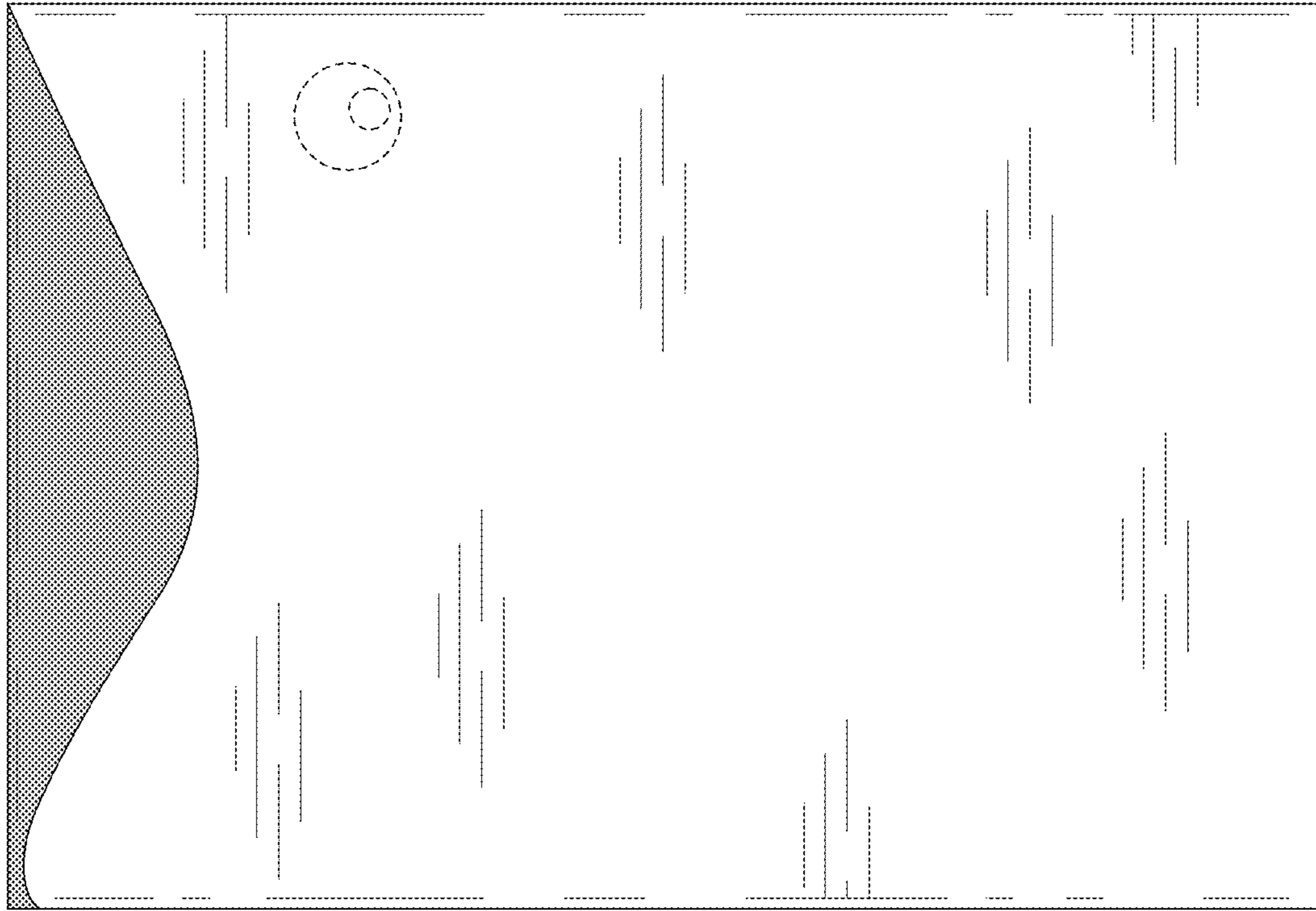
The ornamental design for a pet waste bag with mouth, as shown and described.

**DESCRIPTION**

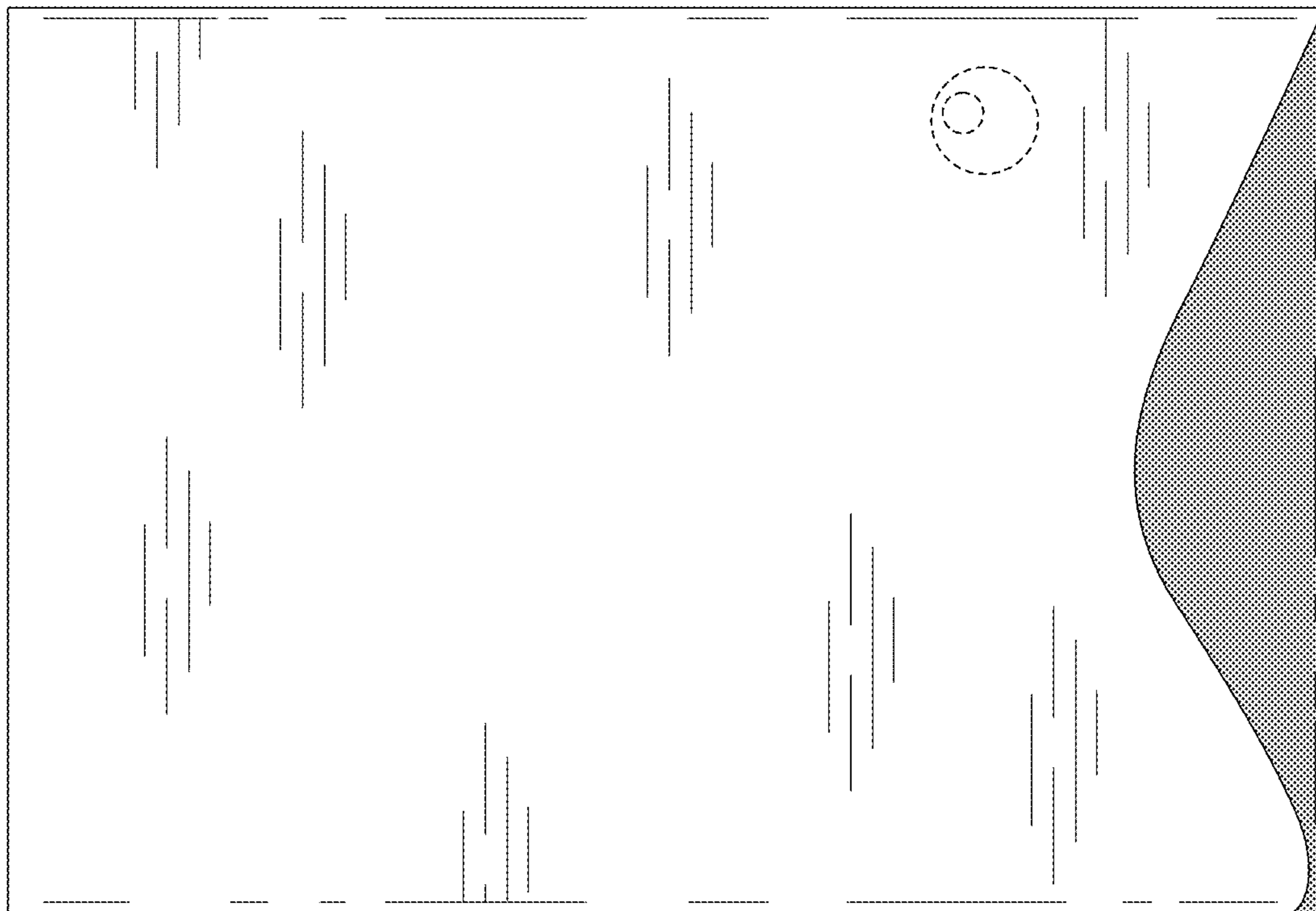
FIG. 1 is a left side view of my new pet waste bag with mouth design;

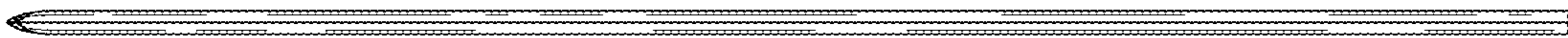

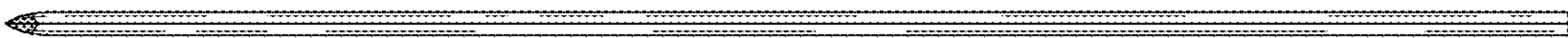

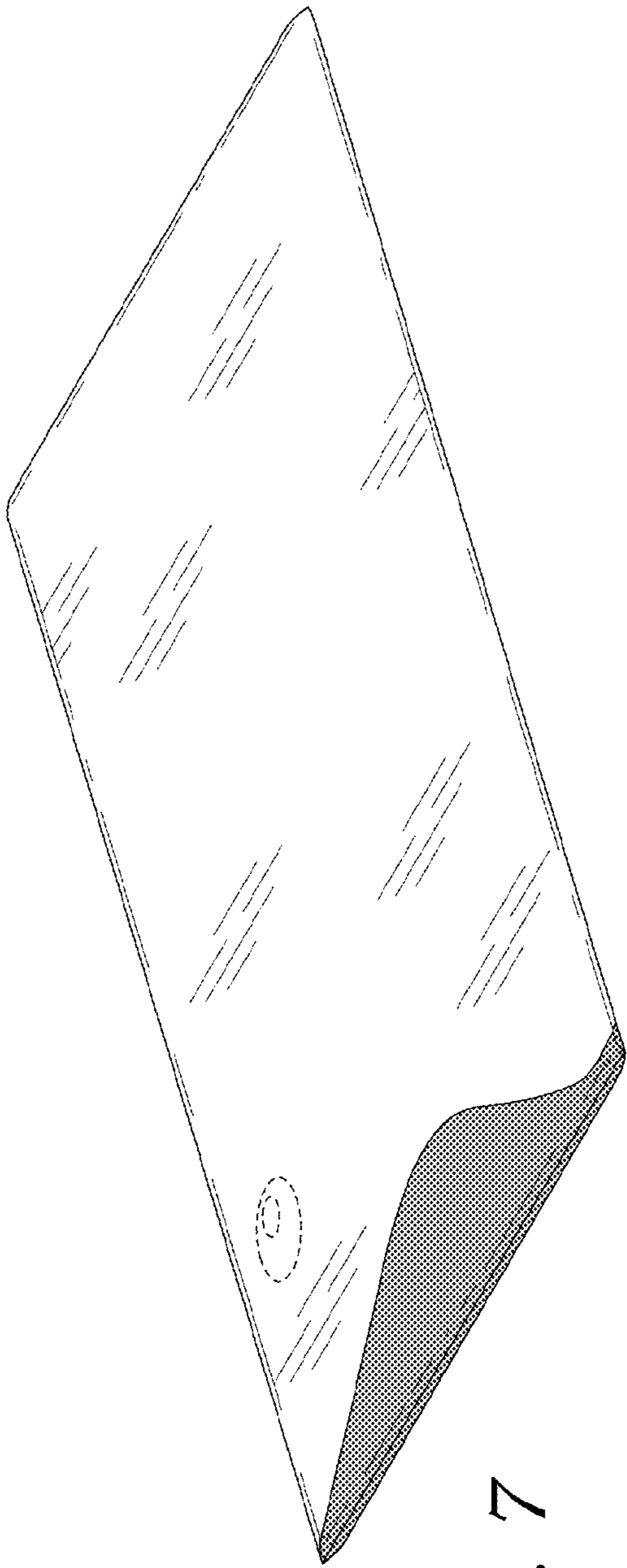

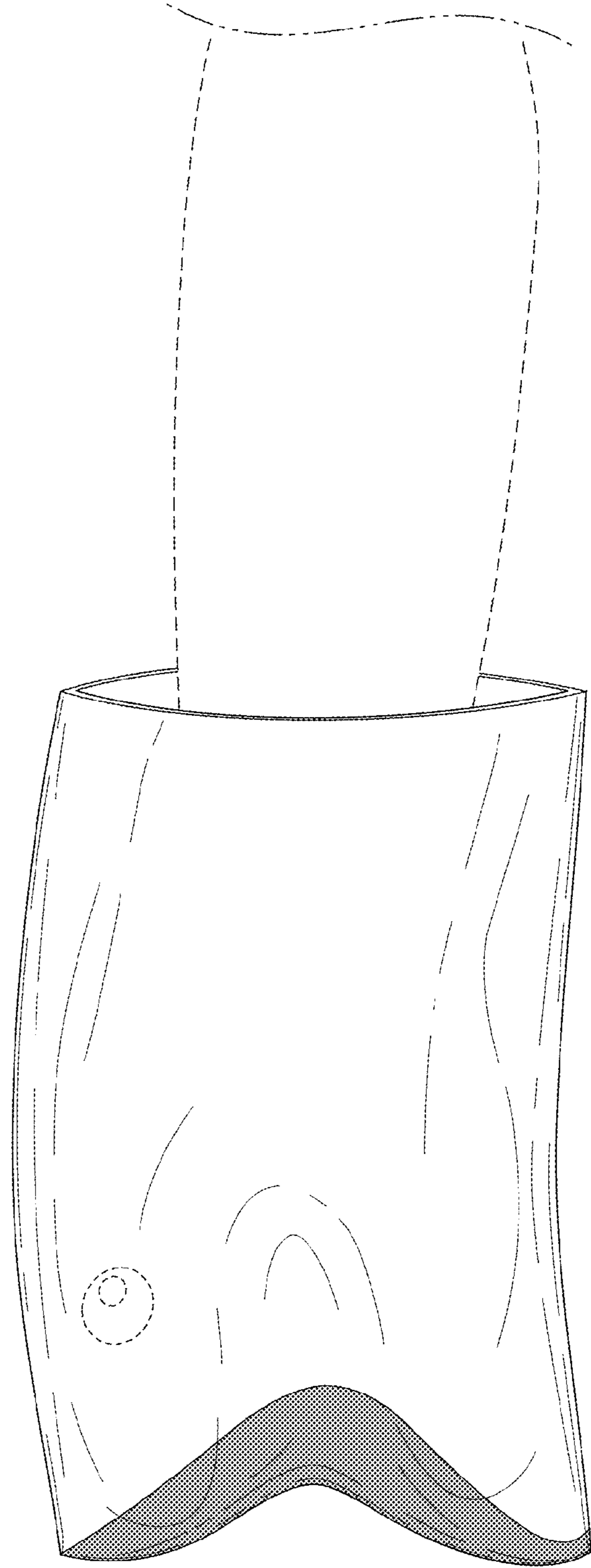
