The ornamental design for a glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a lower right front perspective view of a glove, showing our new design;  
FIG. 2 is a lower left front perspective view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a right side elevation view thereof; and,

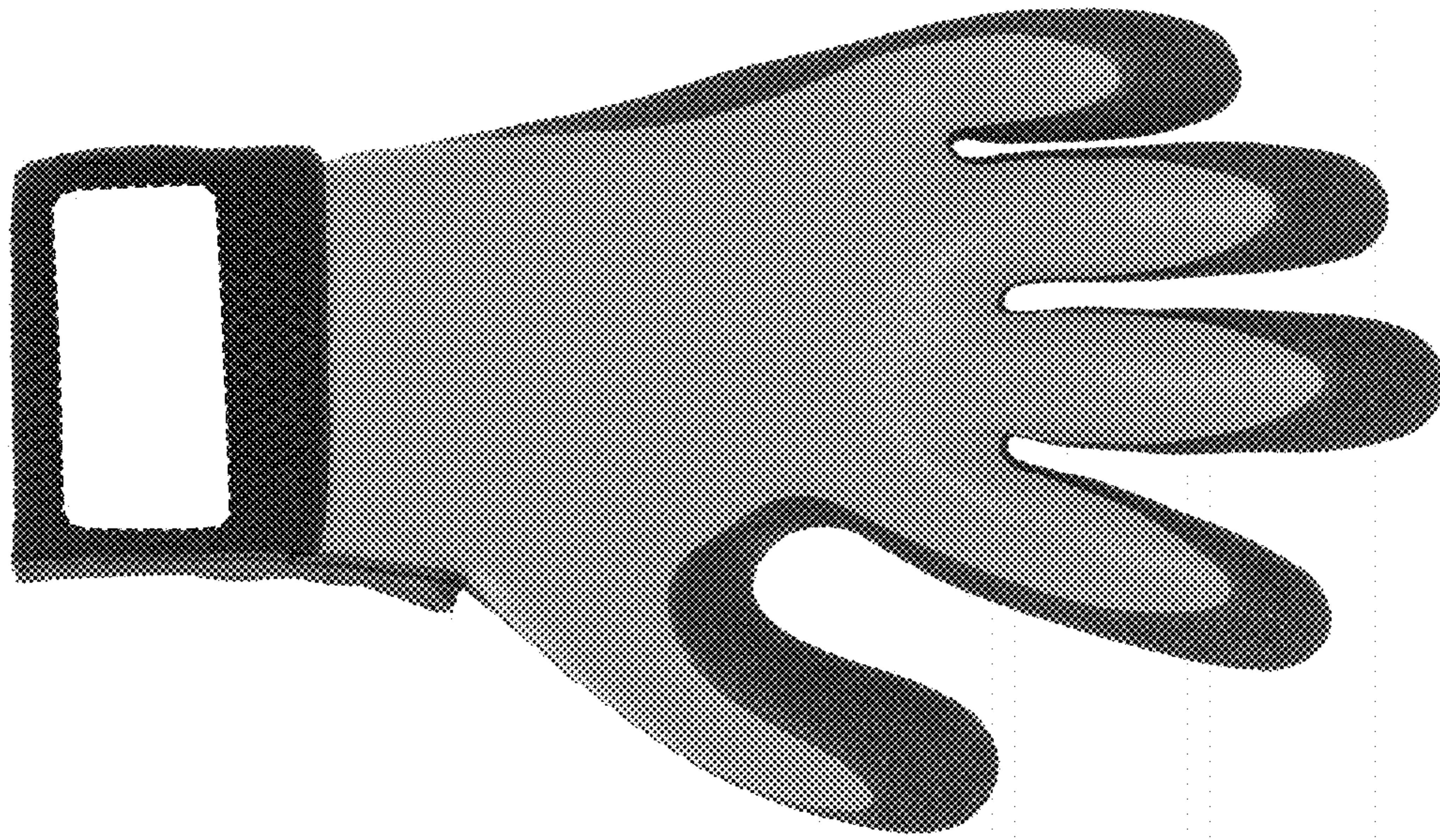

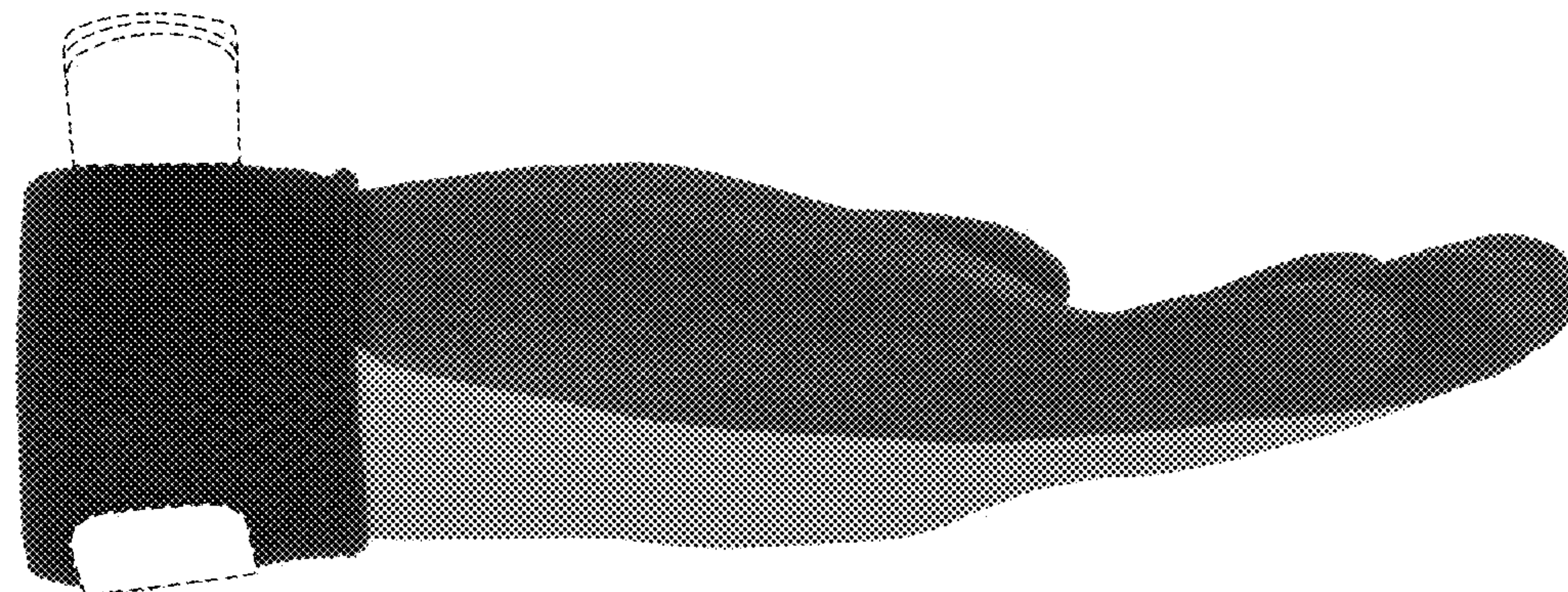

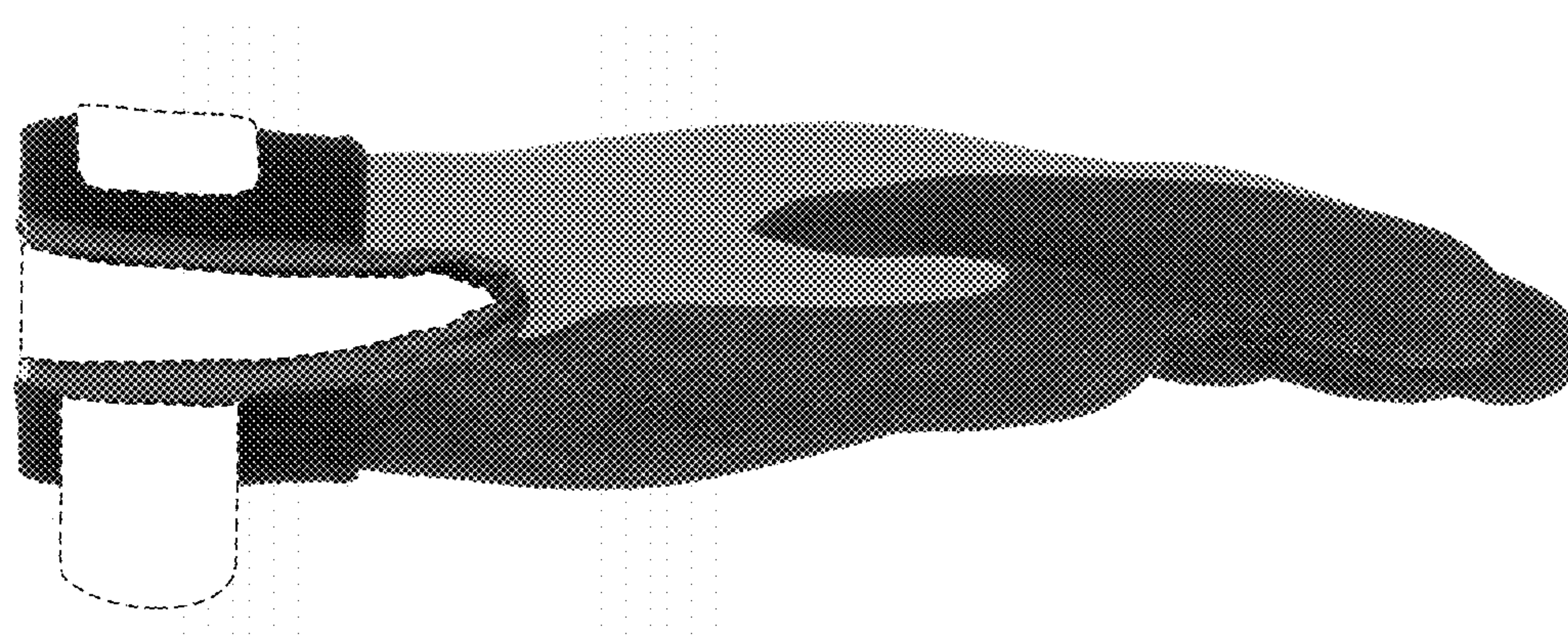

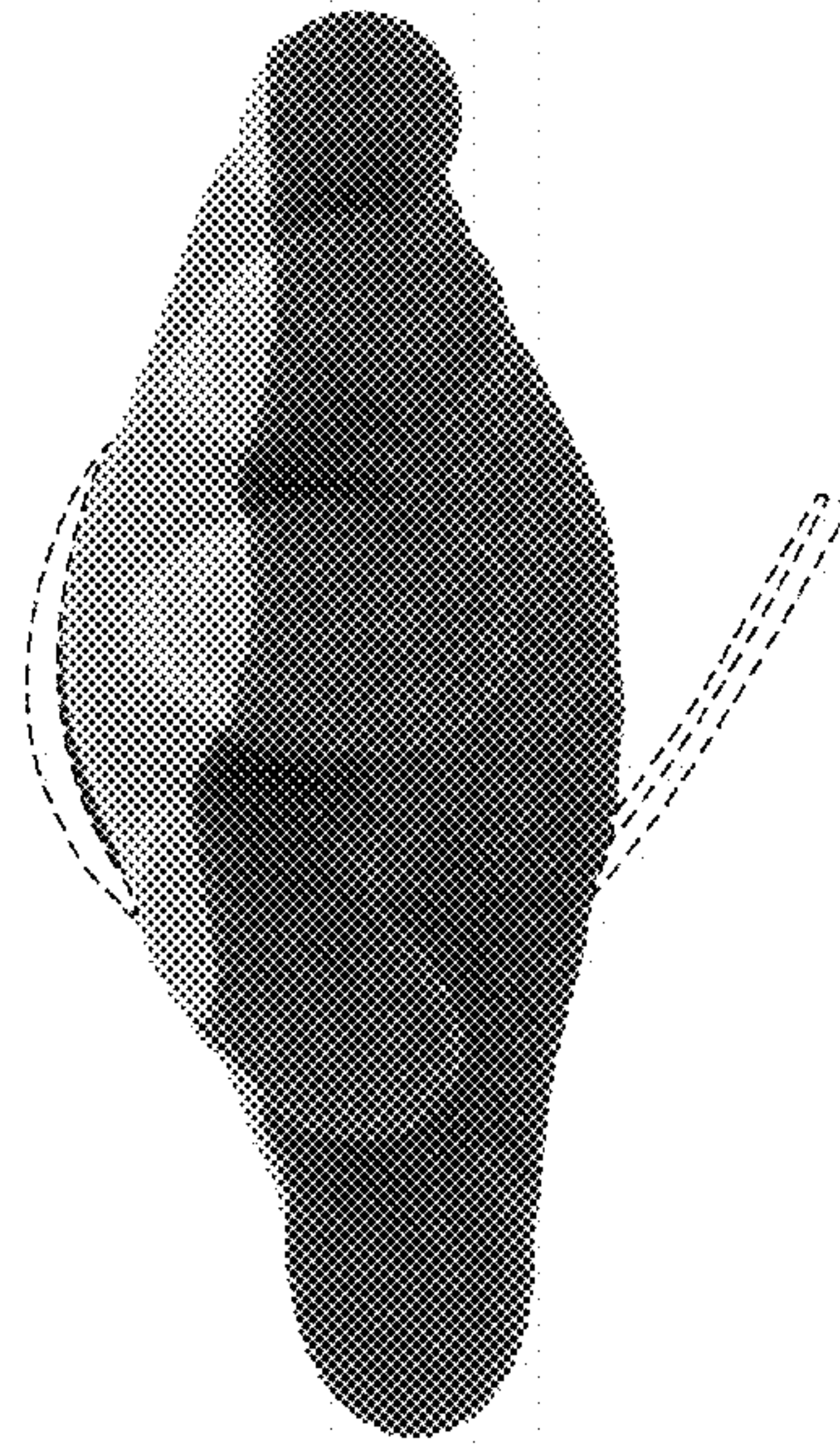




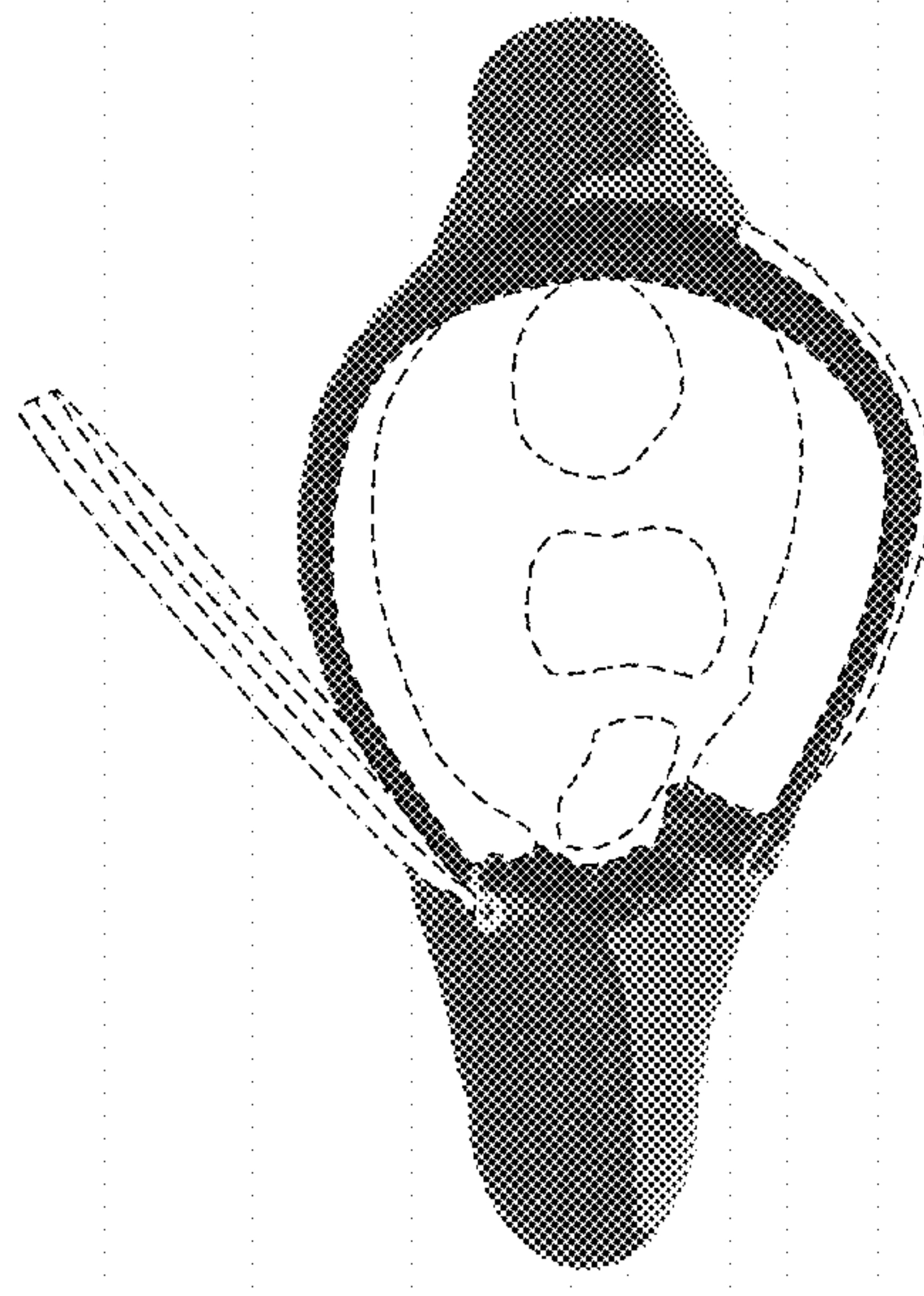
