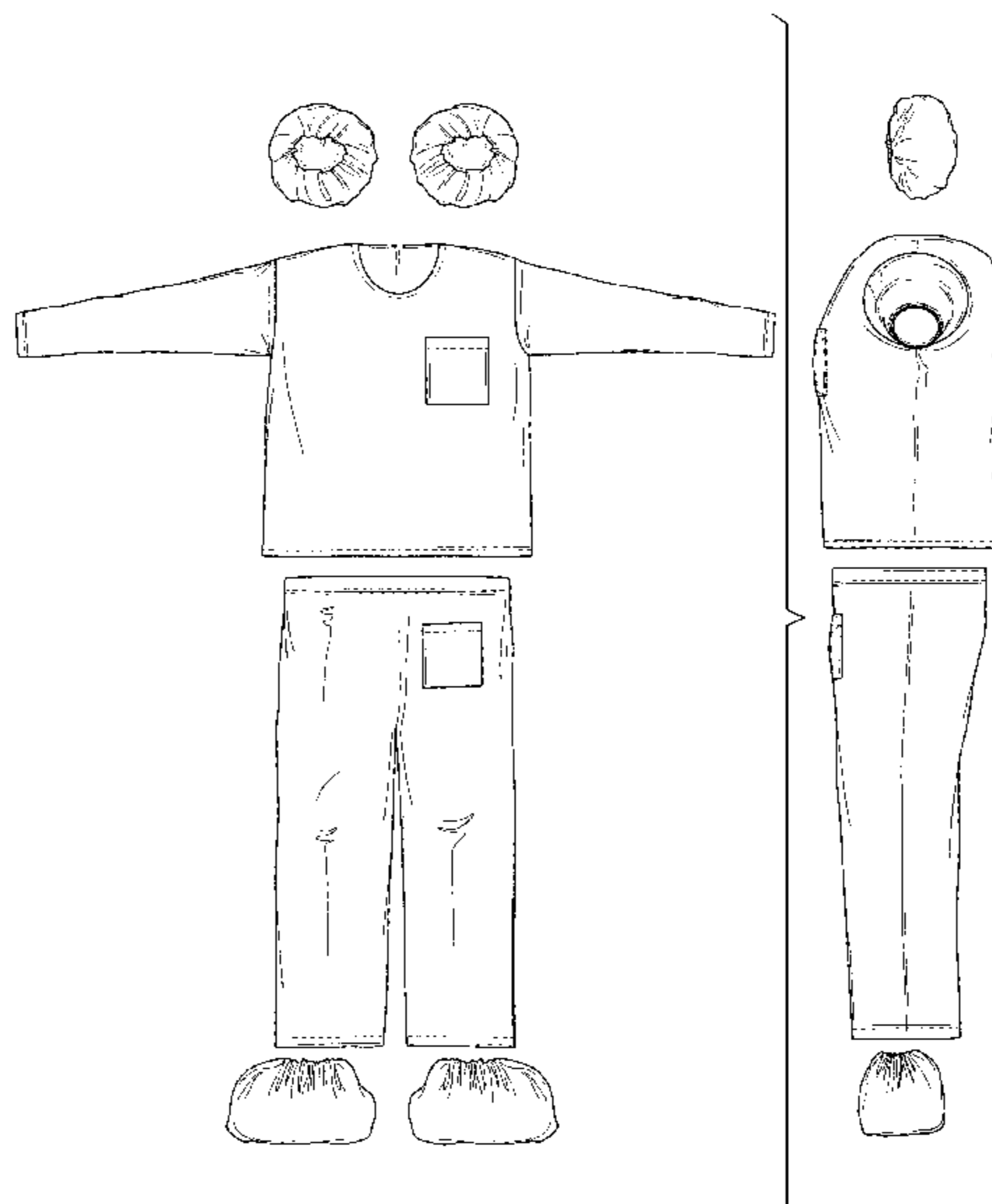
(57) **CLAIM**

We claim the ornamental design for a set of medical scrubs with longsleeves, as shown and described.

DESCRIPTION

FIG. 1 is an exploded perspective view of a set of medical scrubs with longsleeves, showing our new design; FIG. 2 is an exploded front elevational view of FIG. 1; FIG. 3 is an exploded rear elevational view of FIG. 1; FIG. 4 is an exploded right-side elevational view of FIG. 1; FIG. 5 is an exploded left-side elevational view of FIG. 1; FIG. 6 is an exploded top plan view of FIG. 1; and, FIG. 7 is an exploded bottom plan view of FIG. 1. The broken lines represent stitching, and are part of the claimed design.

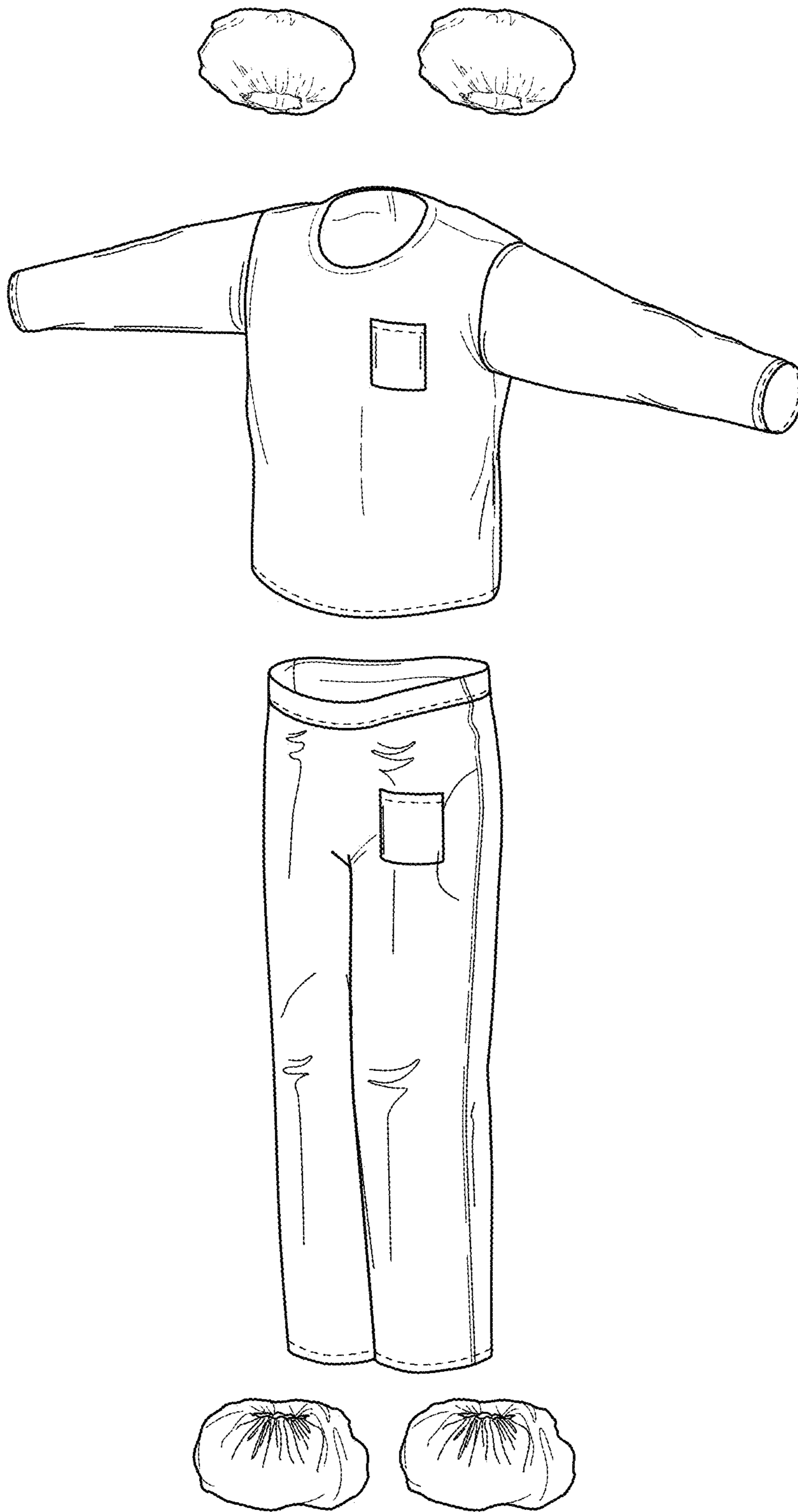

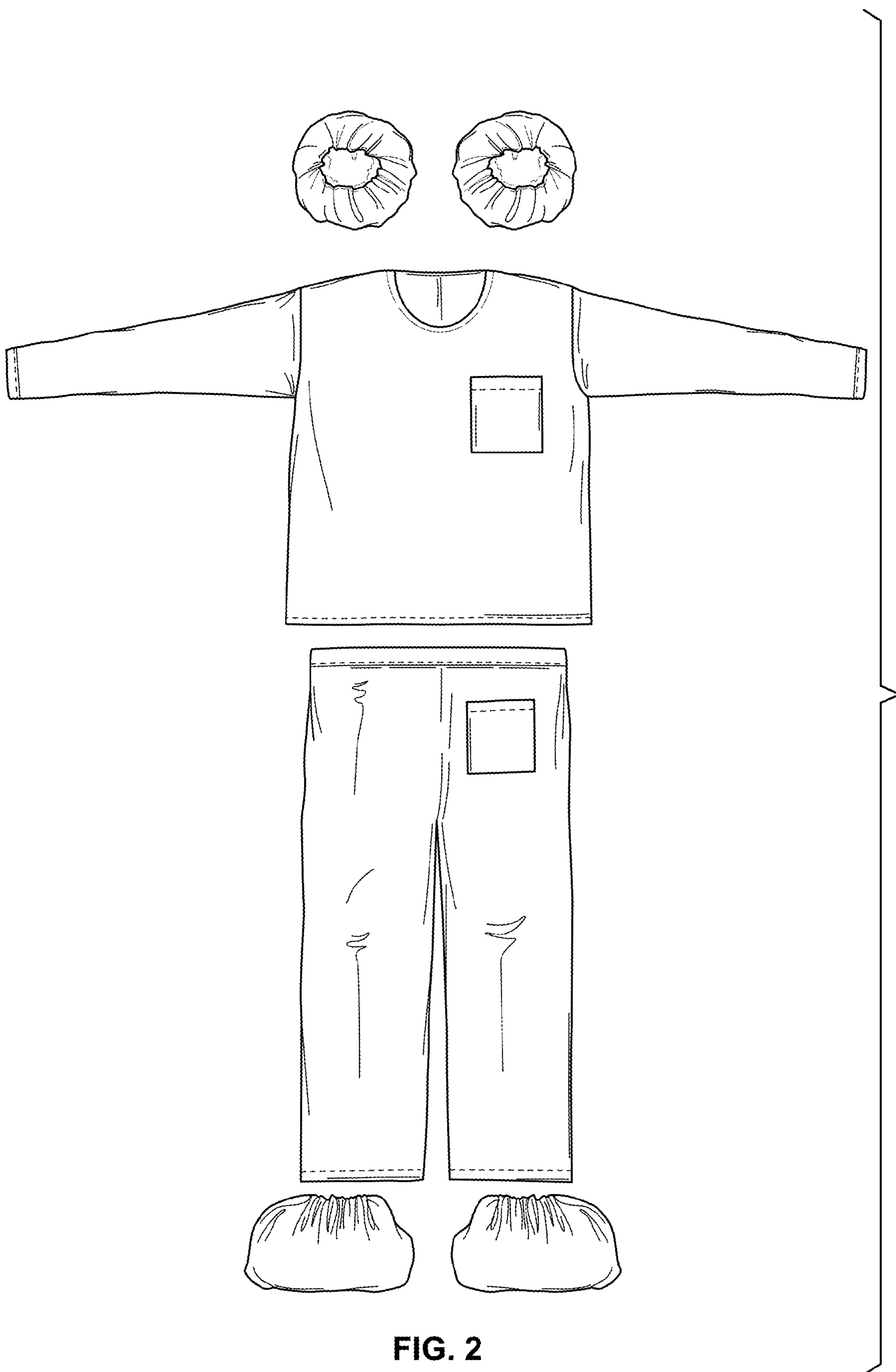

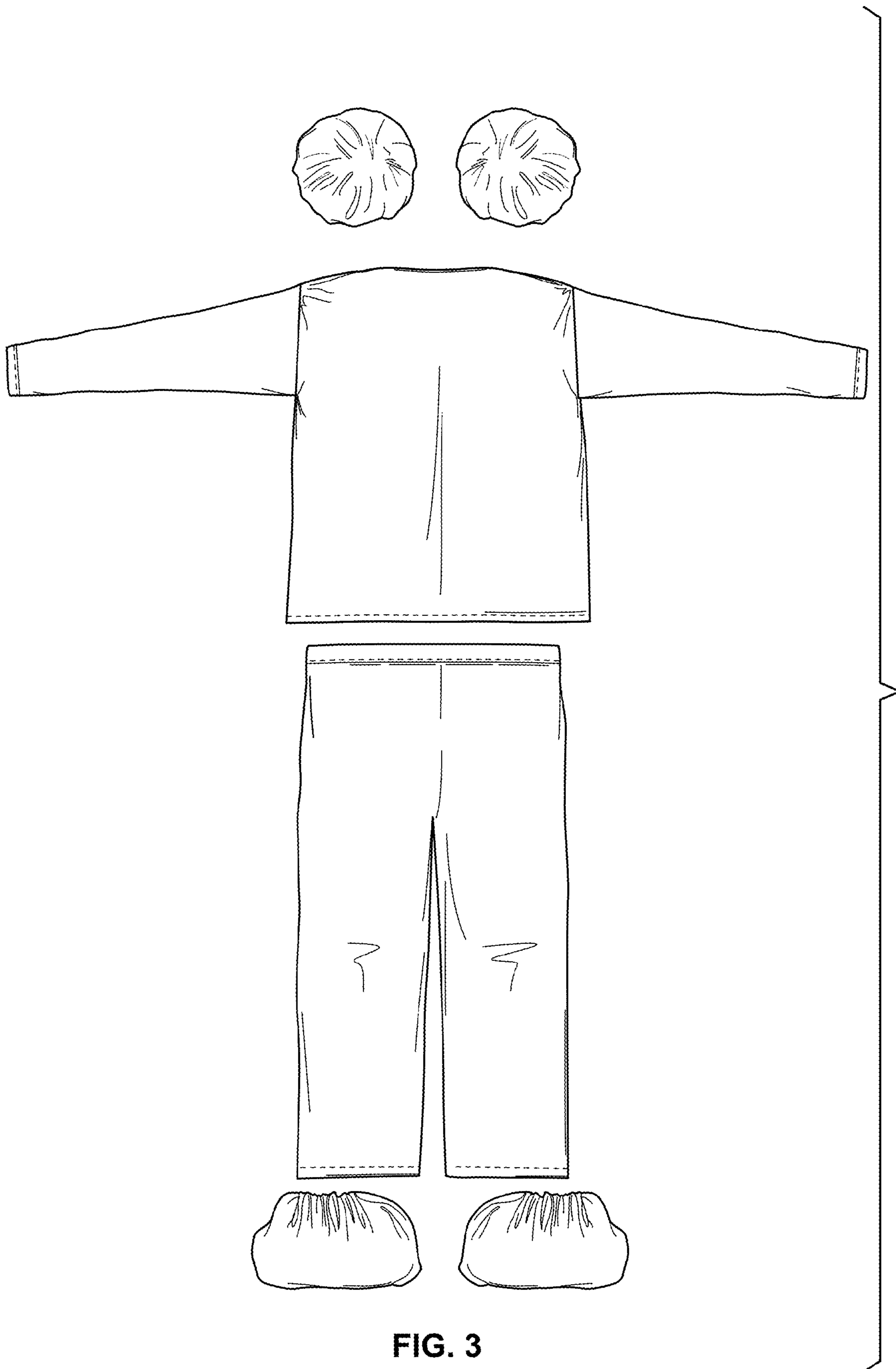

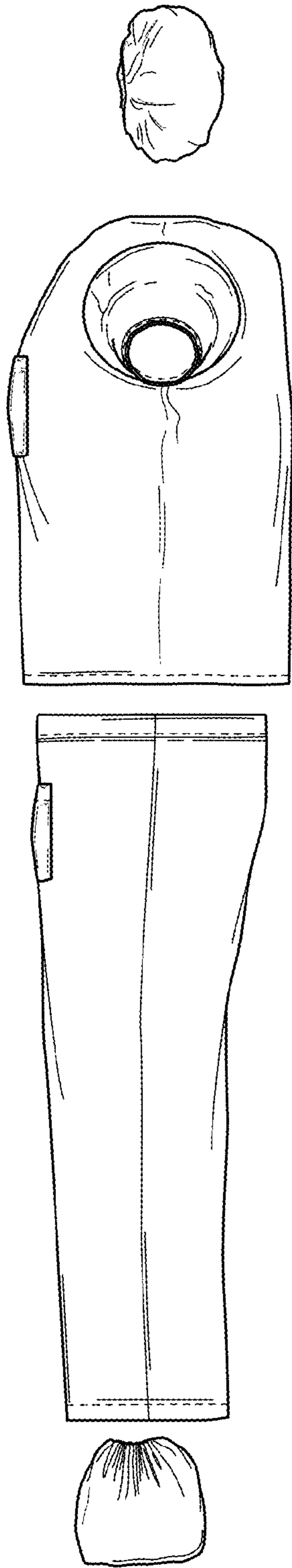

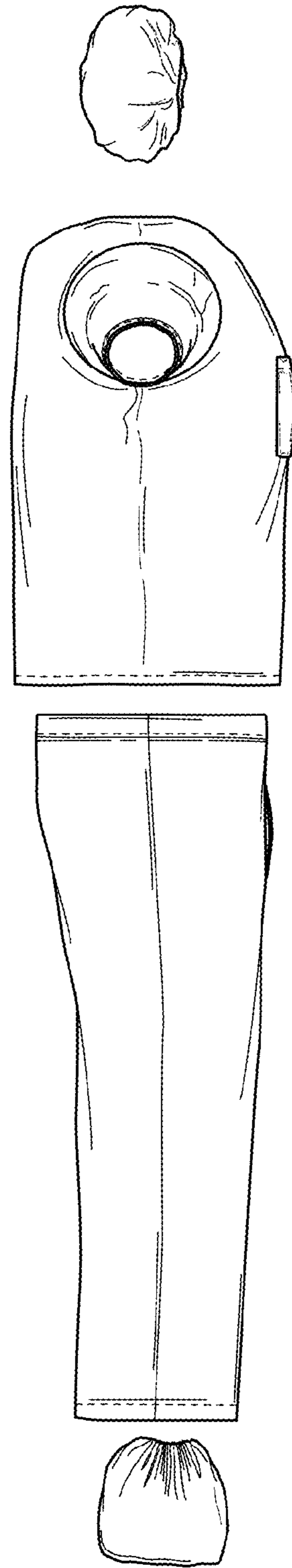

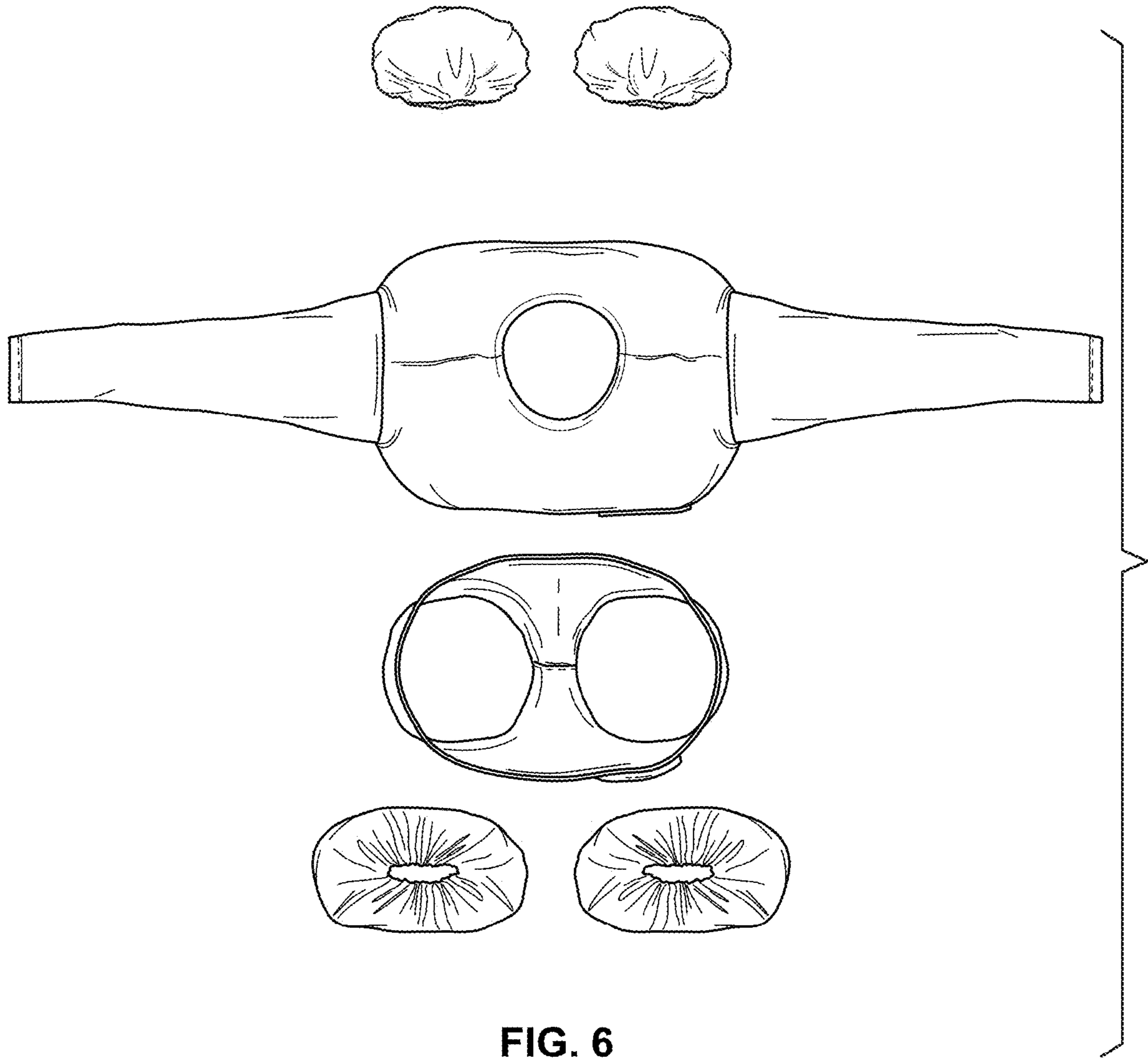

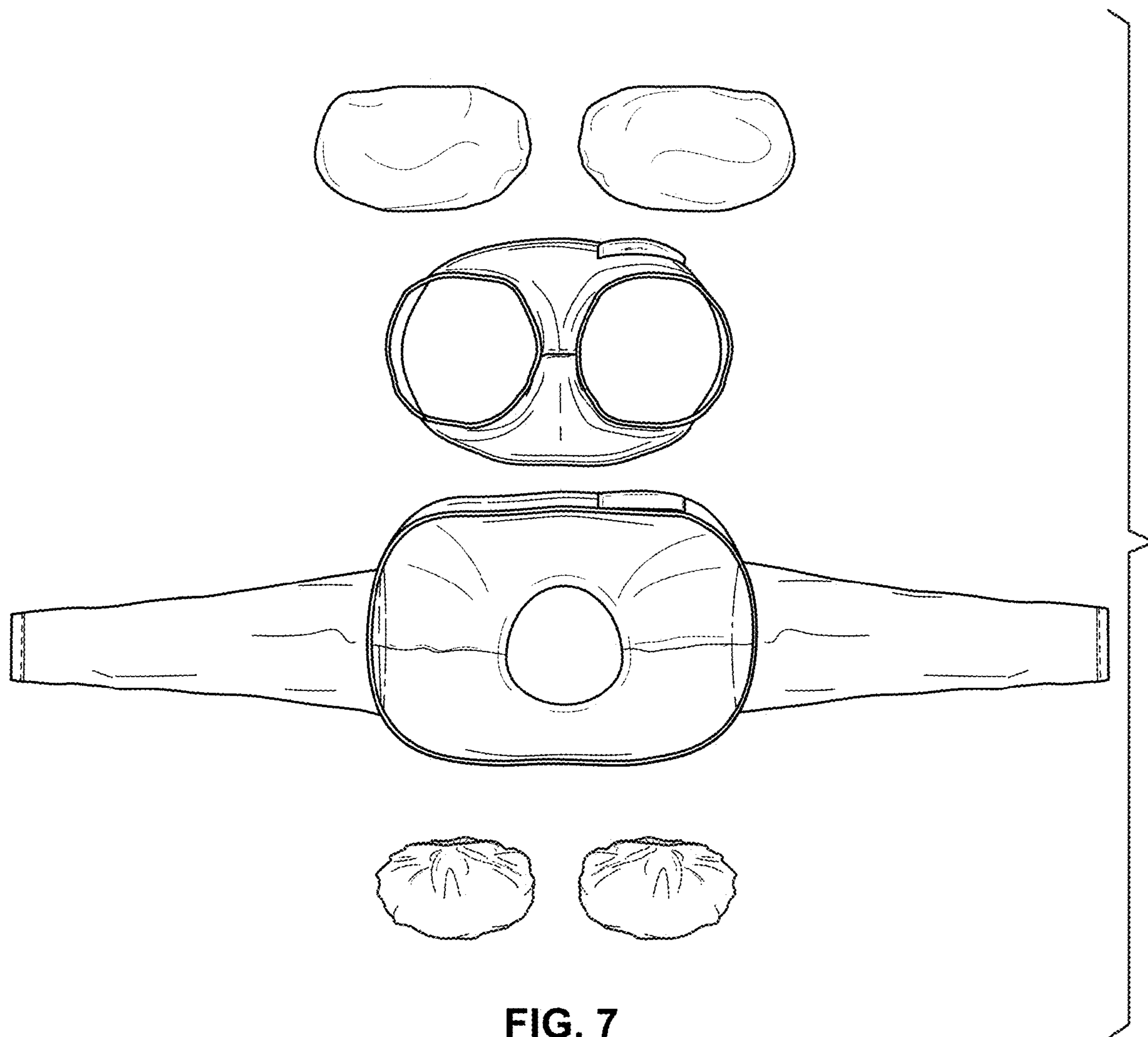
