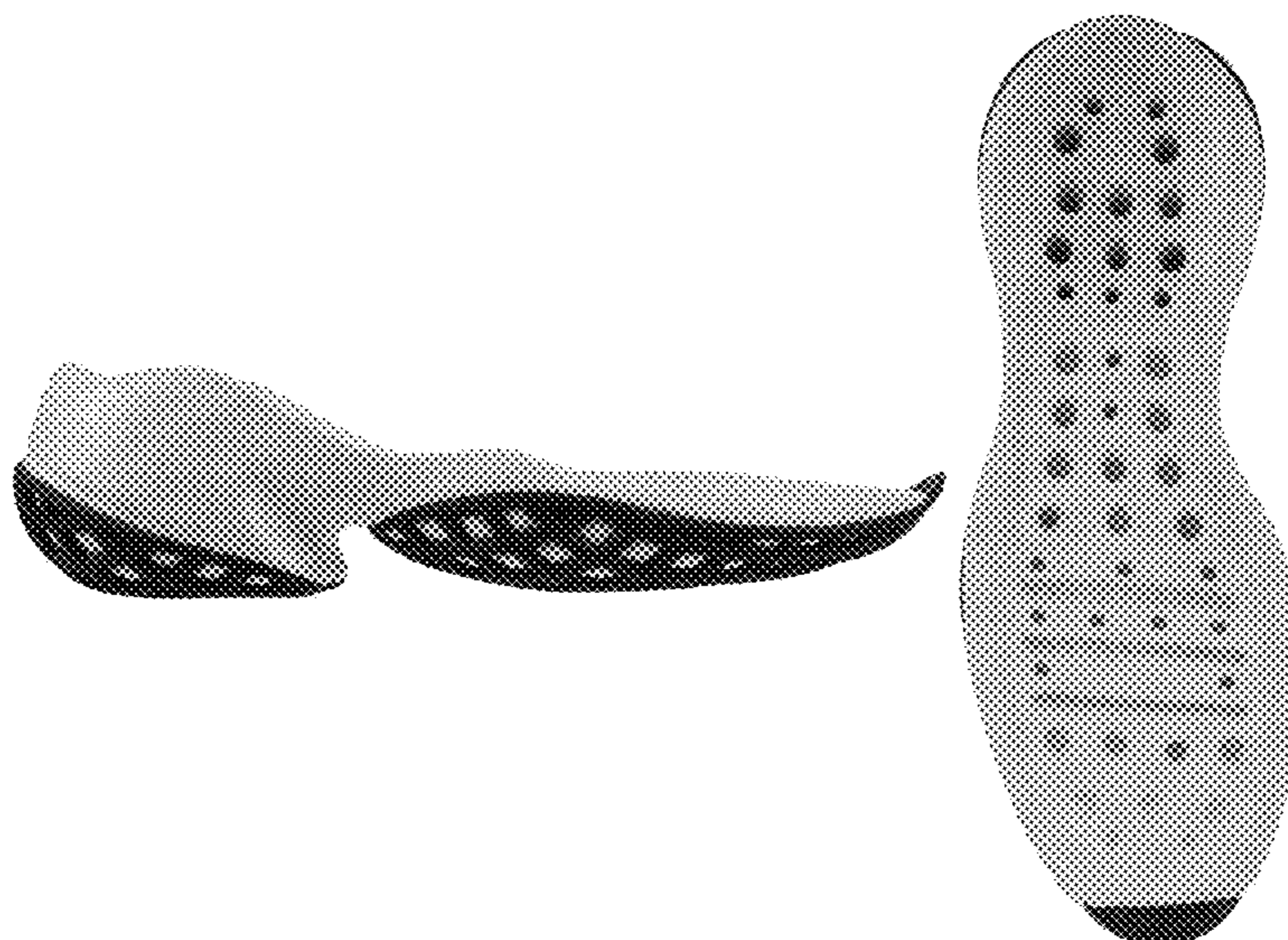

The ornamental design for a shoe sole, as shown and described.

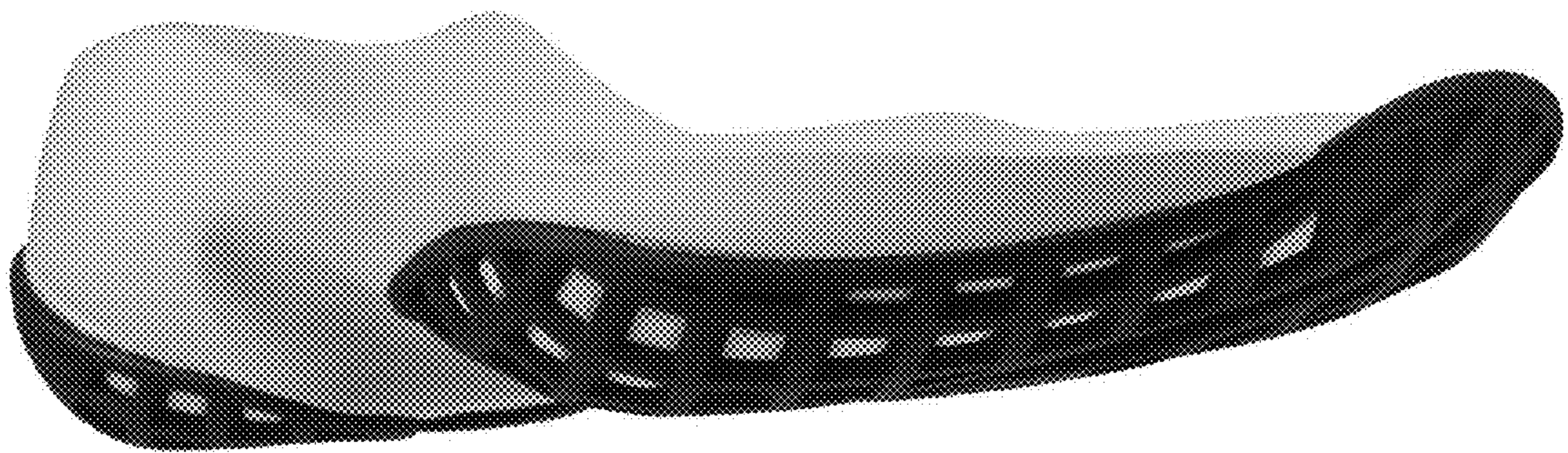
**DESCRIPTION**

- 1.7 is a bottom view thereof.

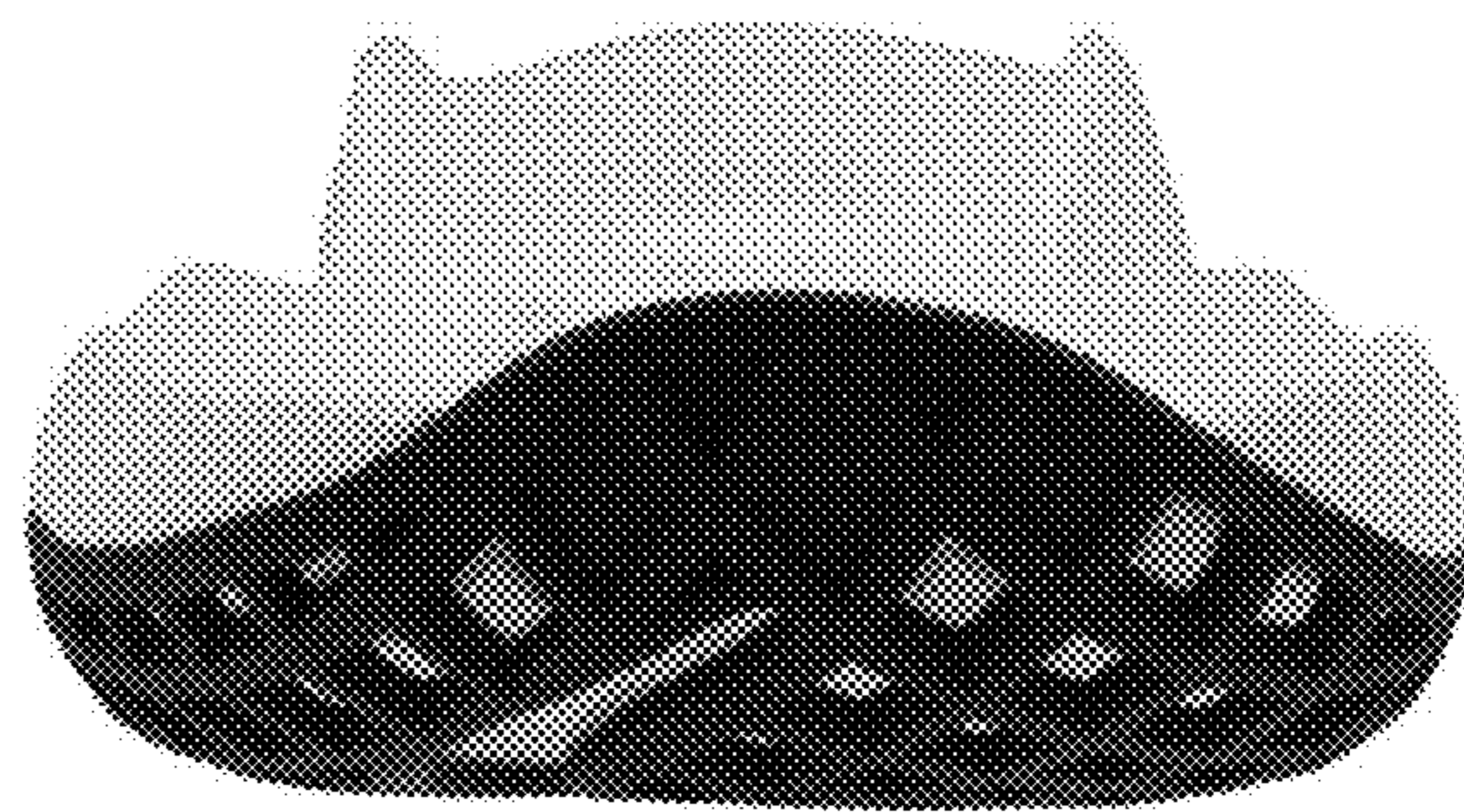

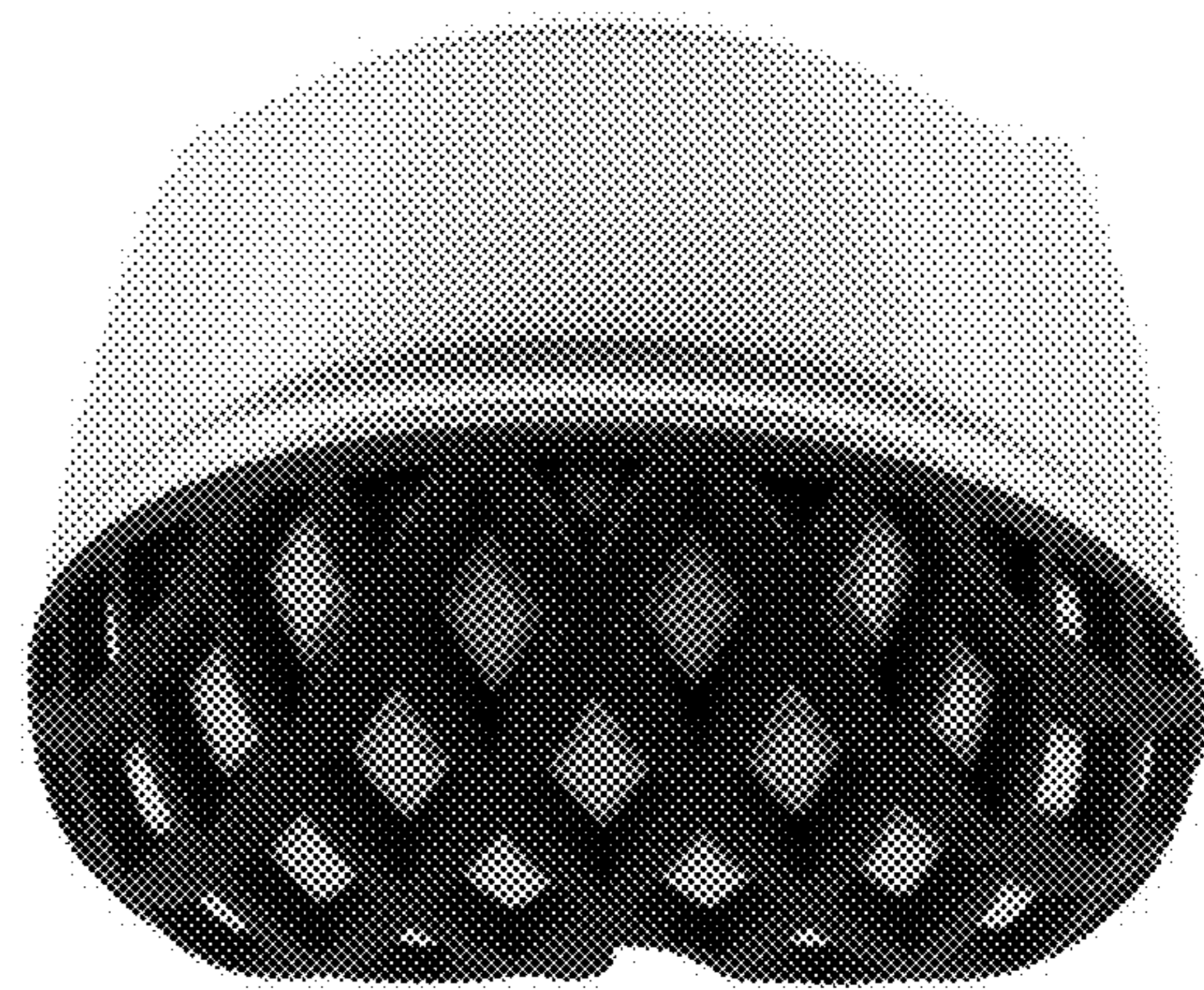

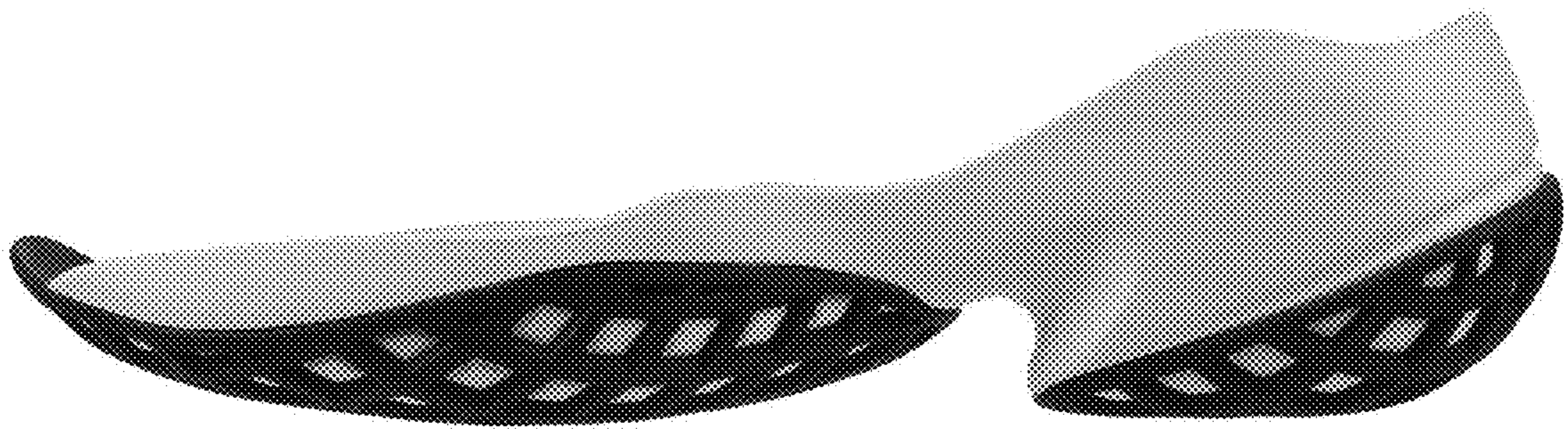

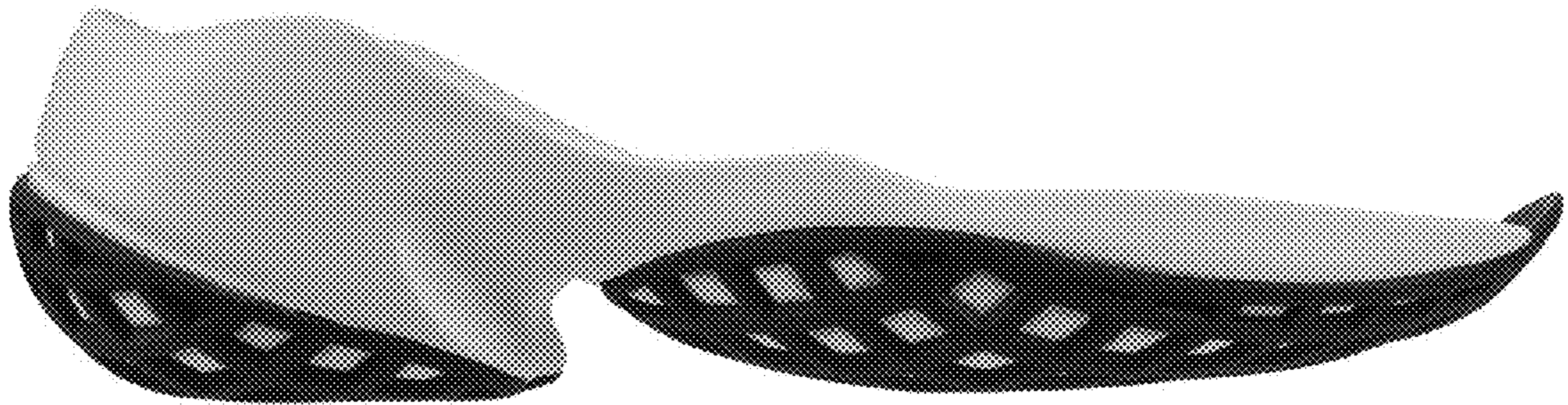

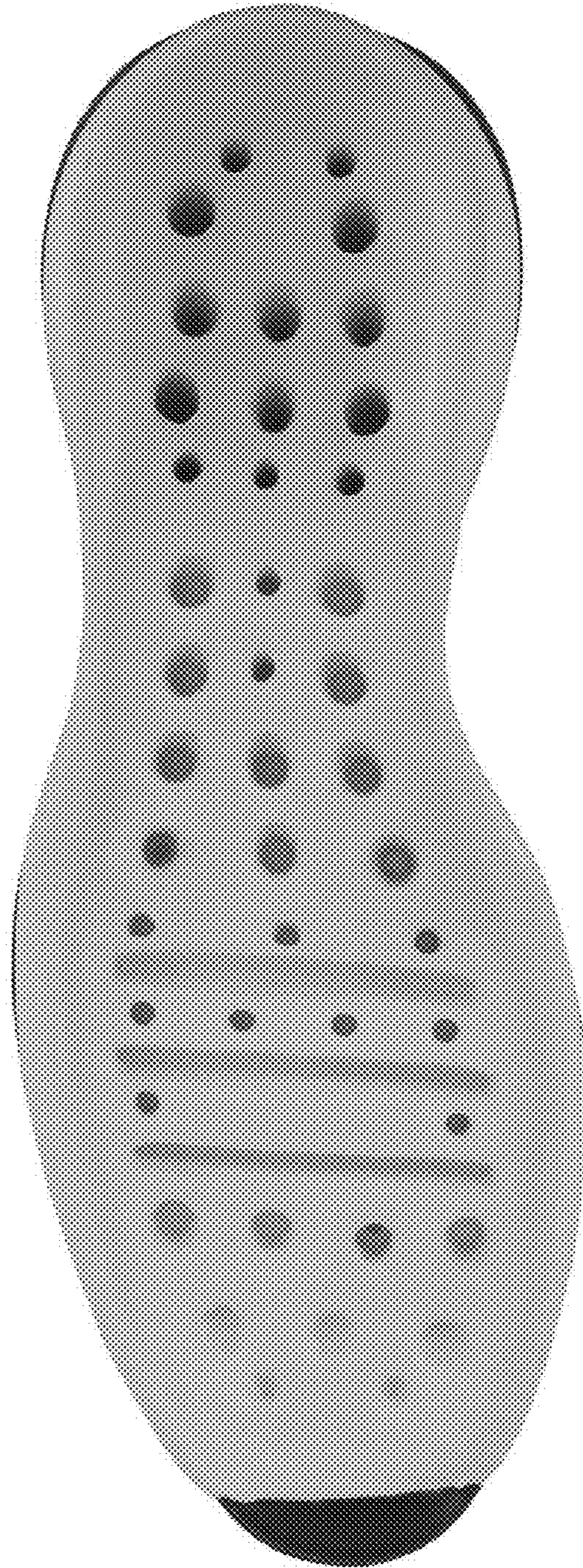
