(57) **CLAIM**

The ornamental design for a shoelace, as shown and described.

DESCRIPTION

2.-3. Shoelaces
2.1 is a front side elevational view of a first embodiment of a shoelace showing my new design;
2.2 is a back side elevational view thereof;
2.3 is a right side elevational view thereof;
2.4 is a top plan view thereof;
2.5 is an enlarged sectional view taken from the left side of the shoelace shown in **2.1**;
2.6 is an enlarged sectional view taken from the right side of the shoelace shown in **2.1**;
2.7 is an enlarged view of FIG. **2.3**;
3.1 is a front side elevational view of a second embodiment of a shoelace showing my new design;
3.2 is a back side elevational view thereof
3.3 is a right side elevational view thereof;
3.4 is a top plan view thereof;
3.5 is an enlarged sectional view taken from the right side of the shoelace shown in **3.1**; and
3.6 is an enlarged view of FIG. **3.3**.

The articles to the subject designs (hereinafter referred to as the articles) of the present application for designs registration are shoelaces mainly for sneakers; each article illustrated in the drawings have a length of about 120 cm and a width of about 0.8 cm; the grayed part does not represent any particular color, material or texture but show contrast; the left side view is omitted as it appears the same as the right side view; the bottom view is omitted as it appears the same as the top plan view.

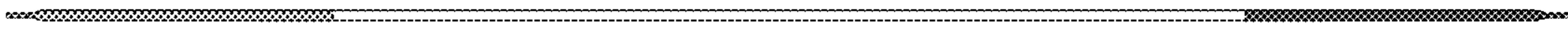

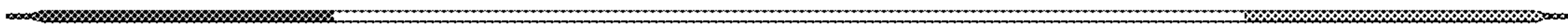

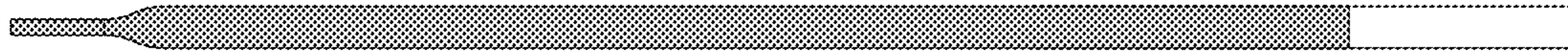

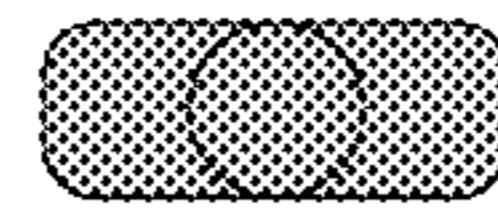

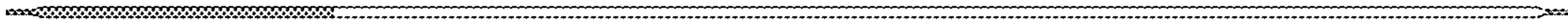

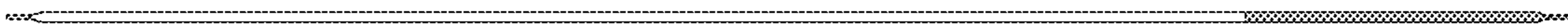
