DESCRIPTION

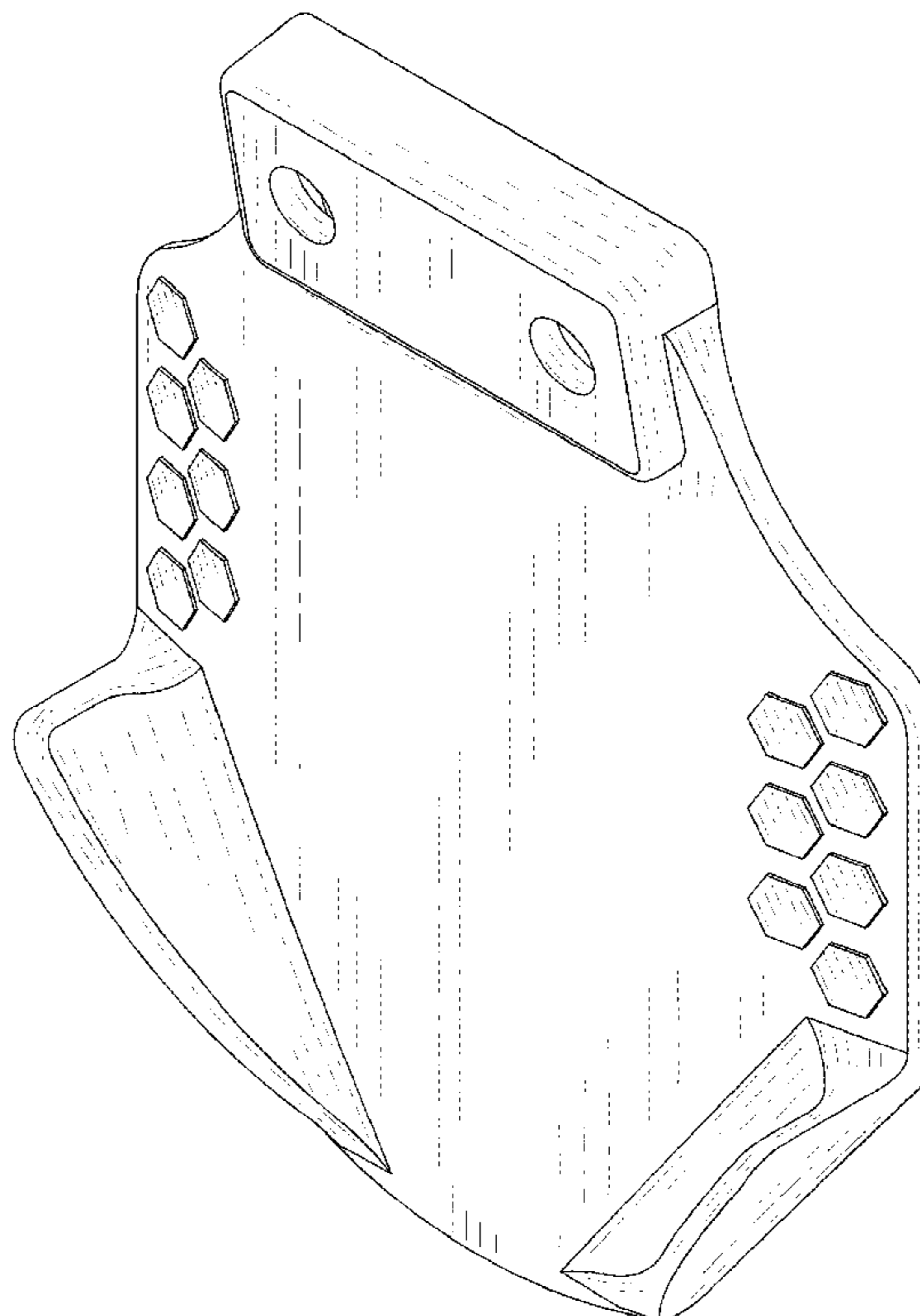
FIG. 1 is a top front perspective view of a paddle attachment showing my new design;

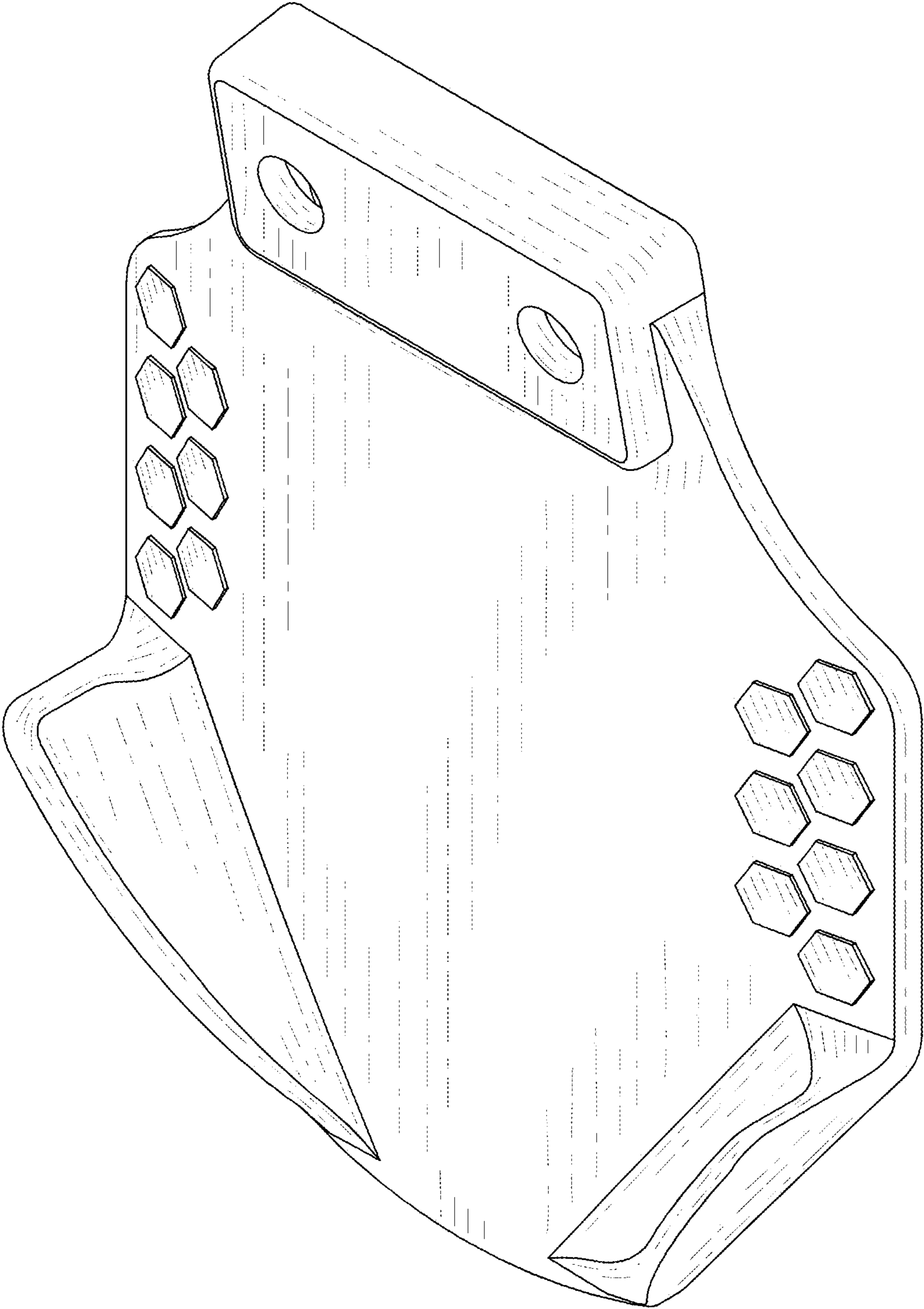

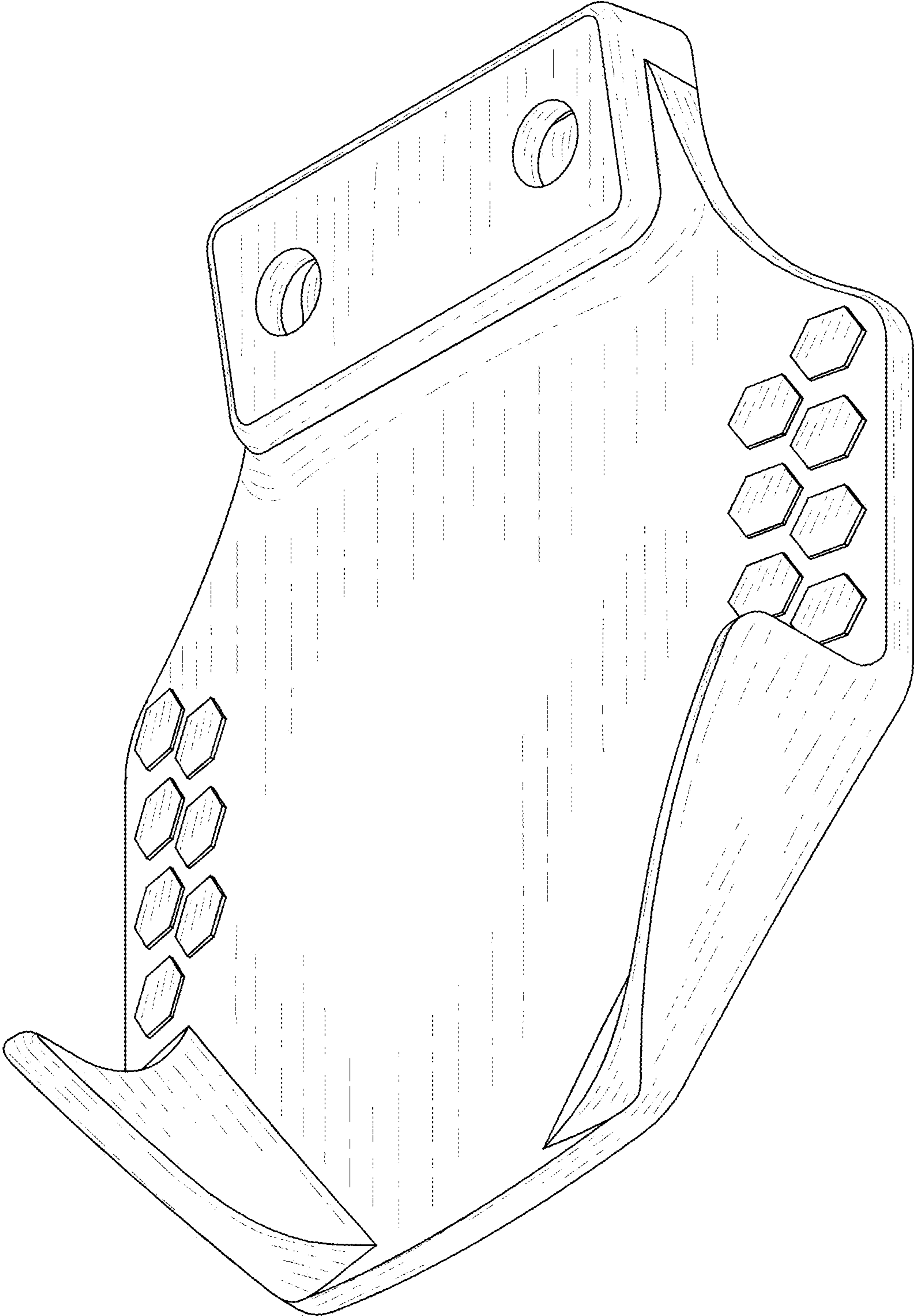

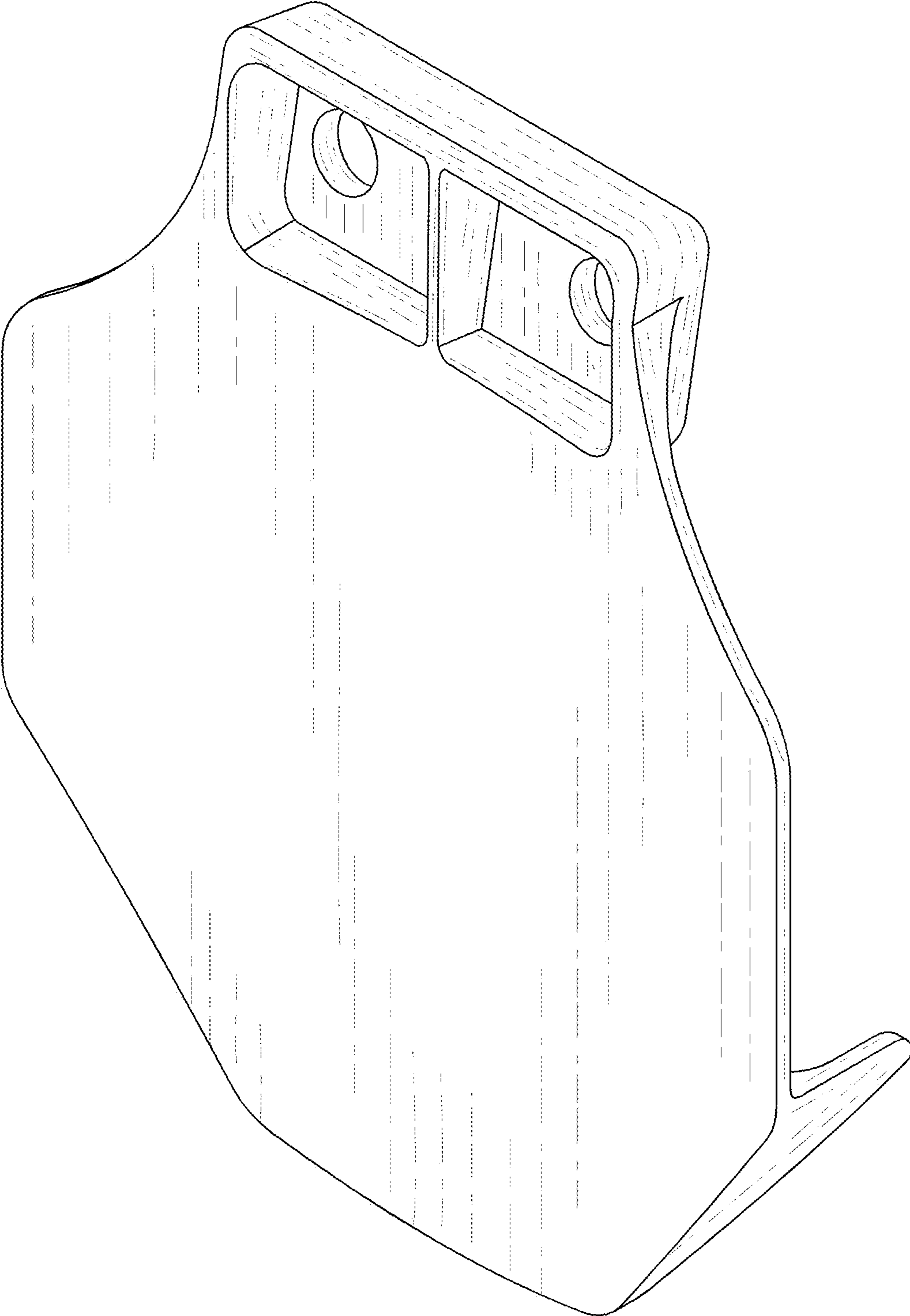

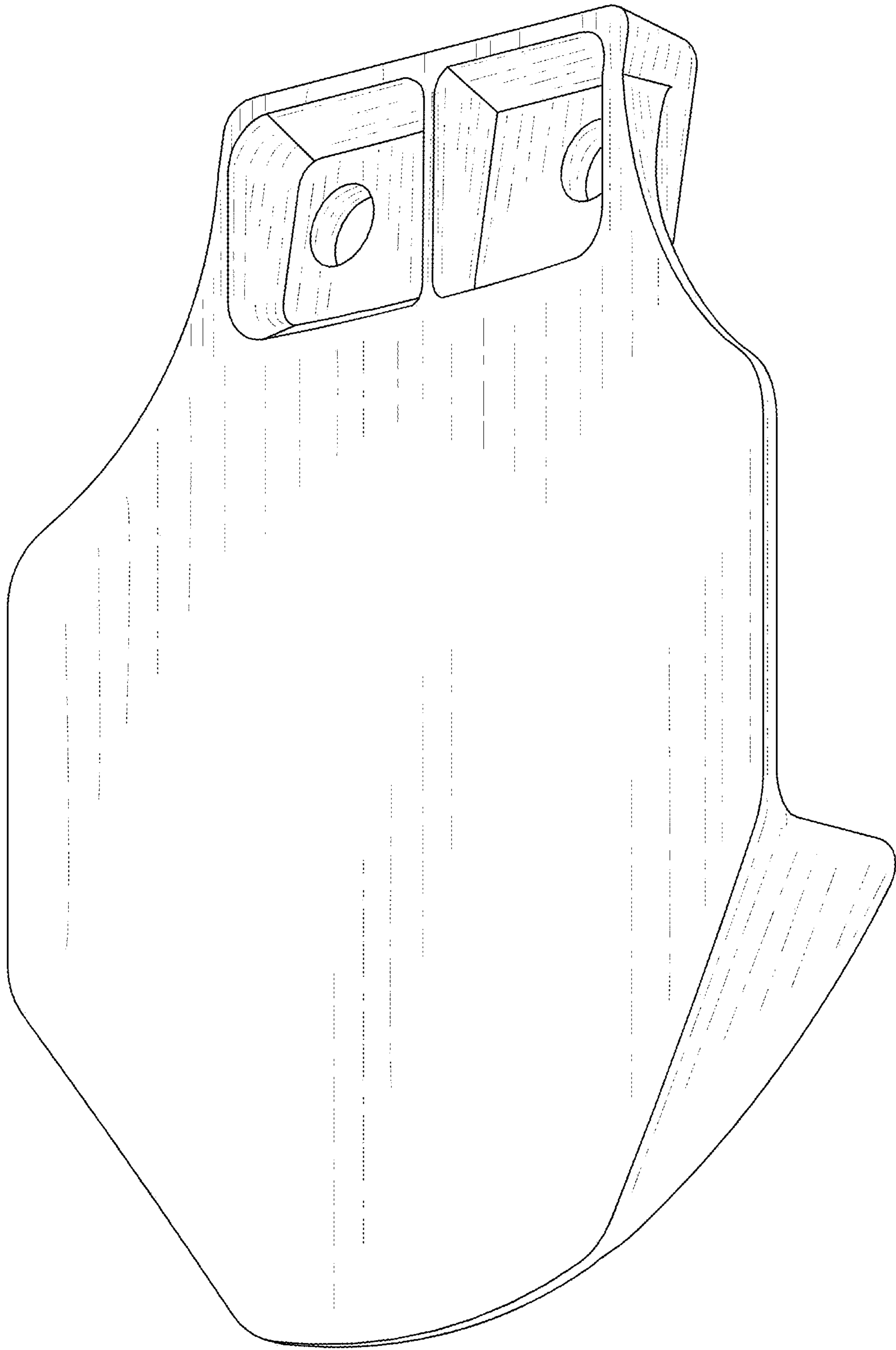

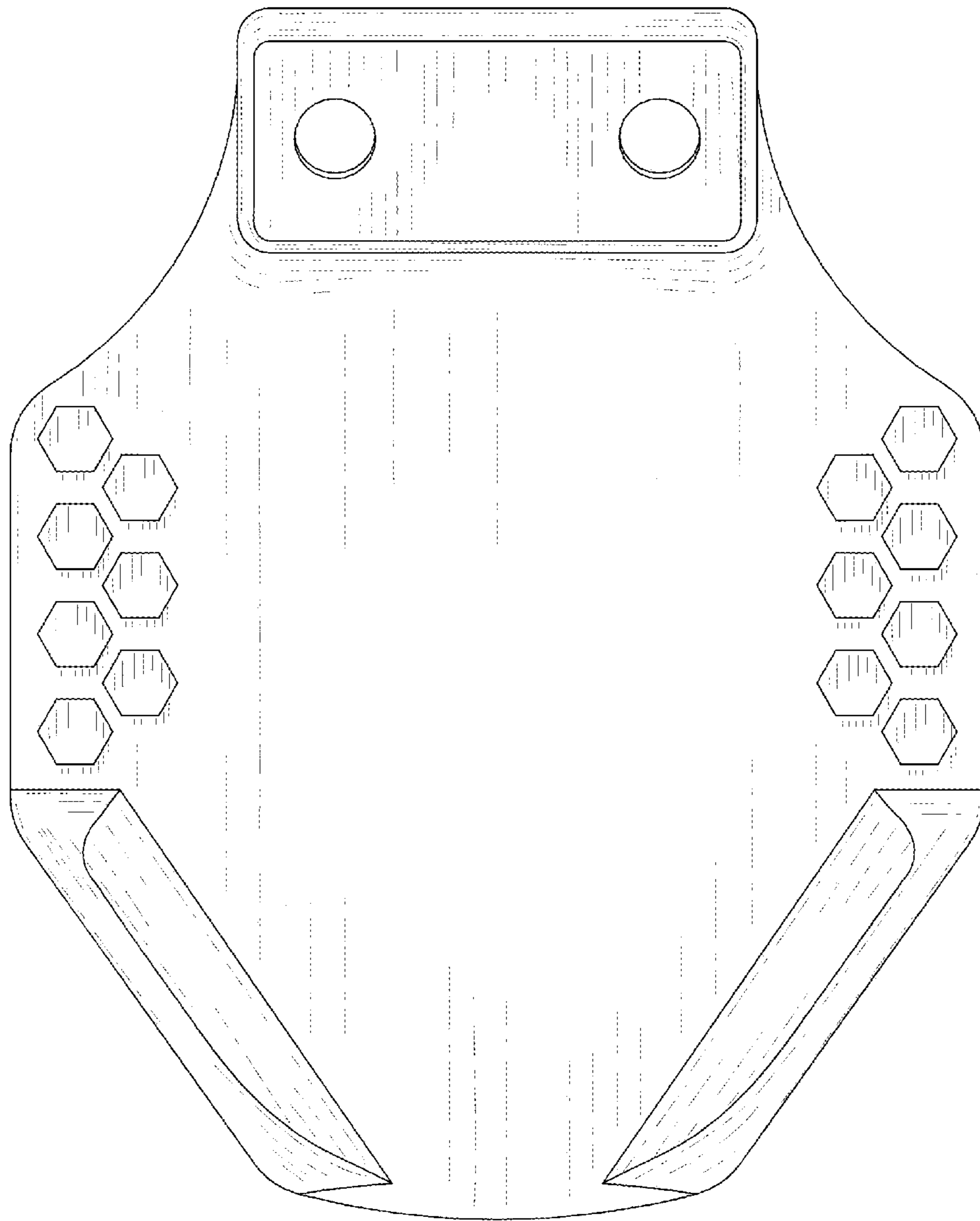

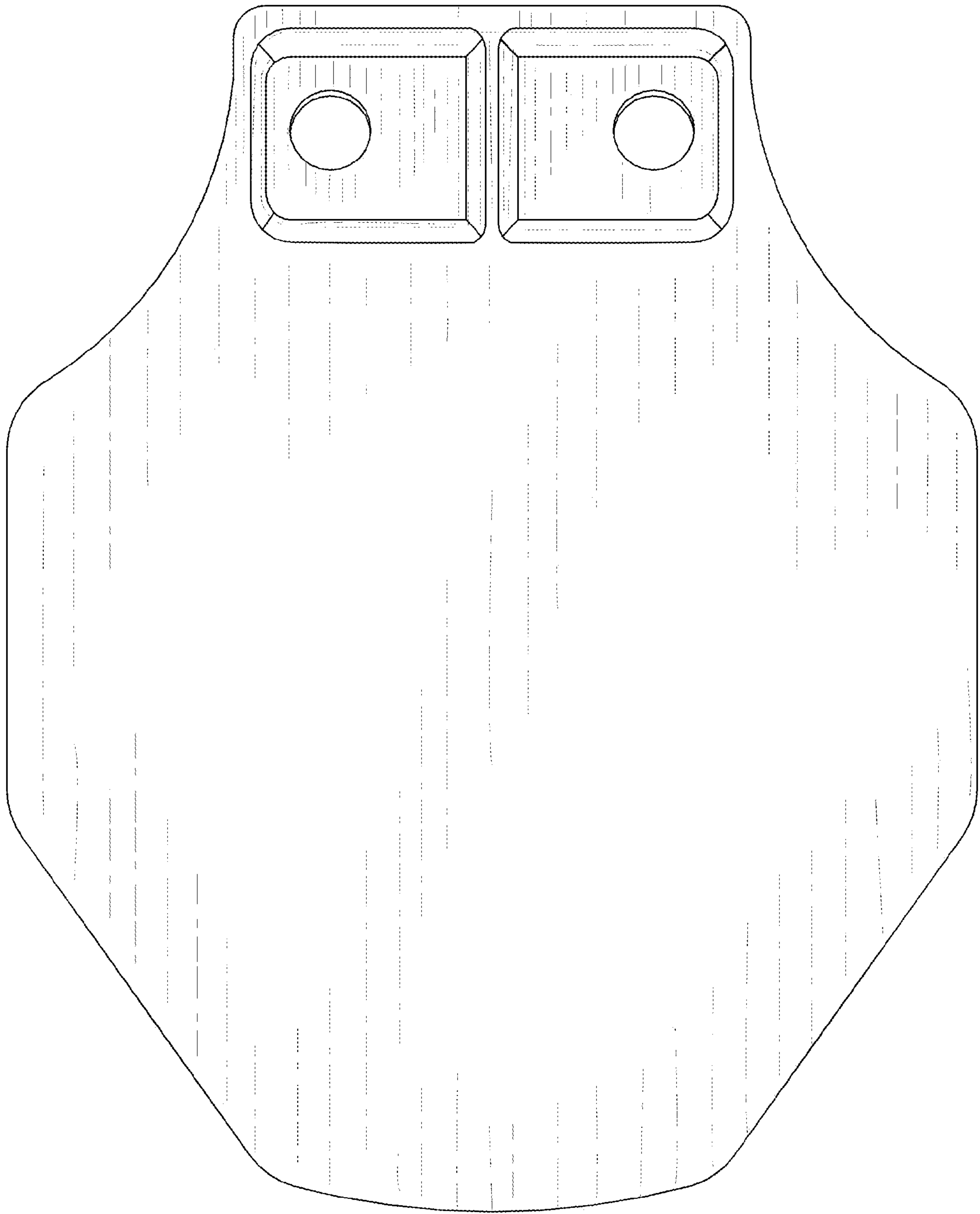

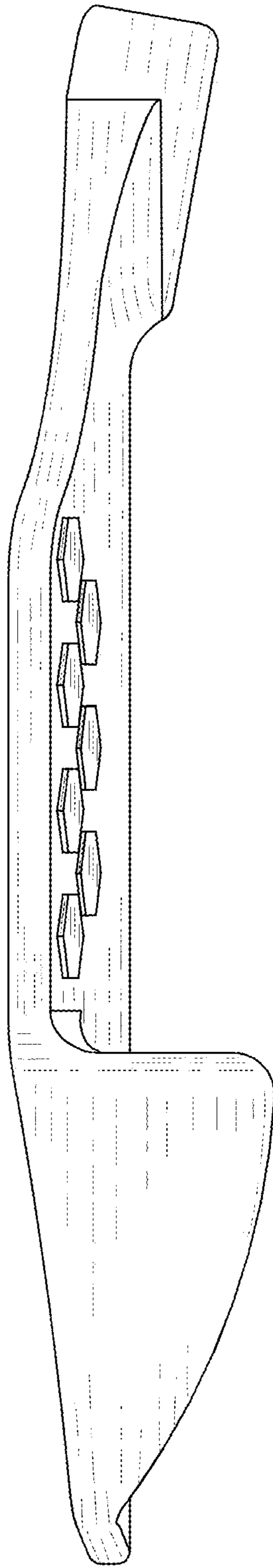

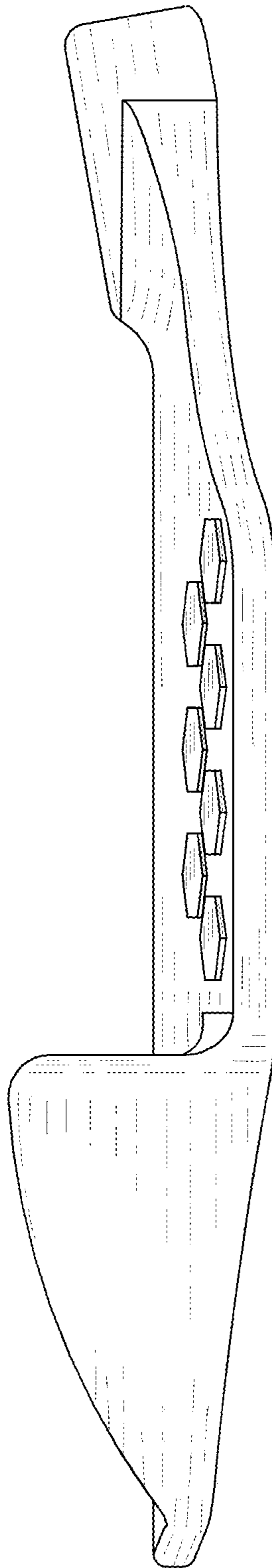

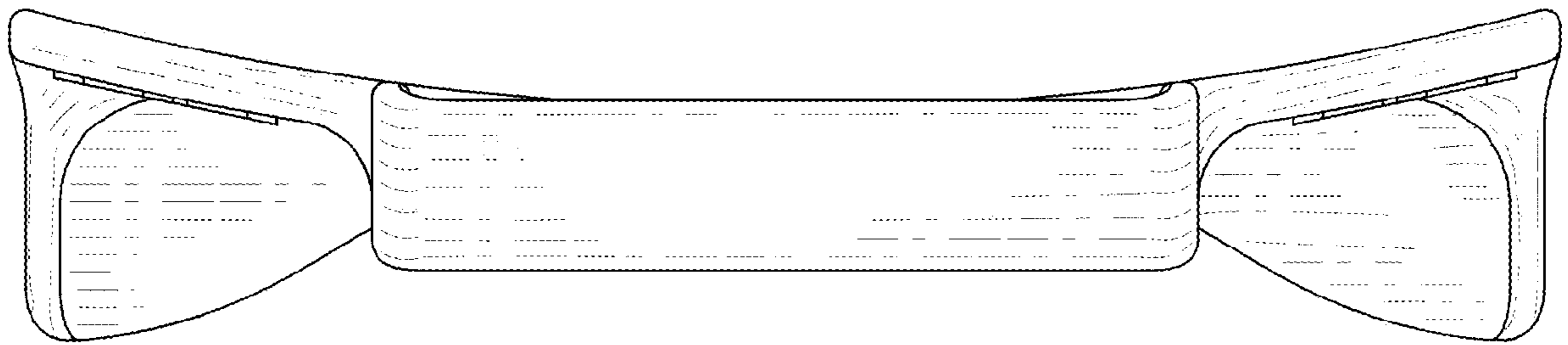

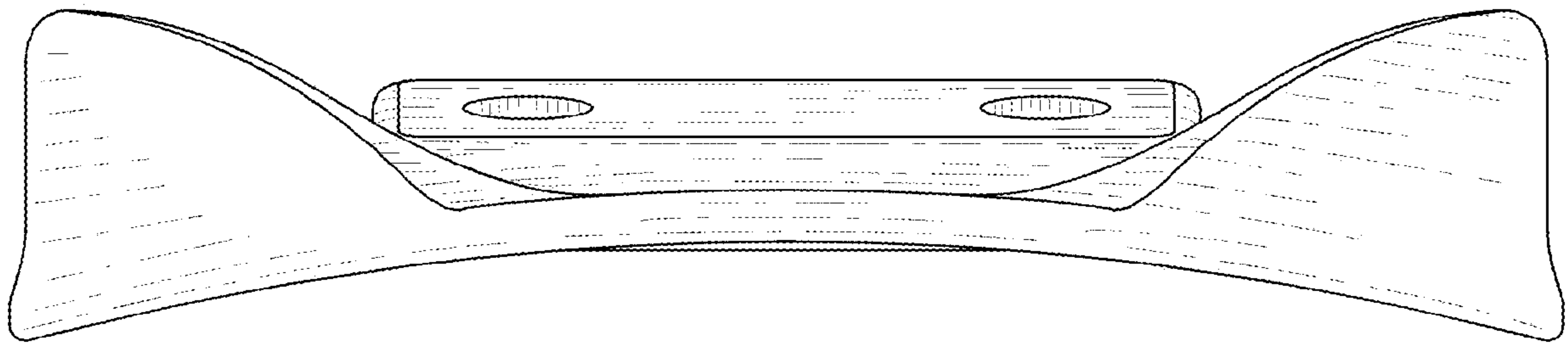
