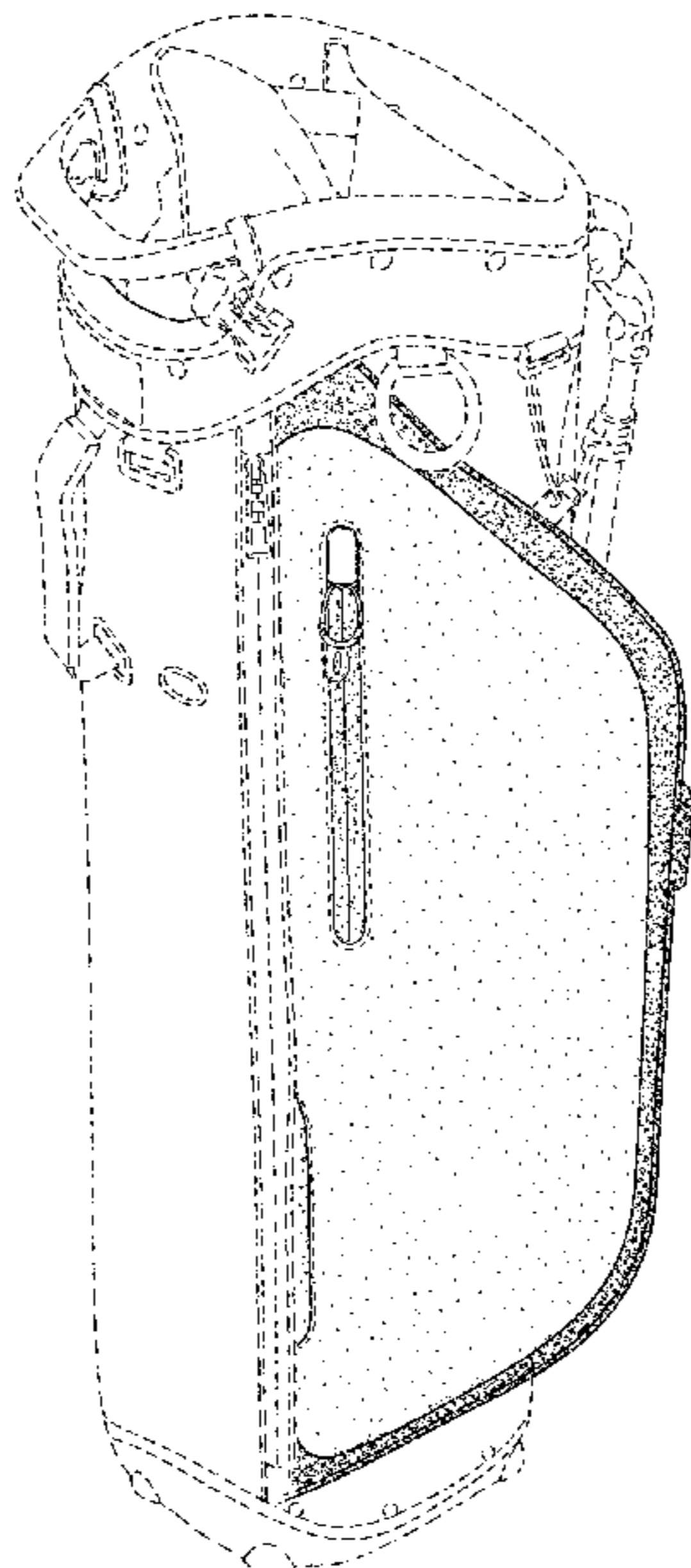
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a first perspective view of the golf bag side pocket of this invention;
FIG. 2 is a rear view of the golf bag side pocket of this invention;
FIG. 3 is a first side view of the golf bag side pocket of this invention;

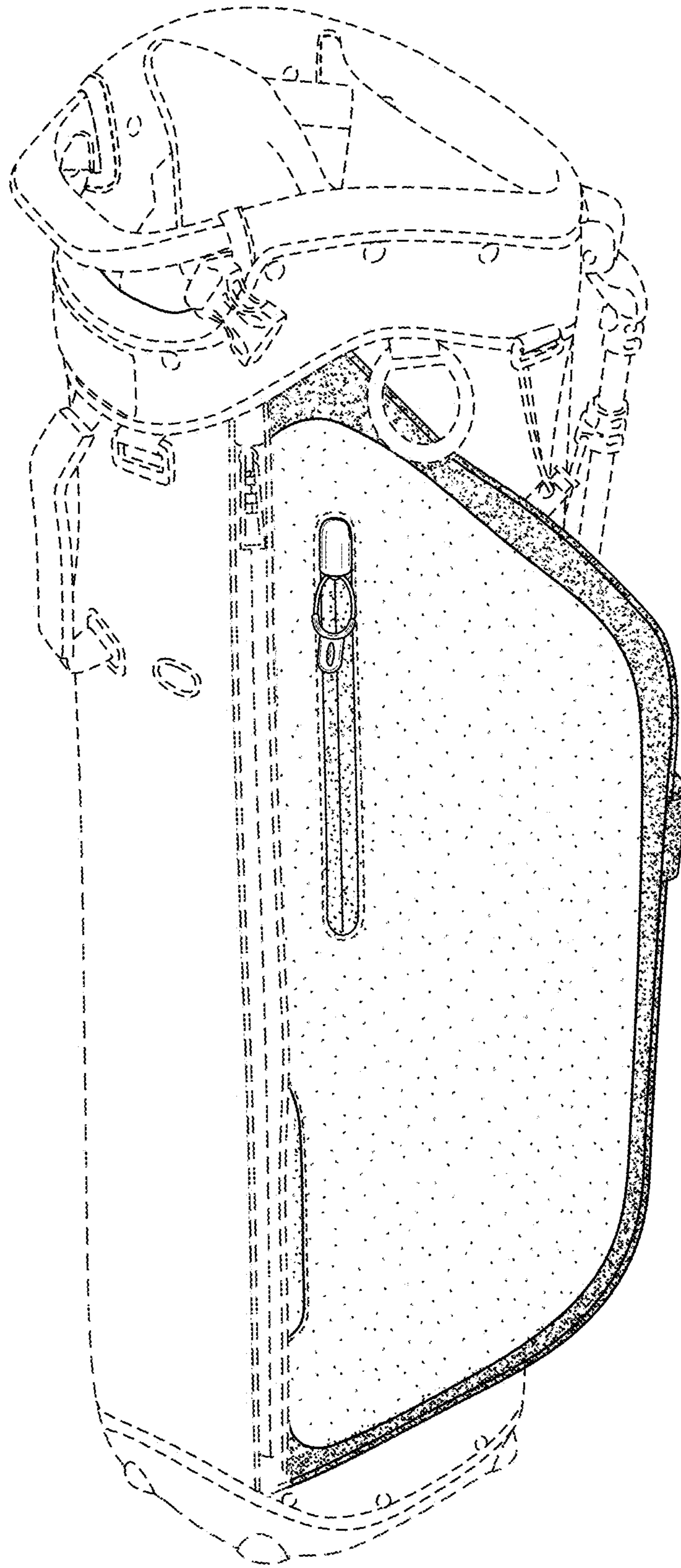

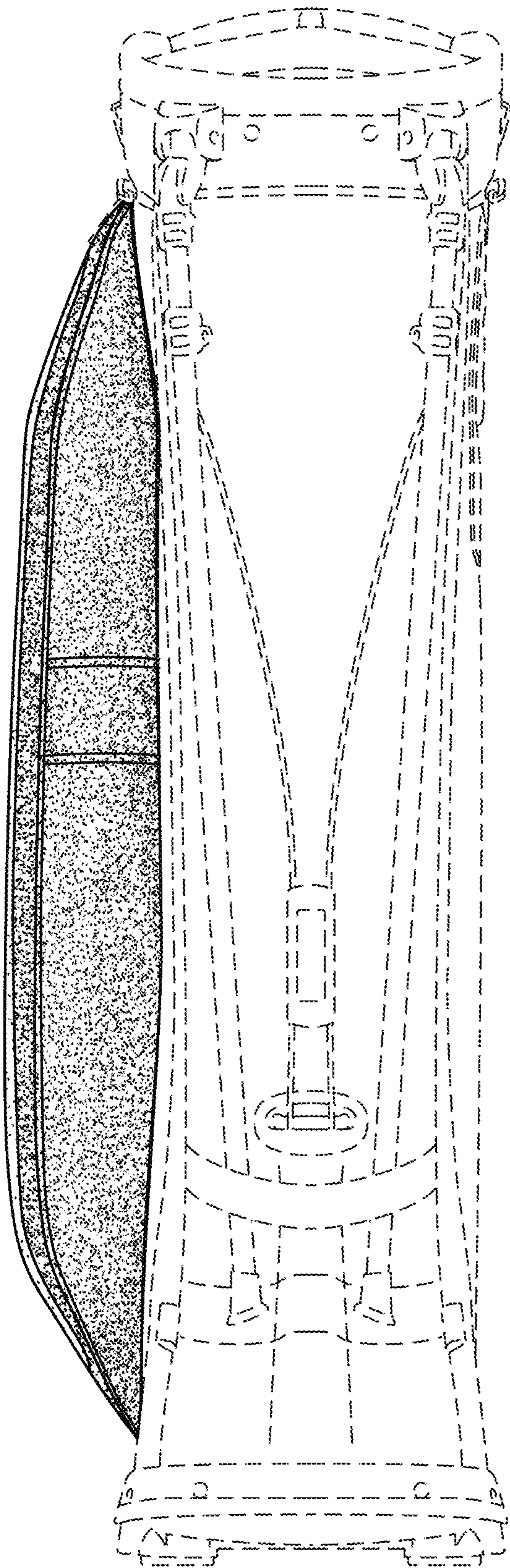

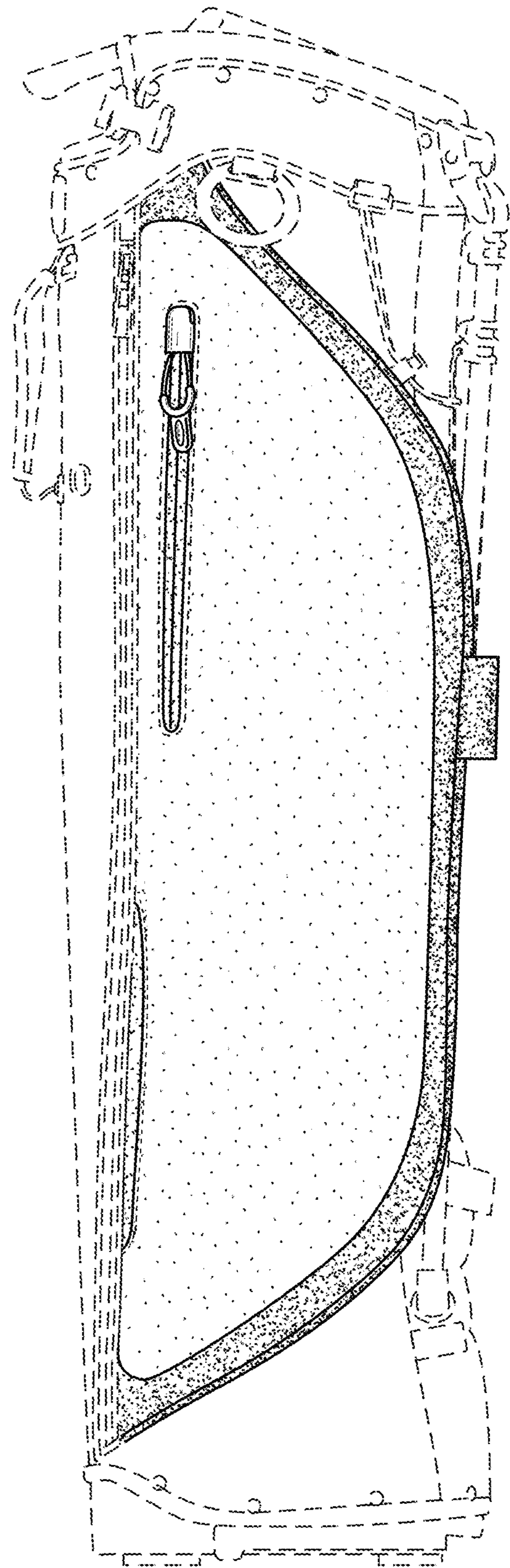

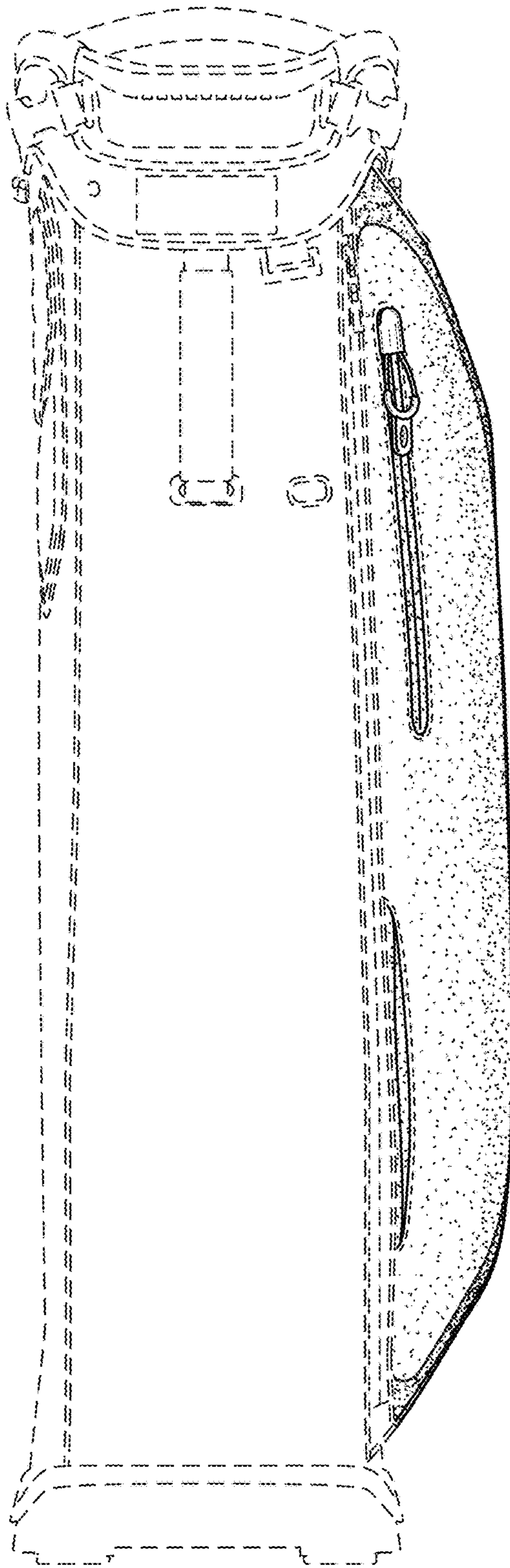

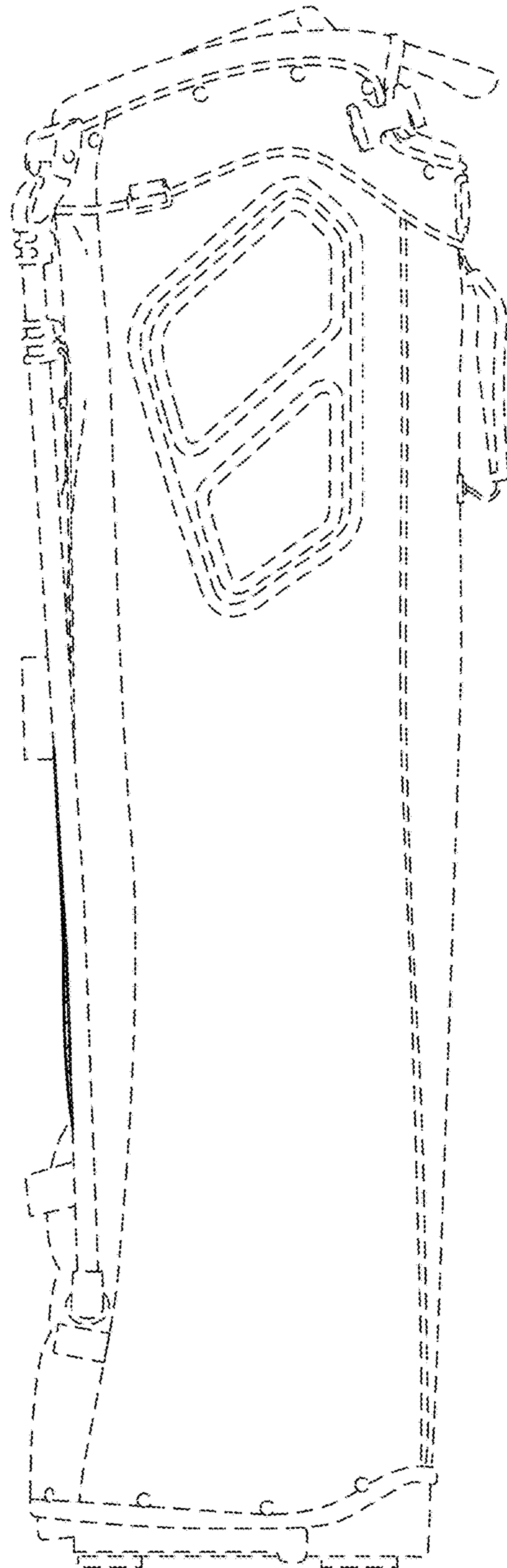

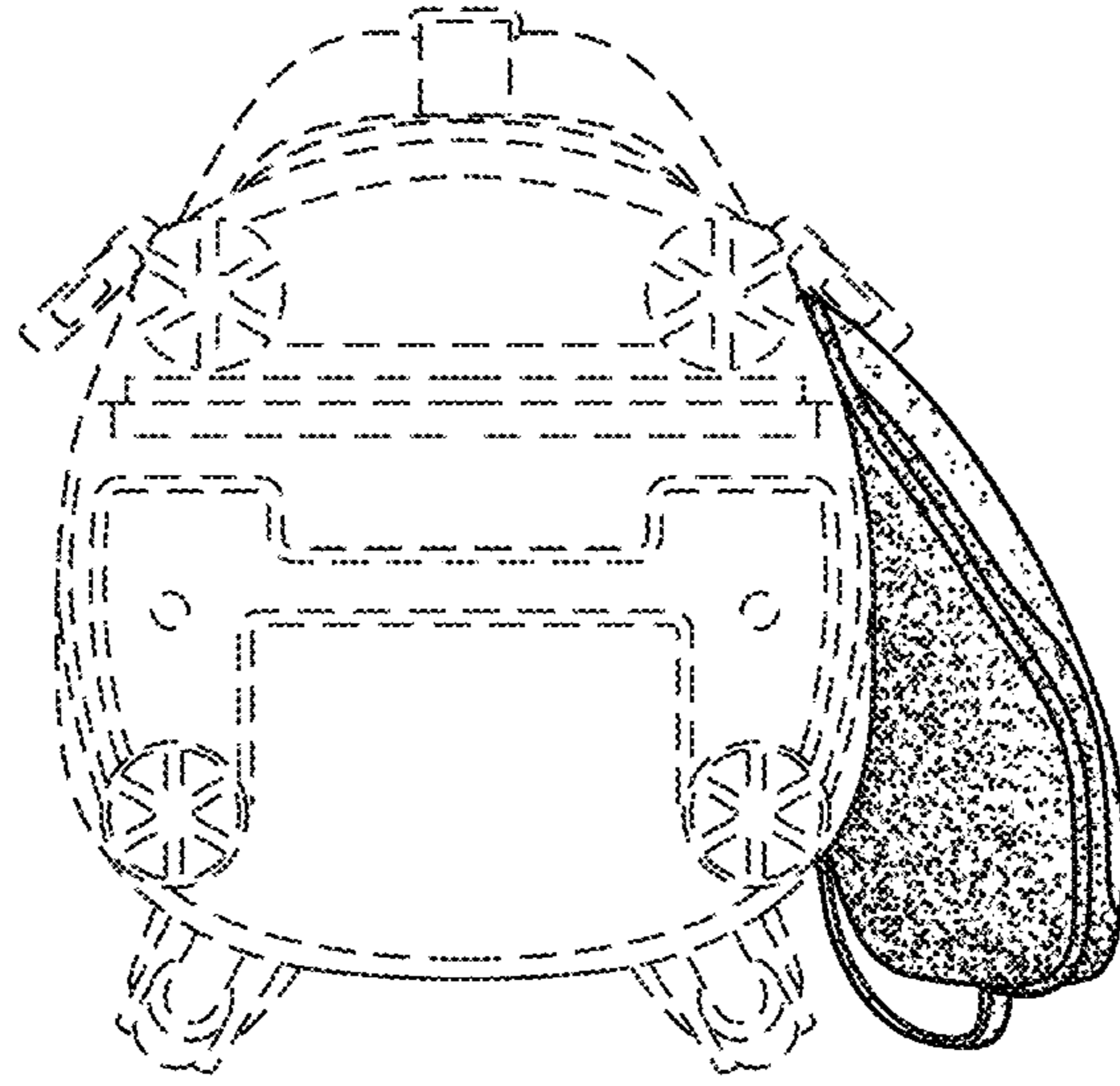

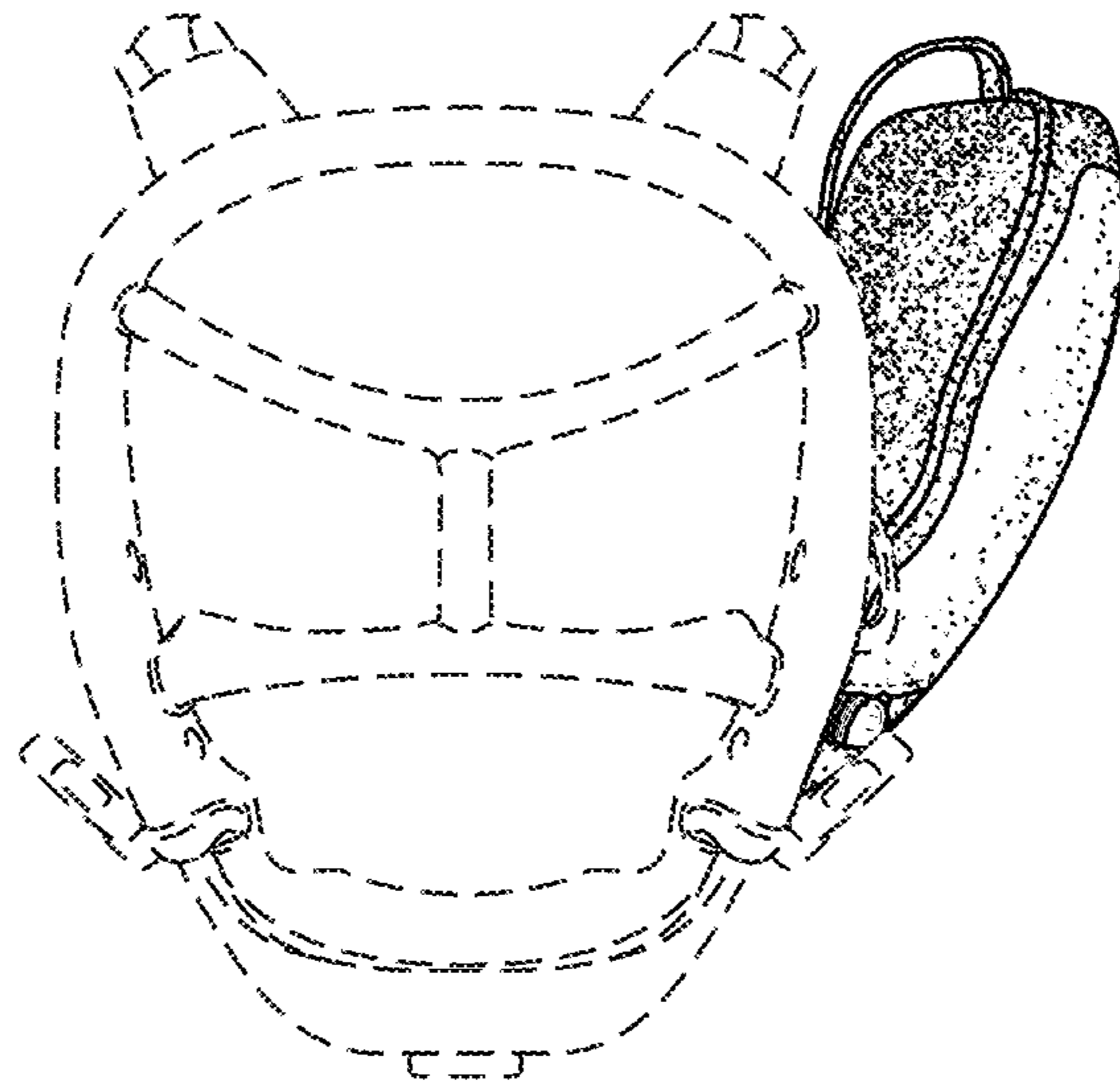
