(57) **CLAIM**

I claim the ornamental design for a cosmetic case, as shown and described.

**DESCRIPTION**

FIG. 1 is a Perspective view of a cosmetic case showing my new design;

FIG. 5 is a Right-side view of the cosmetic case as shown in FIG. 1;

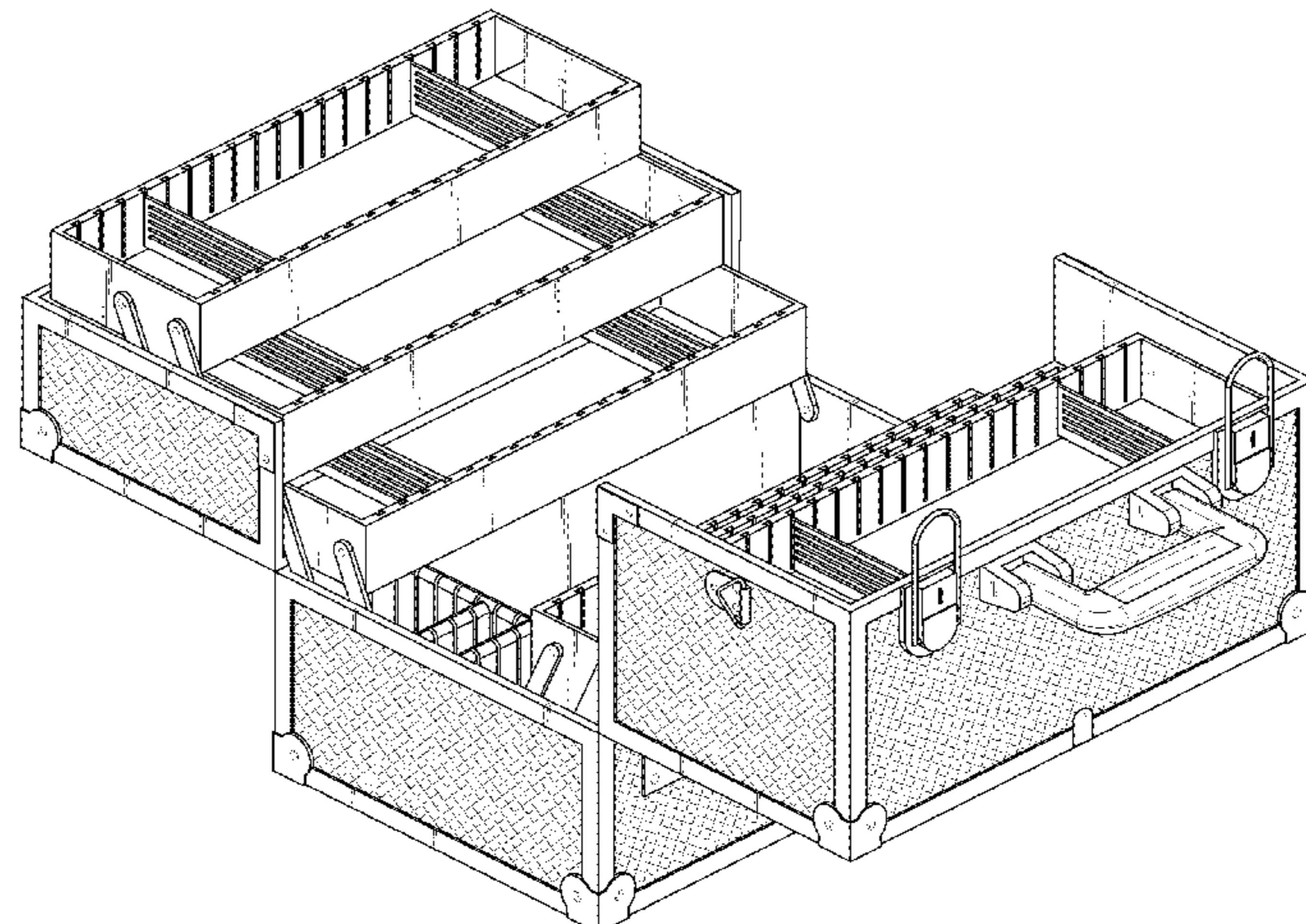
FIG. 6 is a Top view of the cosmetic case as shown in FIG. 1;

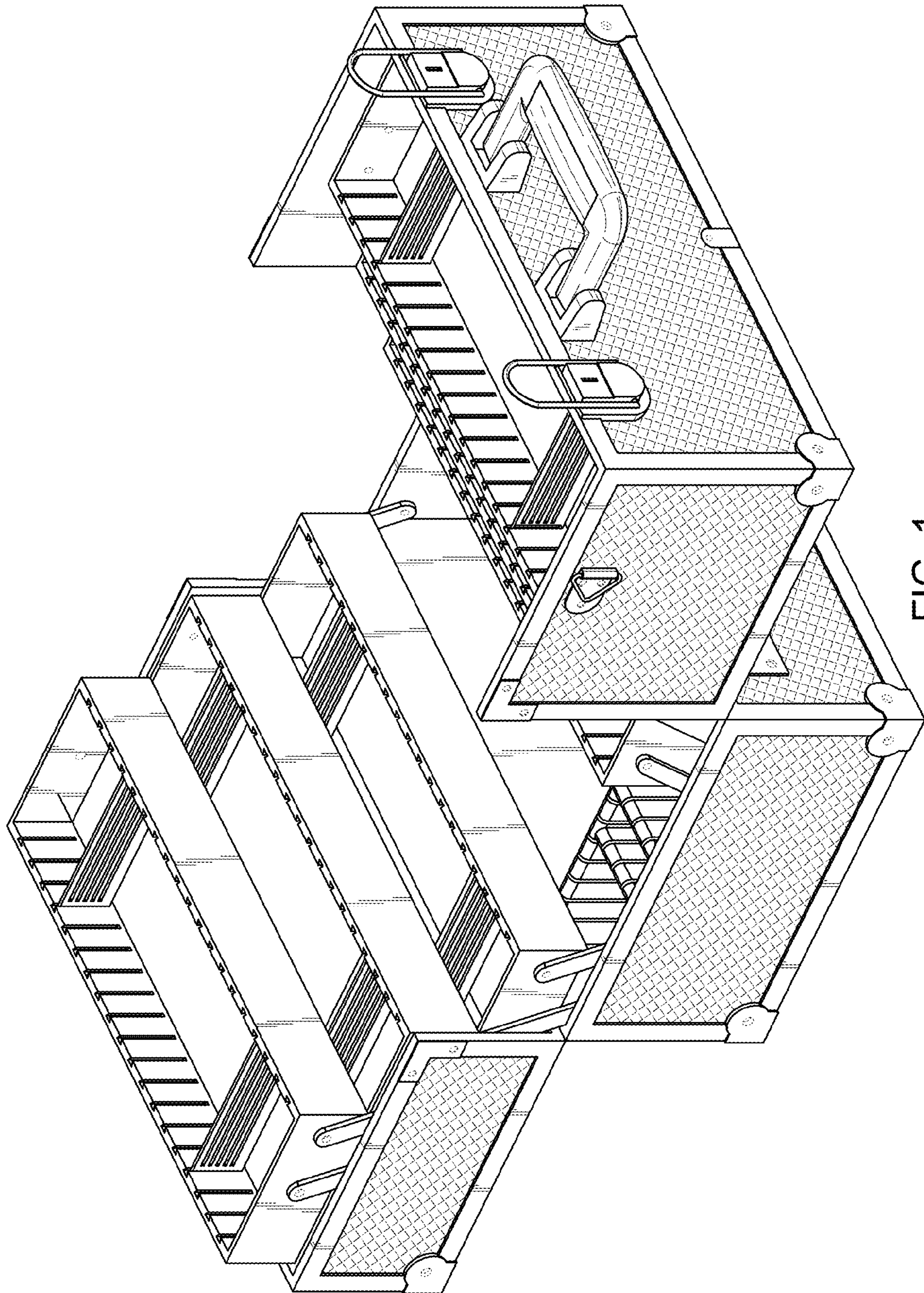

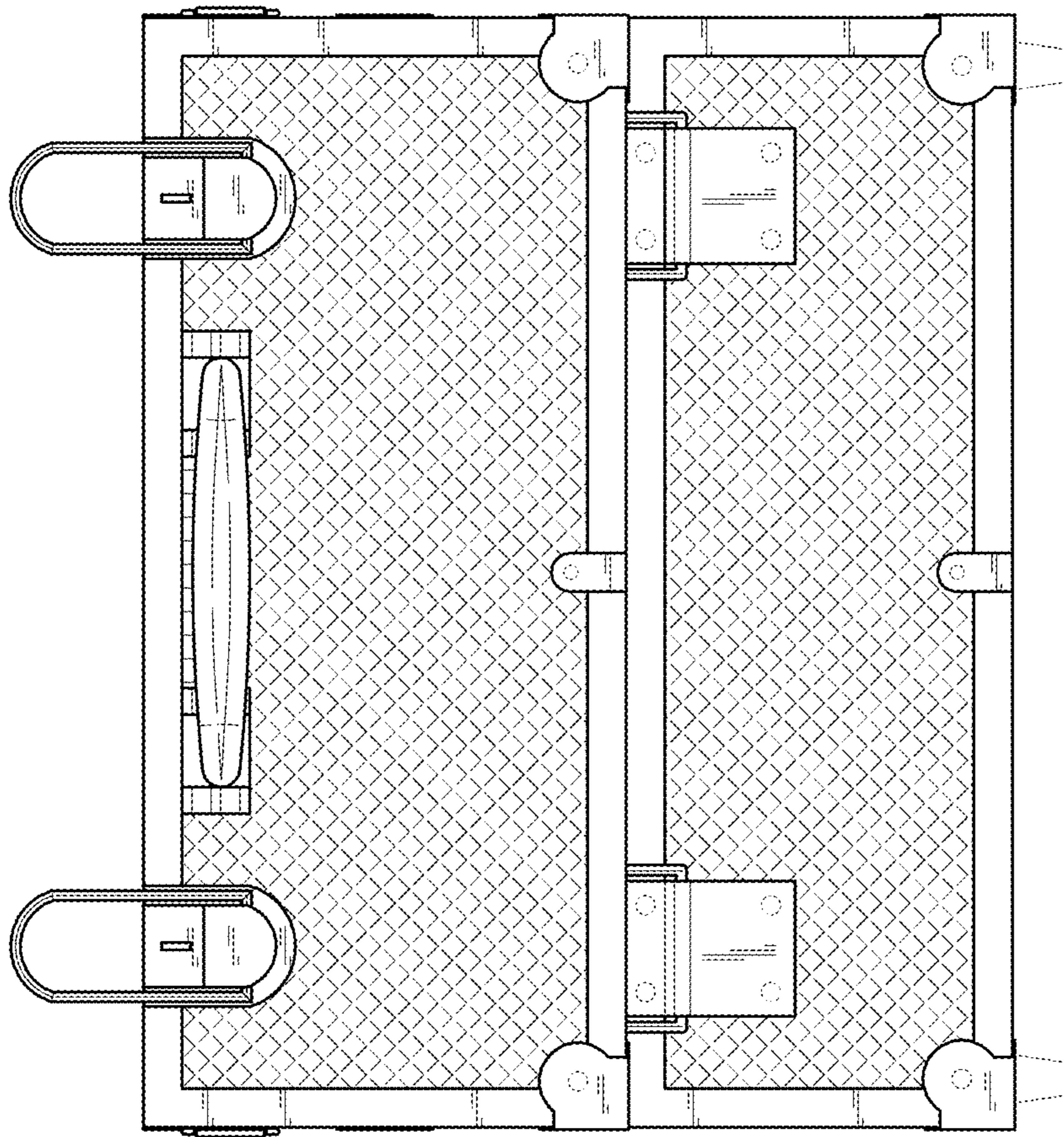

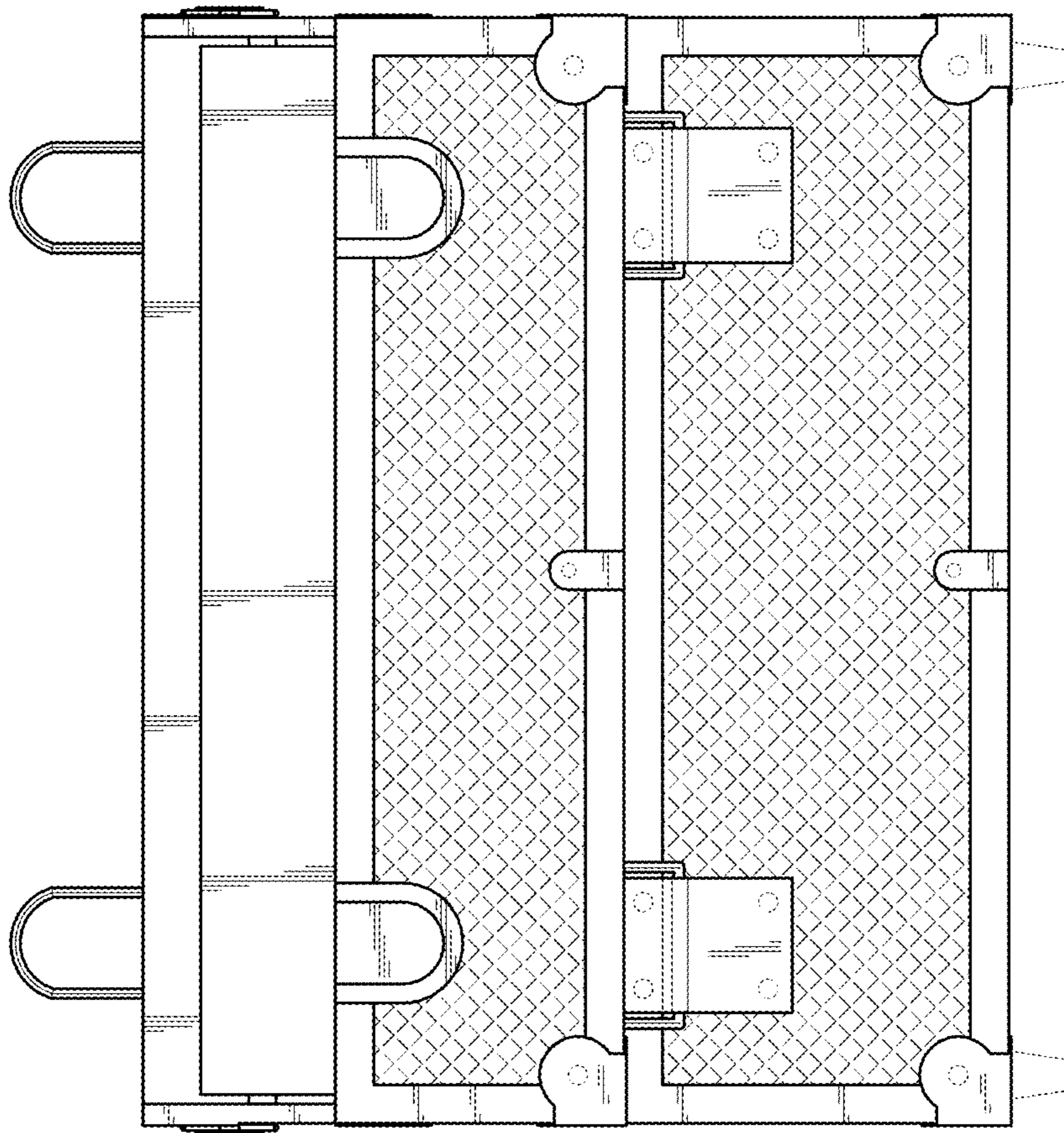

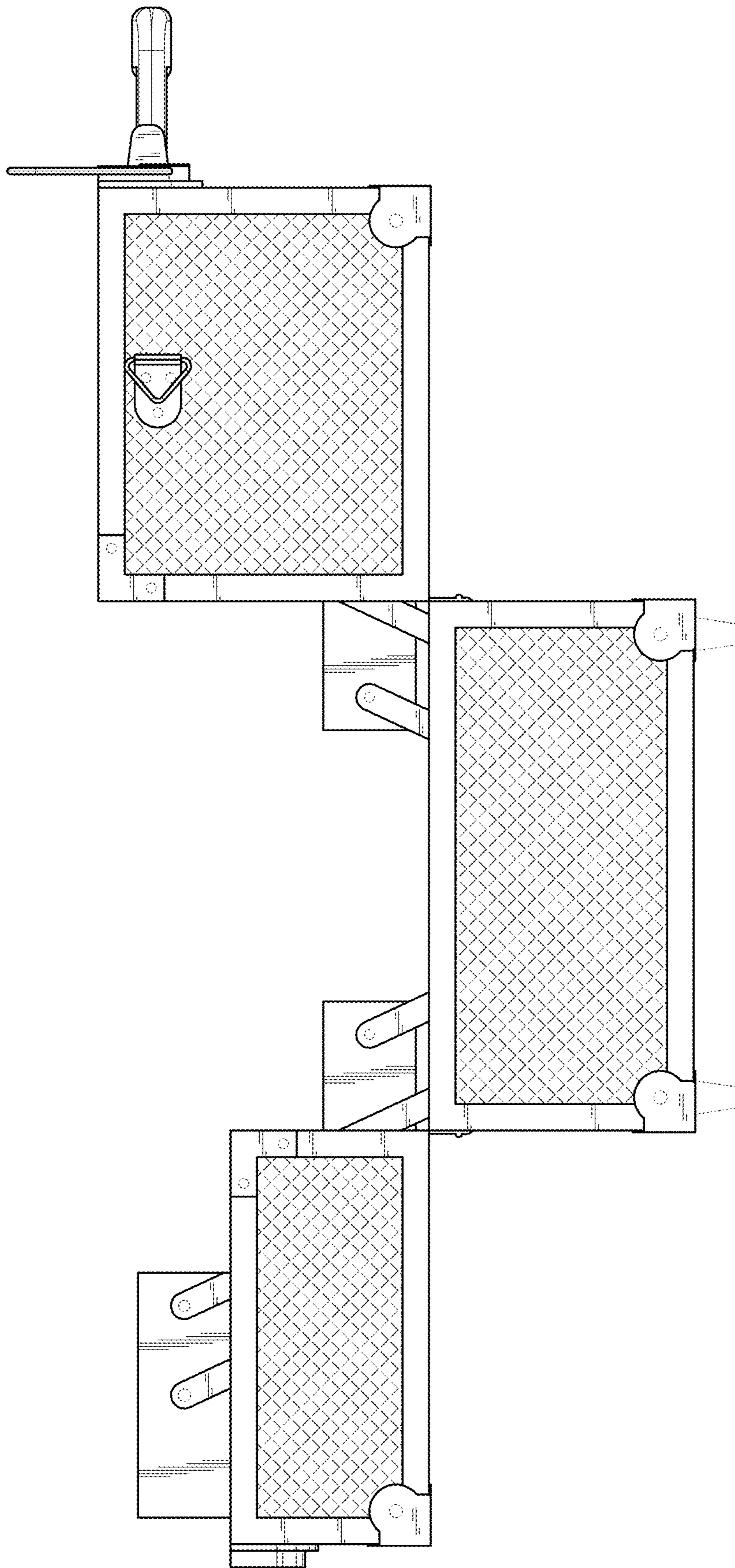

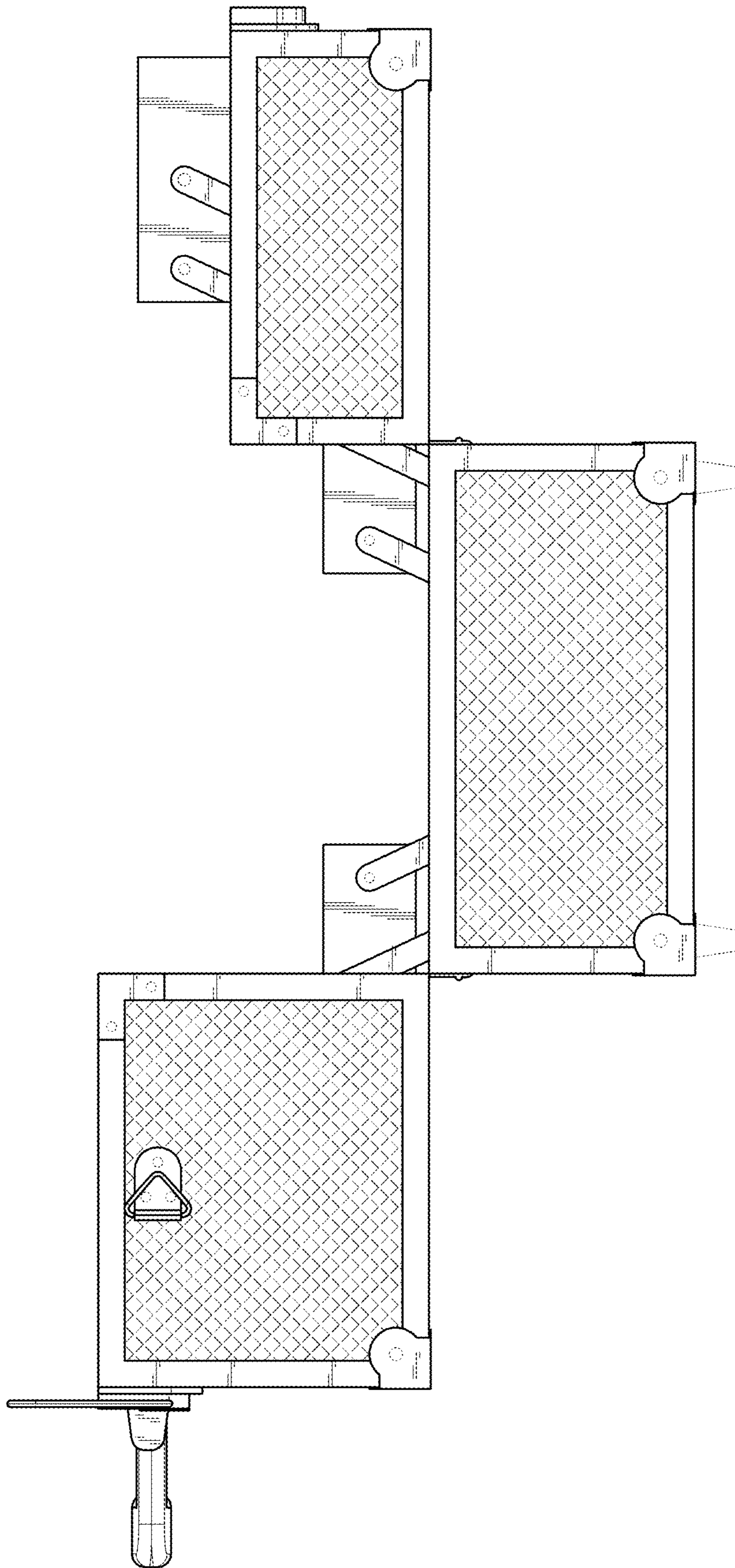

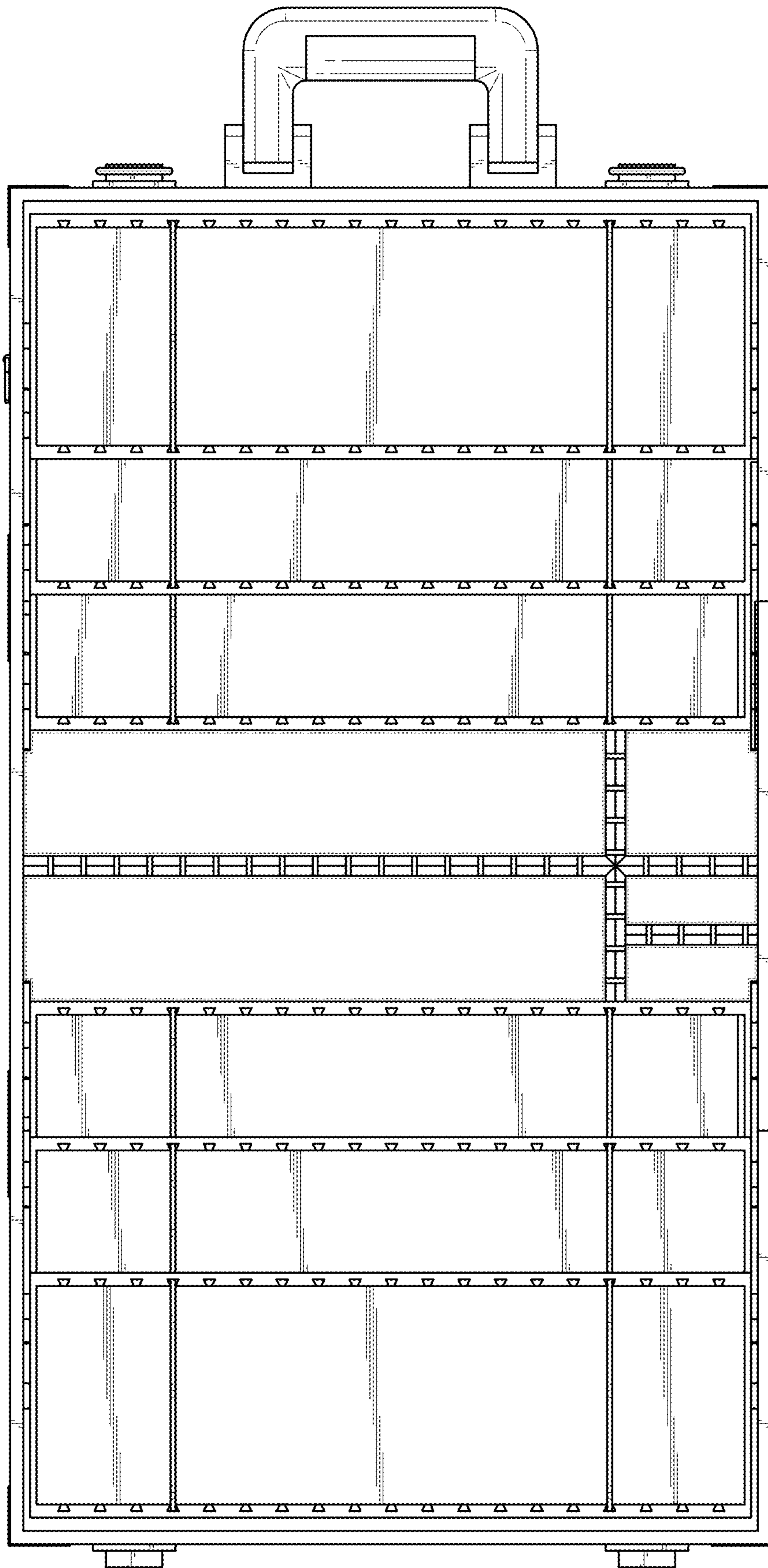

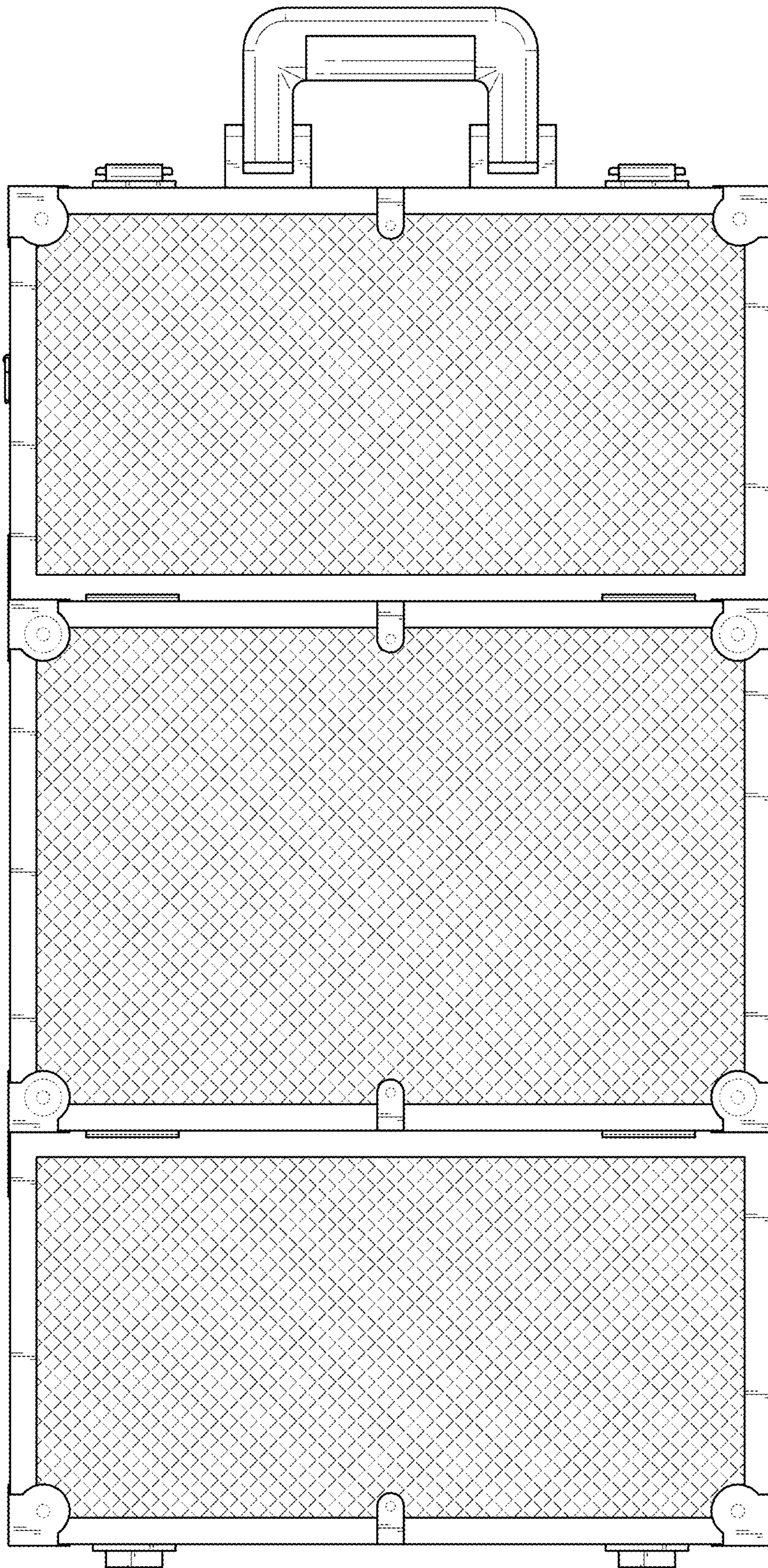

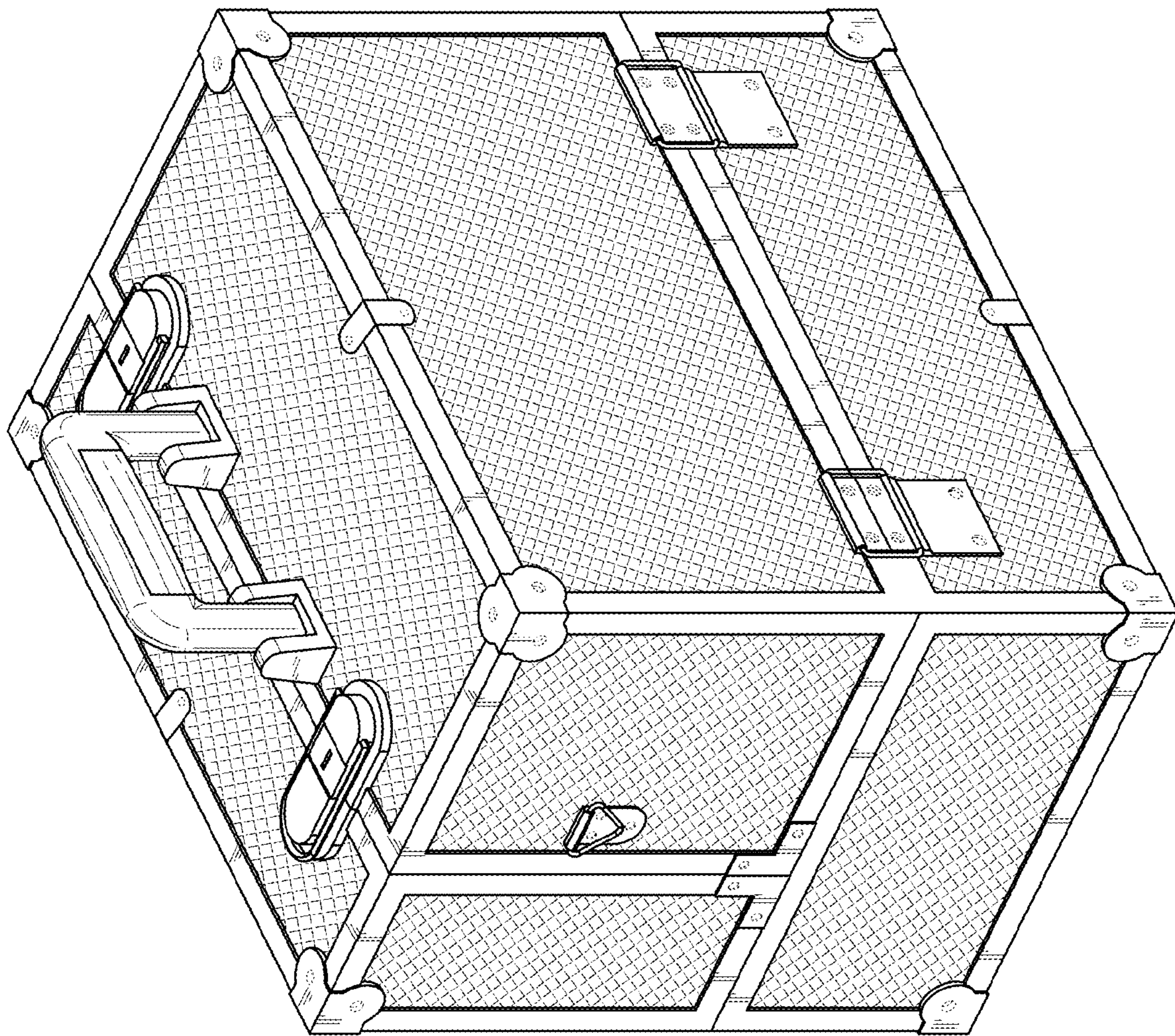
