(57) **CLAIM**

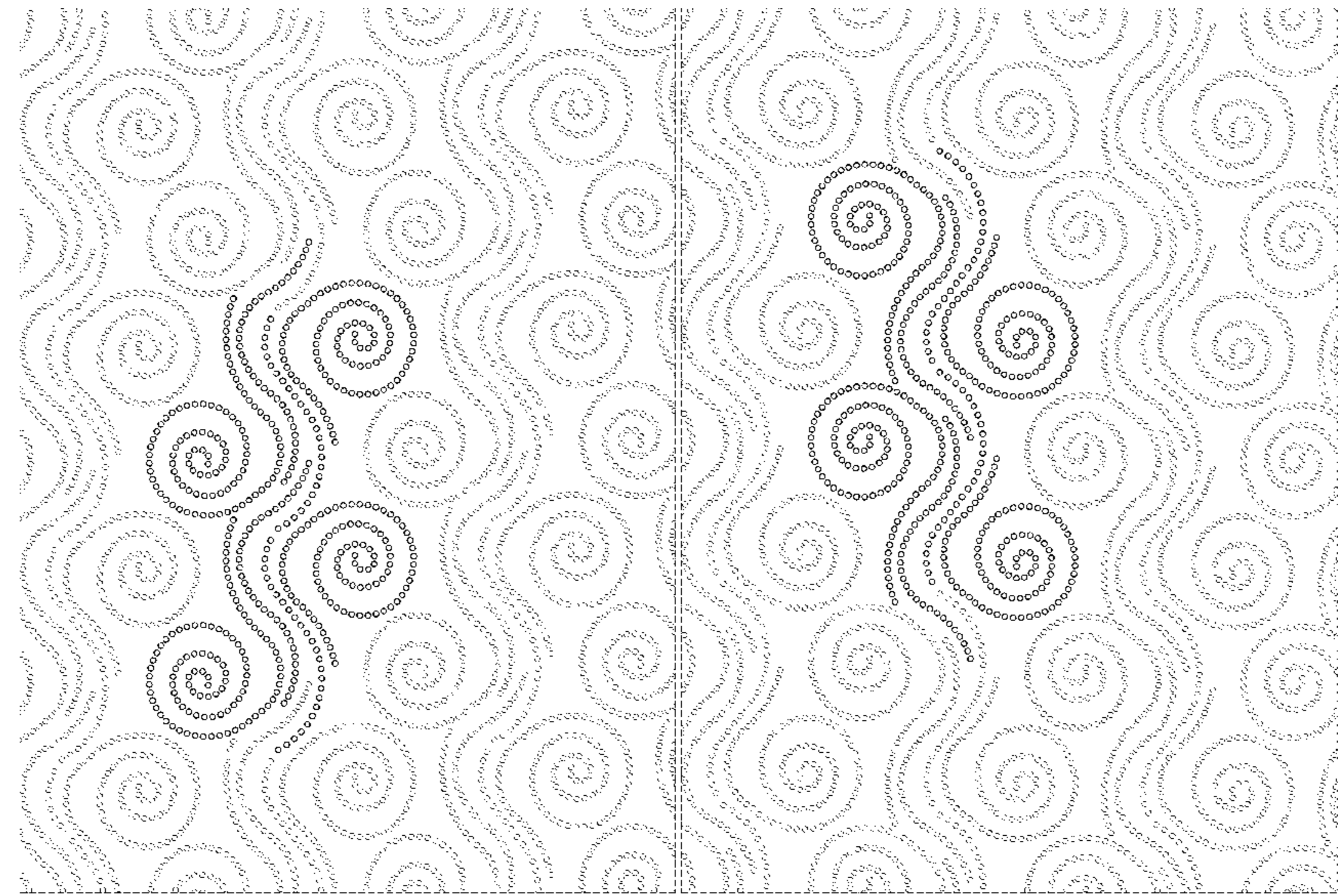
The ornamental design for a nonwoven sheet, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a nonwoven sheet according to our new design.  
FIG. 2 is a top plan view of the nonwoven sheet of FIG. 1; and,  
FIG. 3 is a rear plan view of the nonwoven sheet of FIG. 1.  
The broken lines and all areas adjacent to the solid lines depict portions of the nonwoven sheet that form no part of the claimed design.

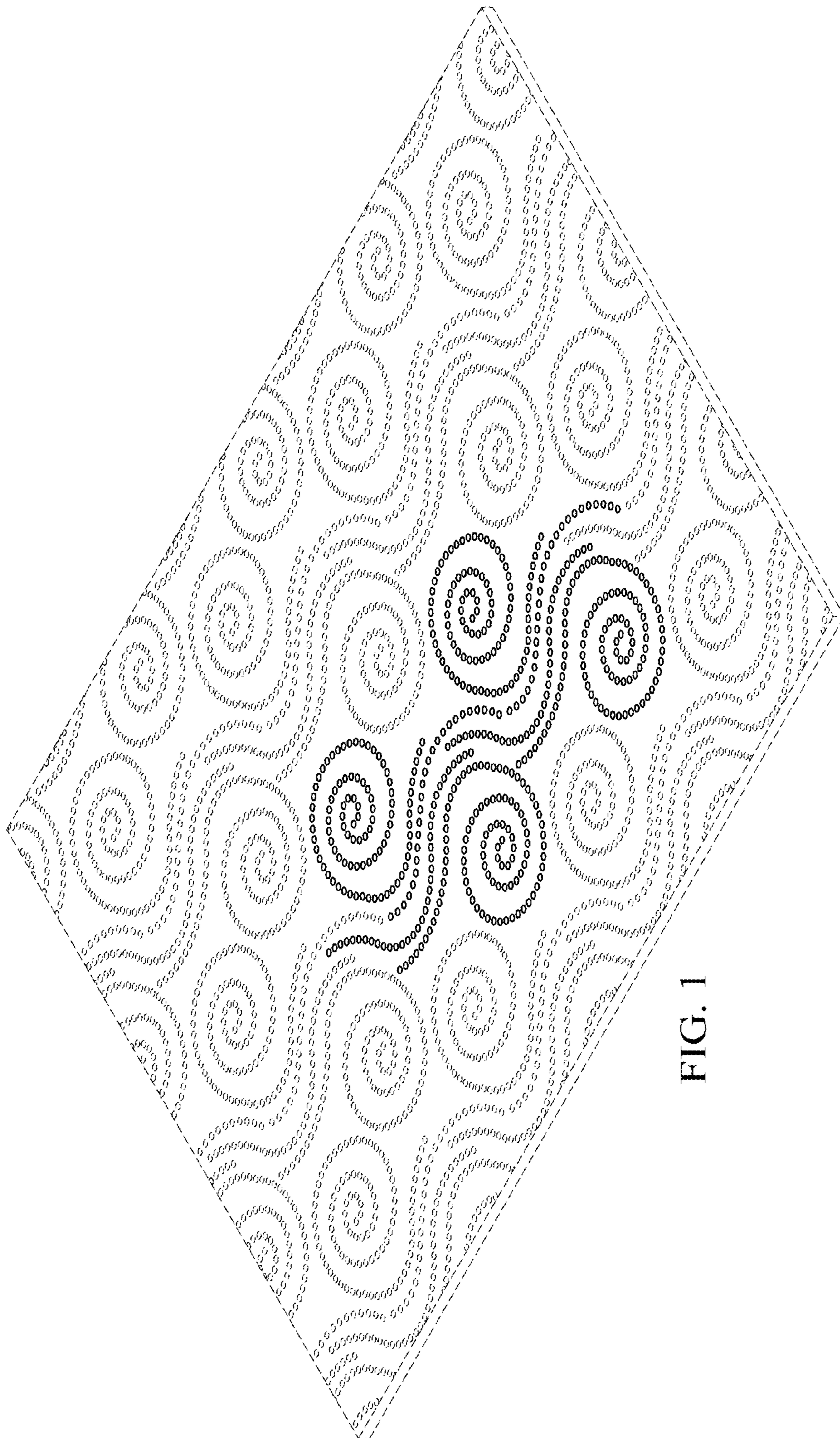
