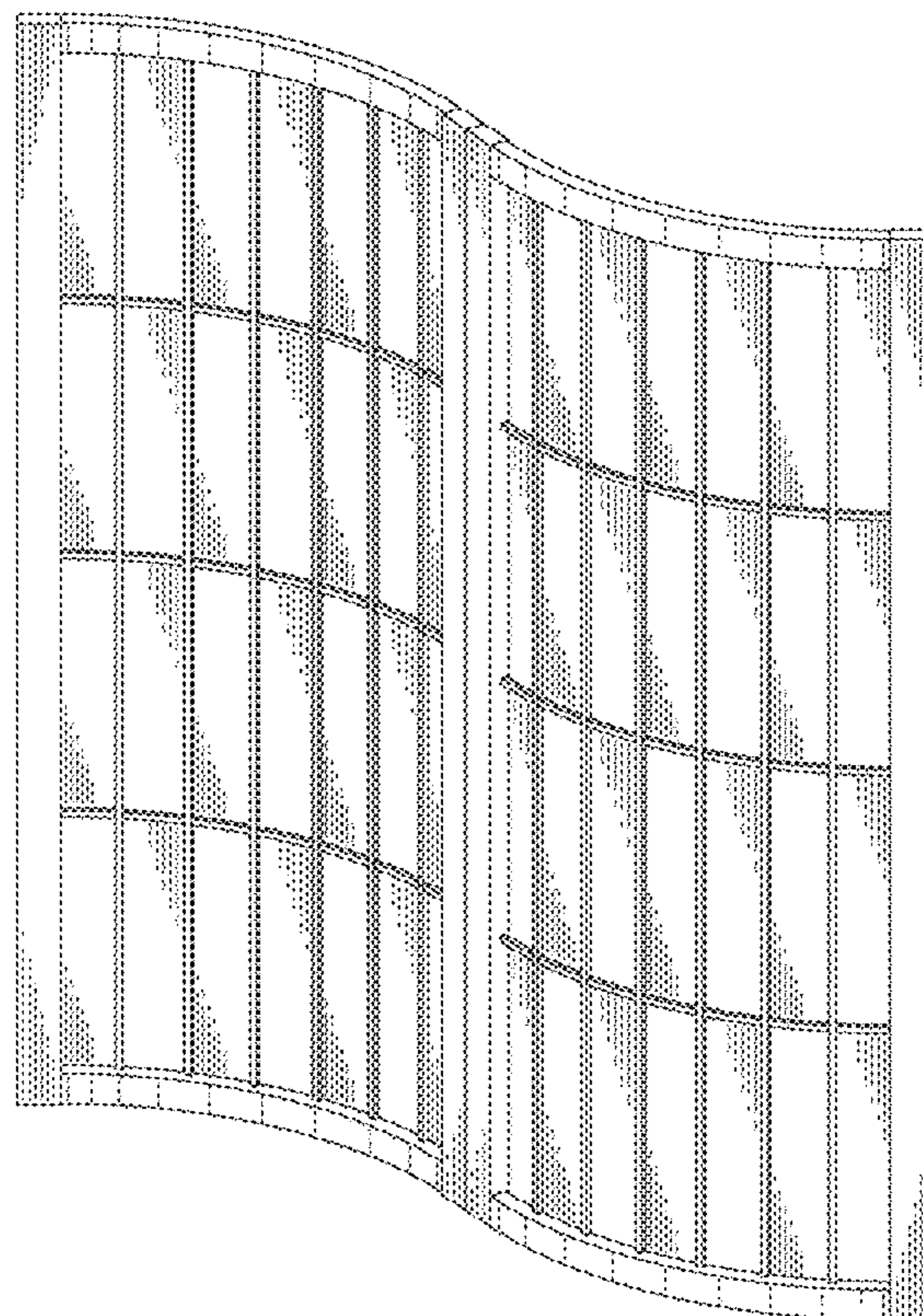
(57) **CLAIM**

The ornamental design for a portable partition, as shown and described.

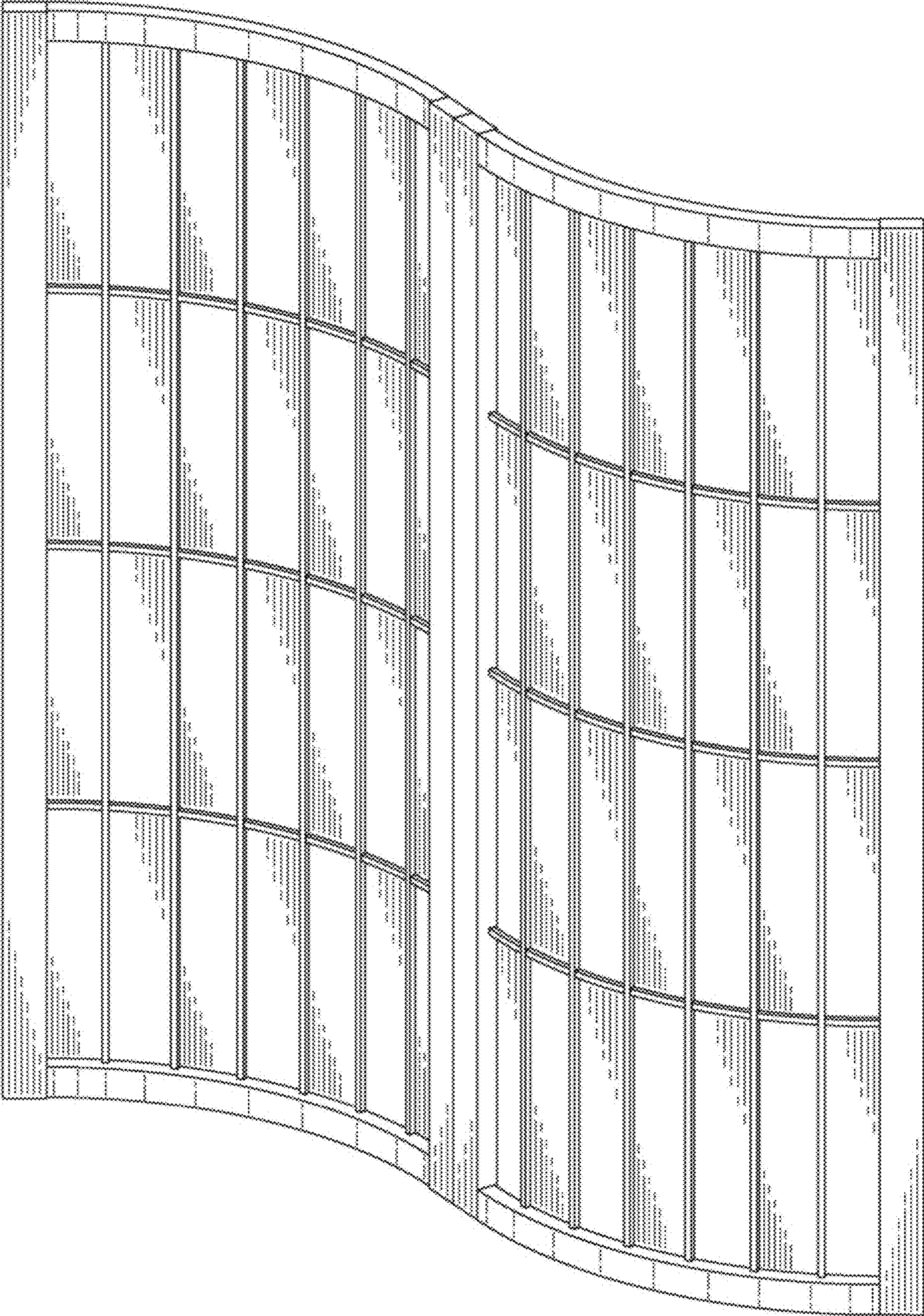
DESCRIPTION

The portable partition can be used to separate a room.

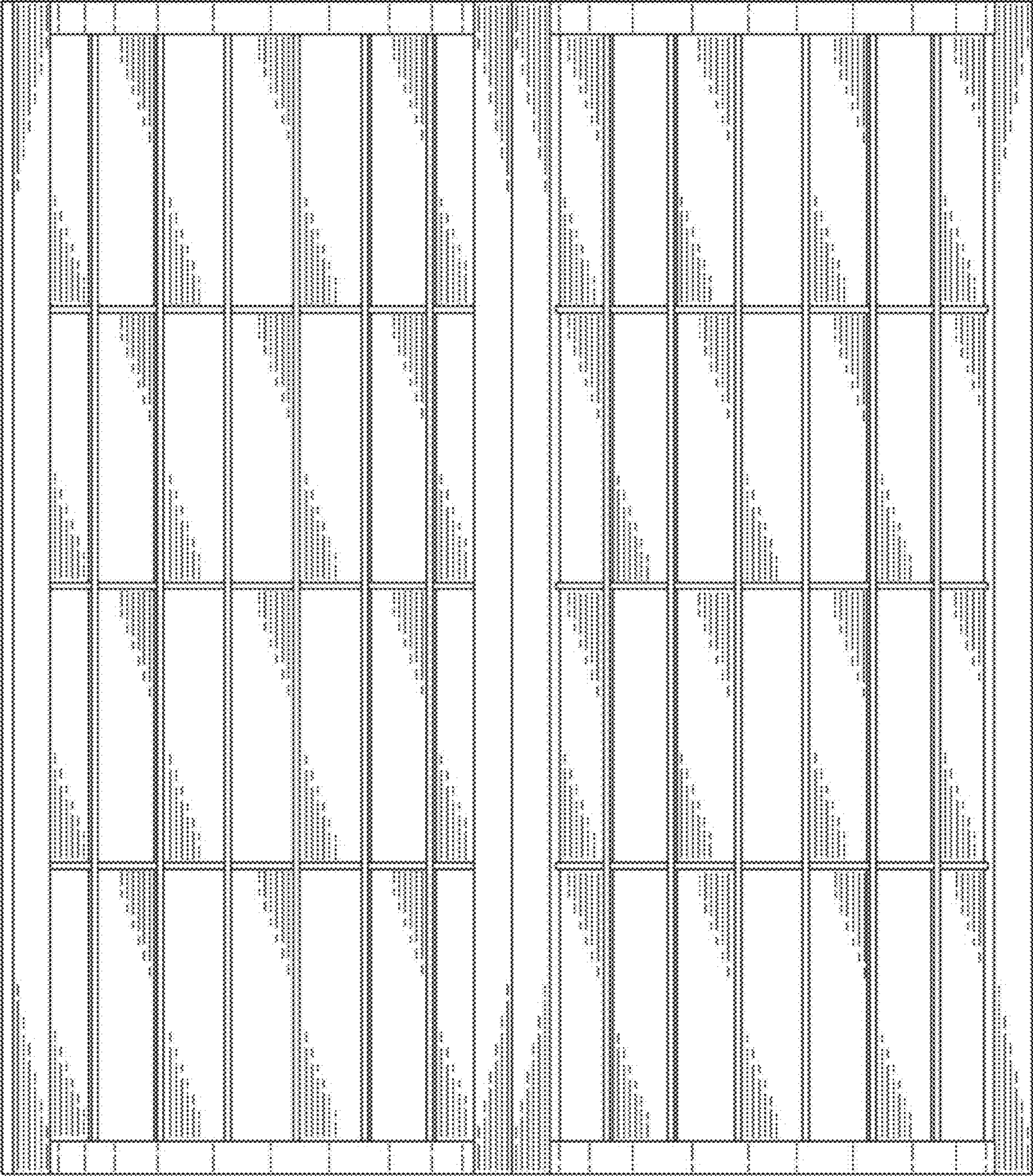

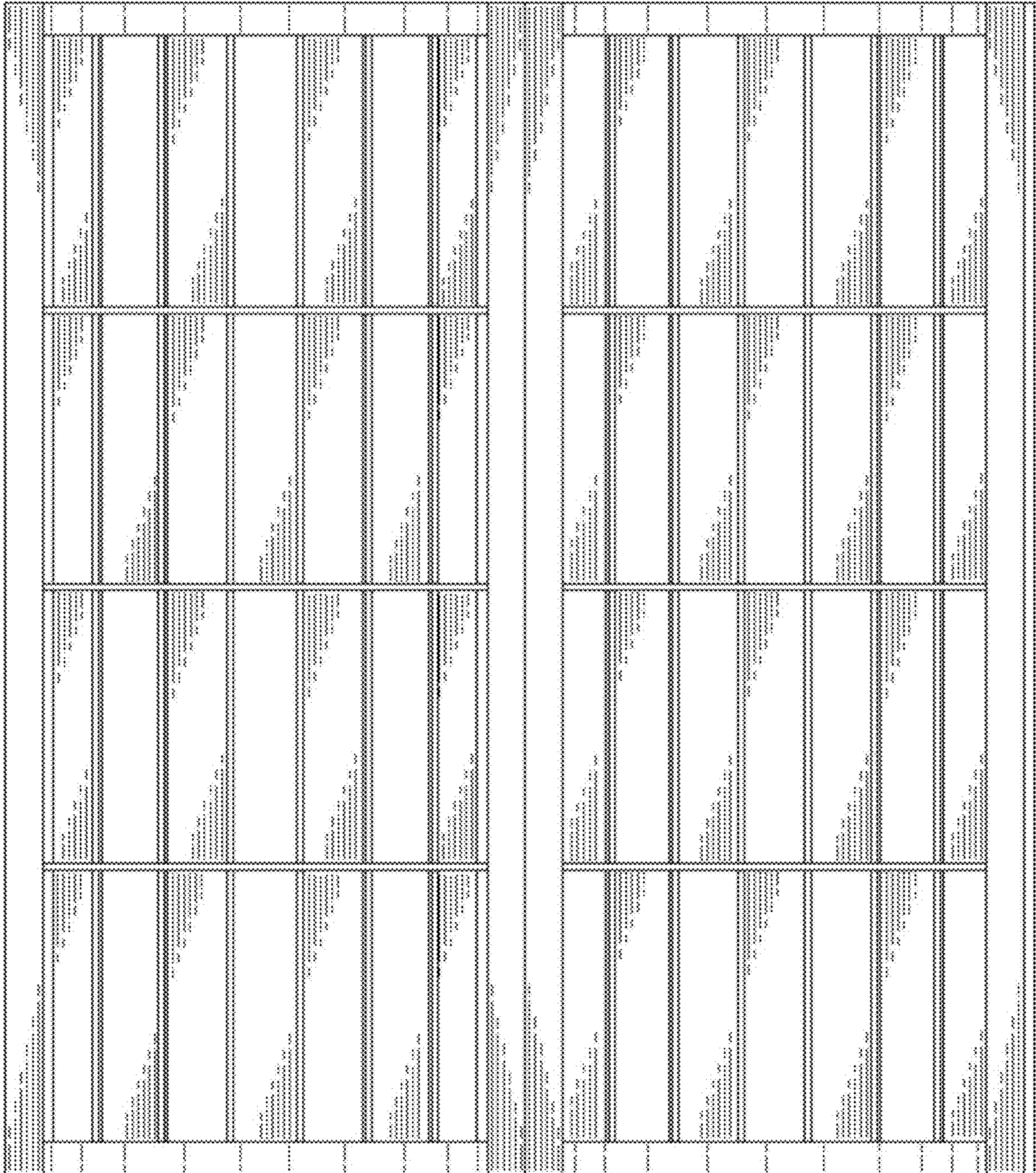

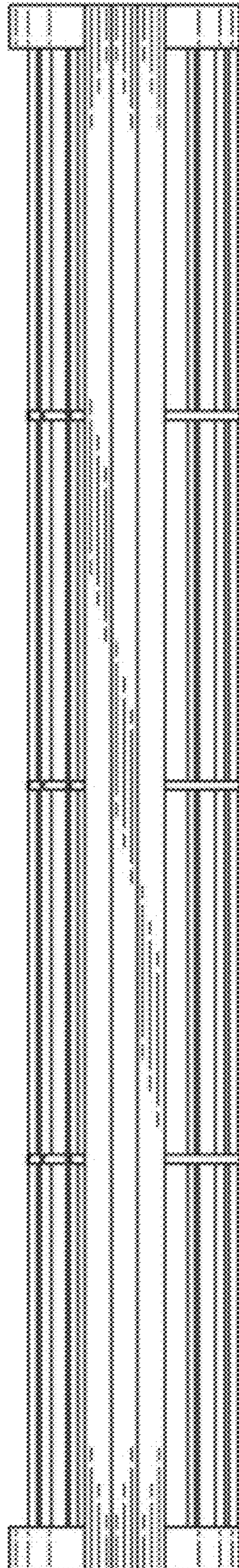

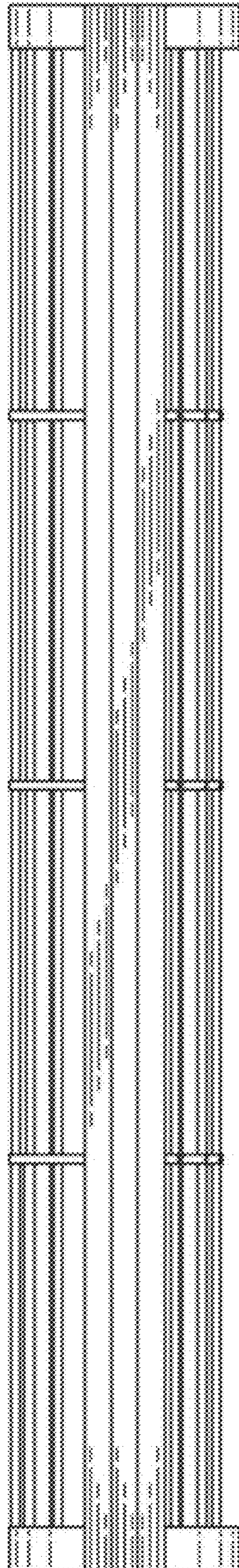

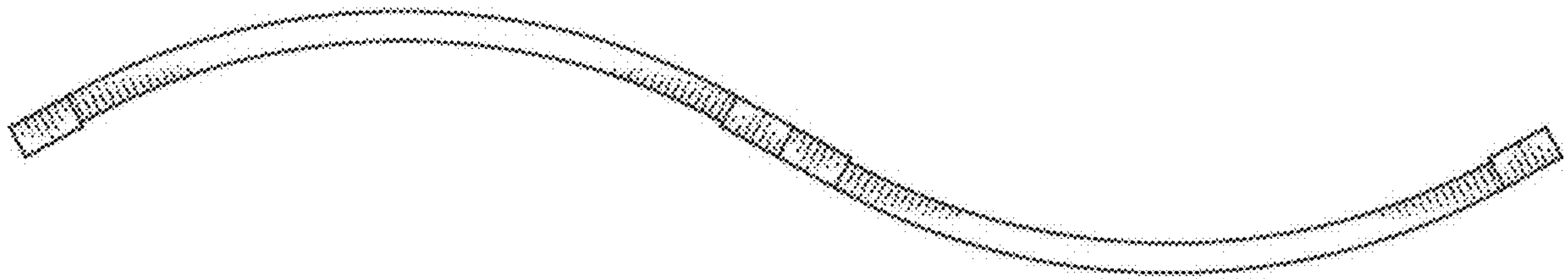
