 The ornamental design for a cabinetry door, as shown and described.

DESCRIPTION
 FIG. 1 is a front view of a cabinetry door according to the new design;
 FIG. 2 is a side view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is an exploded front perspective view thereof, showing the backing, indicated by line 1, and the frame, indicated by line 2, components of the design;
 FIG. 5 is a front perspective view of the design; and,
 FIG. 6 is a rear perspective view thereof.

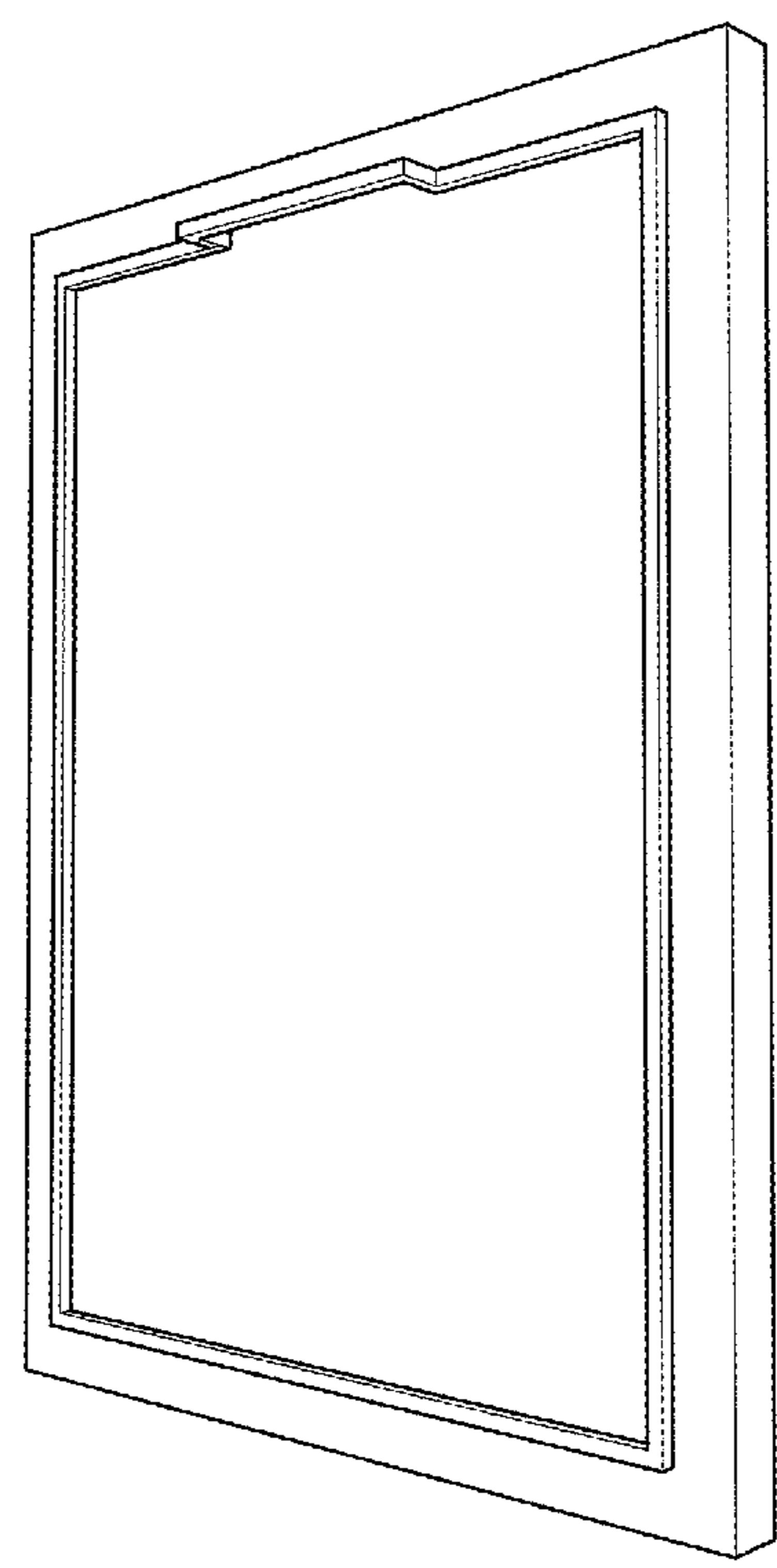

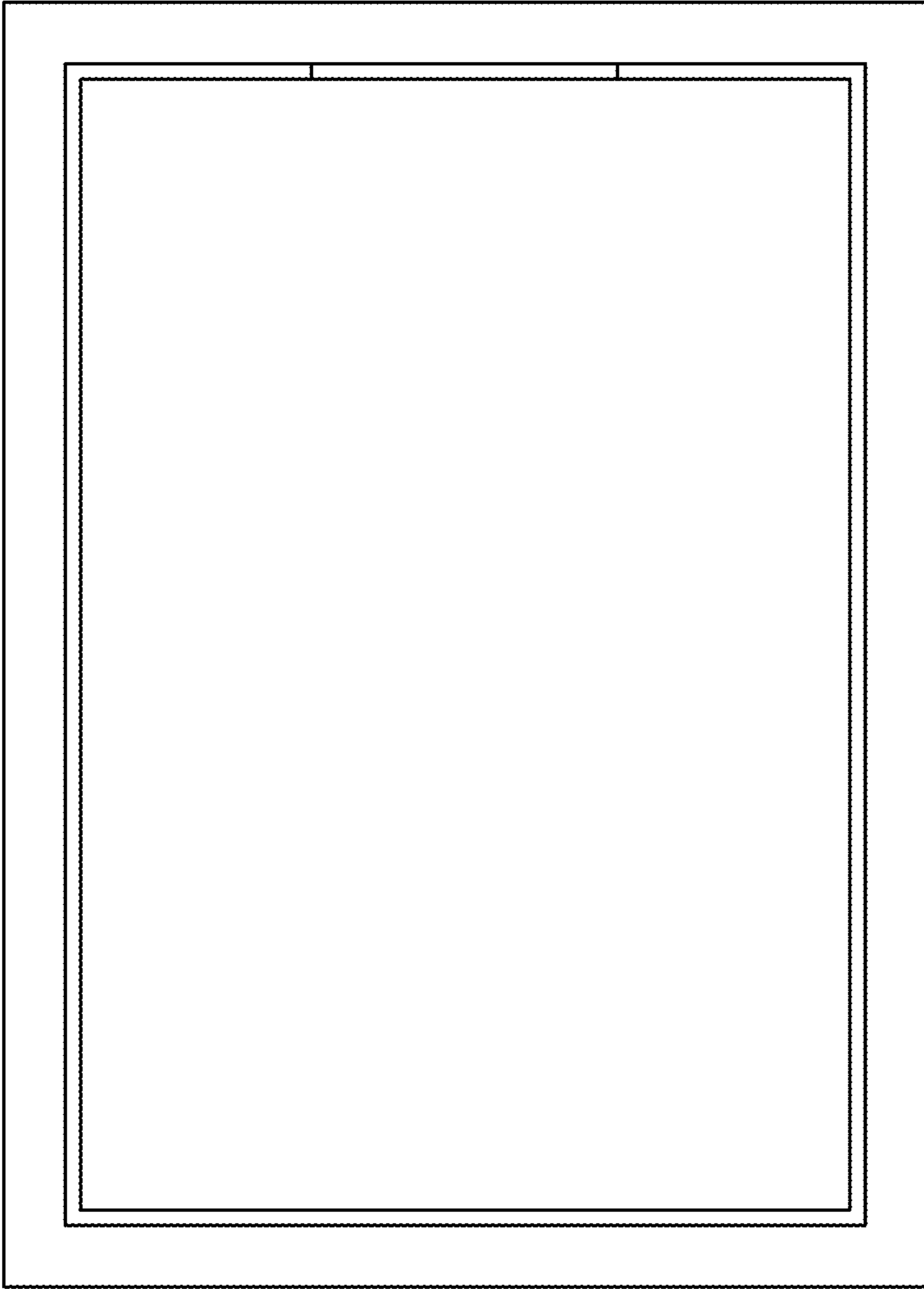

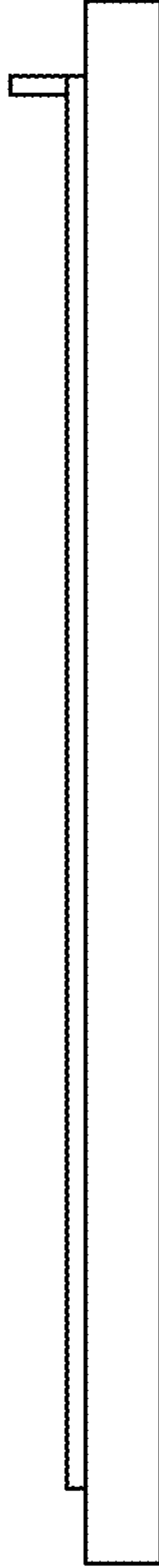

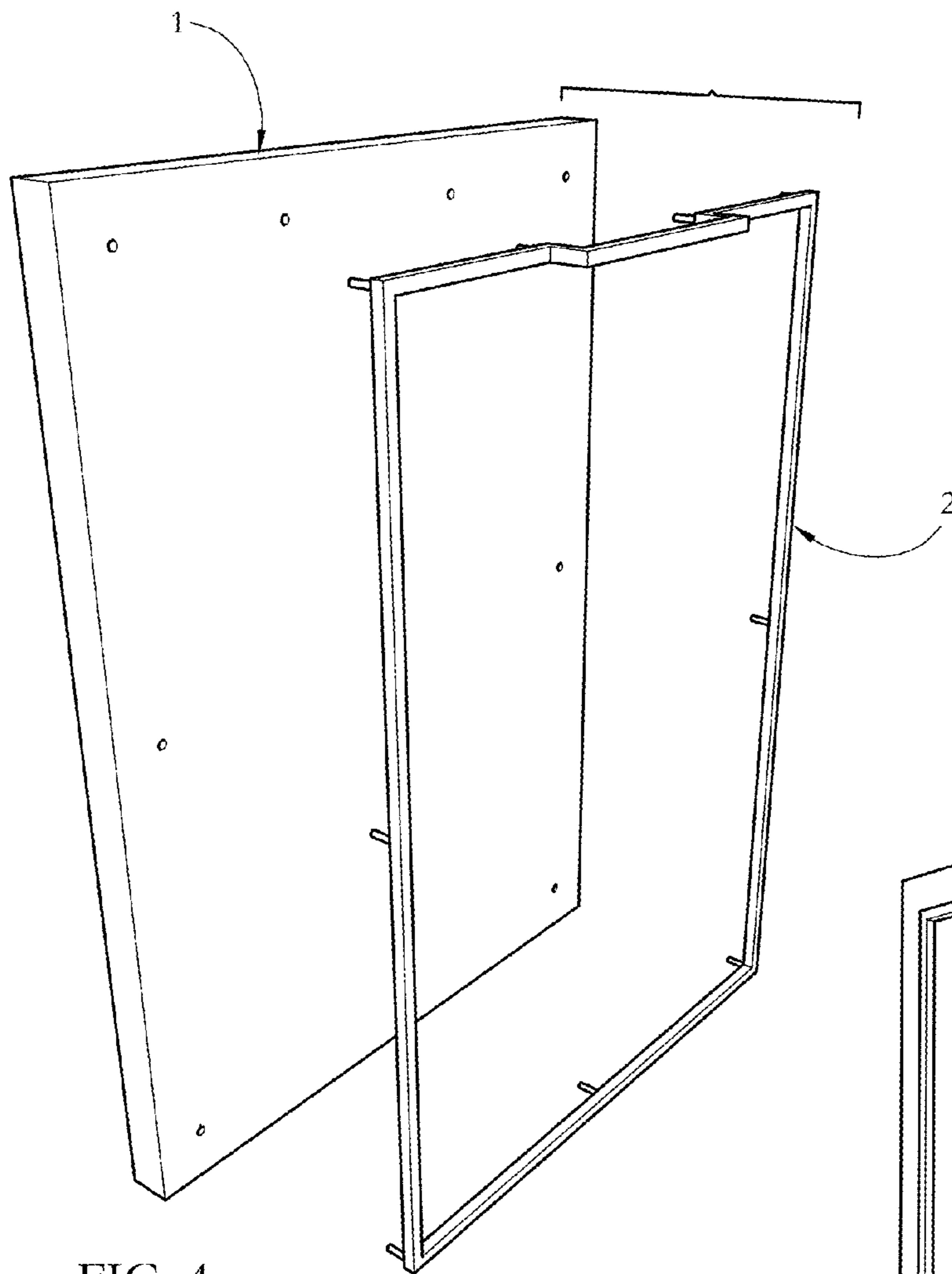

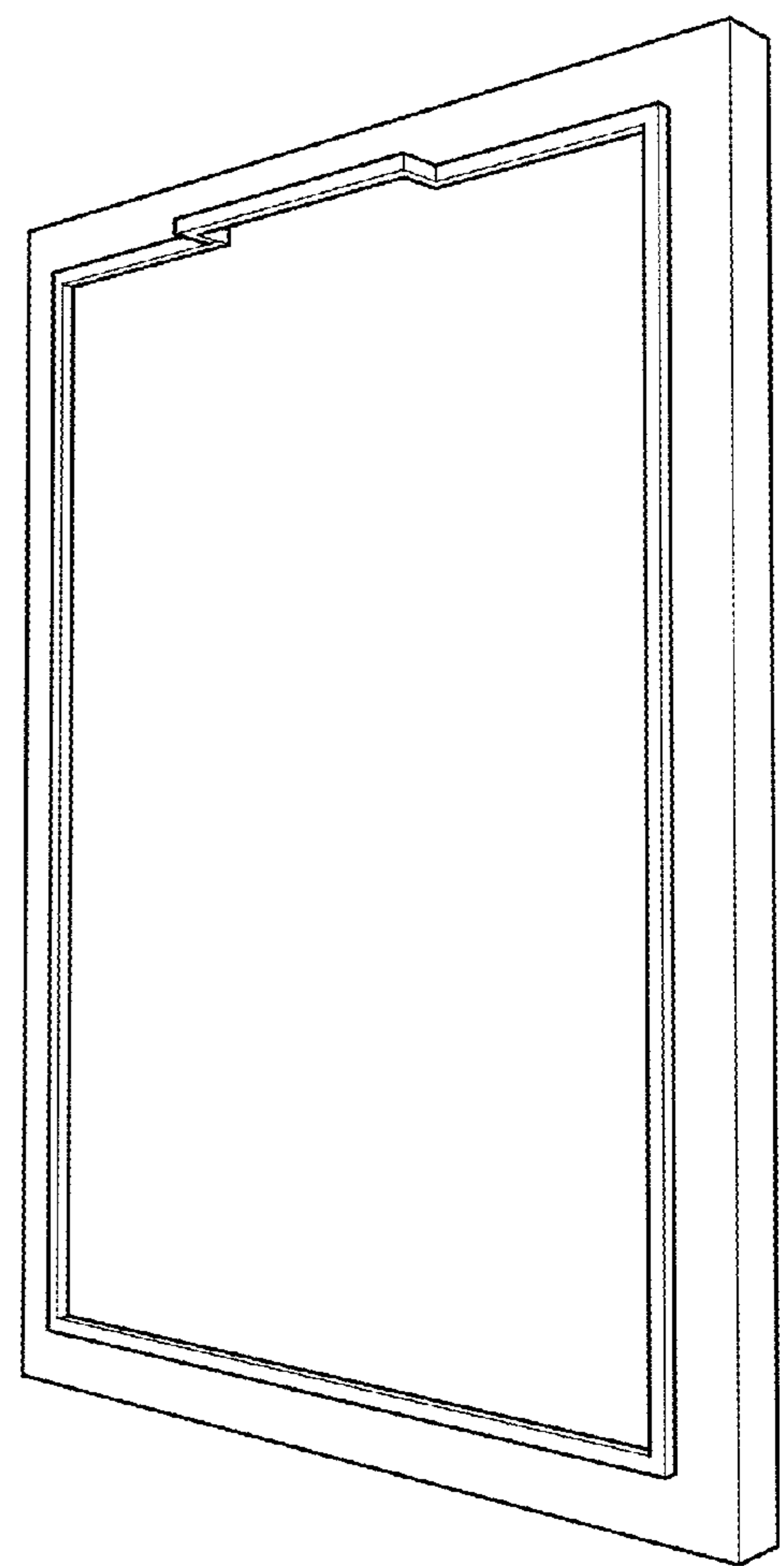

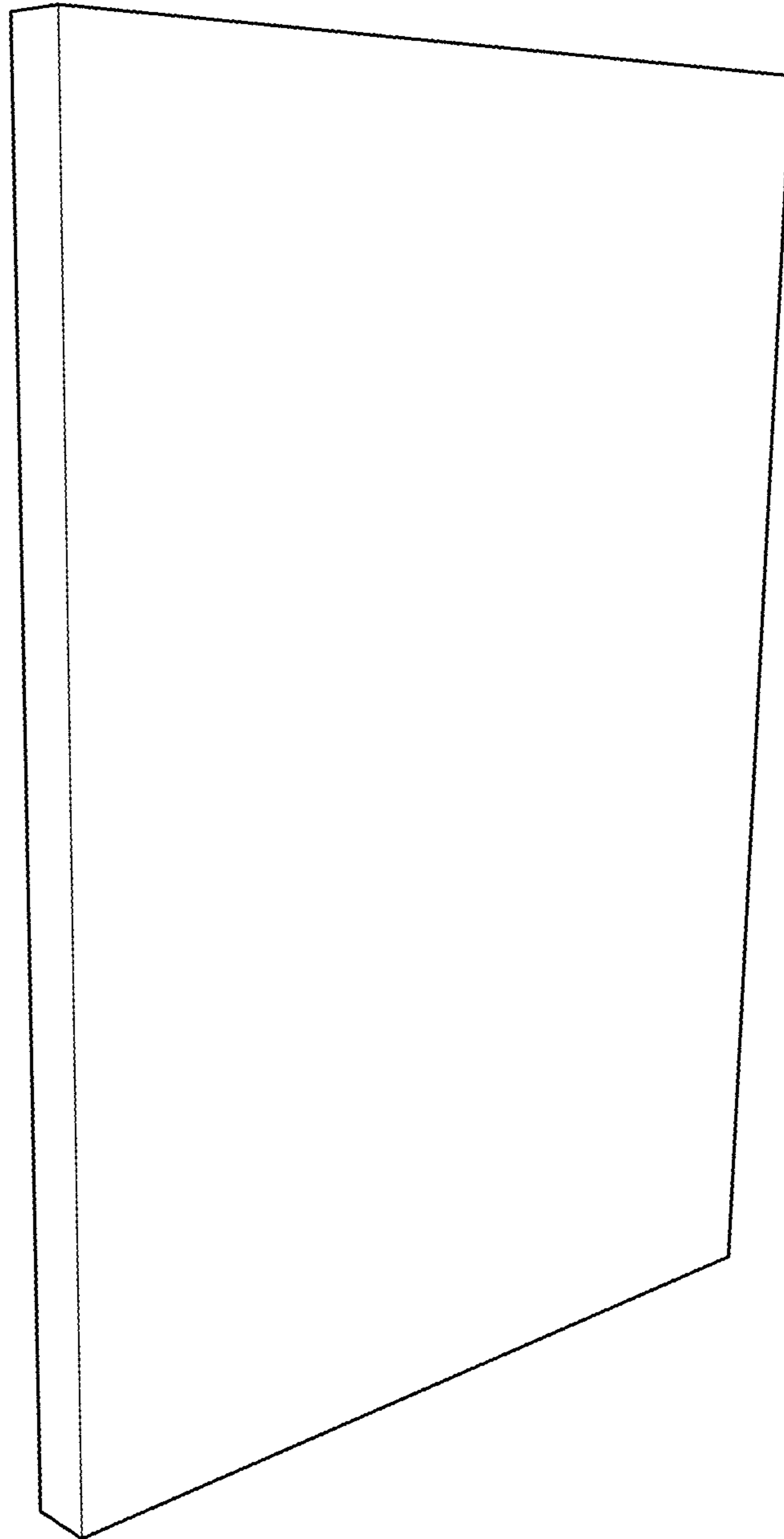
