DESCRIPTION

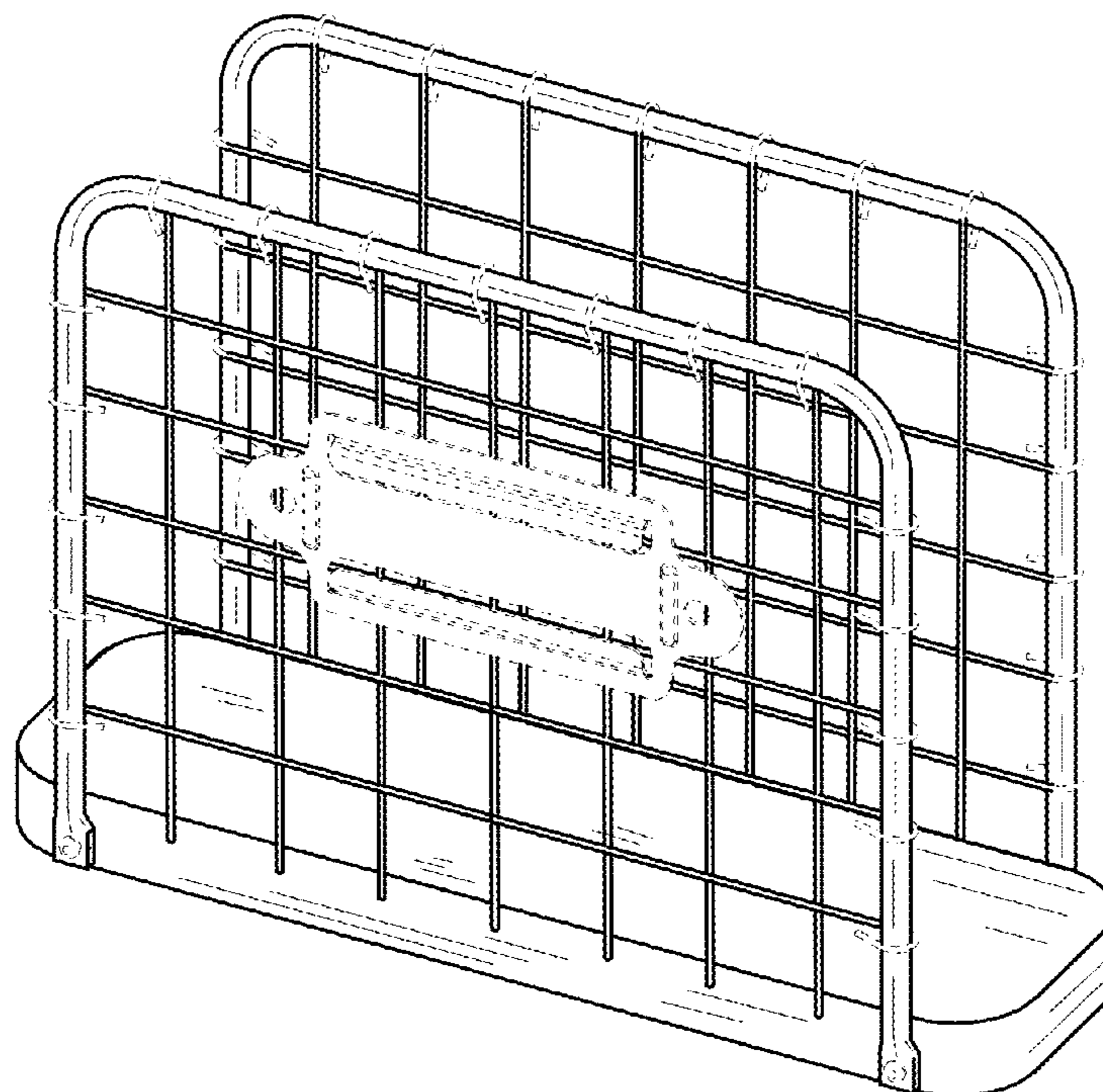
FIG. 1 is a perspective view of a napkin holder showing my

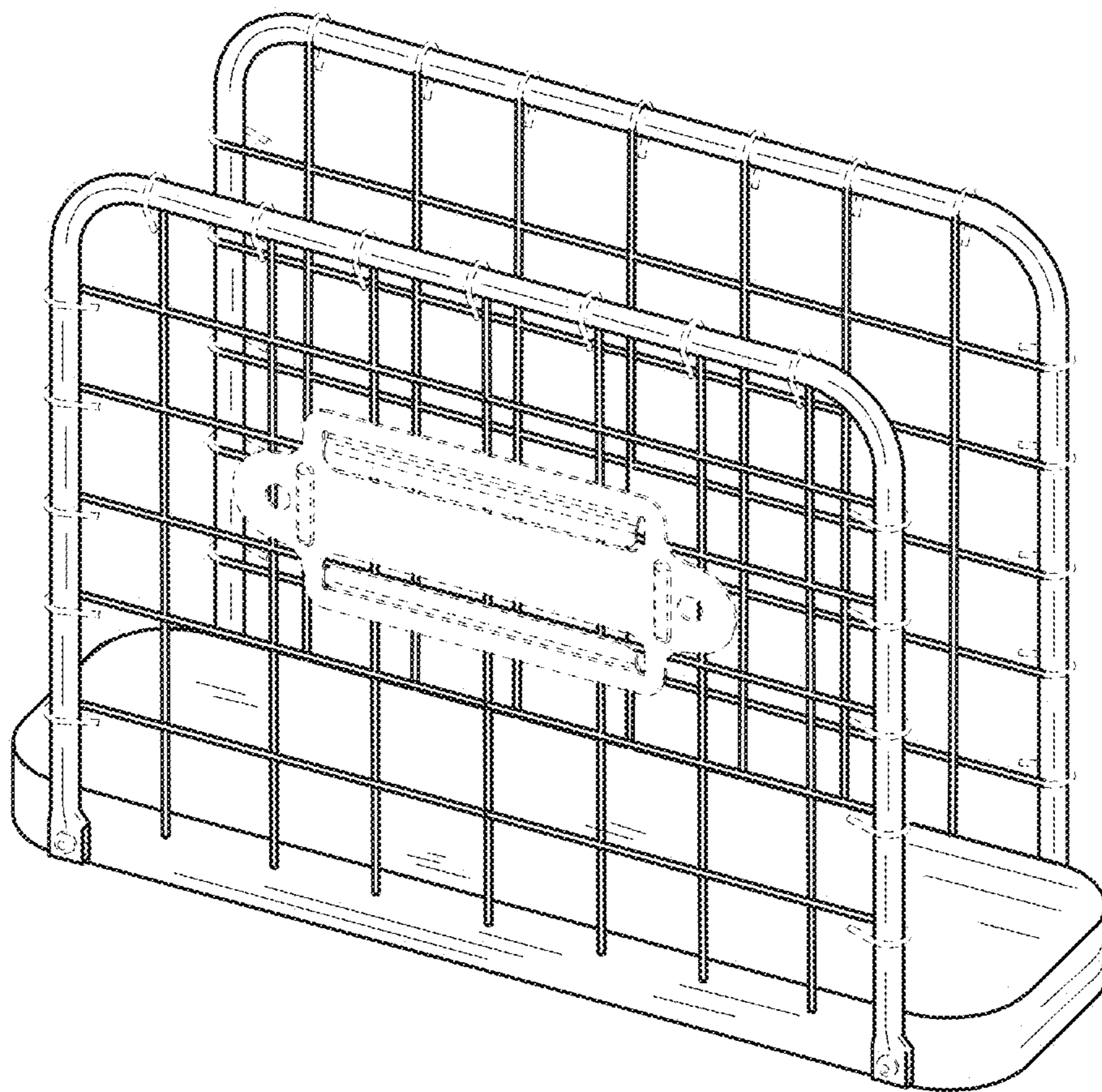

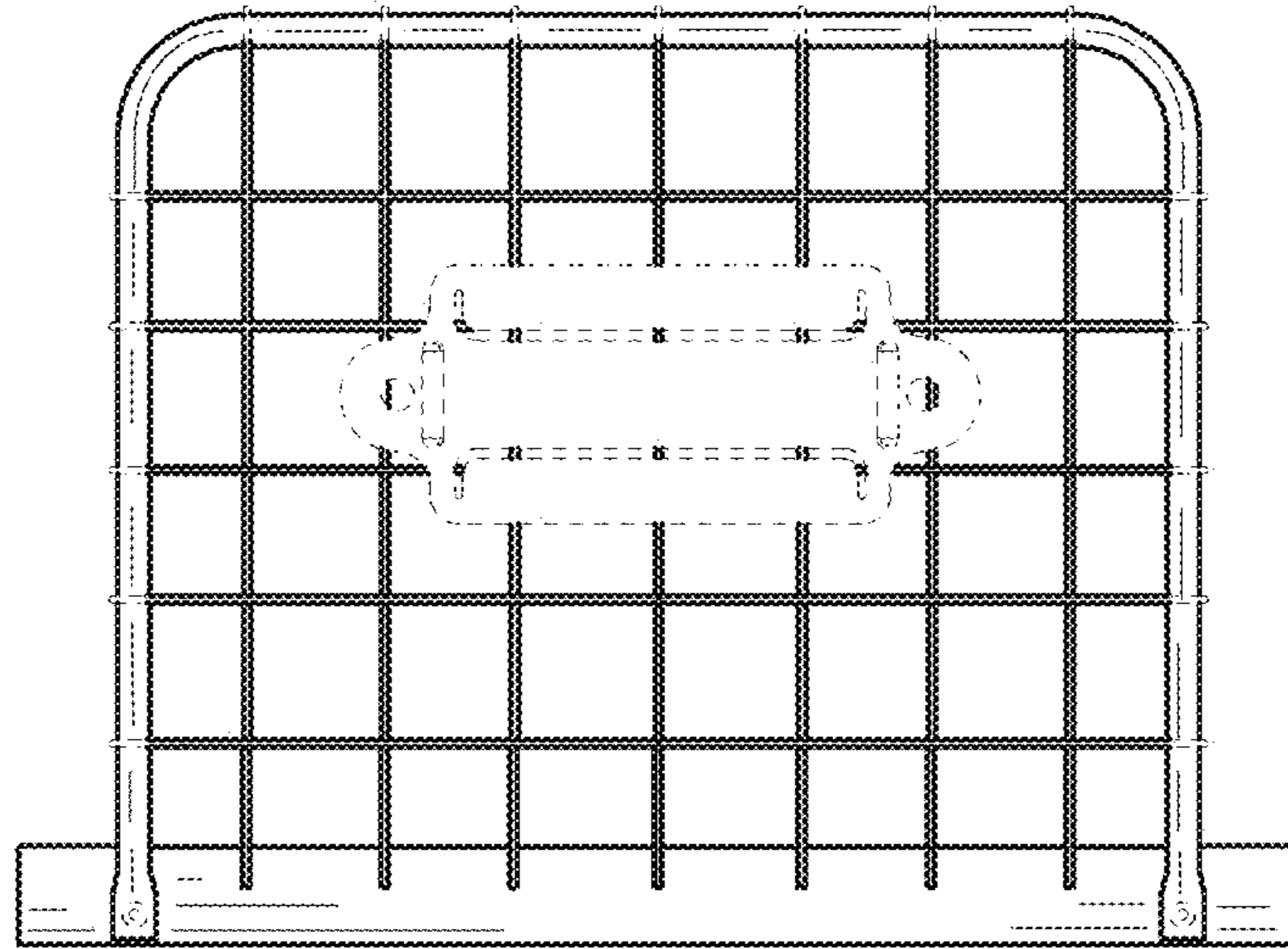

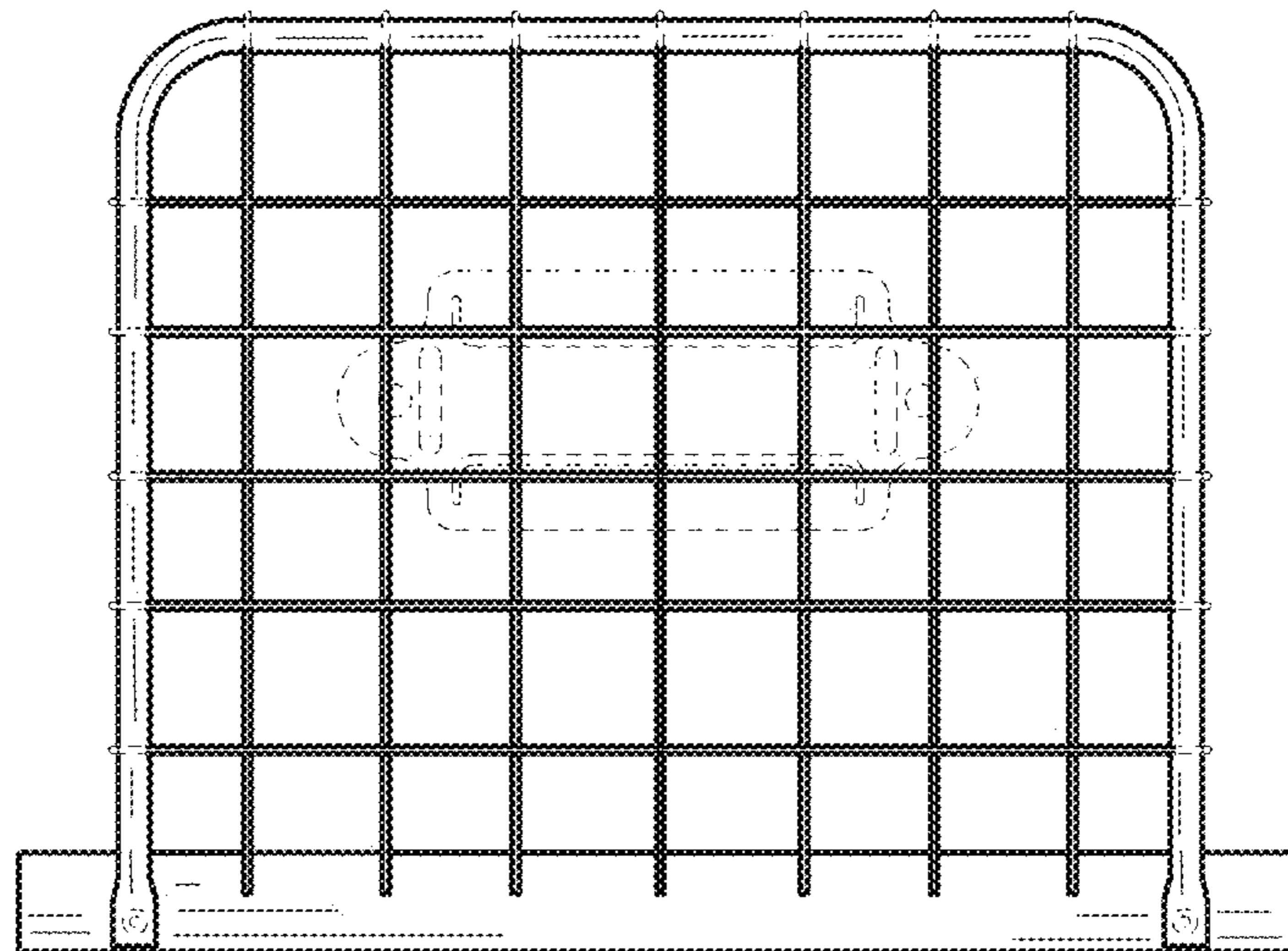

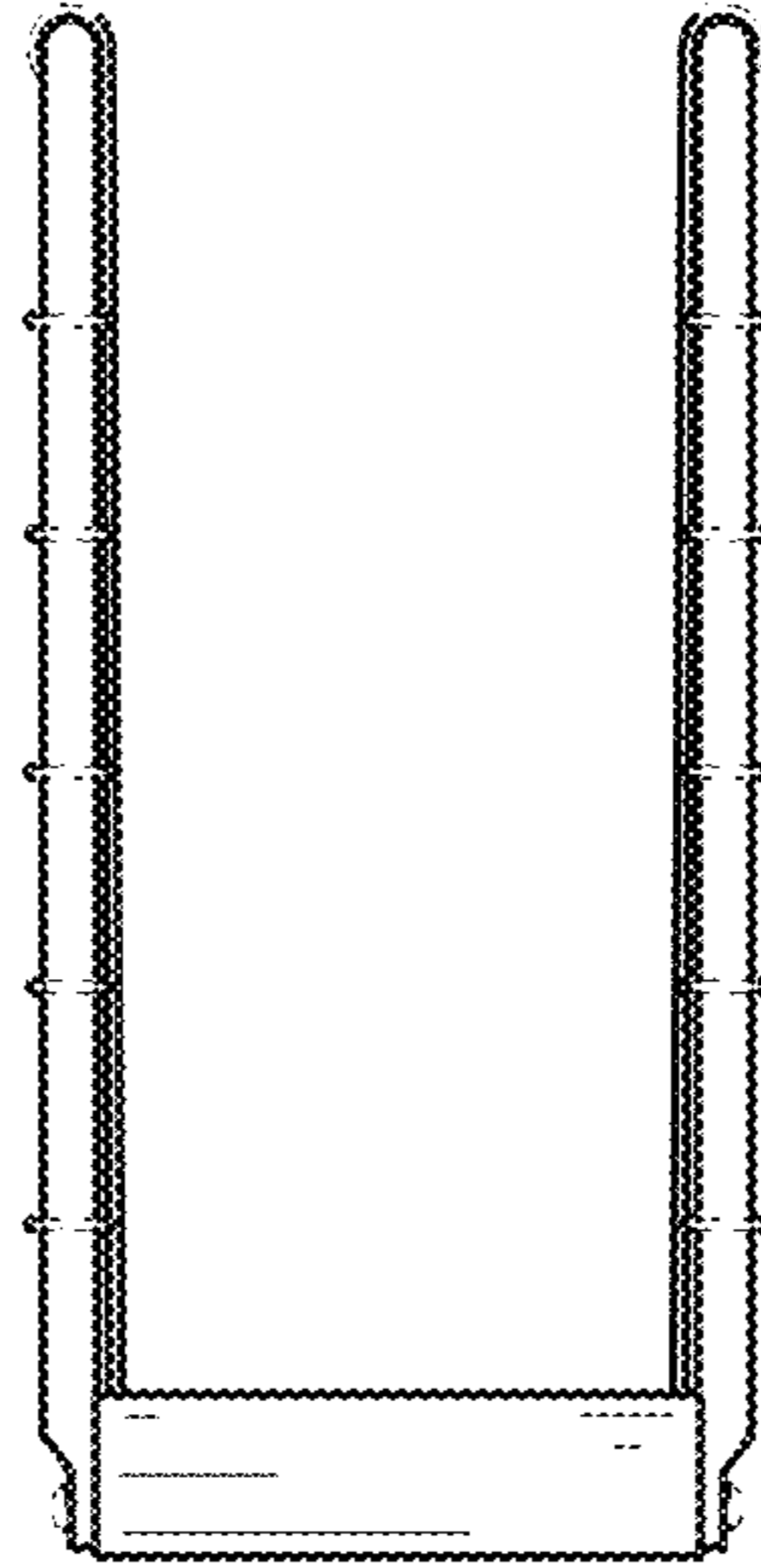

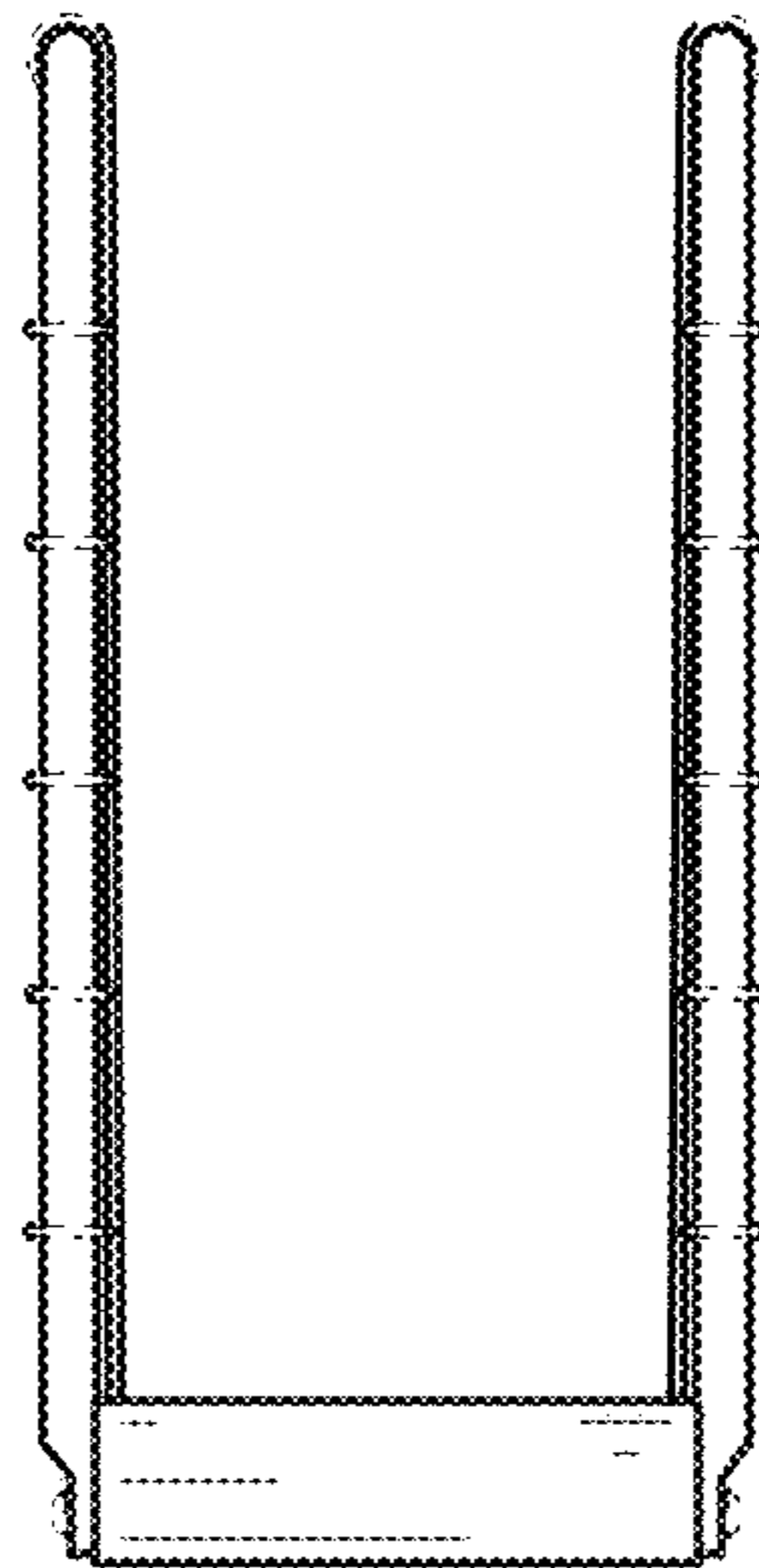

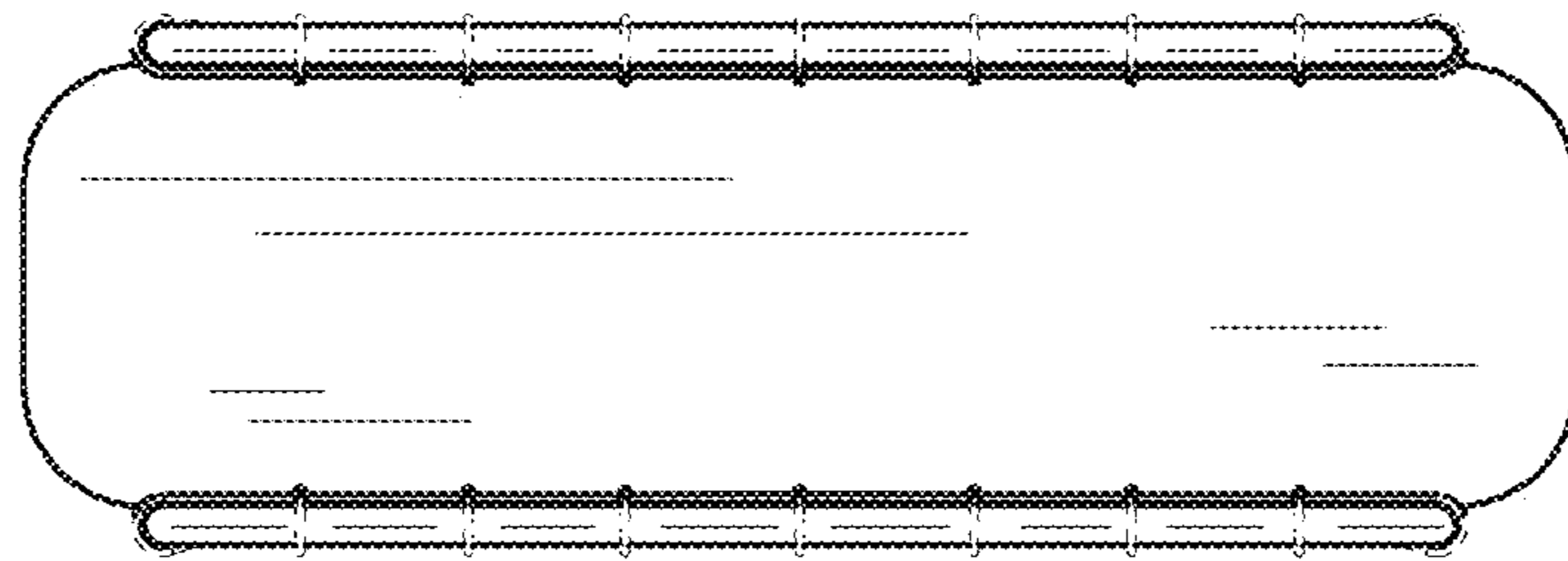

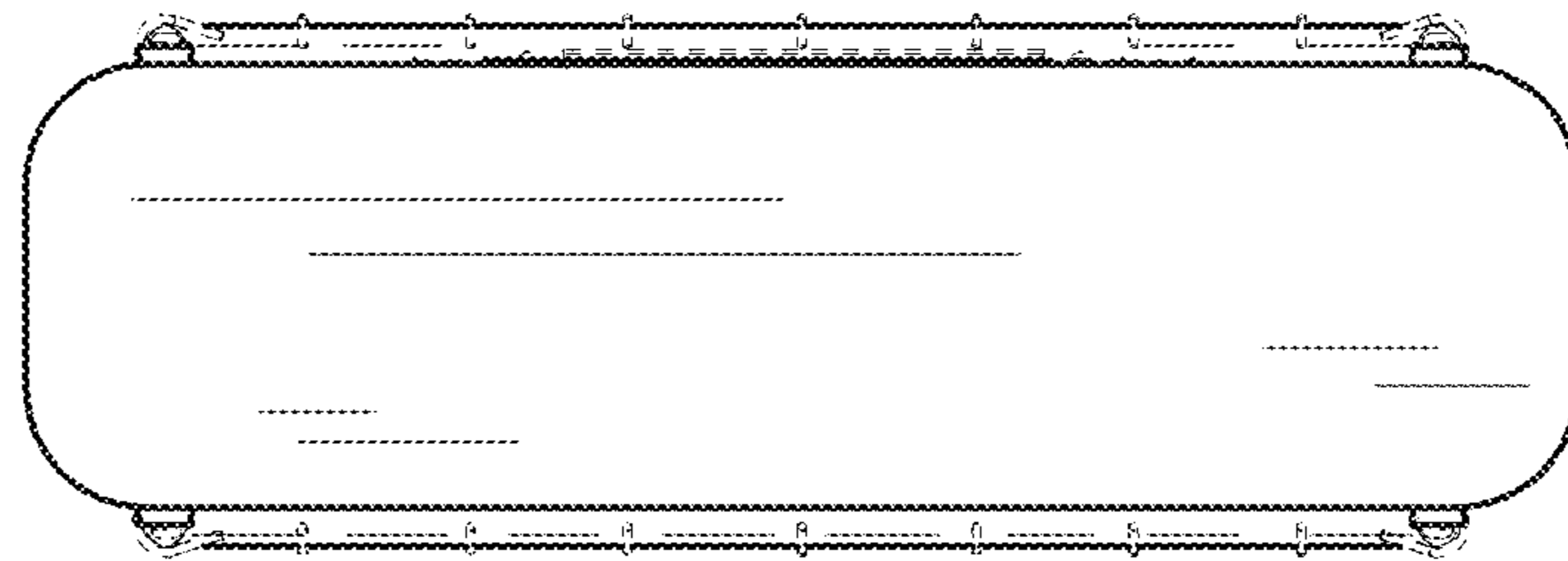
