I claim the ornamental design for a chicken shaped puree food mold, as shown.

**DESCRIPTION**

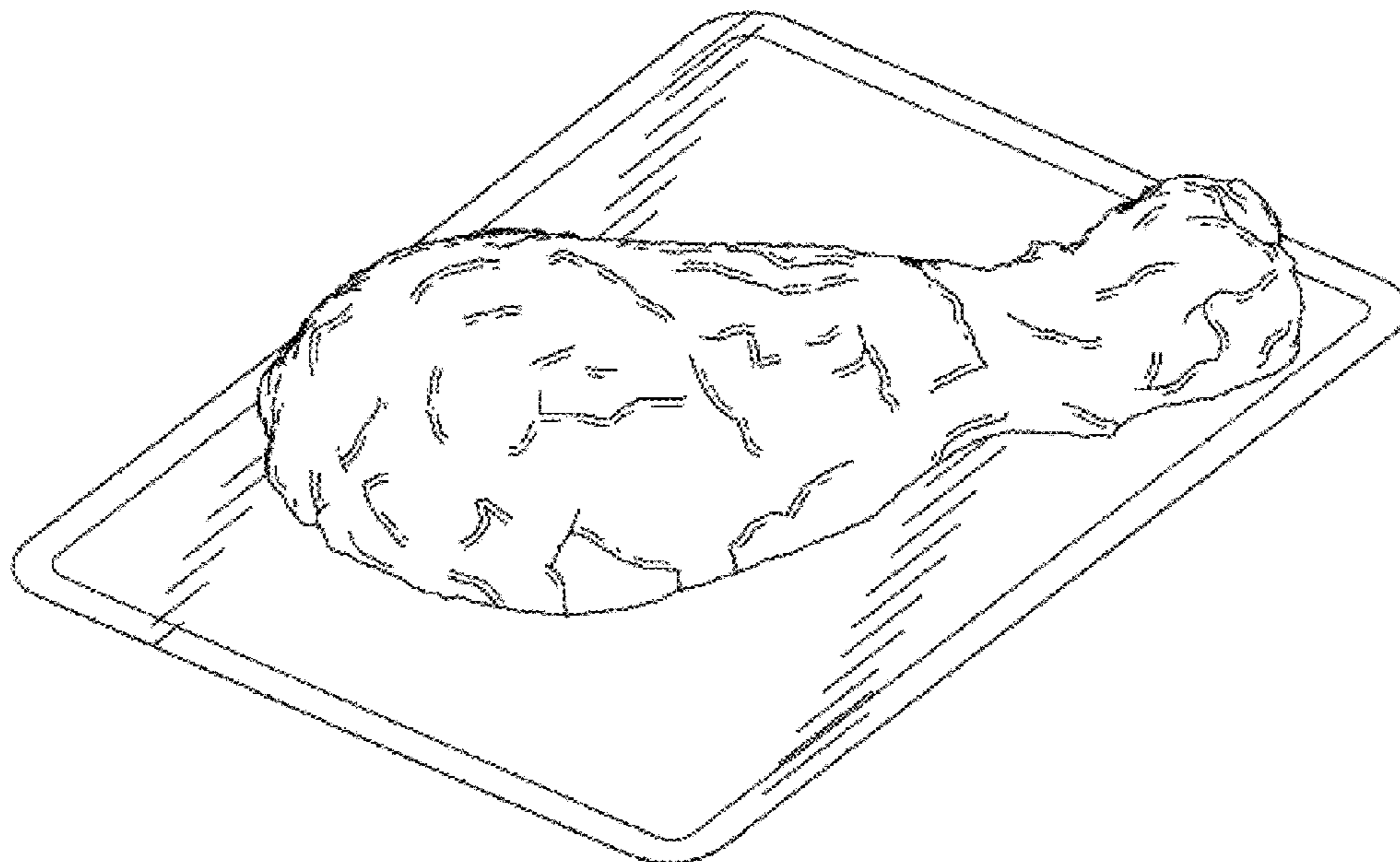

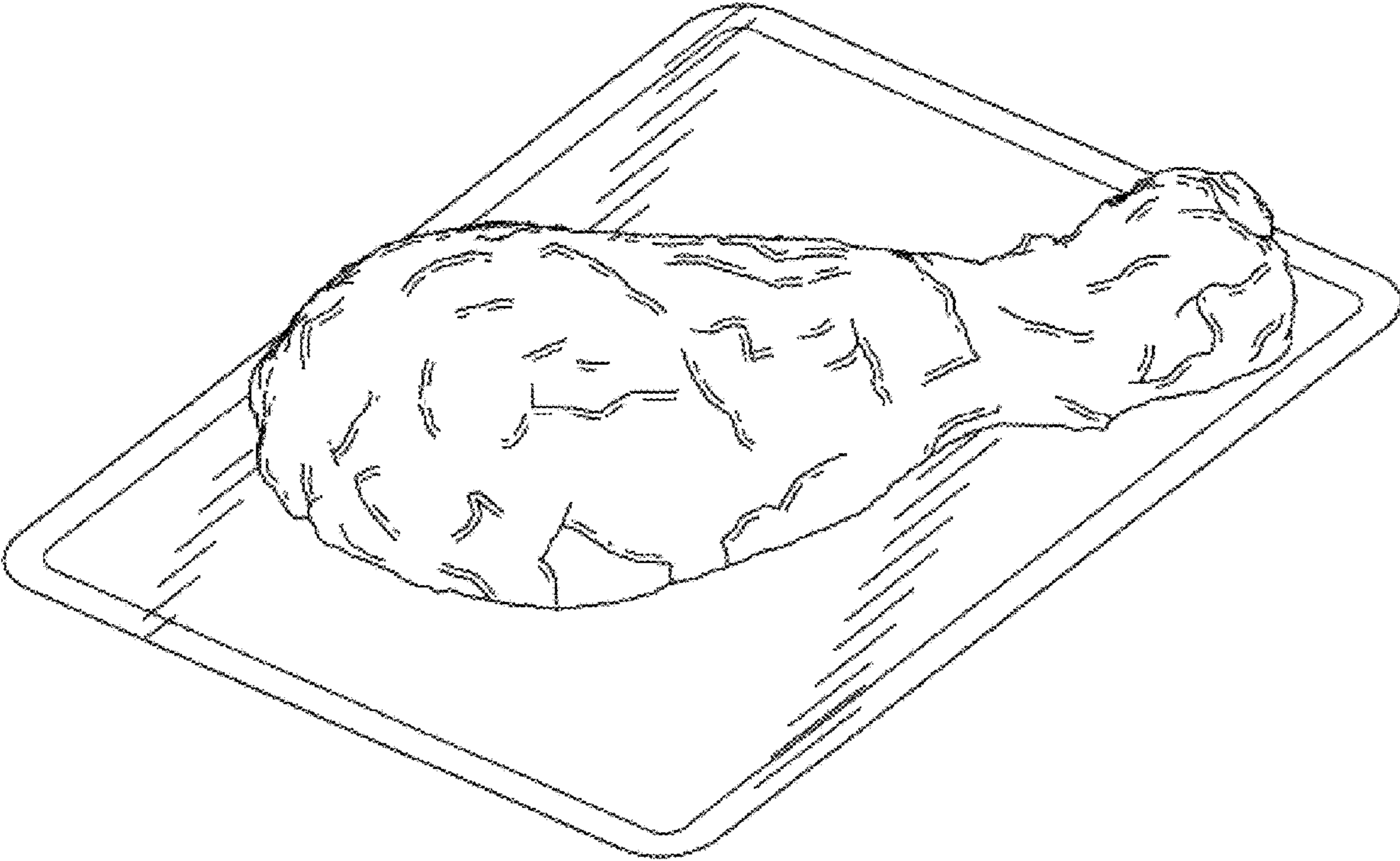

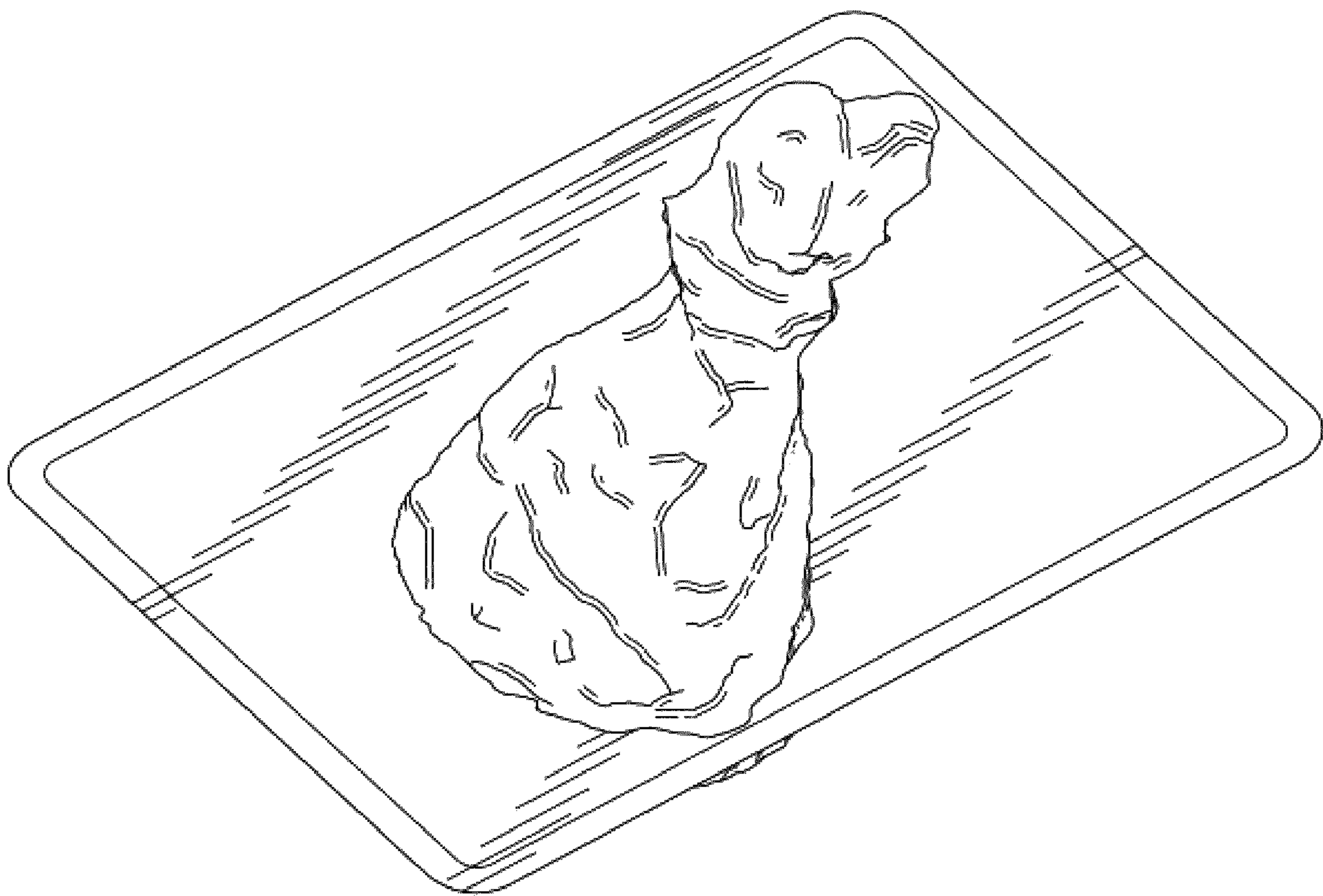

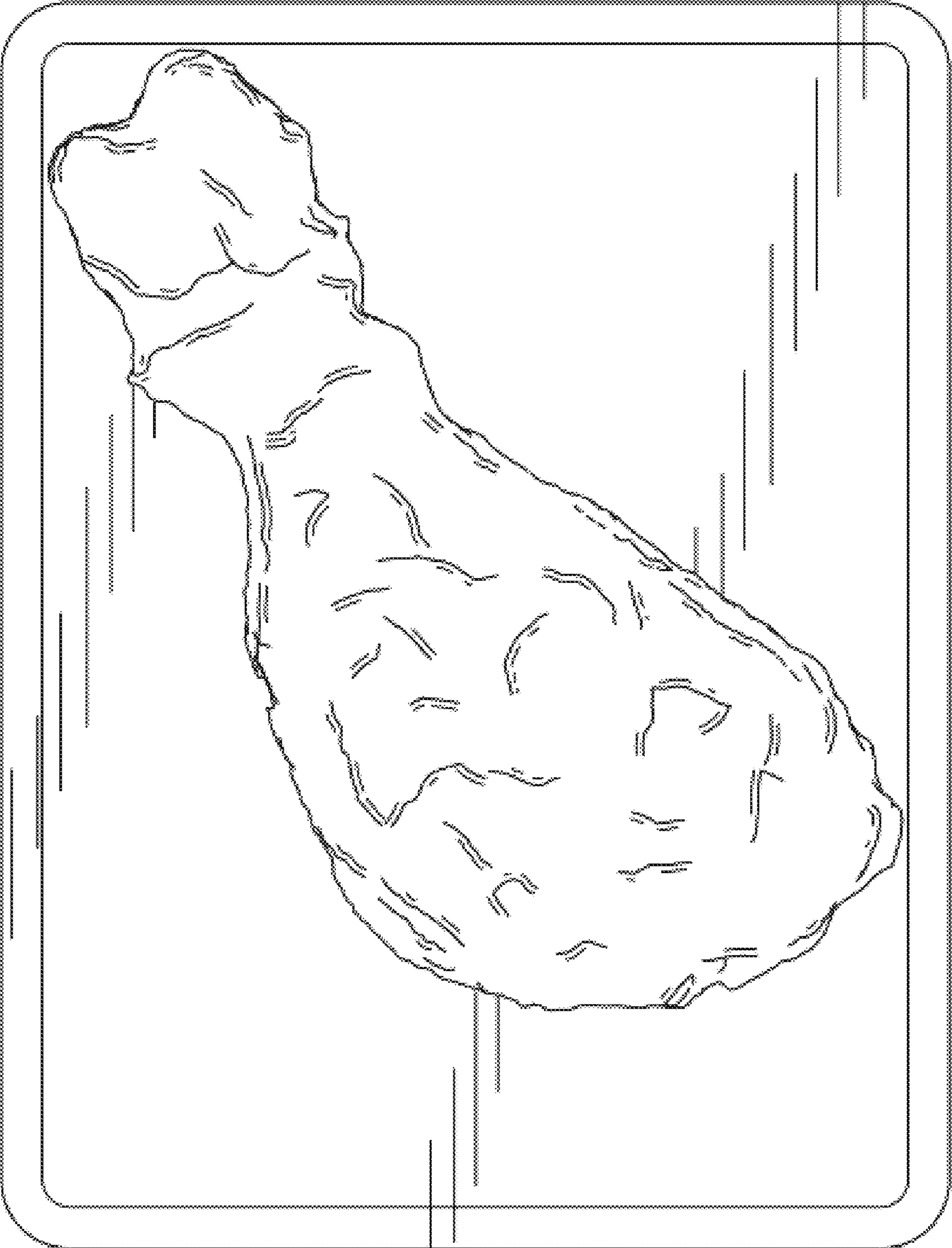
