(57) **CLAIM**

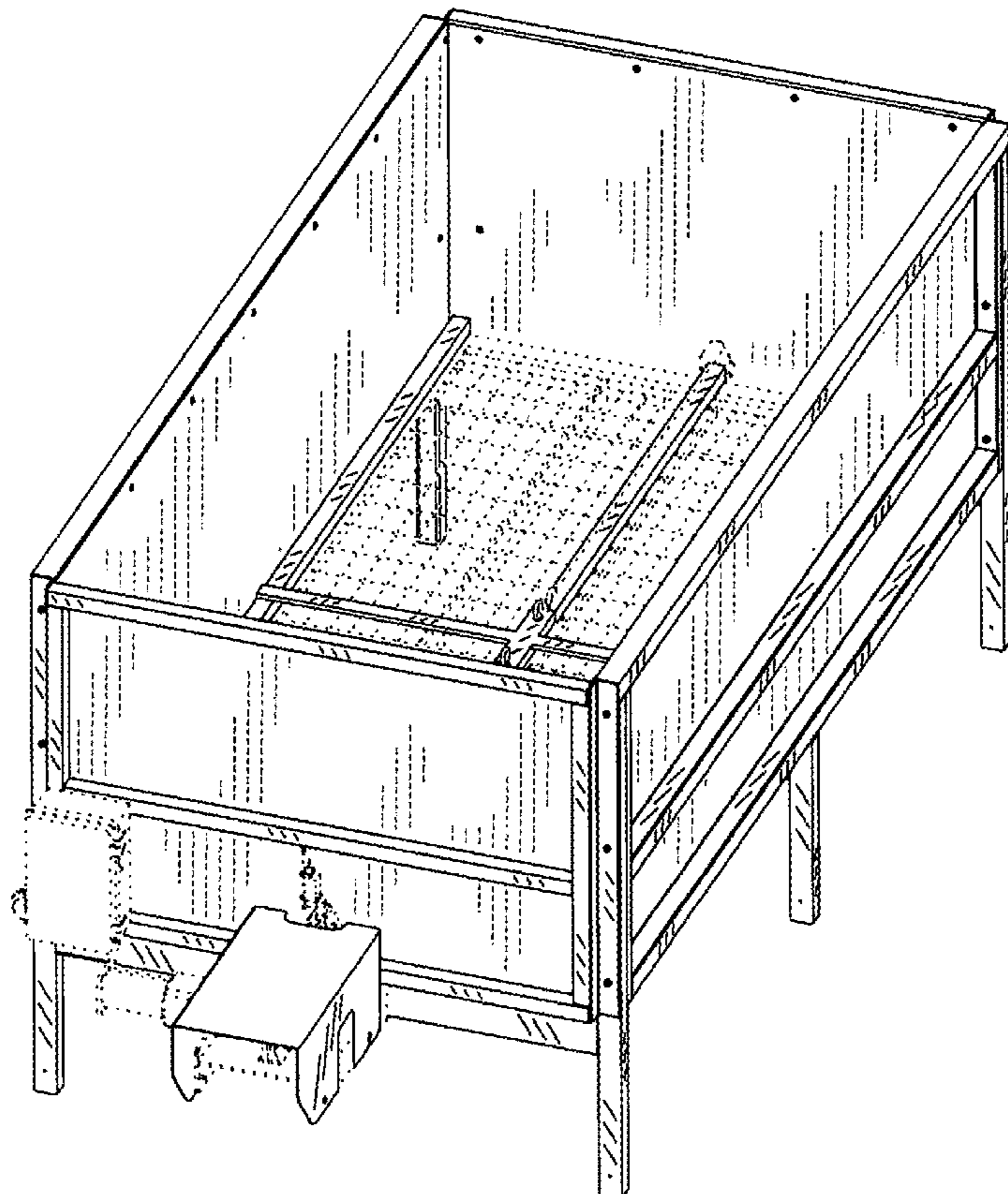
The ornamental design for a vermicomposter bin with guide rails, as shown and described.

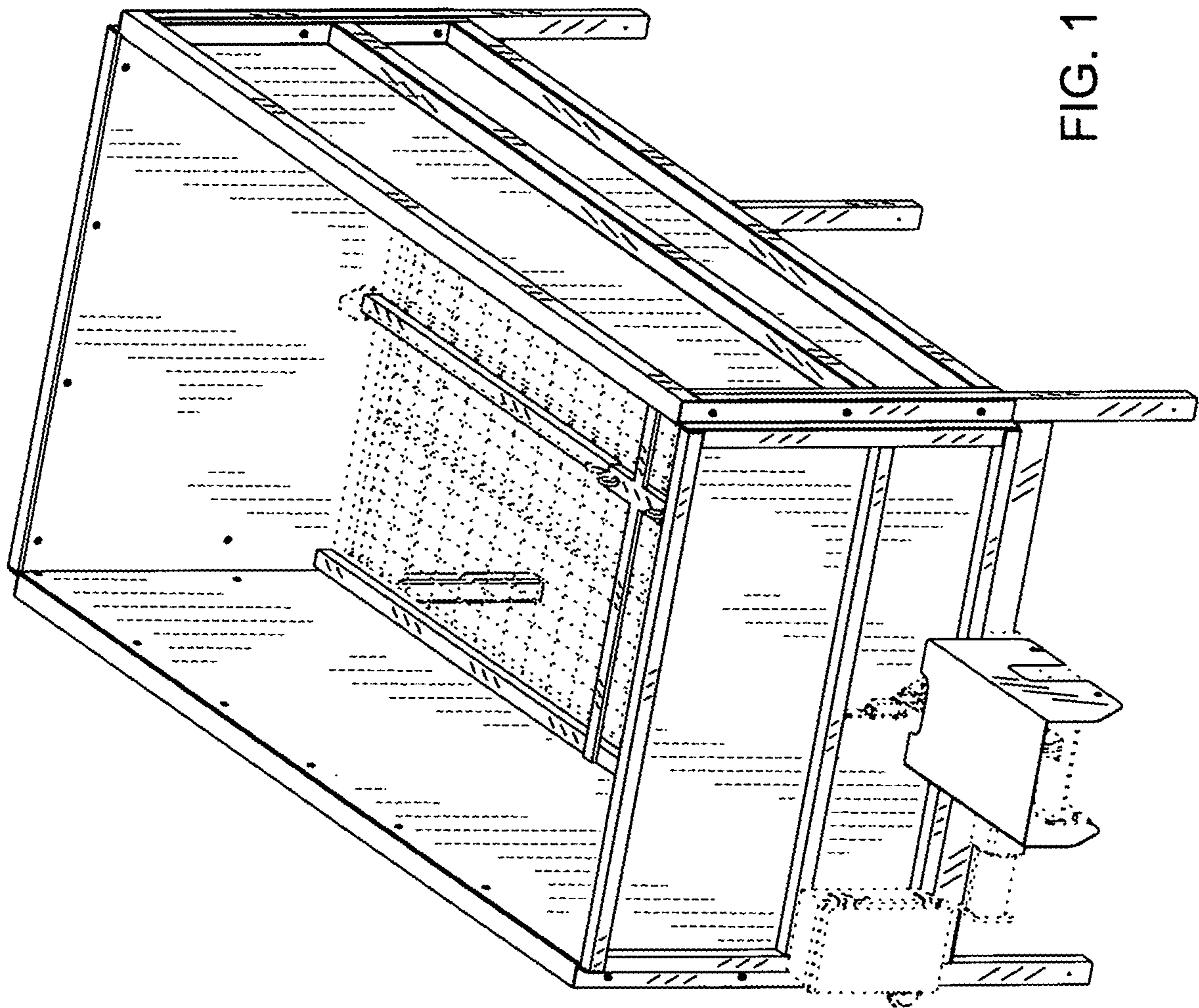

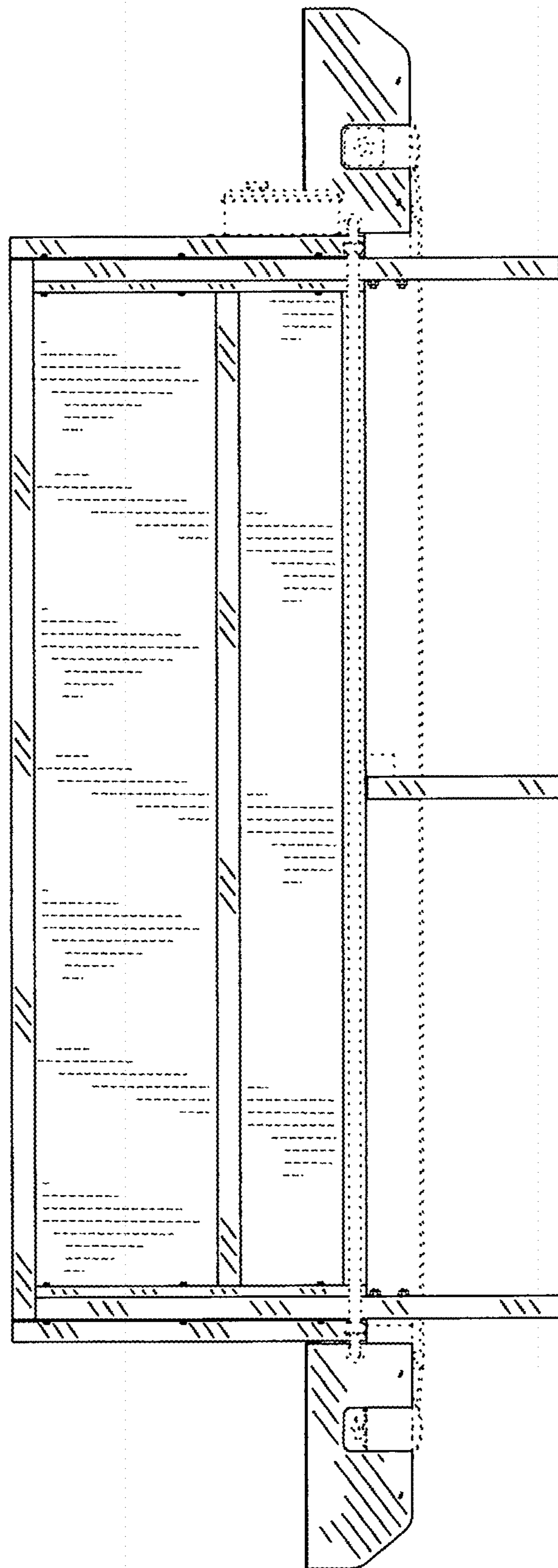

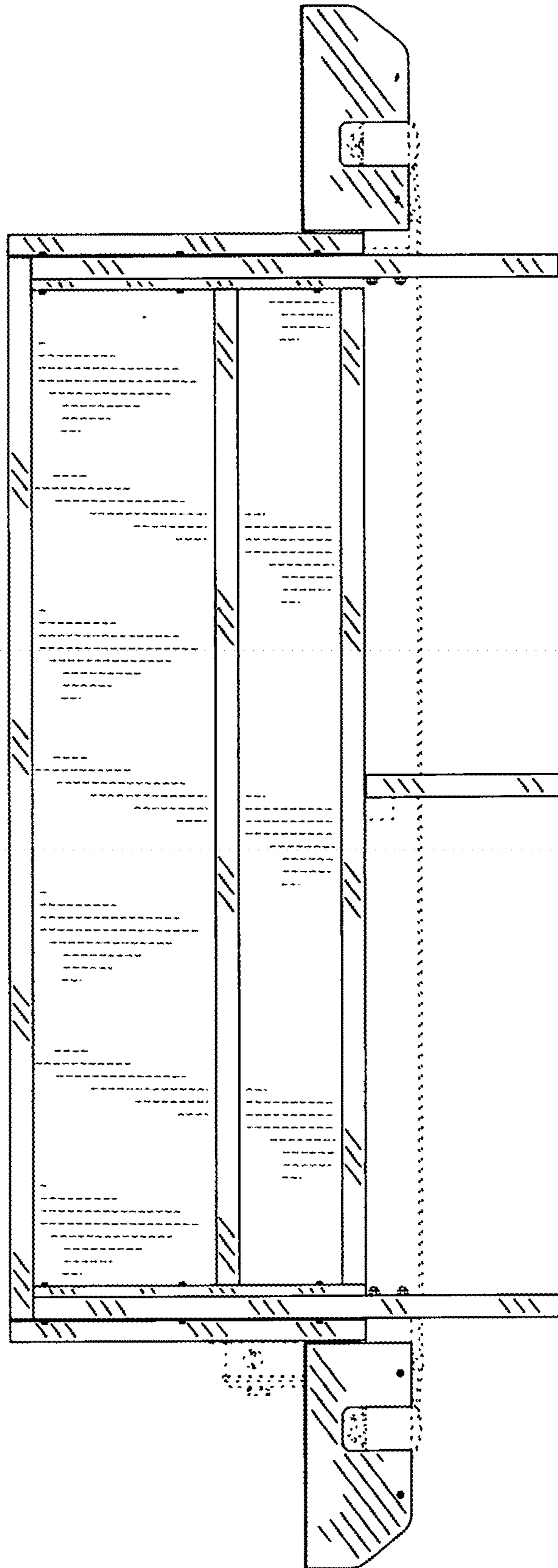

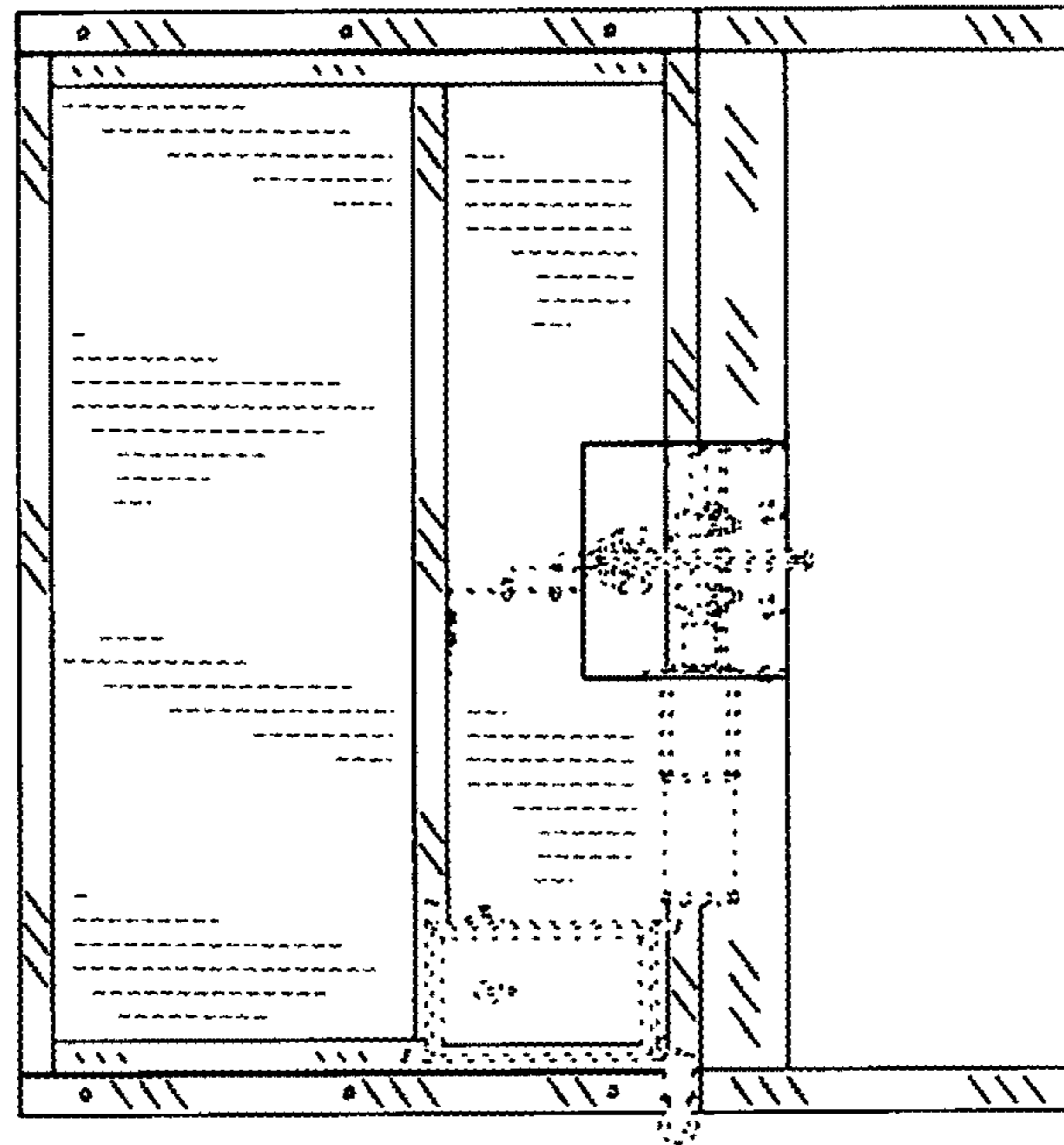

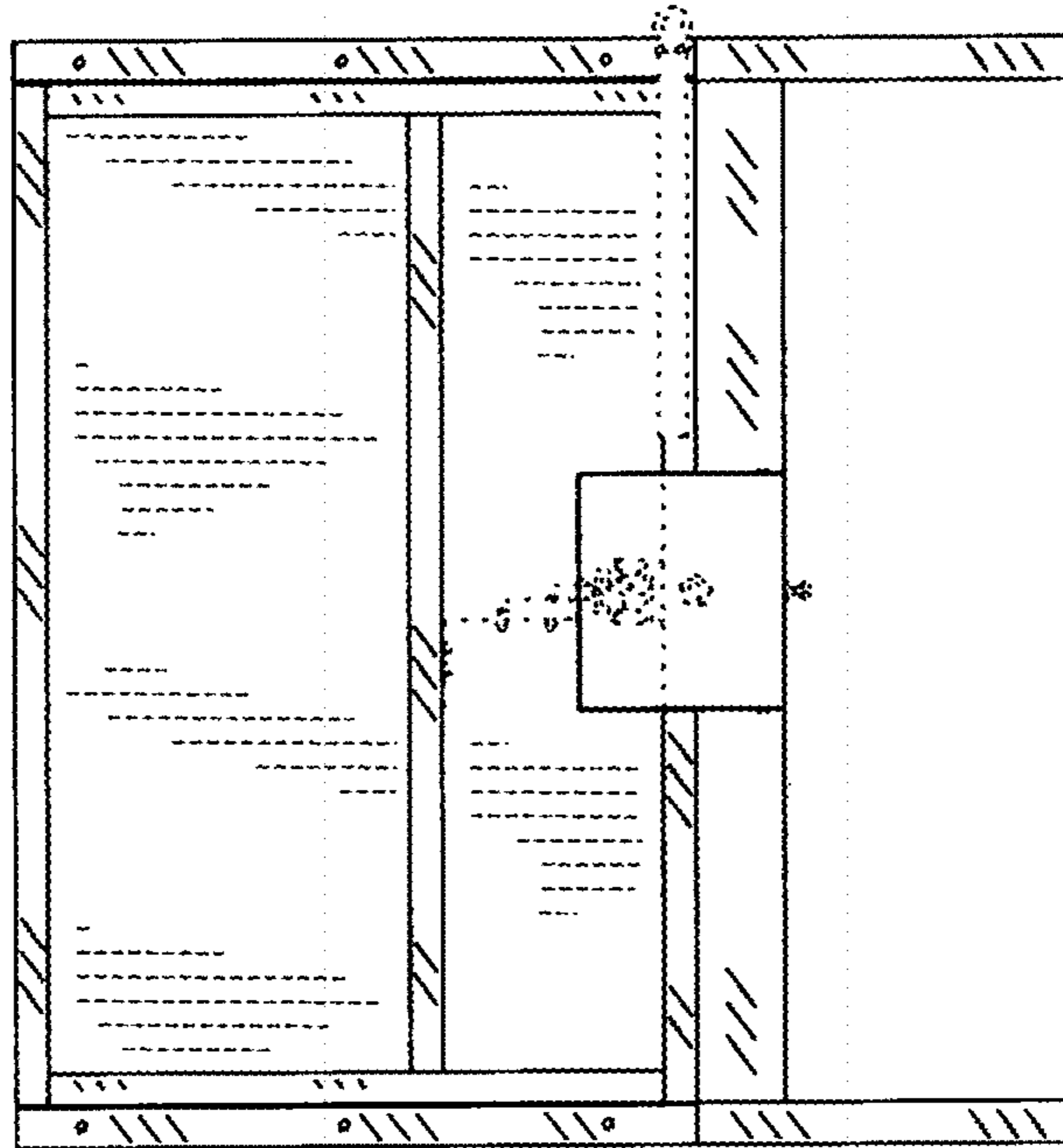

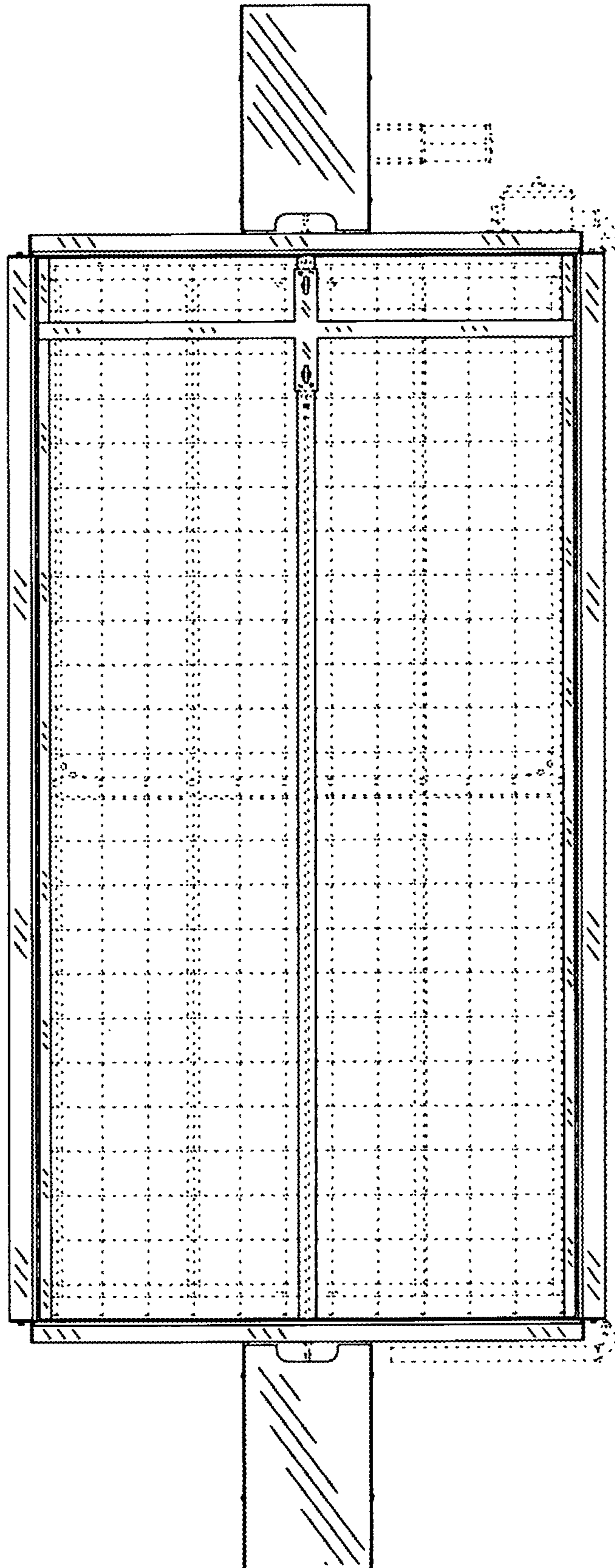

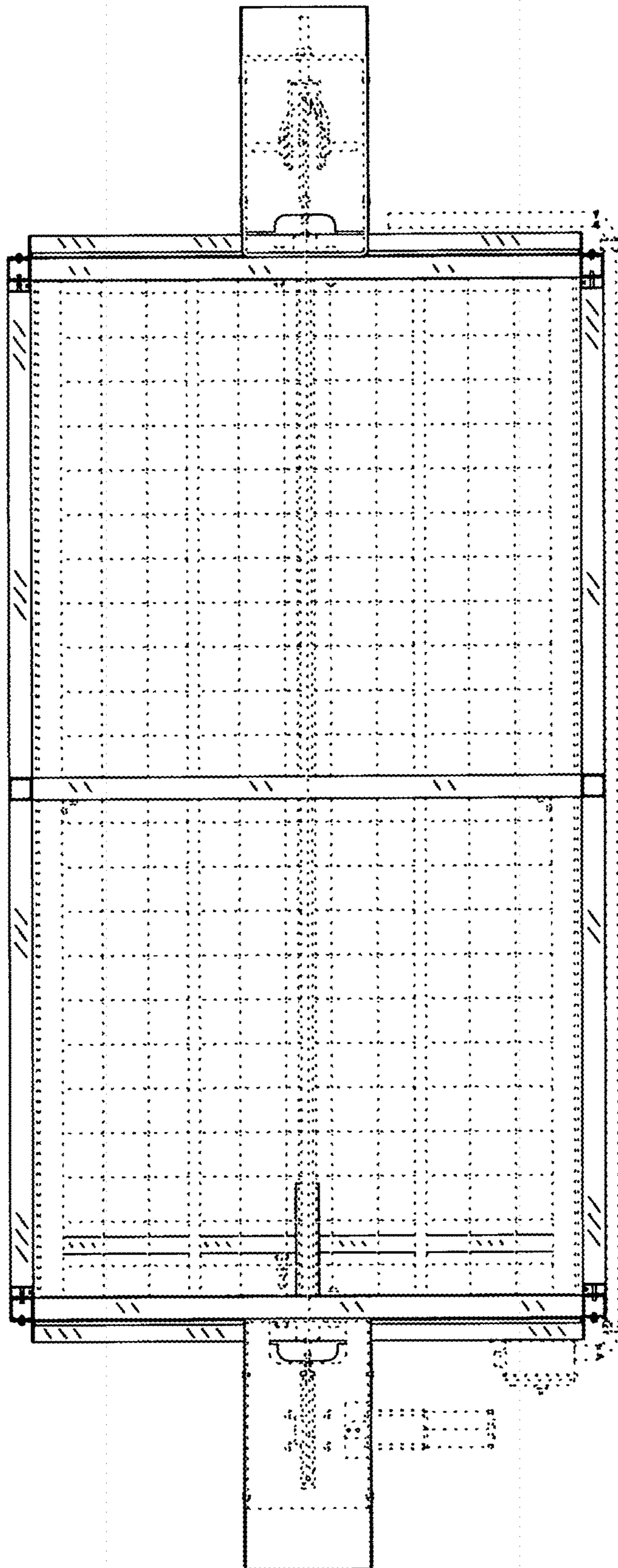
