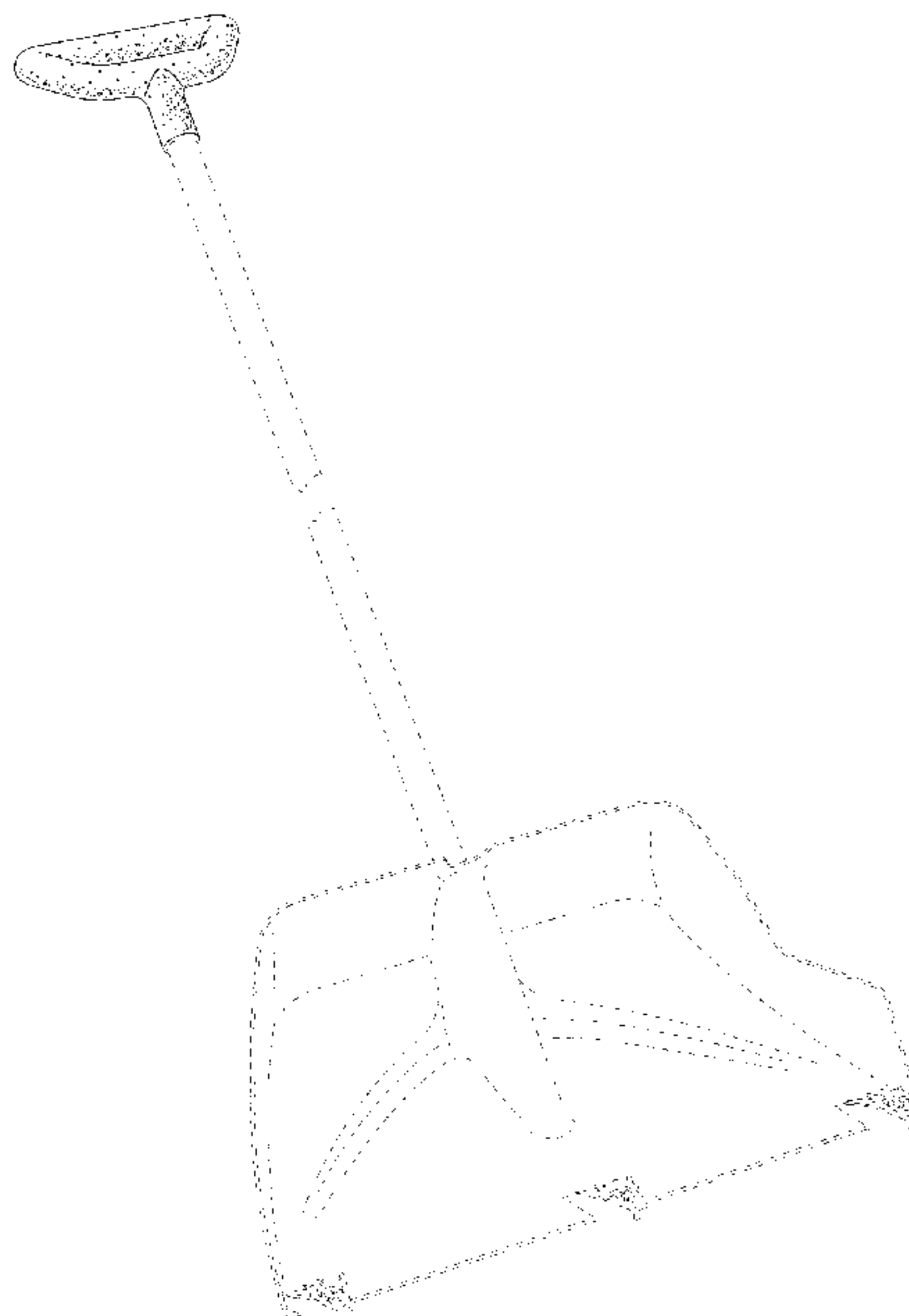
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a handle showing, in particular, the ornamental design thereof.

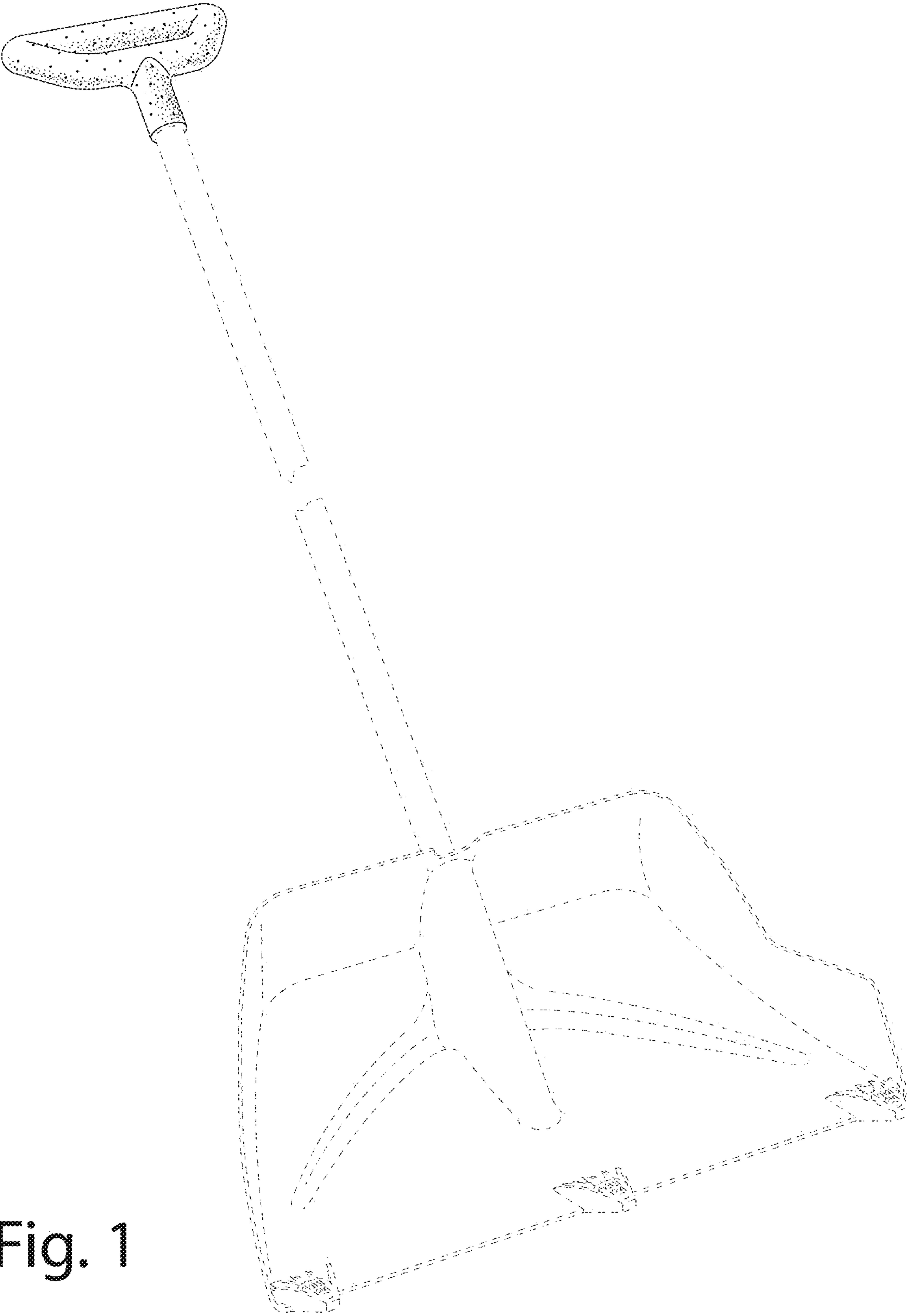

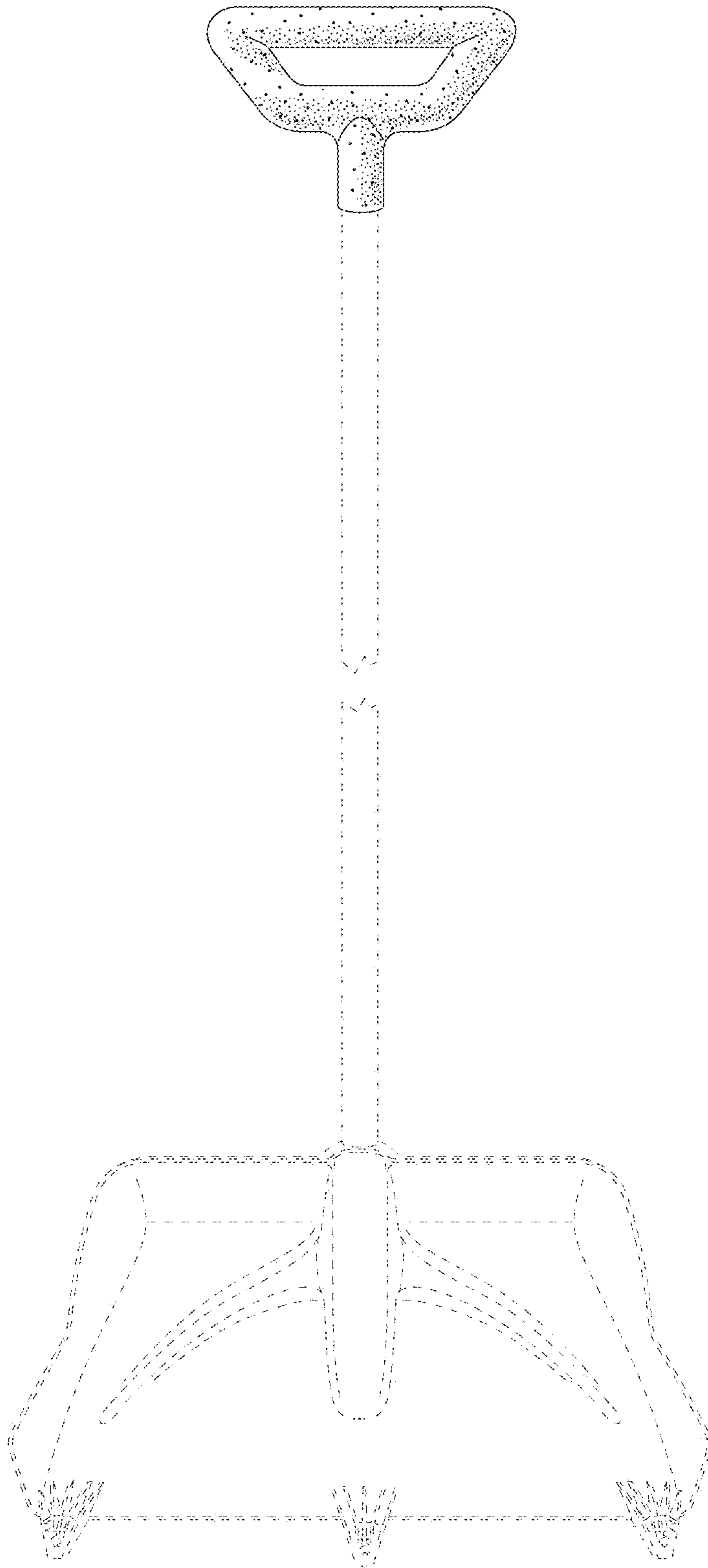

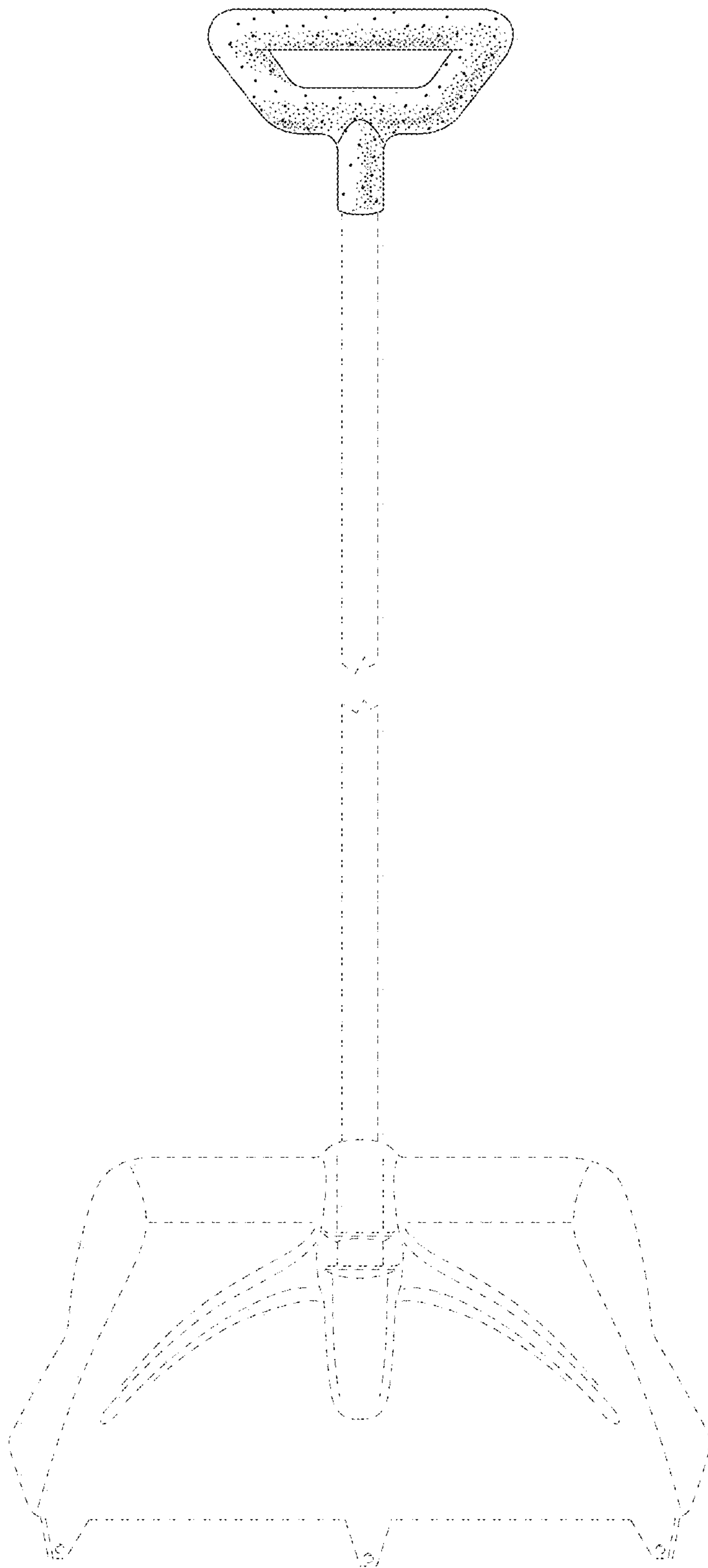

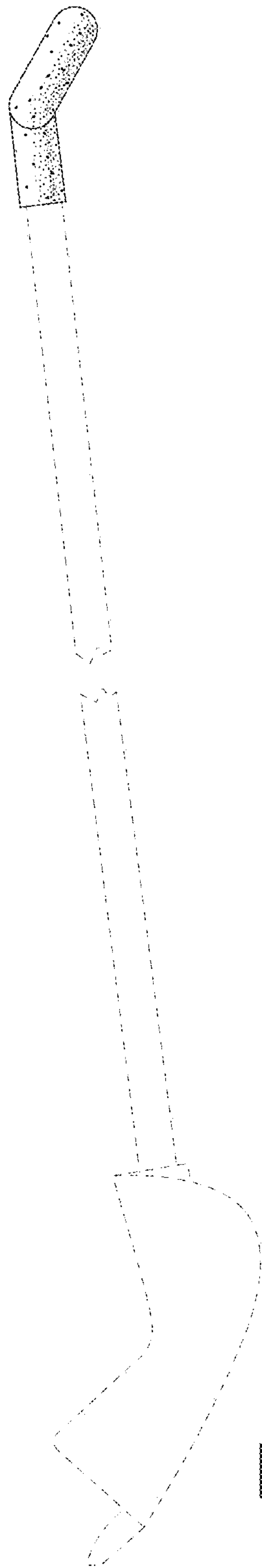
