**DESCRIPTION**

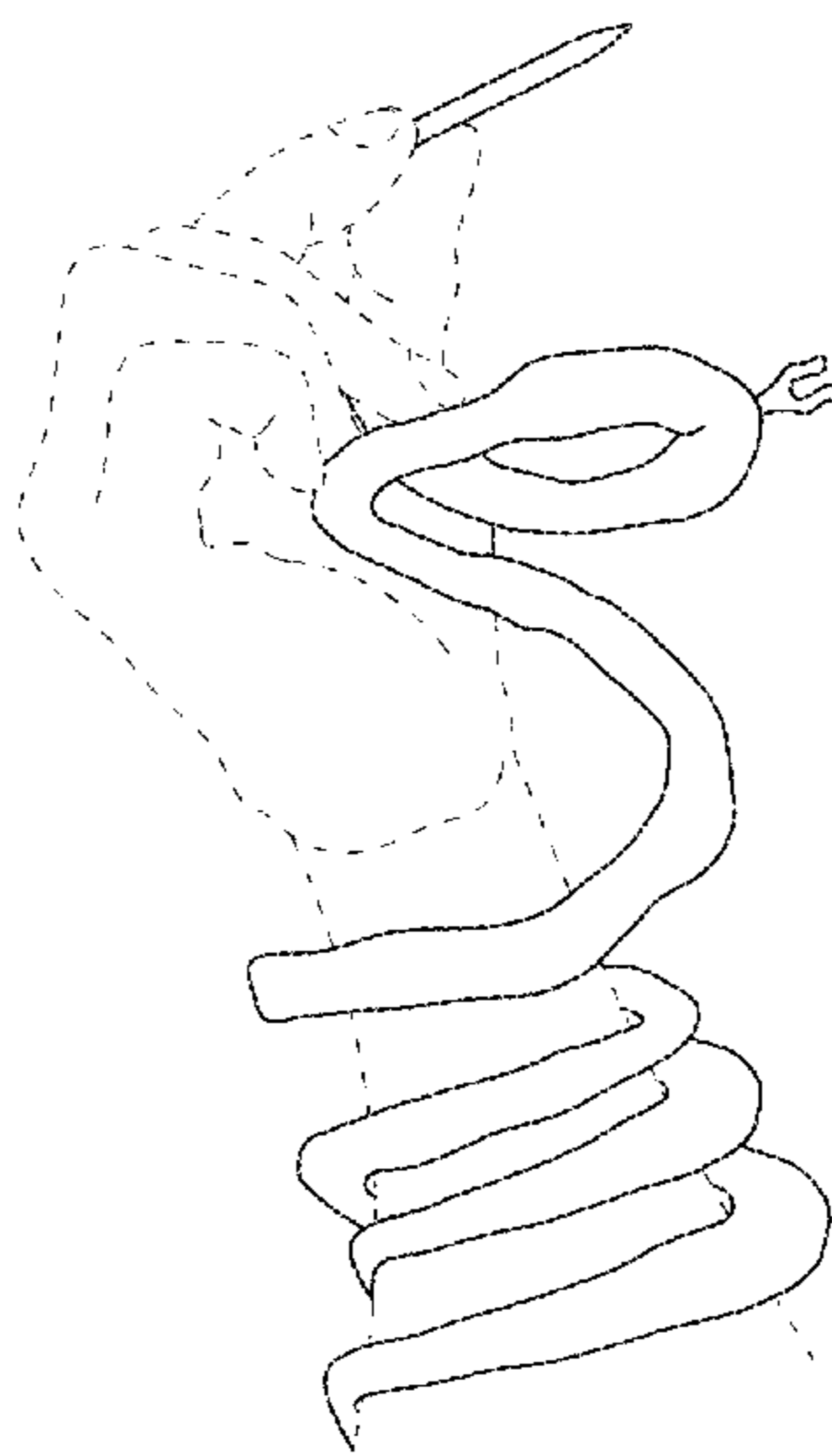
FIG. 1 is a perspective view of the bracelet with integrated hair pick.

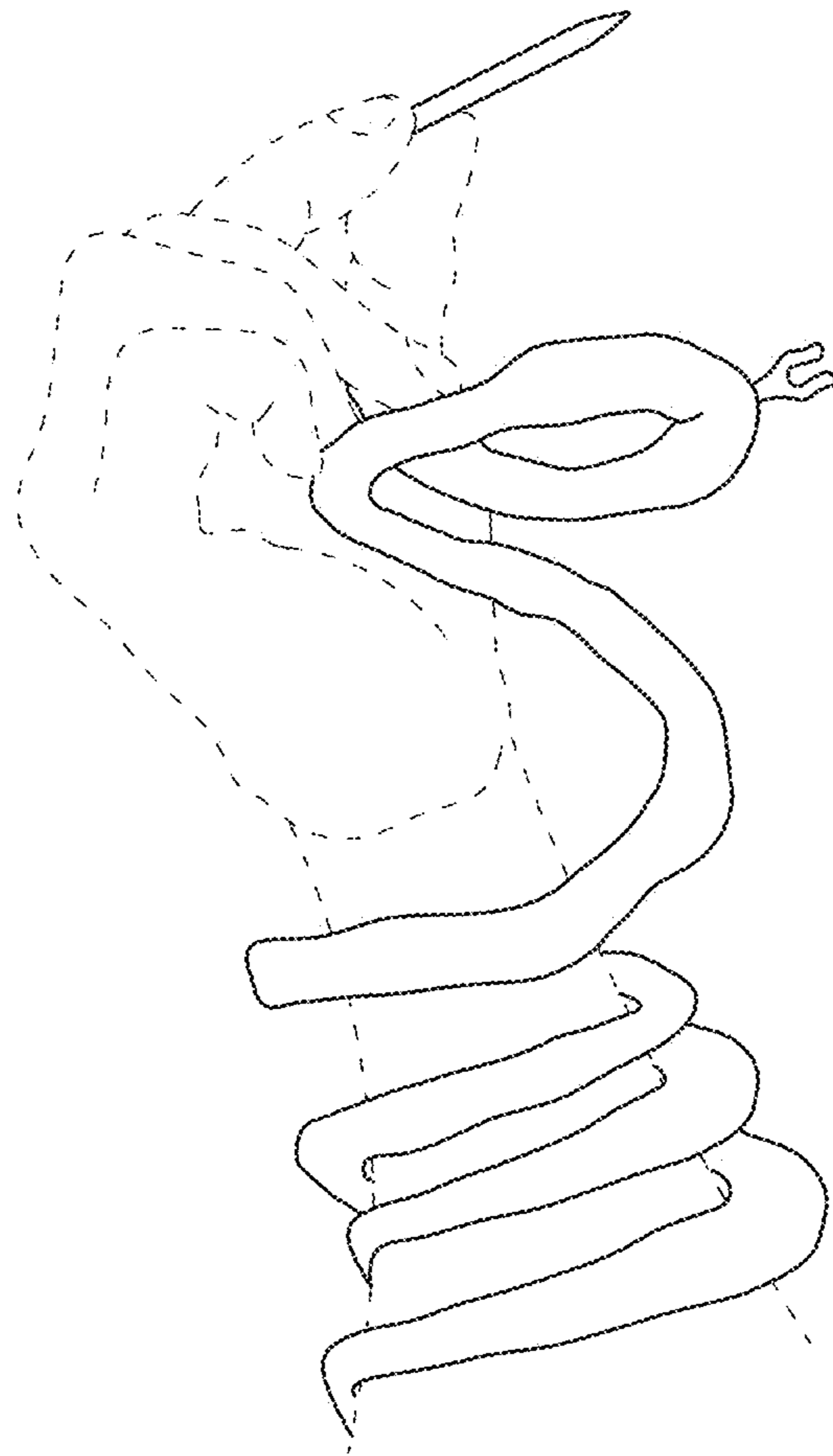

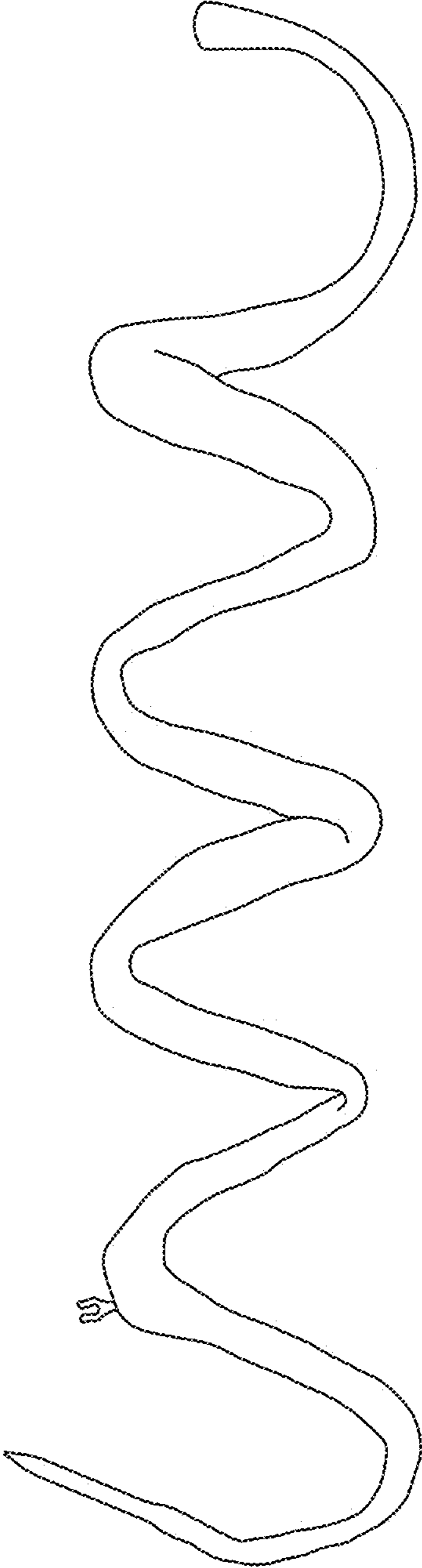

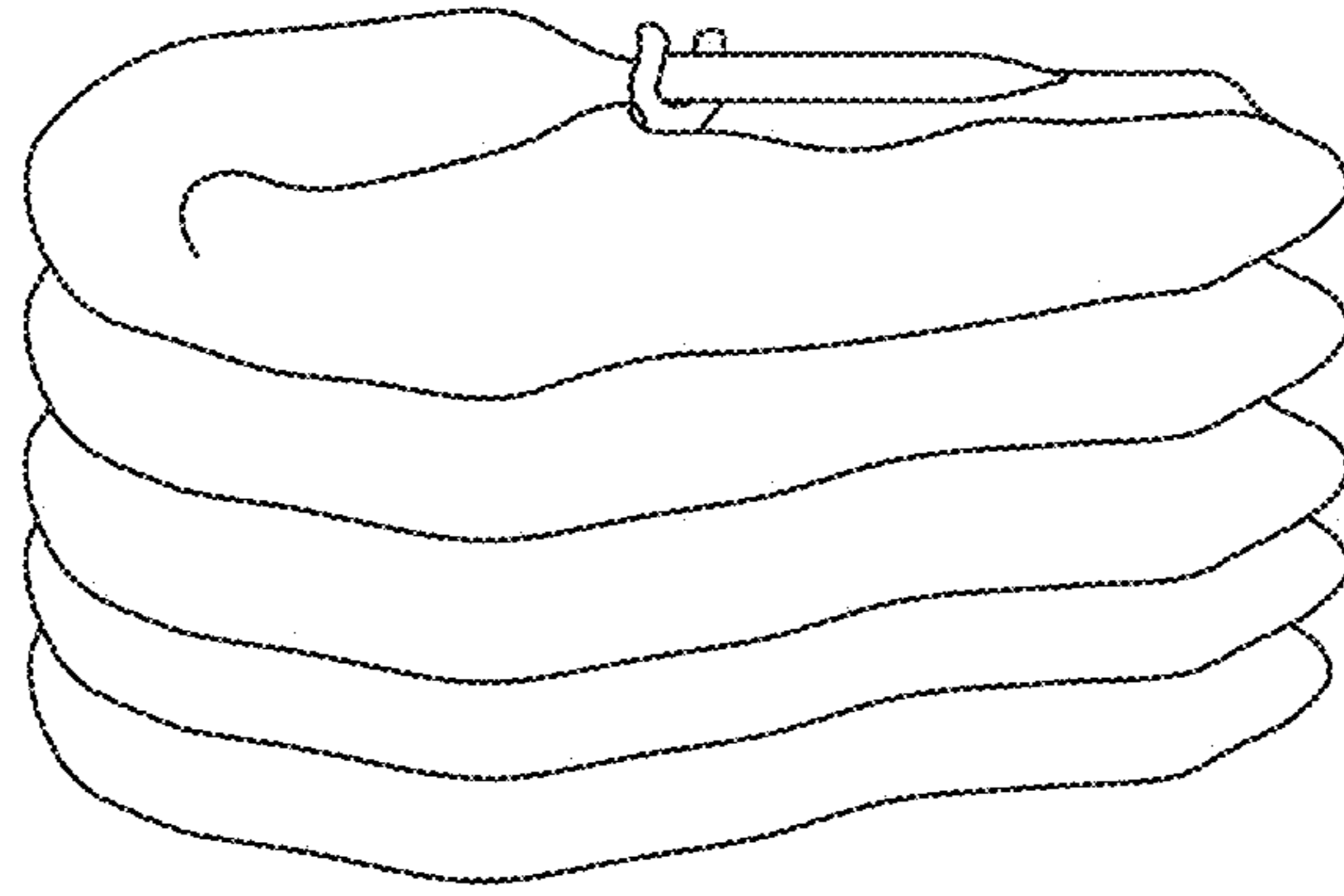

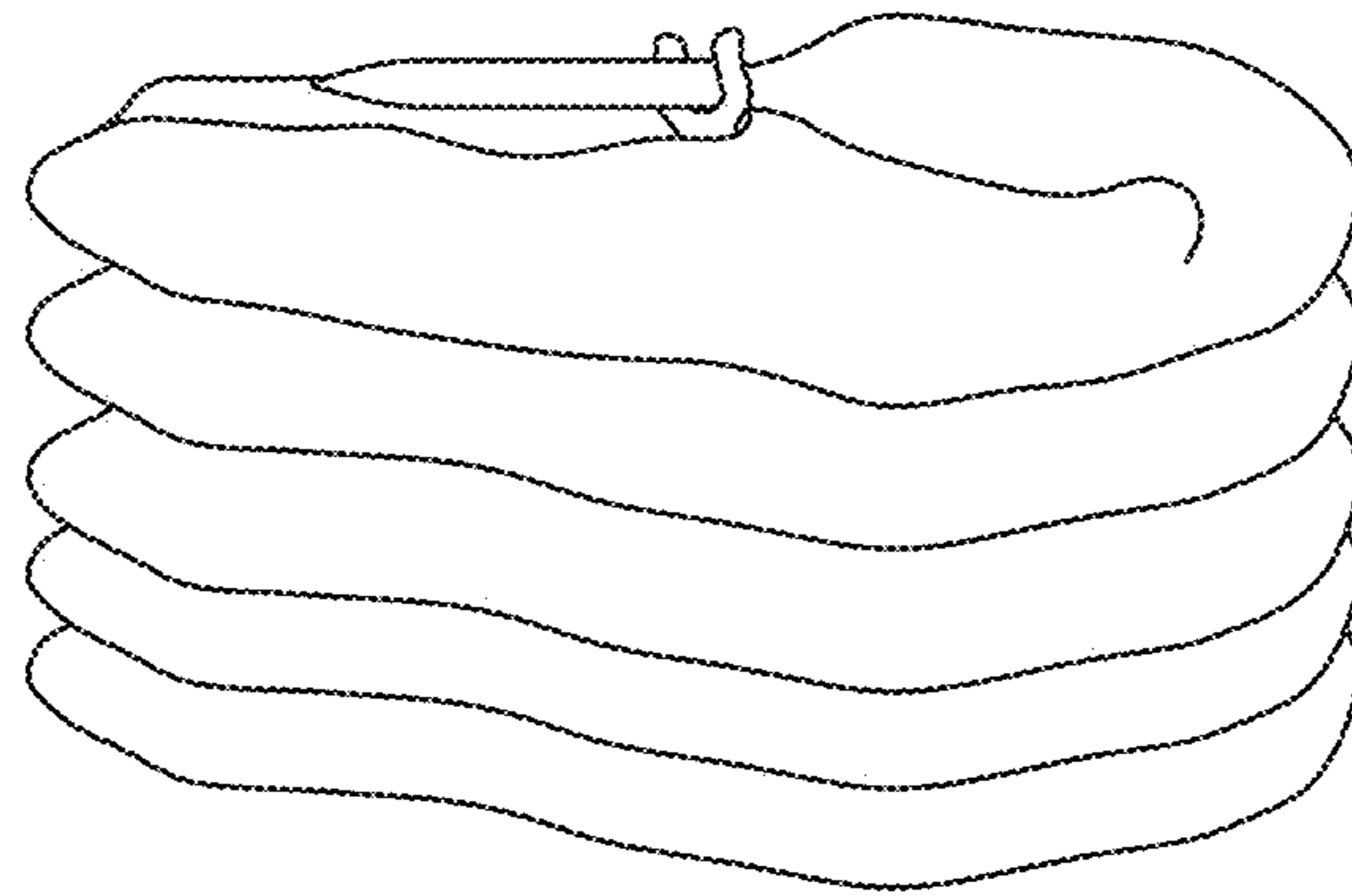

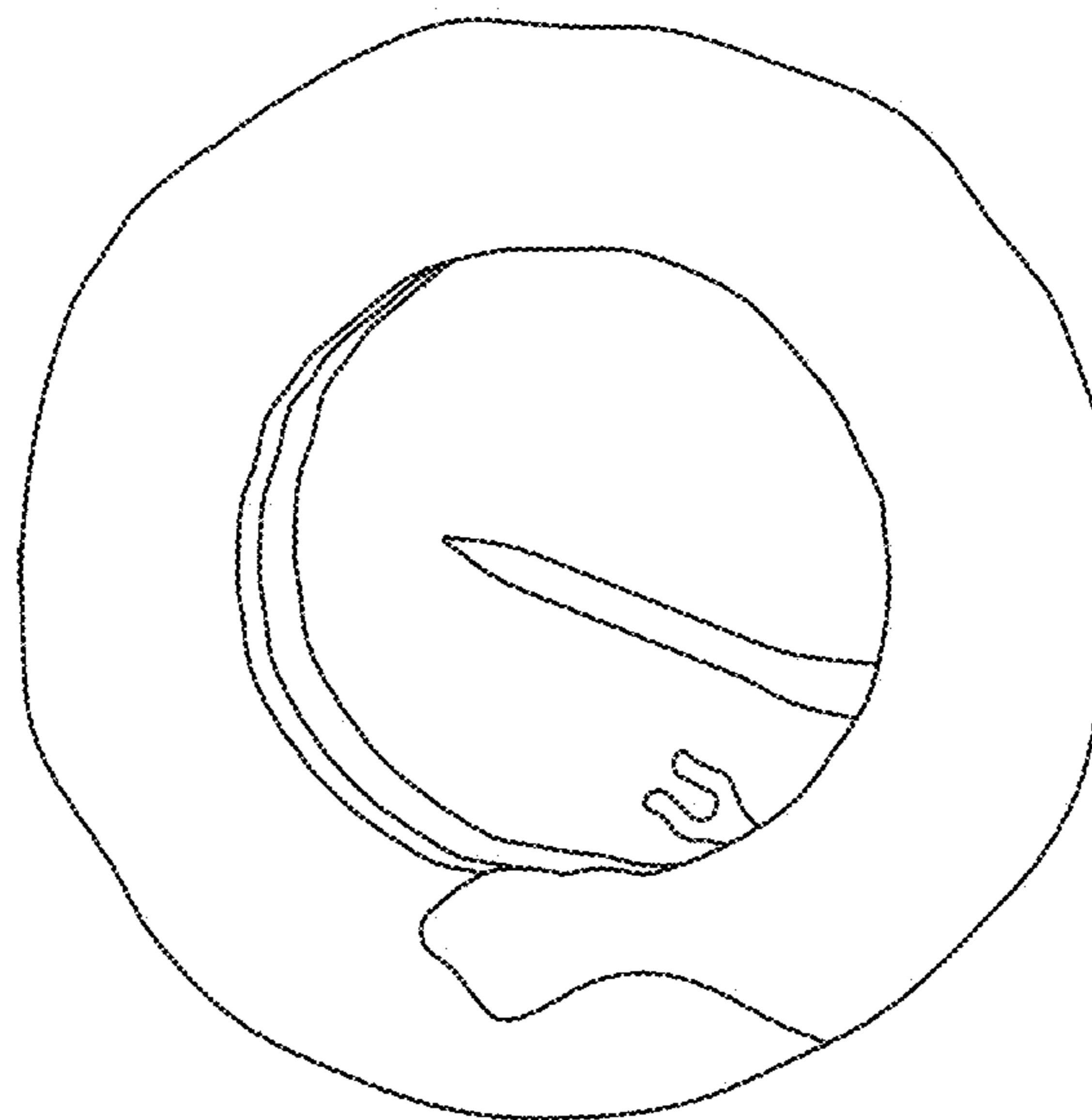

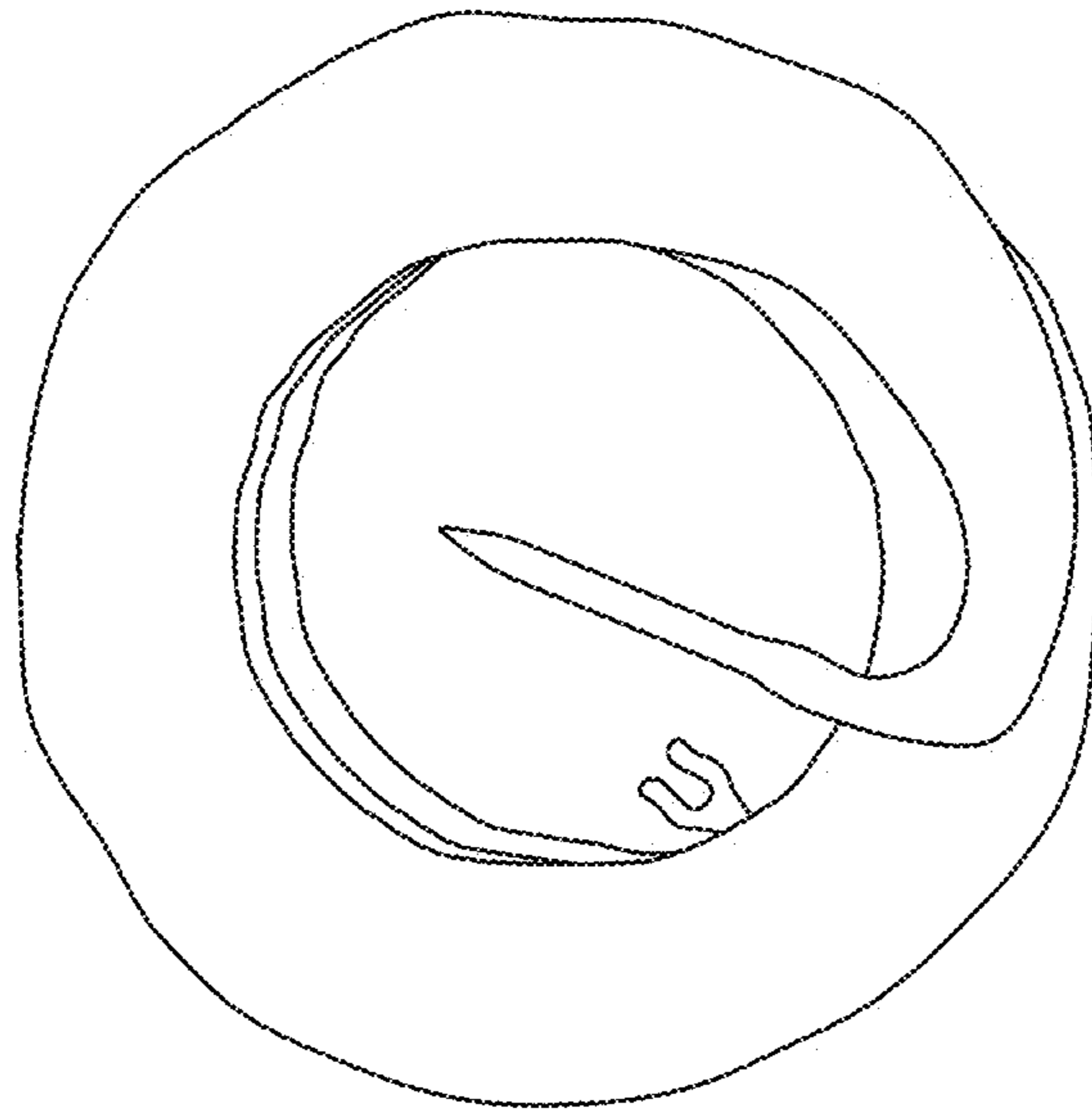

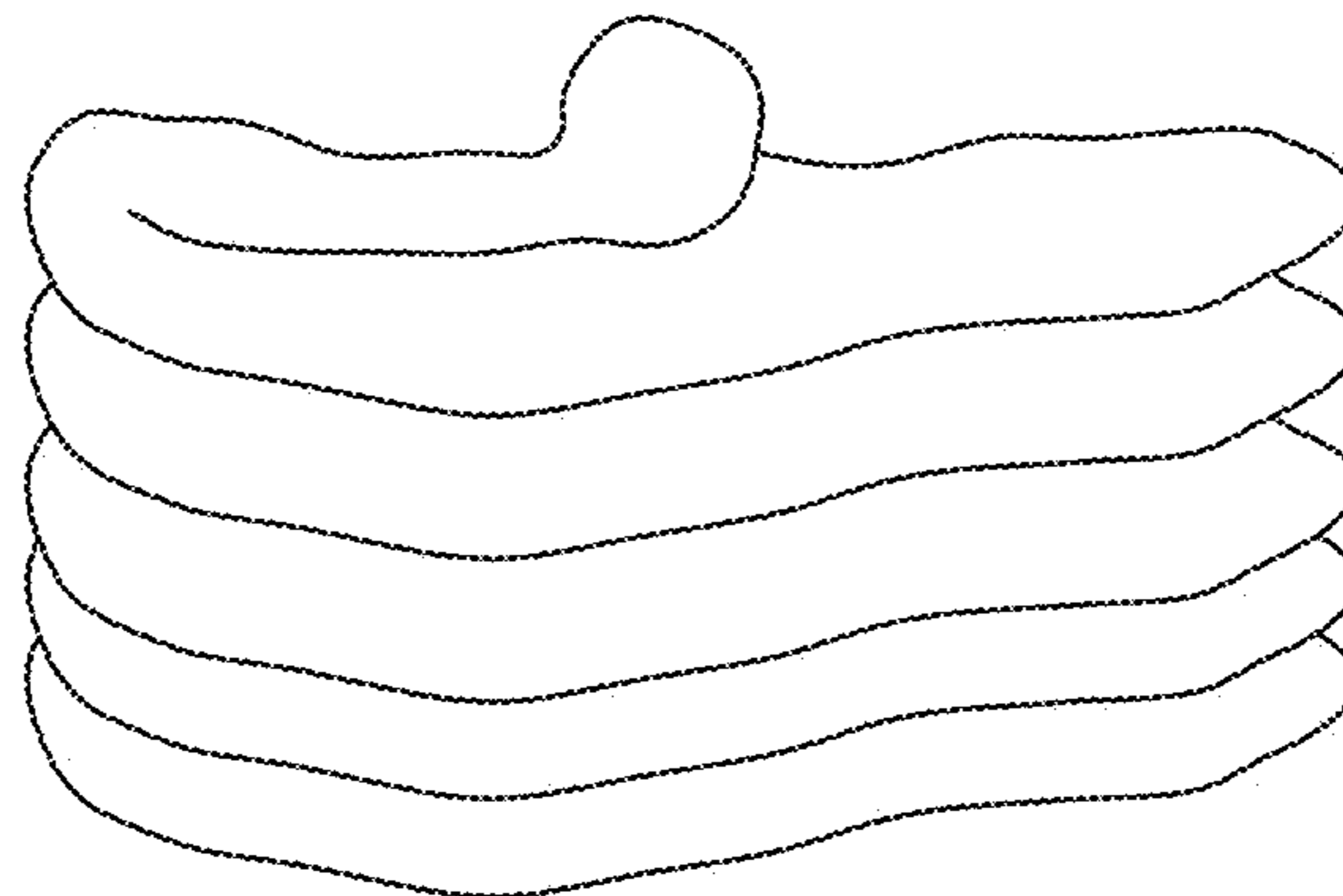

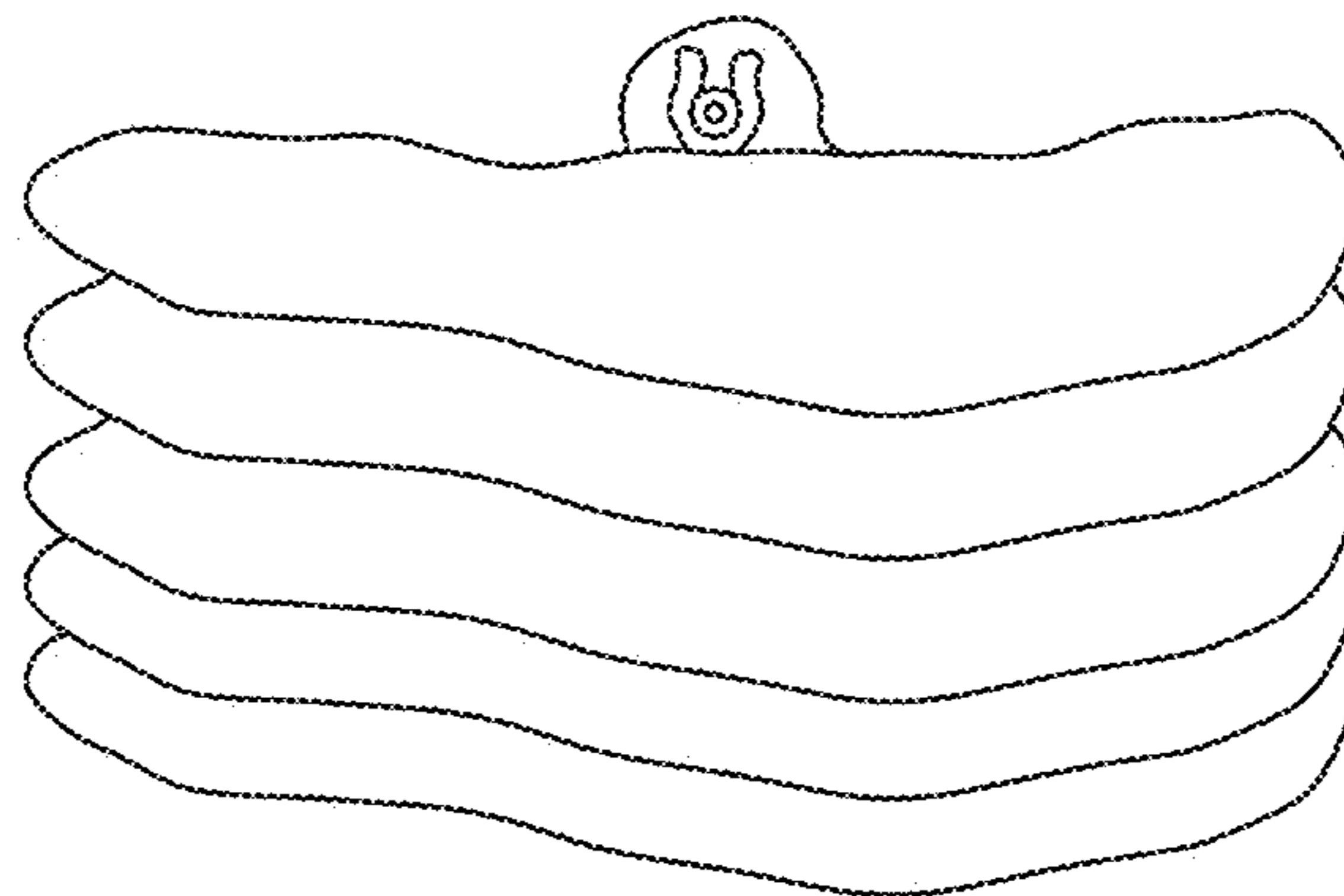
