The ornamental design for a ring, as shown and described.

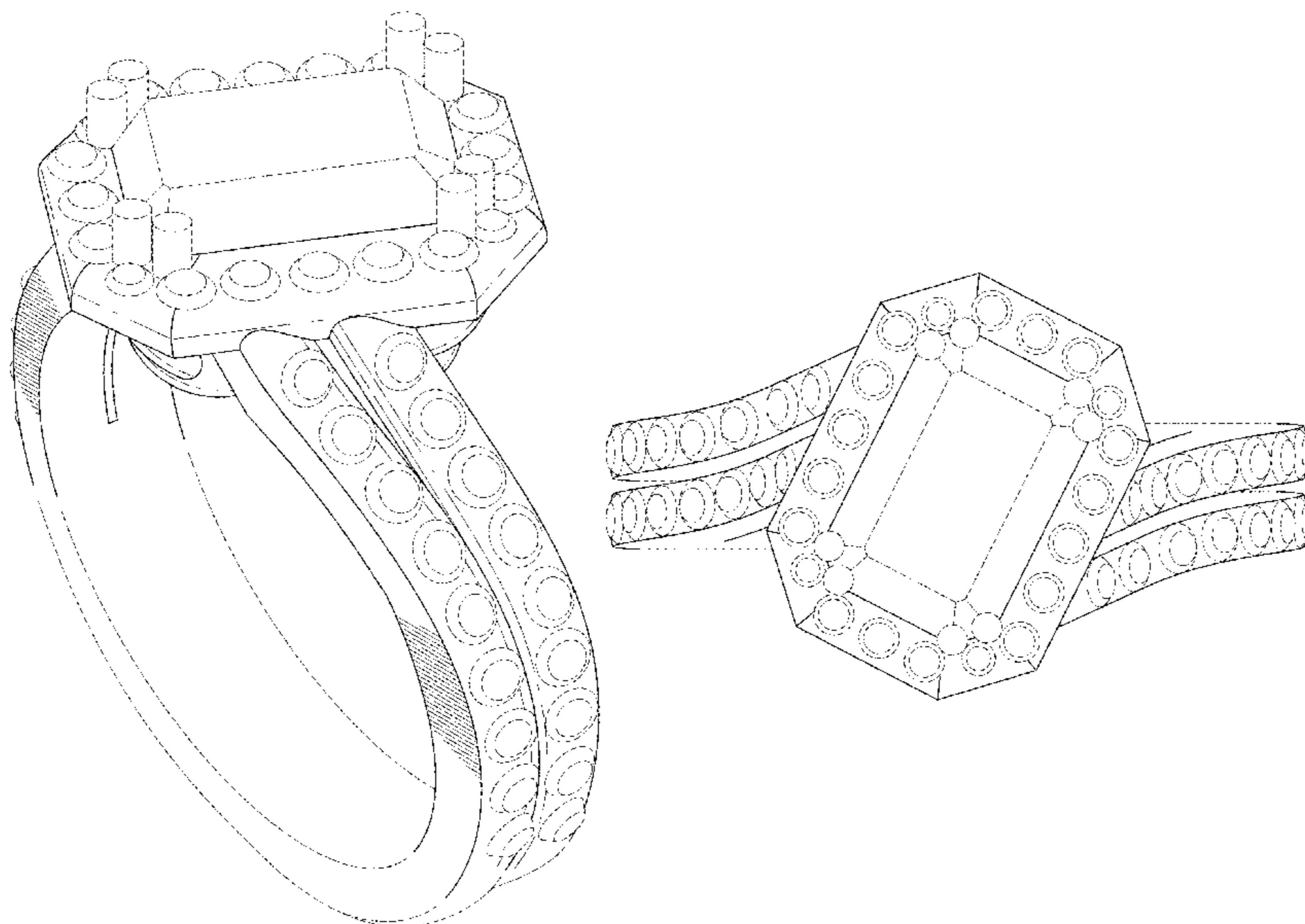
**DESCRIPTION**

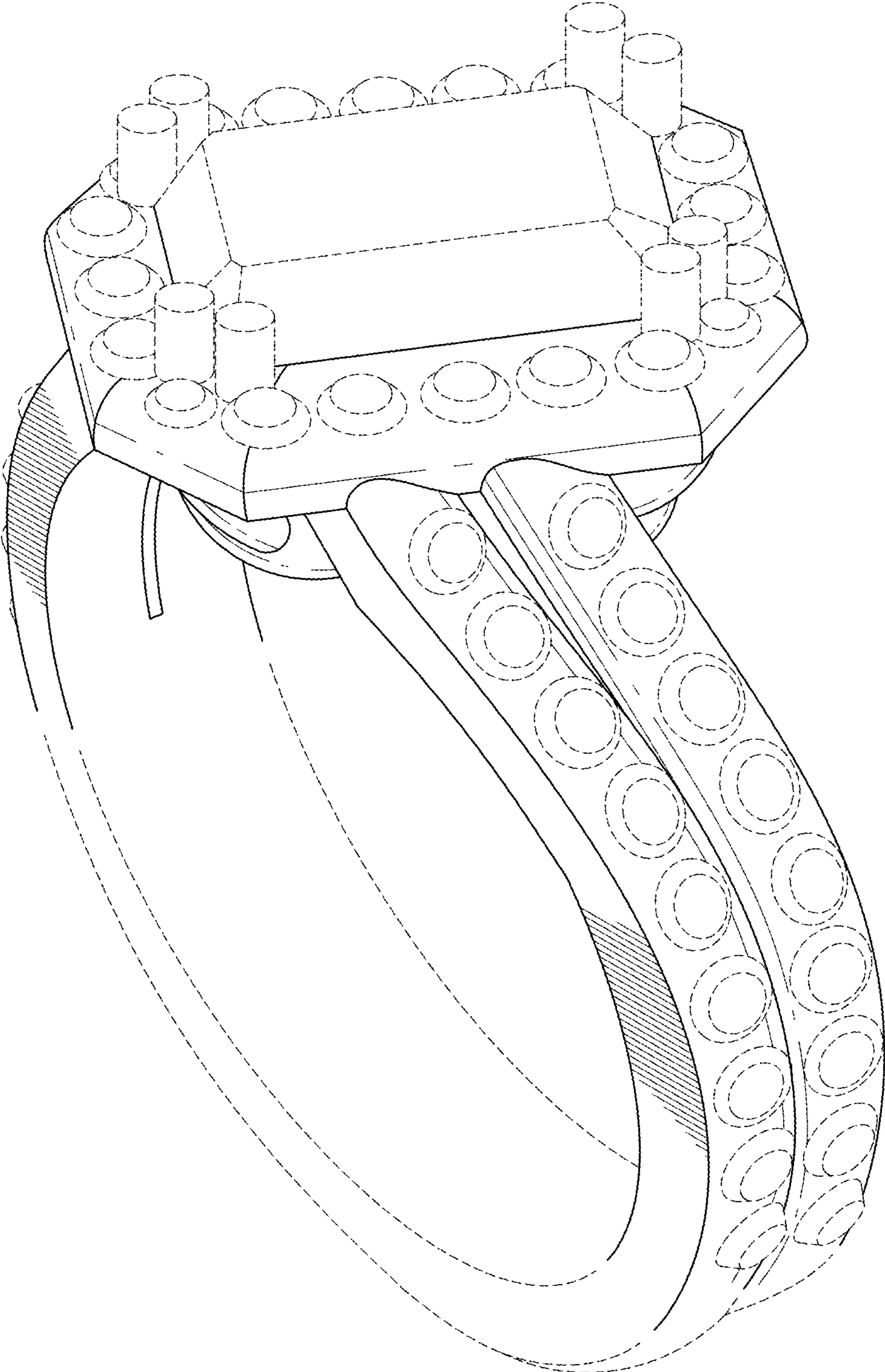
FIG. 1 is a front, side perspective view of my ring.

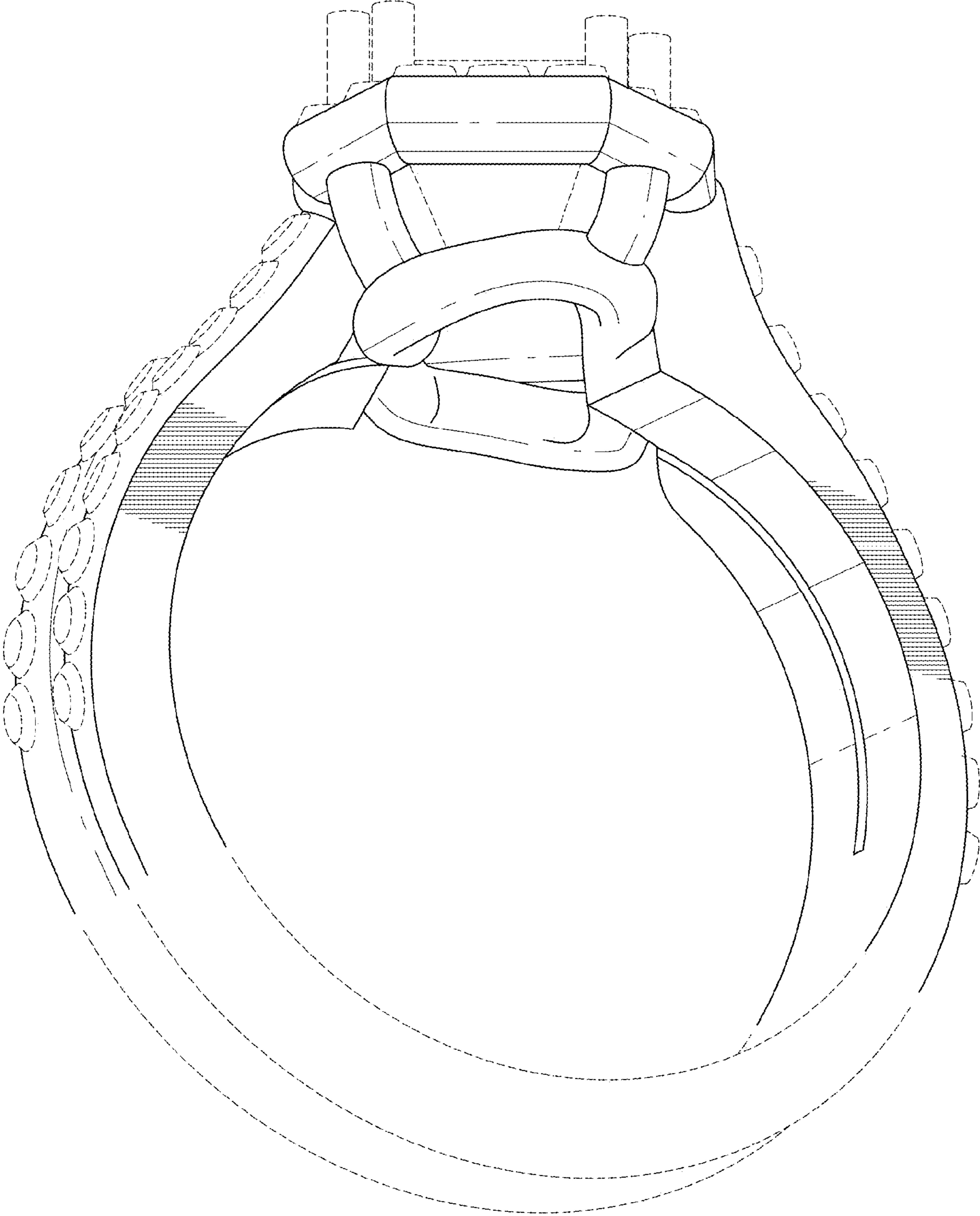
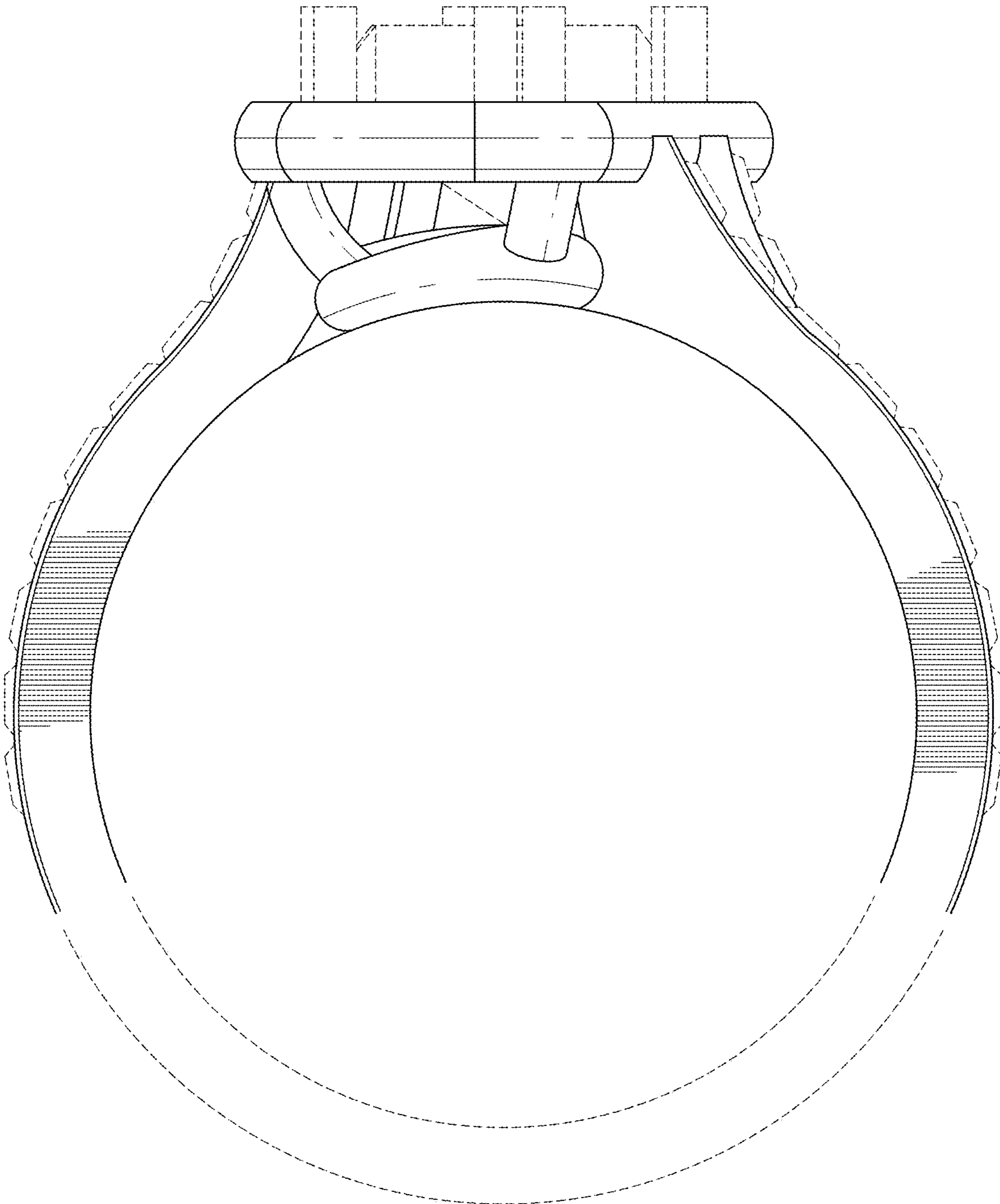
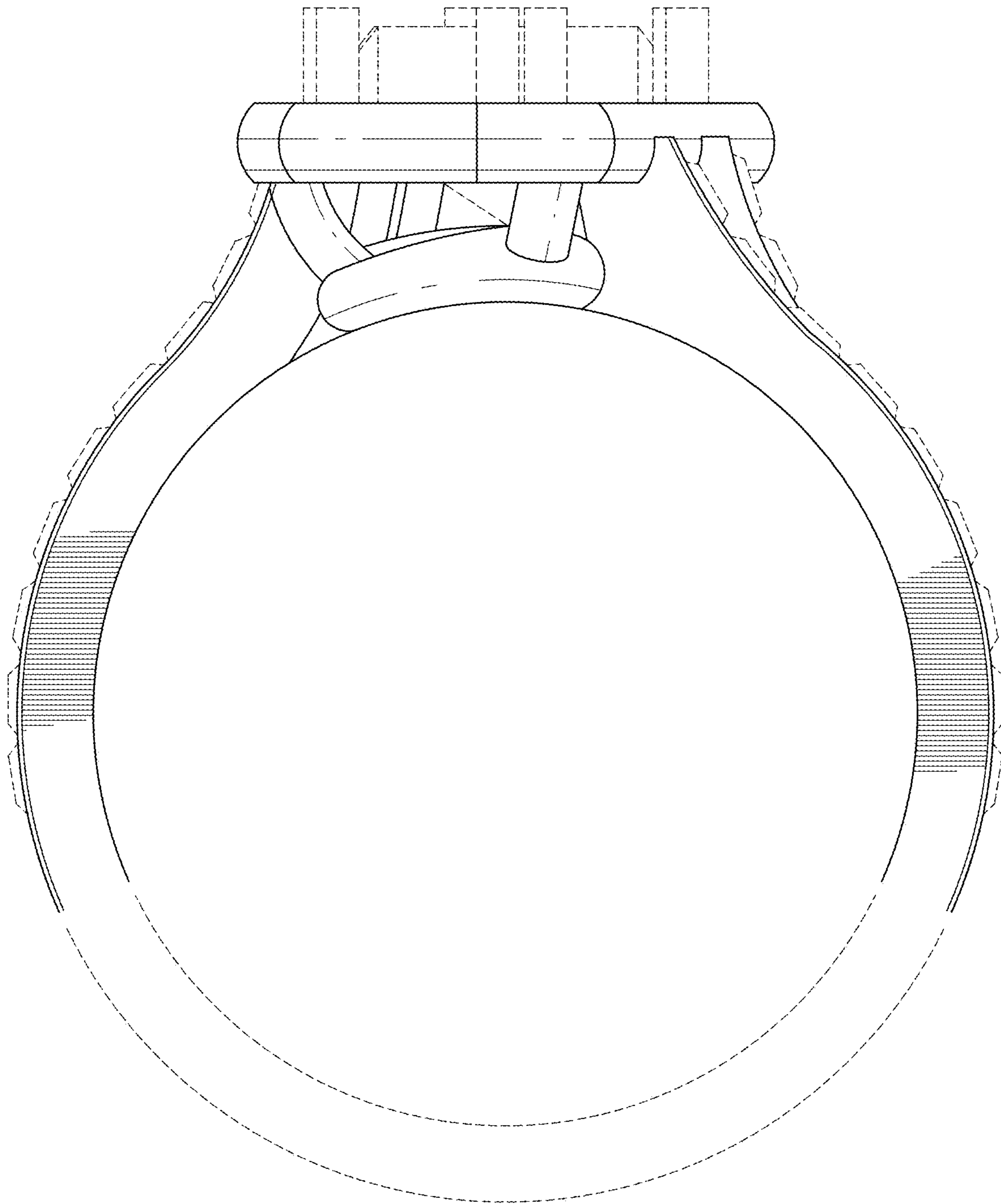


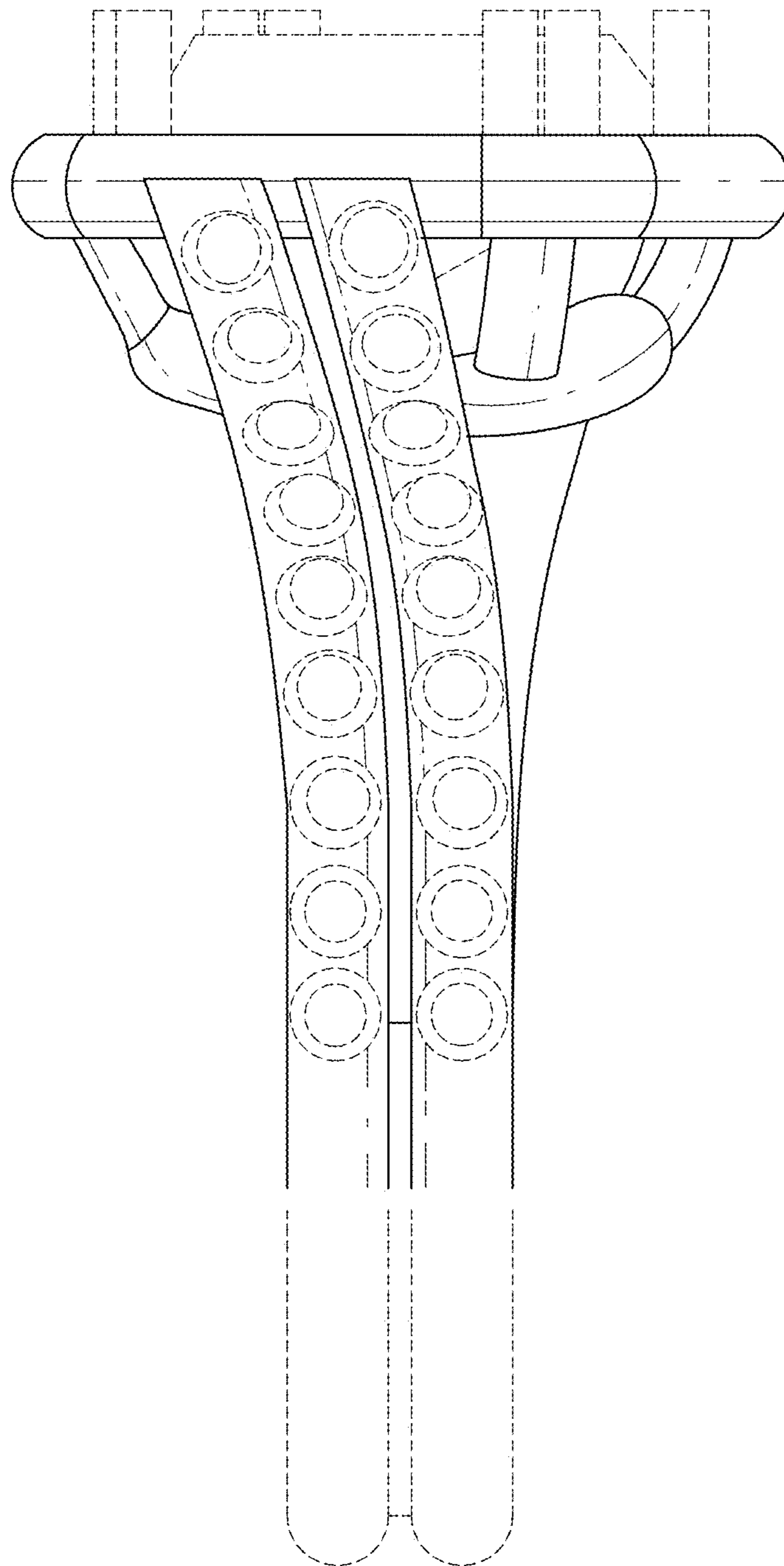

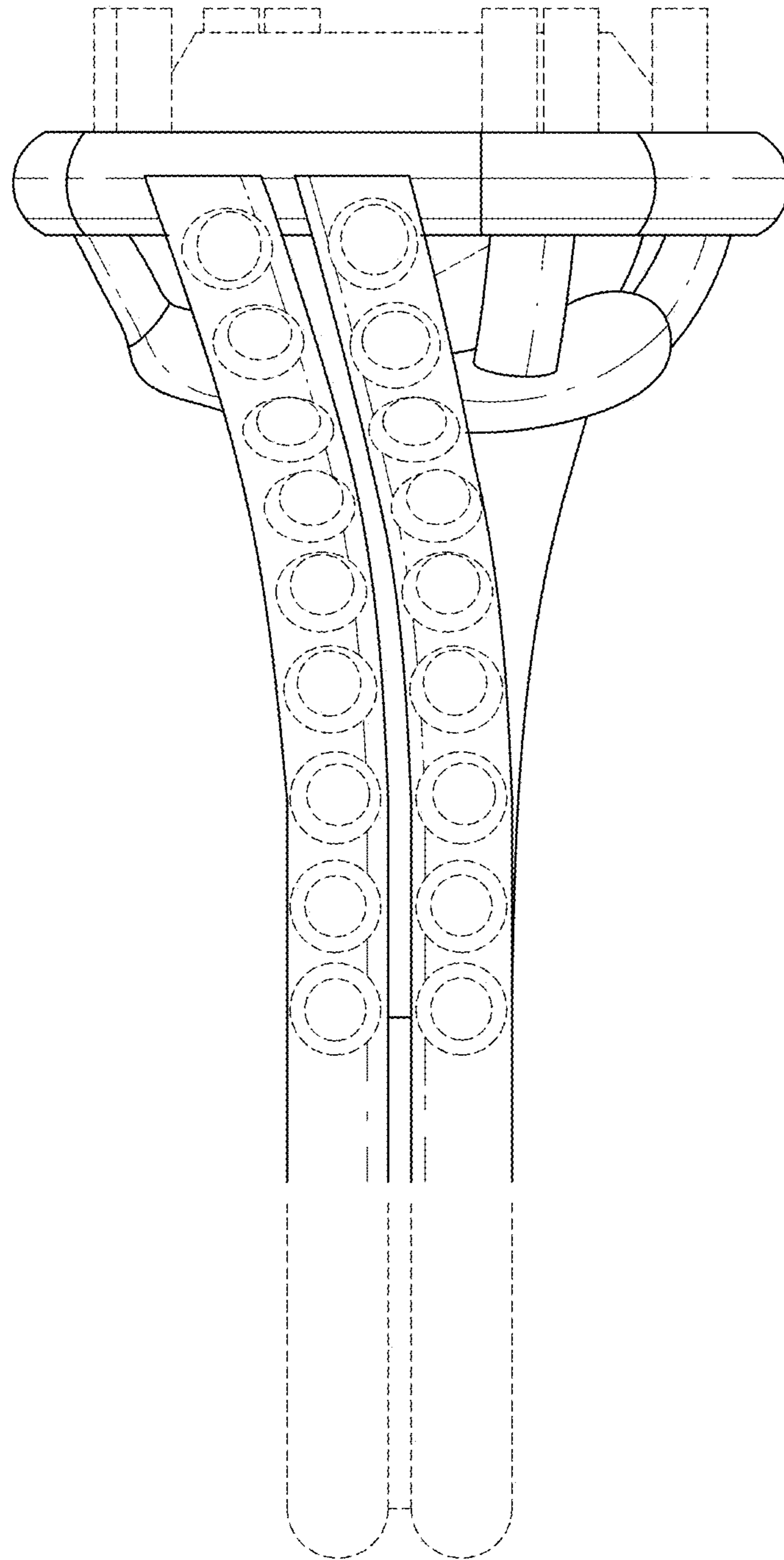

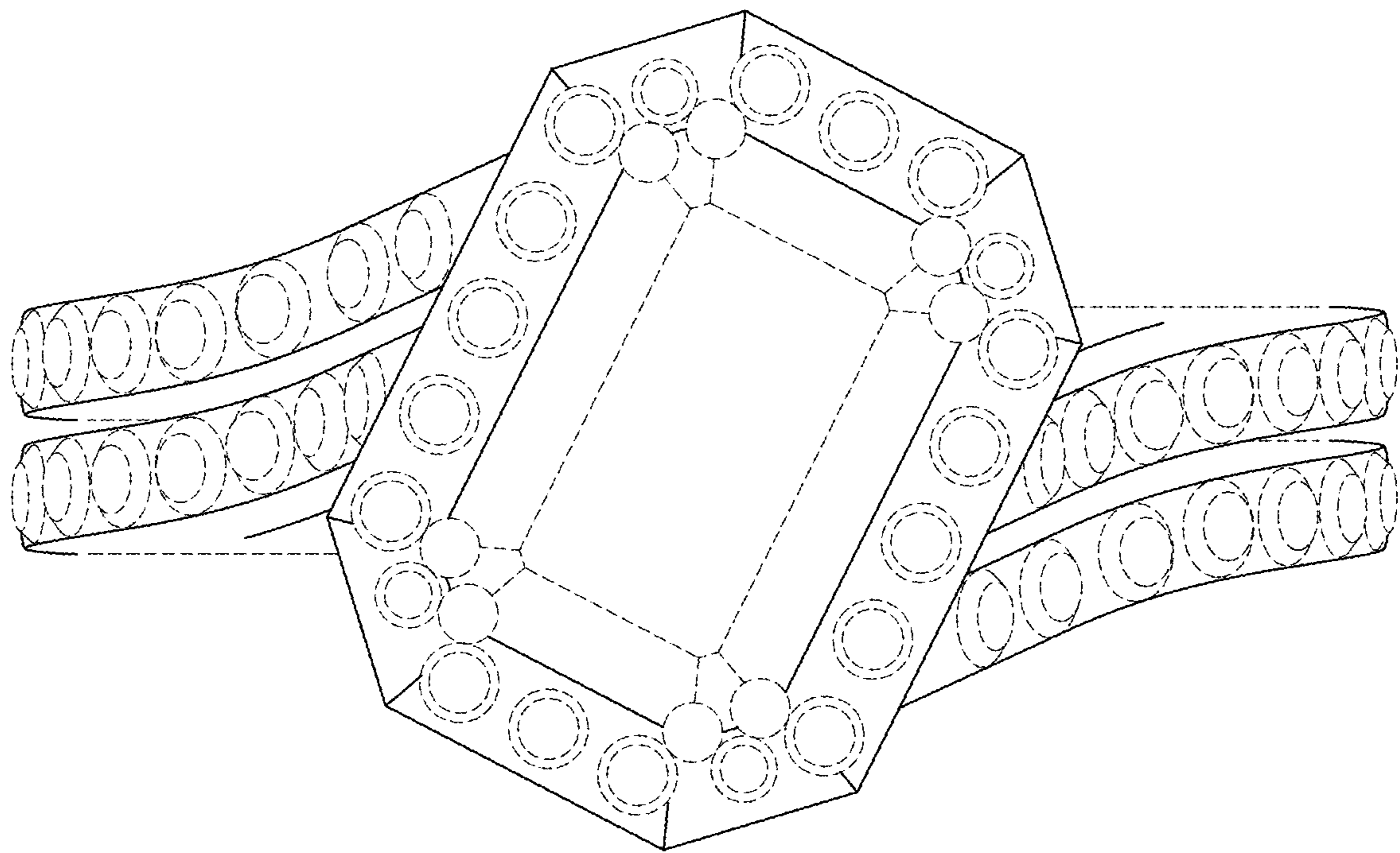

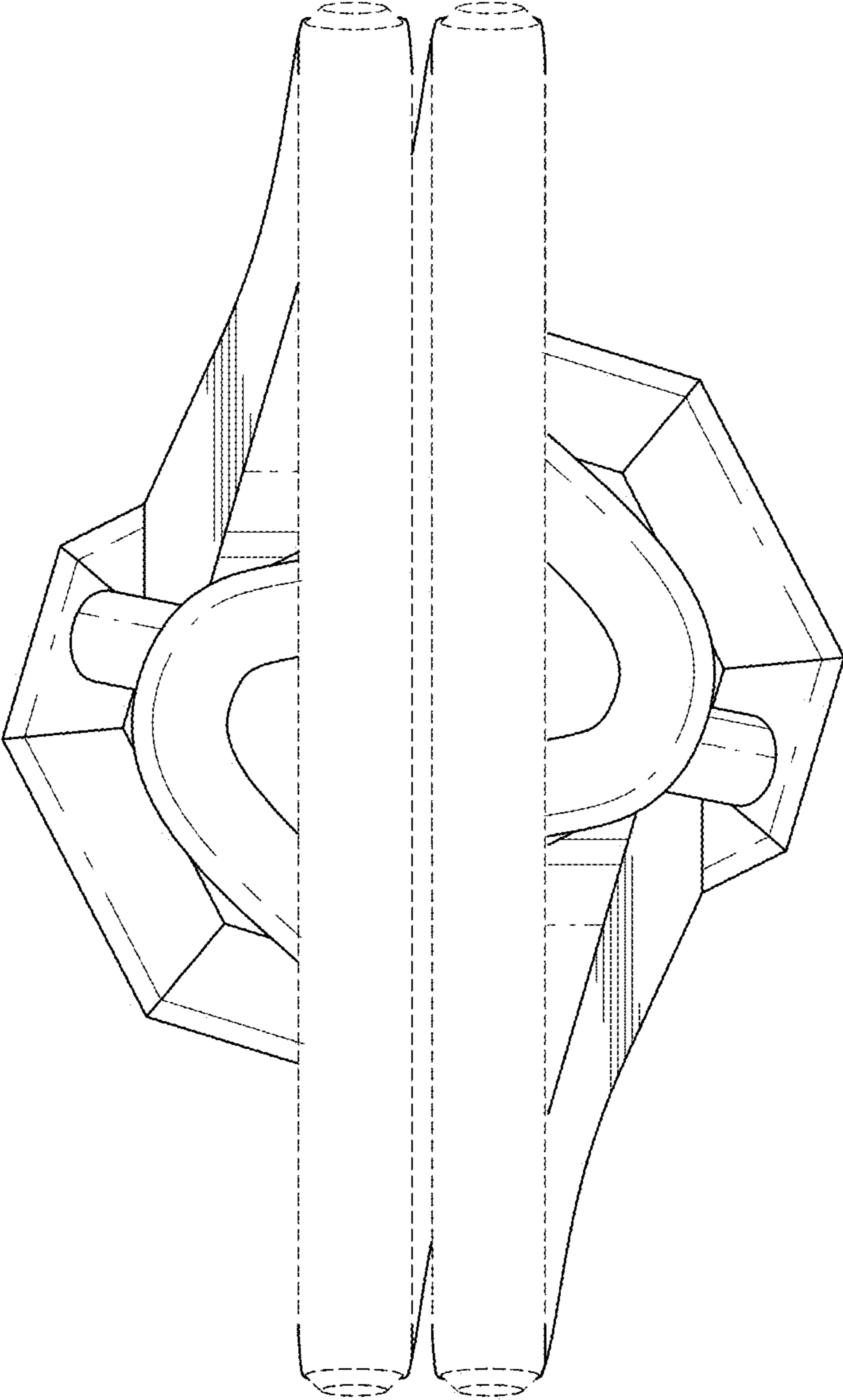
