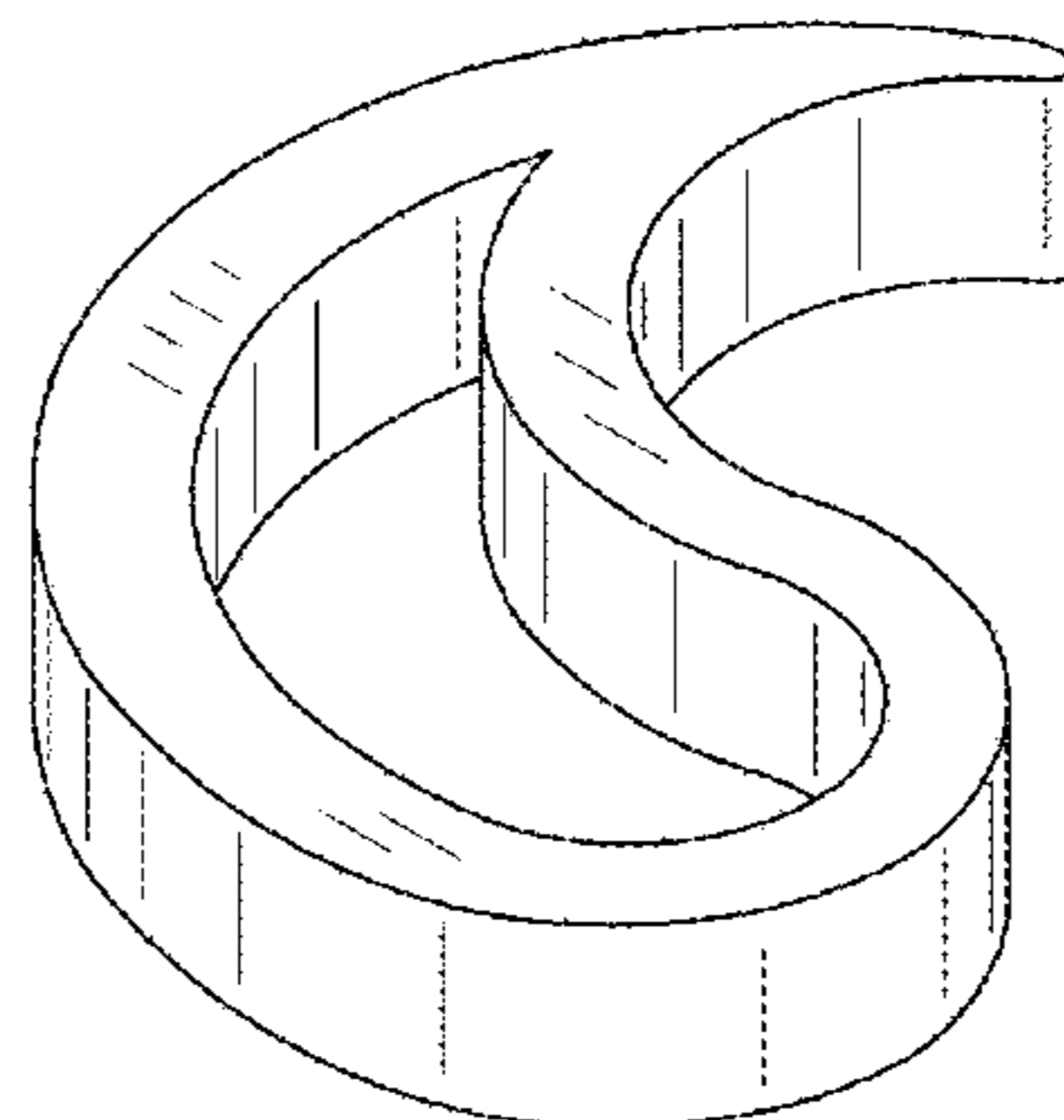
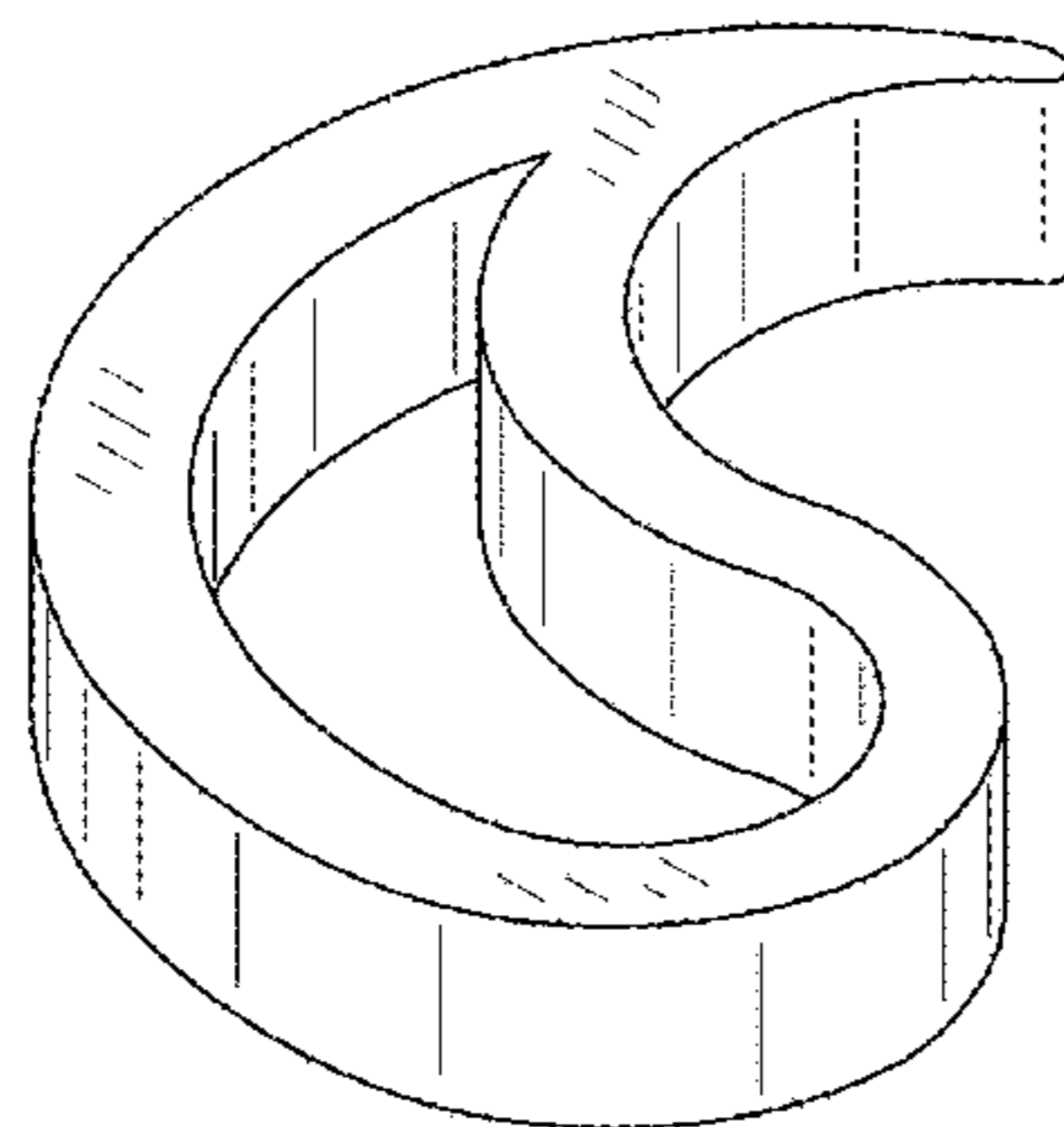

DESCRIPTION

FIG. 1 is a front view of a stress relief curio showing my new design, a rear view being a mirror image thereof; FIG. 2 is a left side view of the stress relief curio; FIG. 3 is a right side view of the stress relief curio; FIG. 4 is a top view of the stress relief curio; FIG. 5 is a bottom view of the stress relief curio; and, FIG. 6 is a bottom front side perspective view of the stress relief curio.

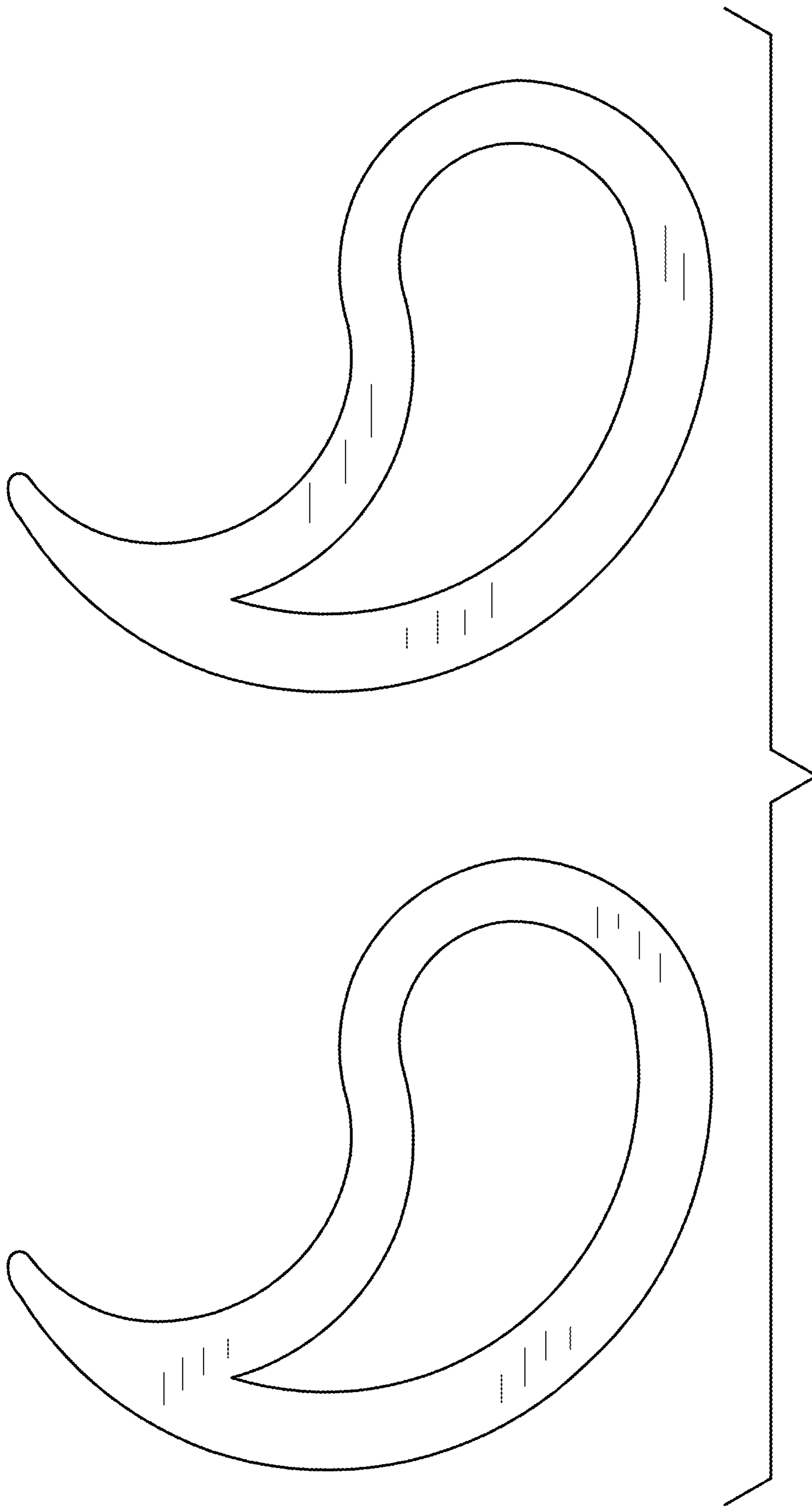

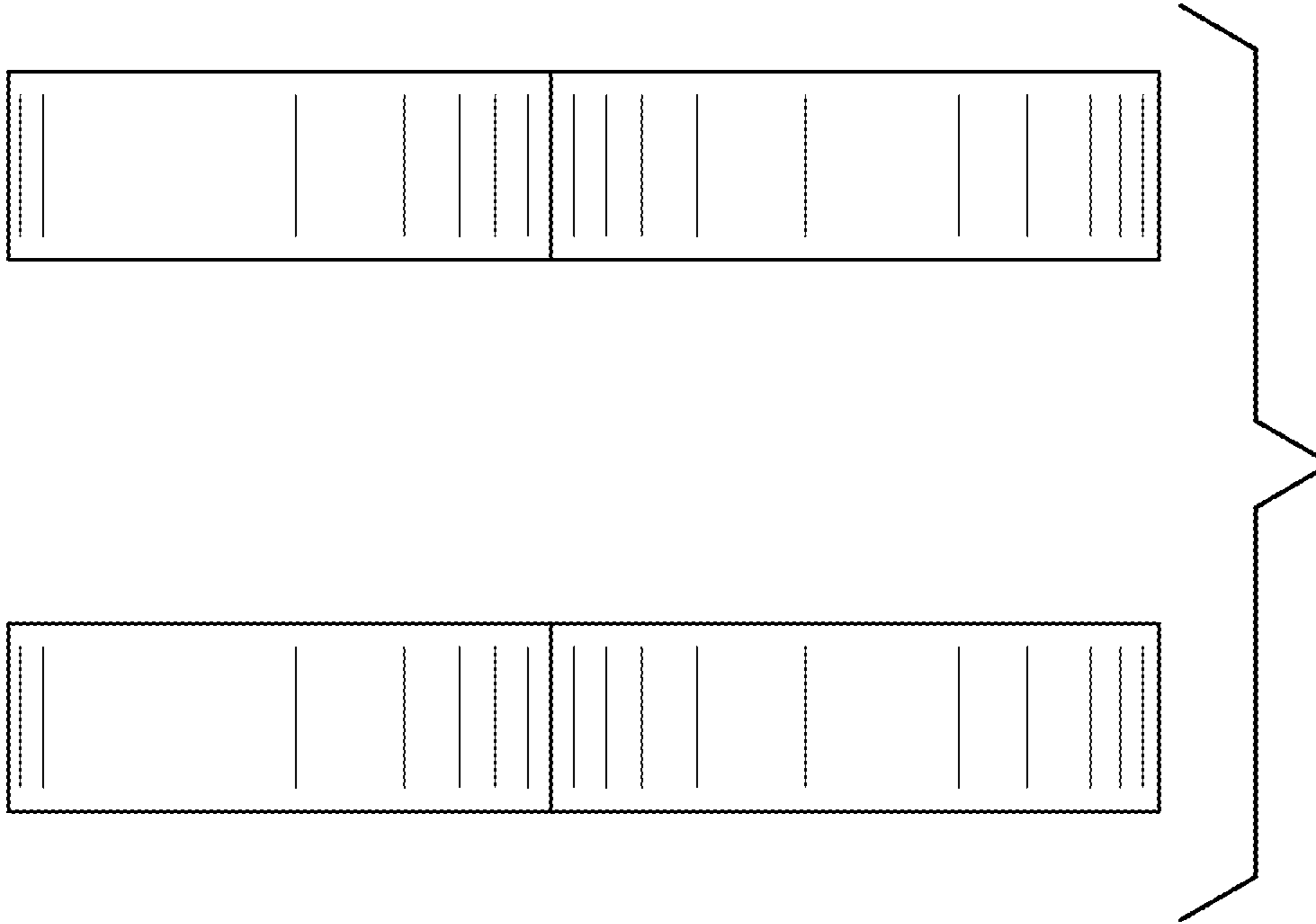

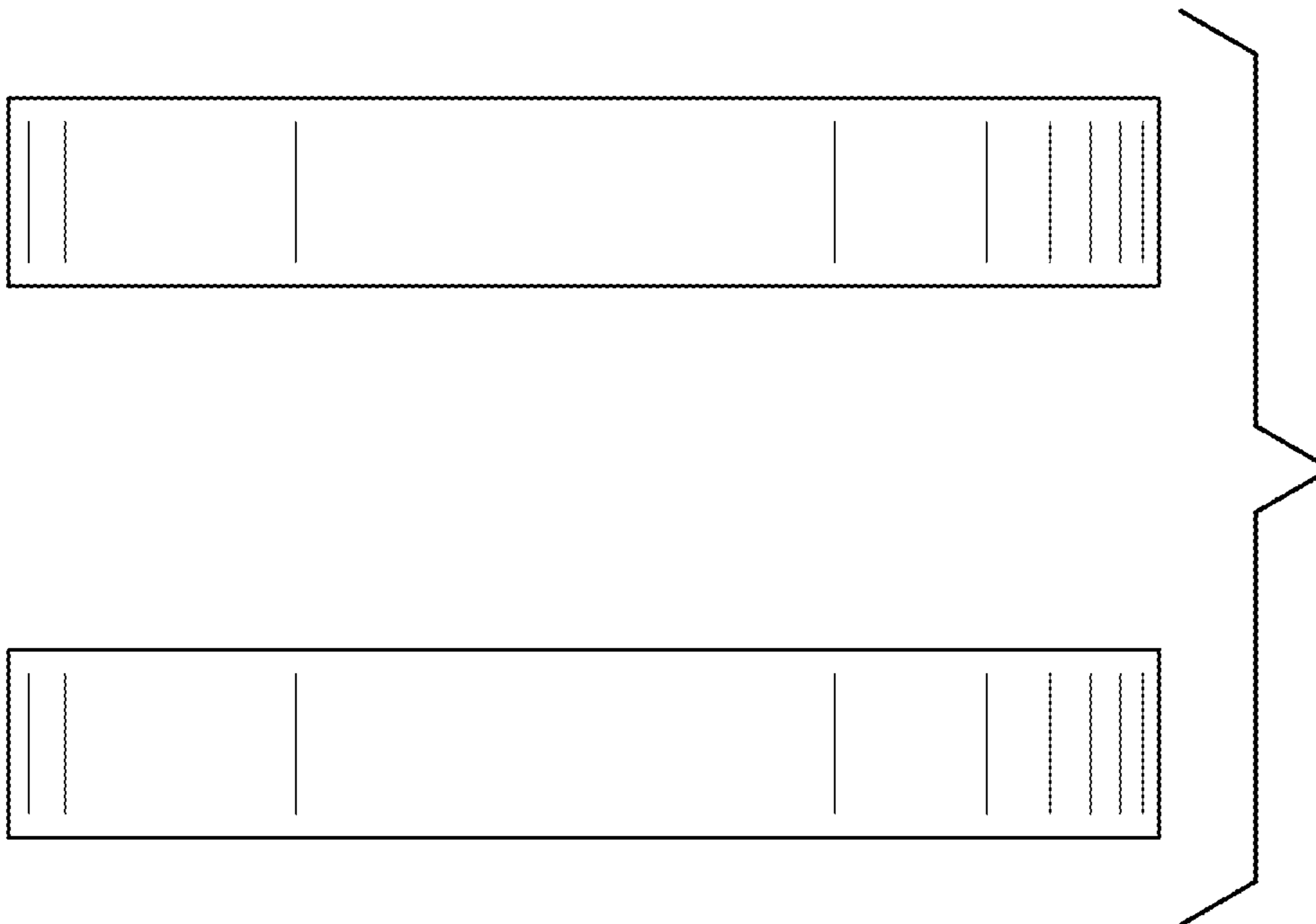

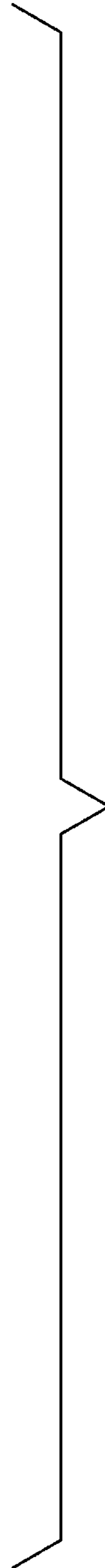
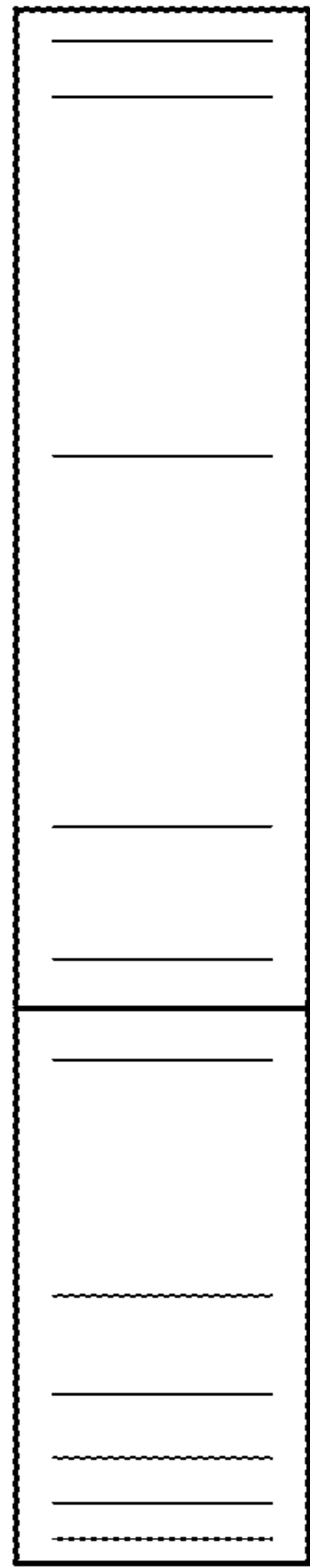

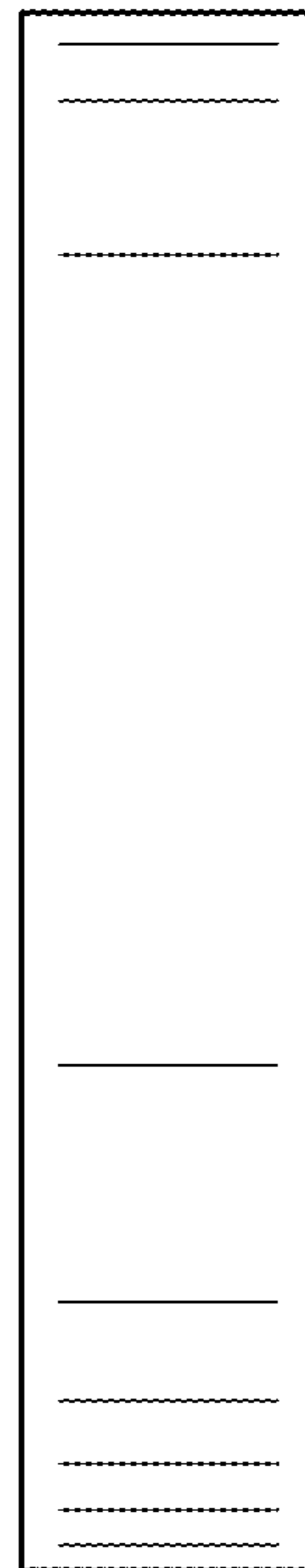

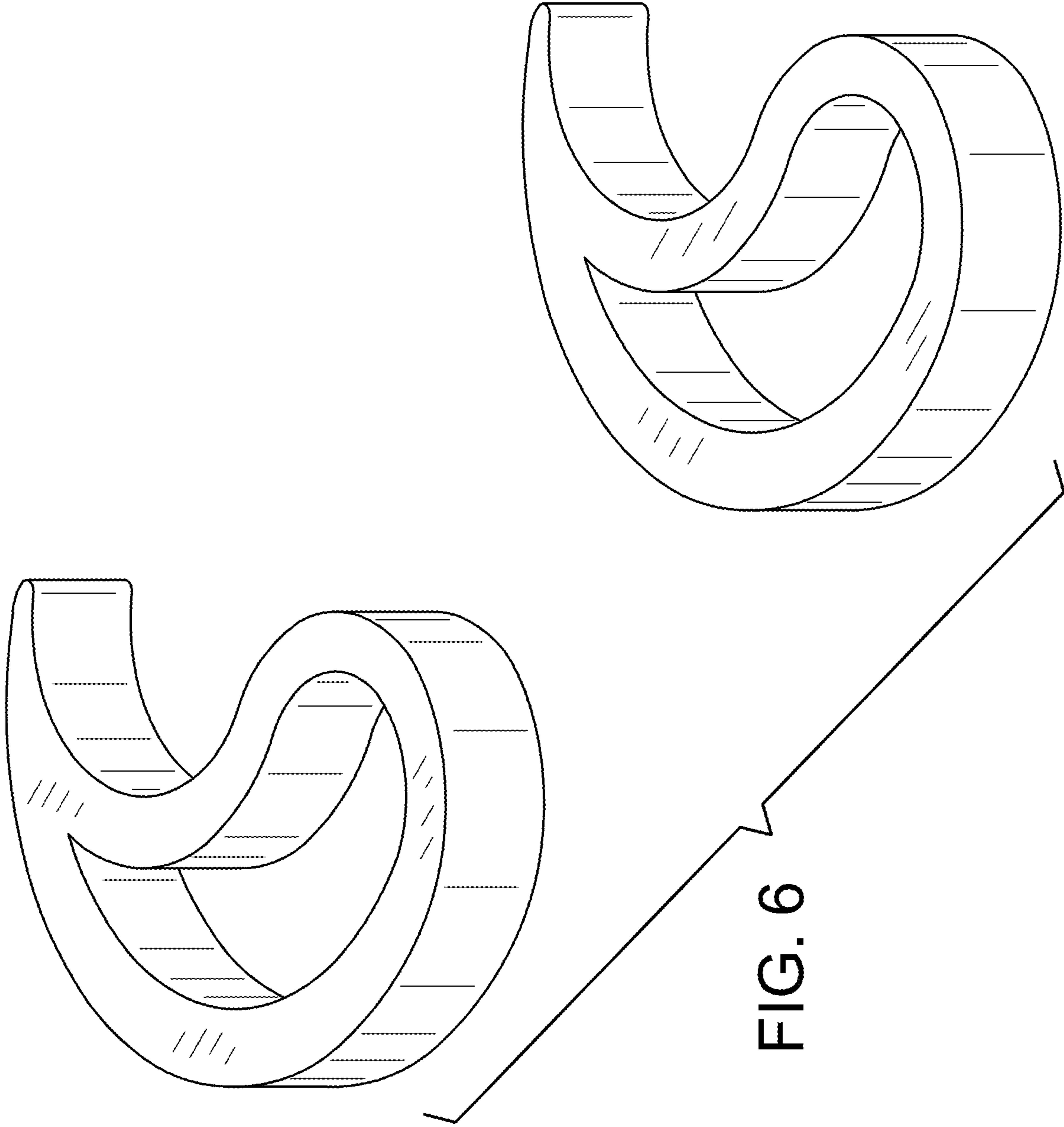
