DESCRIPTION

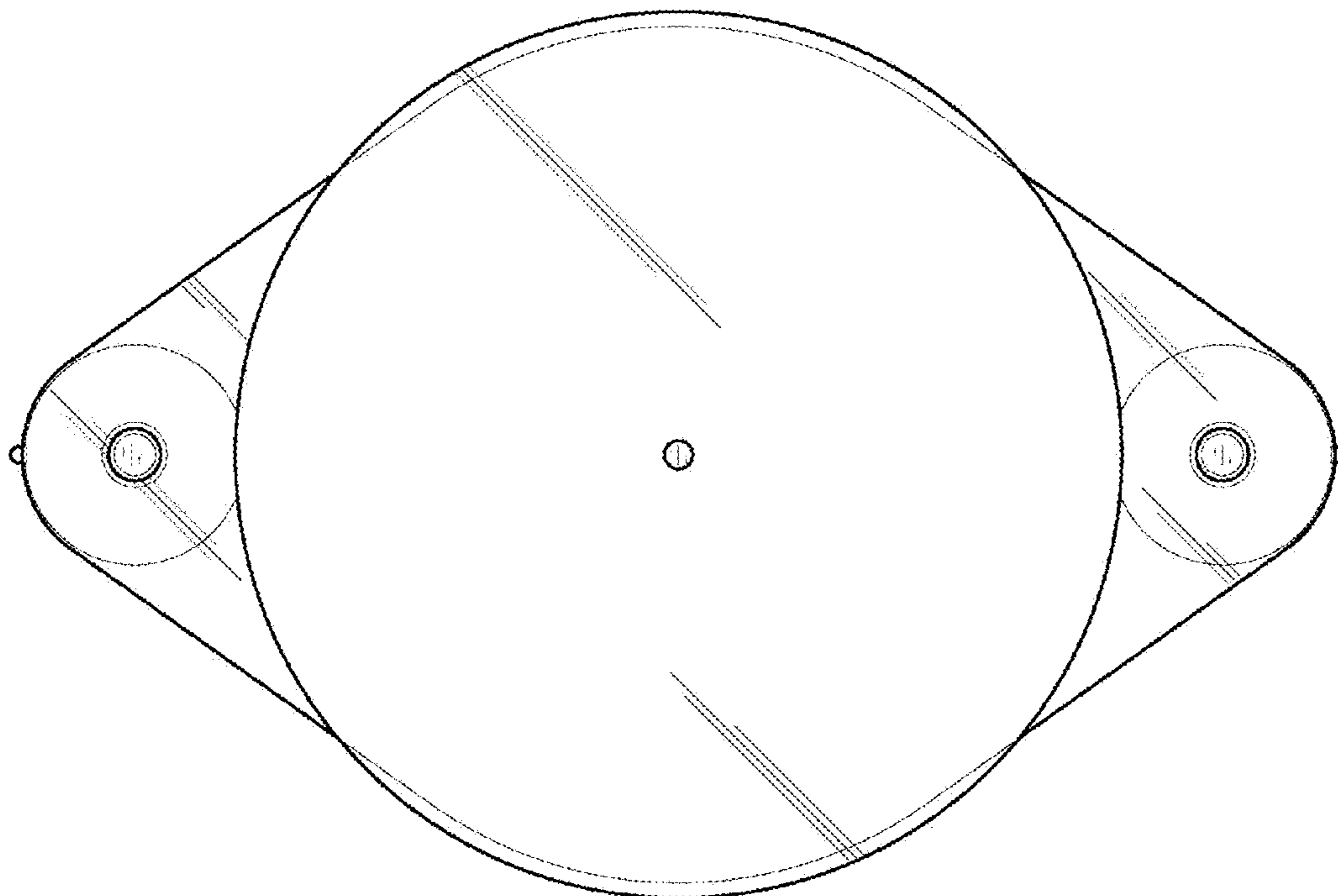
FIG. 1 is a front view of the sideview mirror glare shield.

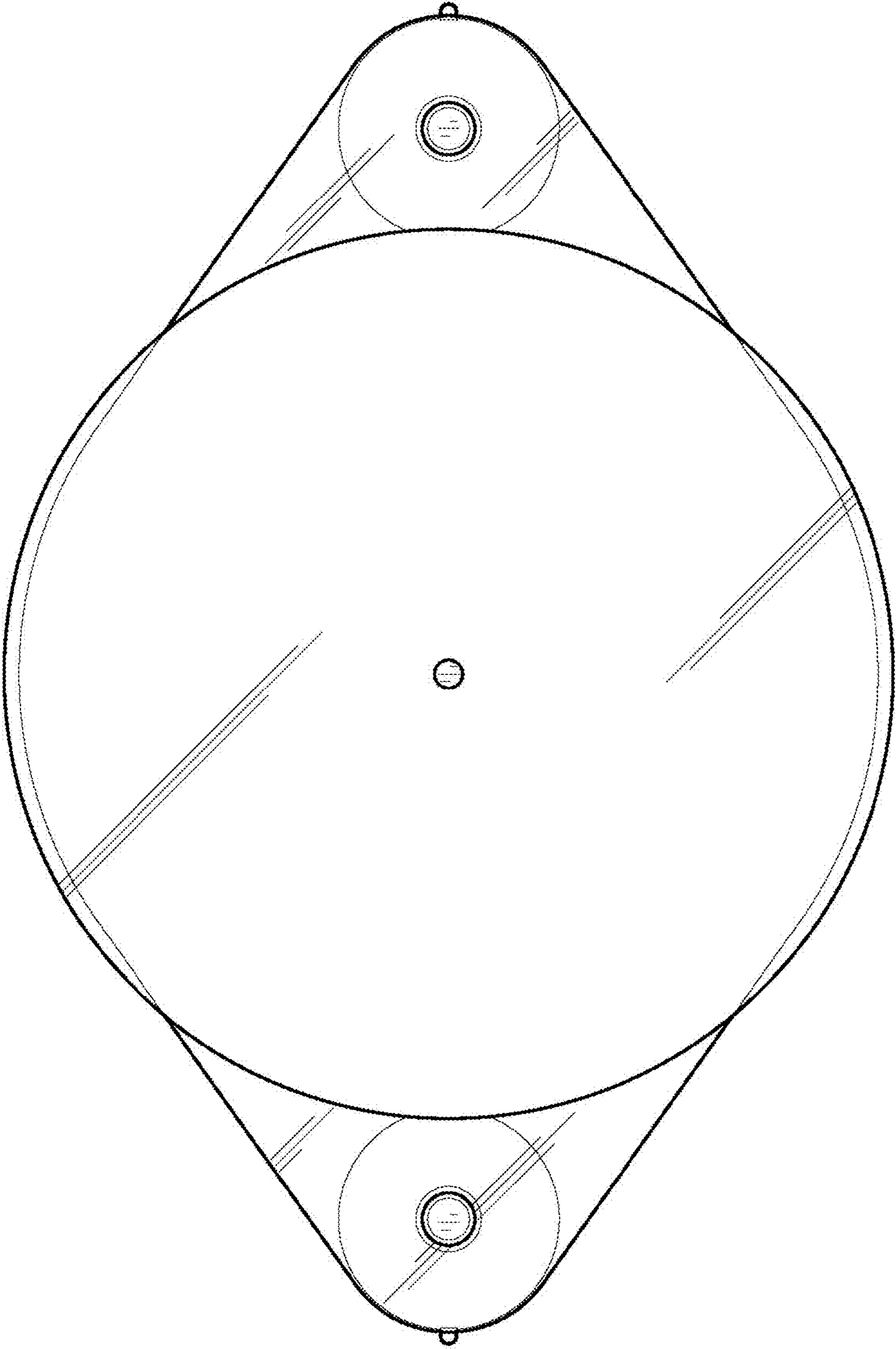

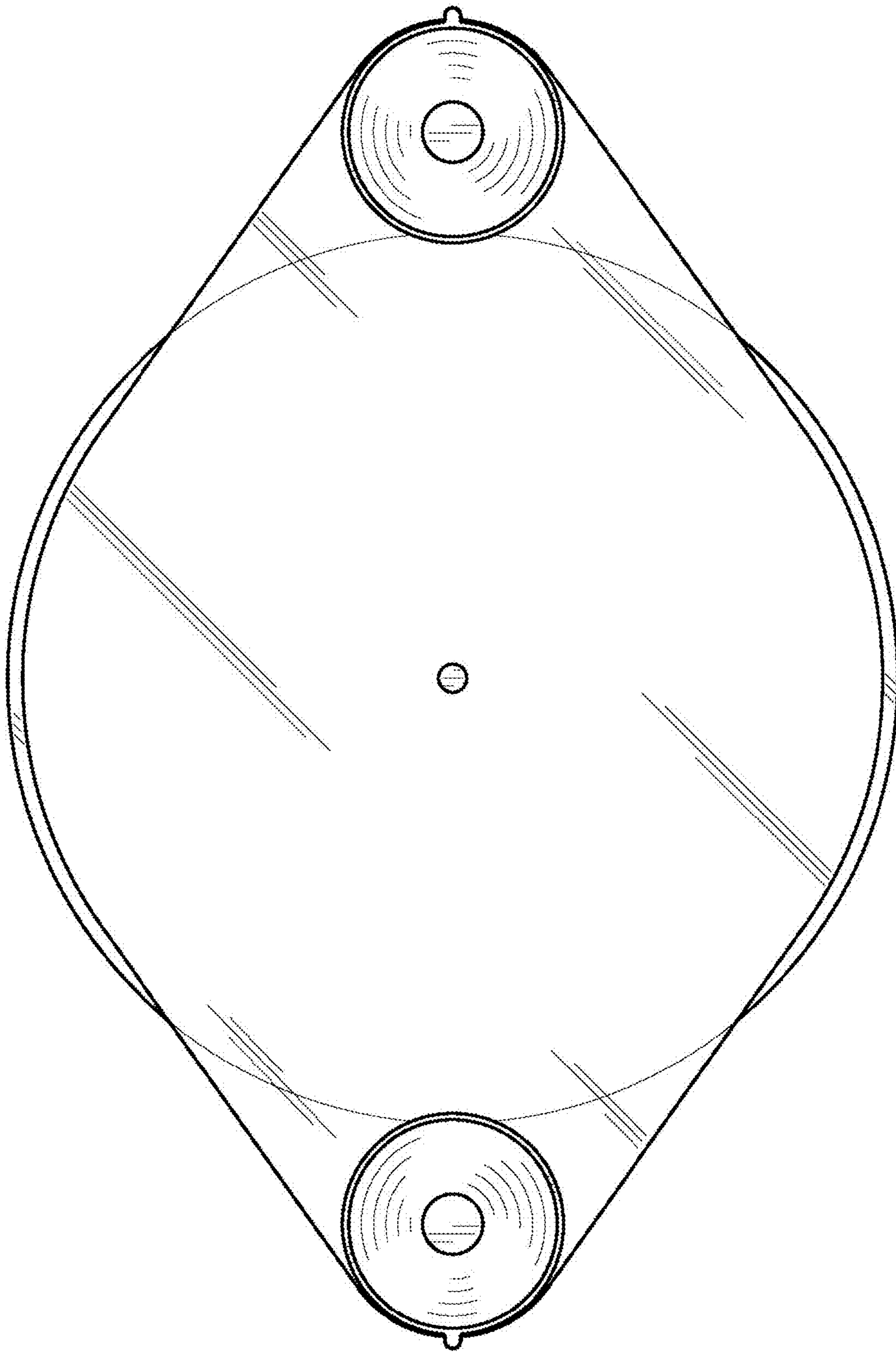

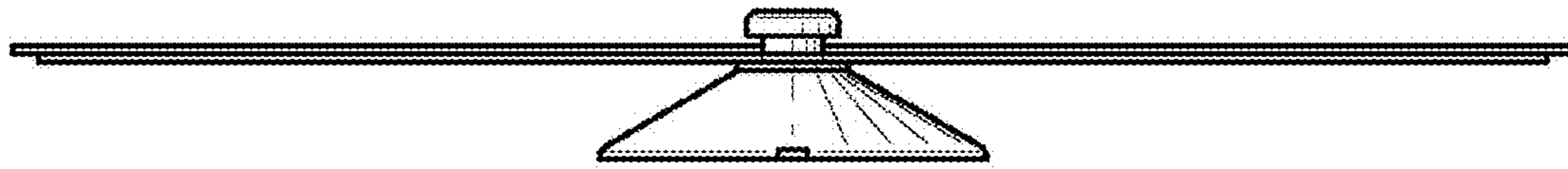

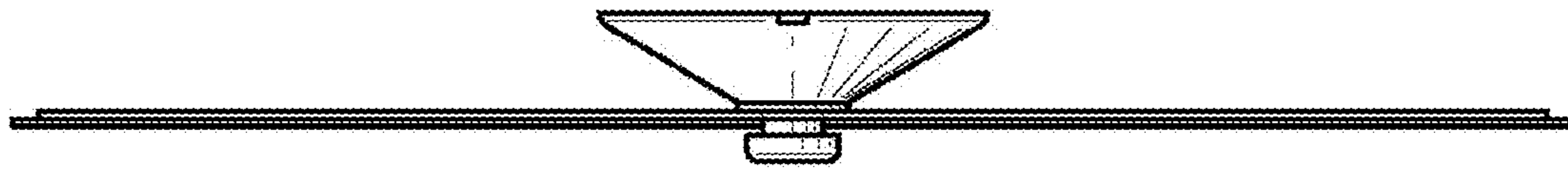

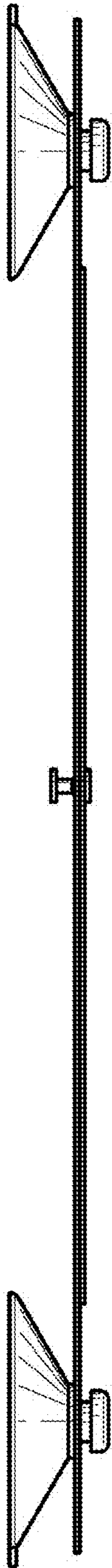

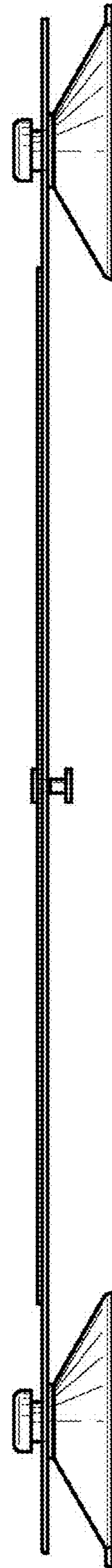
