FIG. 7 is a left side view thereof.

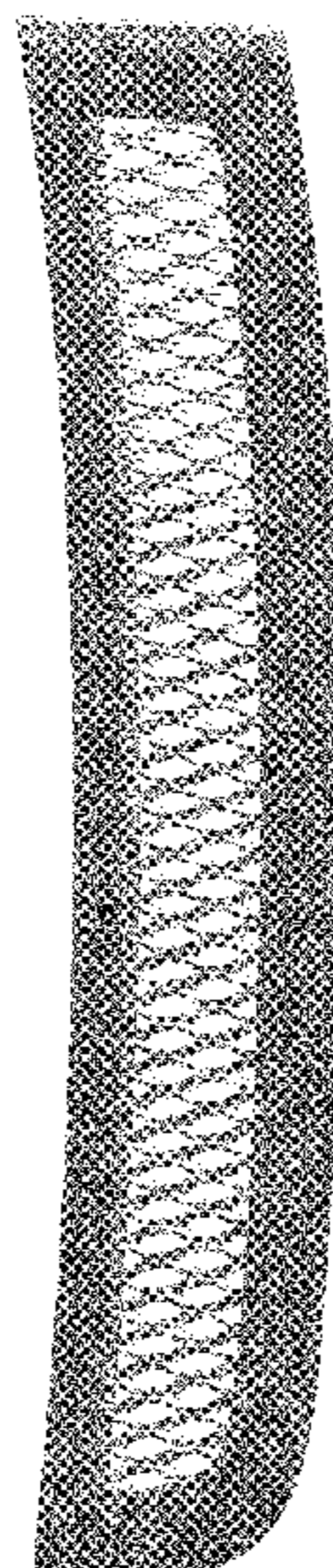
FIG. 8 is a right side view thereof.

and half-tone portions so as to illustrate environmental
structure. These portions form no part of the claimed inven-
tion. More specifically, in FIG. 11, the inventive front fender
vent is shown within the broken line, and the elements
shown outside the broken line form no part of the claimed
invention, but are instead included to show environmental
aspects thereof.

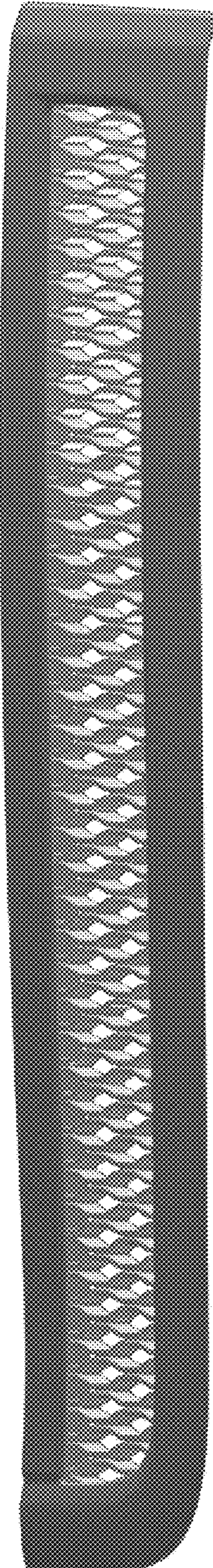

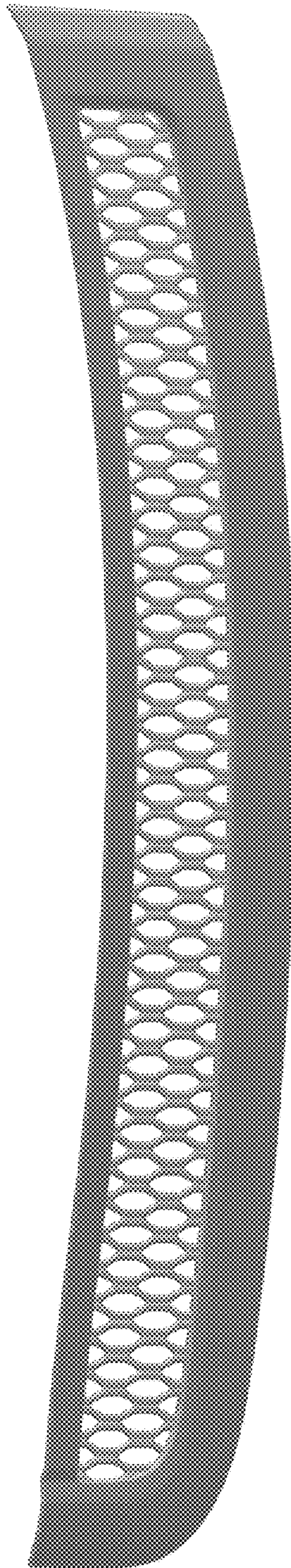

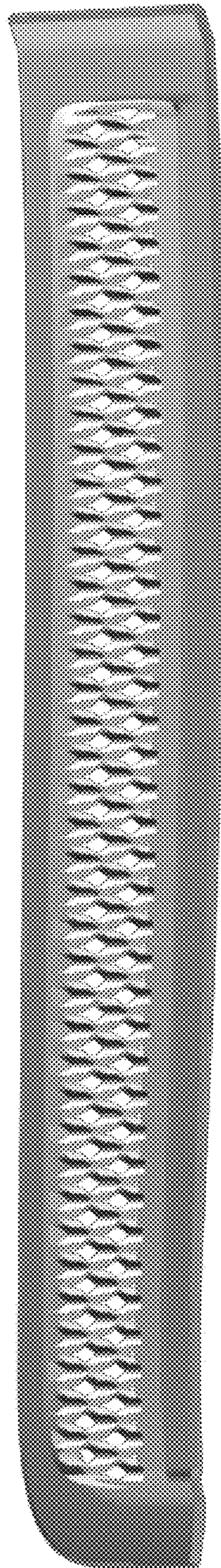

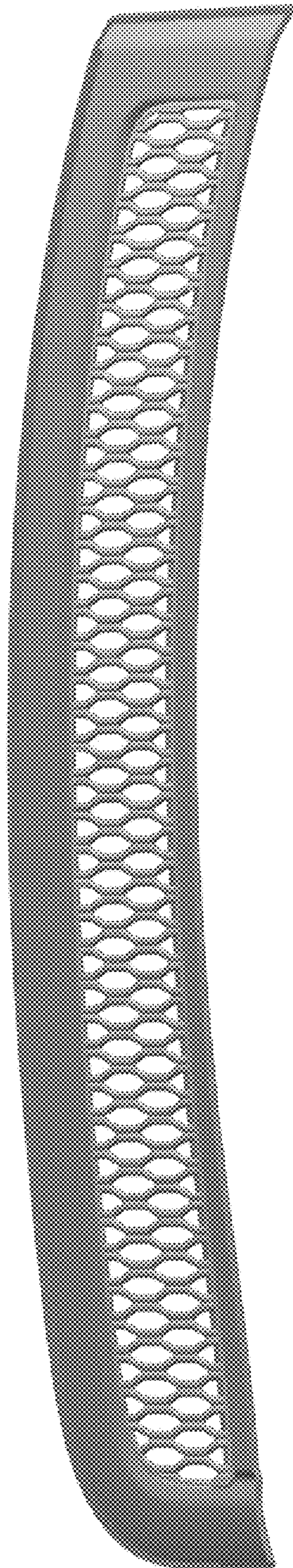

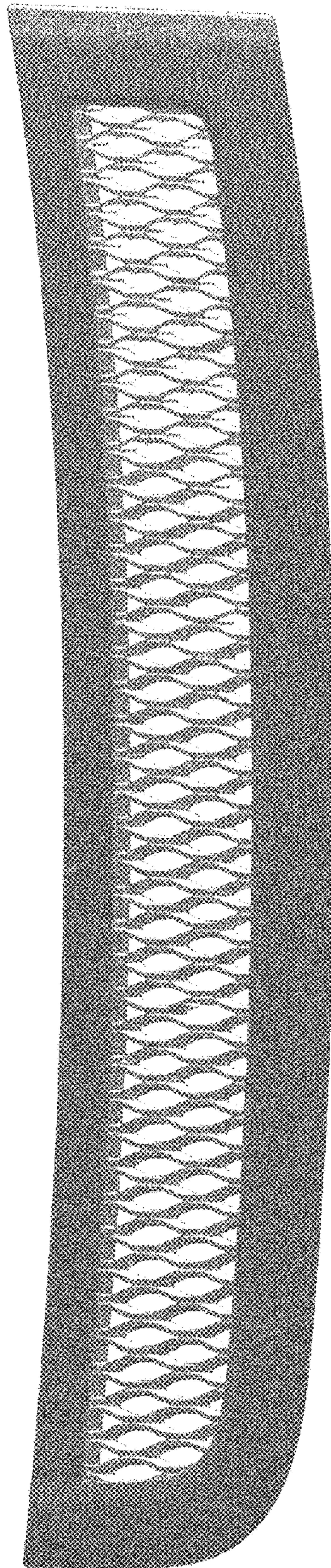

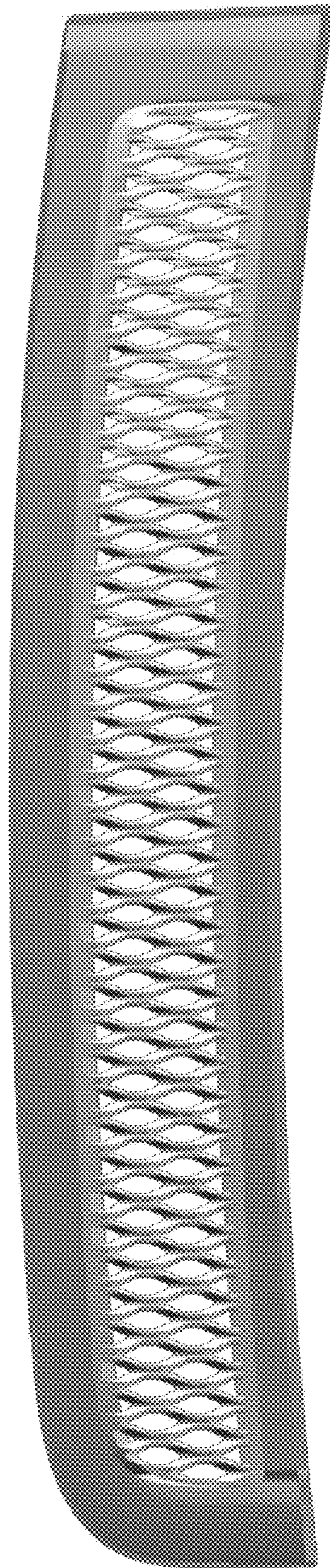

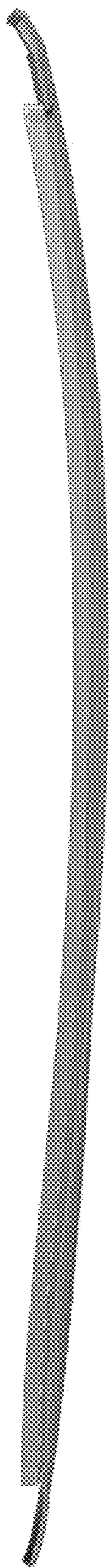

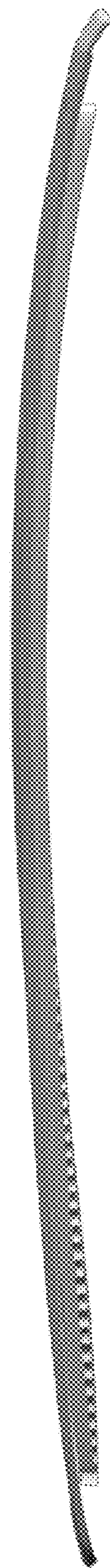

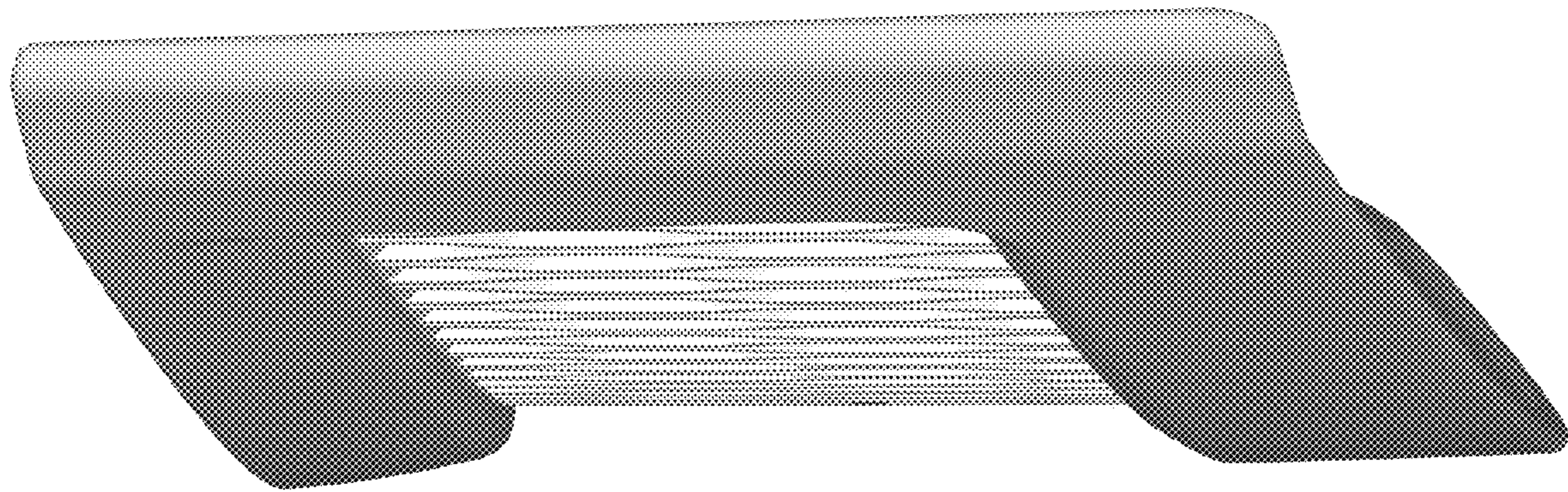

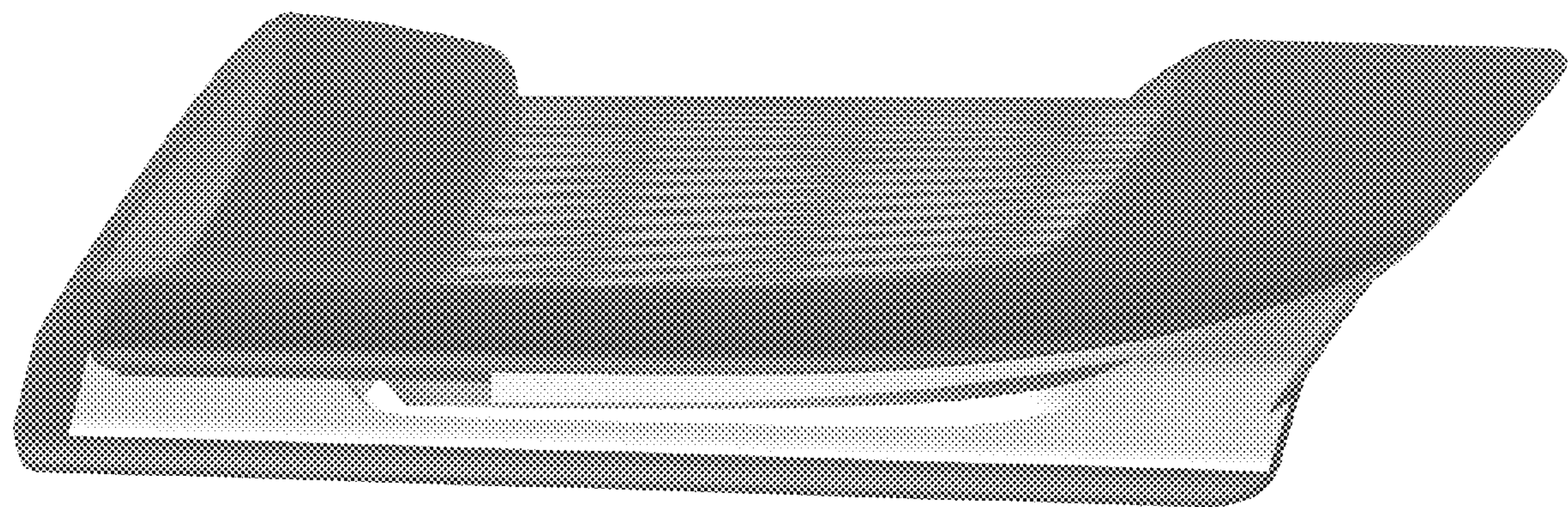

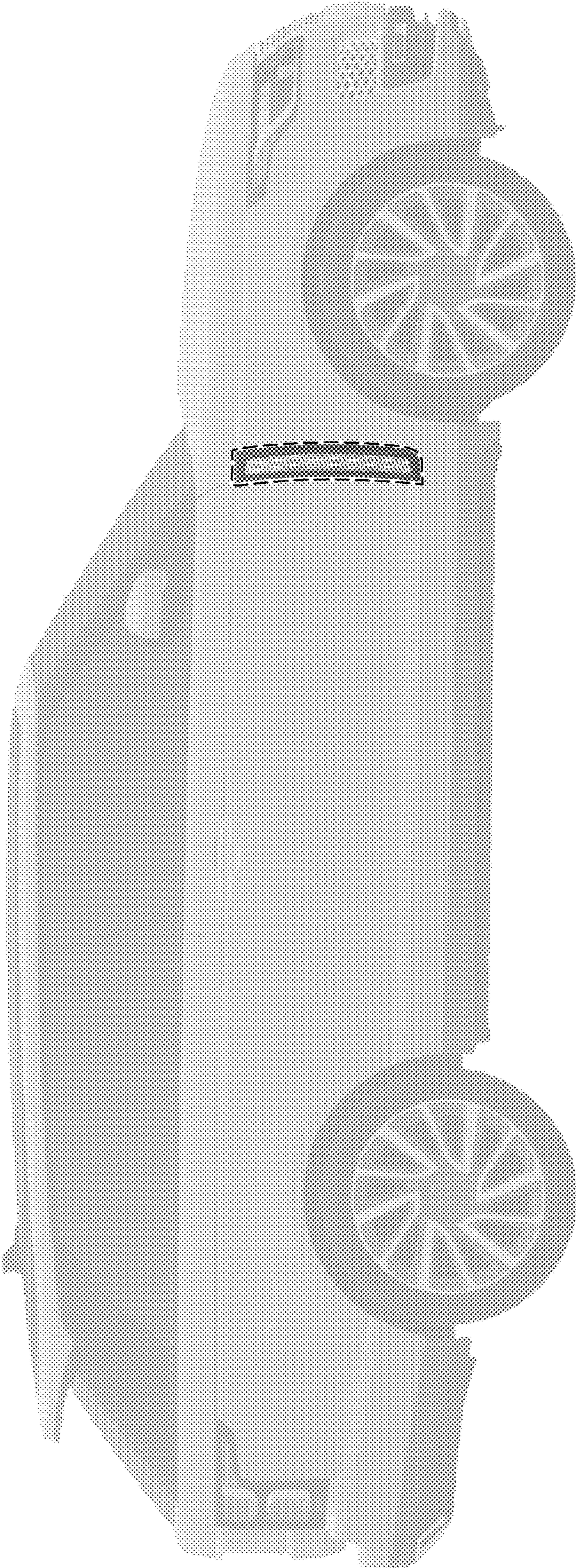
