(57) **CLAIM**

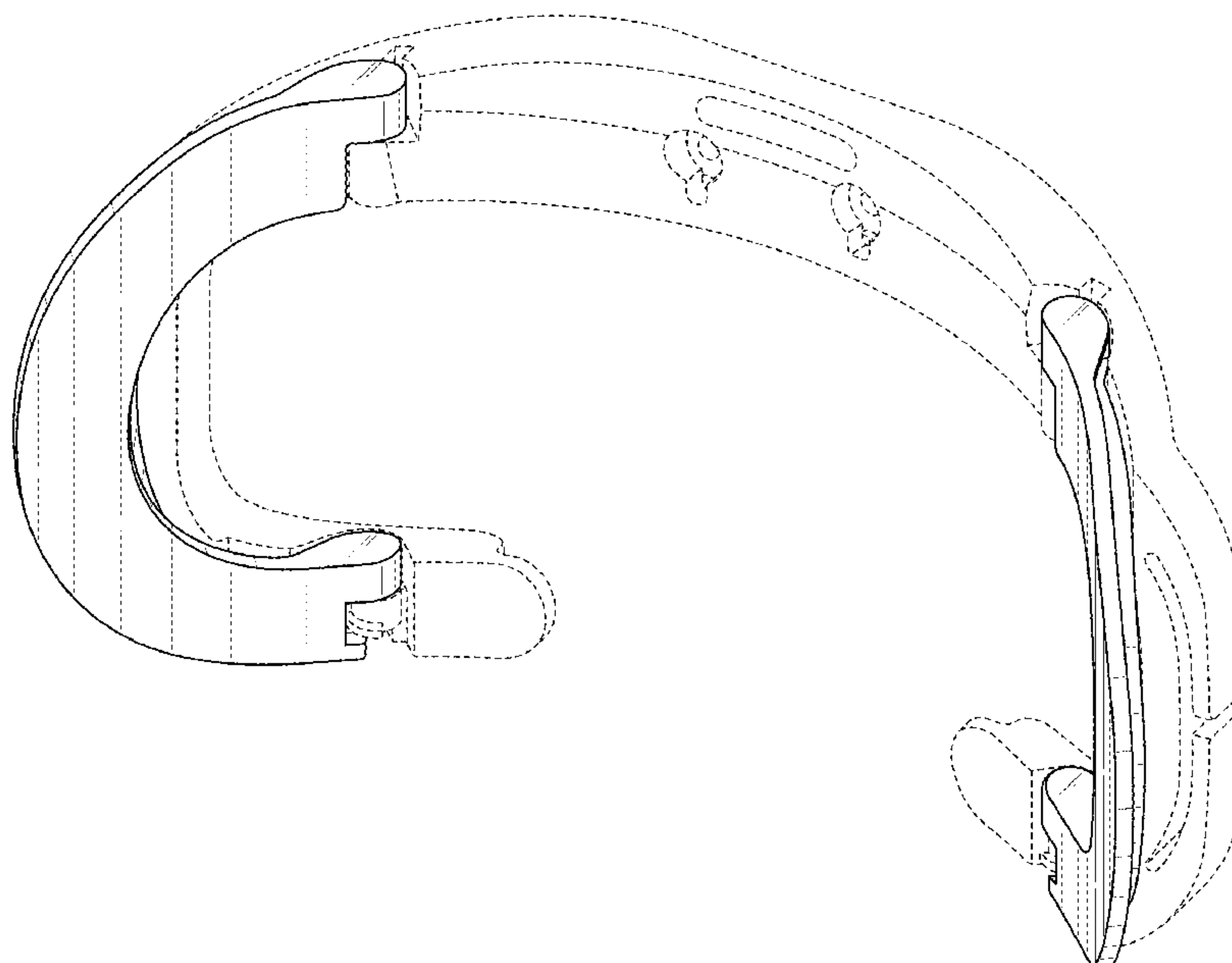
The ornamental design for a head-mounted attachment member for display, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a head-mounted attachment member for display showing my new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a perspective view thereof;
FIG. 8 is a top plan view thereof in a changed state; and,

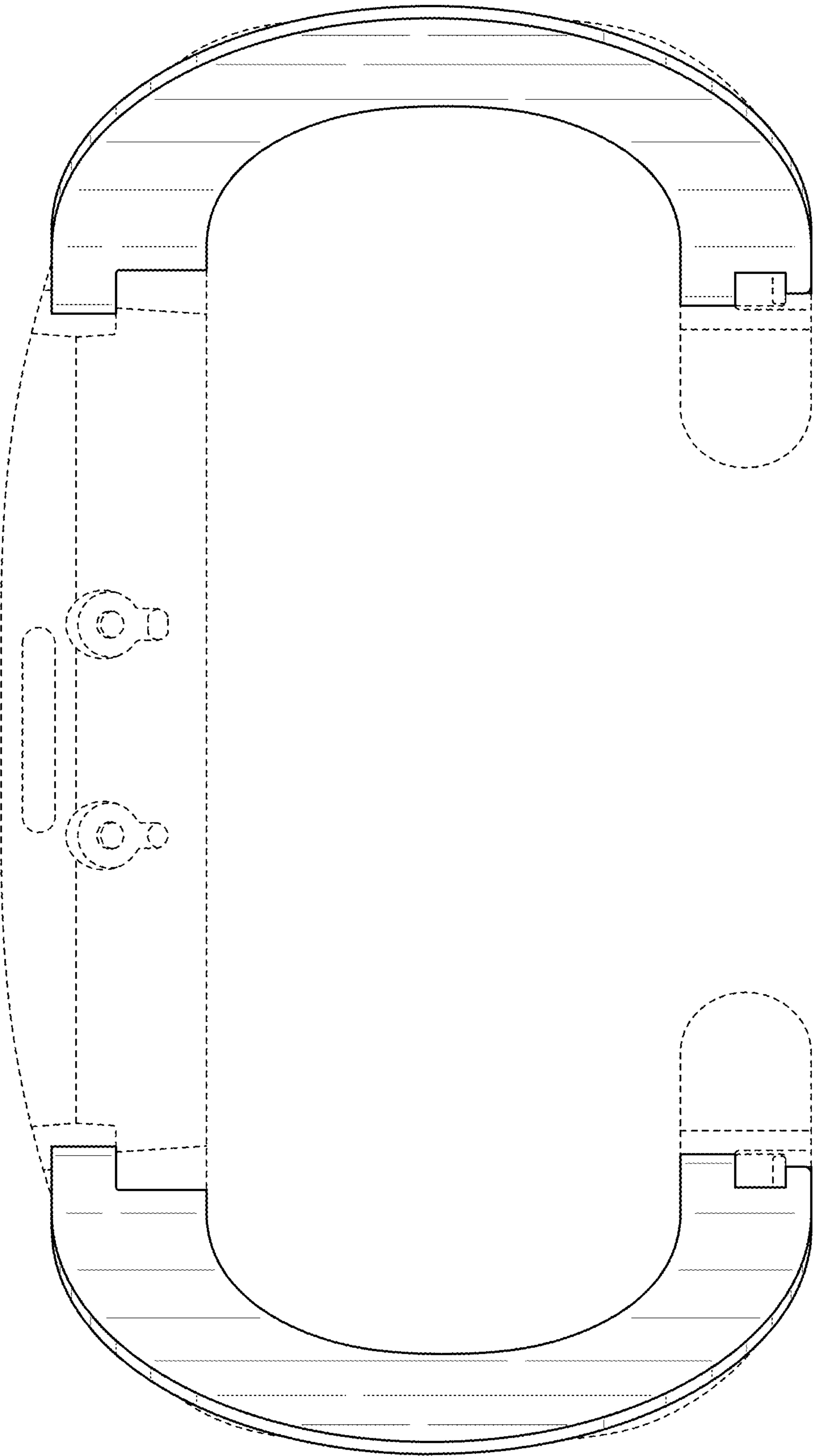

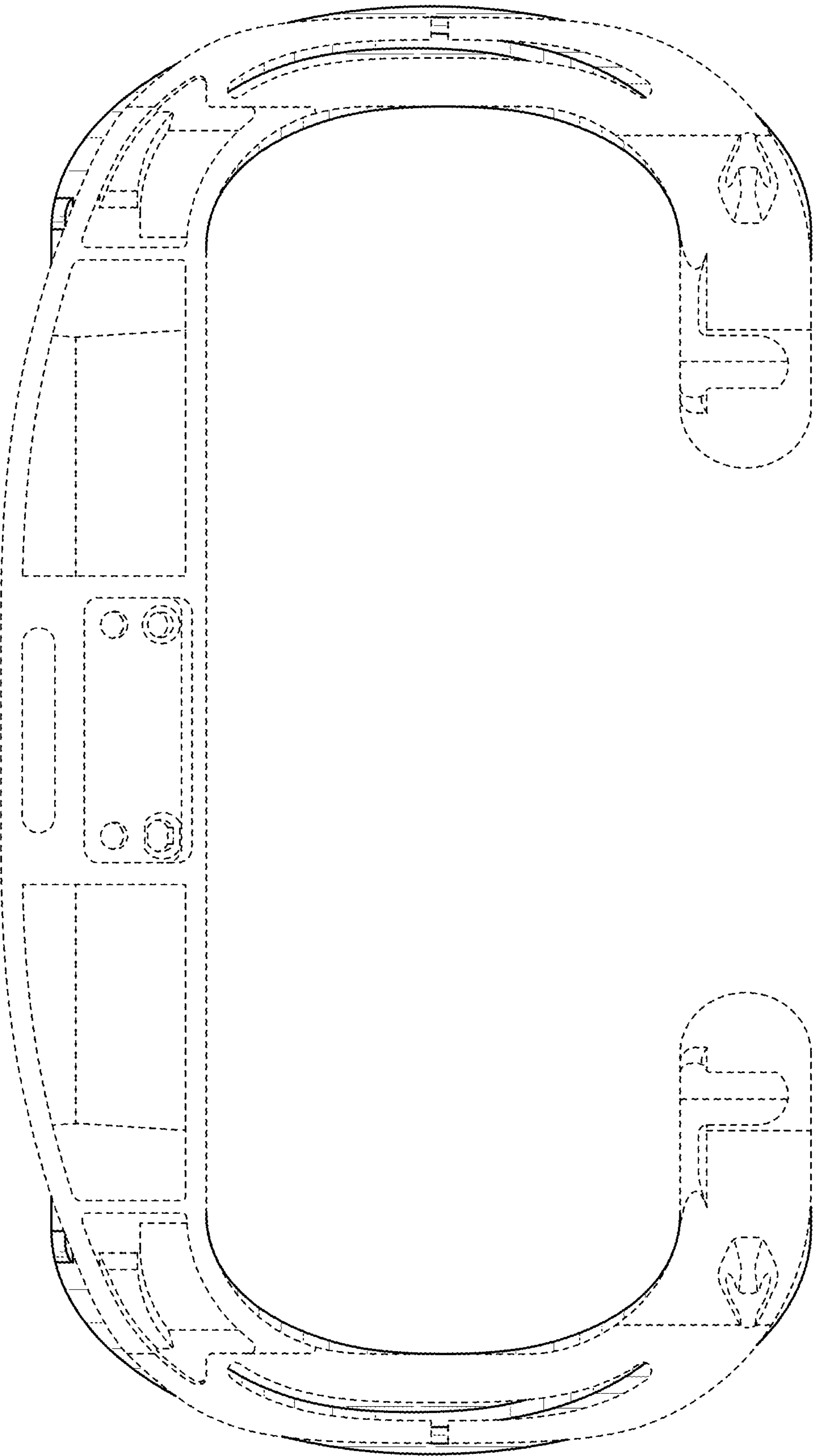

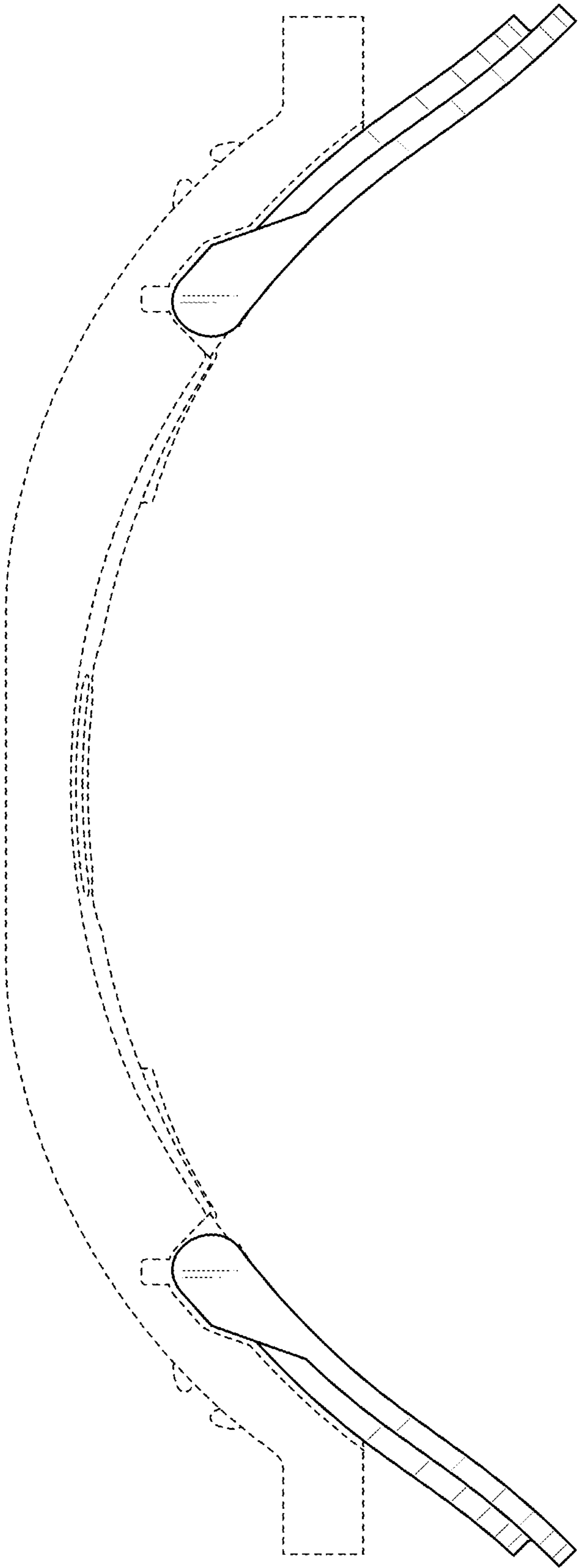

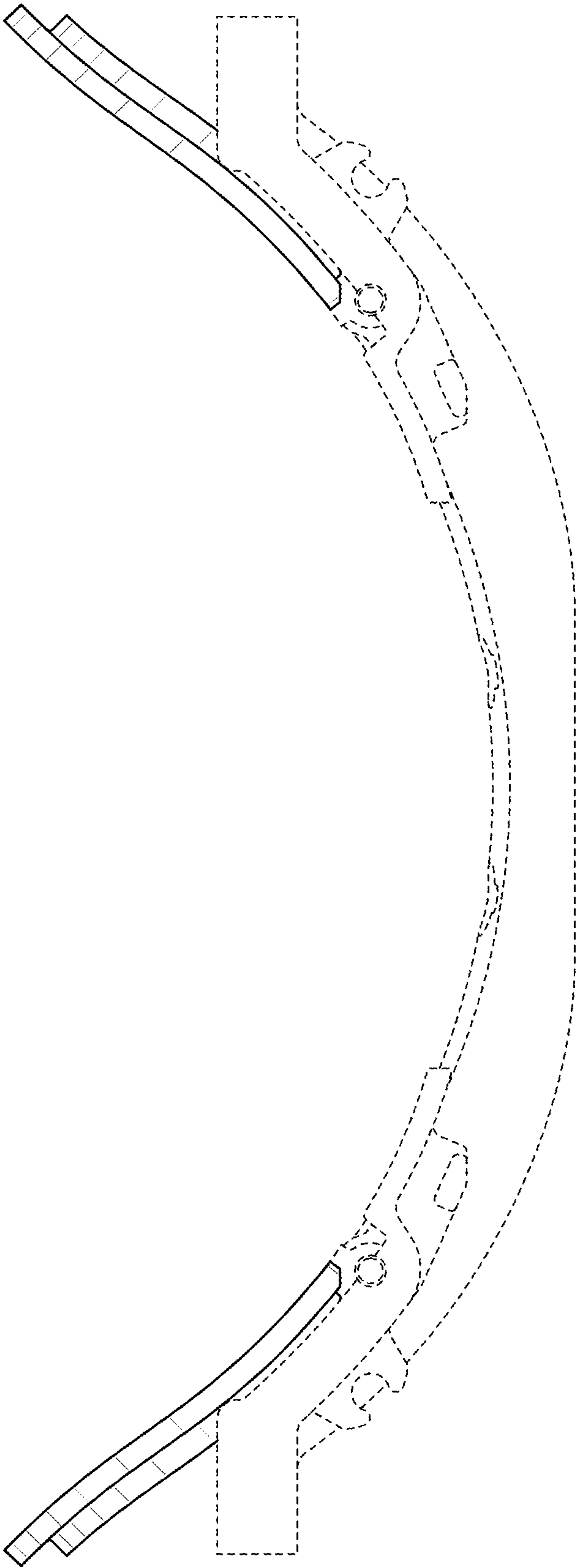

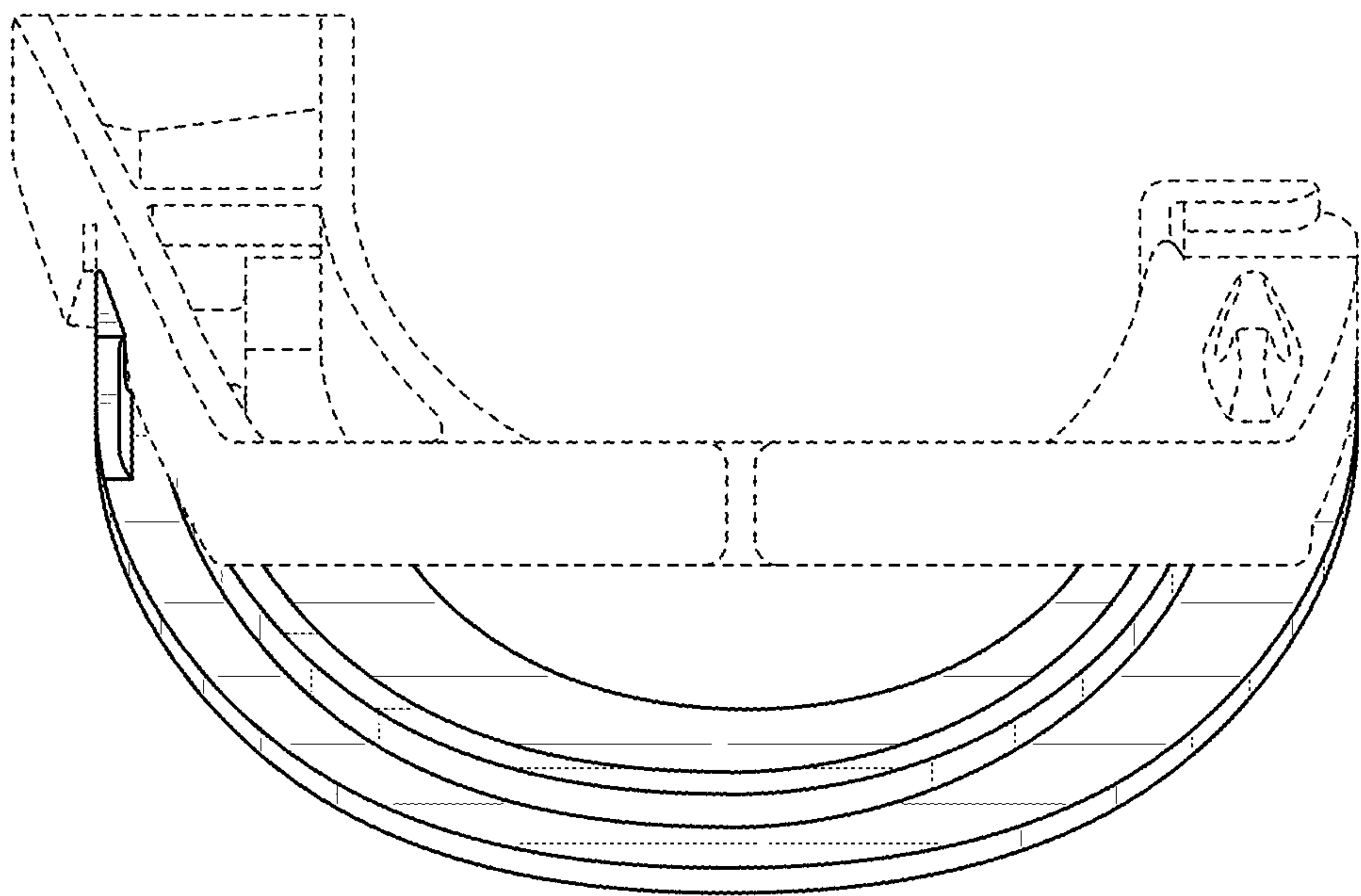

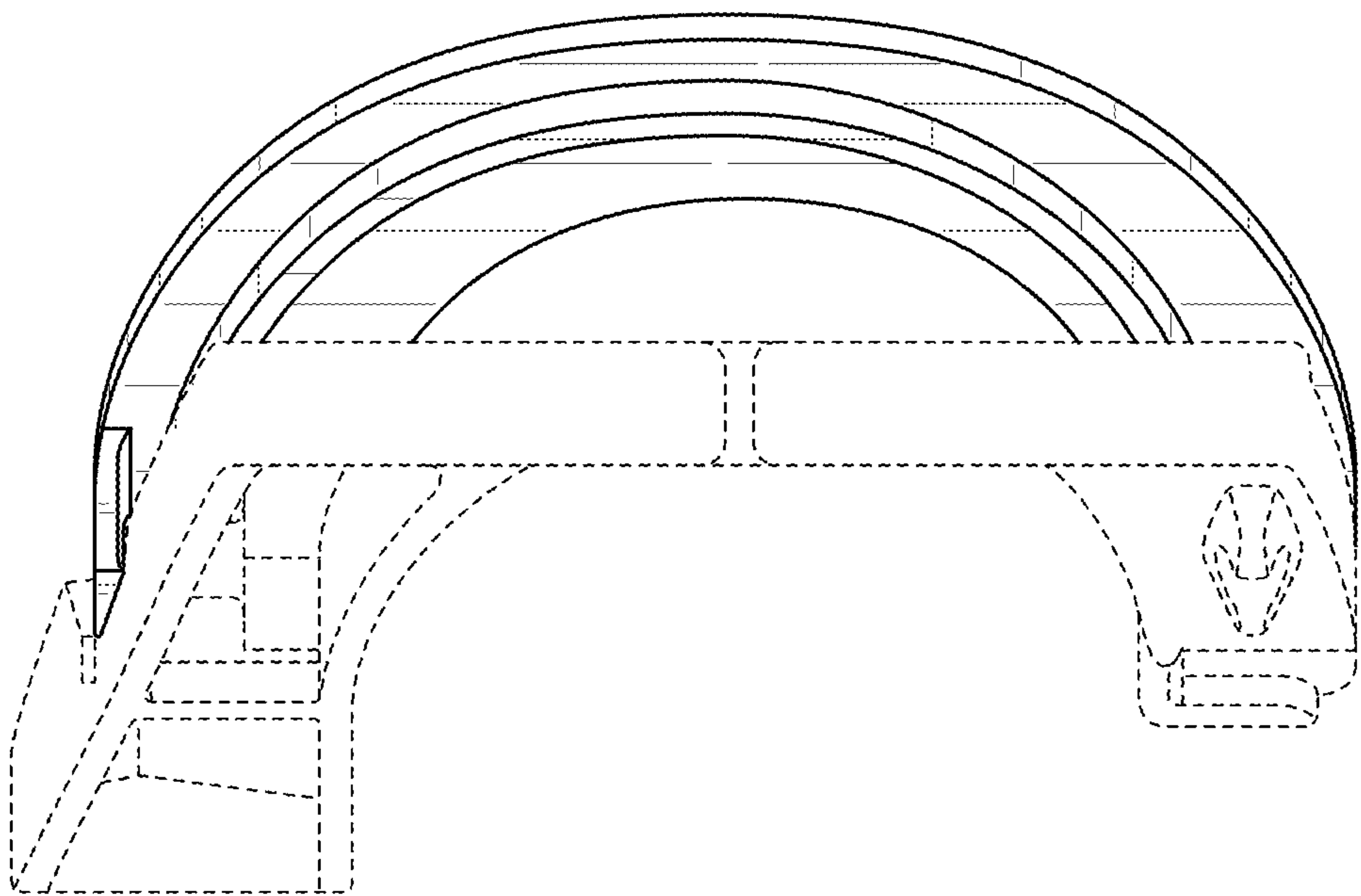

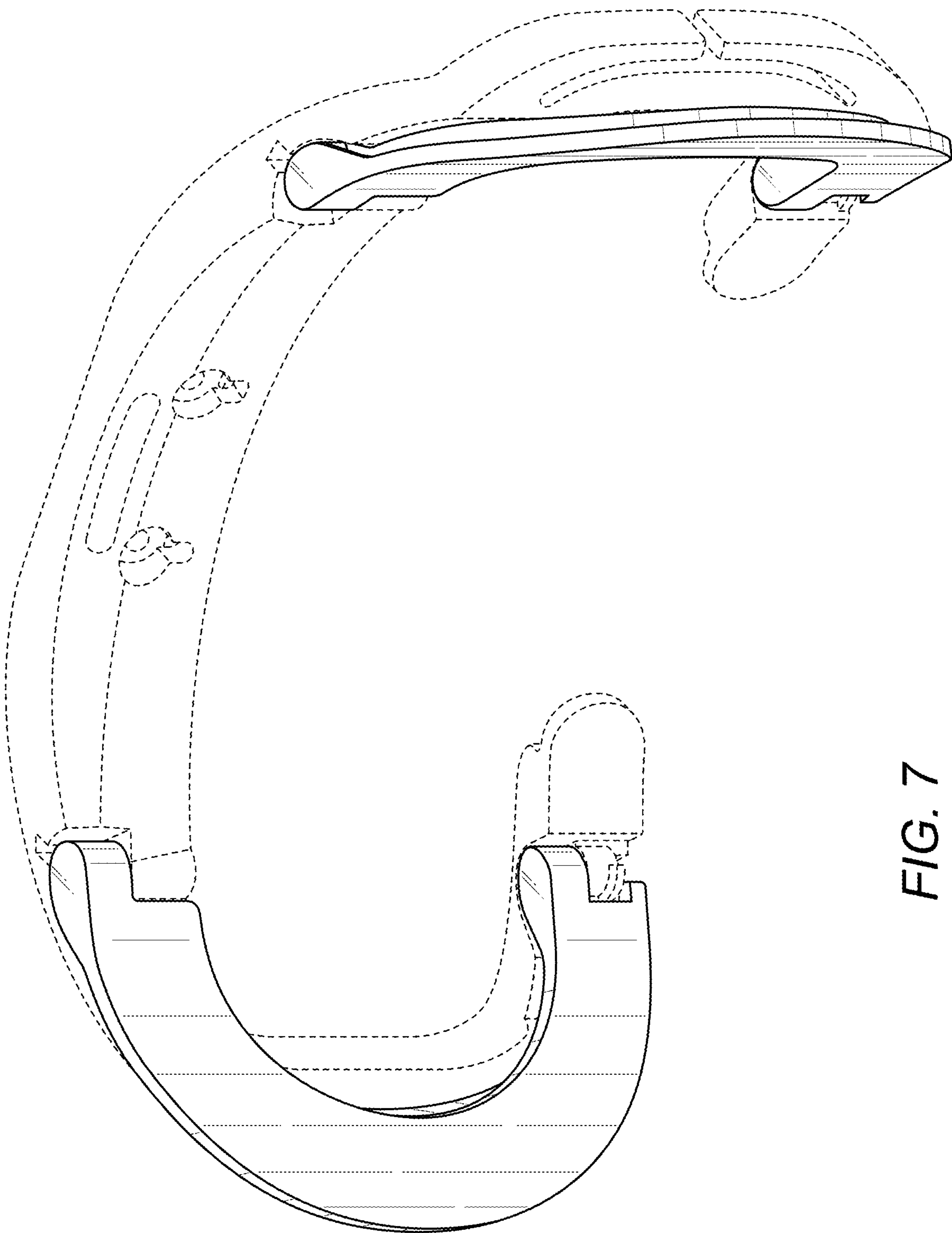

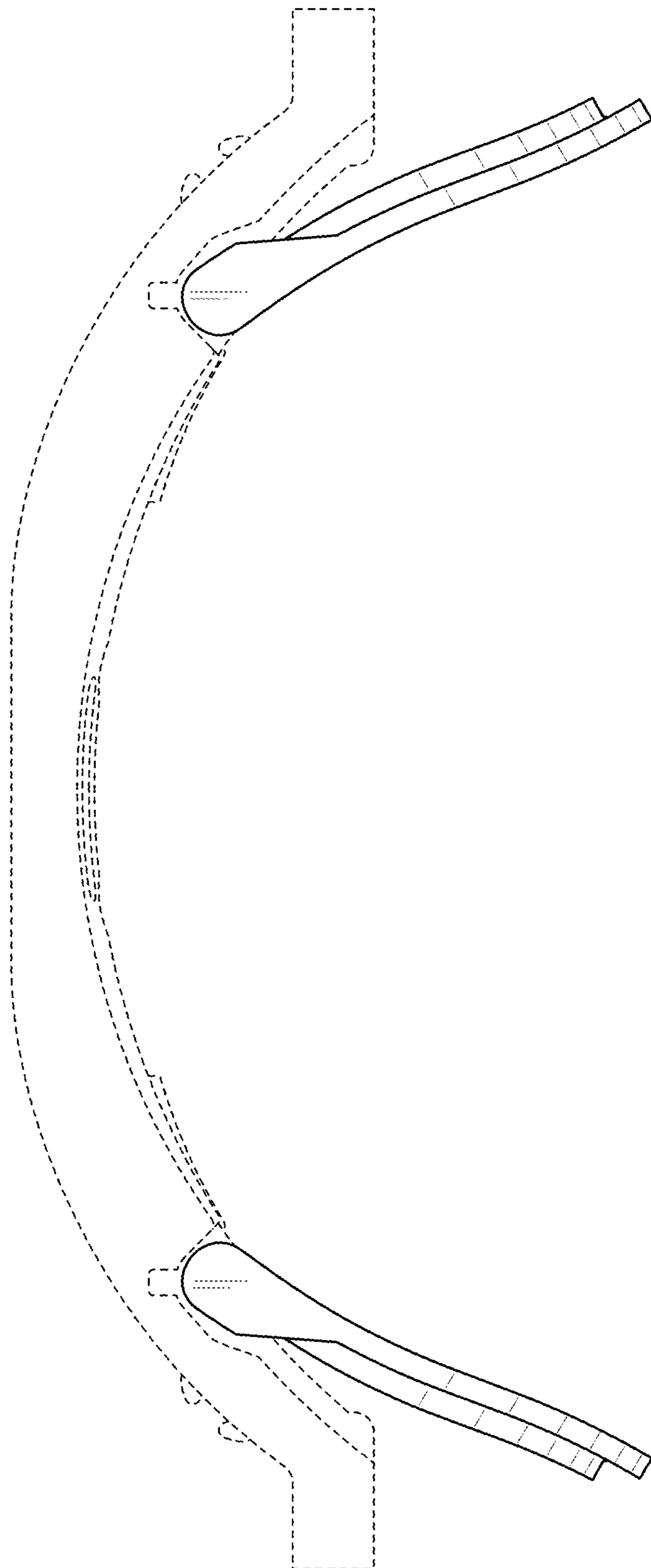

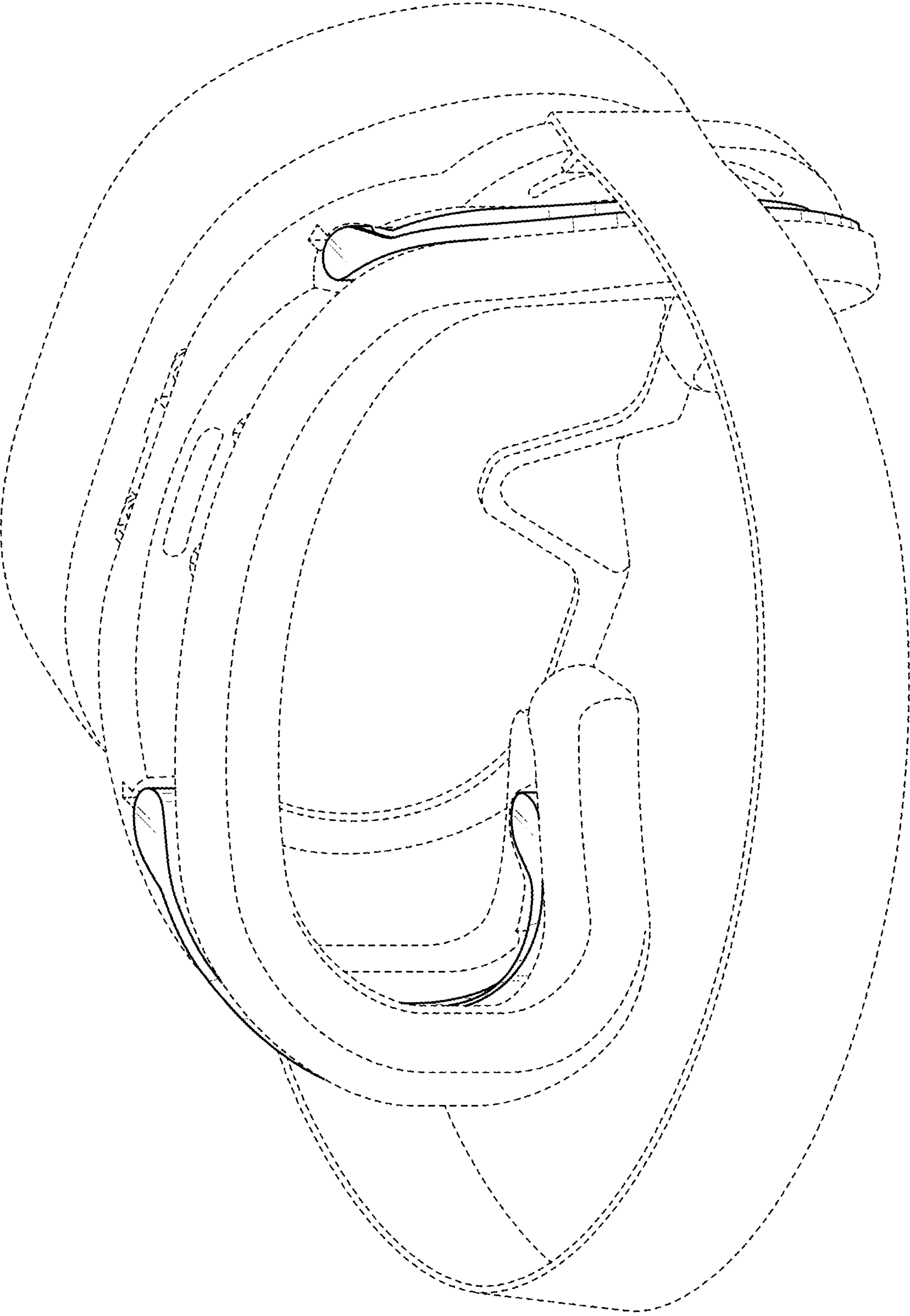
