**DESCRIPTION**

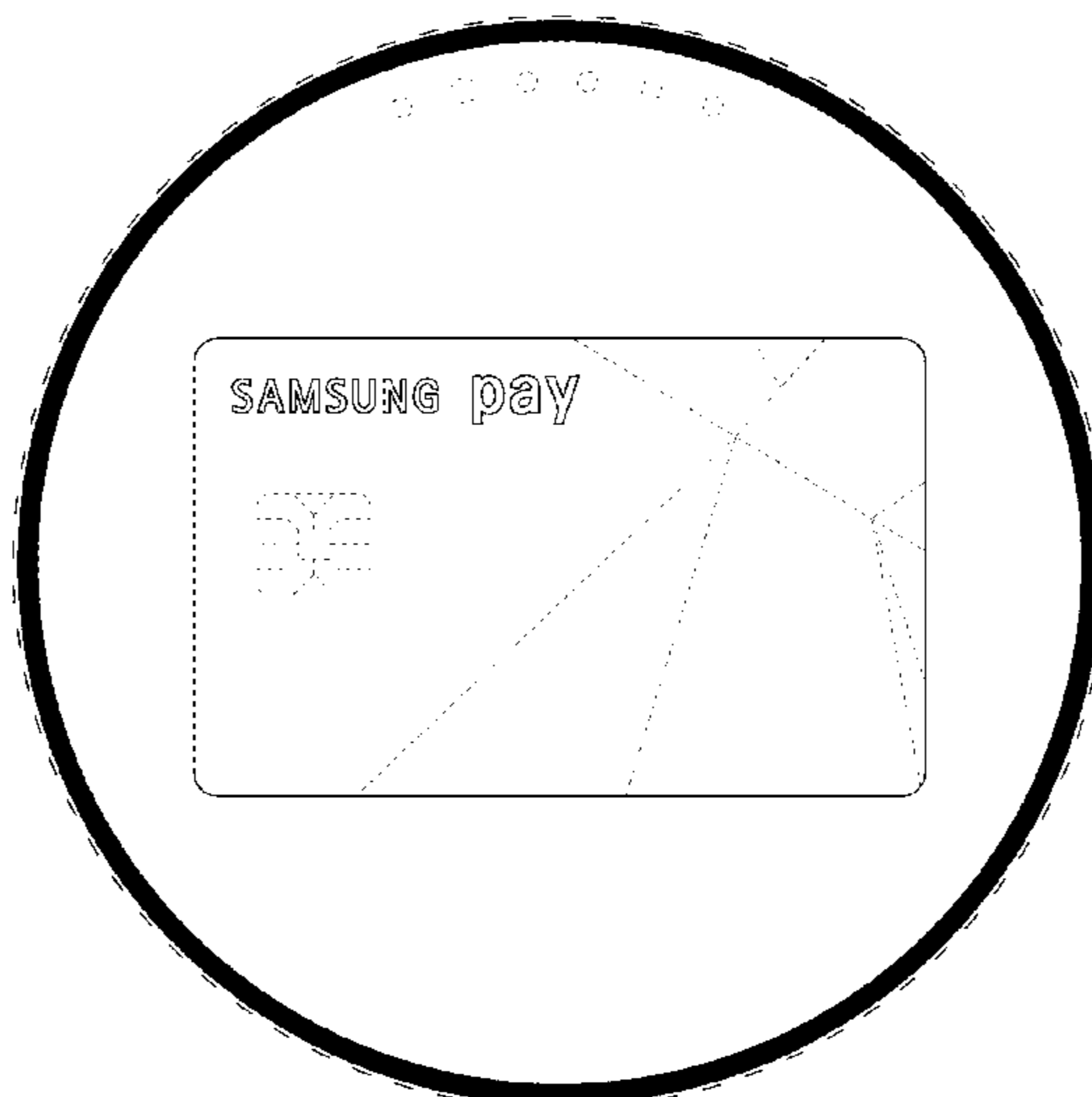
The FIGURE is a front view of a display screen or portion thereof with graphical user interface, showing our new design.
