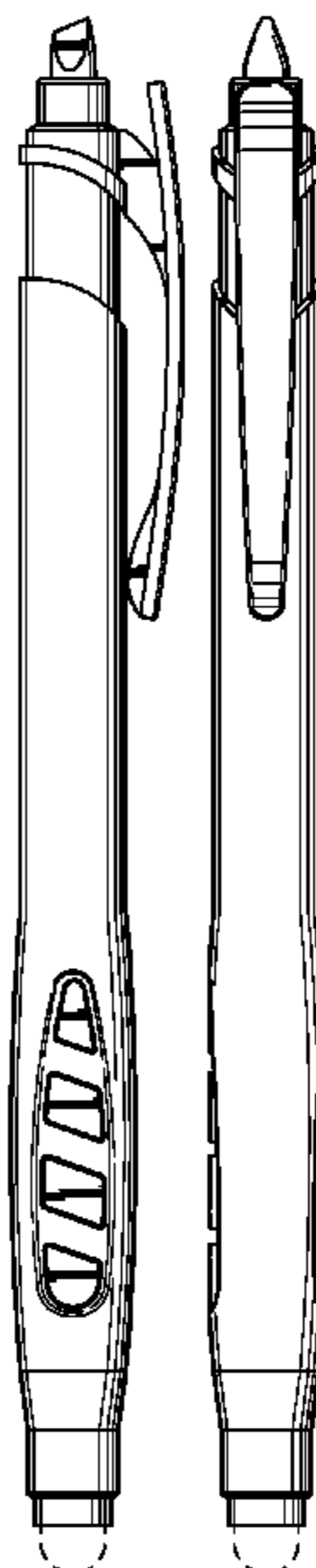
(57) **CLAIM**

The ornamental design for a pen, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevation view of a pen showing my new design;
FIG. 2 is a front elevation view of the pen of FIG. 1;
FIG. 3 is a right side elevation view of the pen of FIG. 1;
FIG. 4 is a rear elevation view of the pen of FIG. 1;
FIG. 5 is a bottom plan view of the pen of FIG. 1;
FIG. 6 is a top plan view of the pen of FIG. 1; and,
FIG. 7 is a perspective view of the pen of FIG. 1, showing environment.
The broken lines in the figures show portions of the pen which form no part of the claimed design.

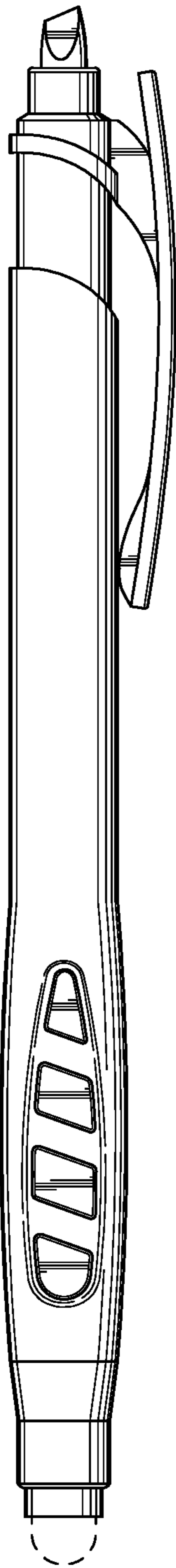

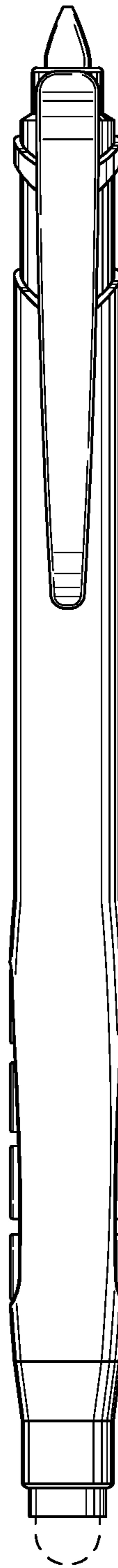

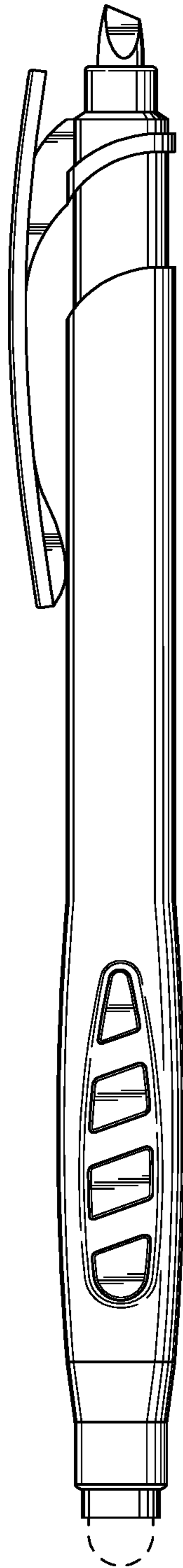

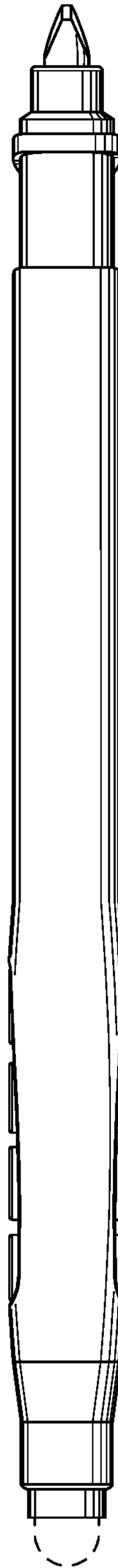

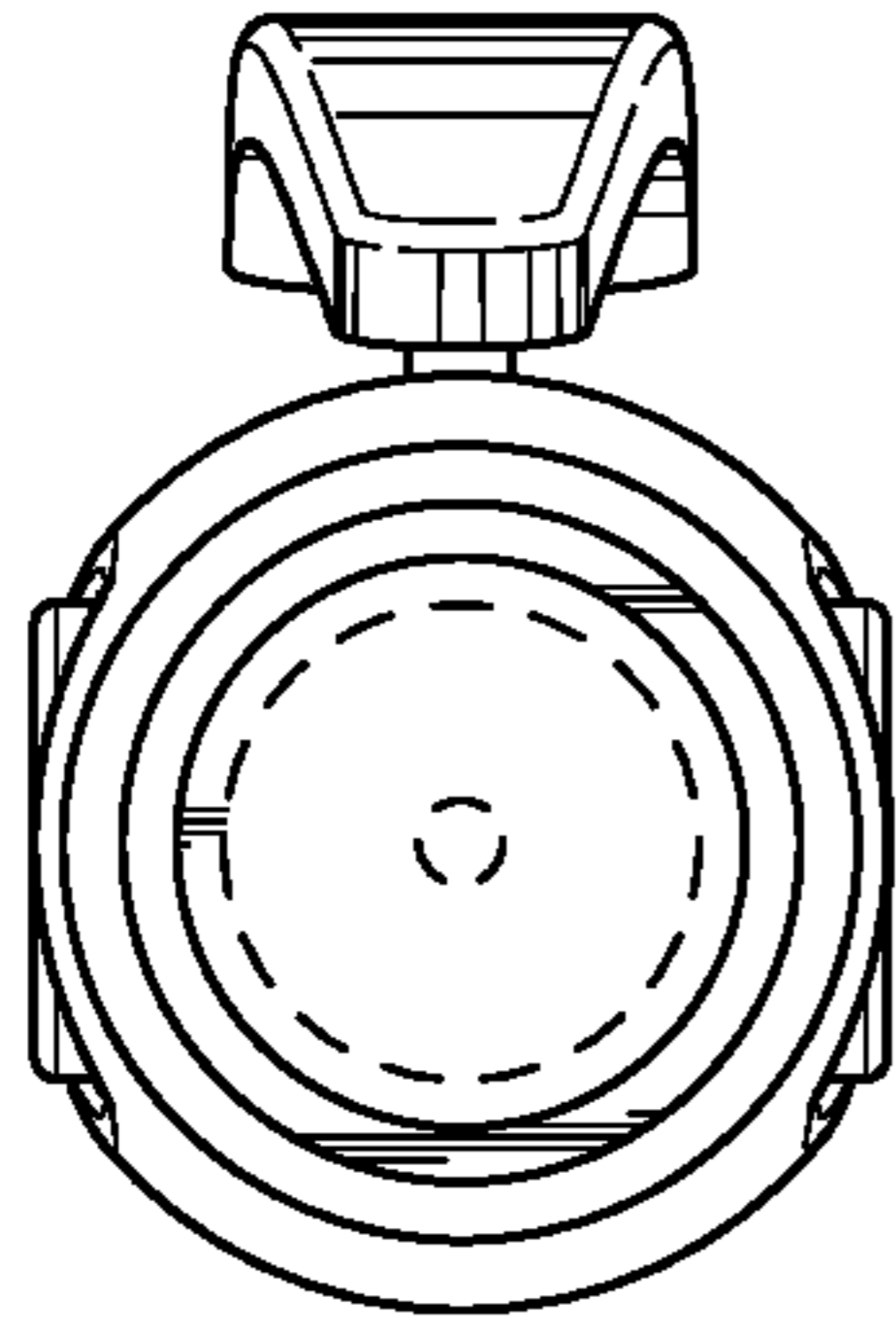

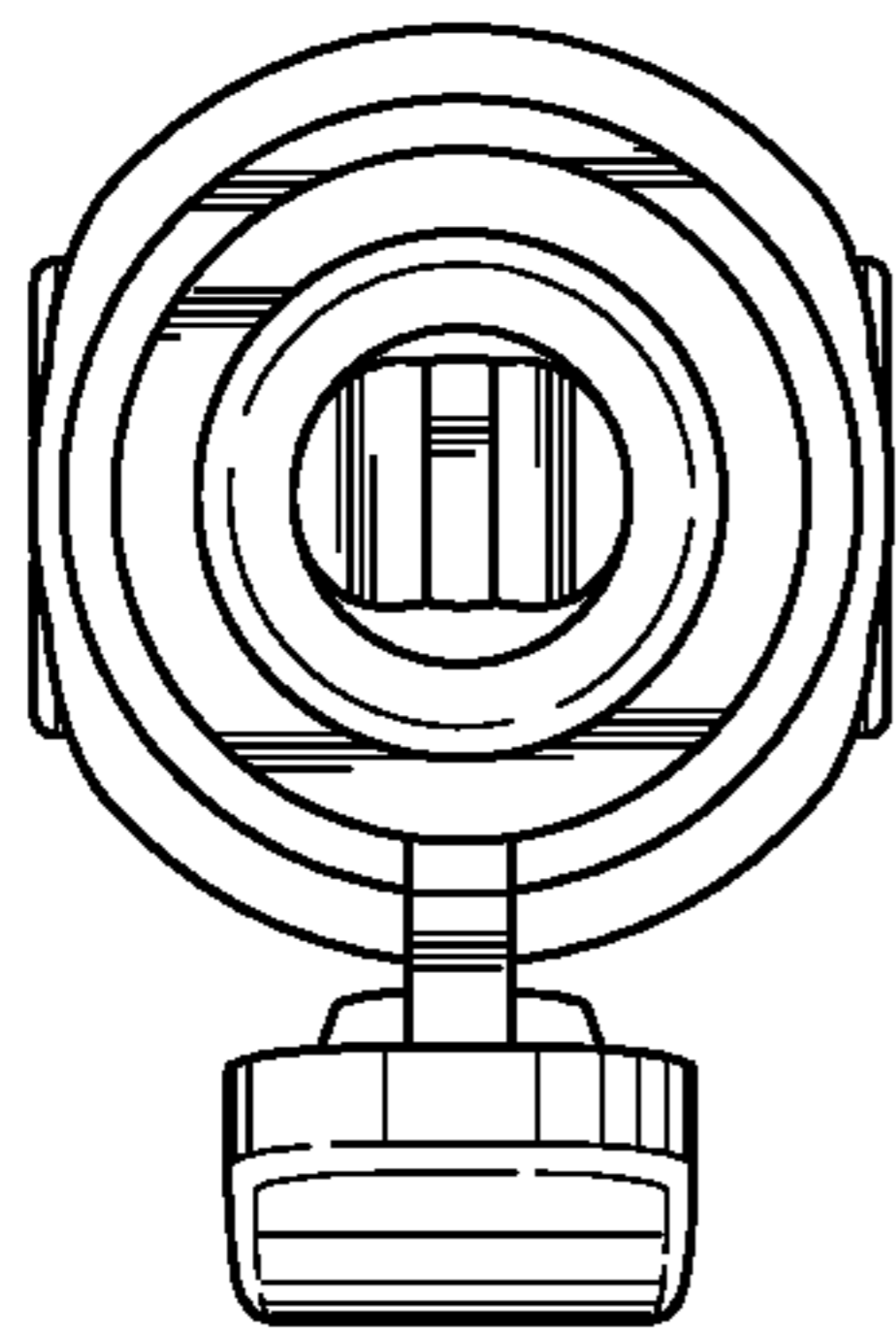

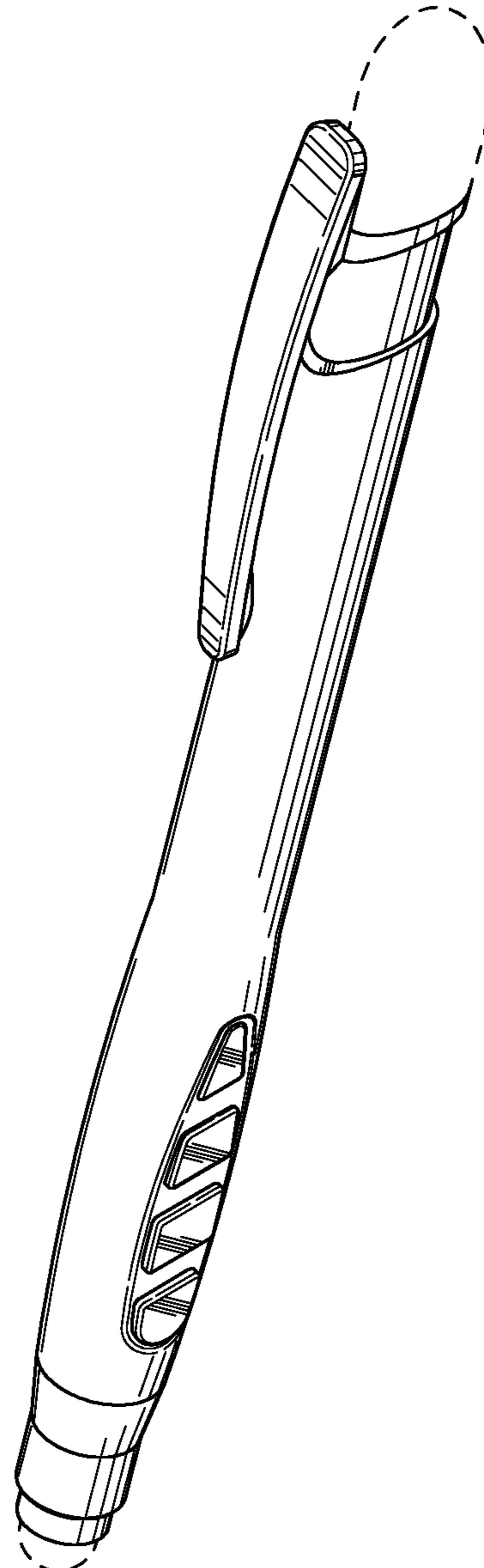
