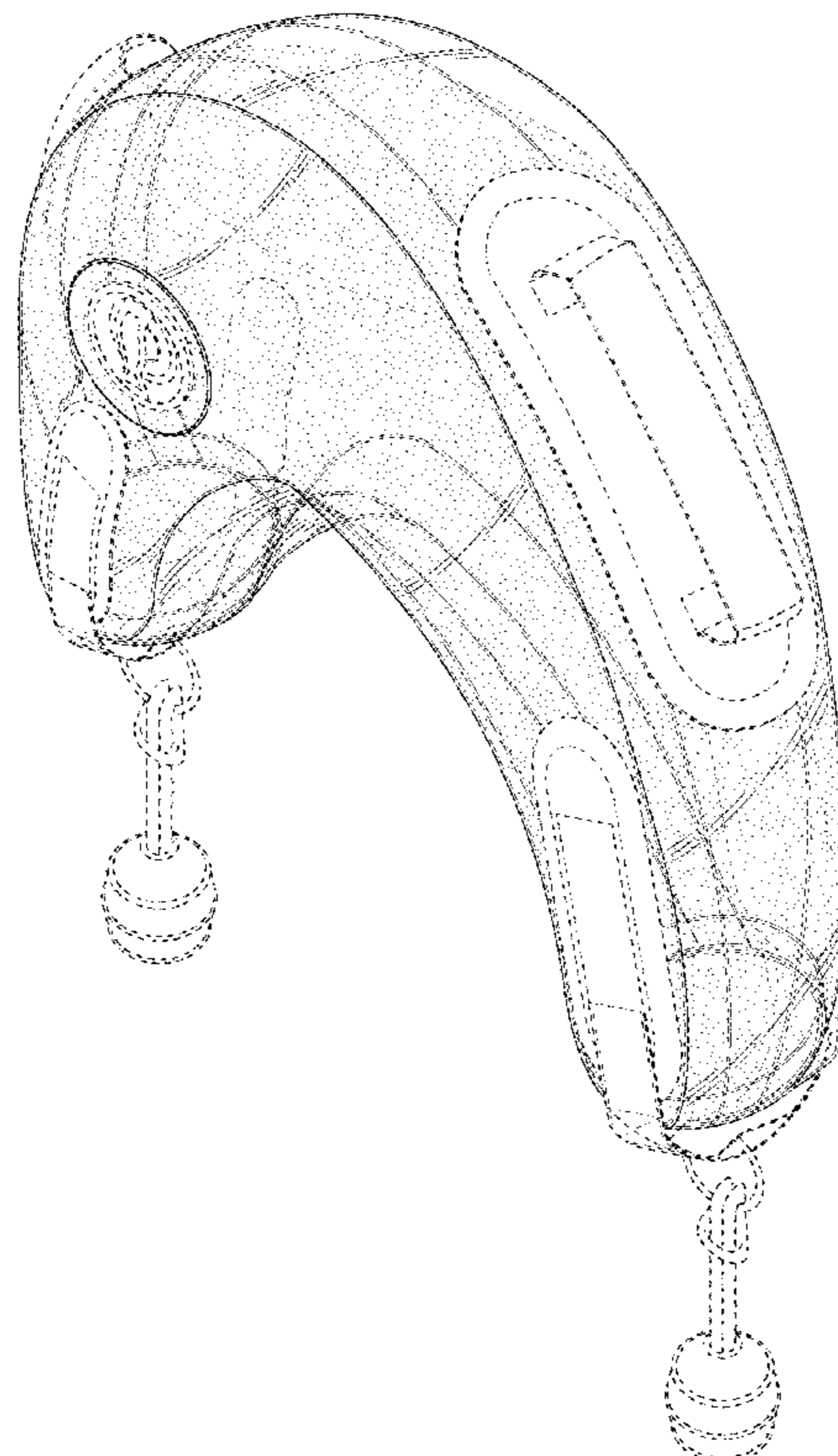
(57) **CLAIM**

The ornamental design for a fitness bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the fitness bag showing our new design;  
FIG. 2 is a front side elevation view thereof;  
FIG. 3 is a back side elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;

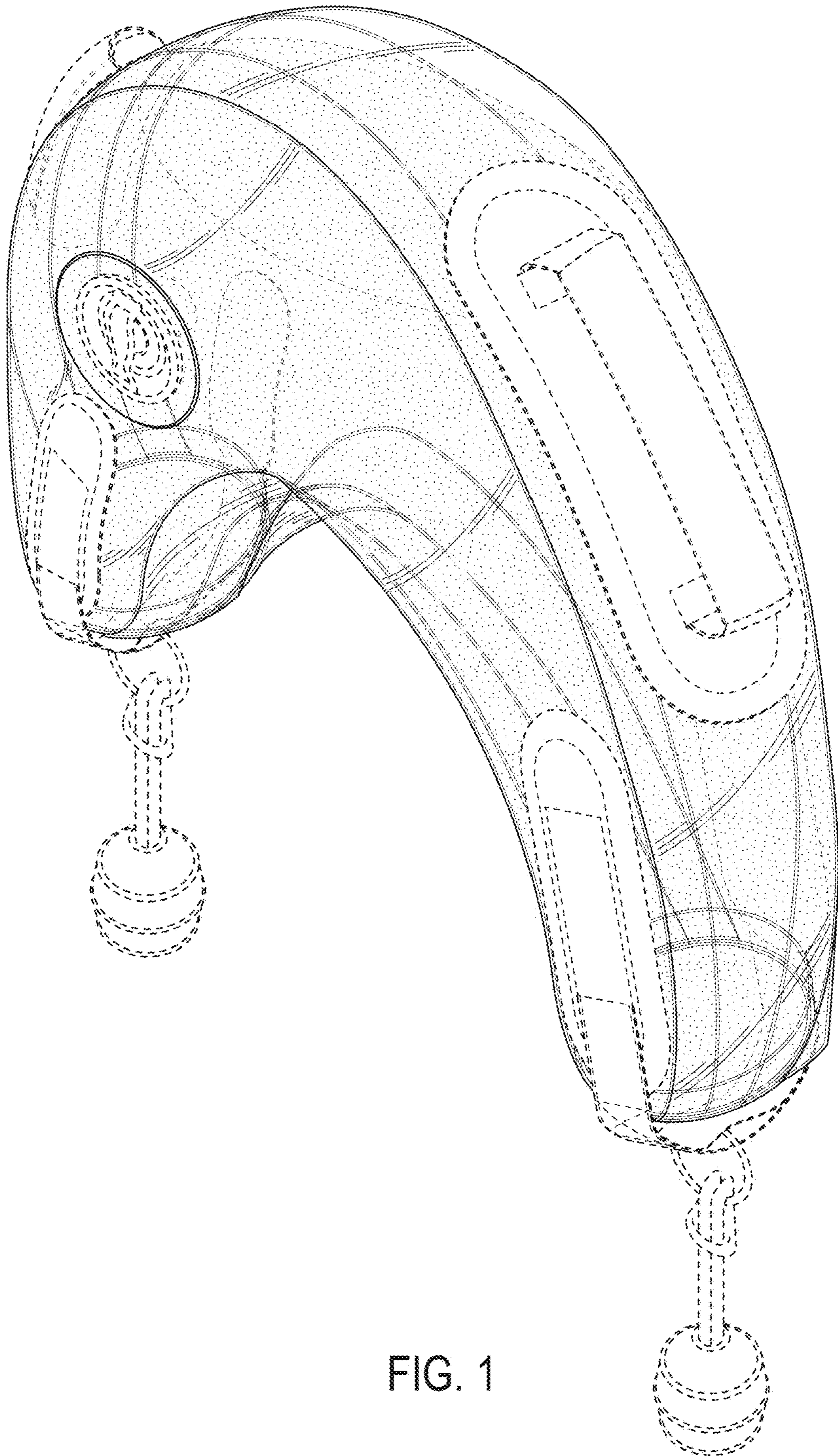

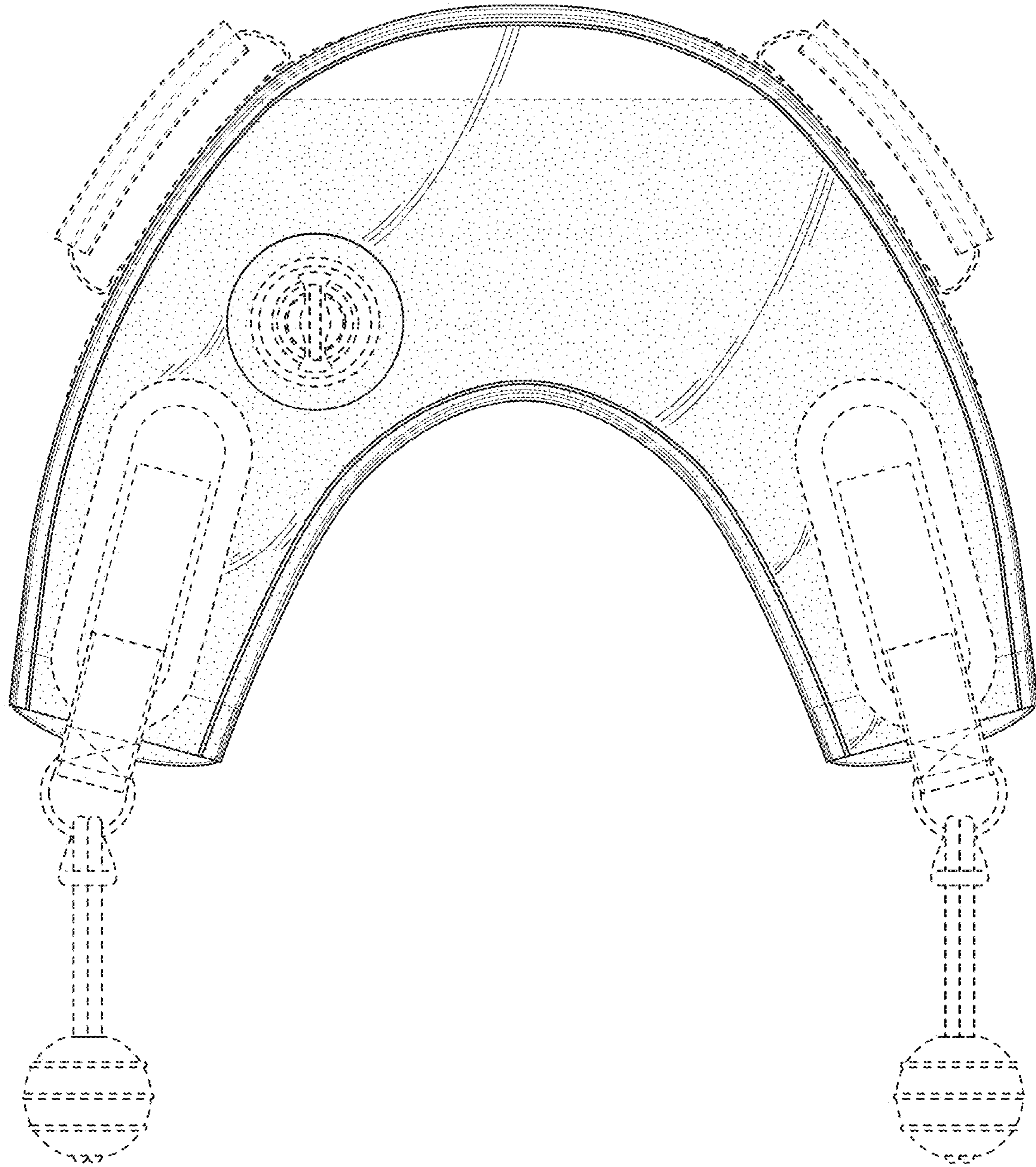

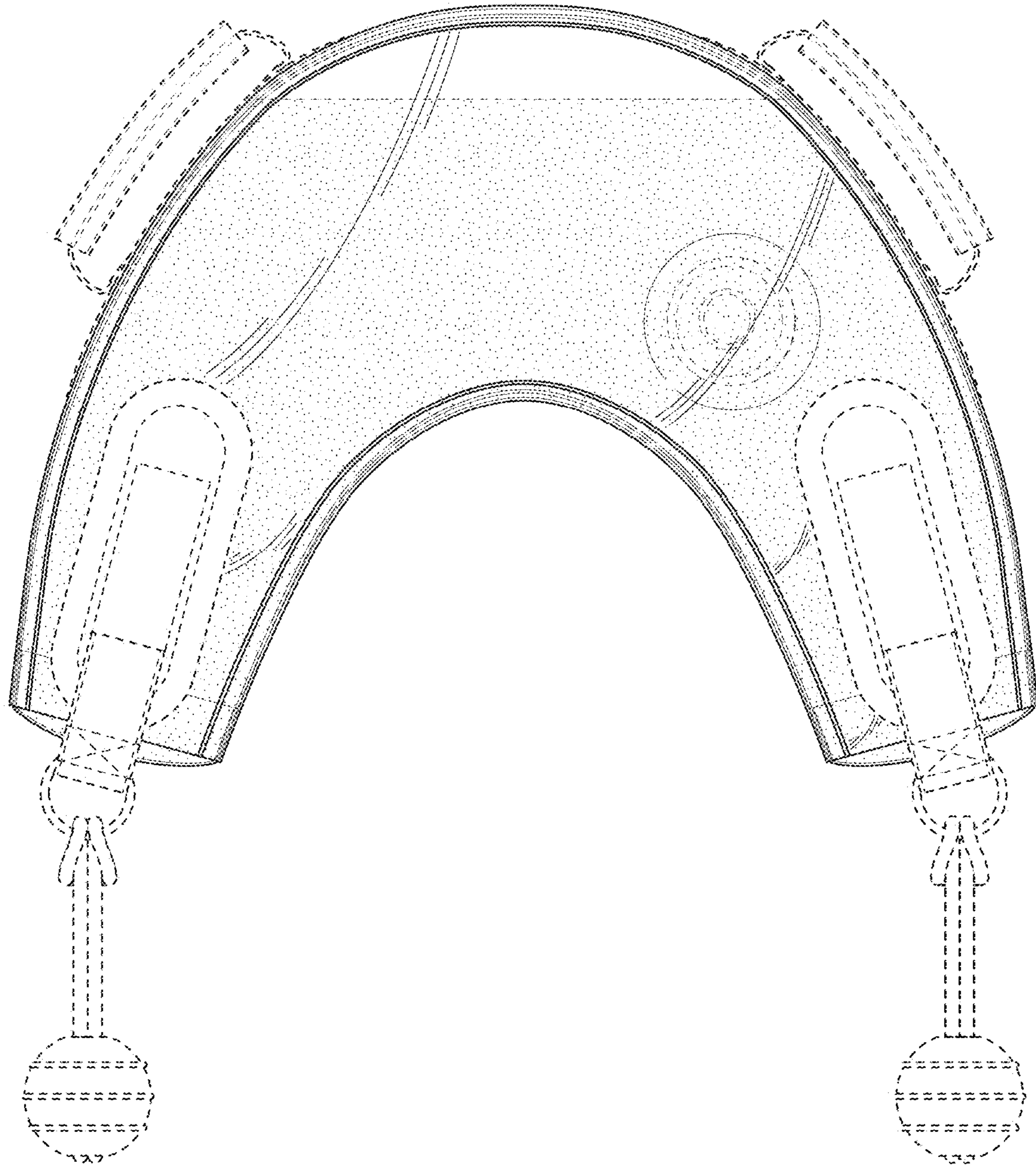

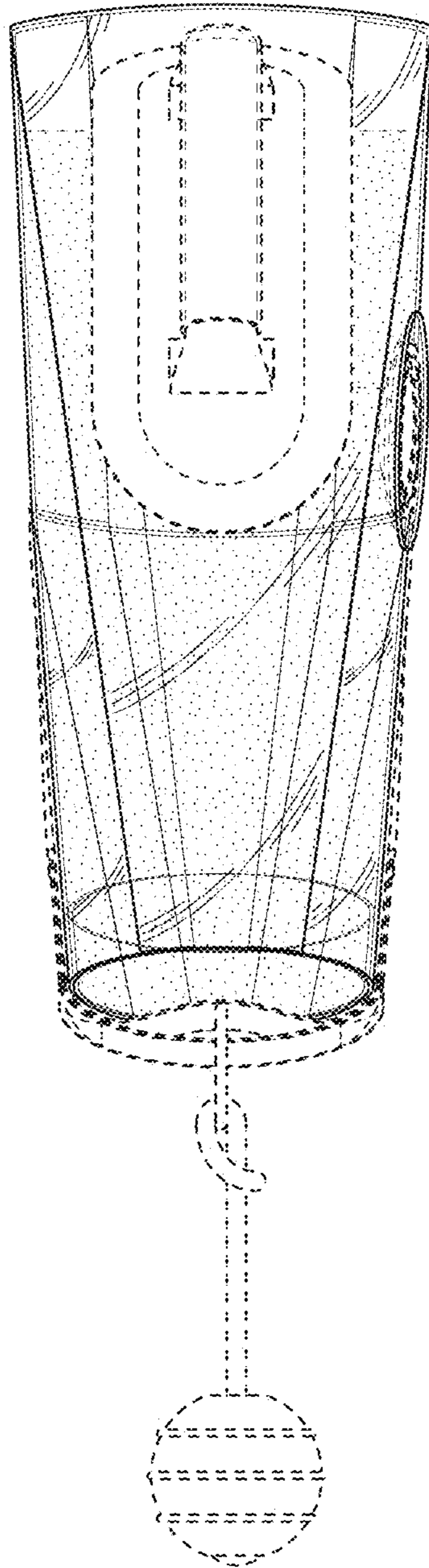

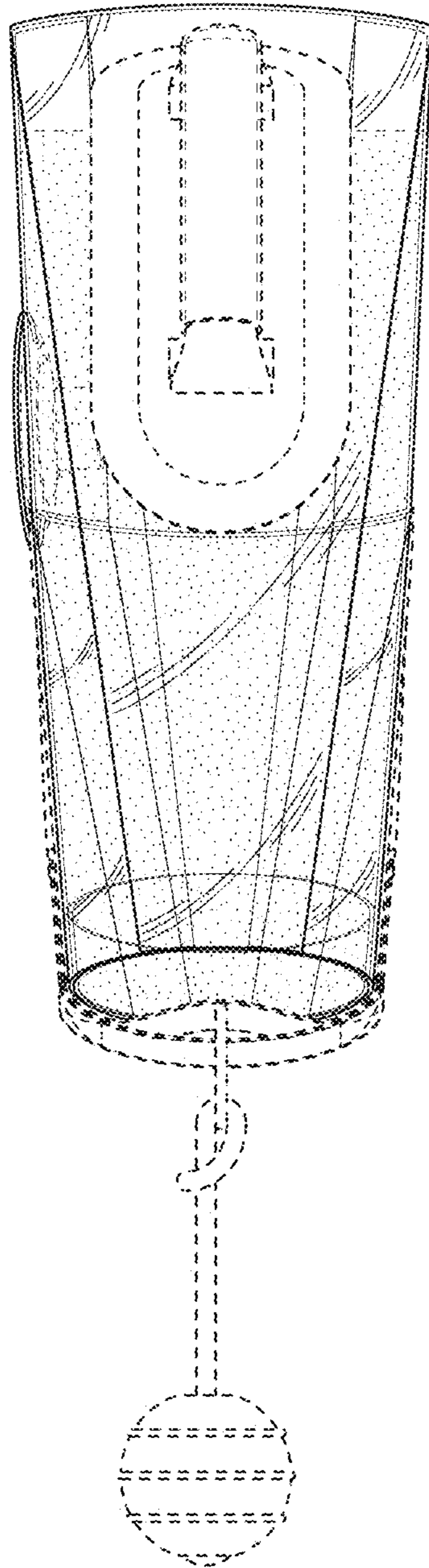

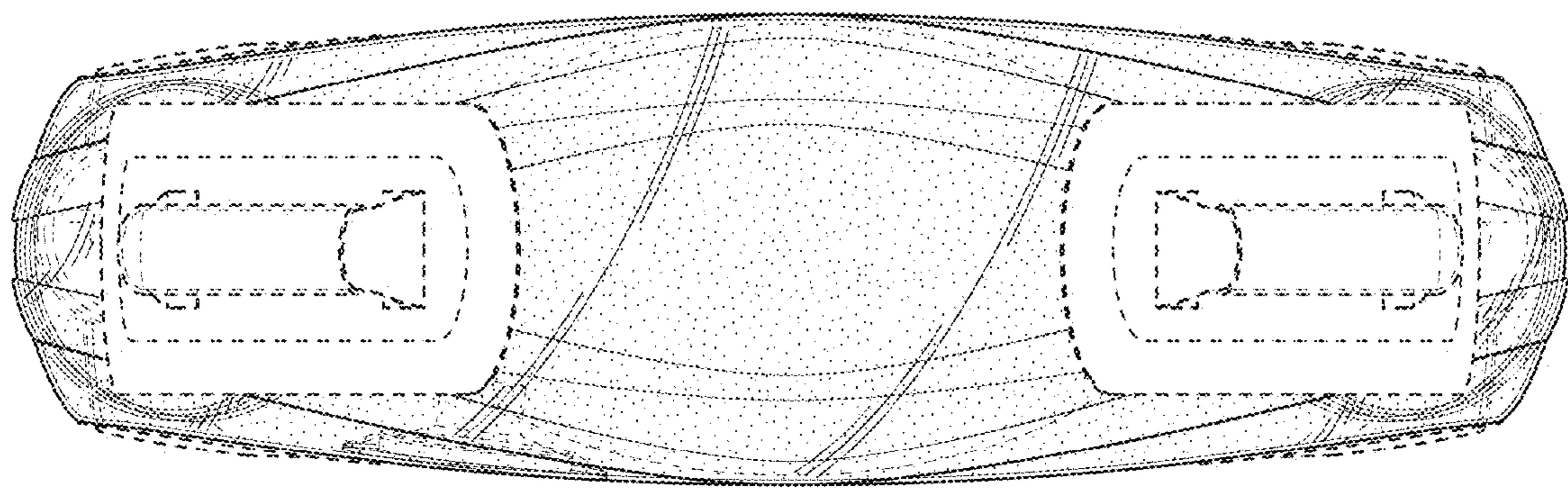

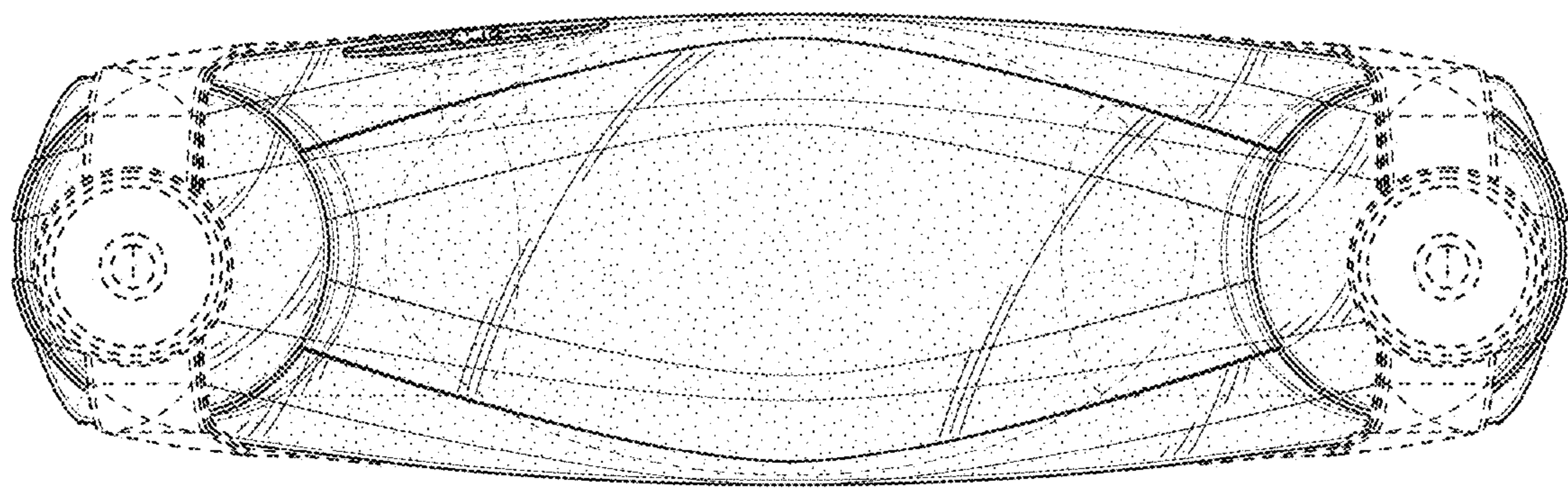
