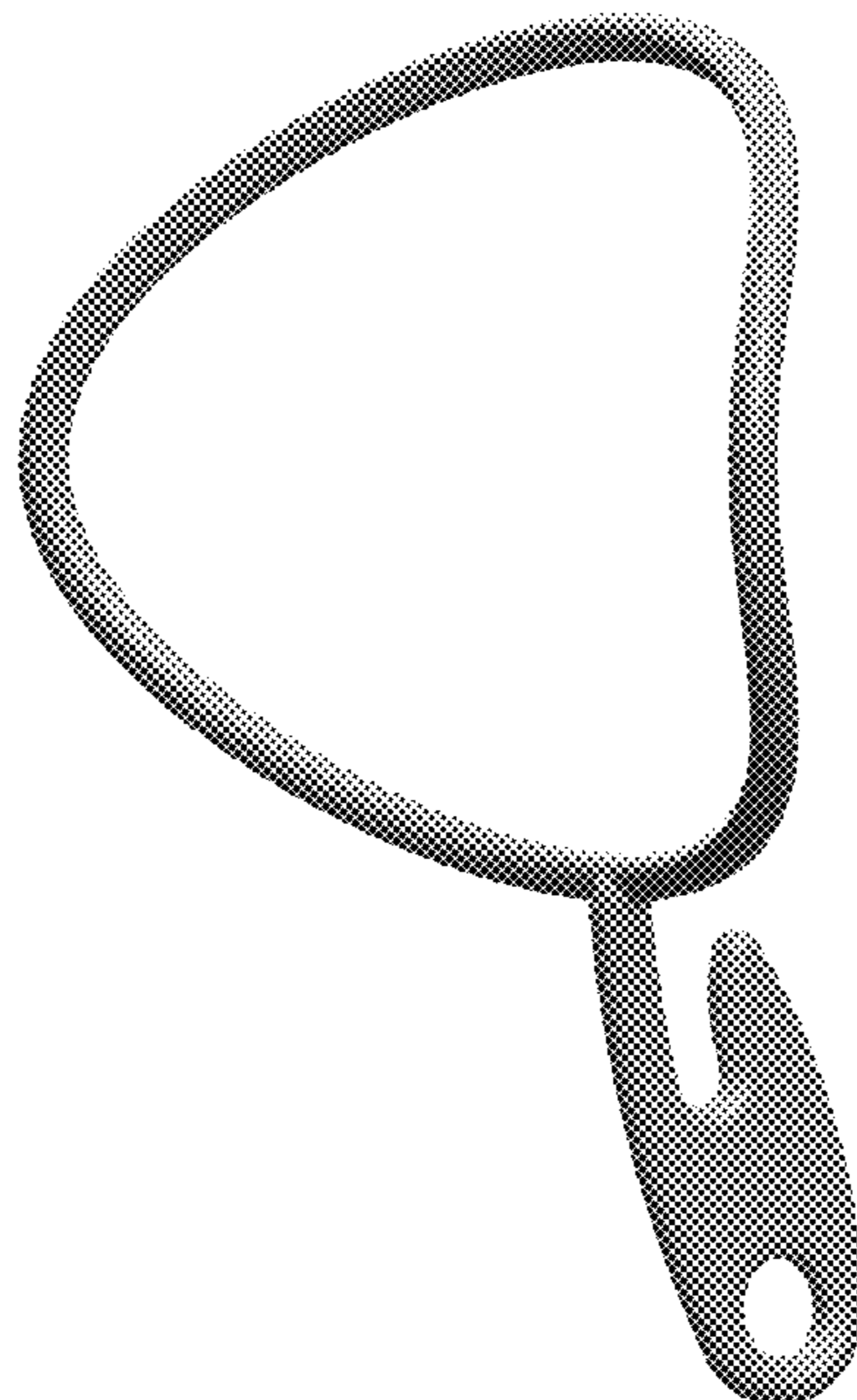
The ornamental design for a cough shield frame, as shown and described.

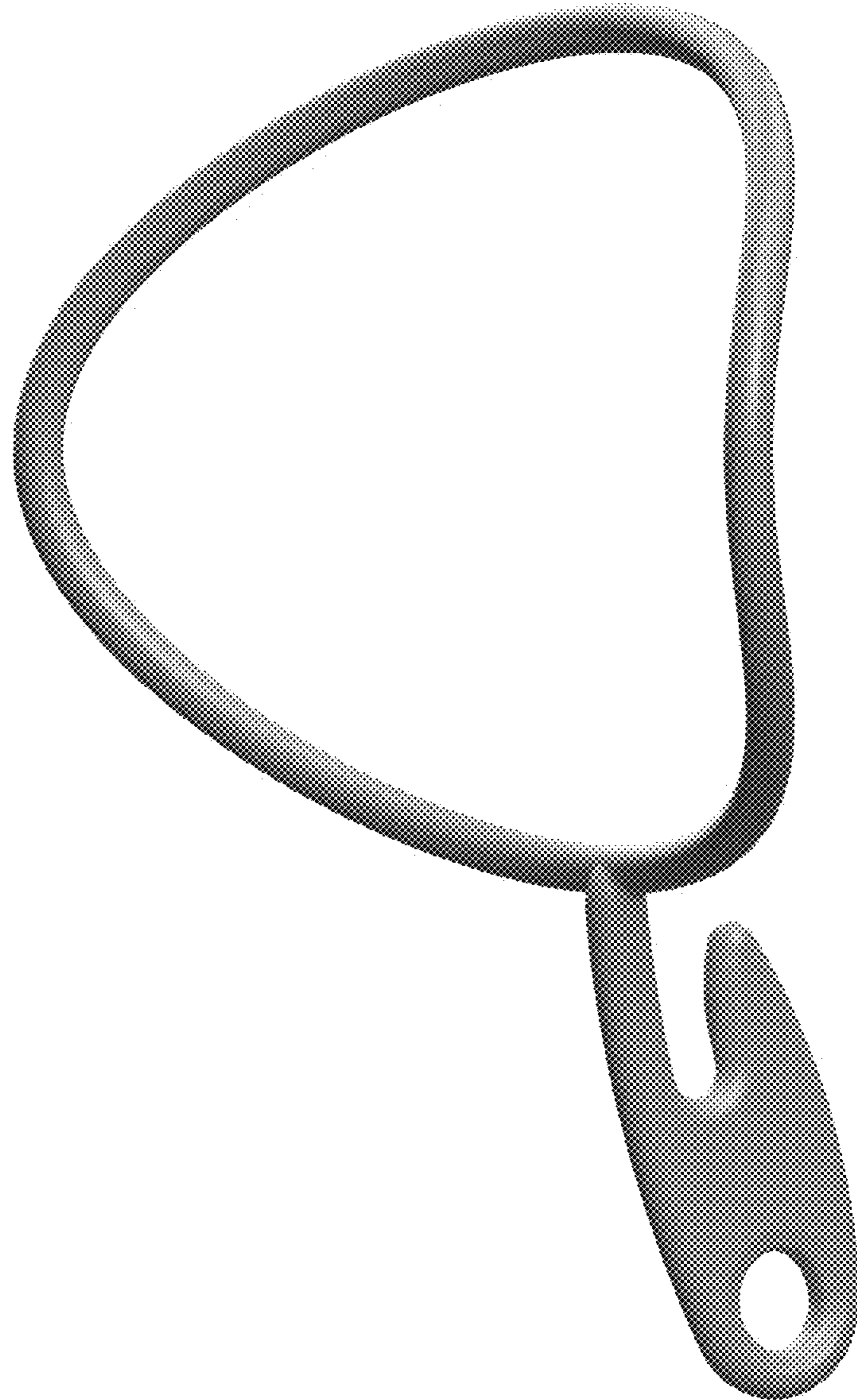

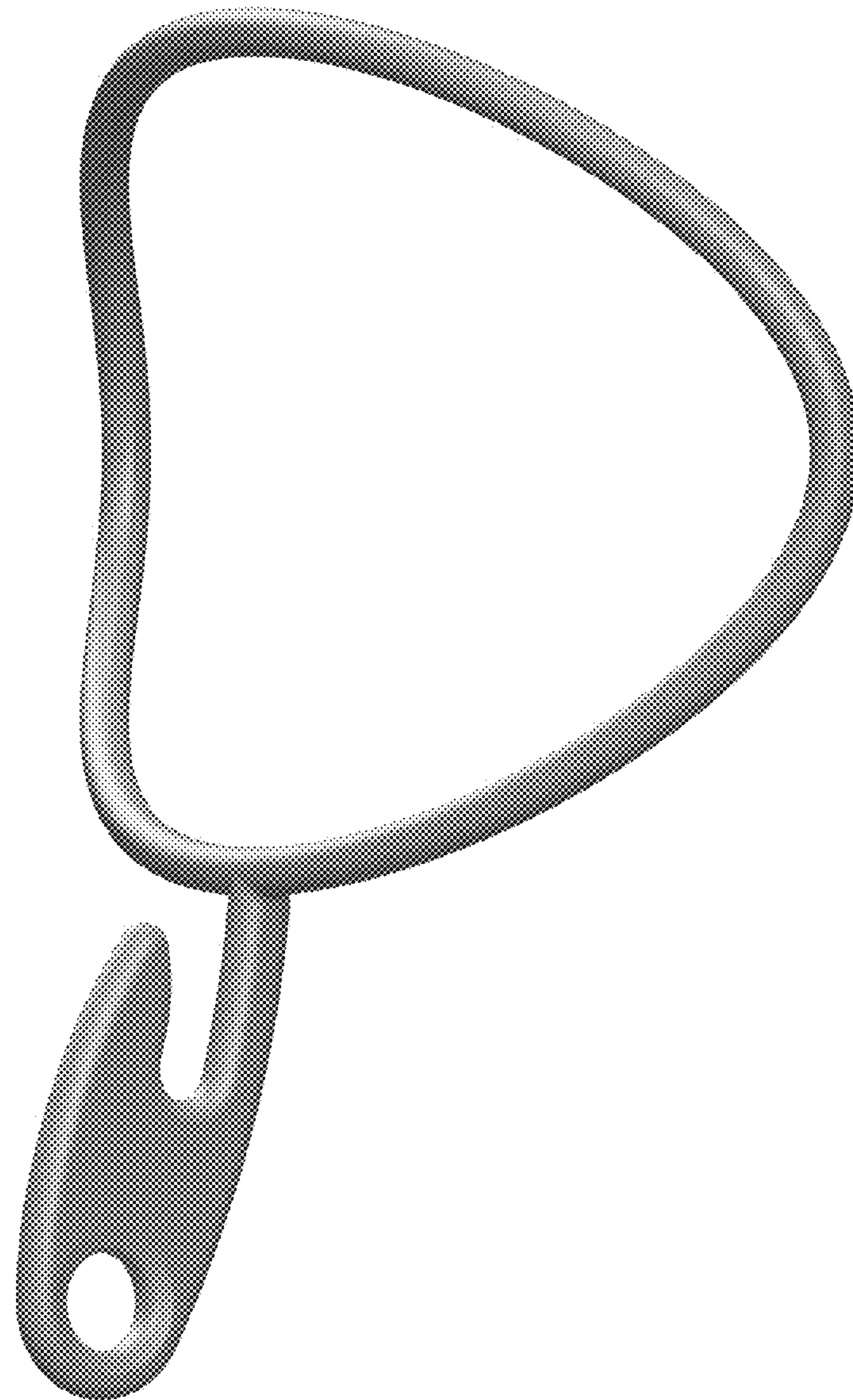

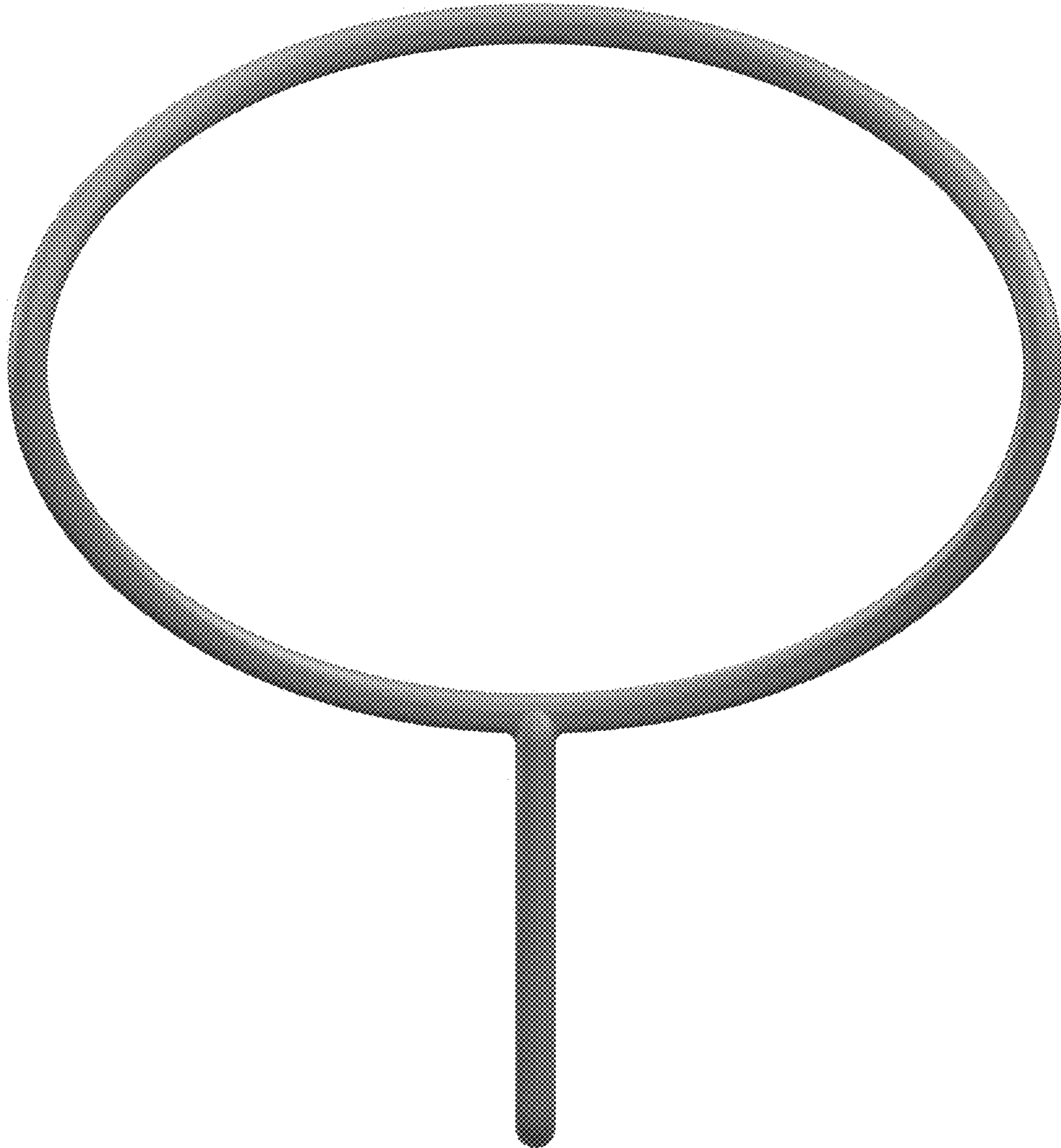

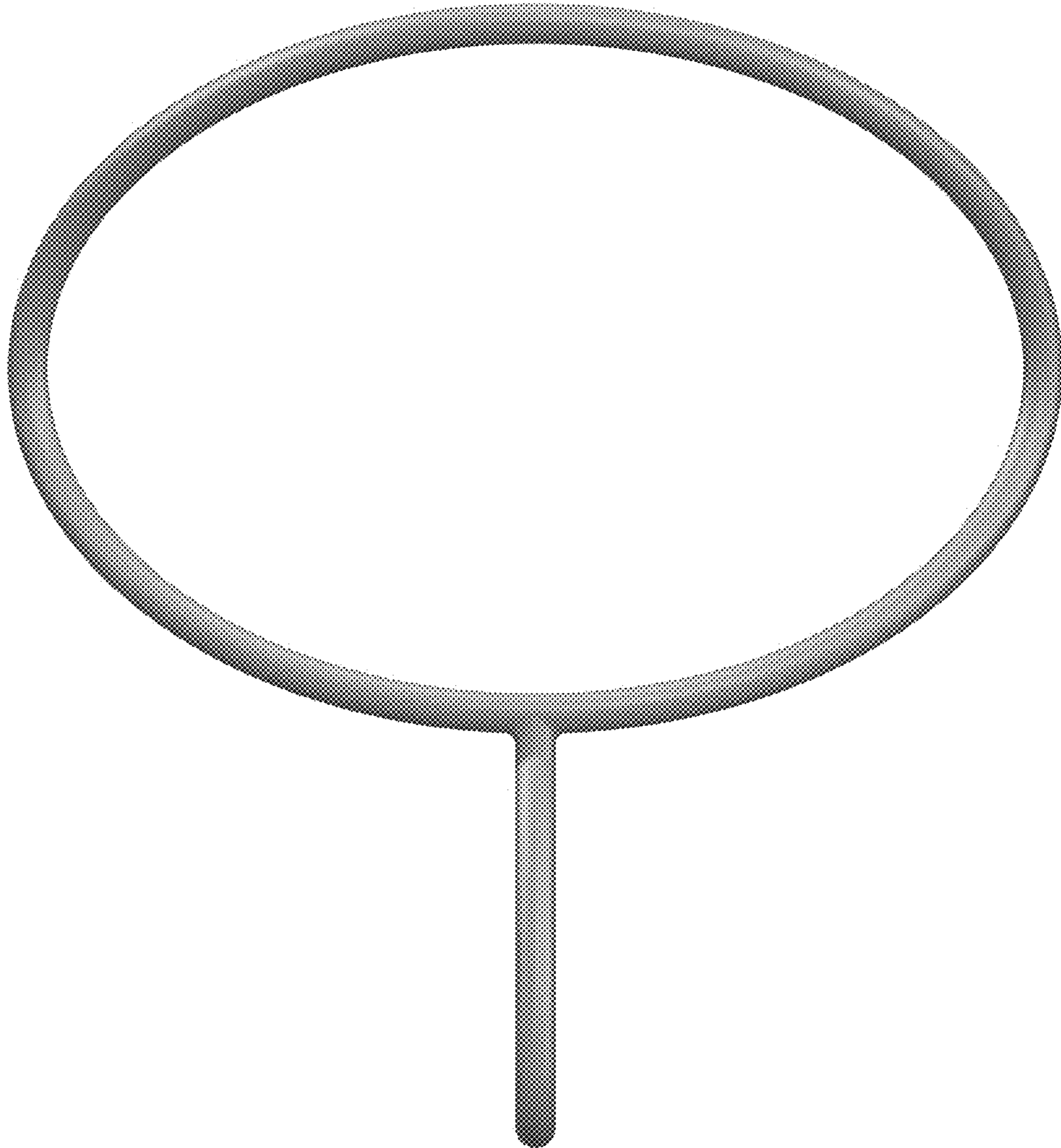

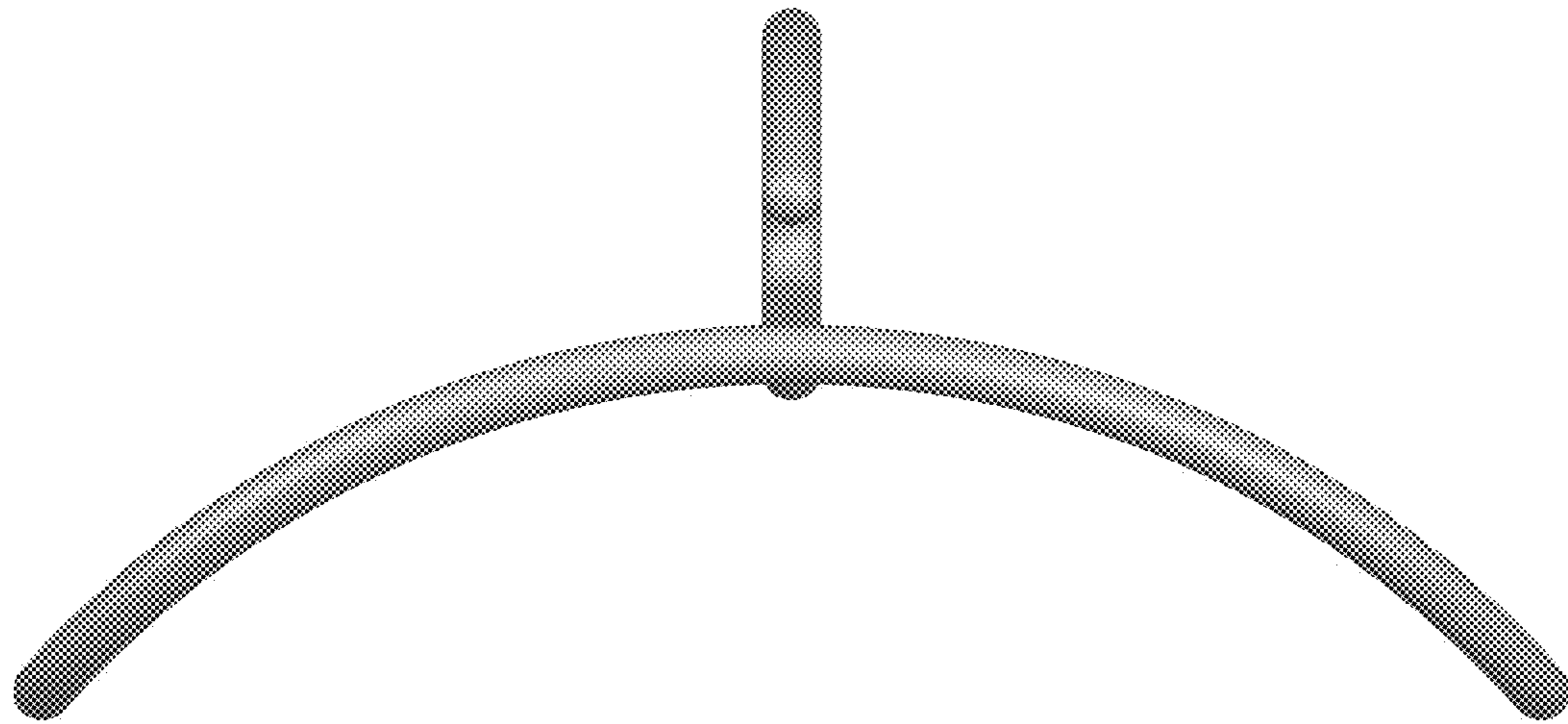

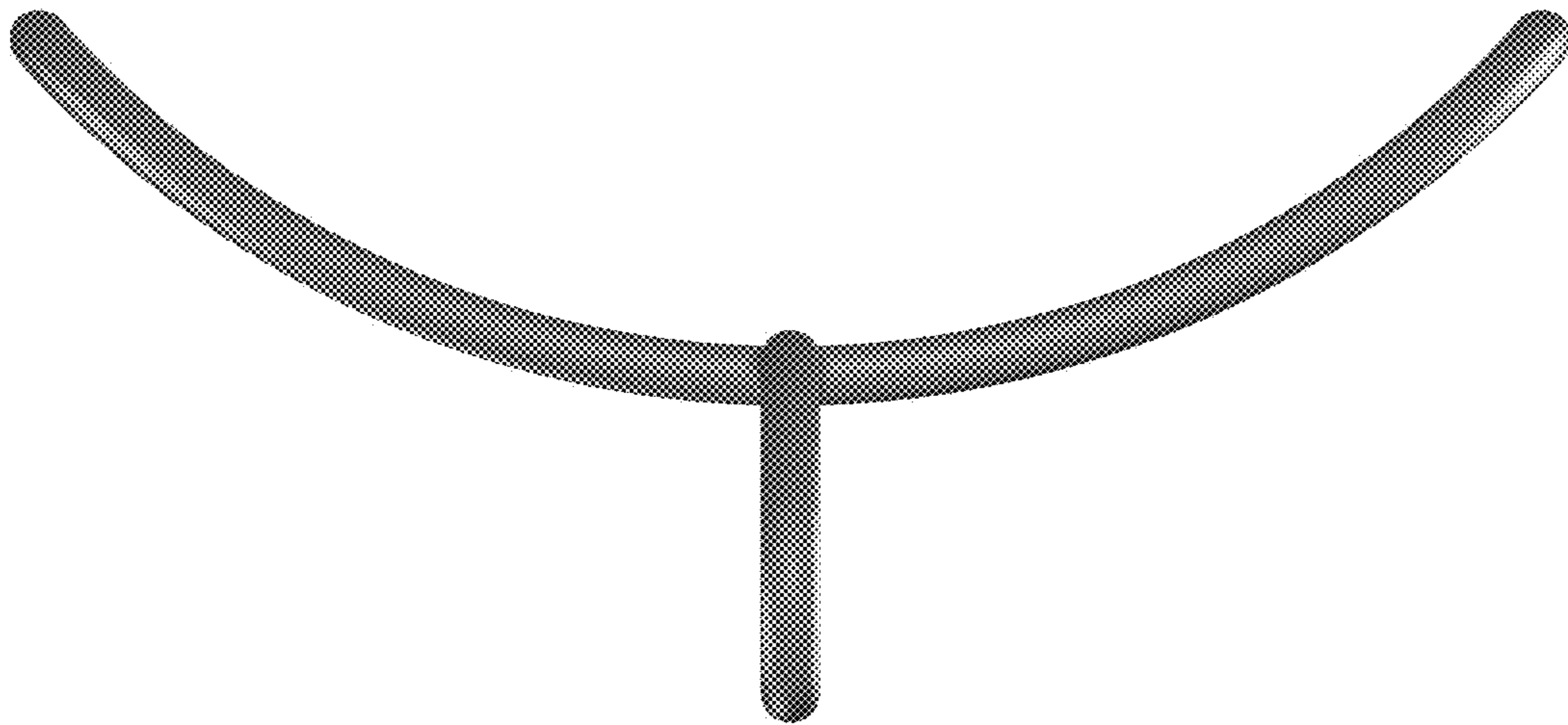
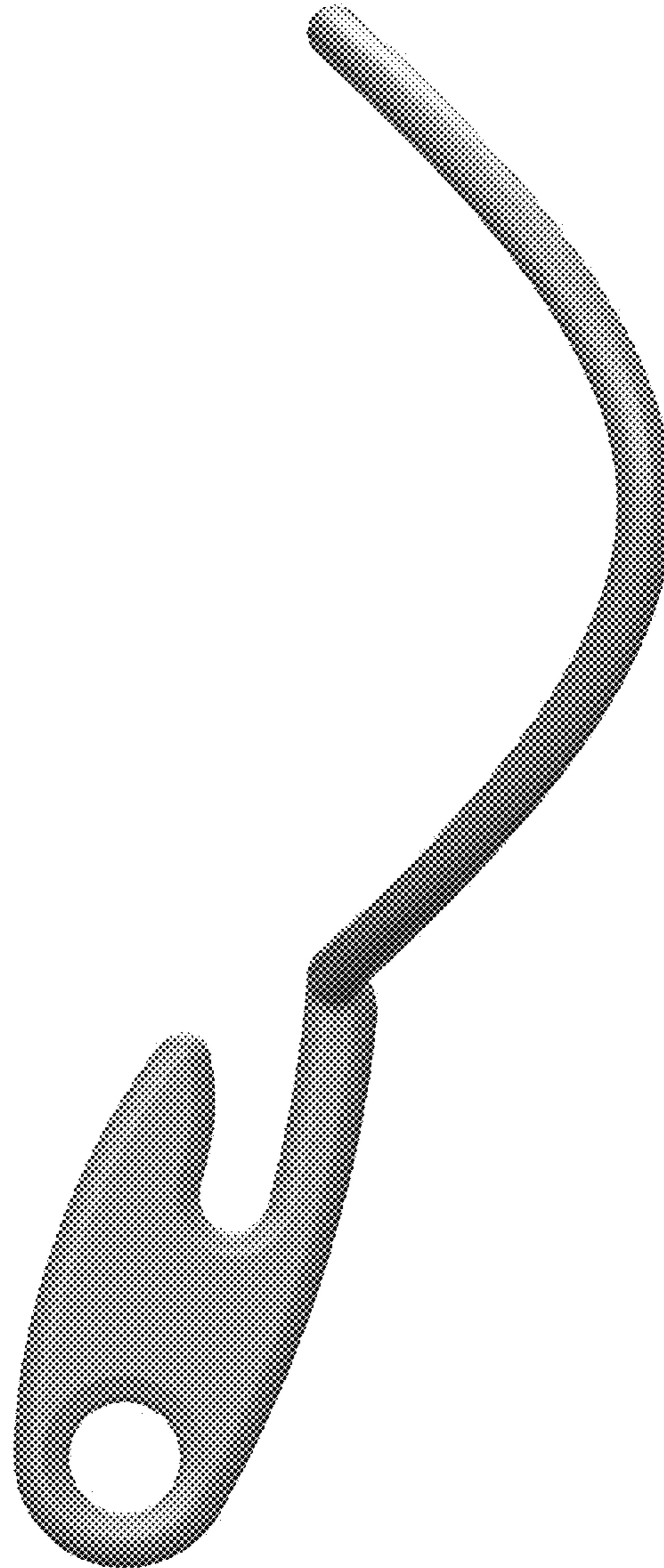

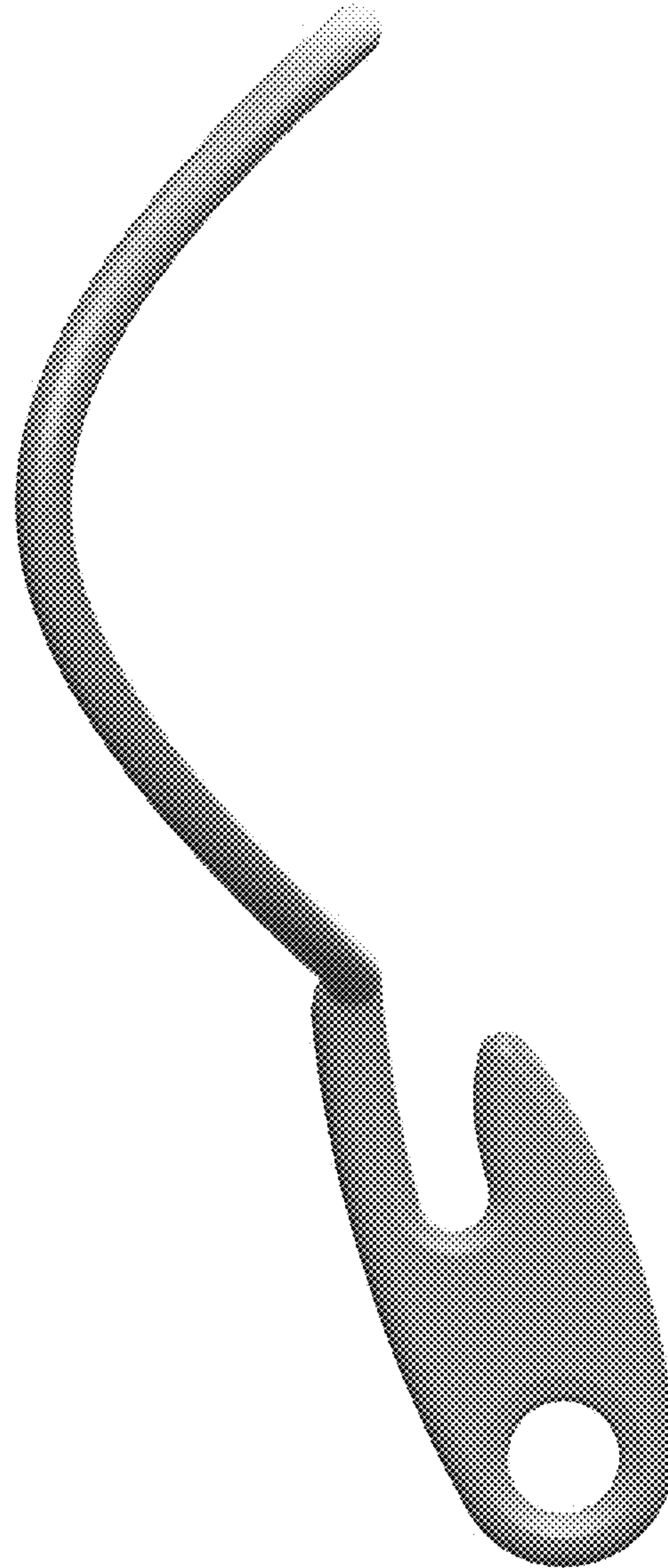
