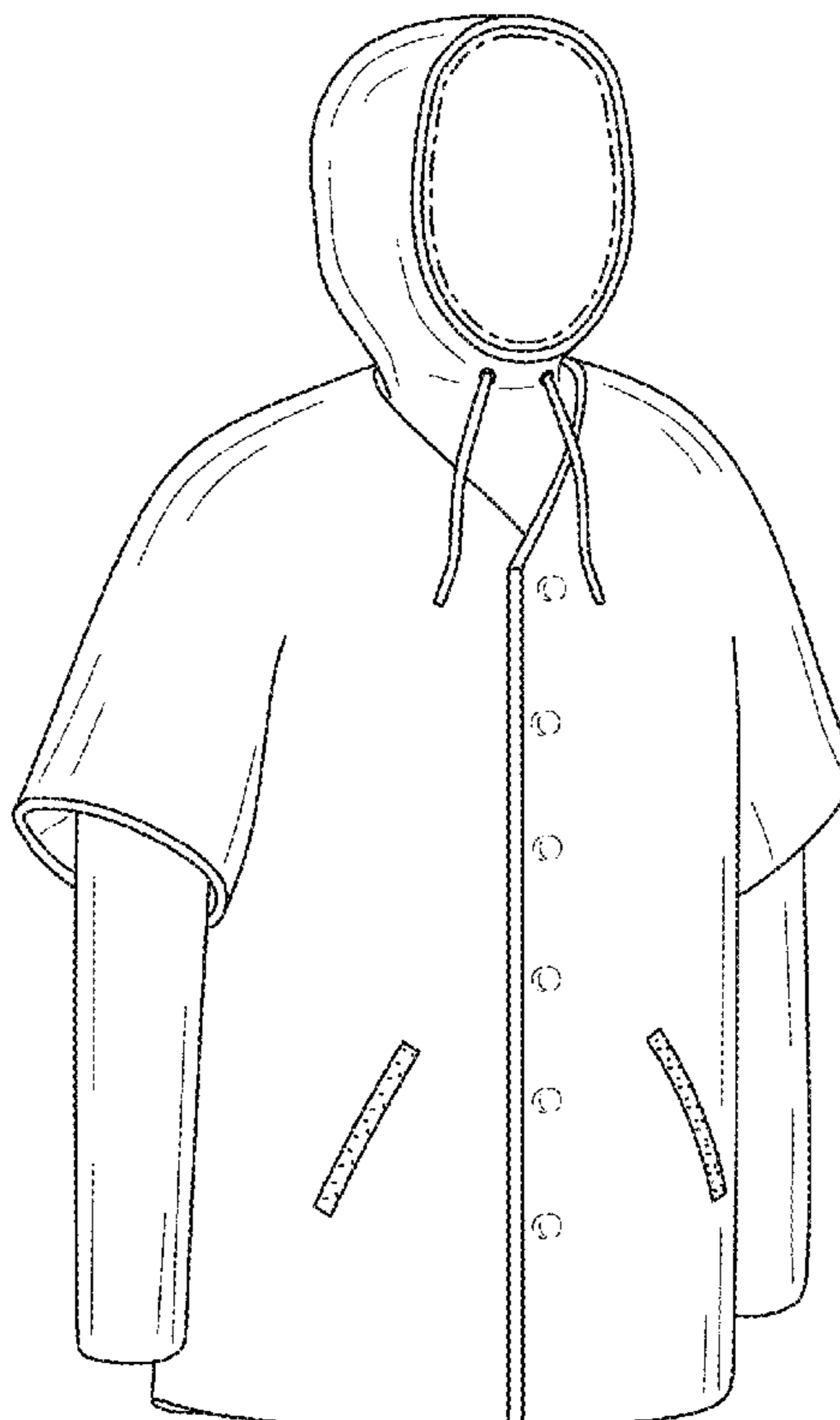
(57) **CLAIM**

The ornamental design for a combined sports jersey and sweatshirt, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a combined sports jersey and sweatshirt showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The dash dot dash lines shown in the drawings illustrate a boundary that forms no part of the claimed design. The broken lines shown in the drawings of the combined sports jersey and sweat shirt are for the purpose of depicting buttons of the article and form no part of the claimed design.

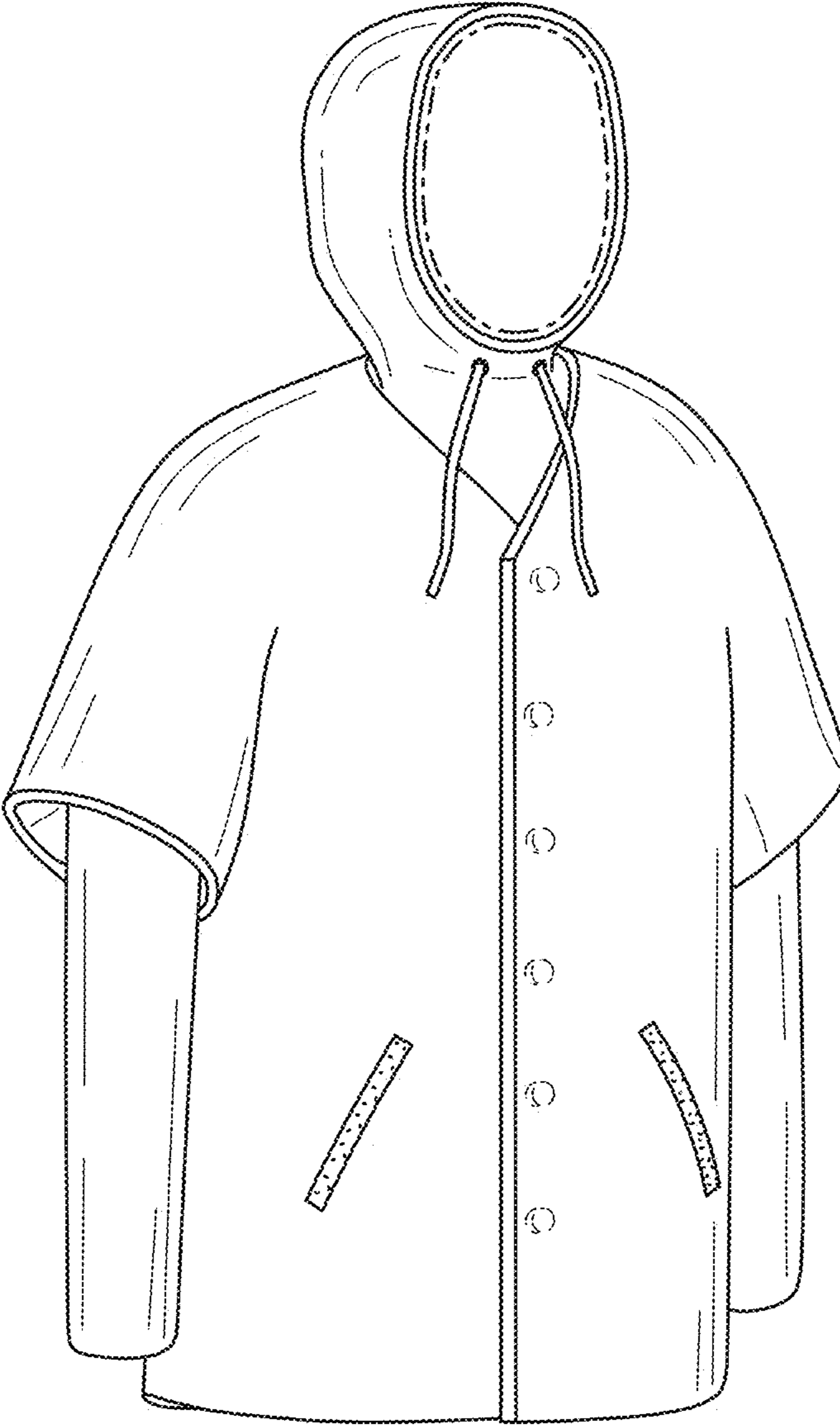

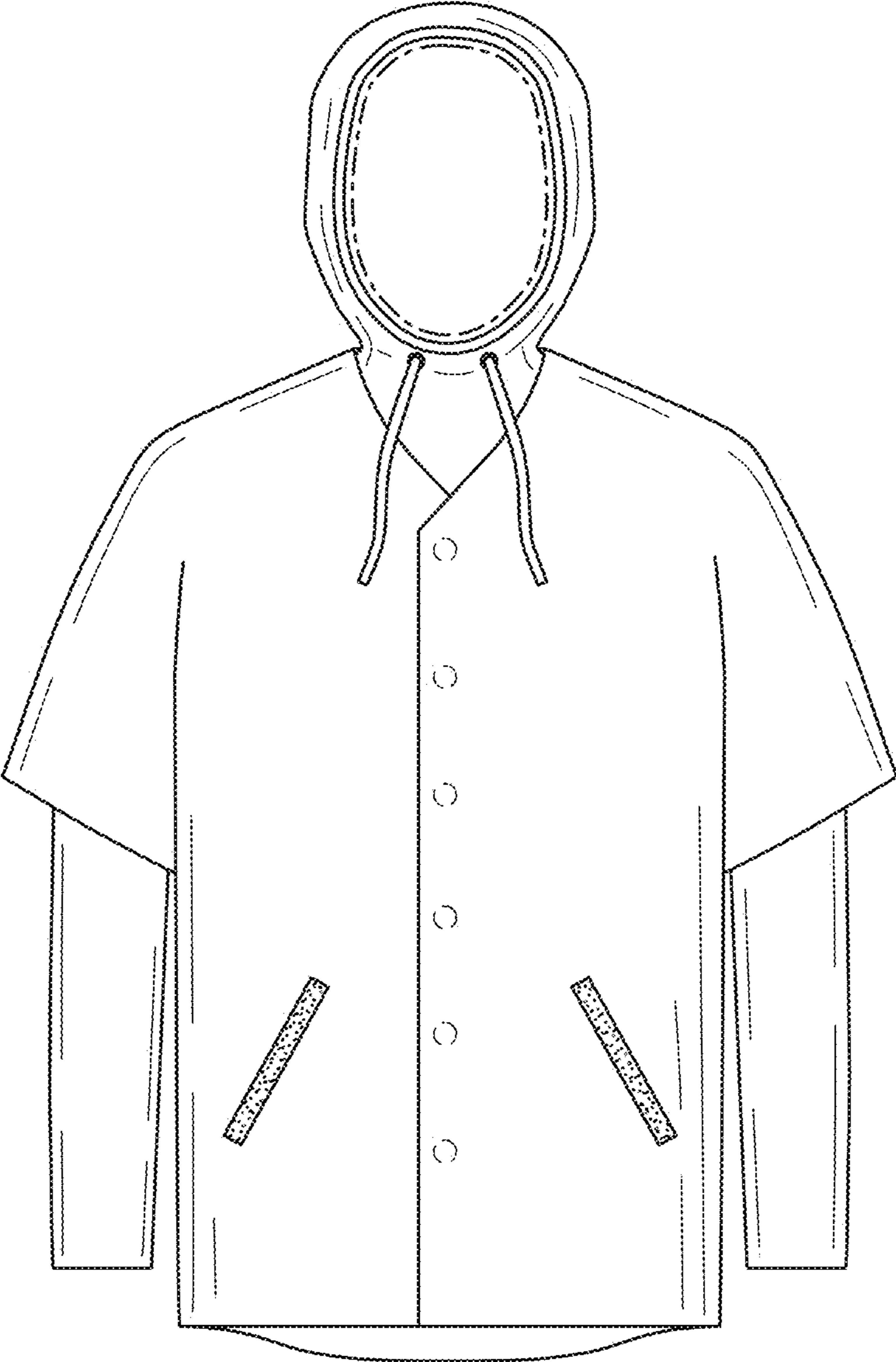

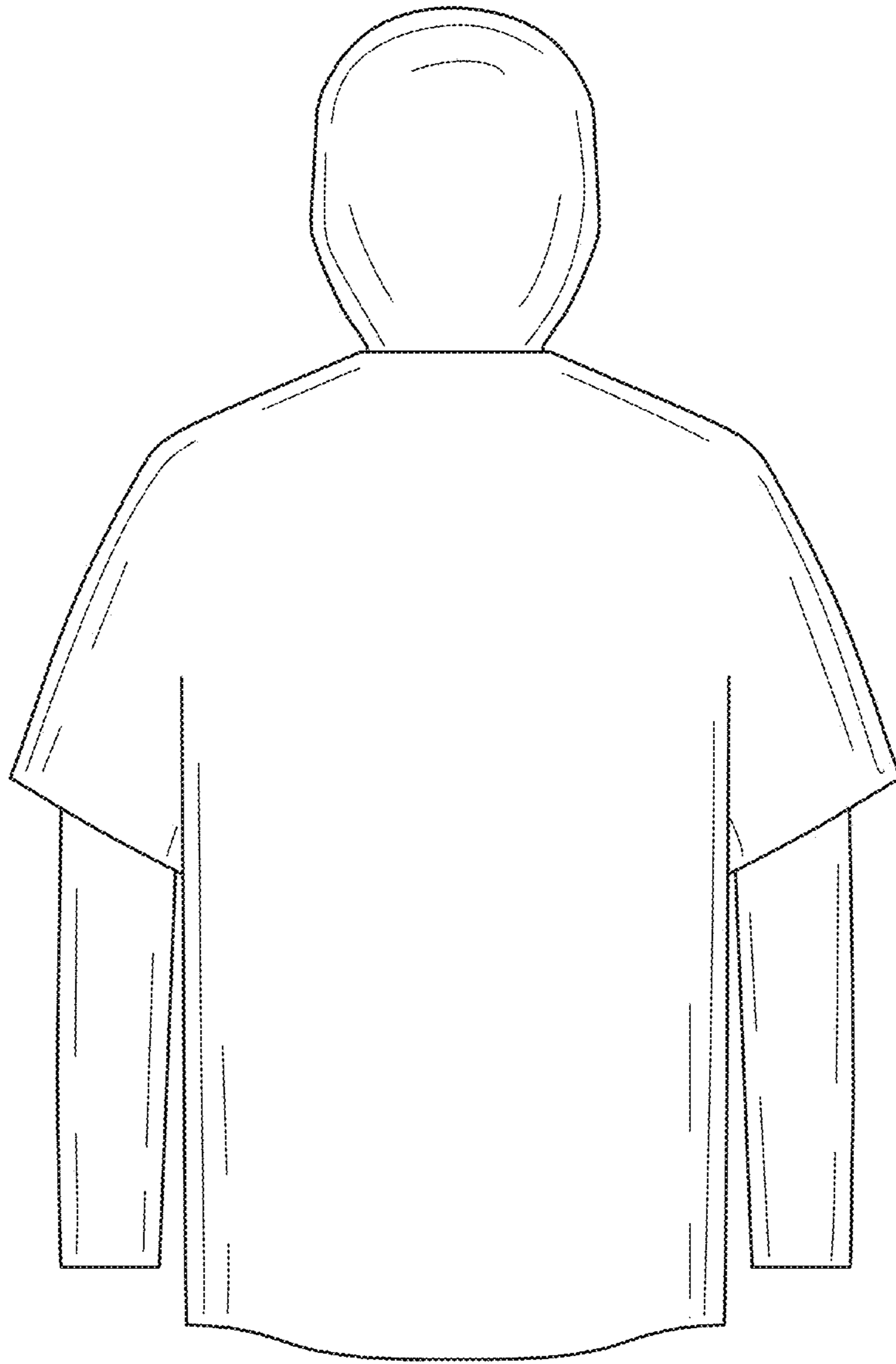

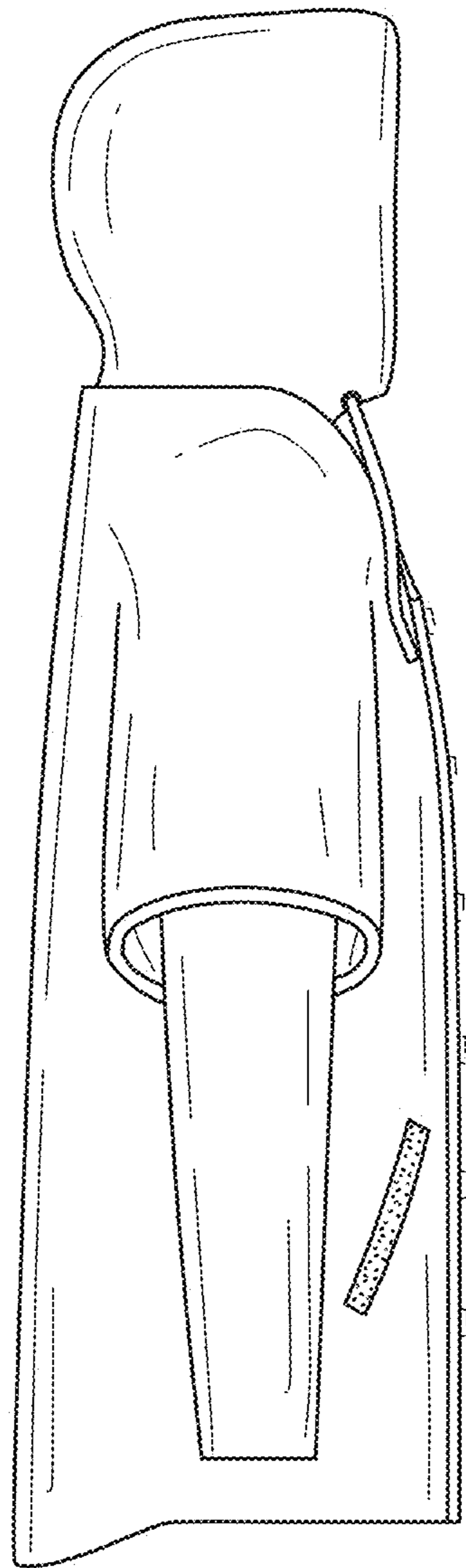

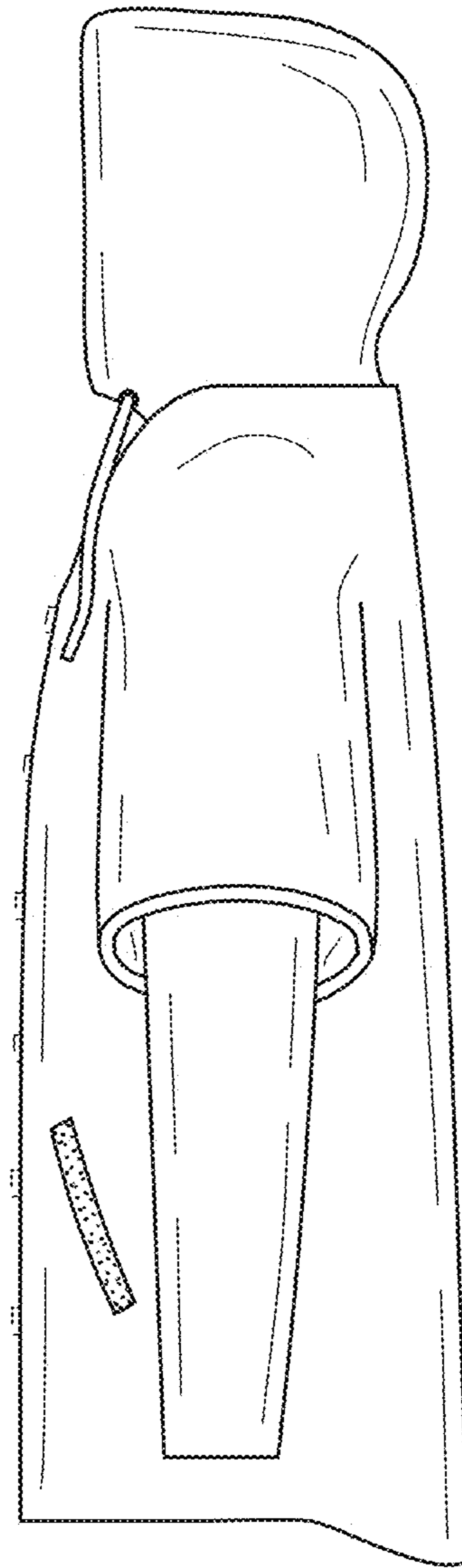

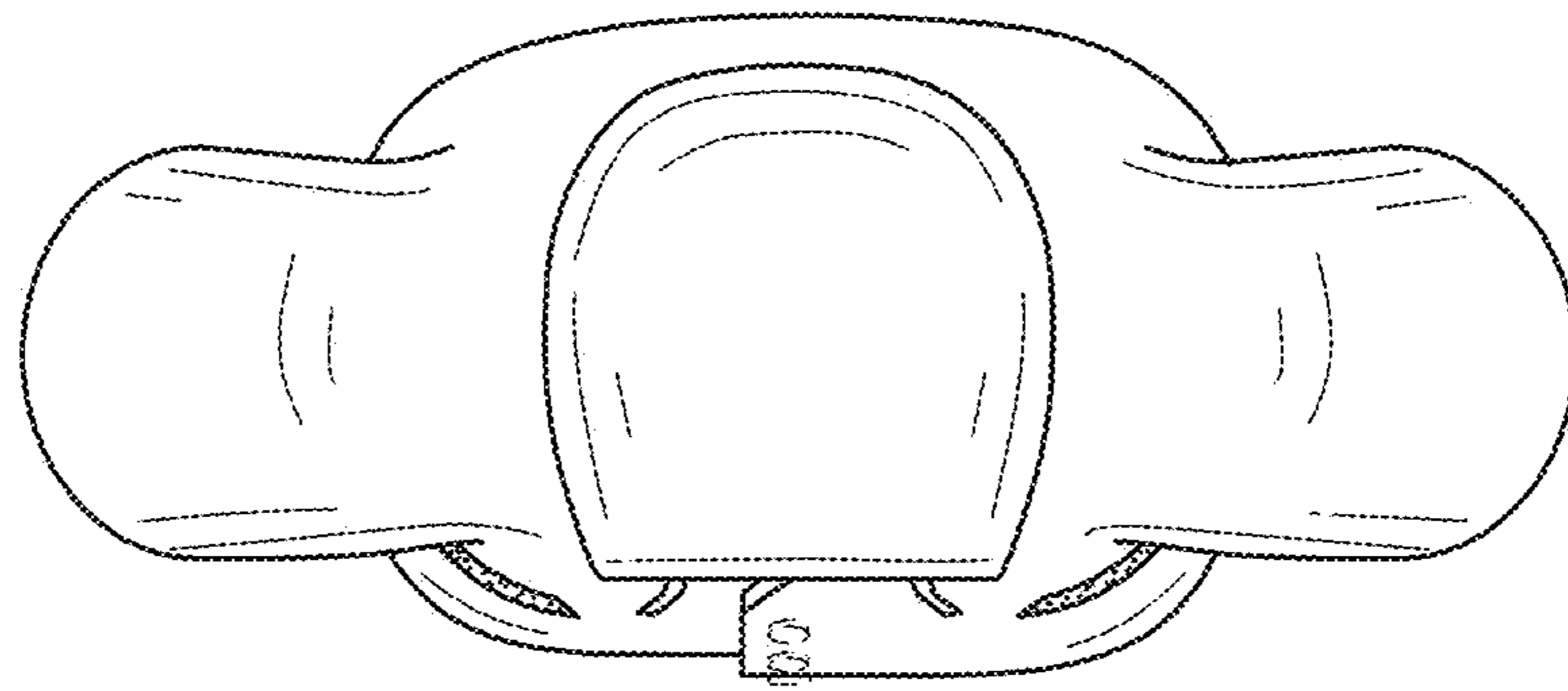

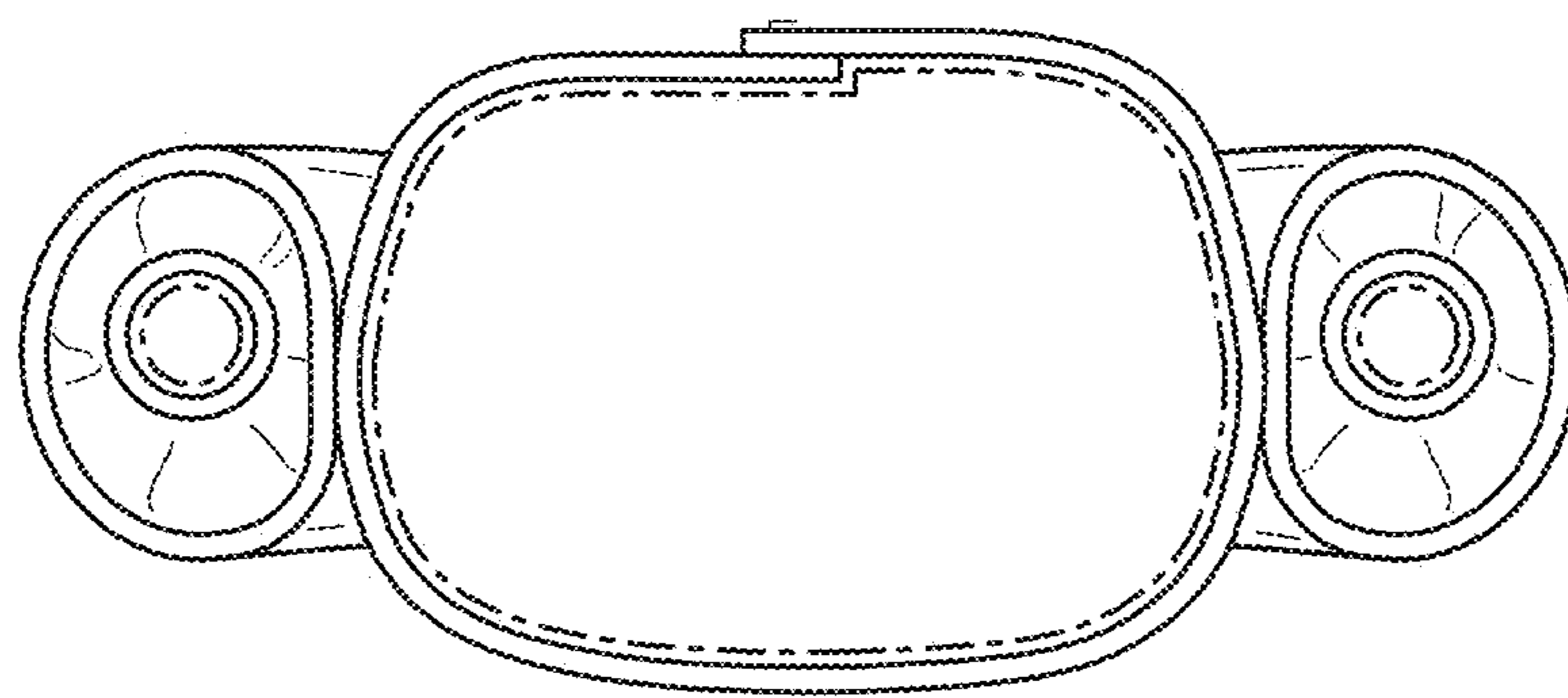
