(57) **CLAIM**

The ornamental design for a wearable holder for items, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a wearable holder for items in an at-rest state;

FIG. 2 is a front view of the wearable holder for items lying substantially flat;

FIG. 3 is a rear view of the wearable holder for items lying substantially flat;

FIG. 4 is a left side view of the wearable holder for items;

FIG. 5 is a right side view of the wearable holder for items;

FIG. 6 is a top view of the wearable holder for items;

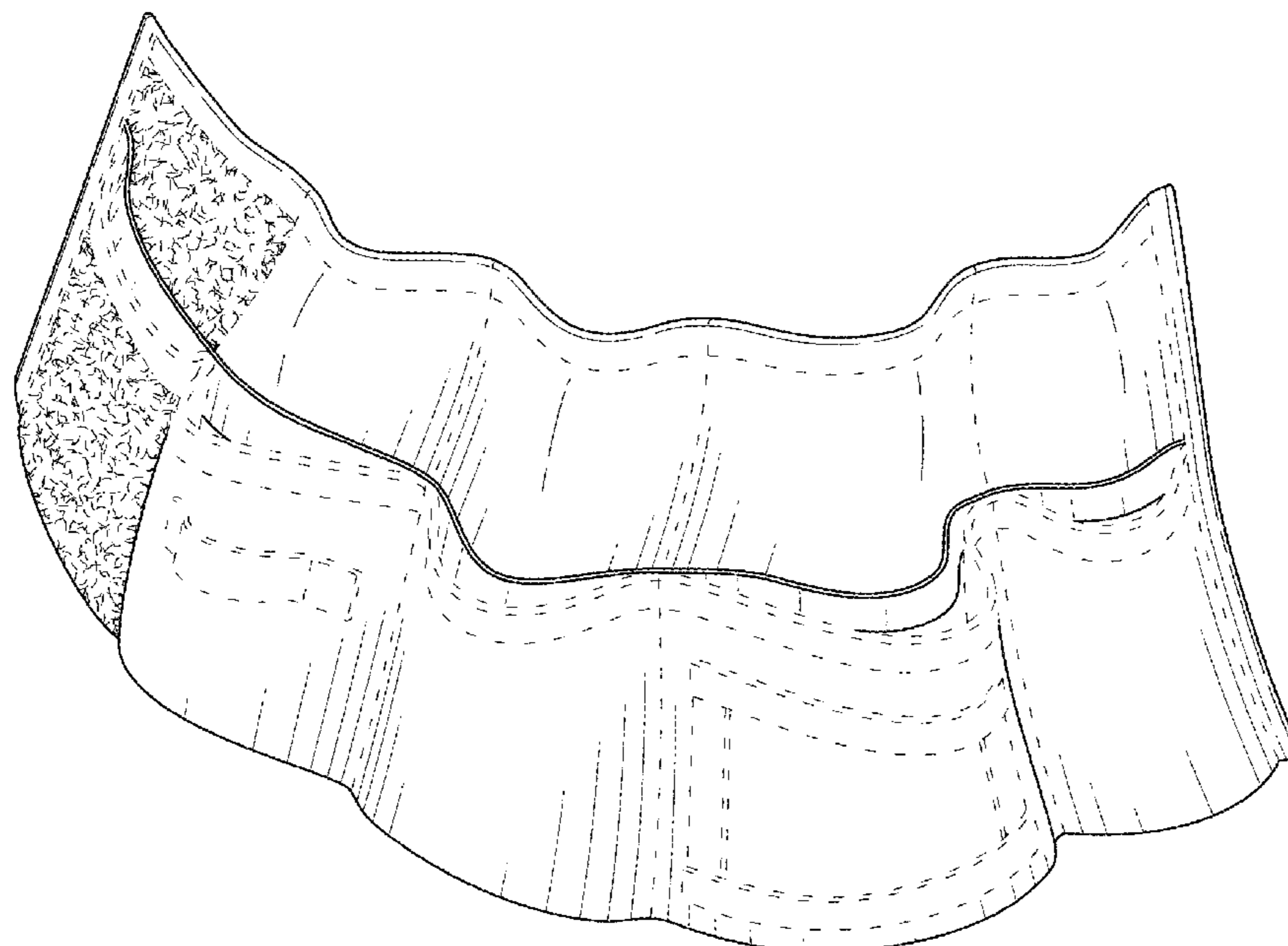
FIG. 7 is a bottom view of the wearable holder for items;

FIG. 8 is a front view of the wearable holder for items lying substantially flat with unclaimed items drawn in broken lines placed into the wearable holder for items; and,

FIG. 9 is an in-use view of the wearable holder for items being worn by an unclaimed user drawn in broken lines with unclaimed items drawn in broken lines placed into the wearable holder for items.

The broken lines showing portions of the design are for illustrative purposes only and form no part of the claimed design.

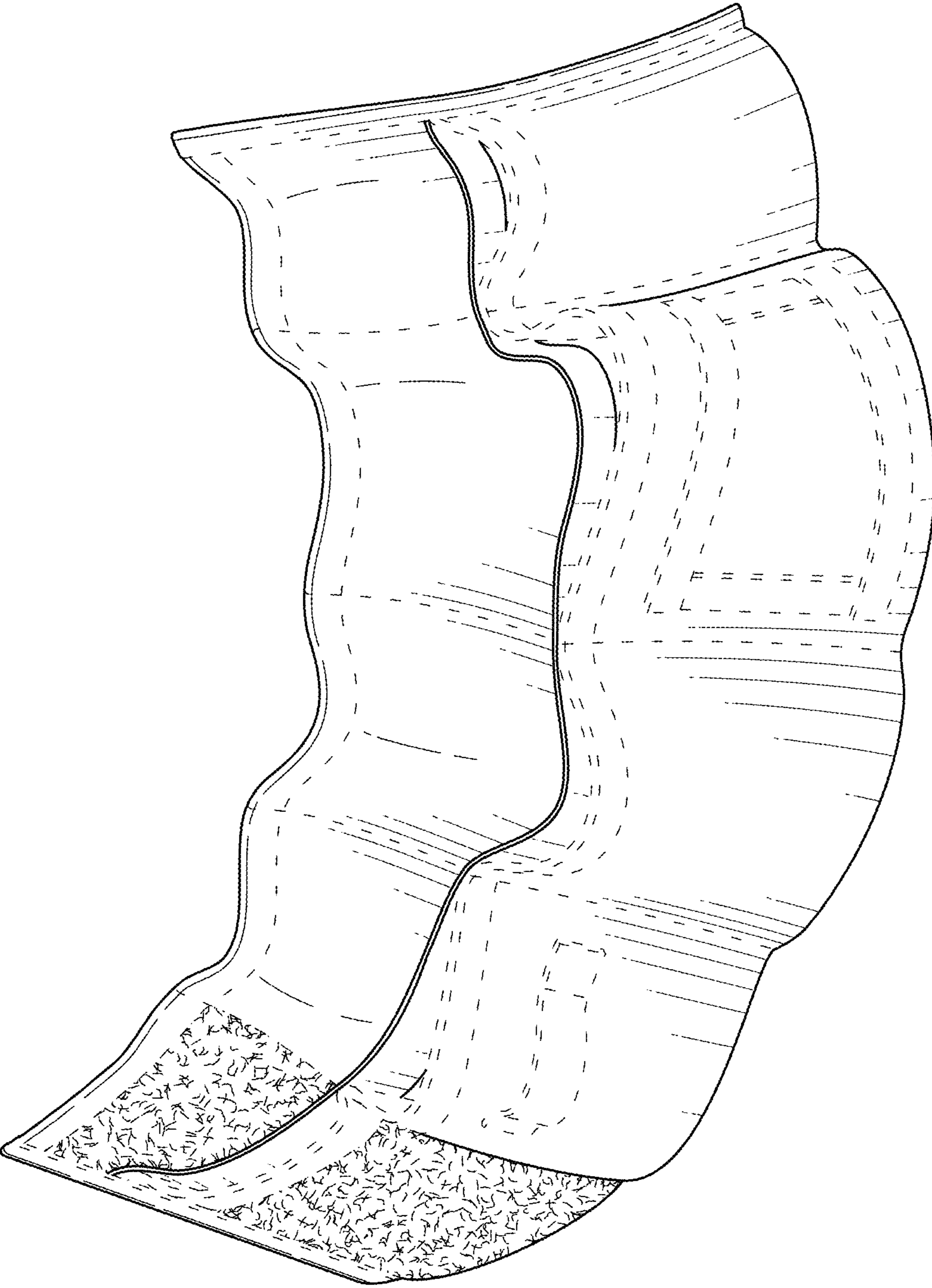

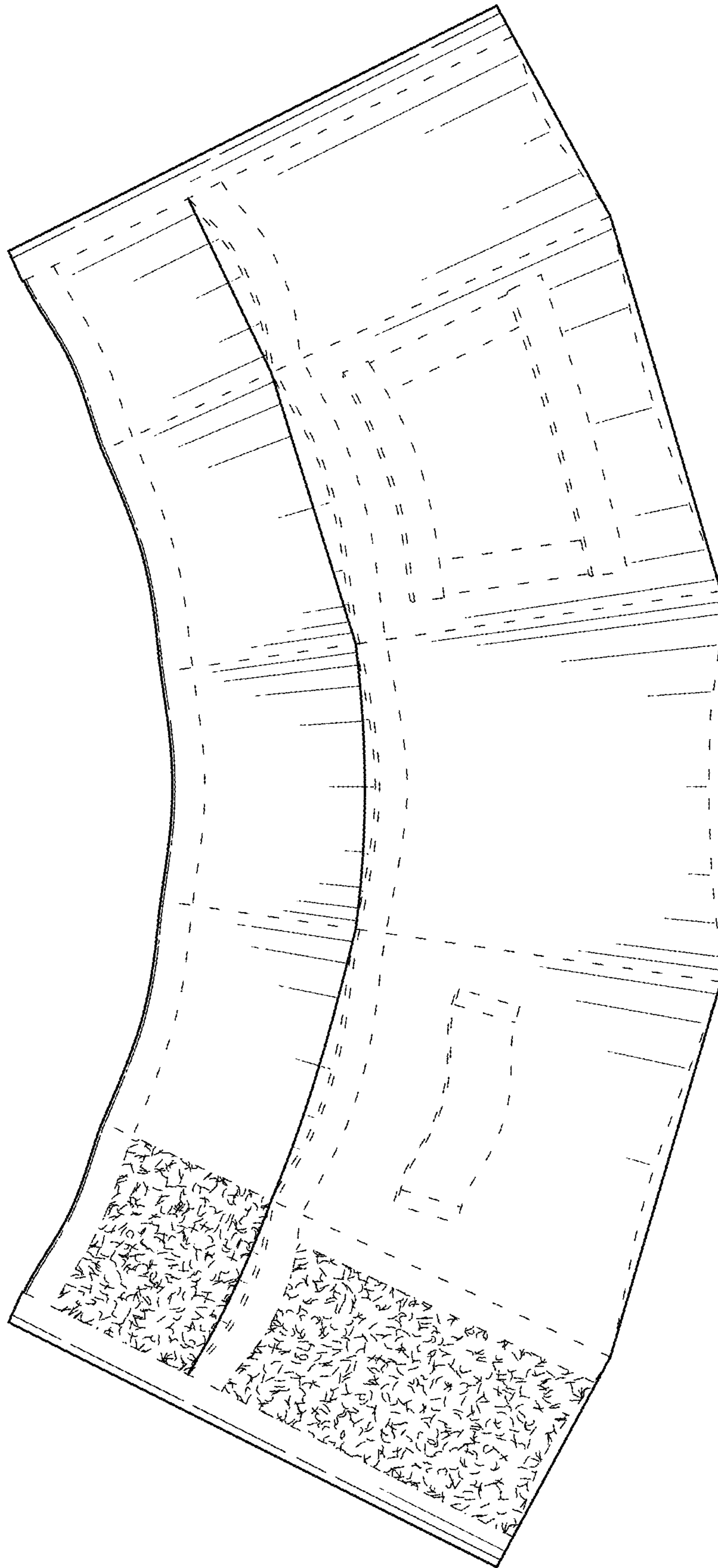

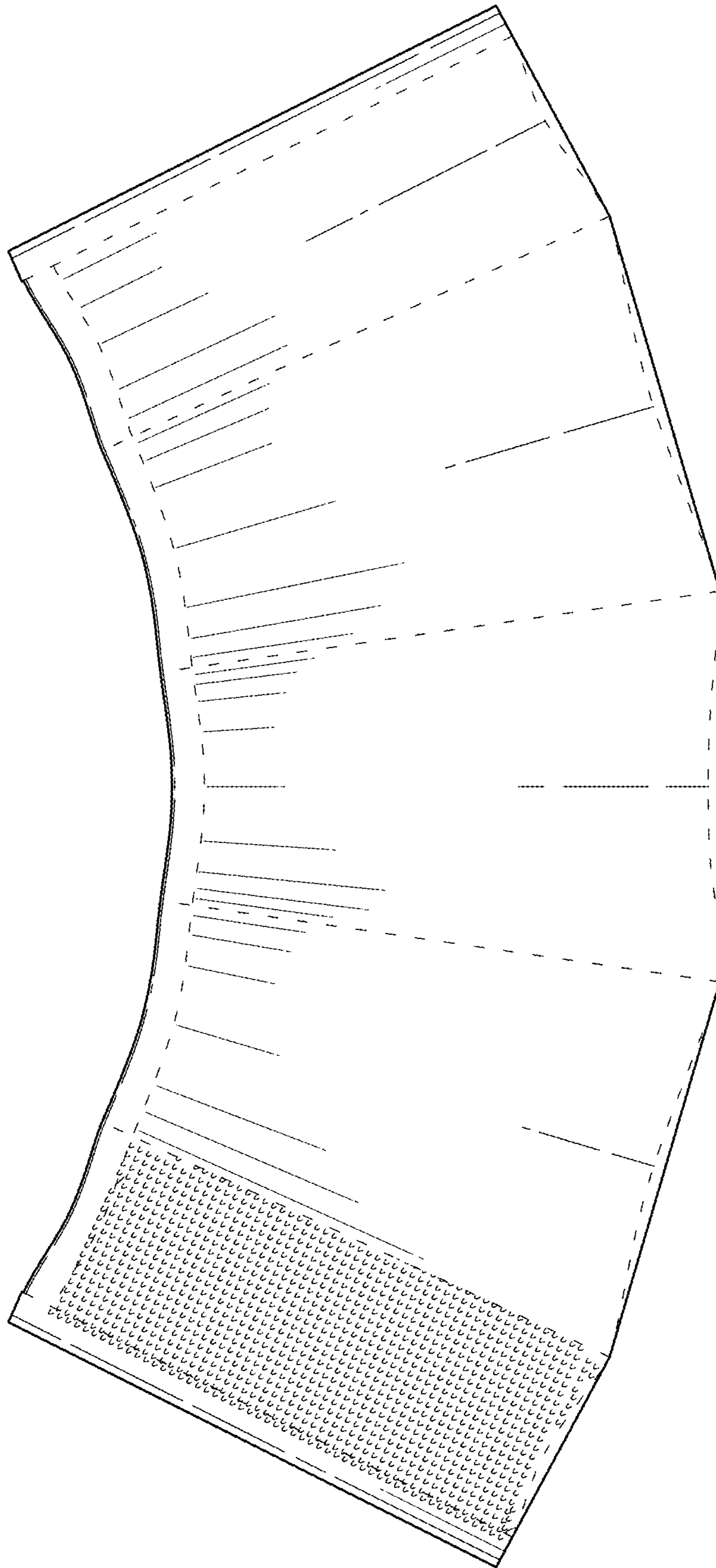

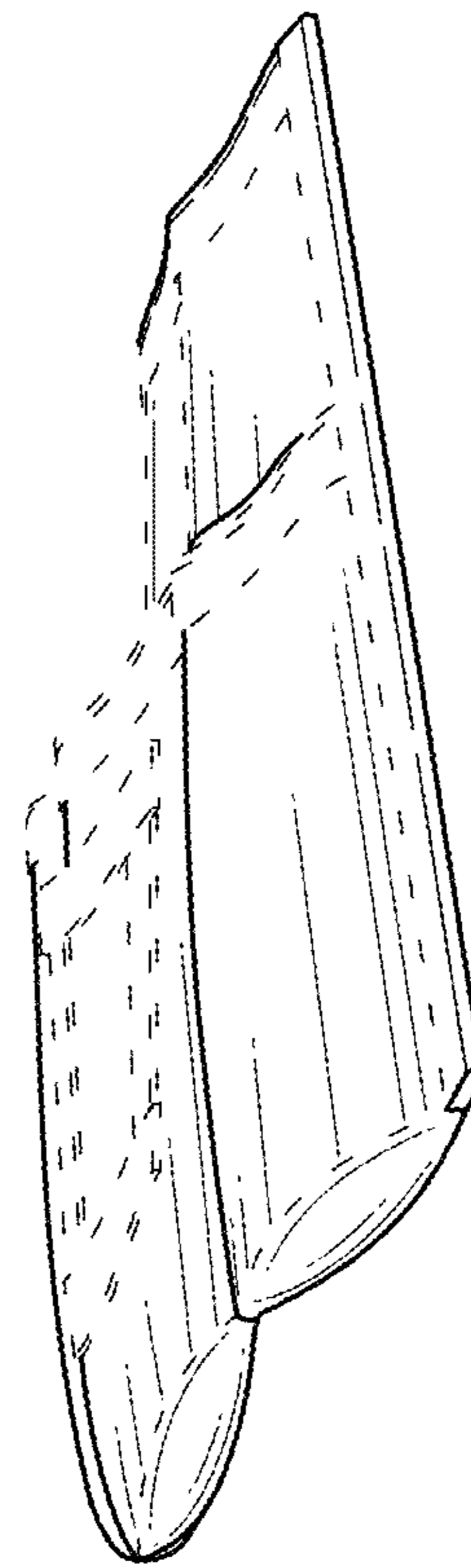

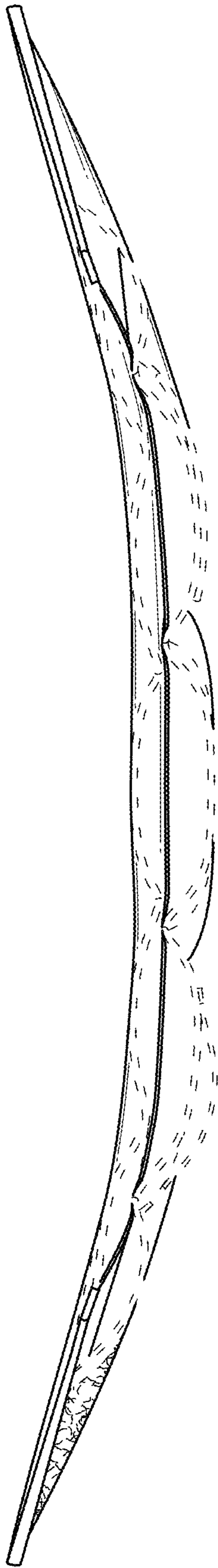

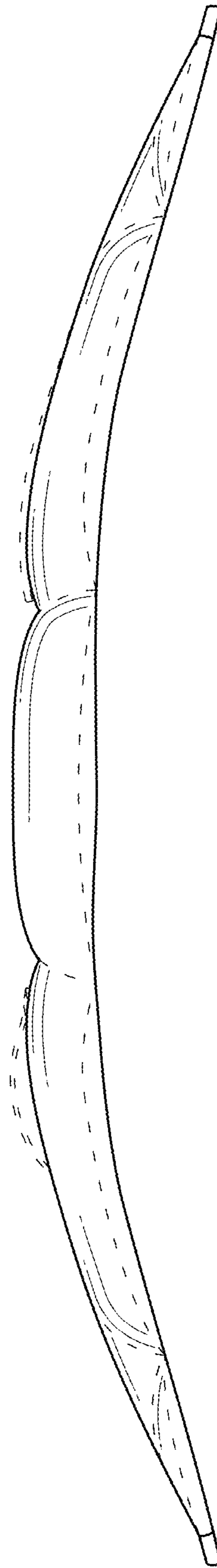

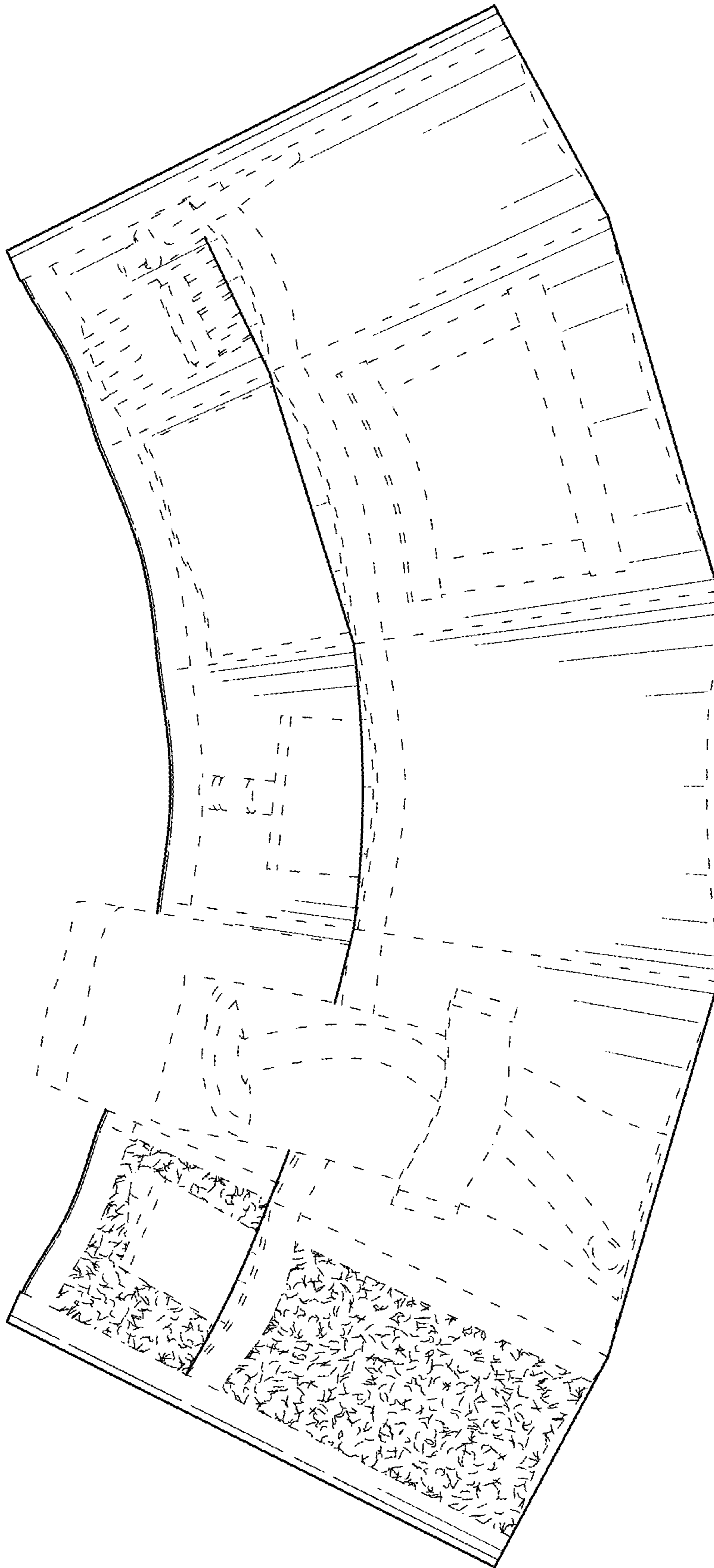

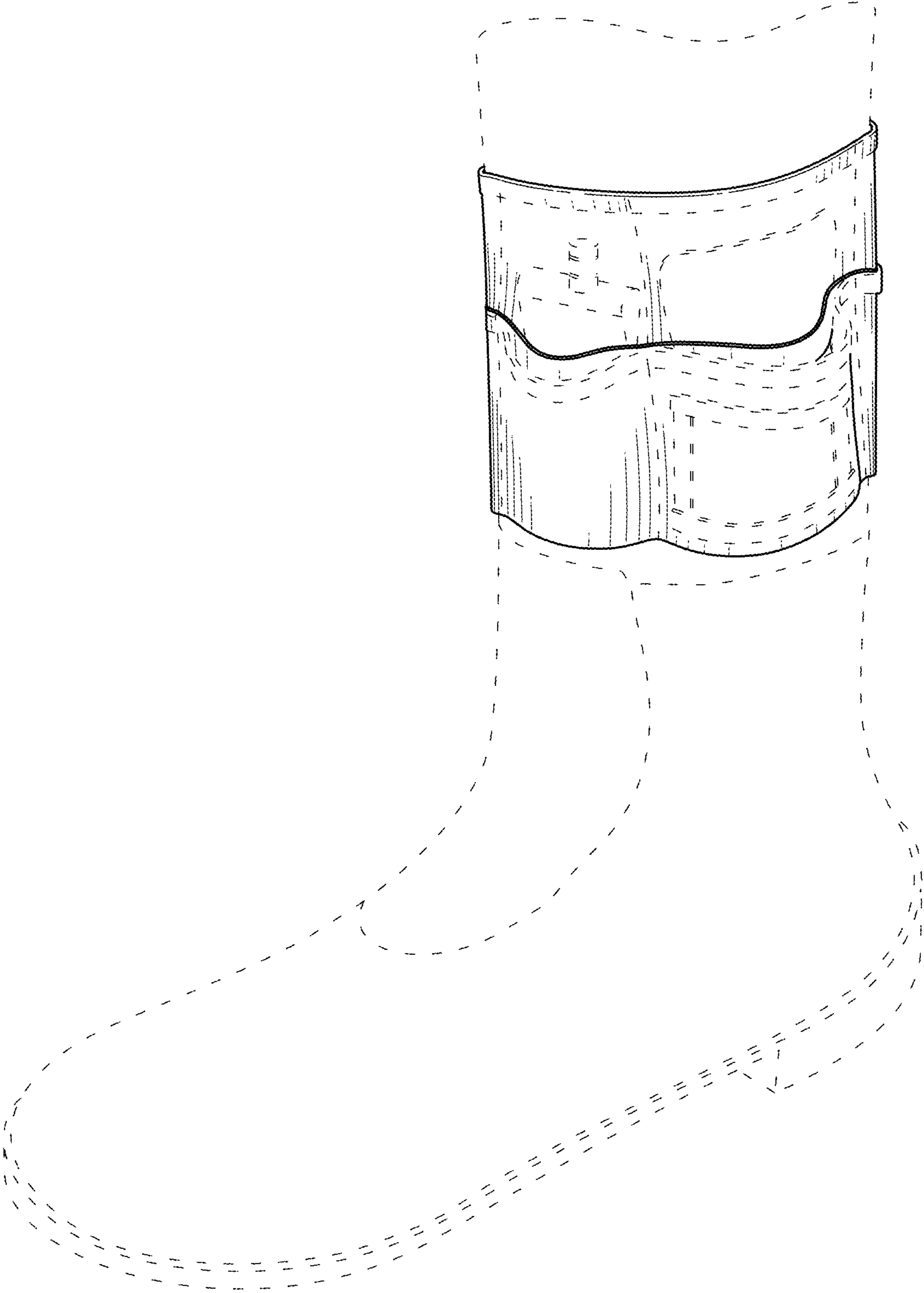
