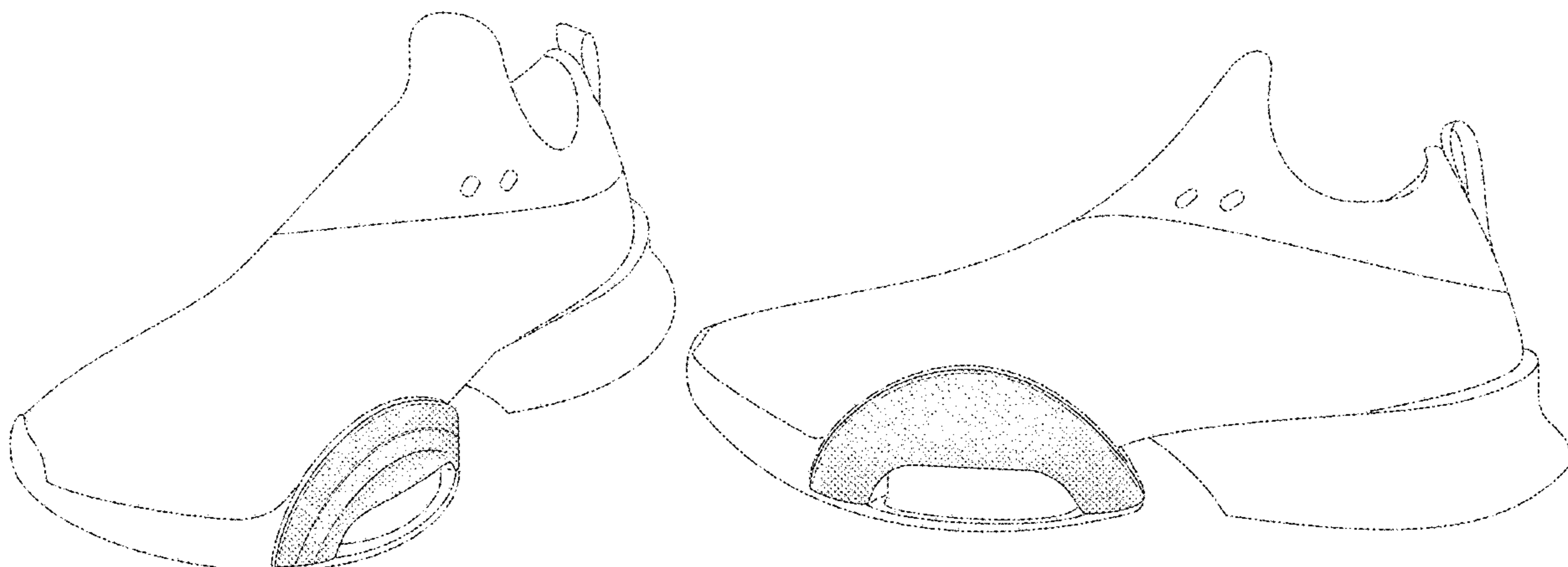
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing our new design;  
FIG. 2 is a side view thereof;  
FIG. 3 is a rear perspective view thereof;  
FIG. 4 is a front perspective view showing an alternative embodiment of our new design;  
FIG. 5 is a side view thereof; and,  
FIG. 6 is a rear perspective view thereof.

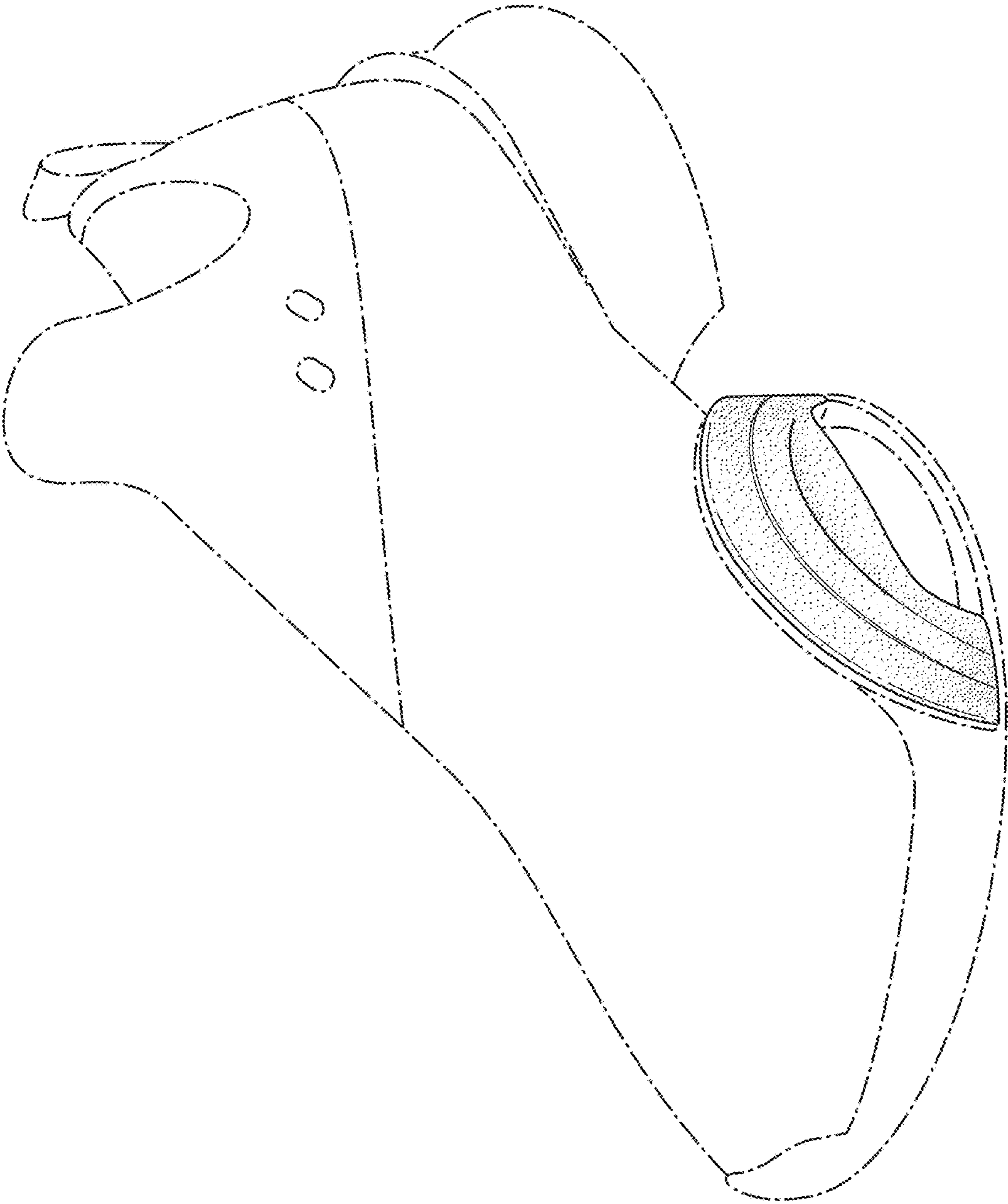

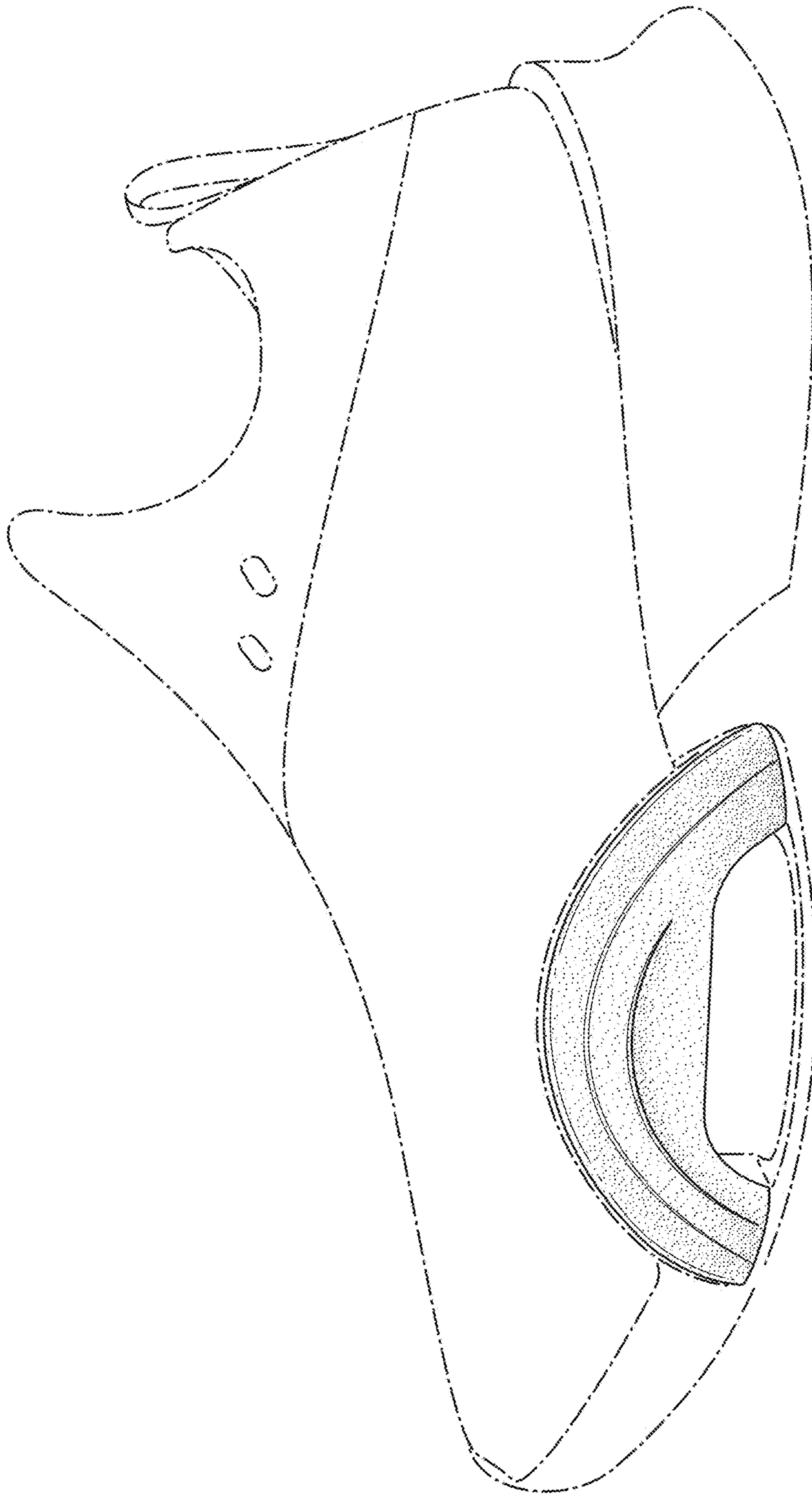

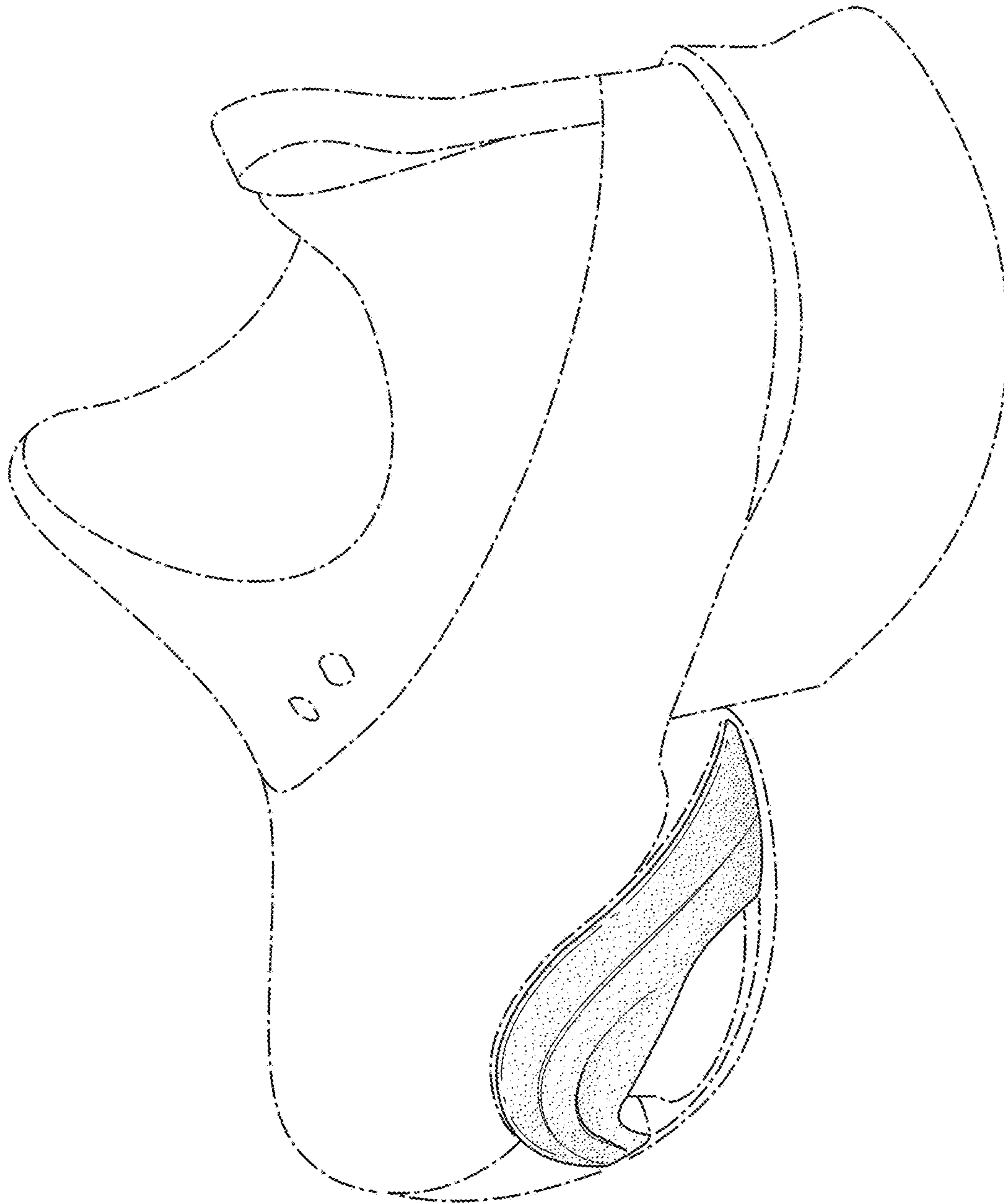

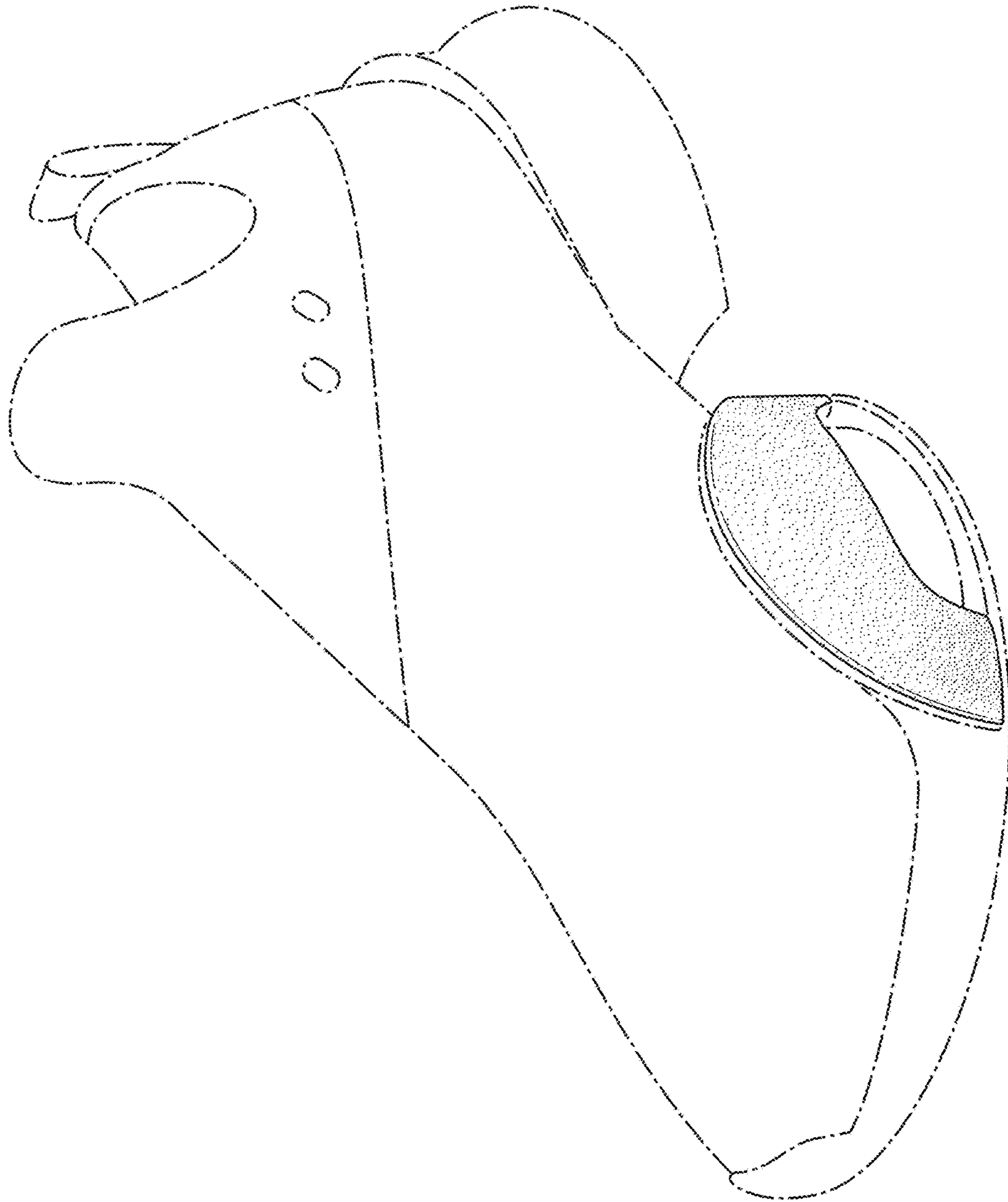

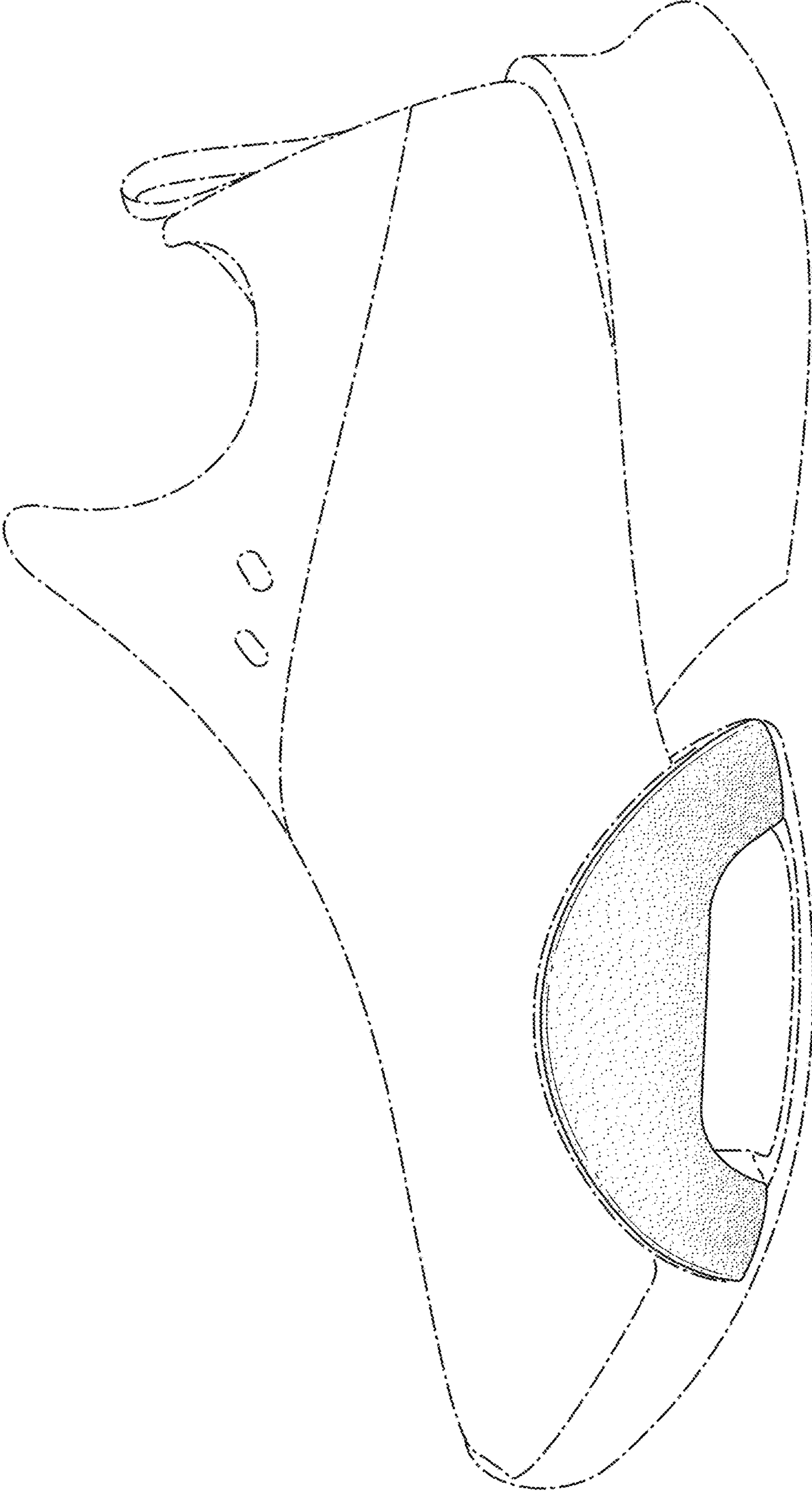

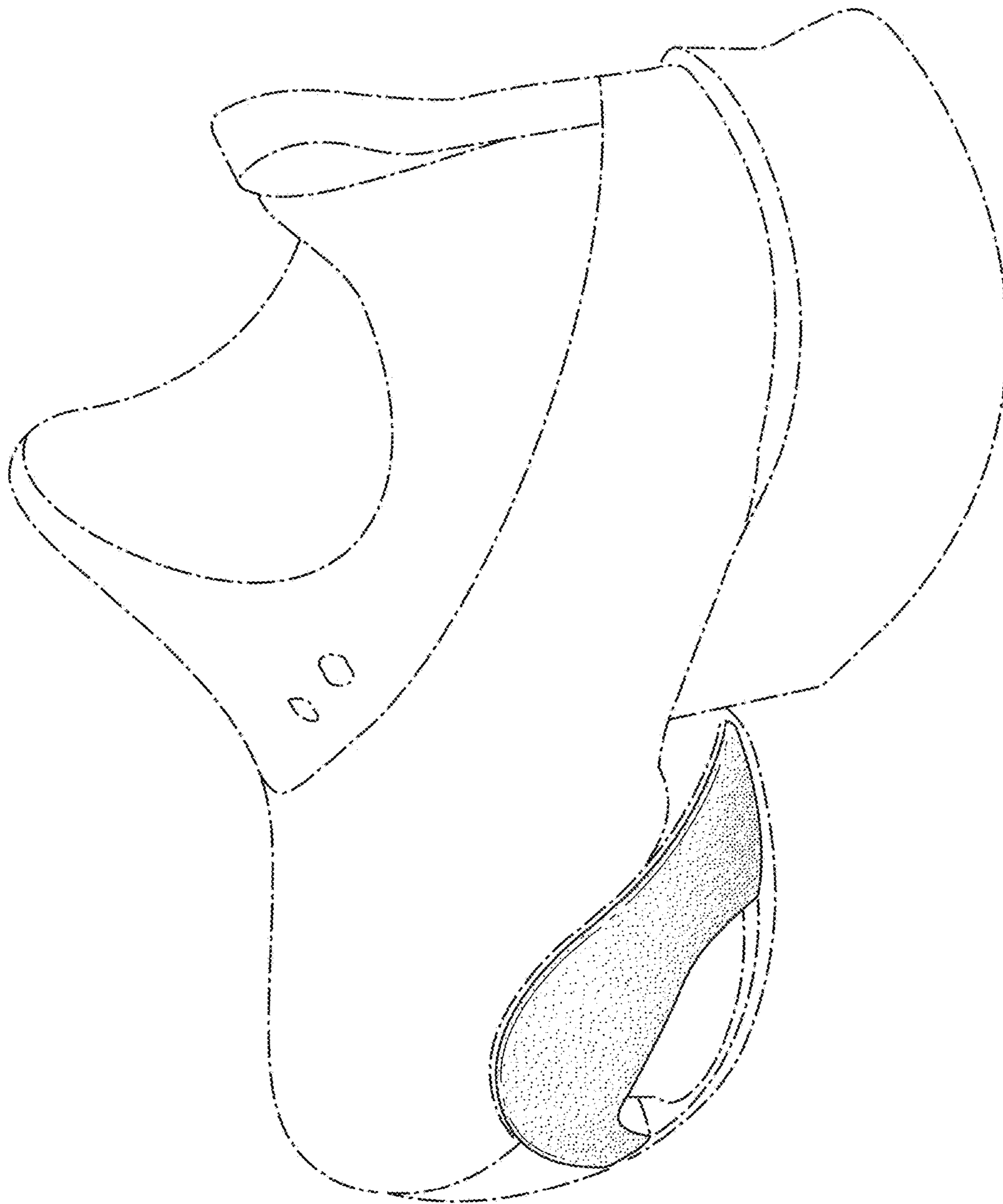
