DESCRIPTION

FIG. 1 is a perspective view of a cane tip showing my new design;

FIG. 2 is a Front view of the cane tip as shown in FIG. 1;

FIG. 3 is a Back view of the cane tip as shown in FIG. 1;

FIG. 4 is a Left-side view of the cane tip as shown in FIG. 1;

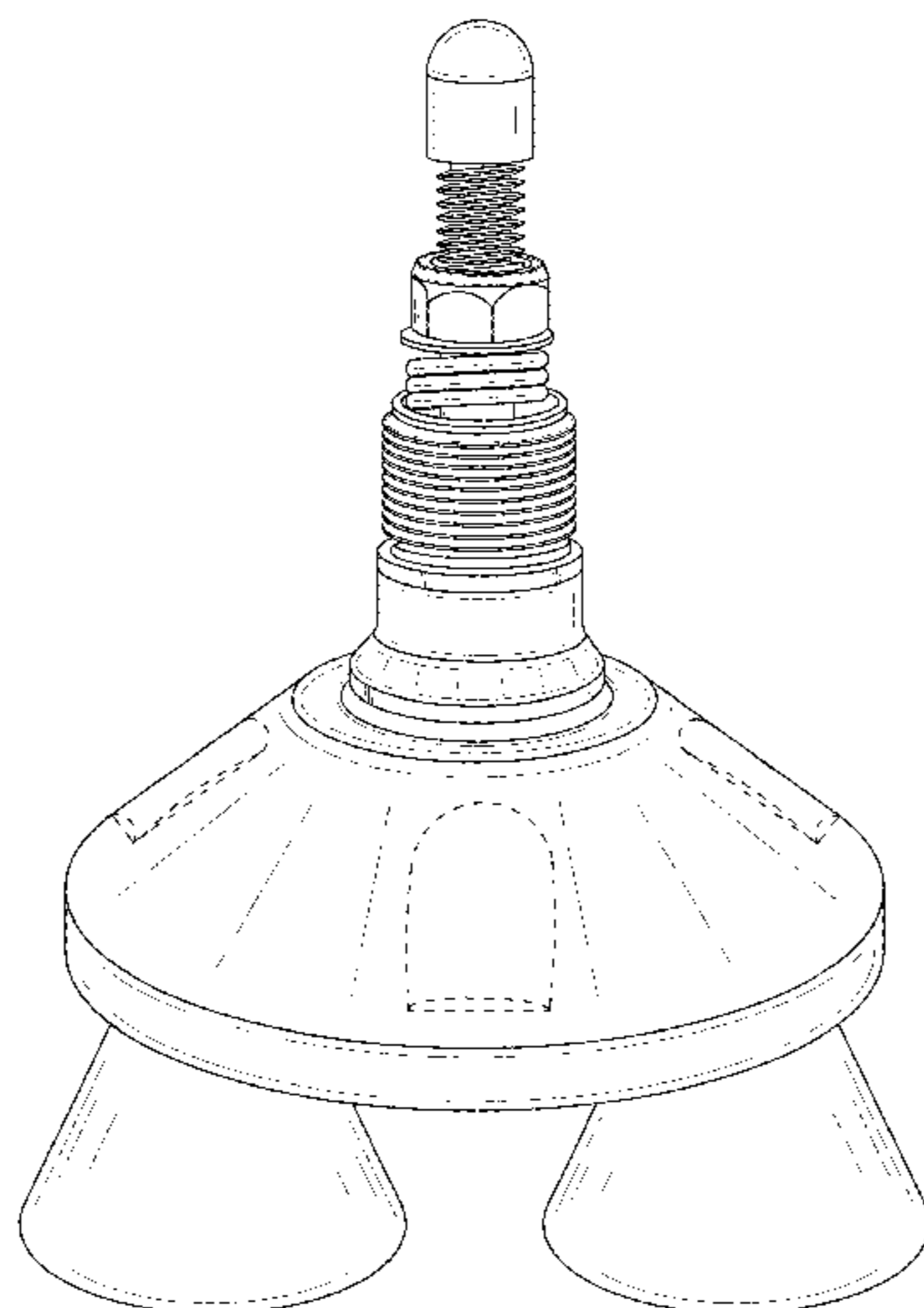
FIG. 5 is a Right-side view of the cane tip as shown in FIG. 1;

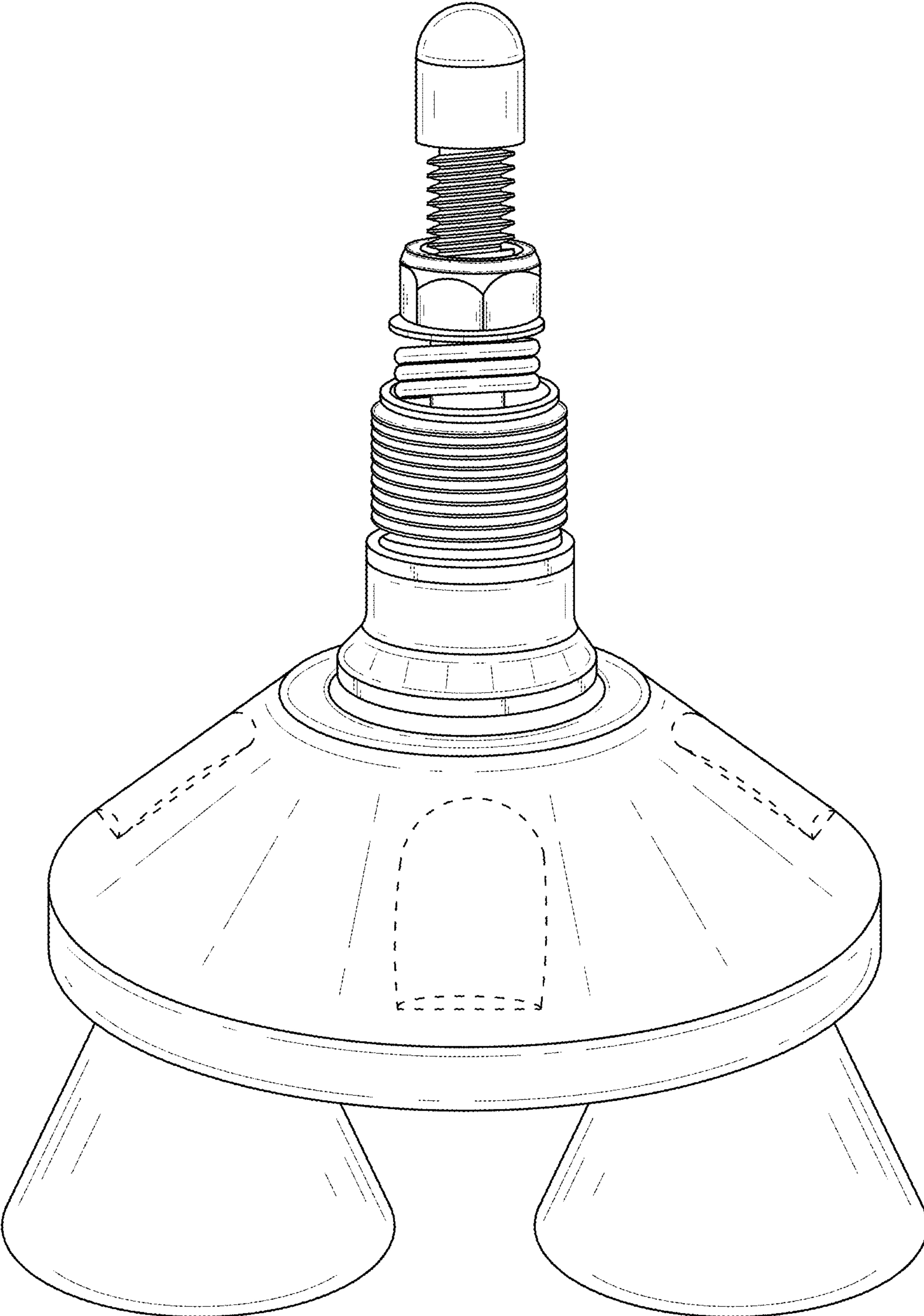

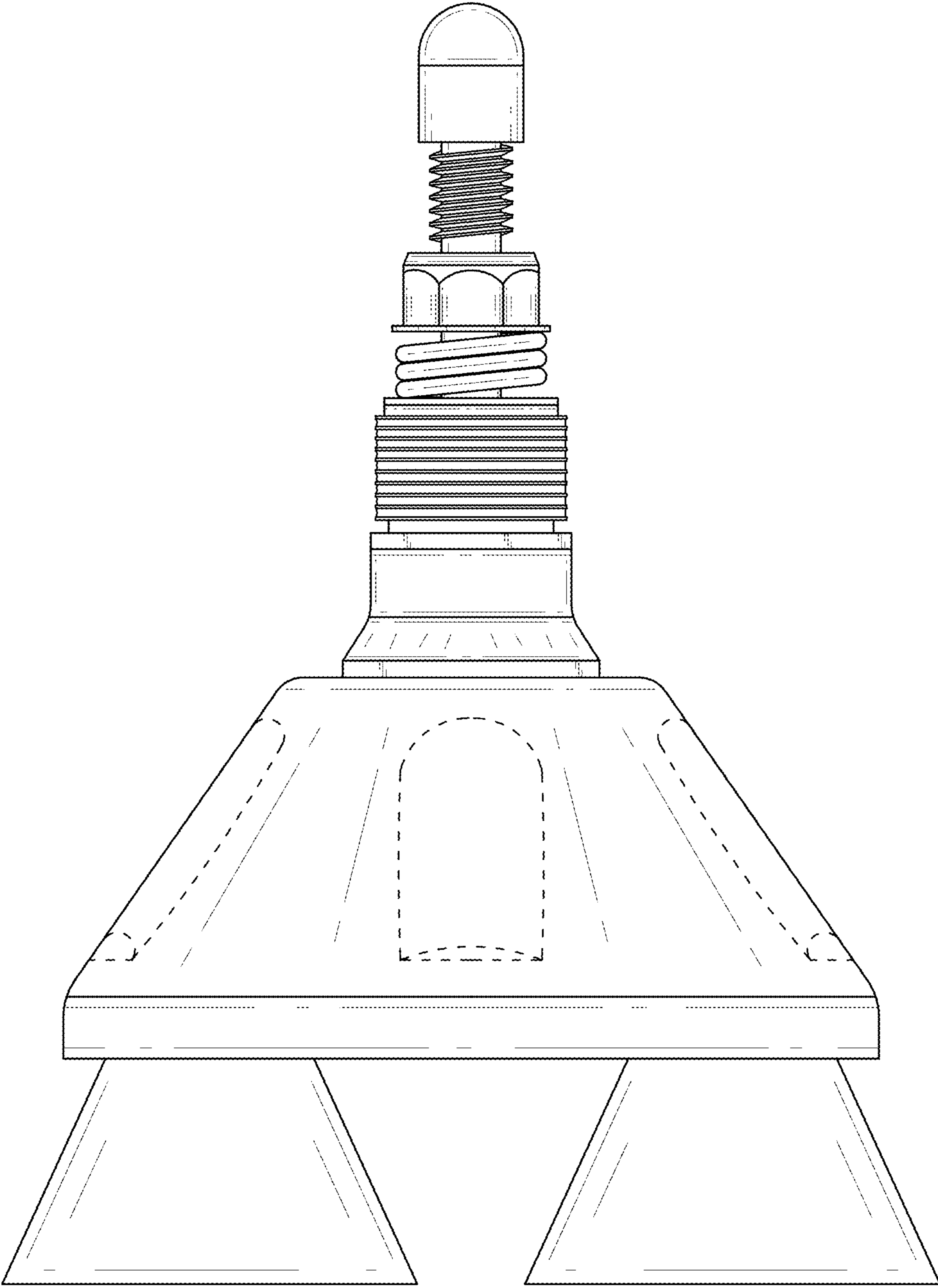

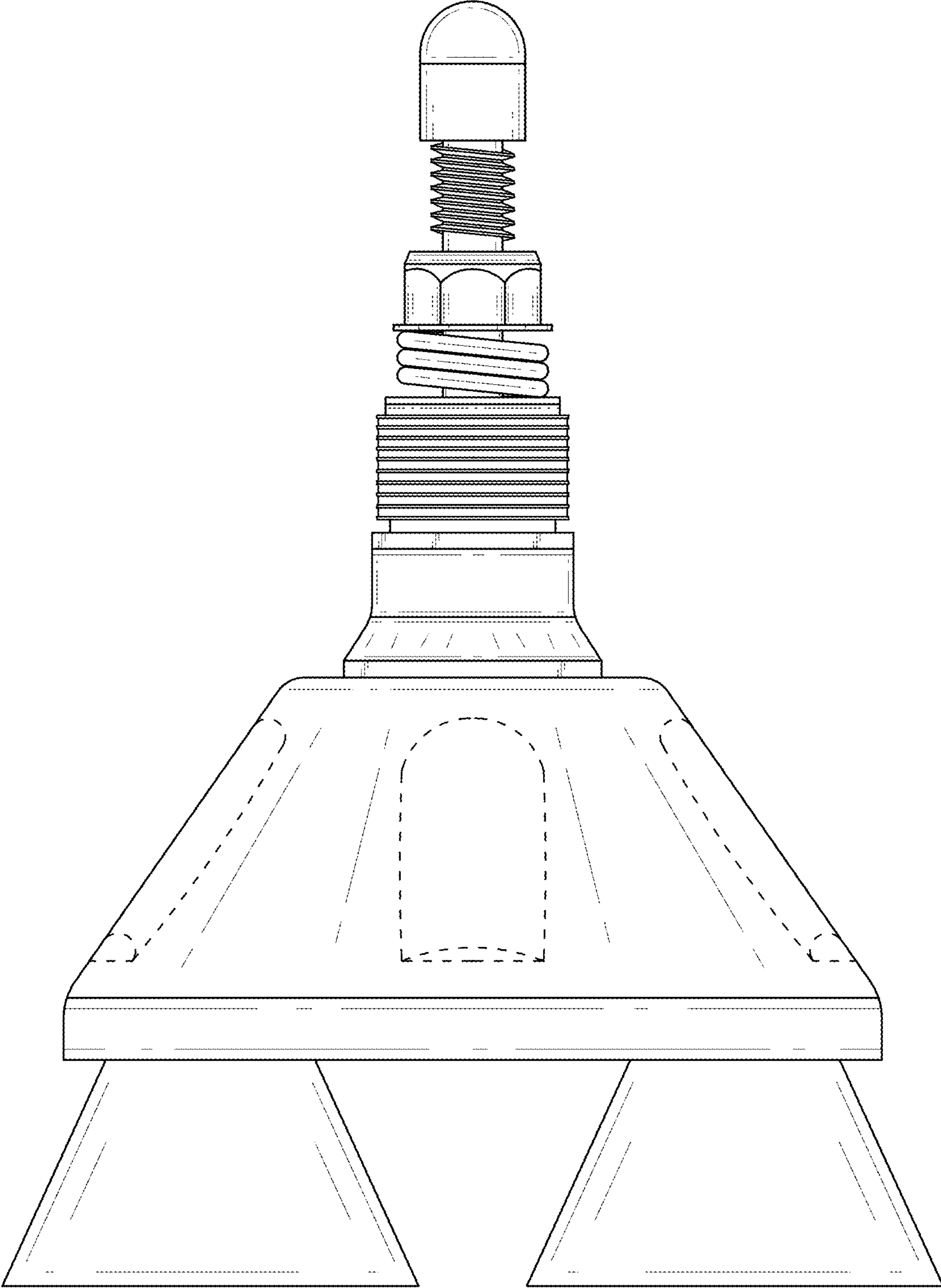

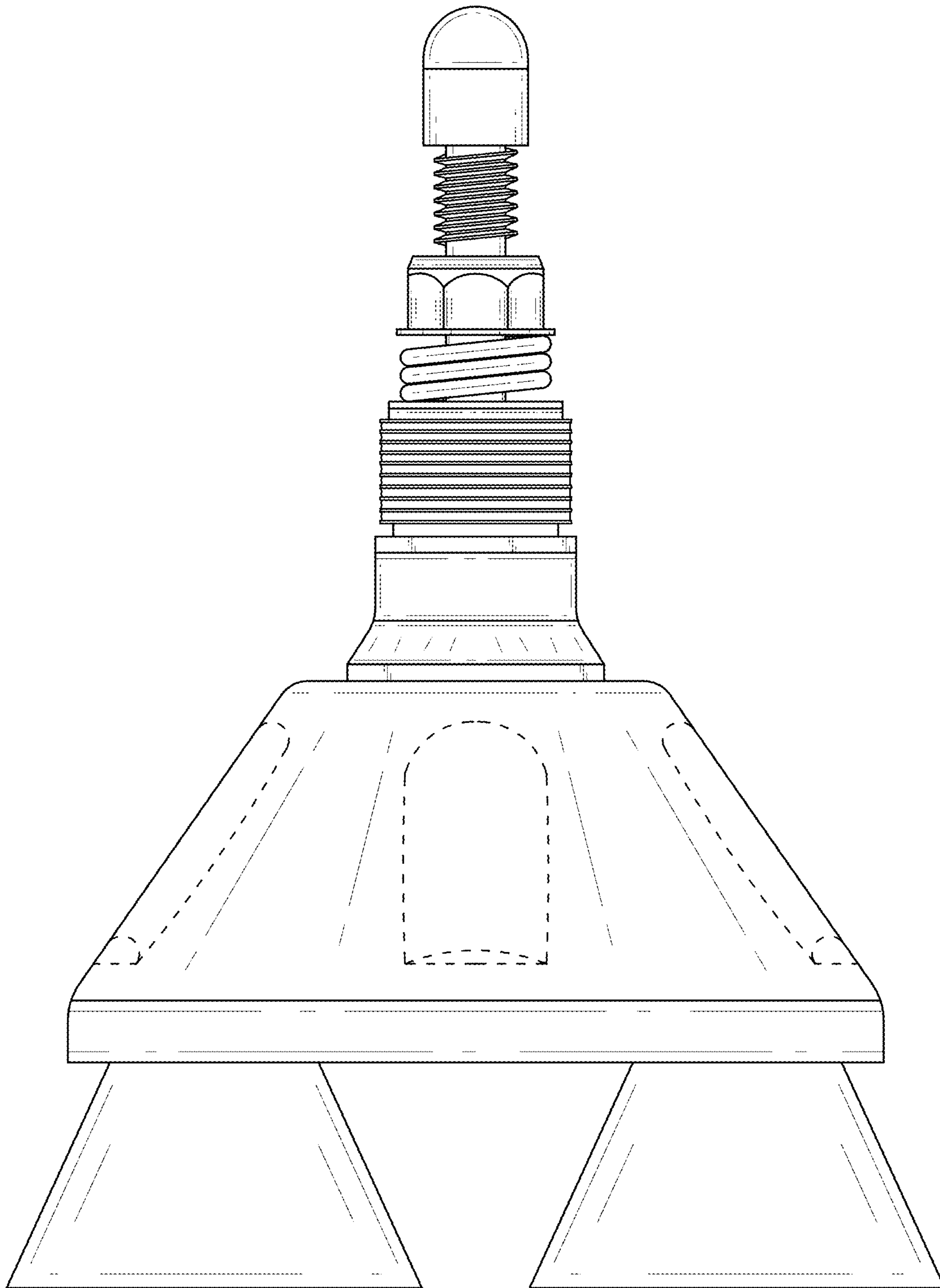

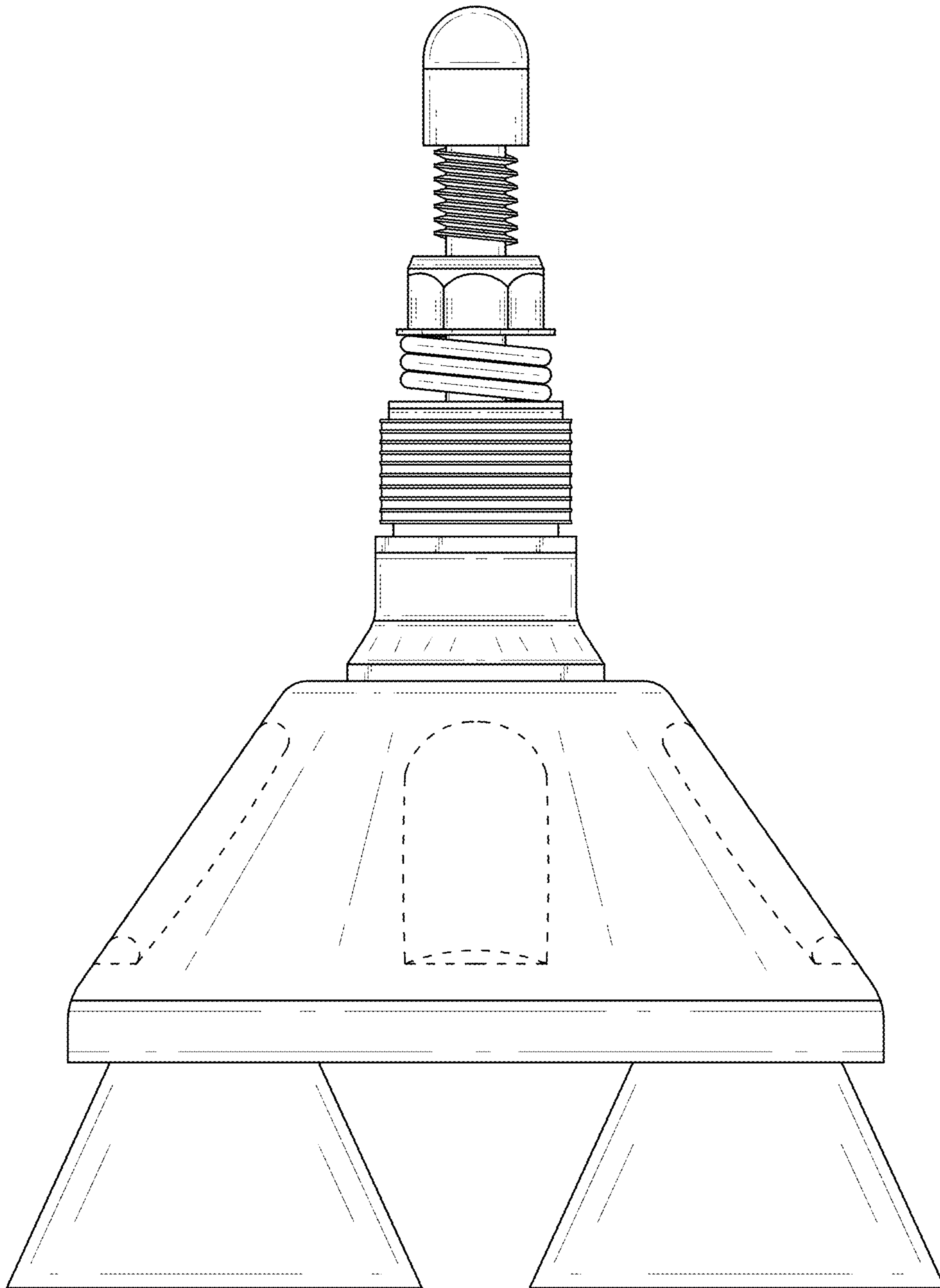

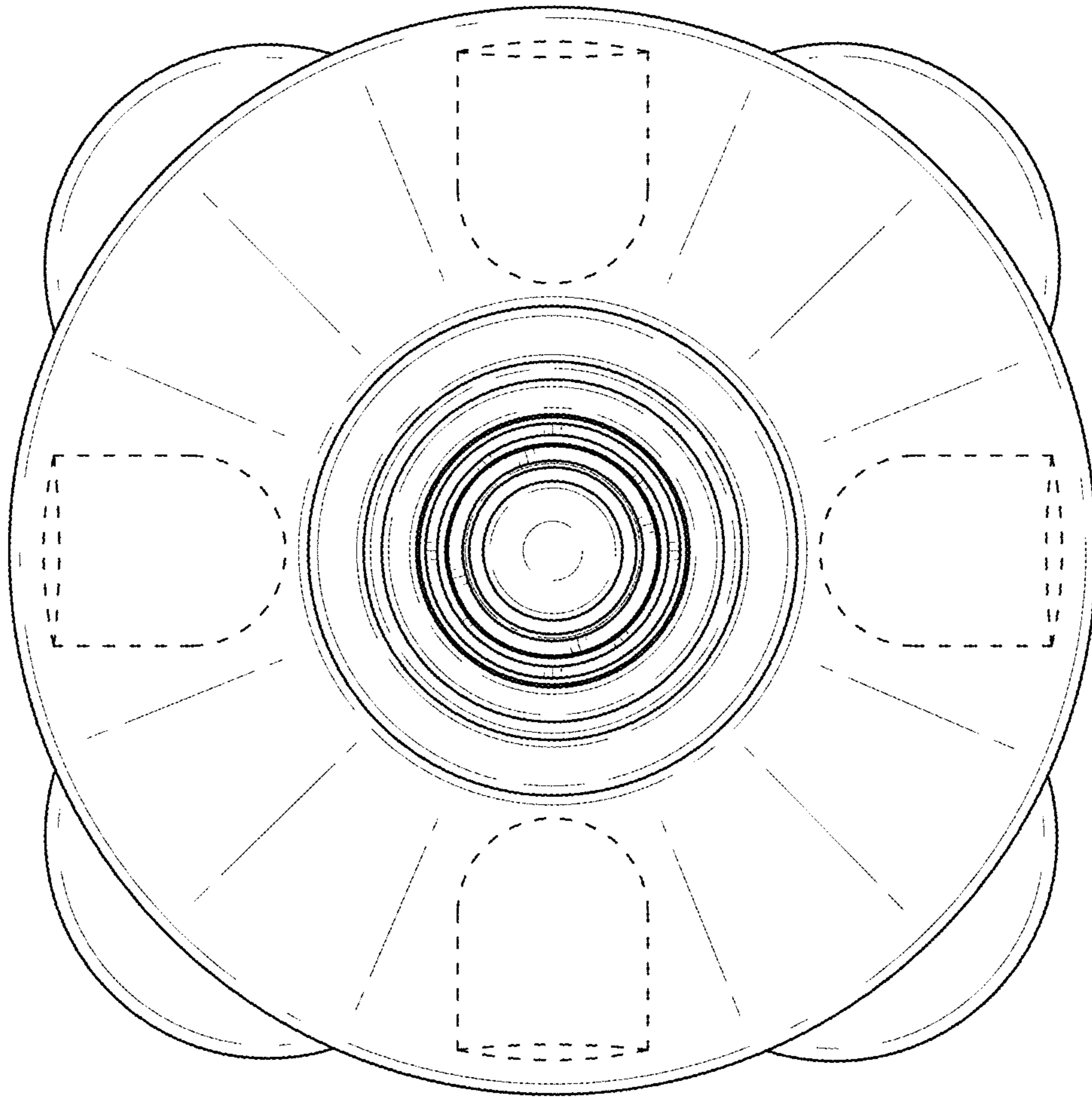

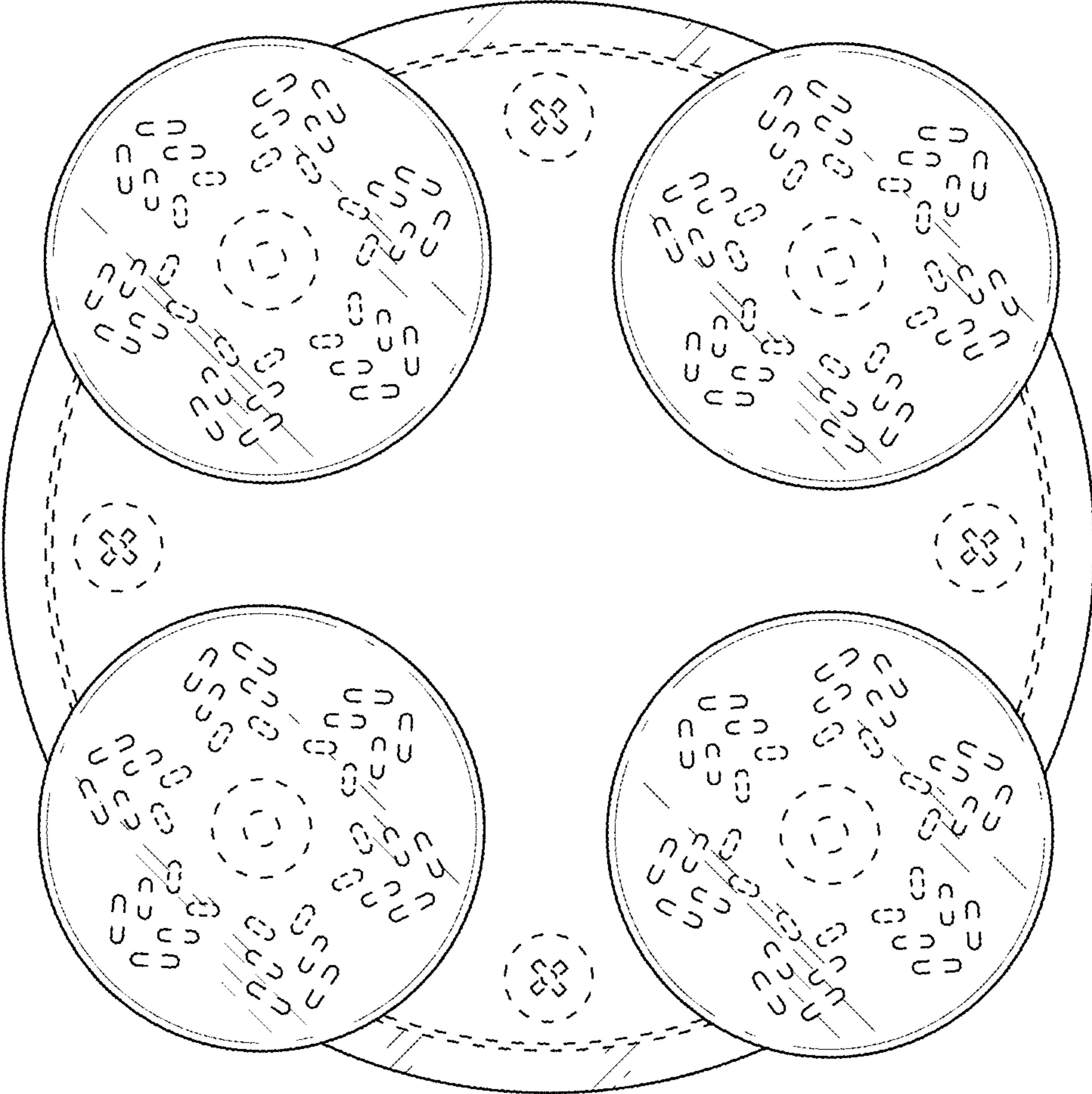
