DESCRIPTION

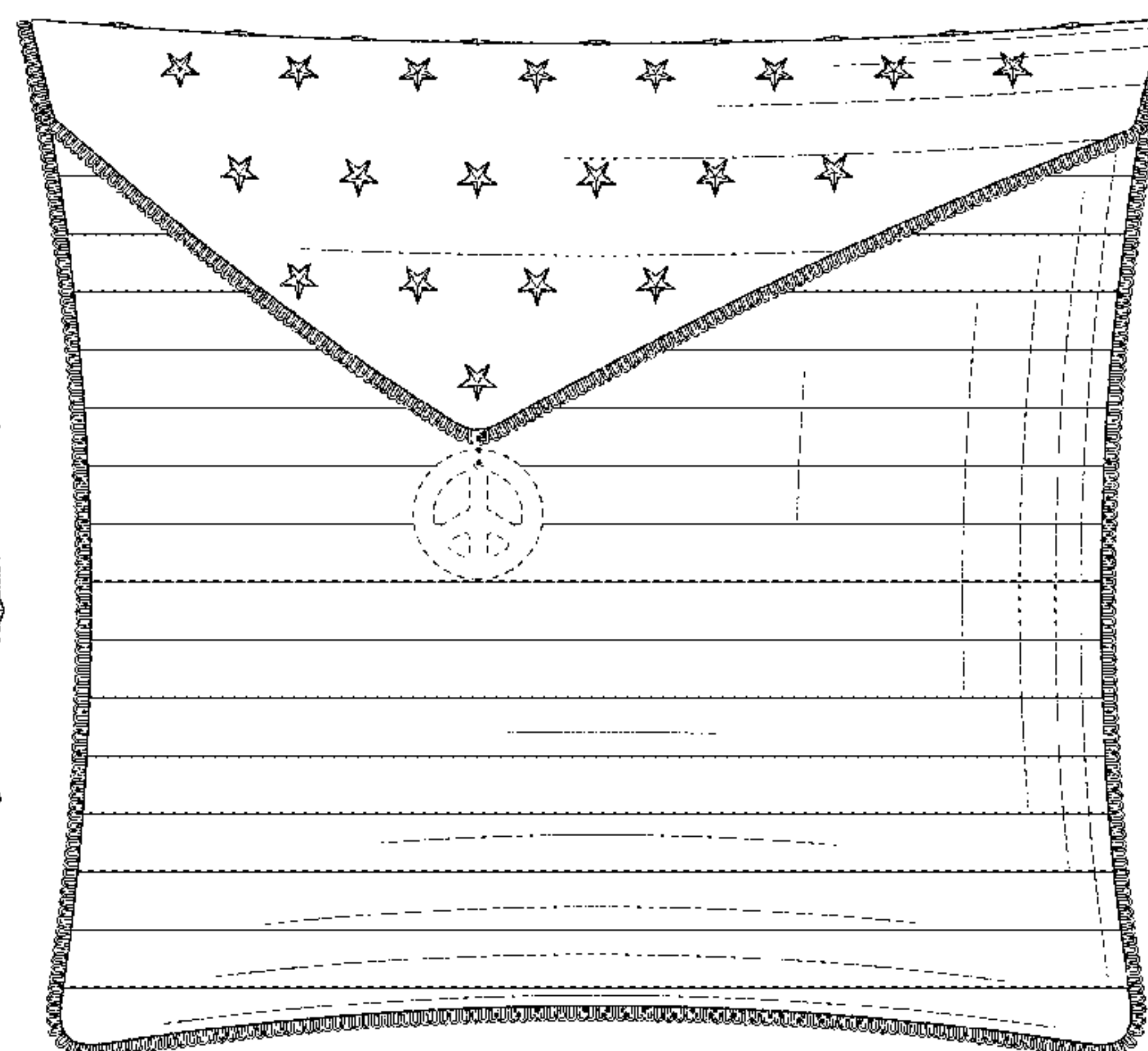
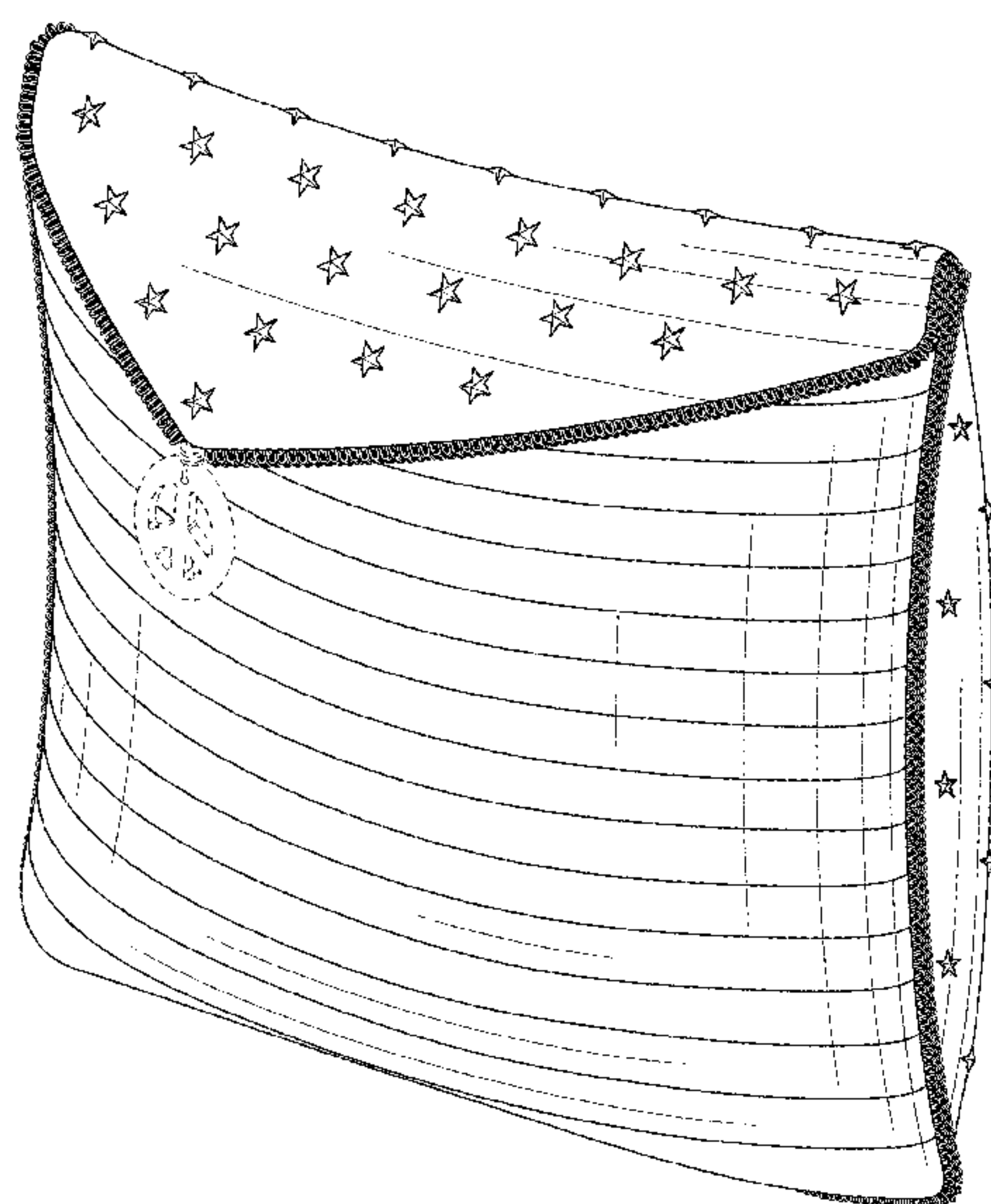
FIG. 1 is a perspective view of a pillowcase showing my new design as it would appear in use on a pillow.

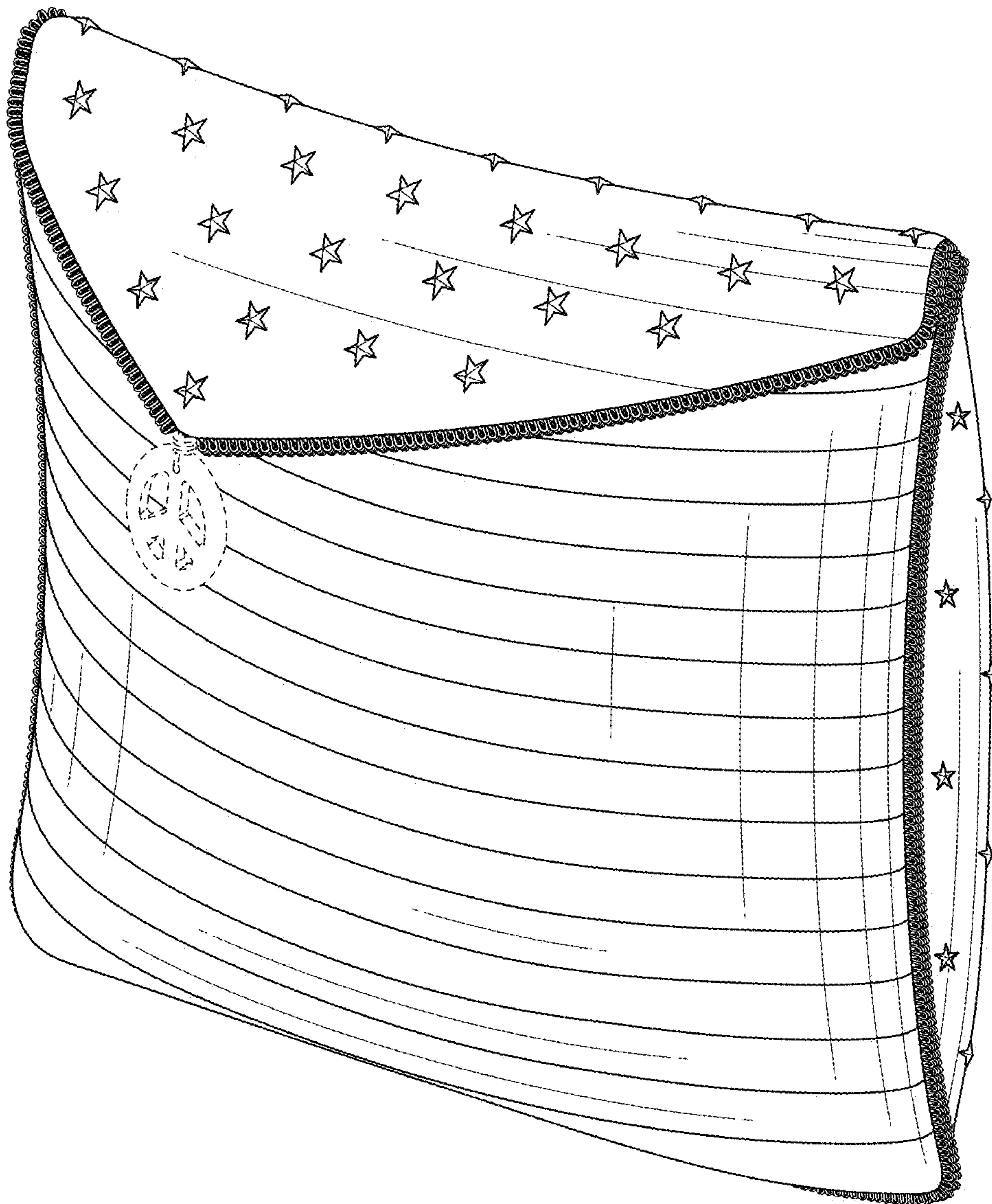

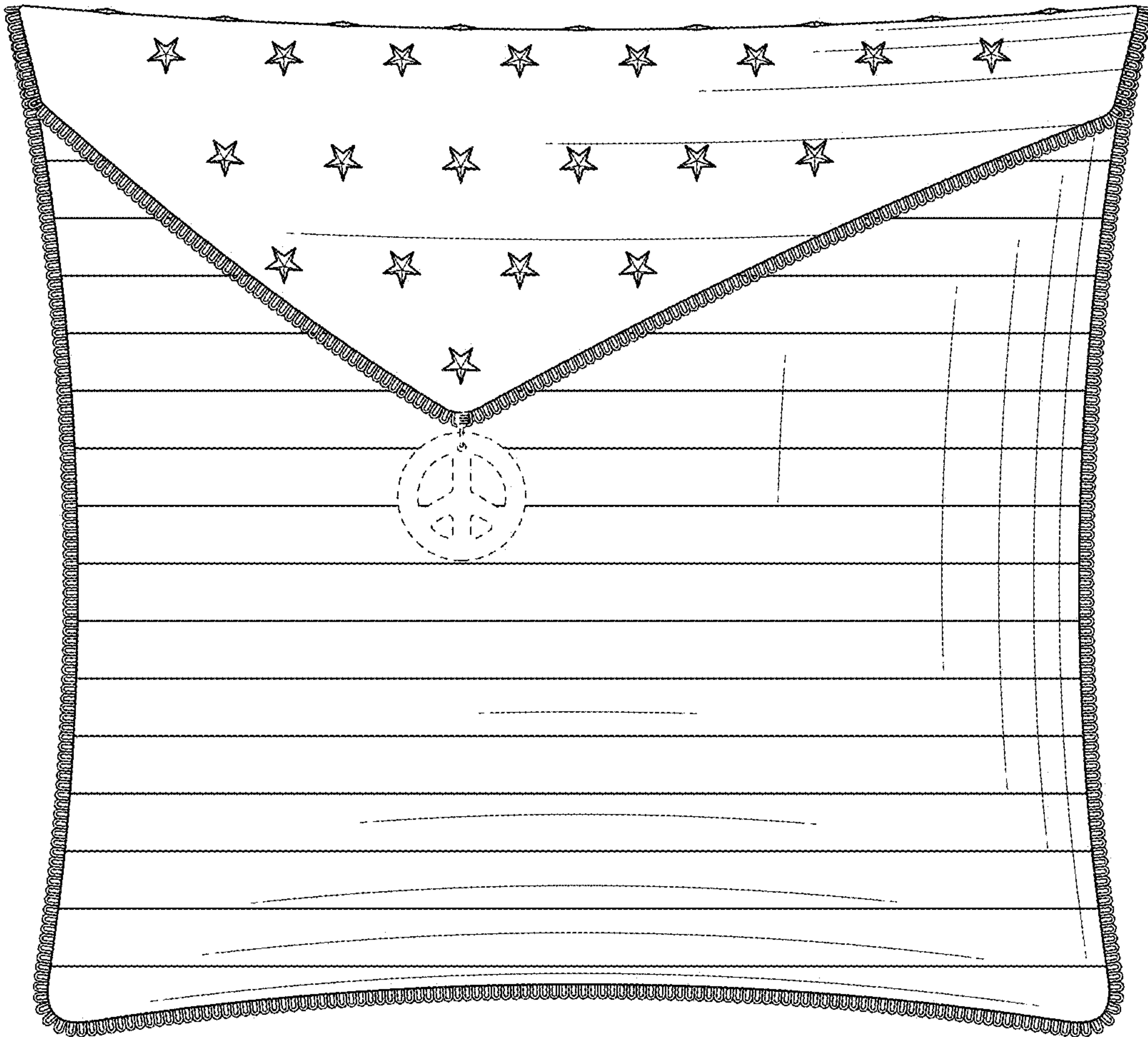

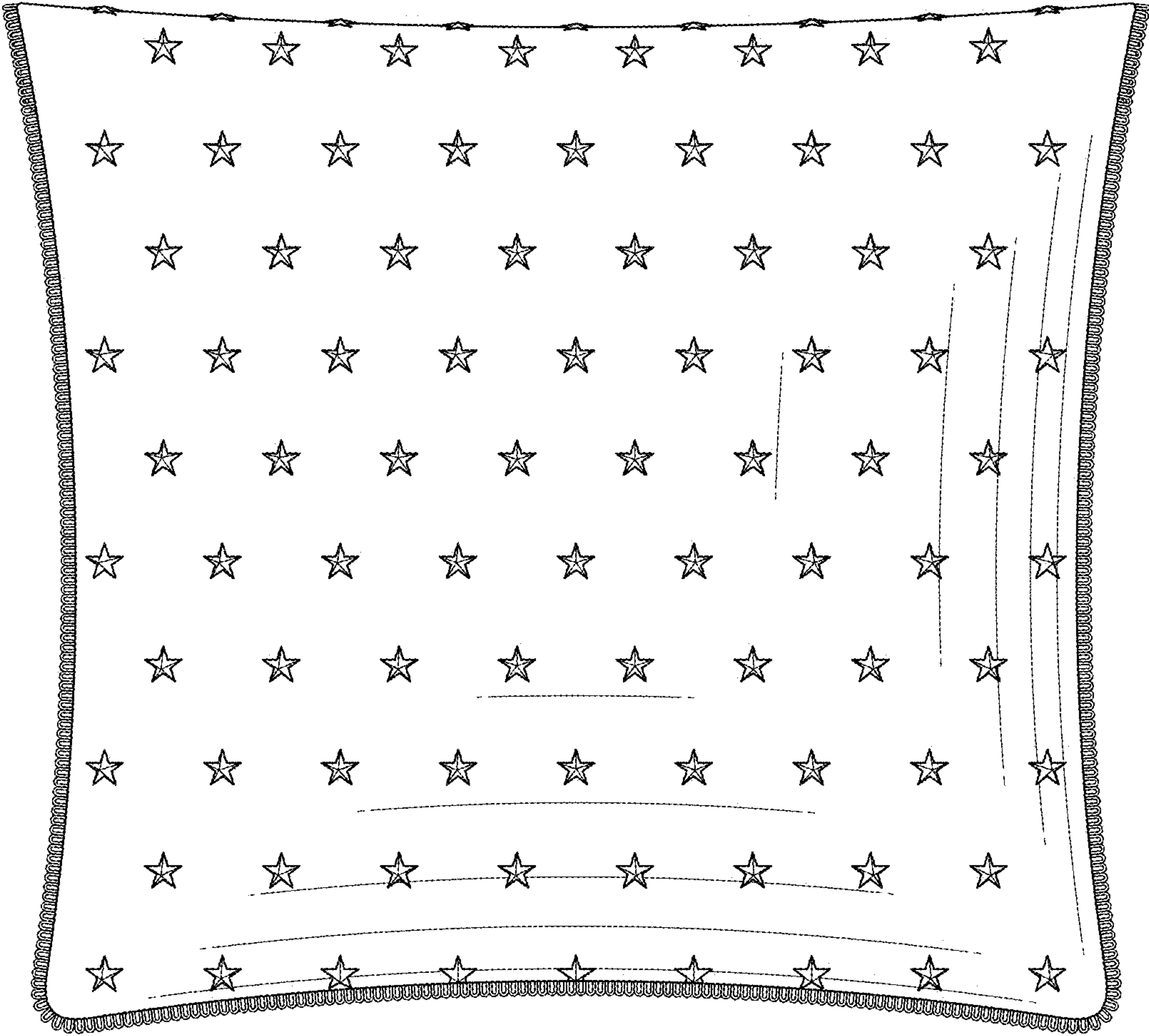

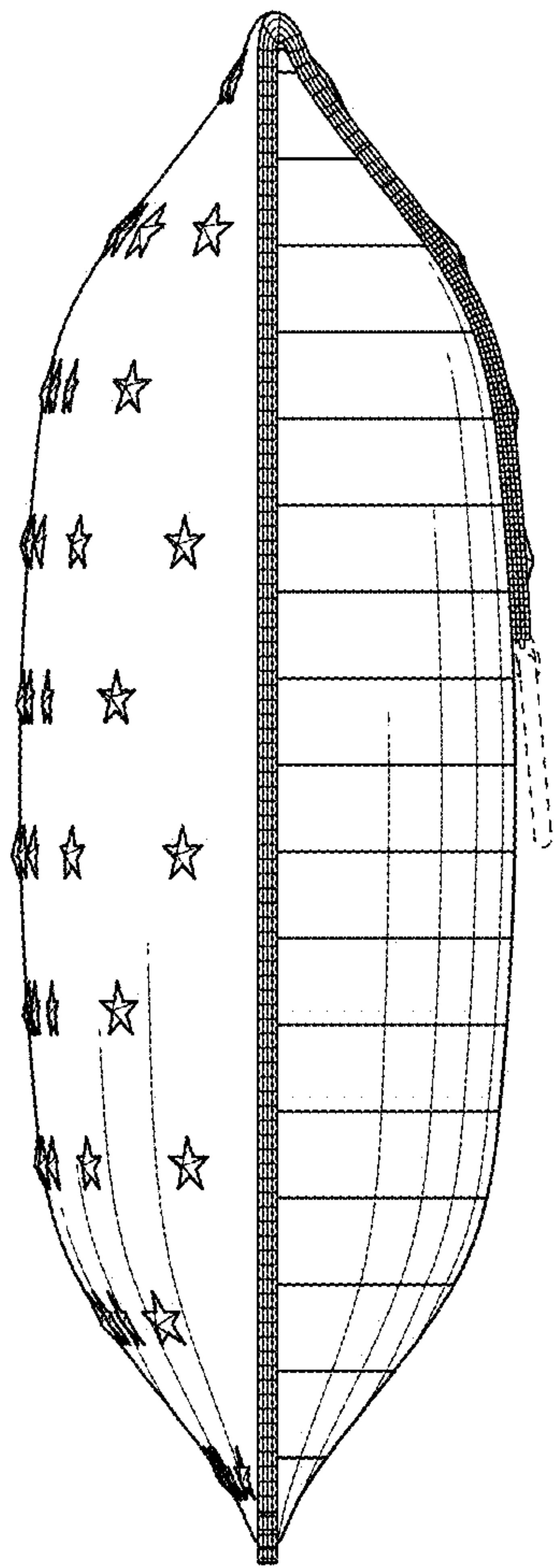

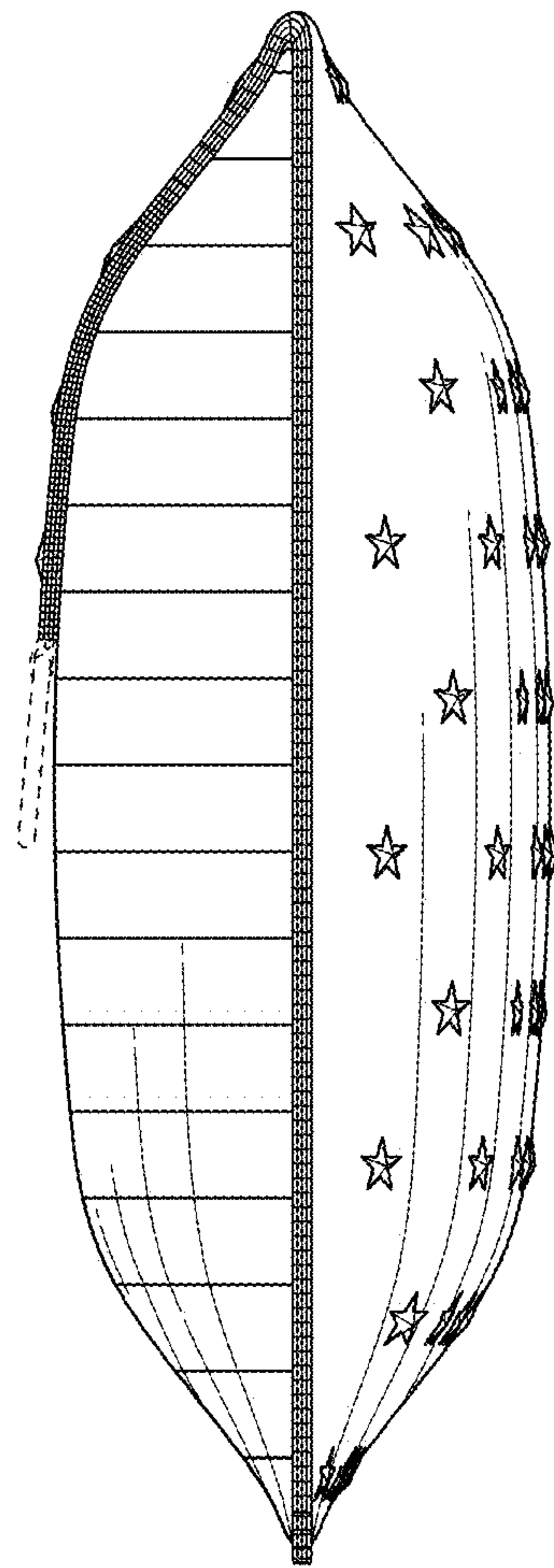

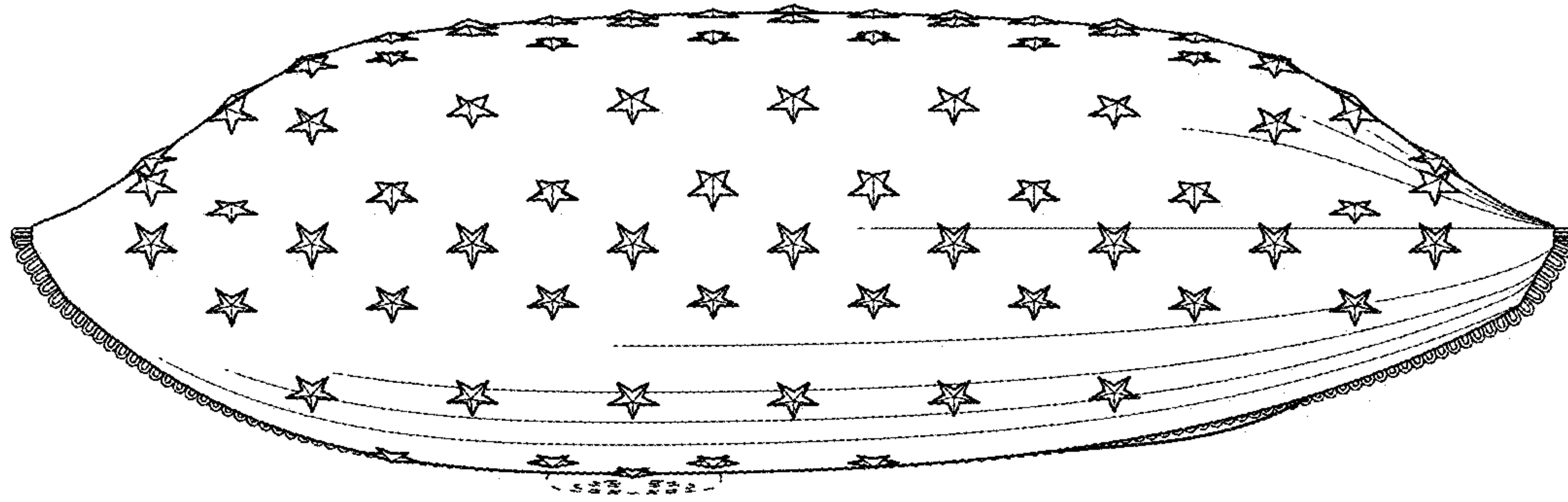

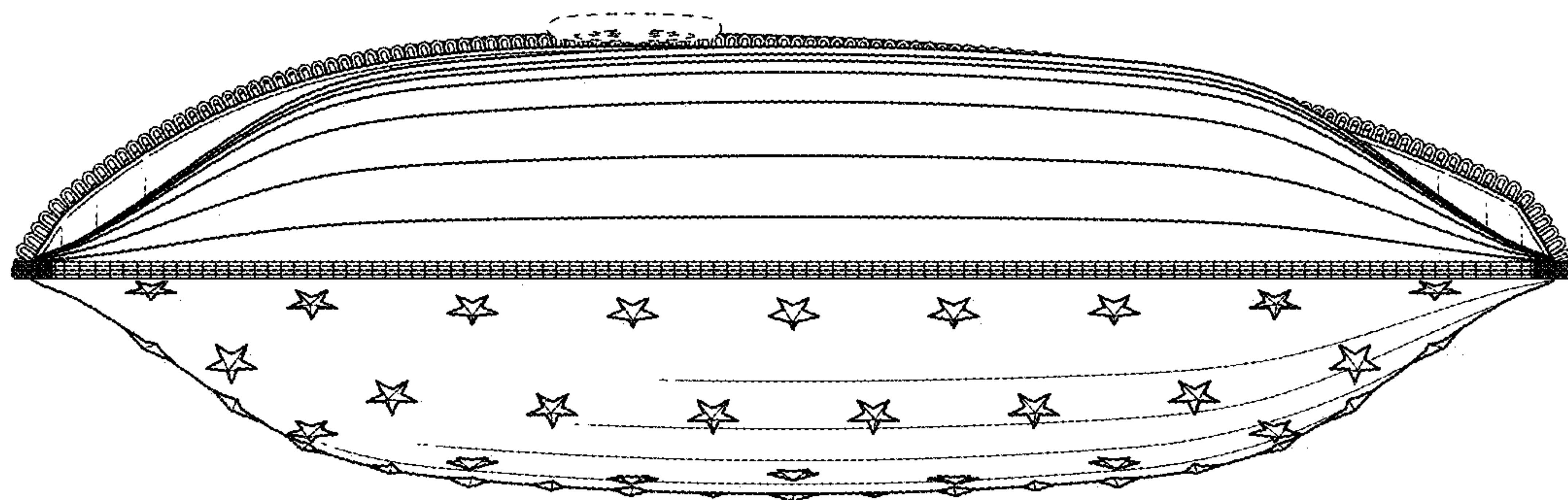

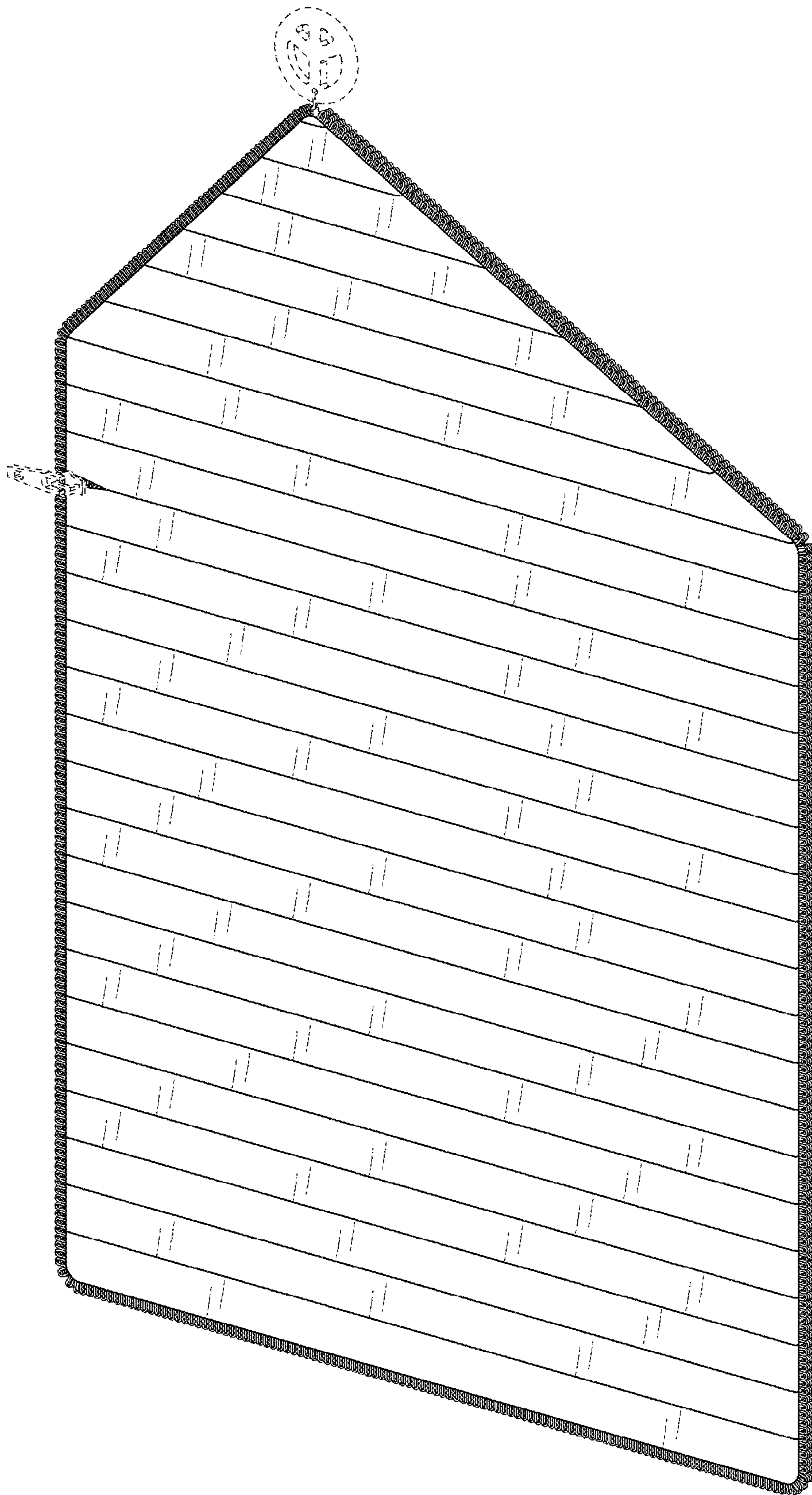

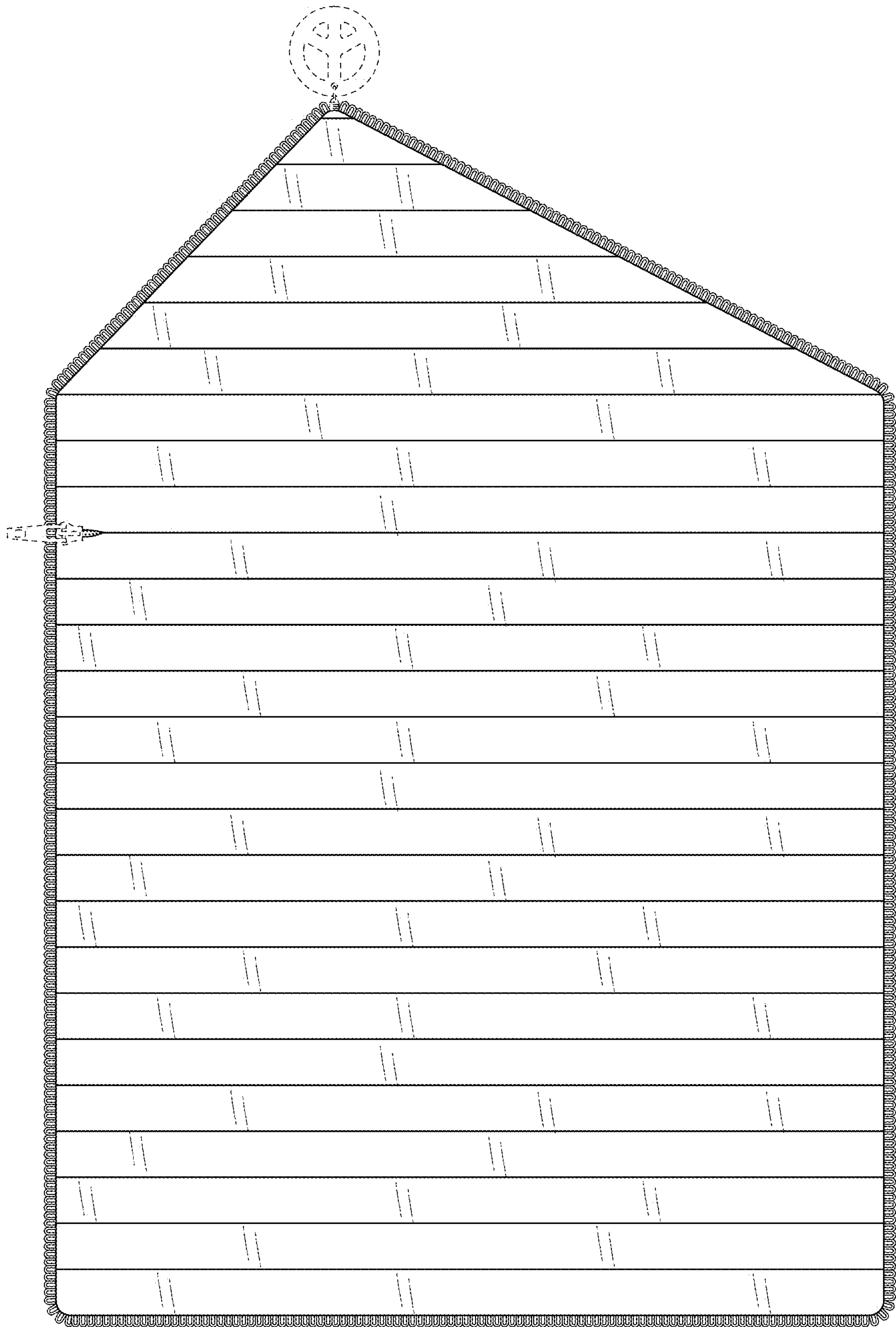

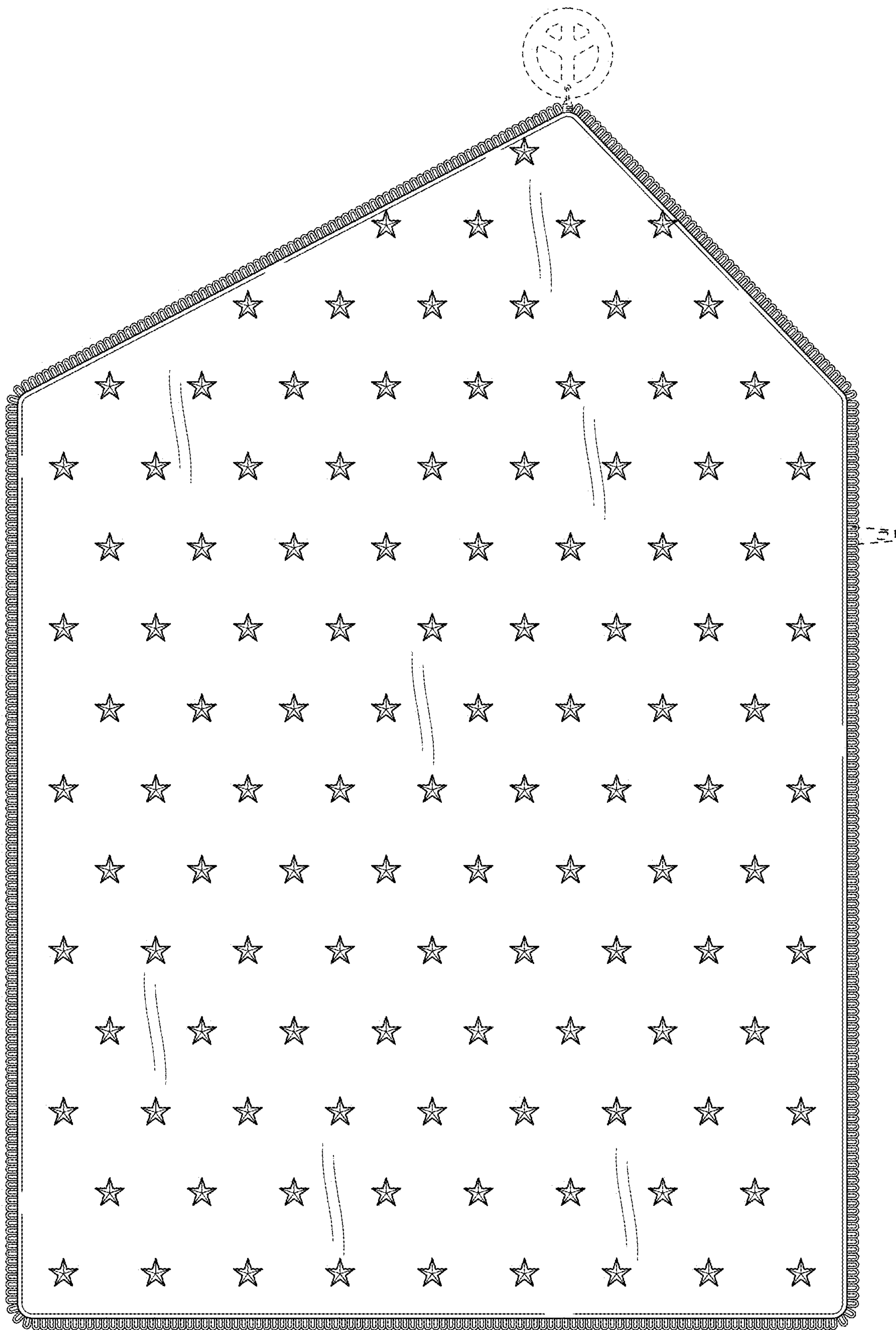

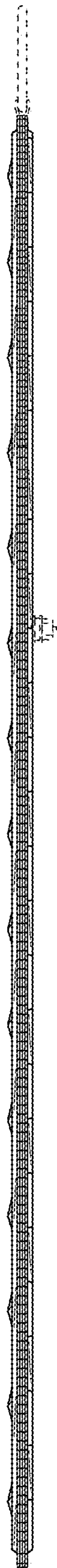

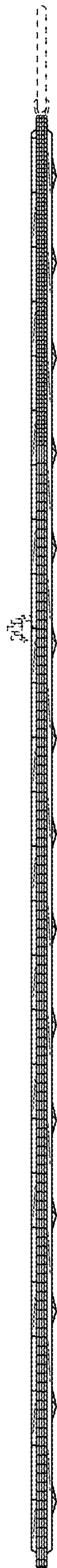
