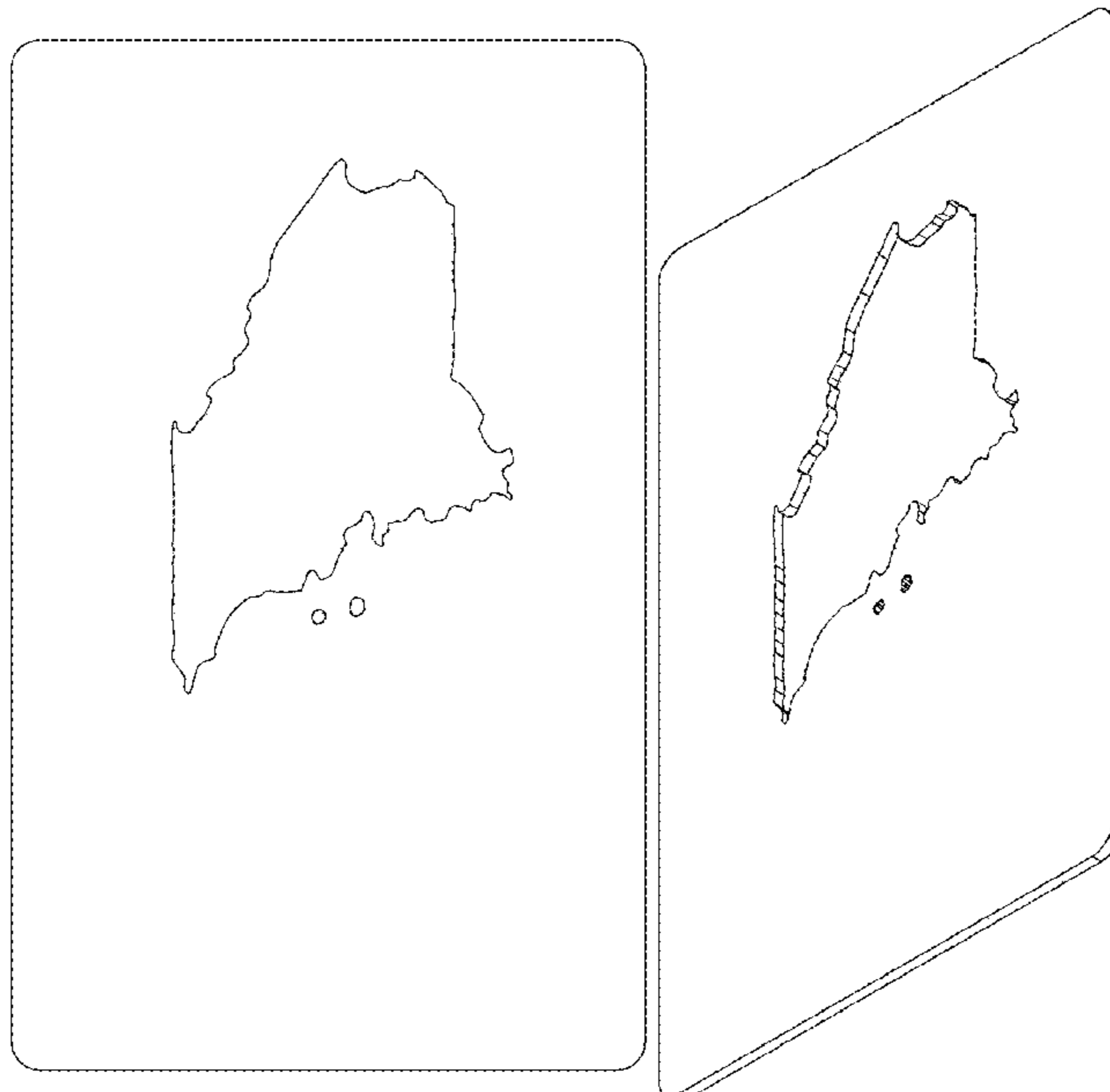
(57) **CLAIM**

The ornamental design for a wallet card state bottle opener, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a wallet card state bottle opener, the bottom view being a mirror image thereof; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof, the right side being a mirror image thereof; and, FIG. 5 is a front perspective view thereof.

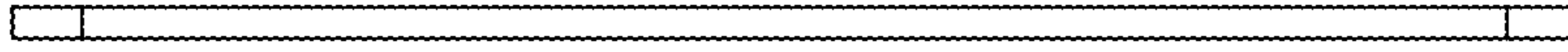

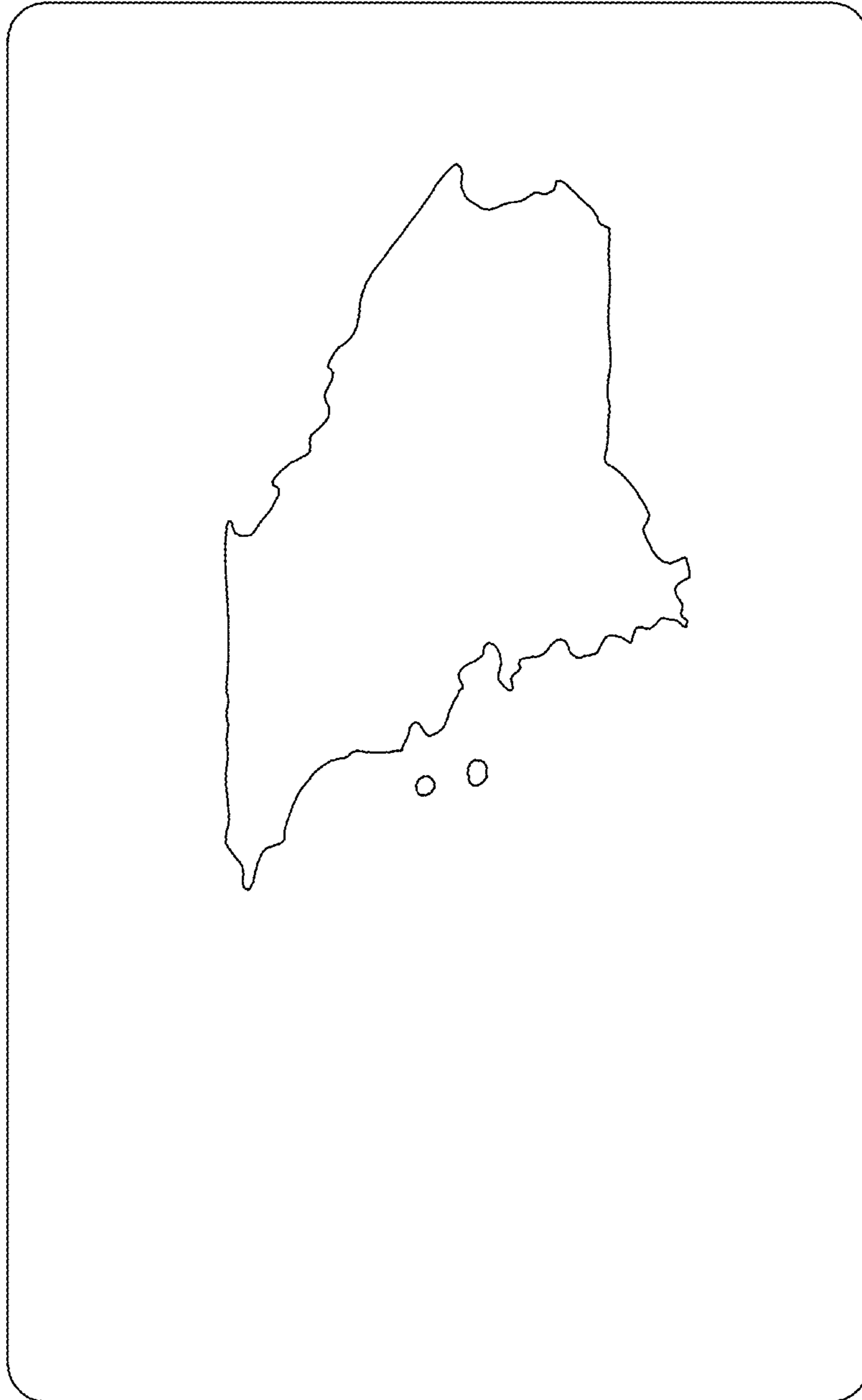

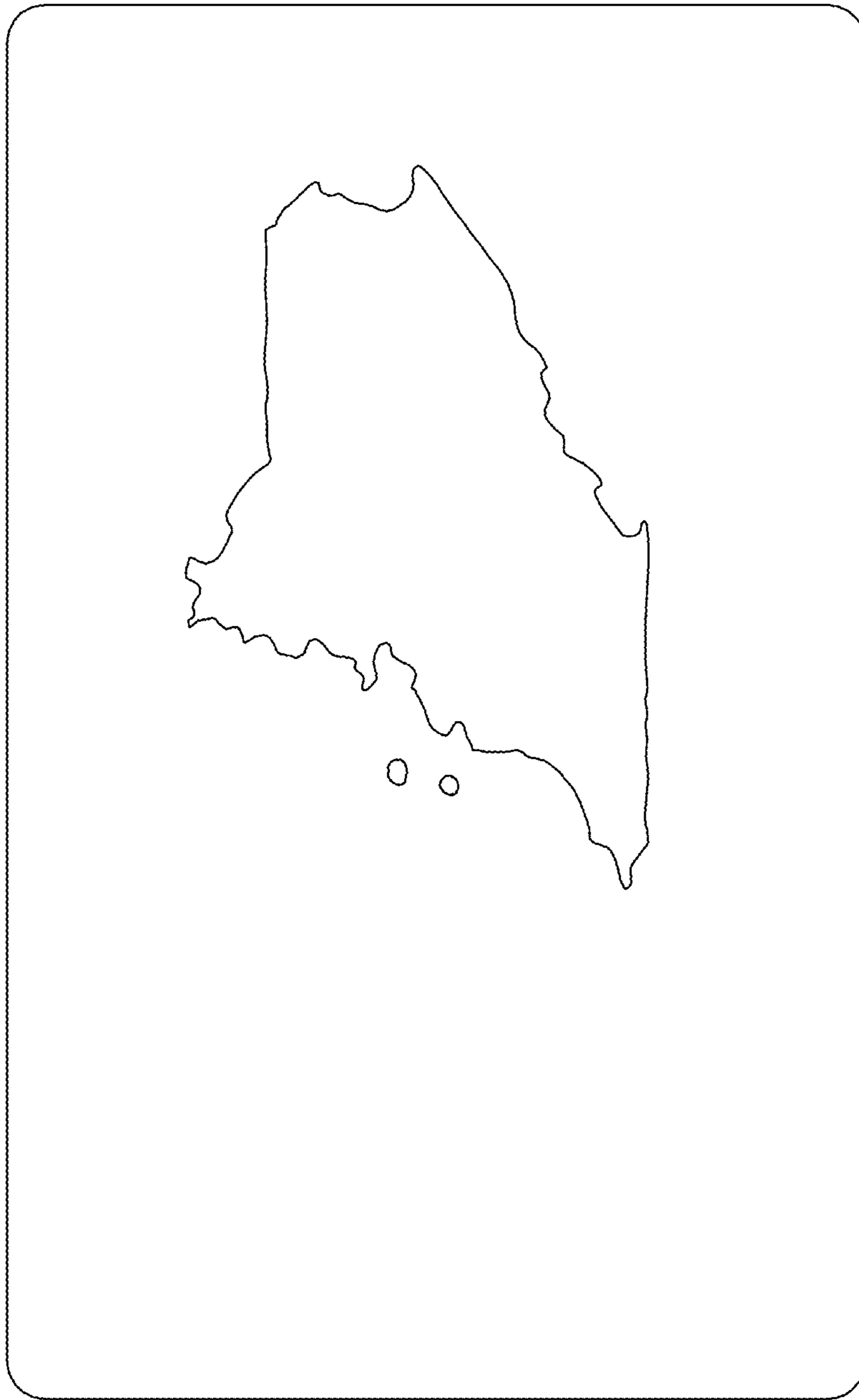

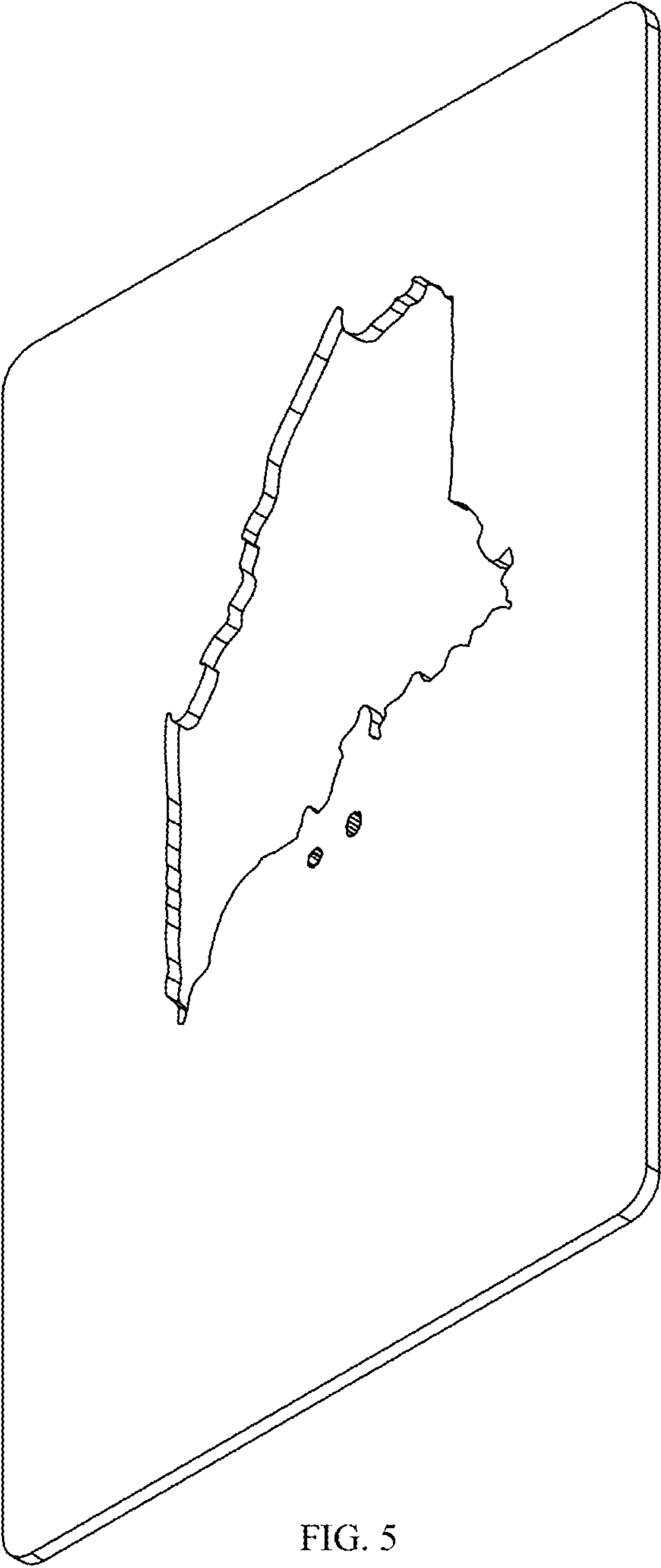
