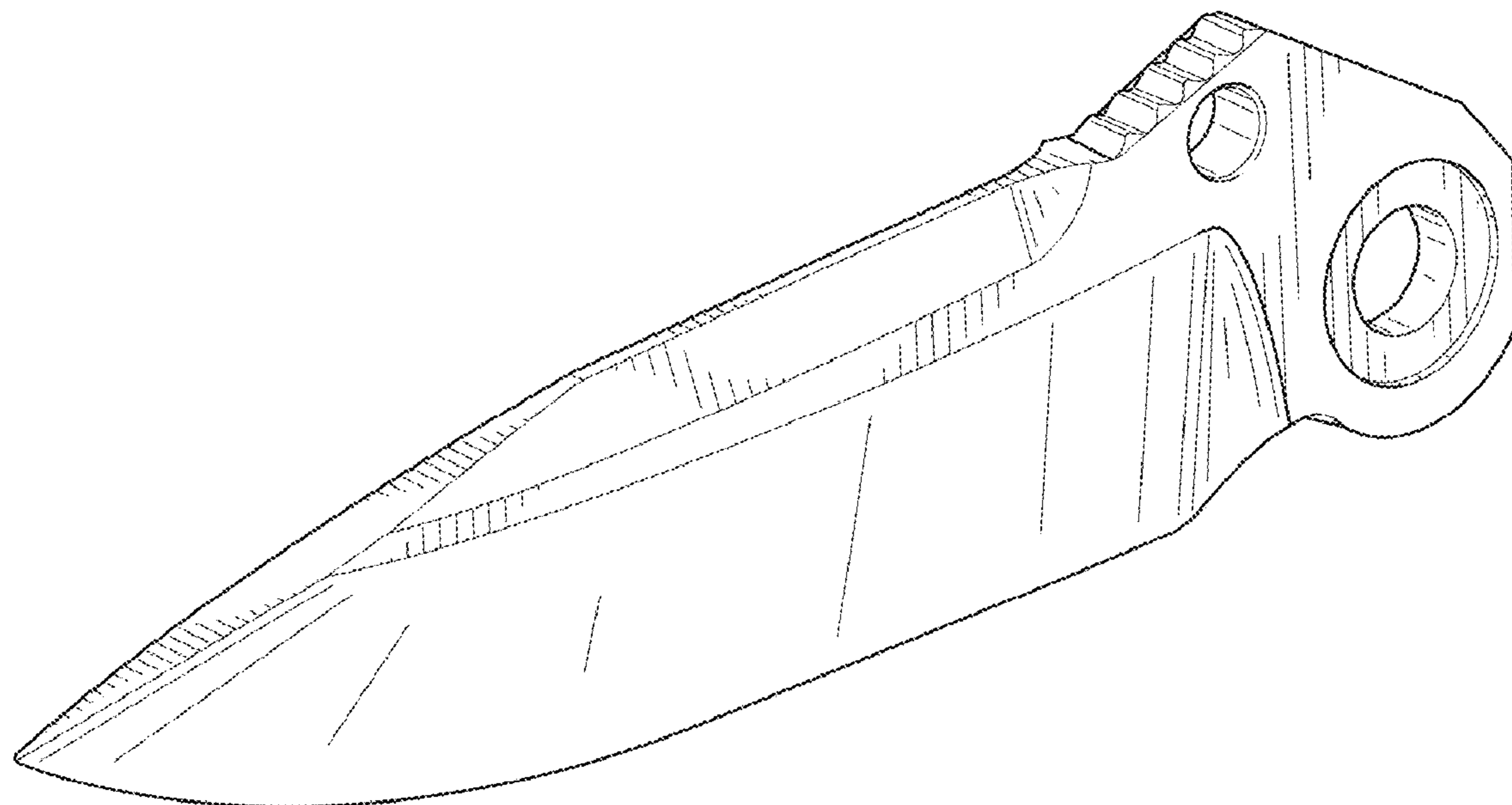
The ornamental design for a blade, as shown and described.

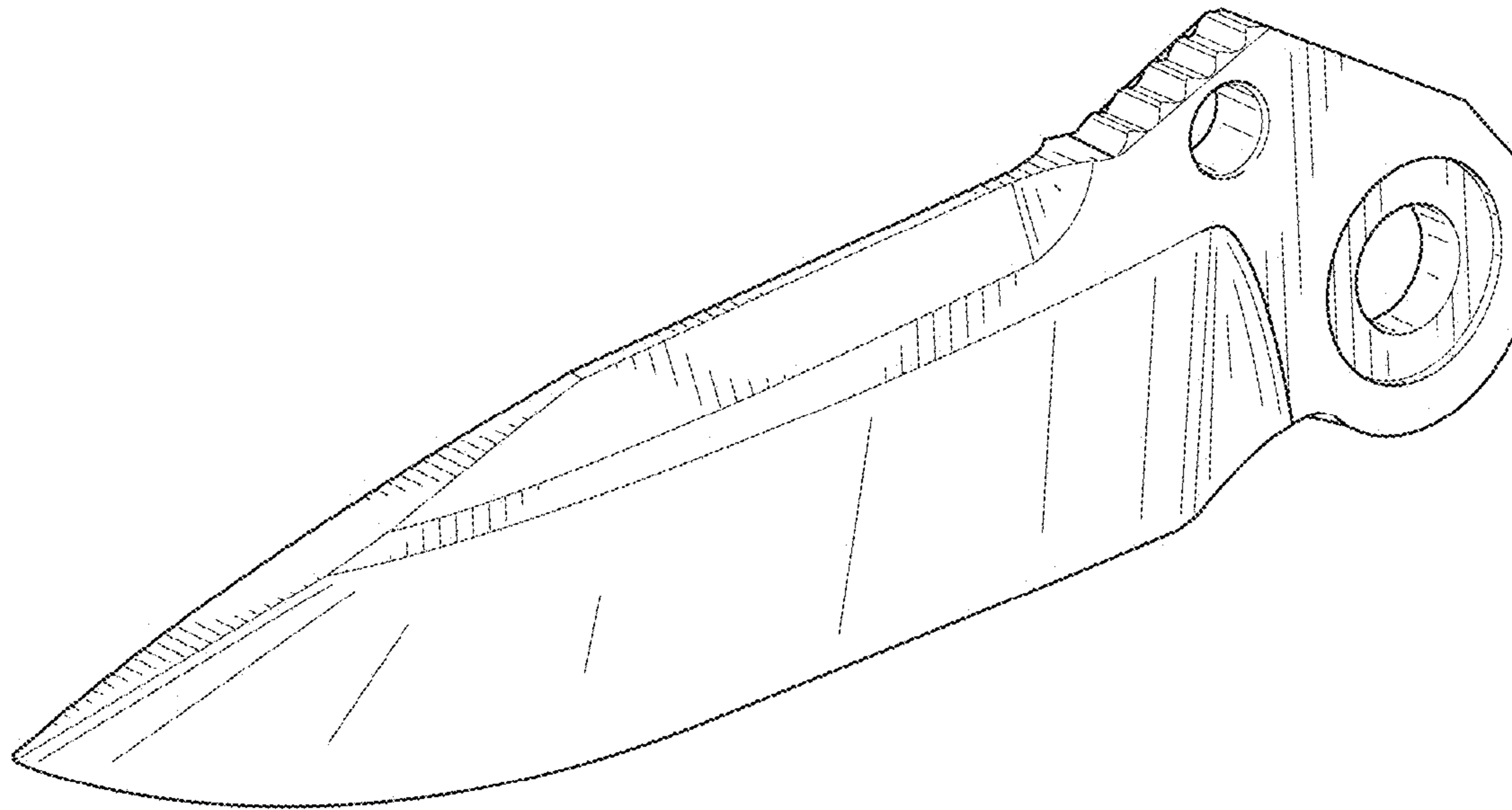

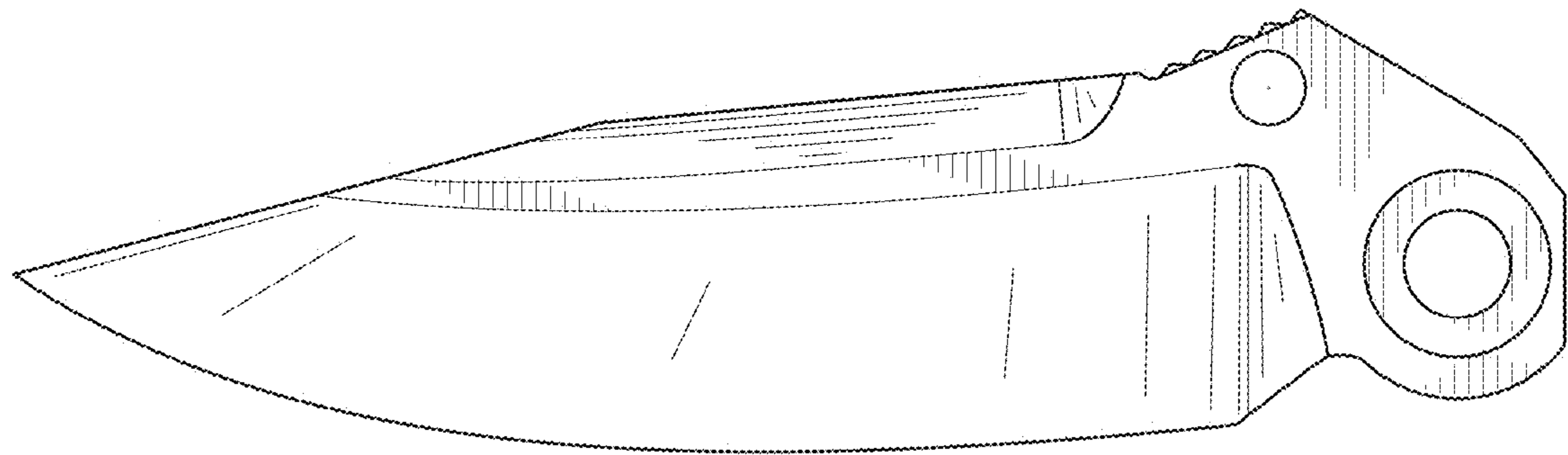

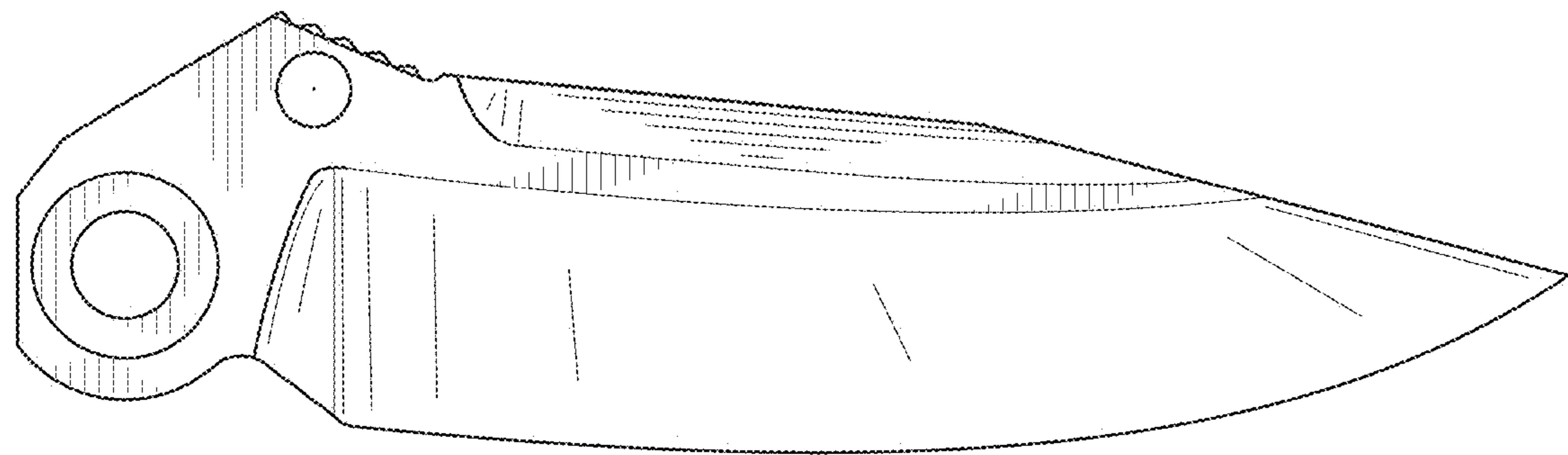
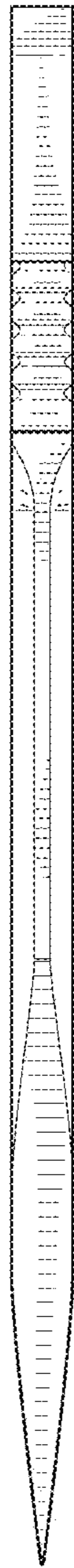
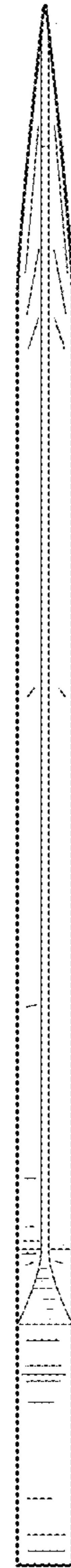
