DESCRIPTION

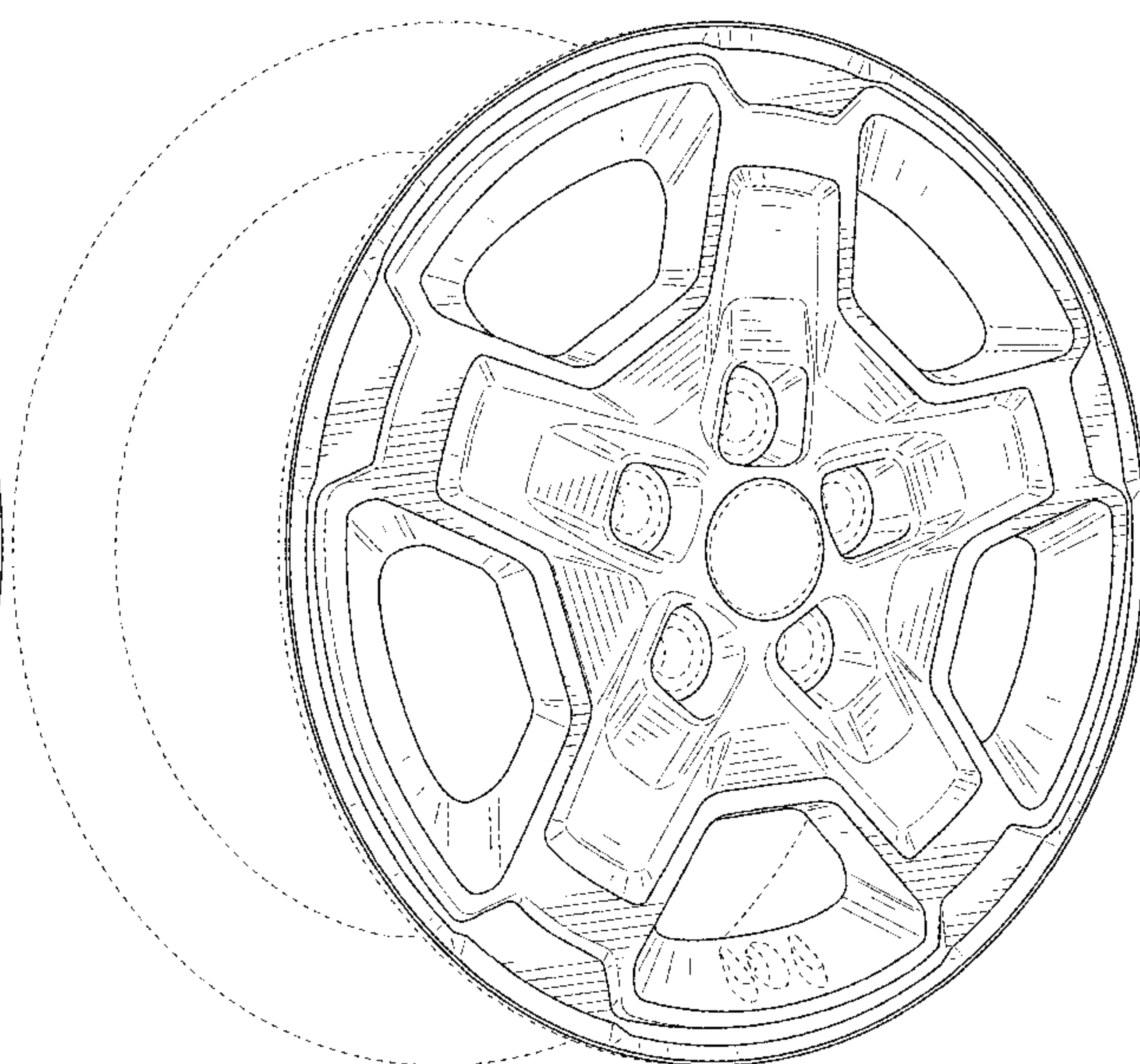
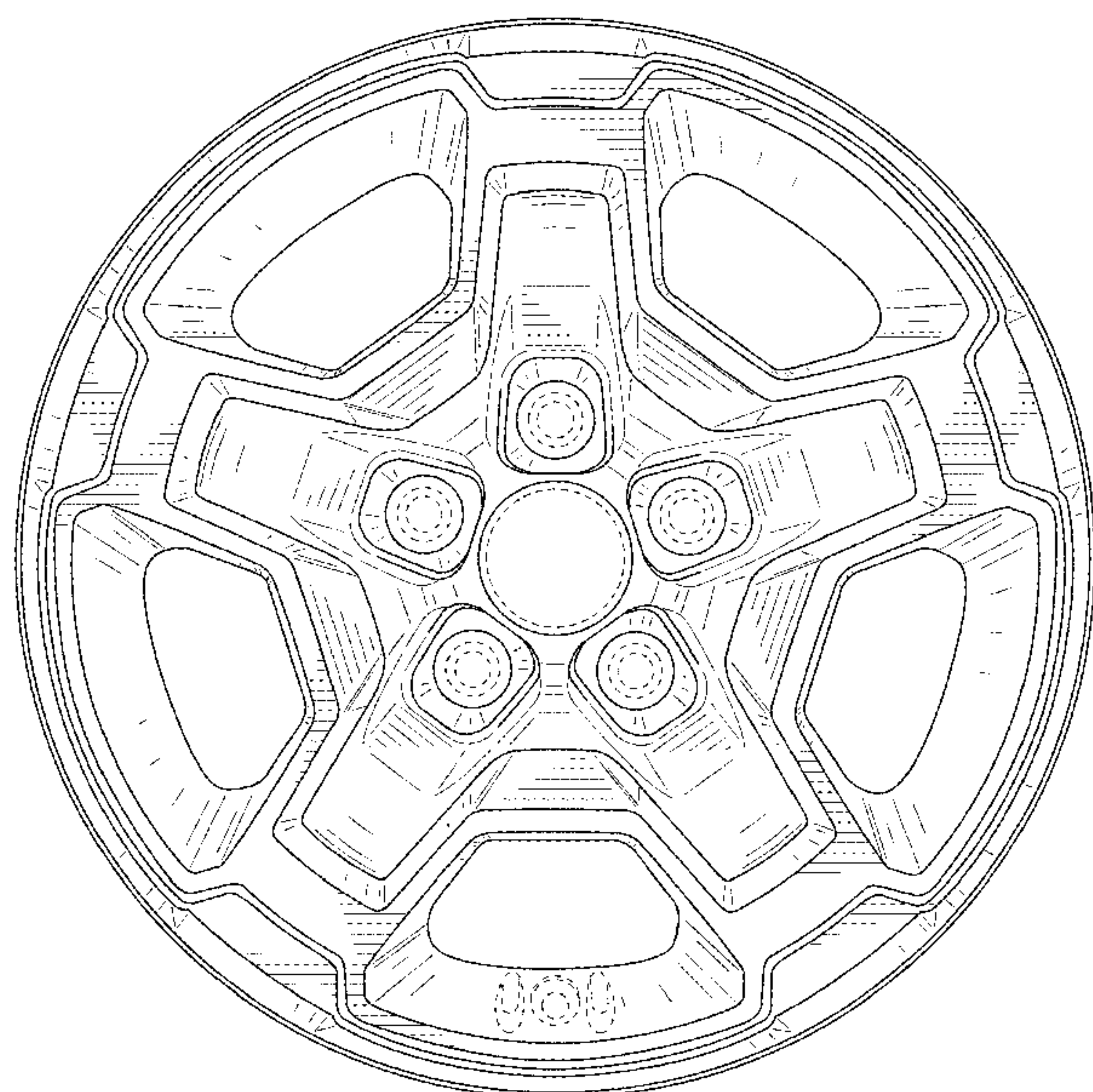
FIG. 1 is a front view of an automobile wheel showing my new design;

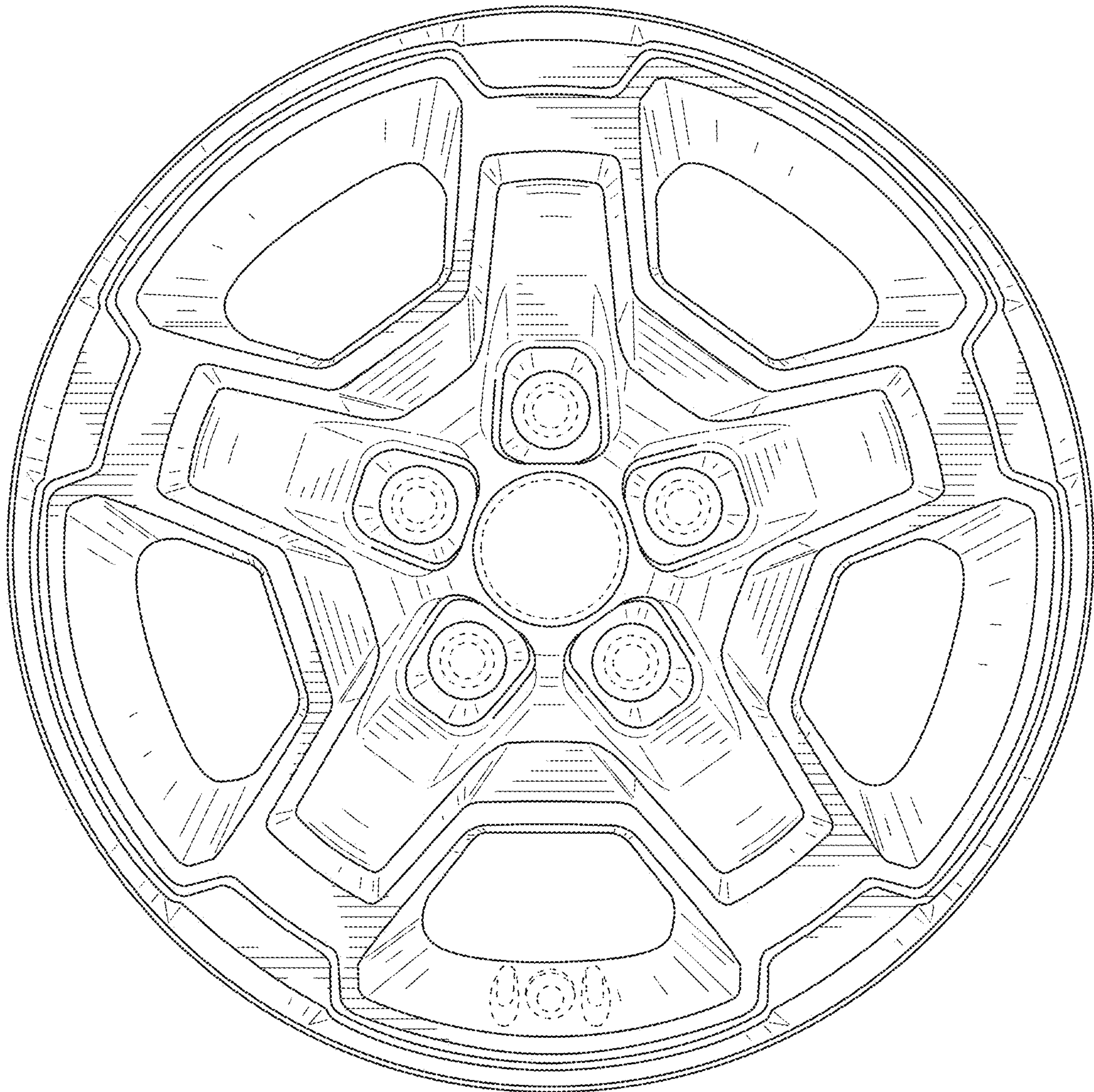

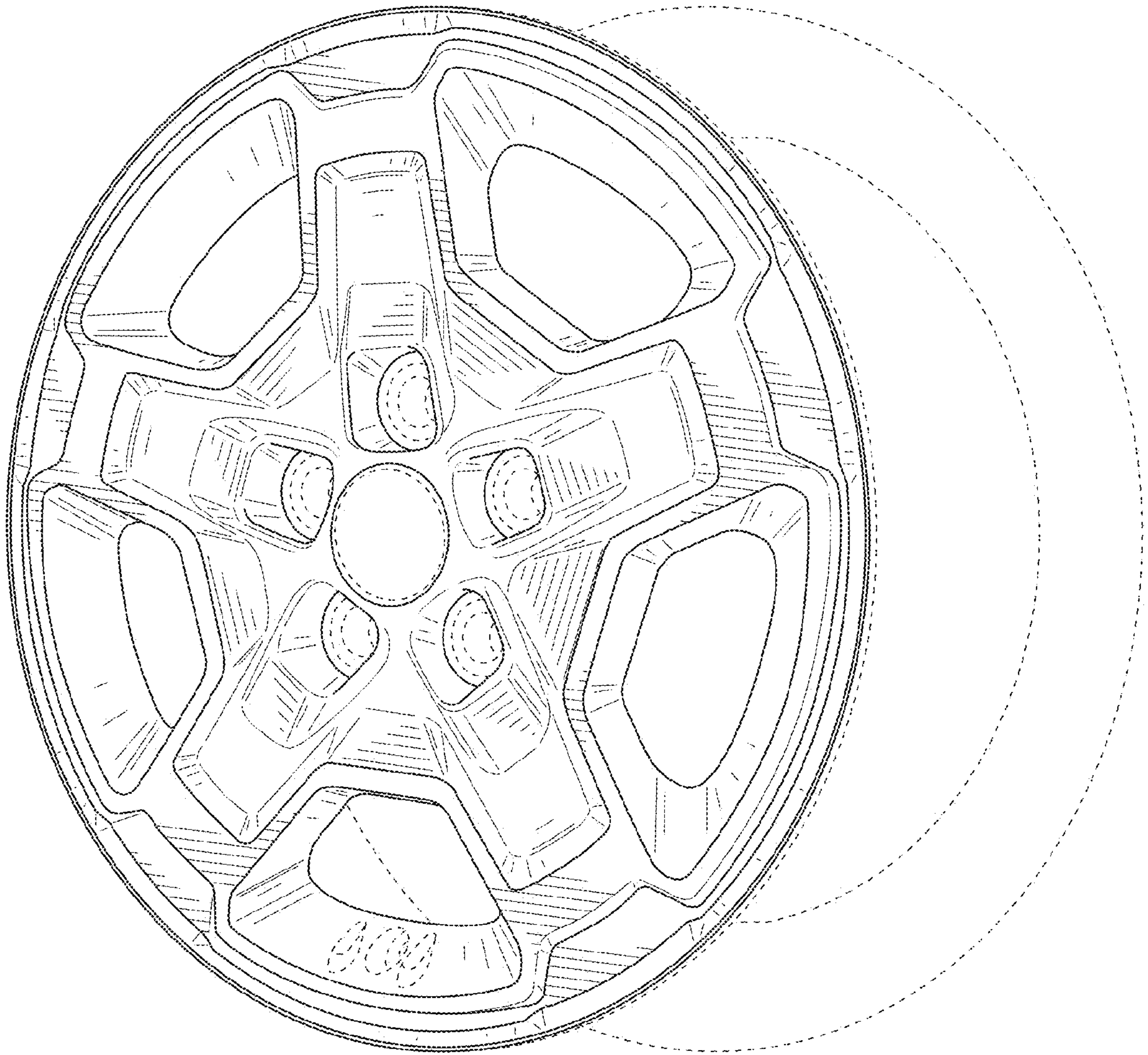

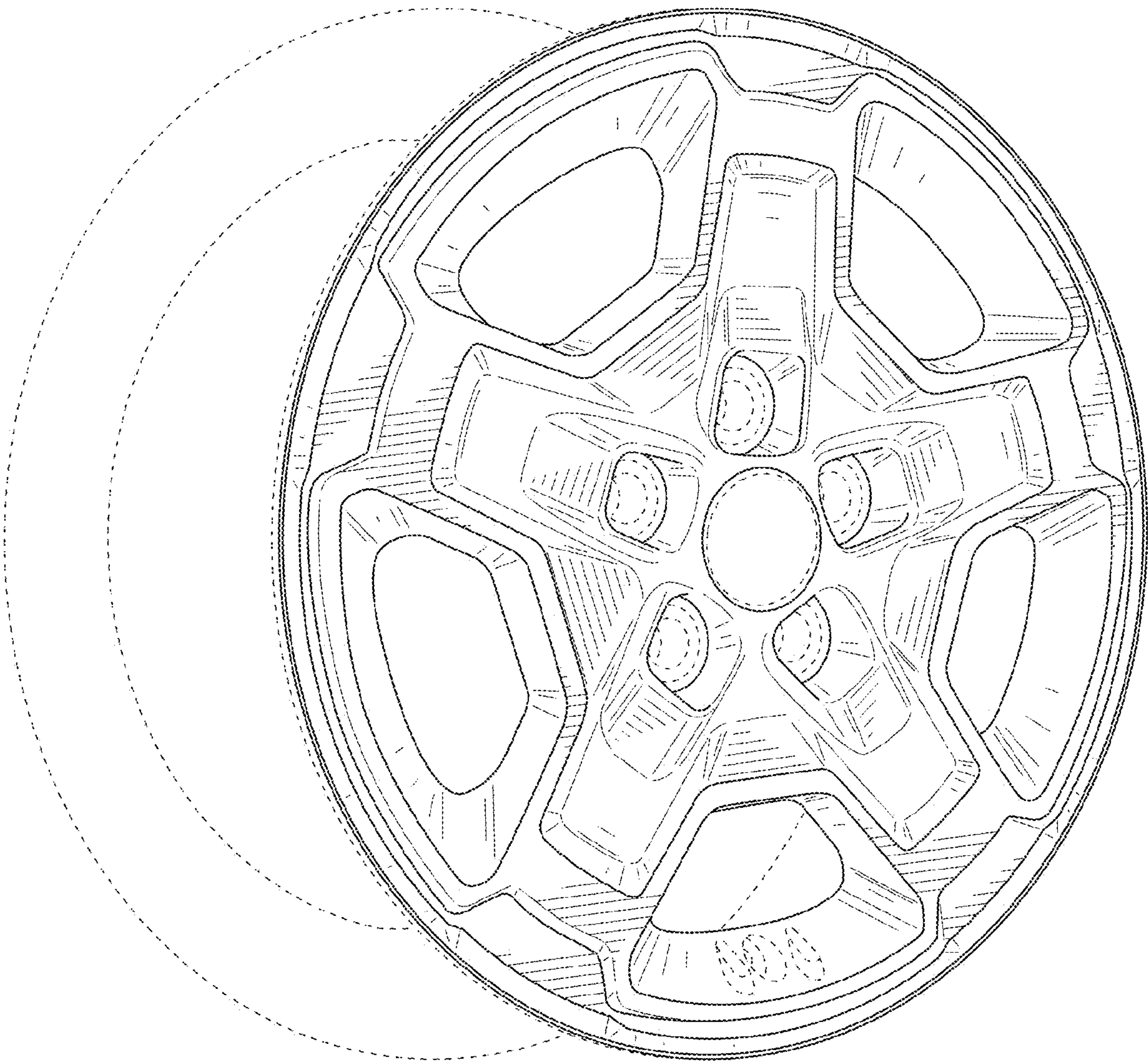
