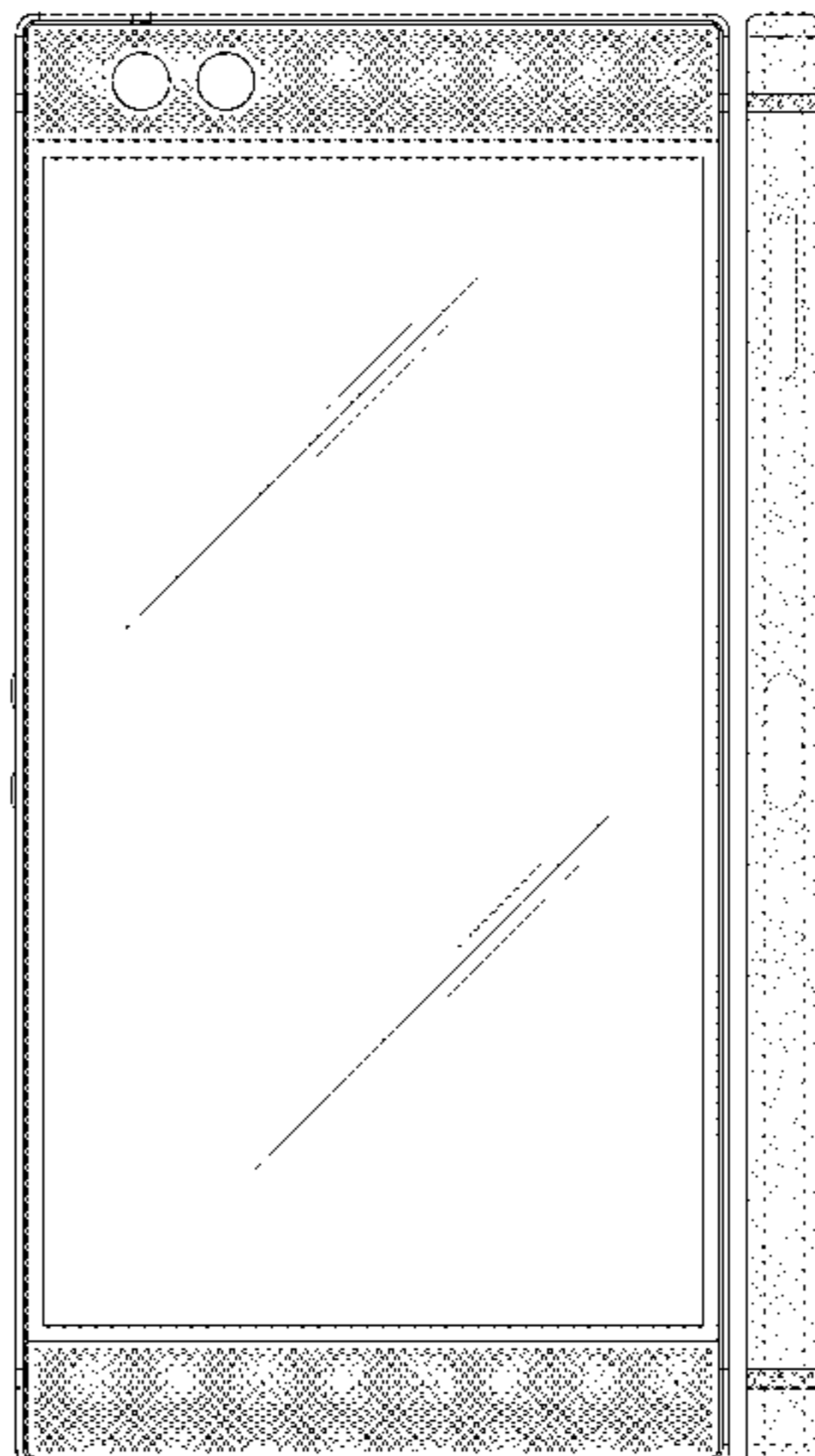


FIG. 30 is a front elevational view thereof;

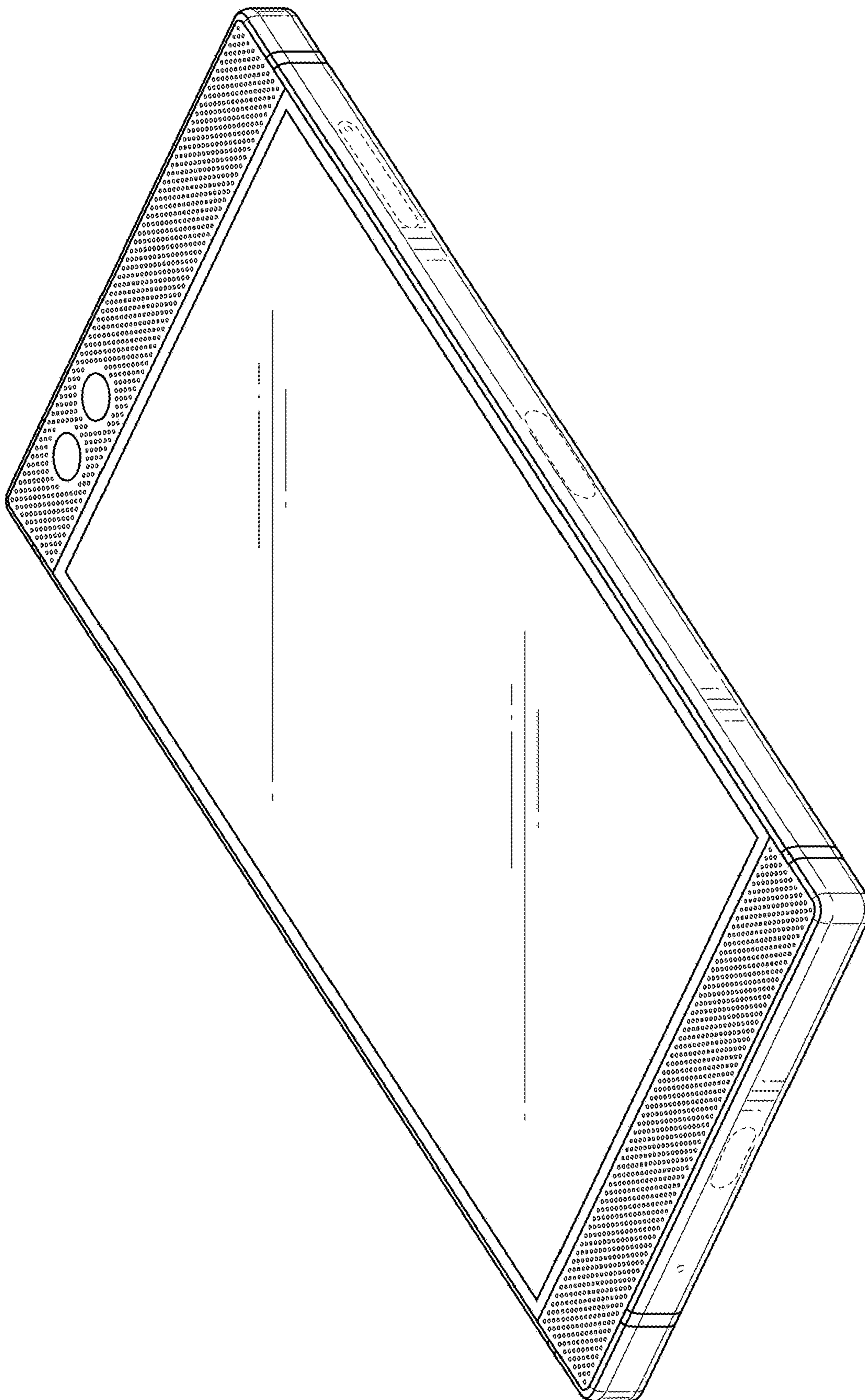

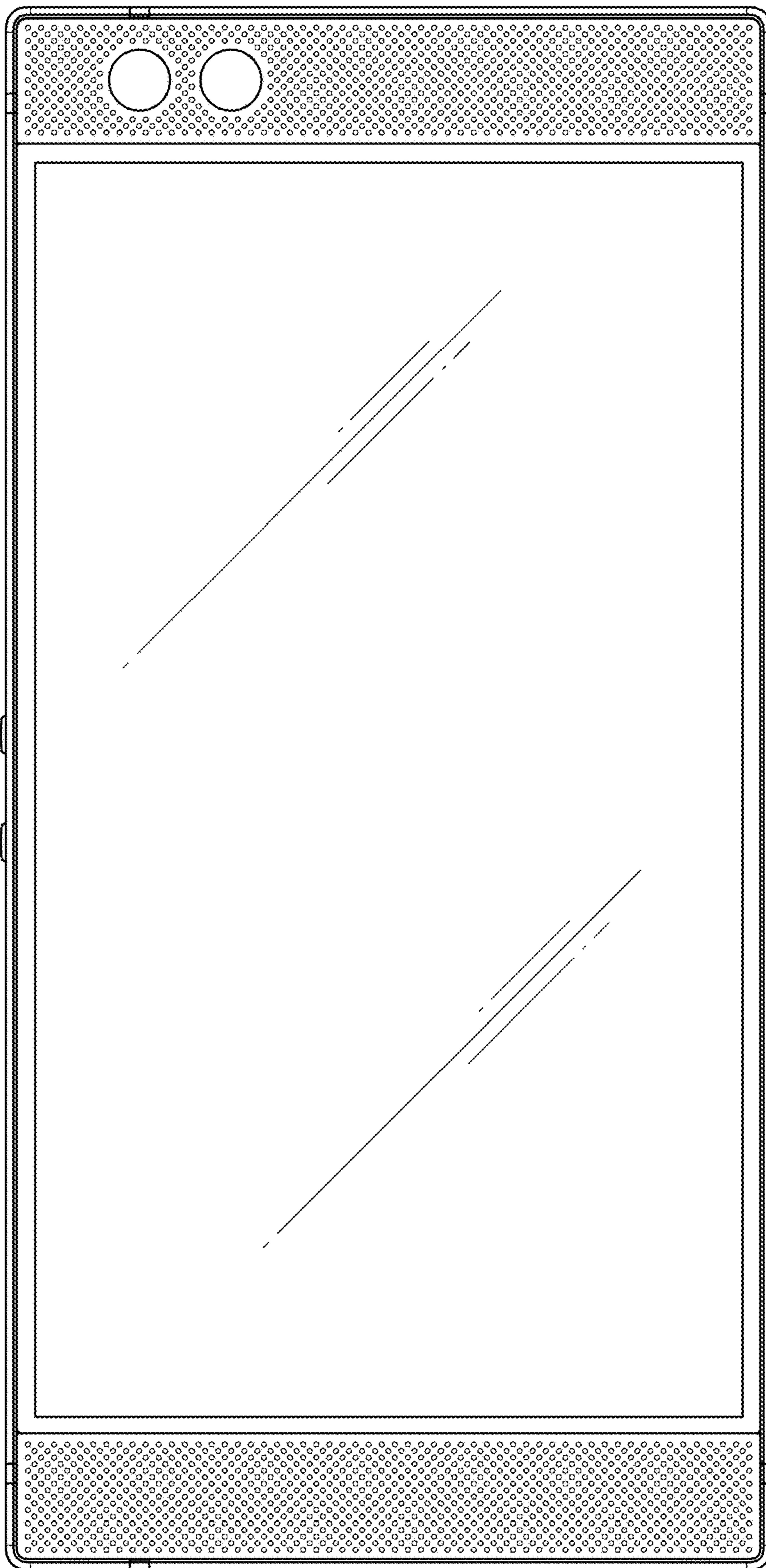

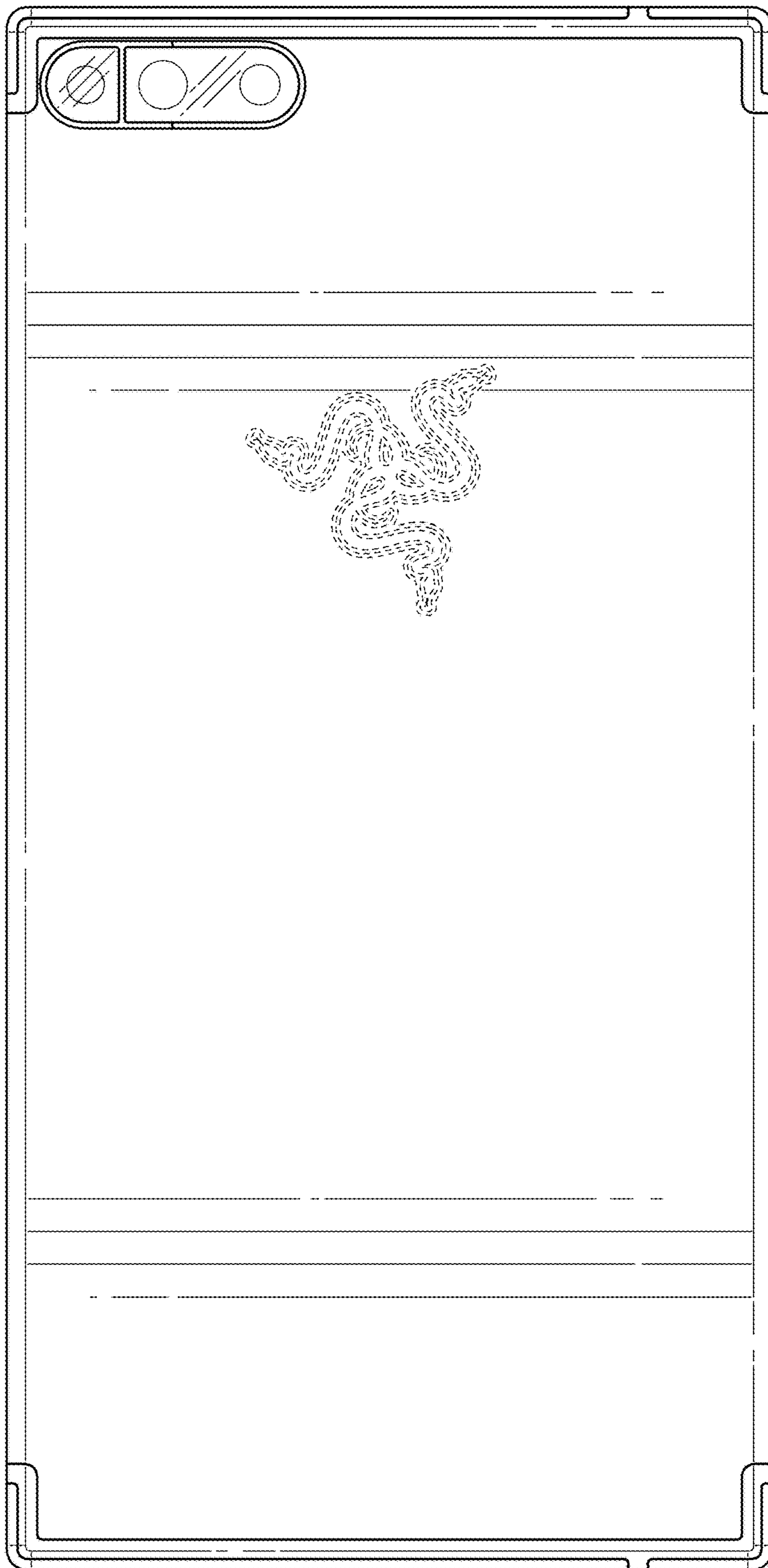

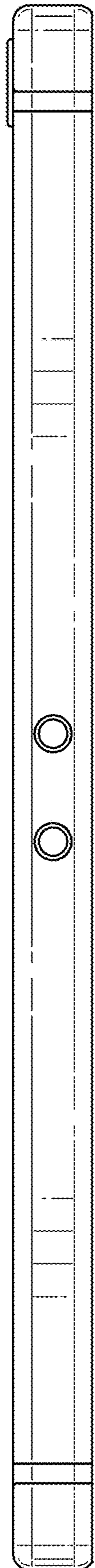

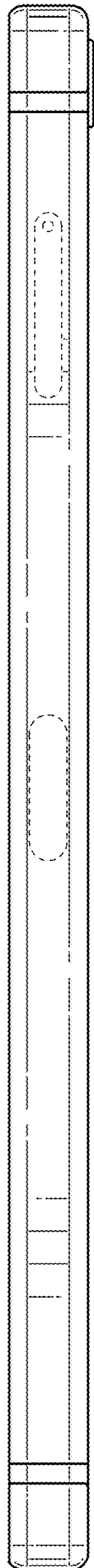

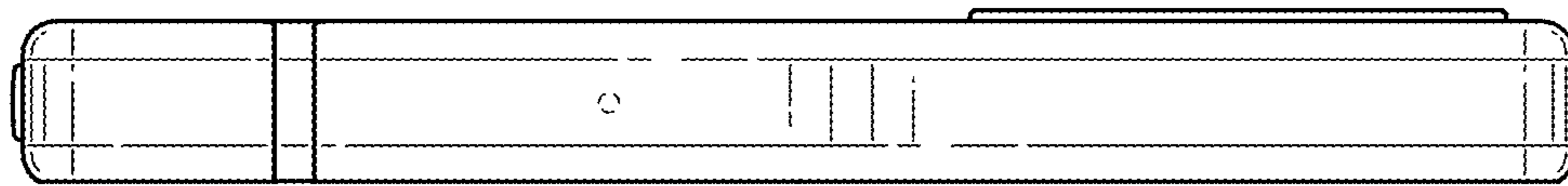

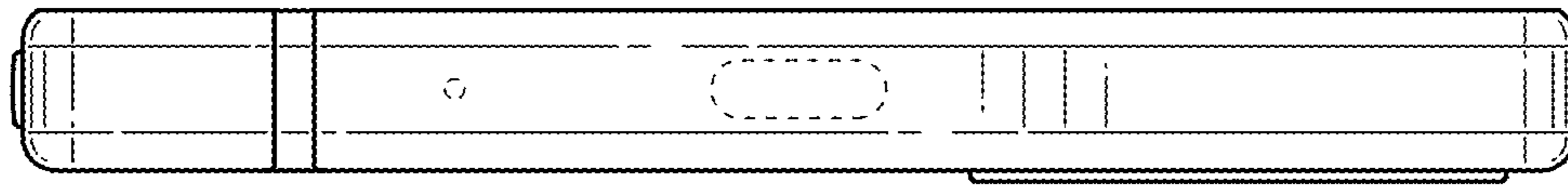

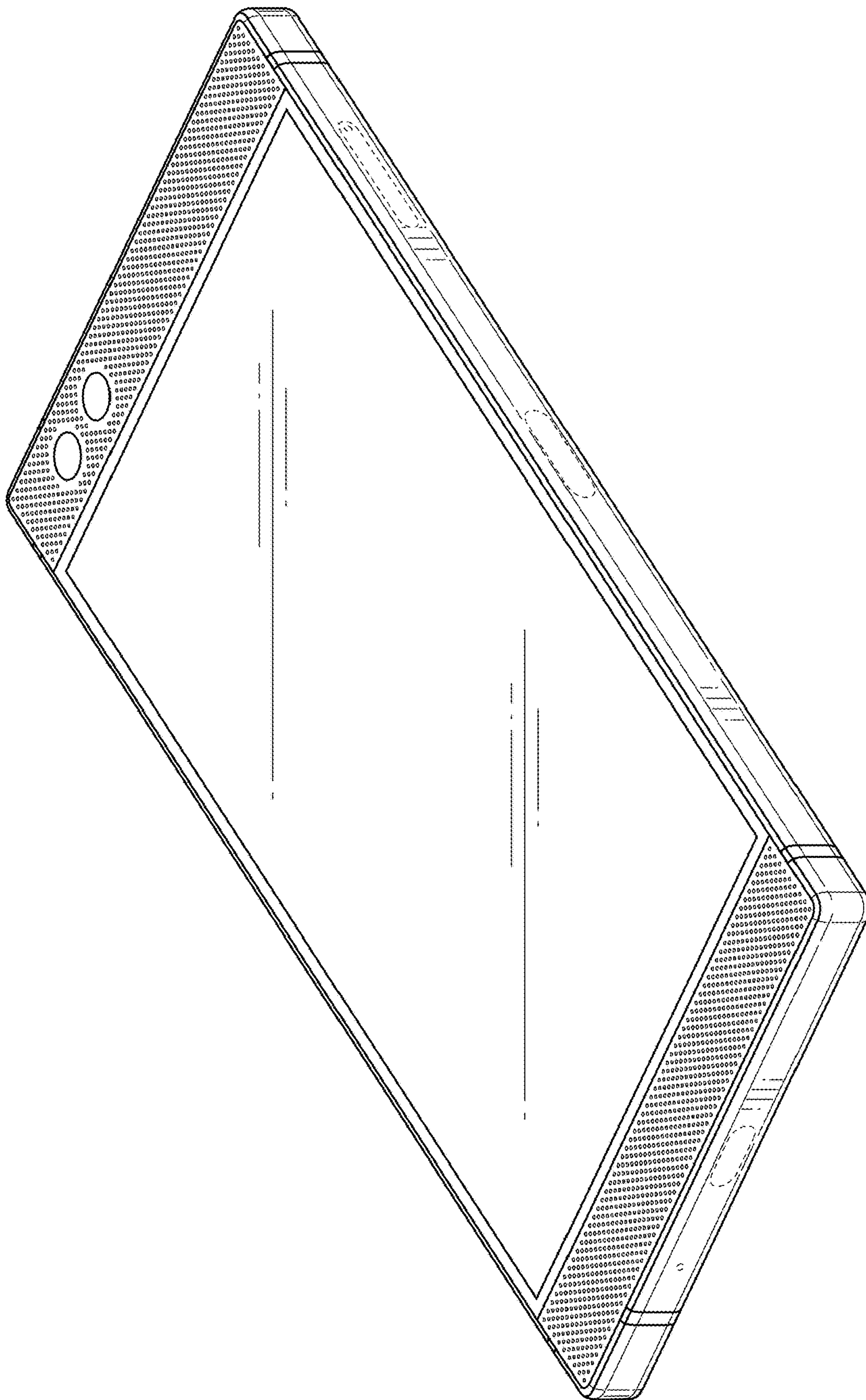

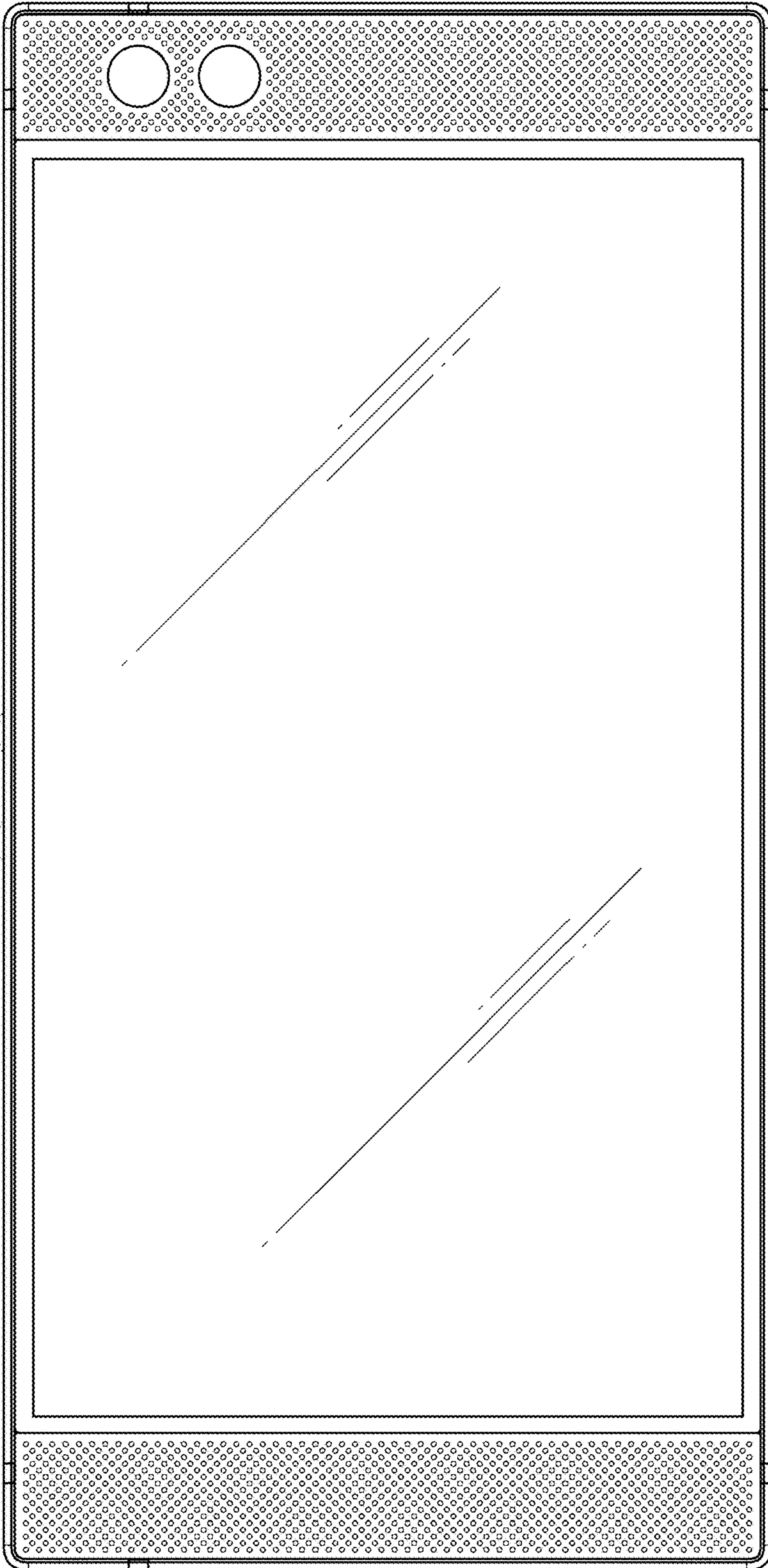

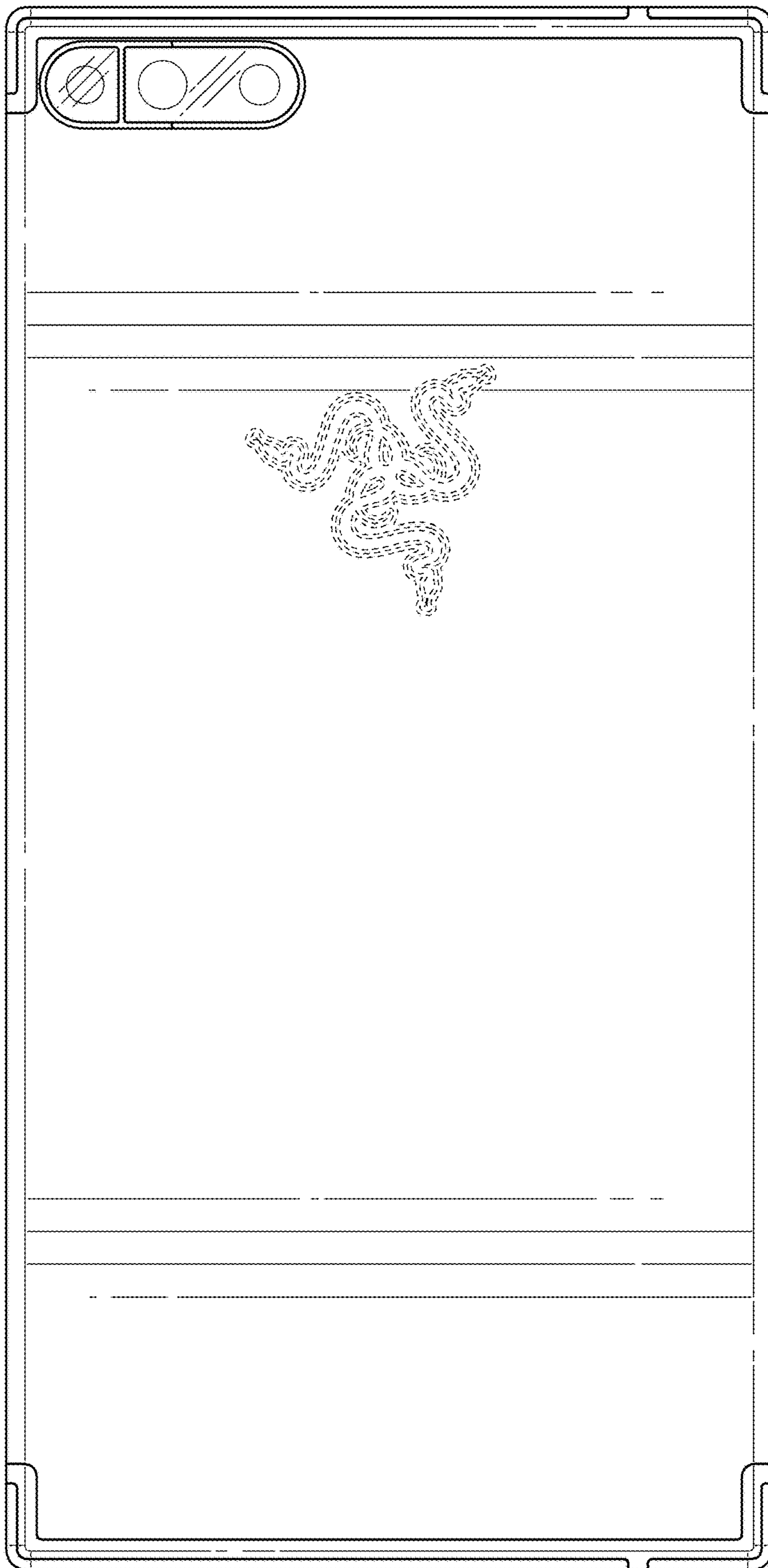

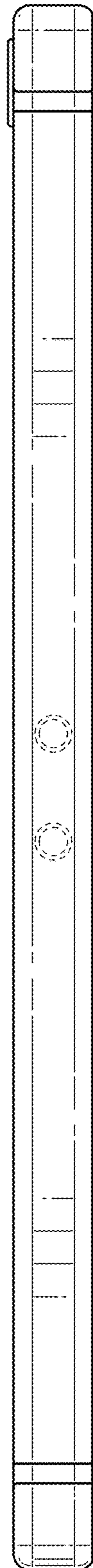

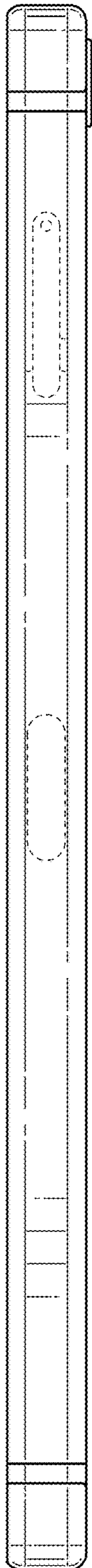

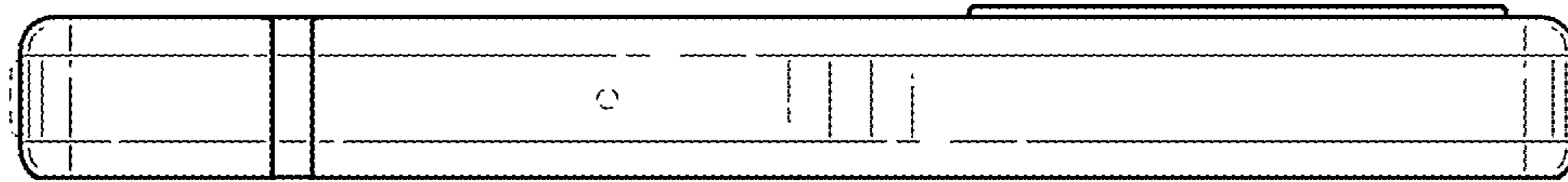

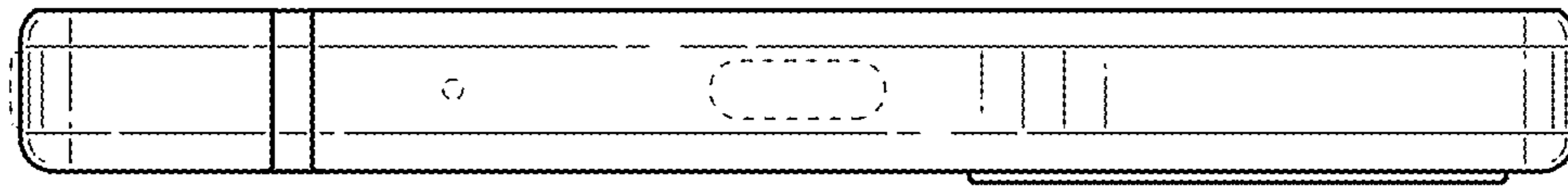

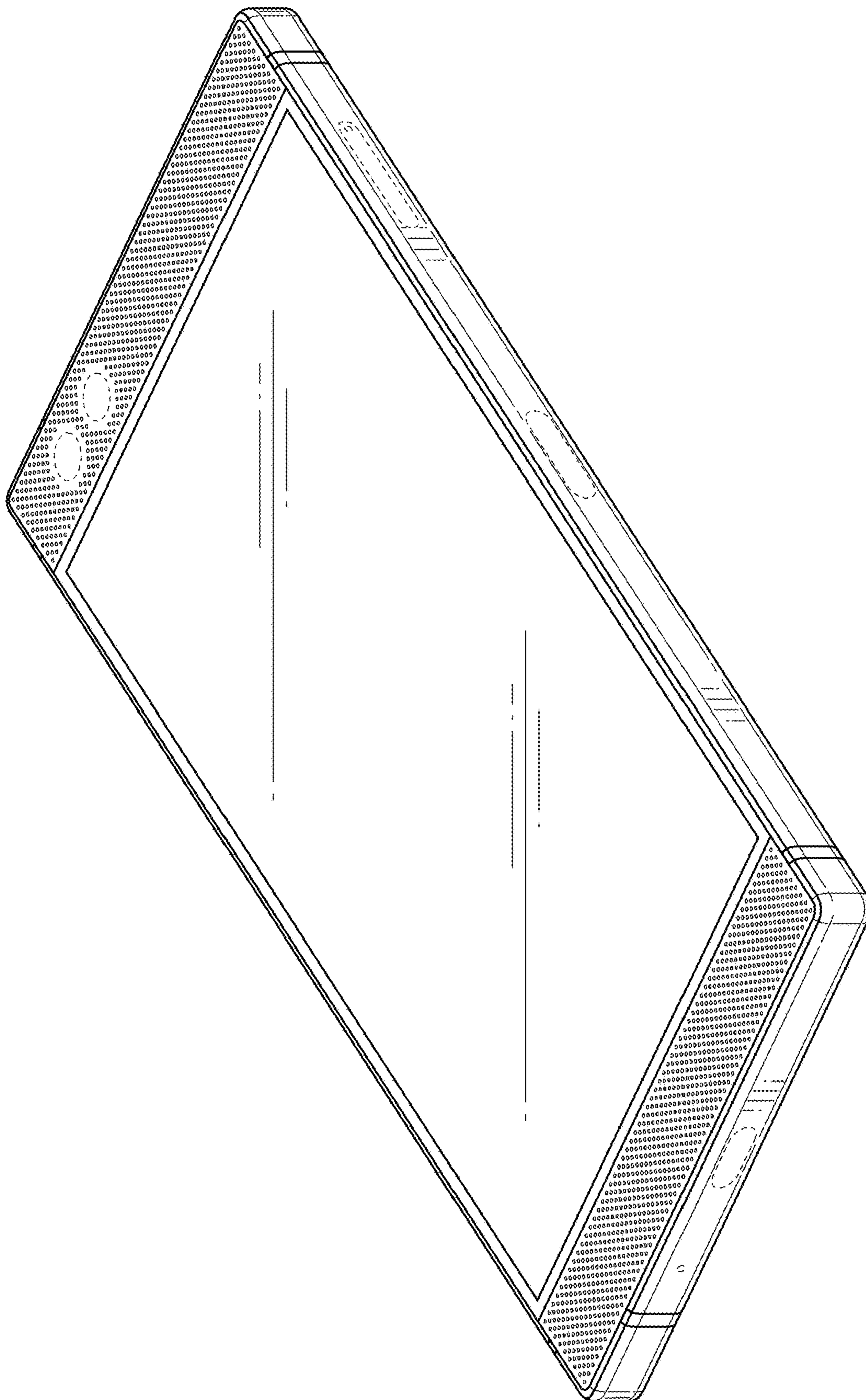

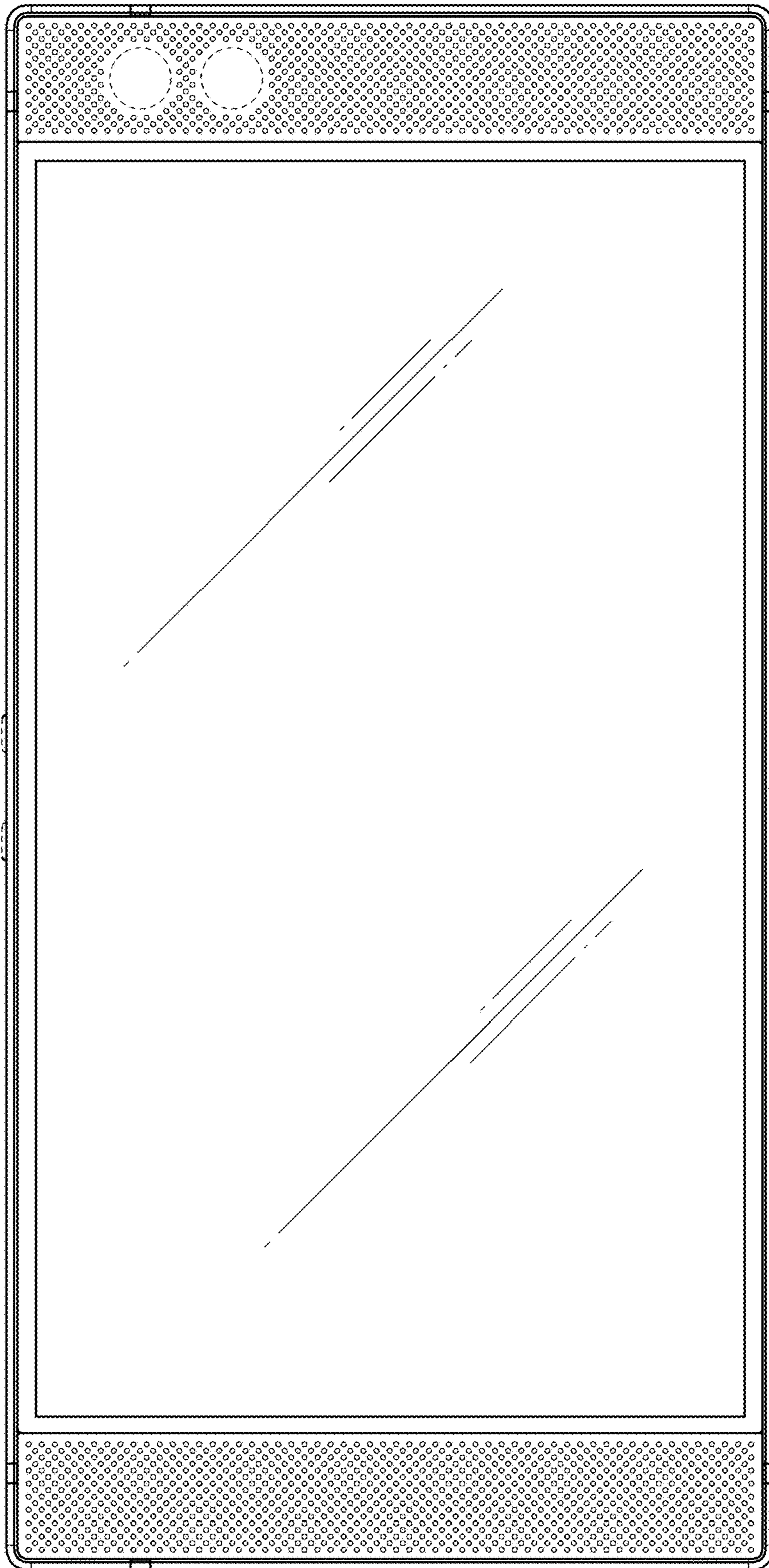

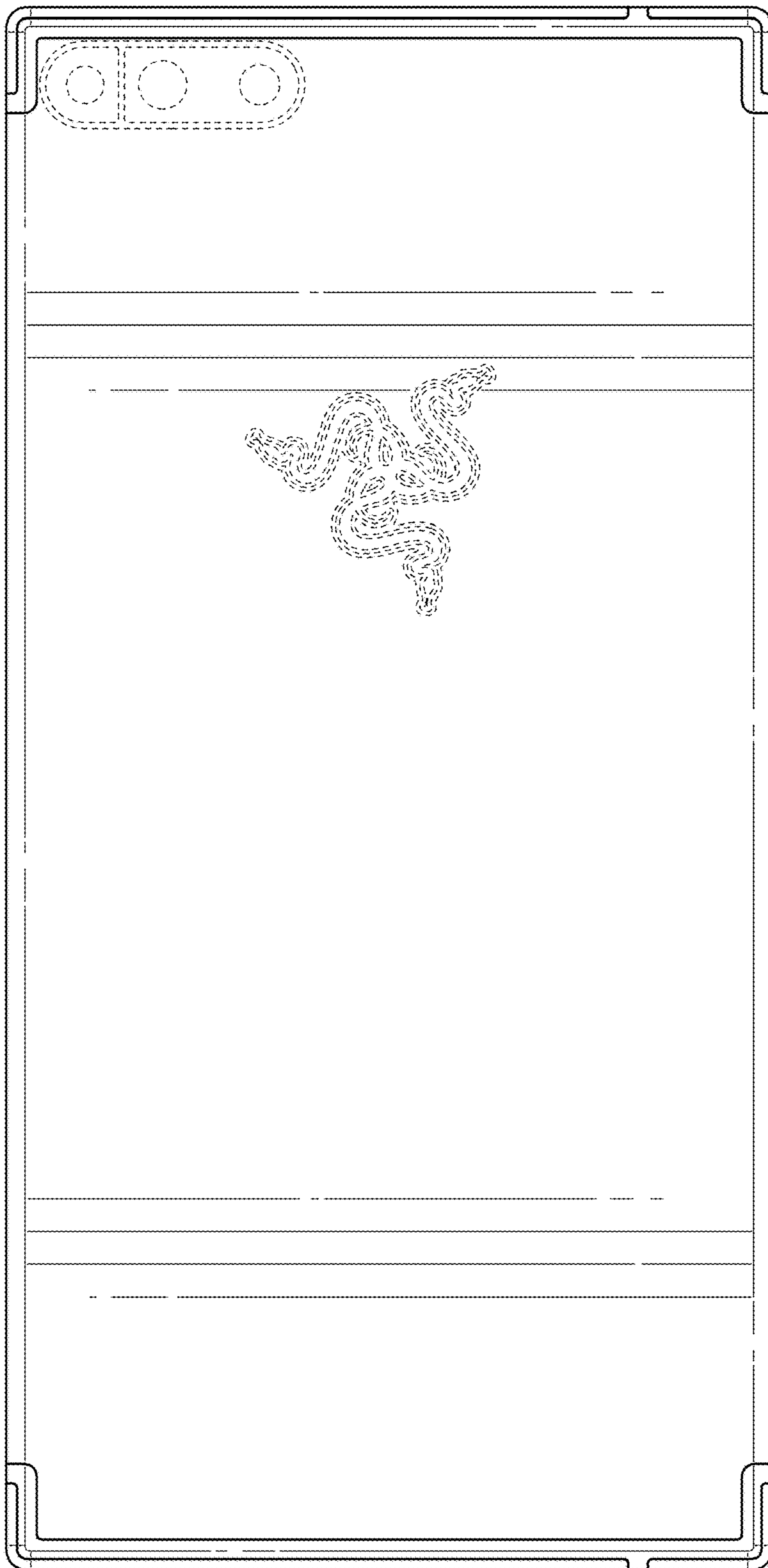

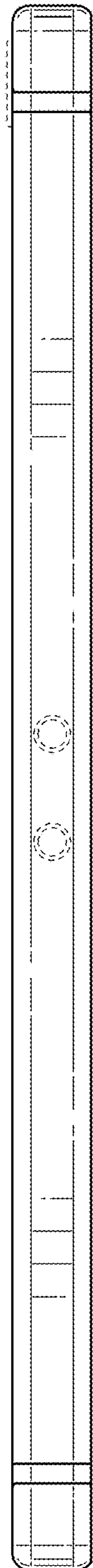

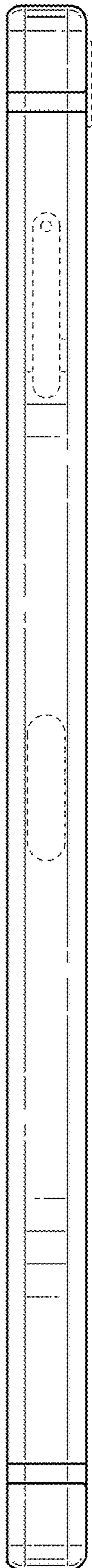

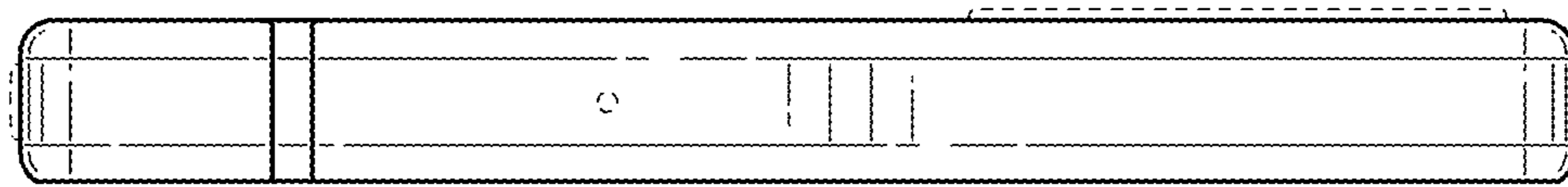

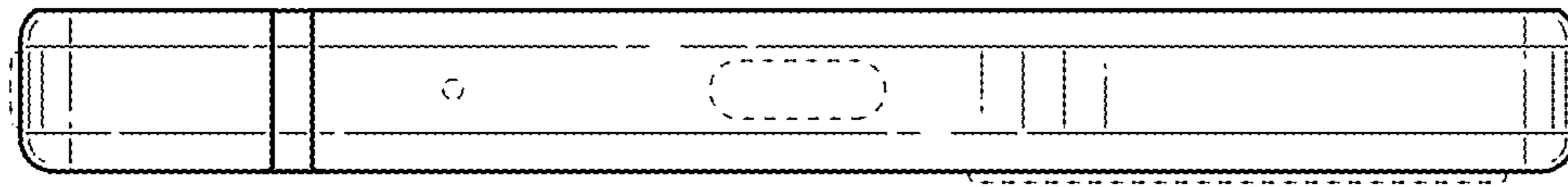

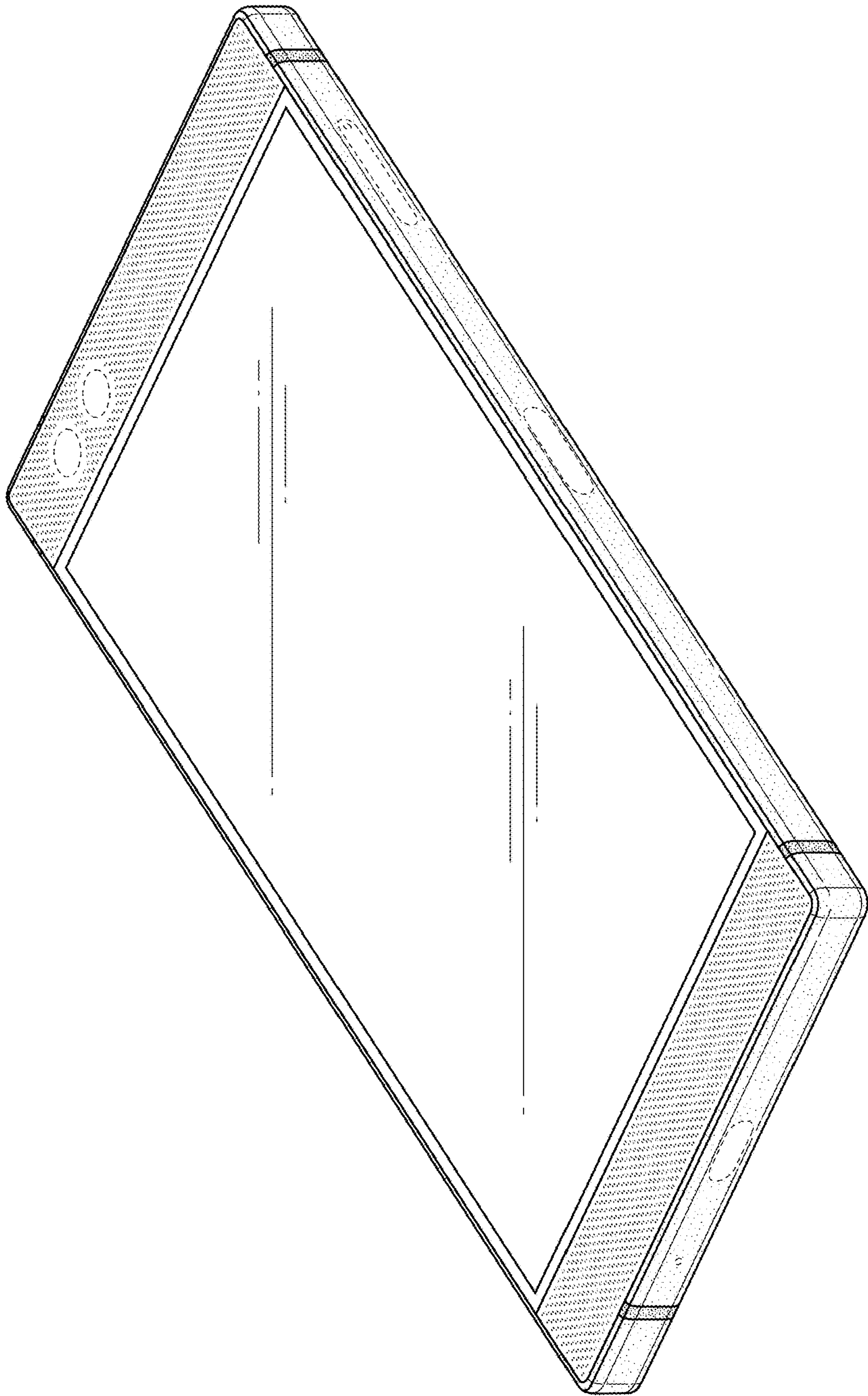

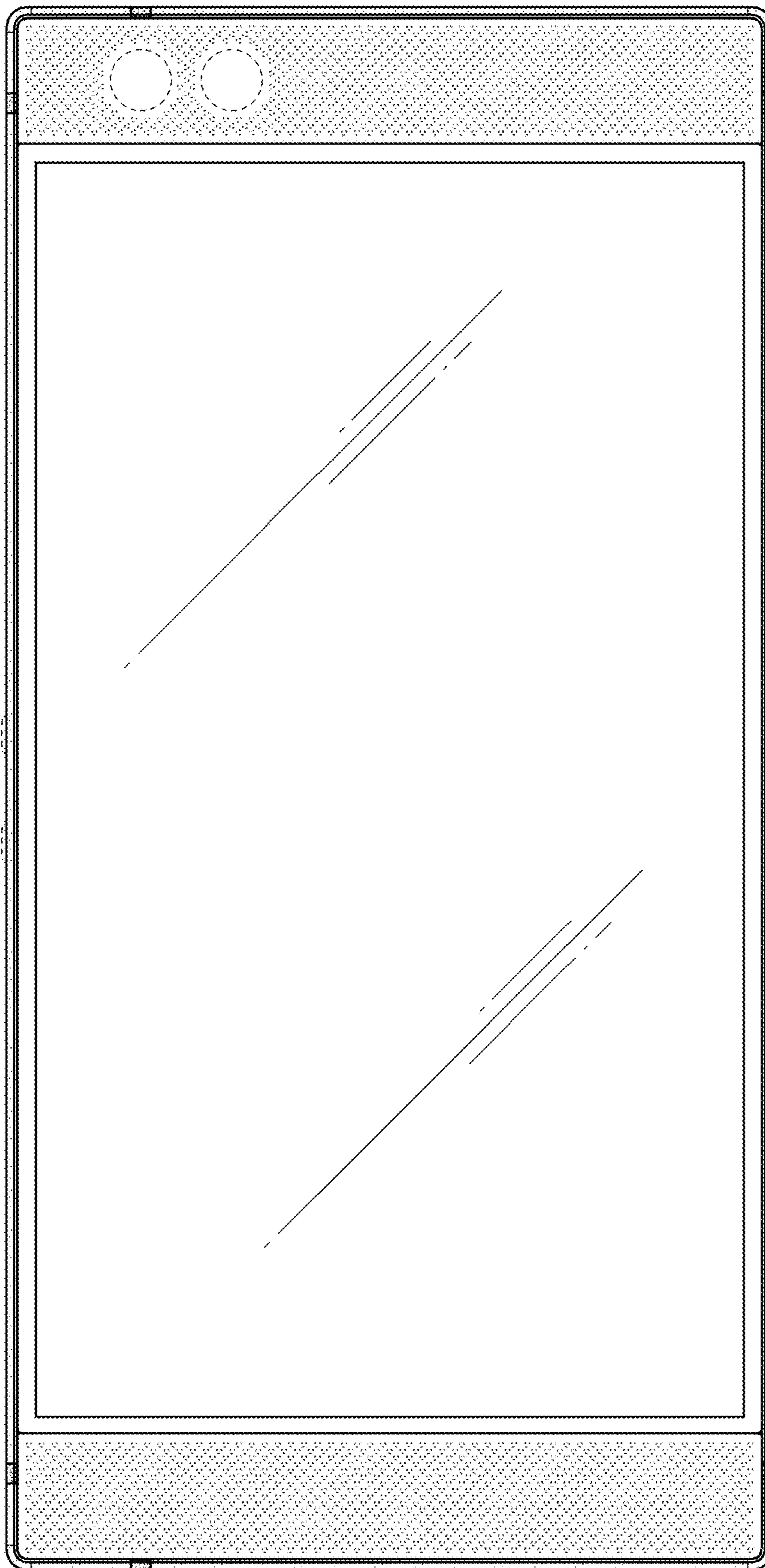

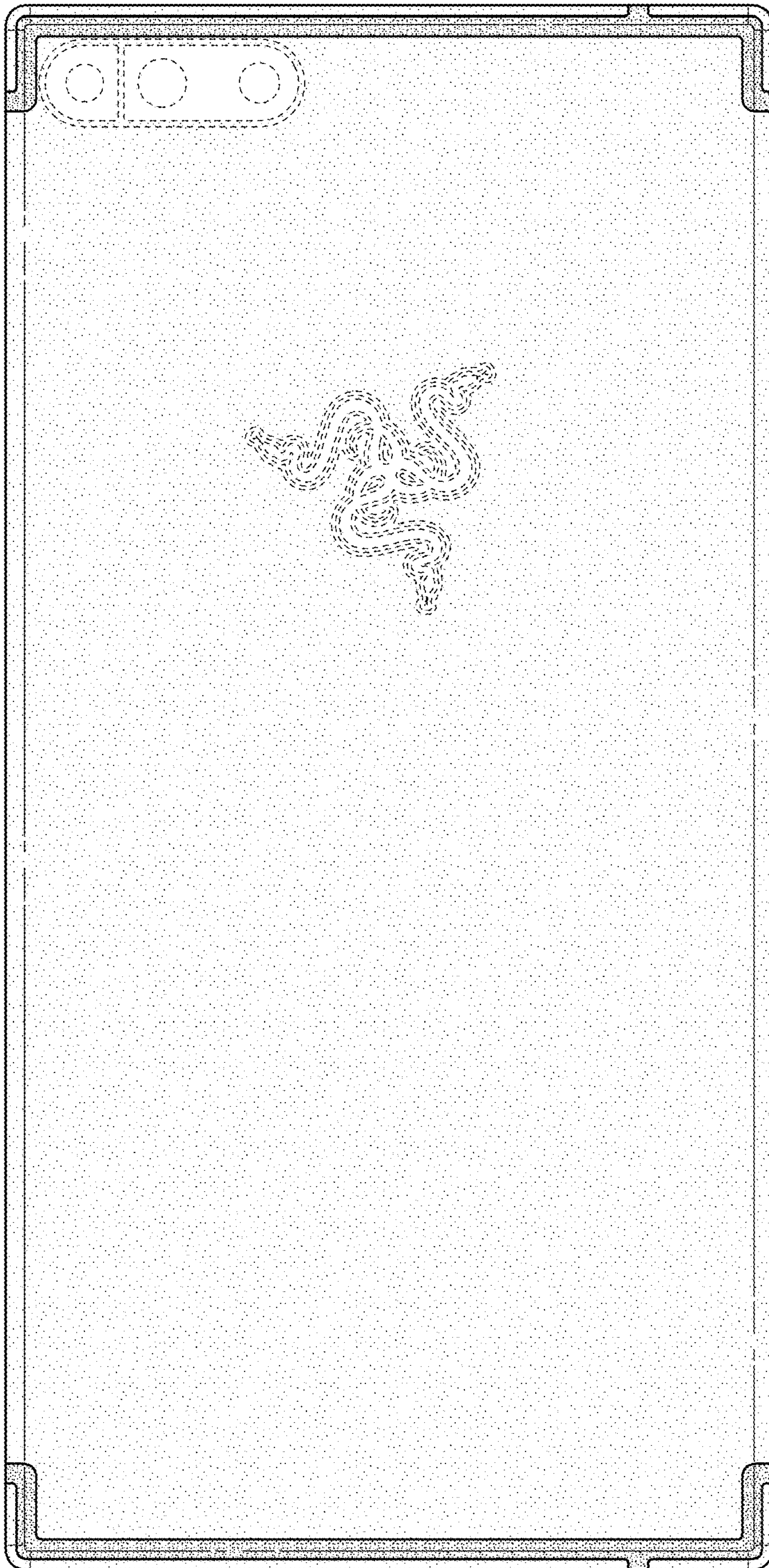

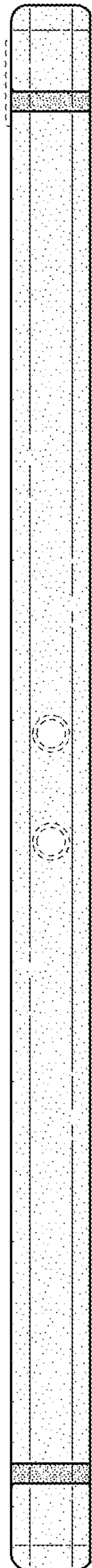

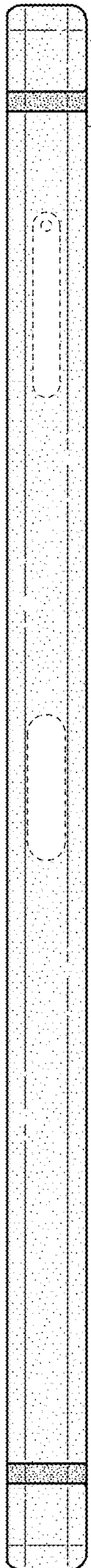

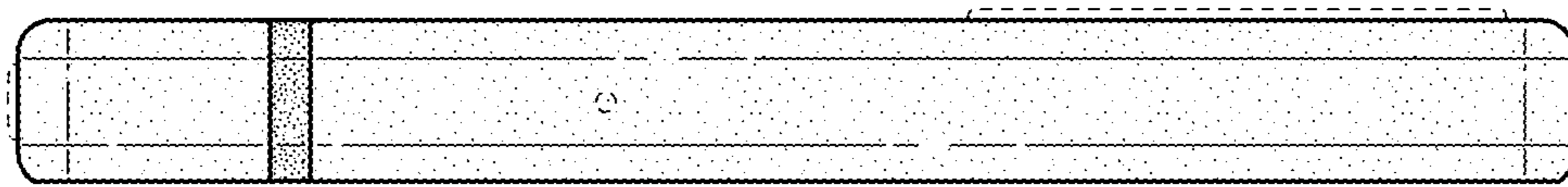

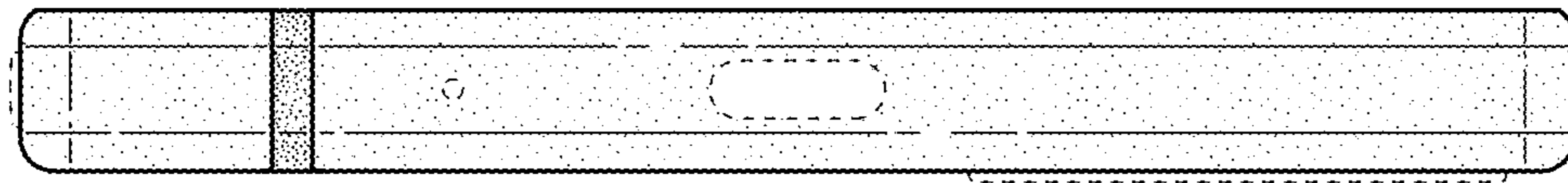

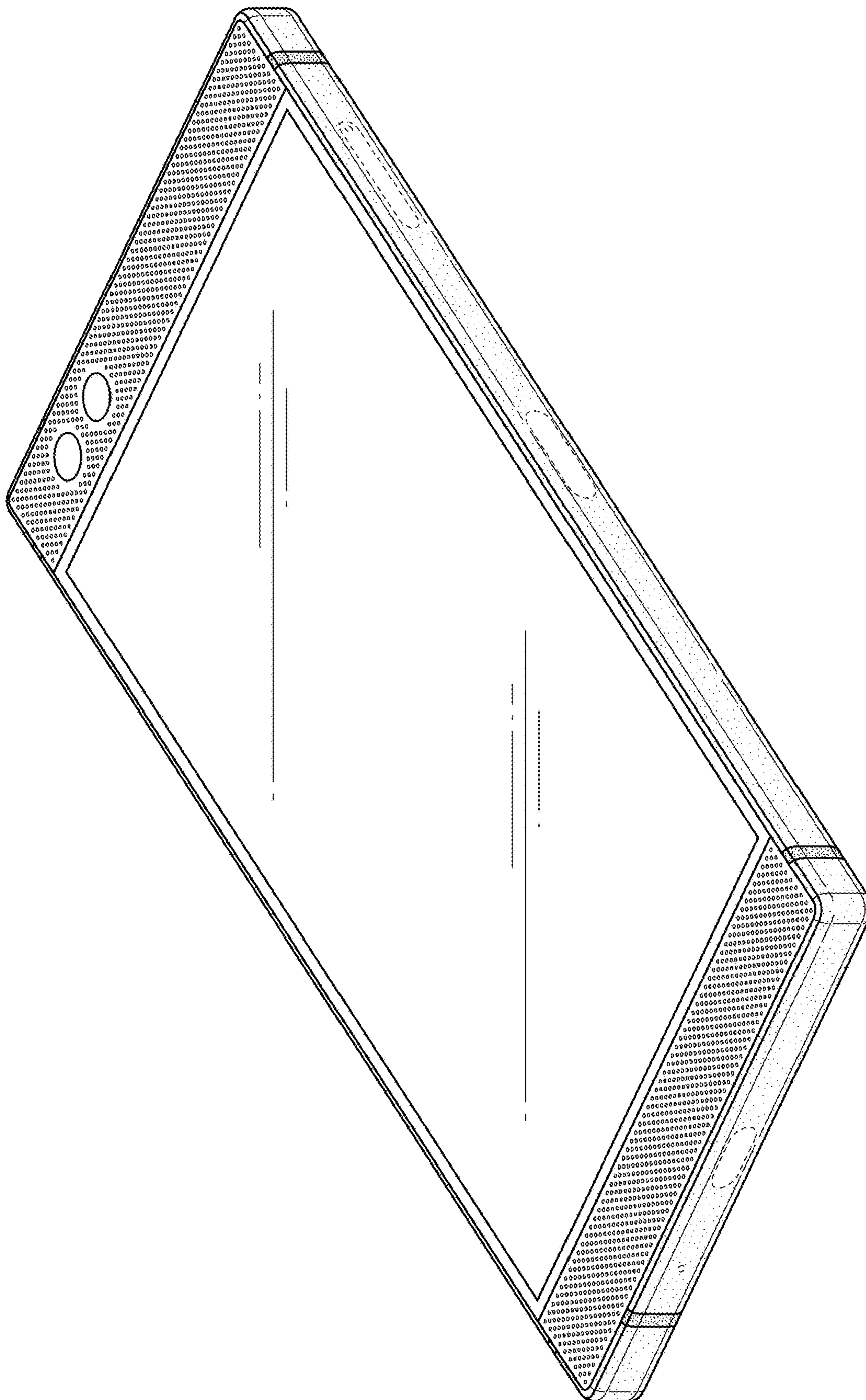

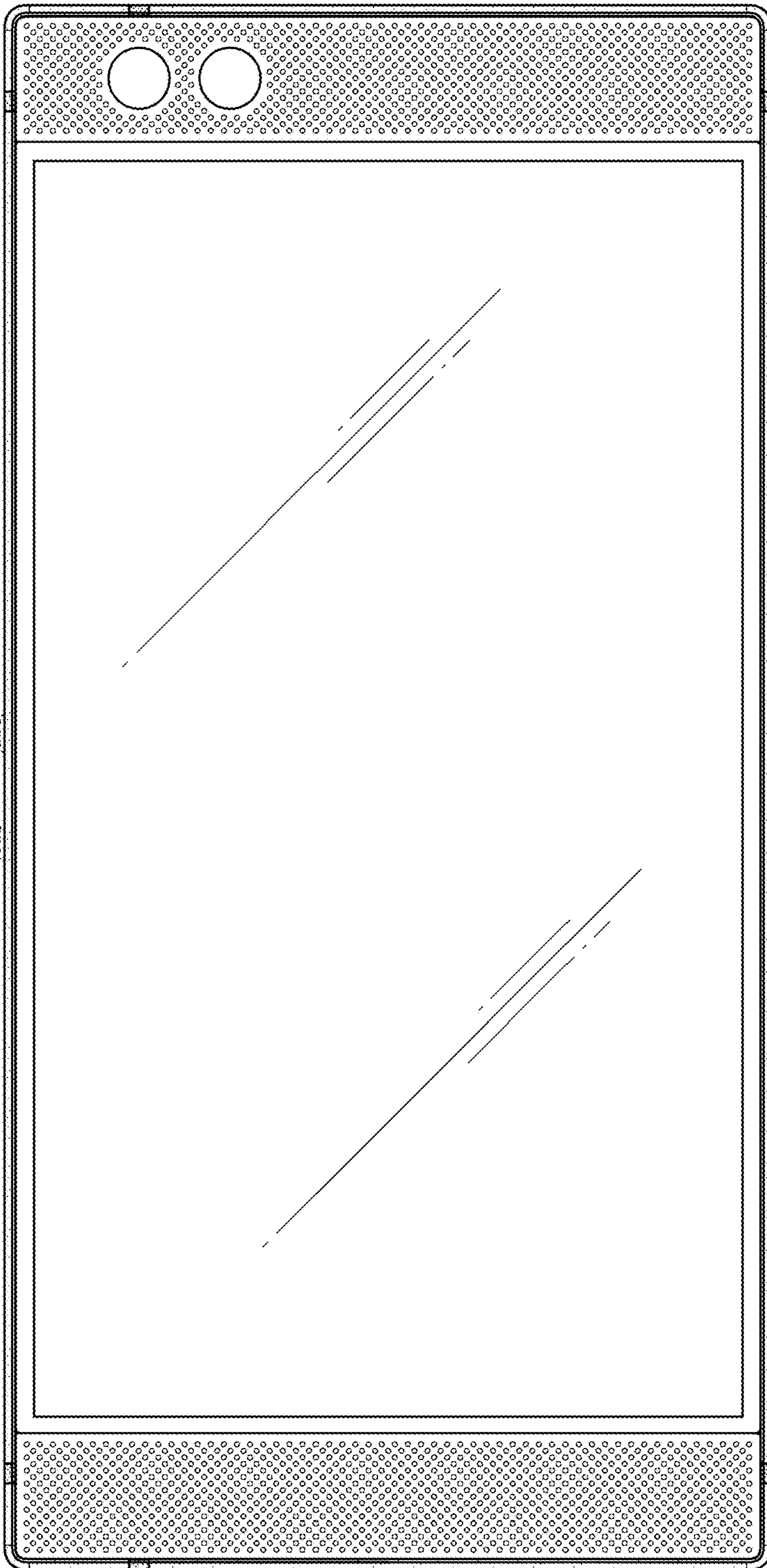

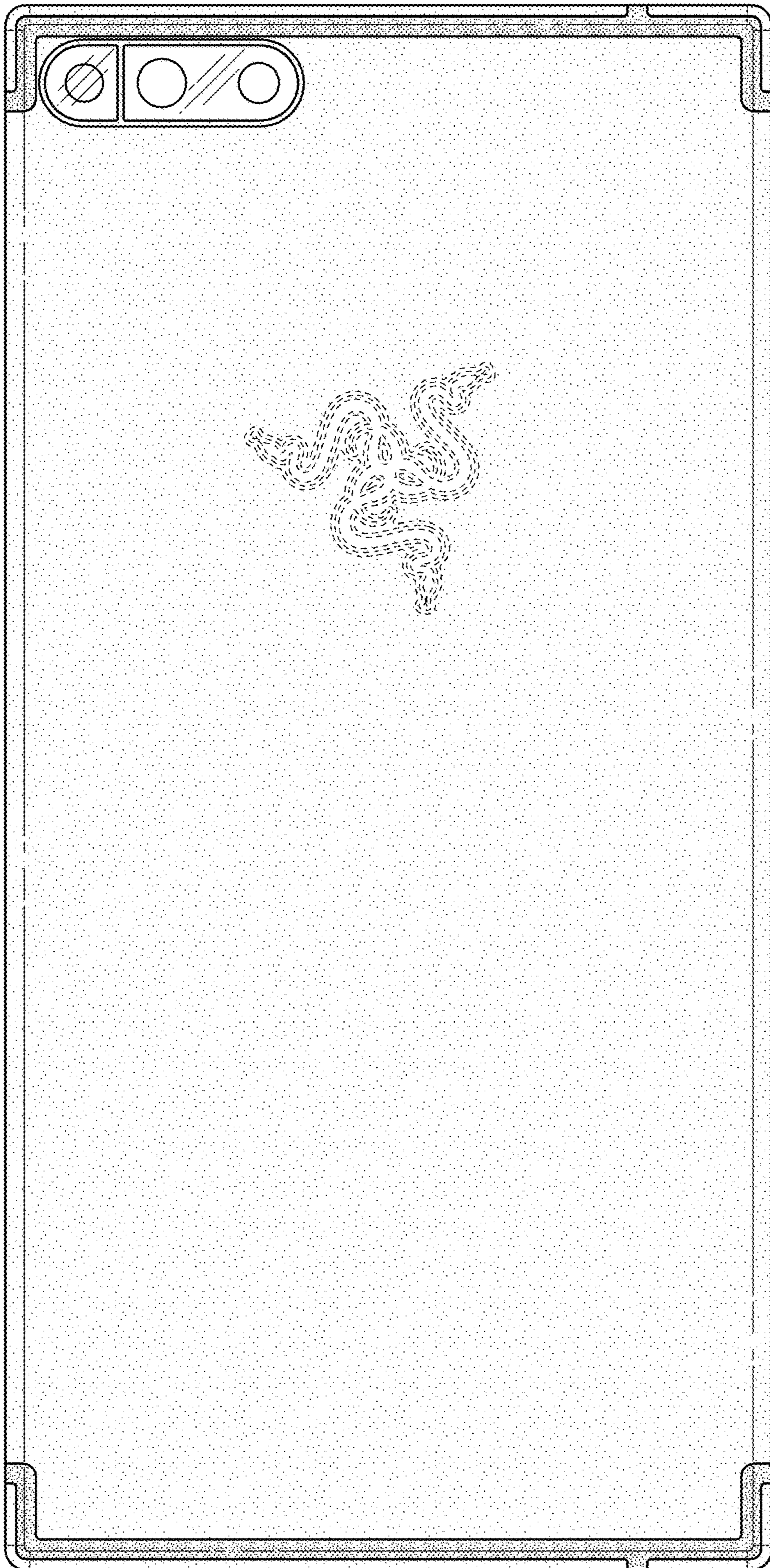

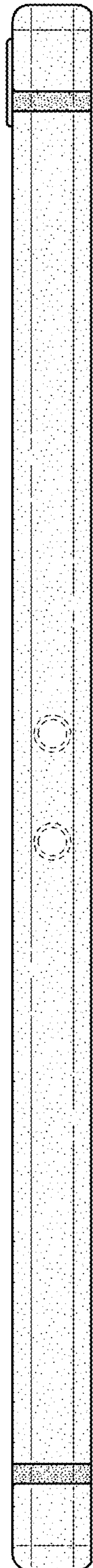

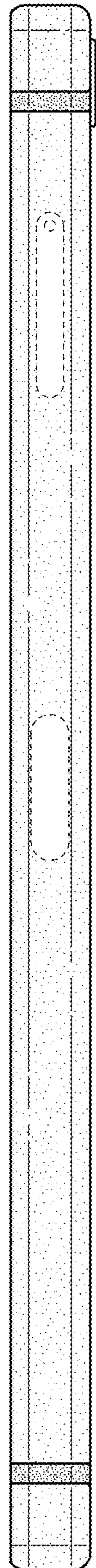

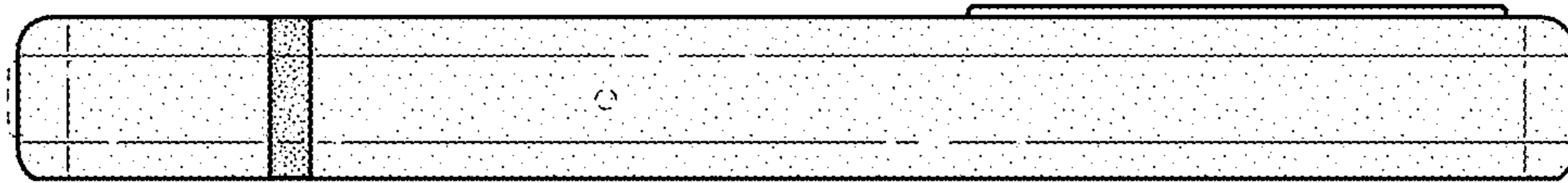

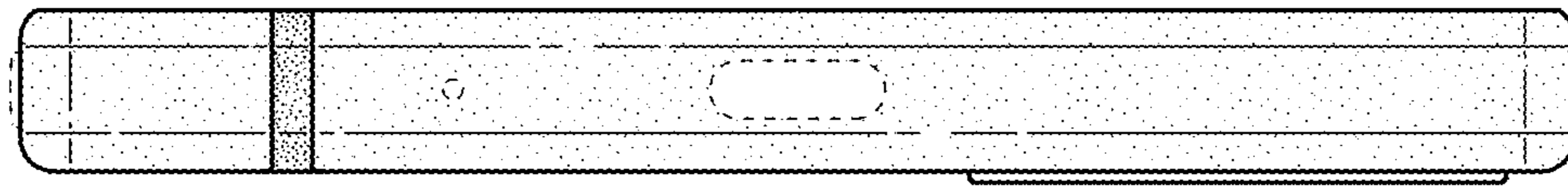

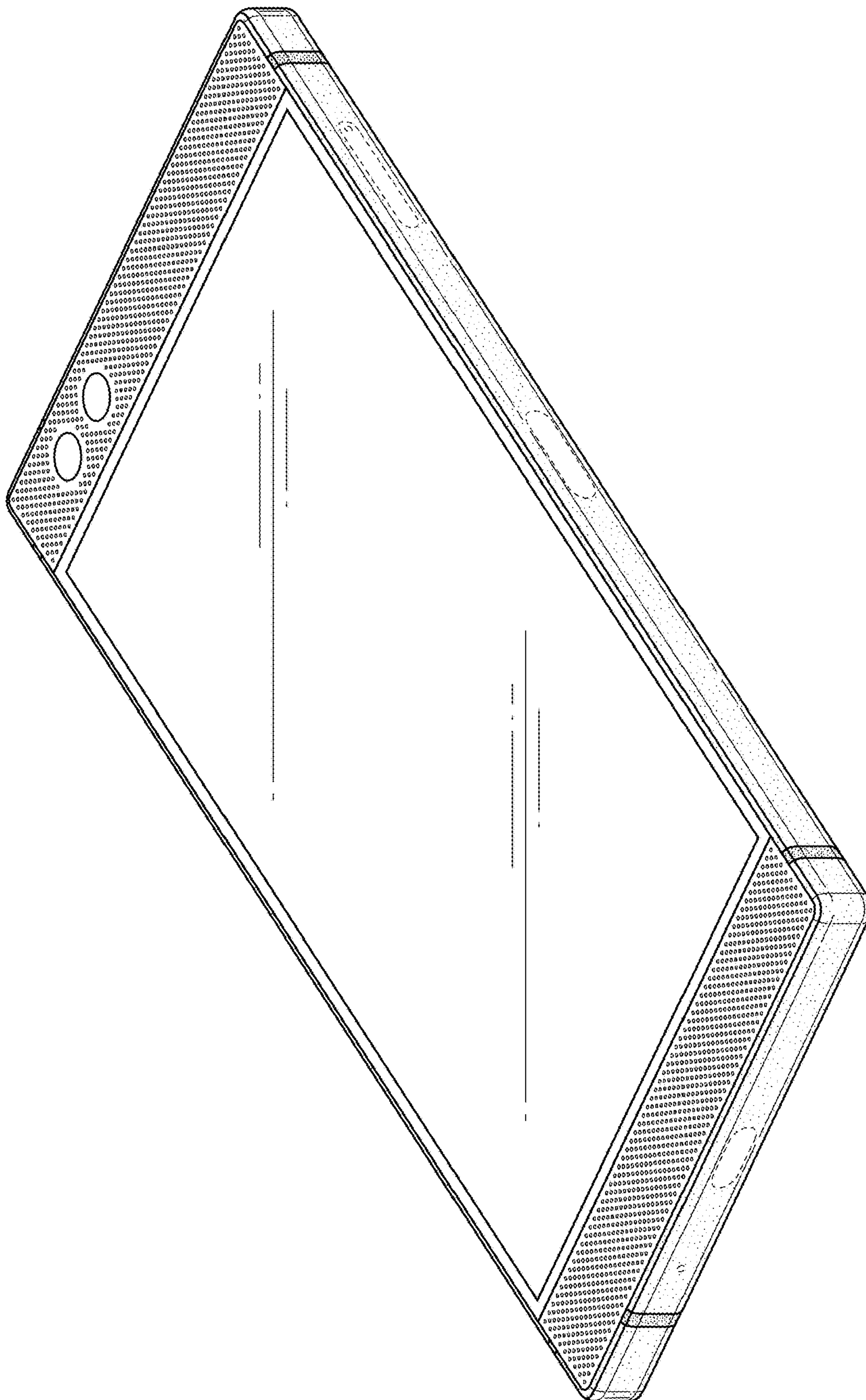

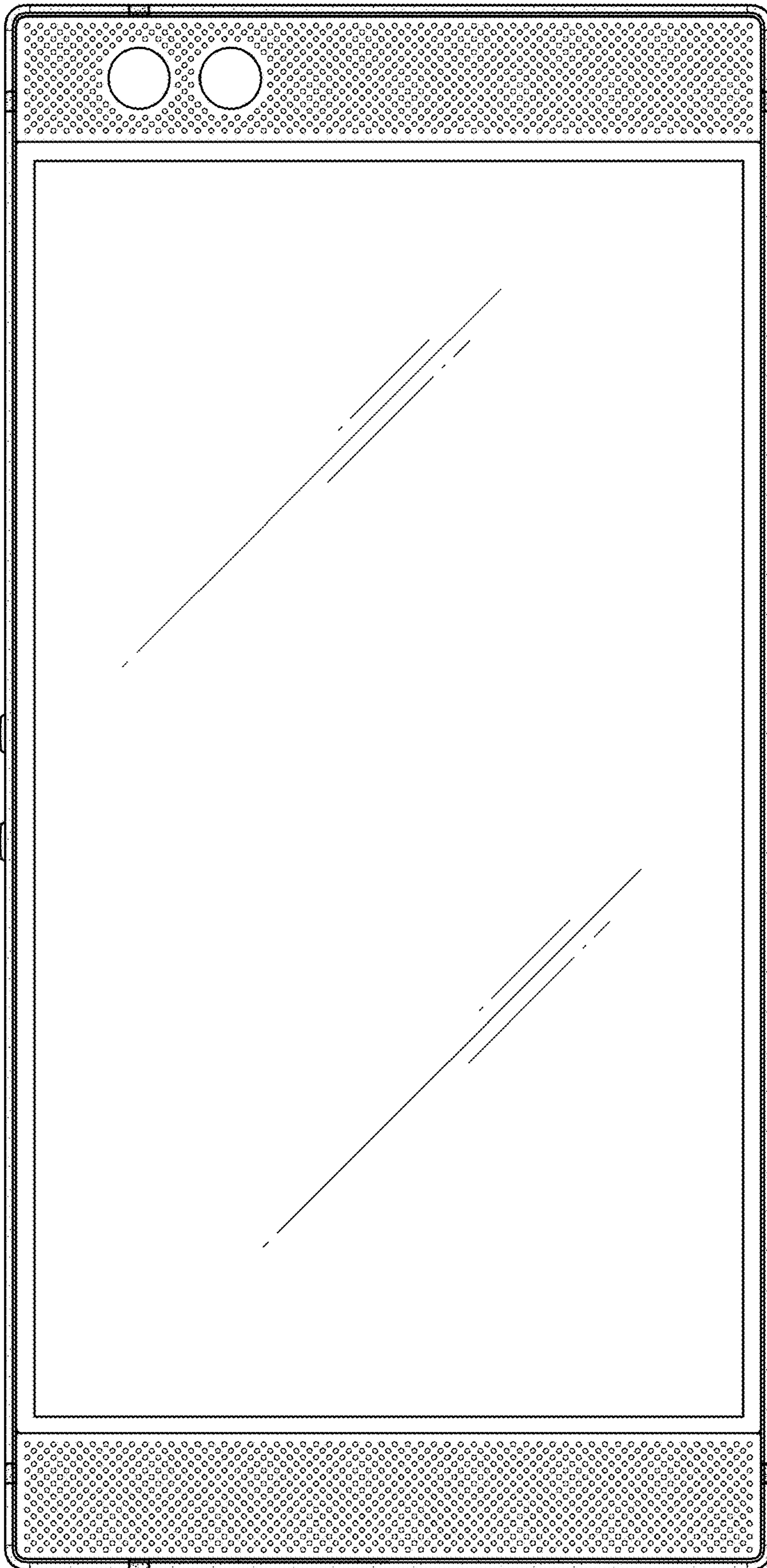

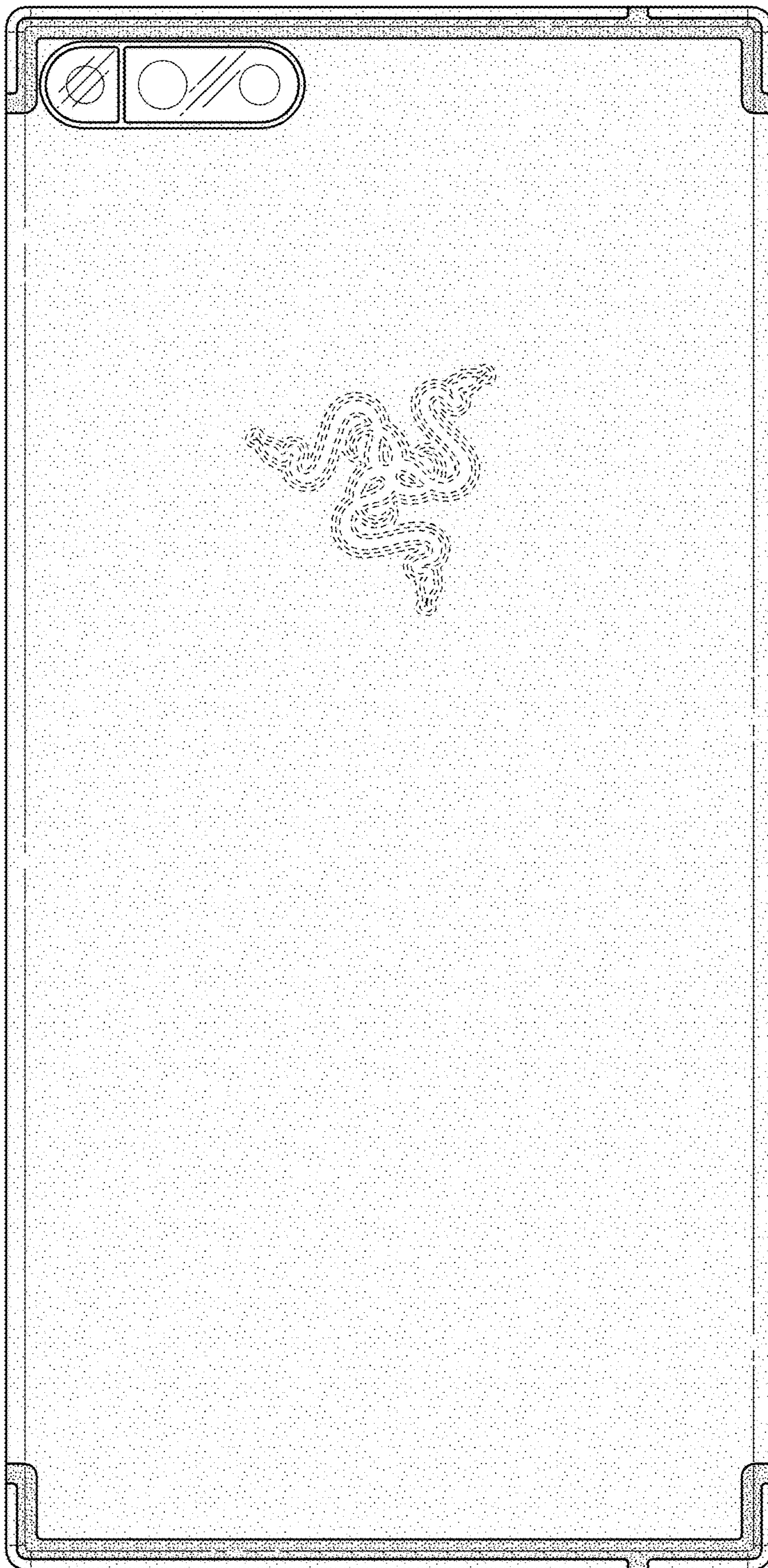

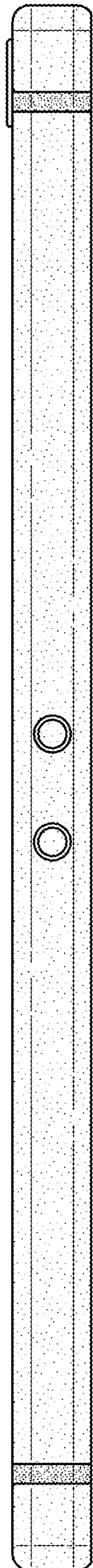

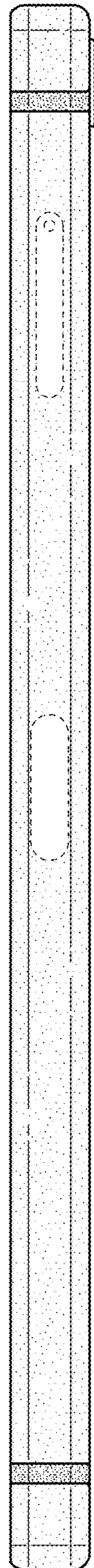

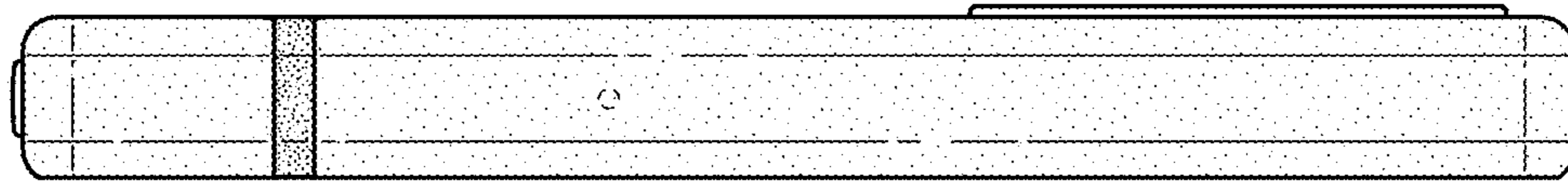

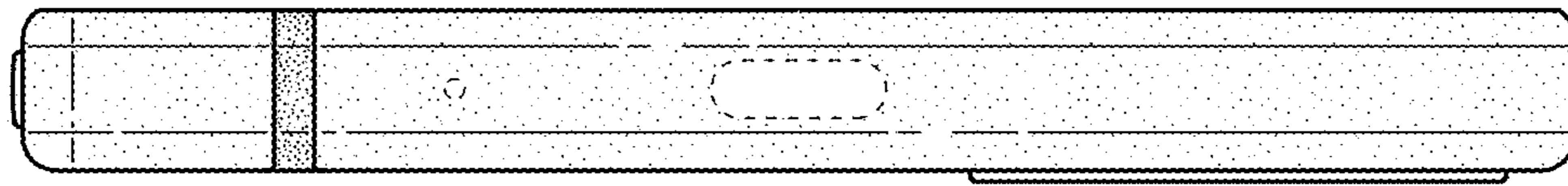
