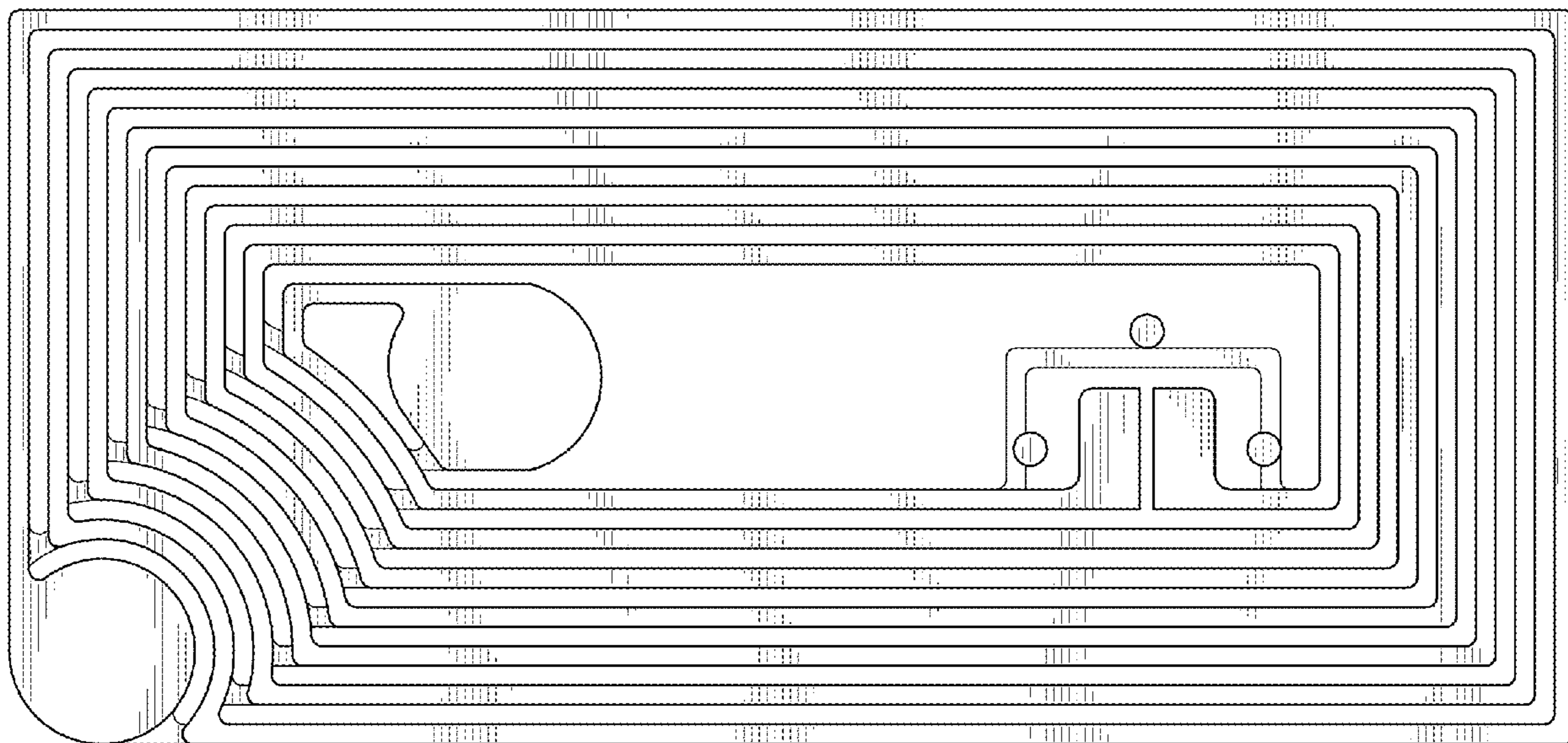
FIG. 1 is an isometric view of an antenna, showing my design; and,

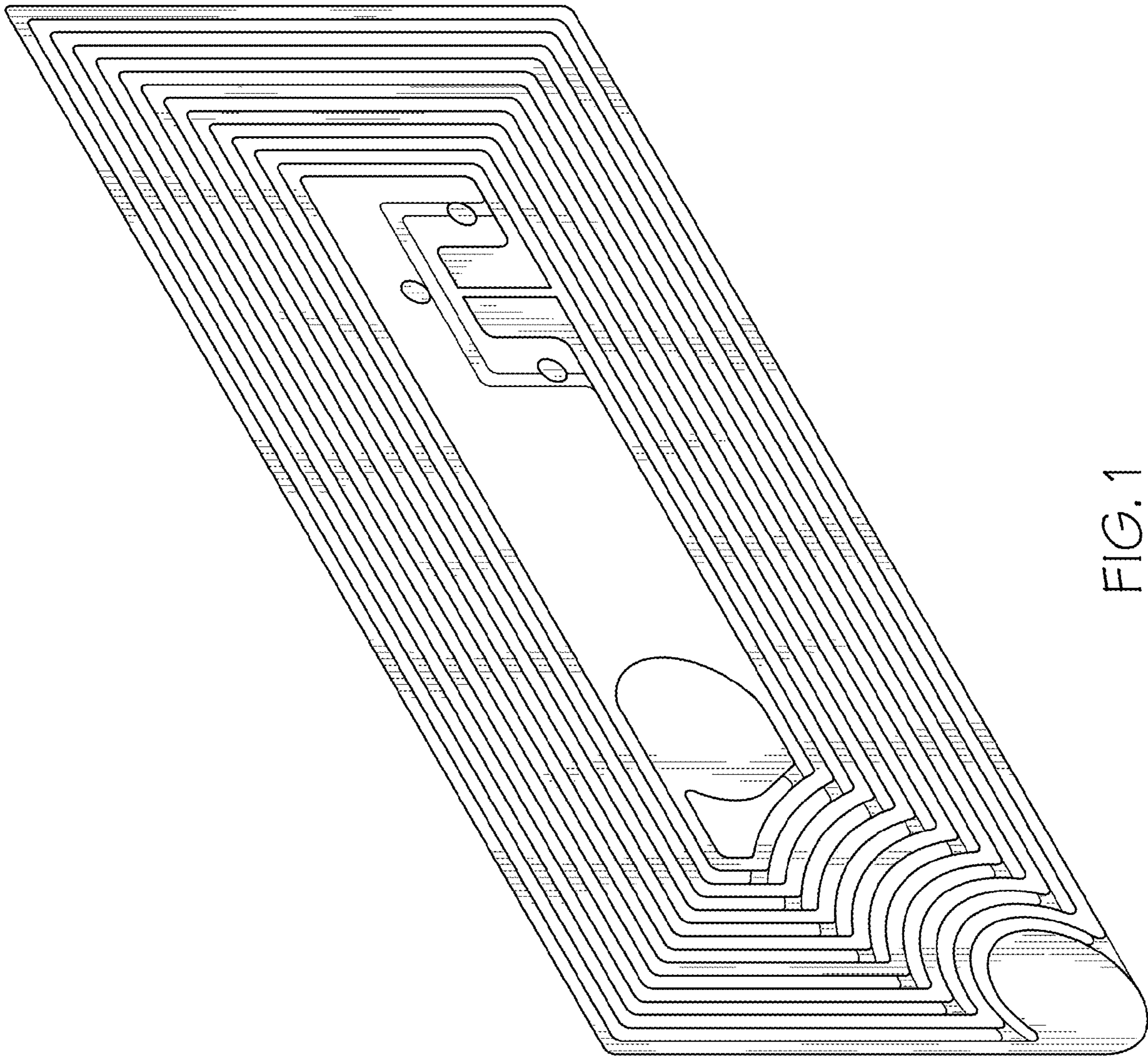

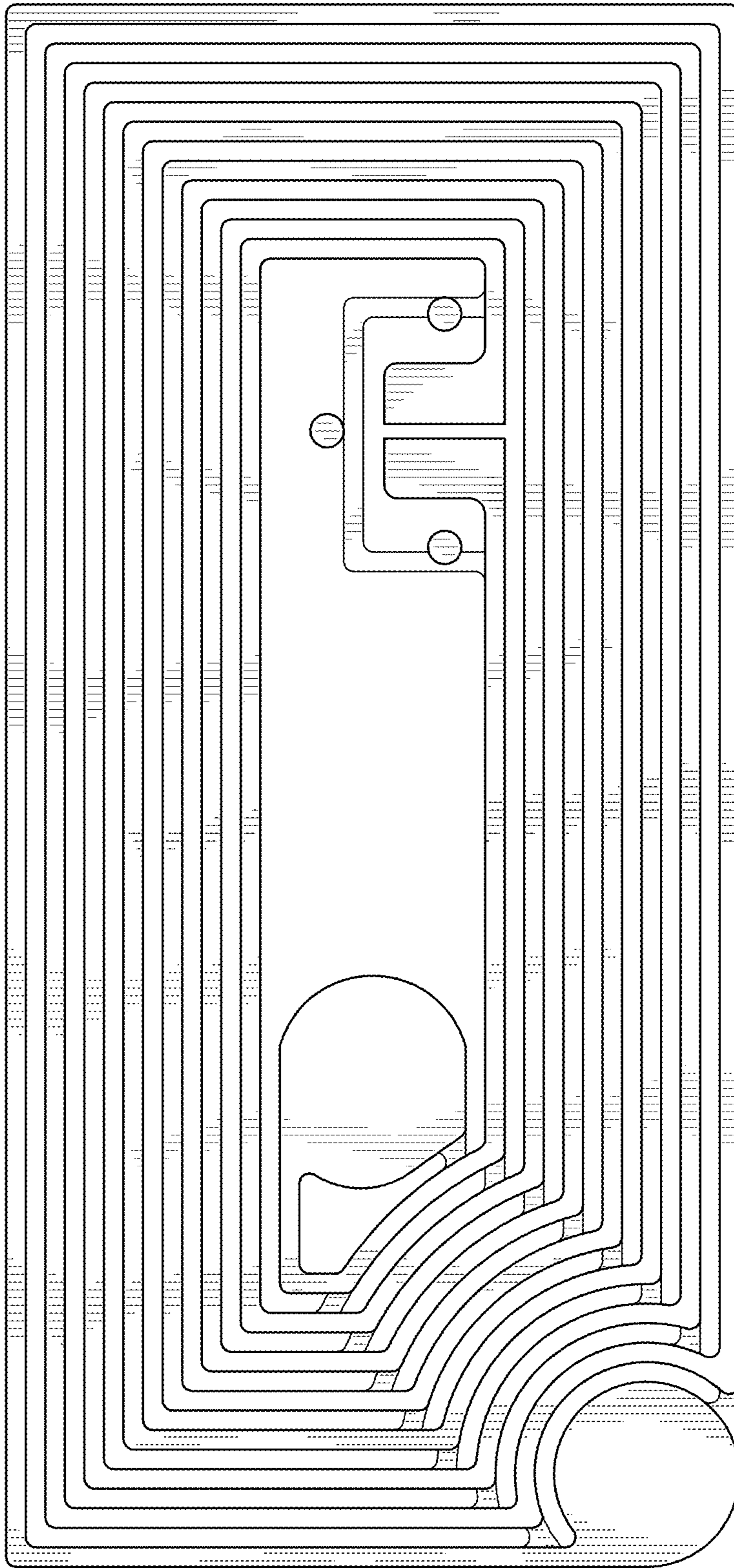
