The ornamental design for a case for electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a case for electronic device showing our new design according to a first embodiment;

FIG. 11 is a front perspective view of a case for electronic device showing our new design according to a second embodiment;

FIG. 15 is a right side elevation view thereof;

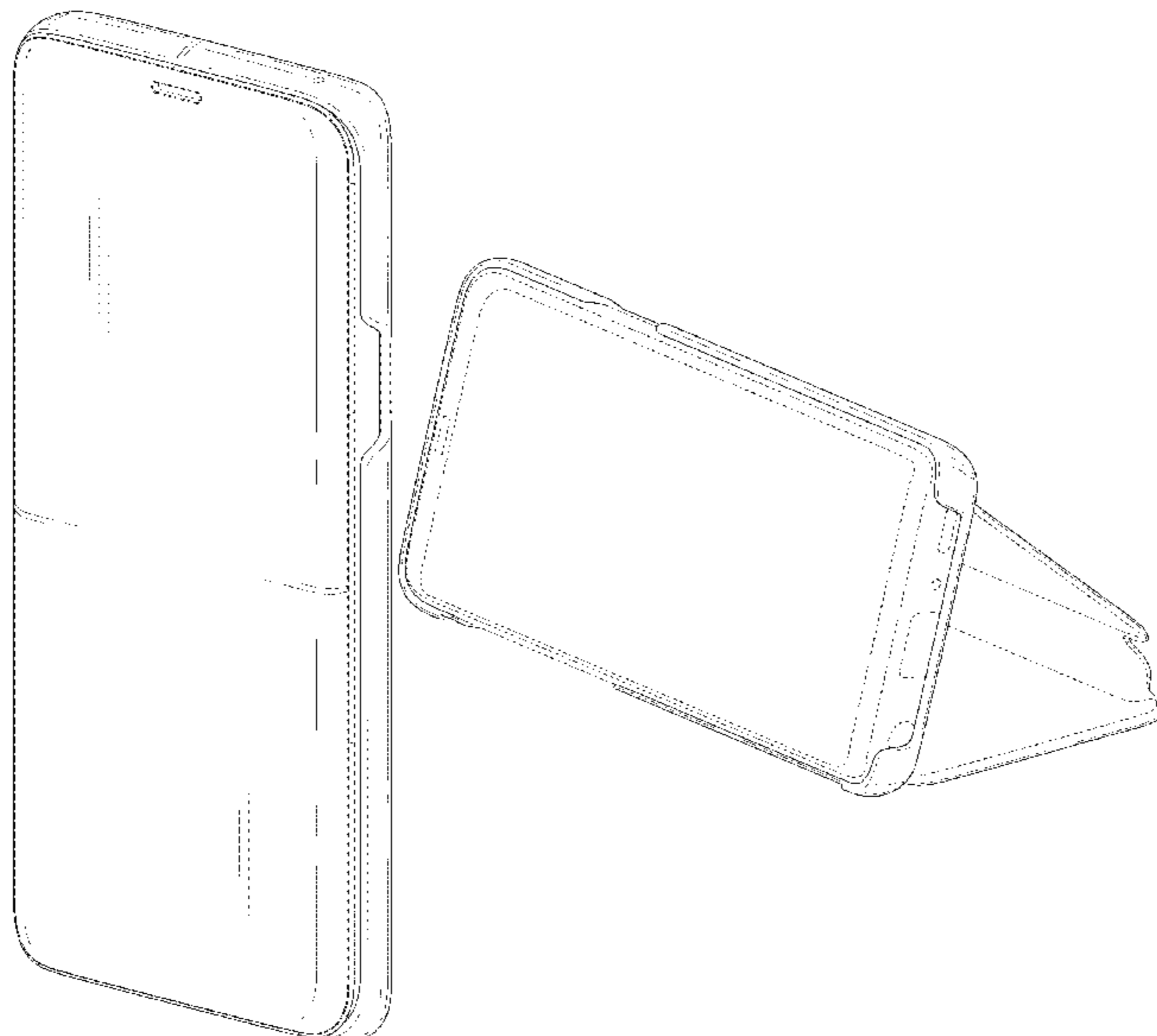
FIG. 16 is a top plan view thereof;

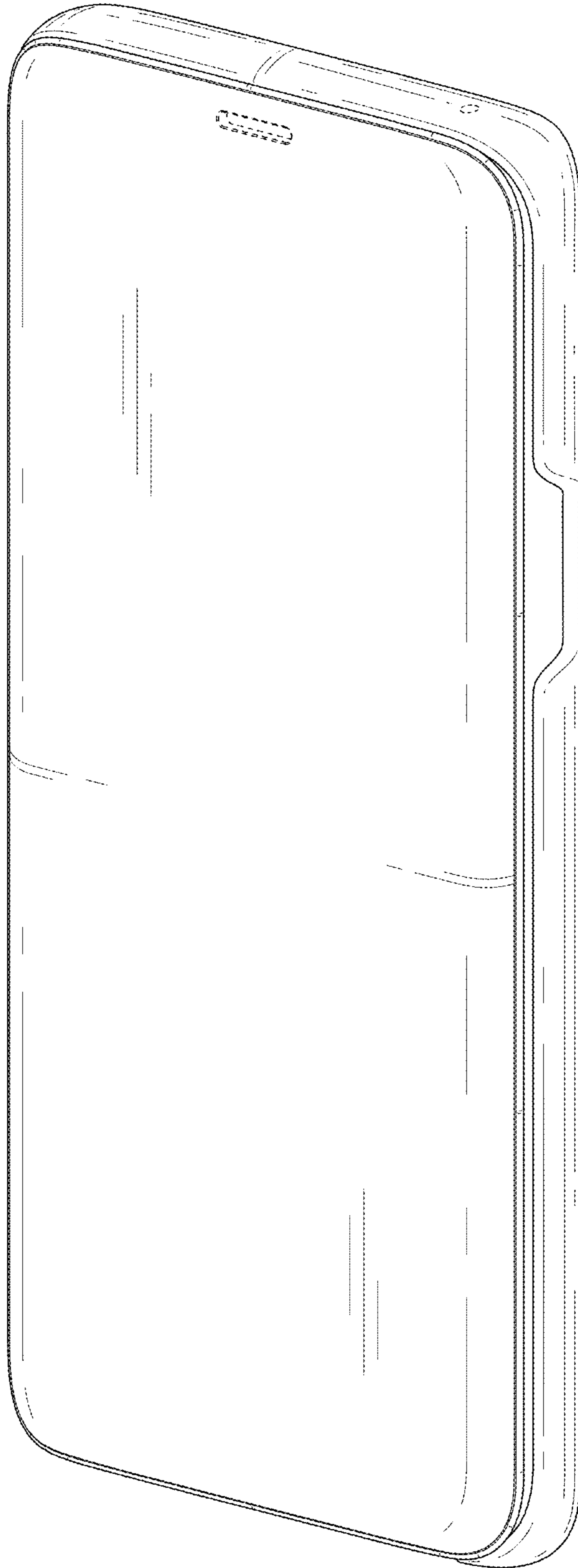

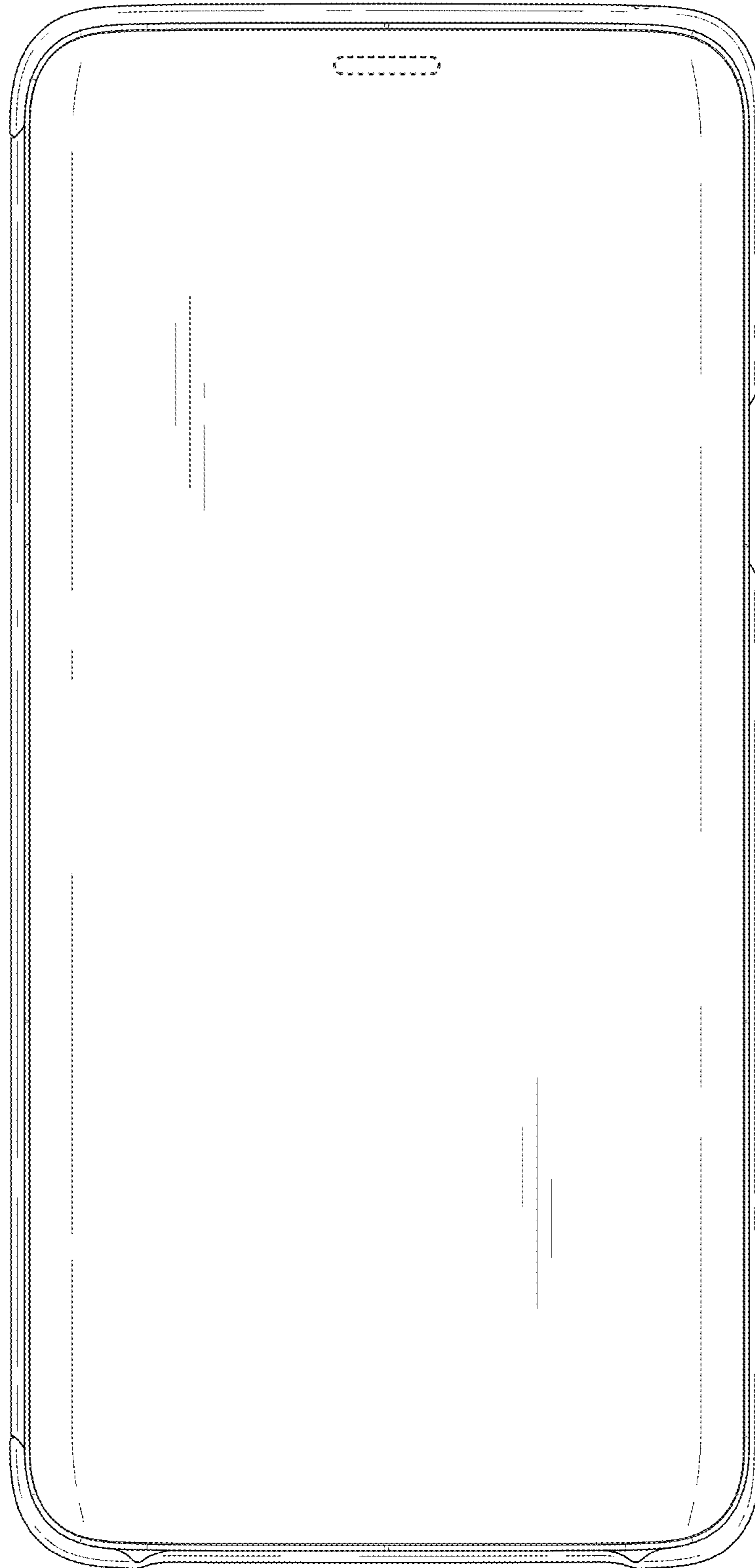

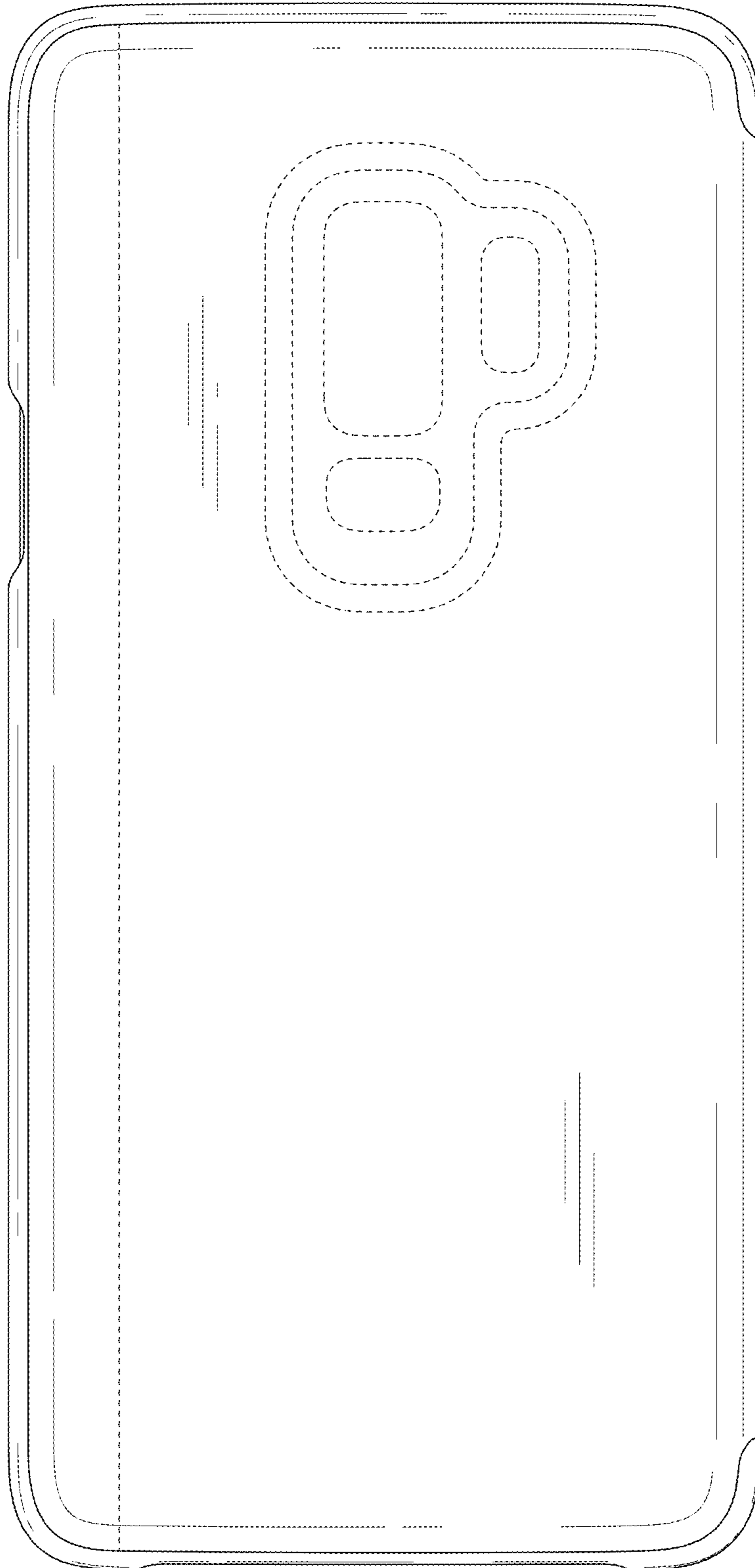

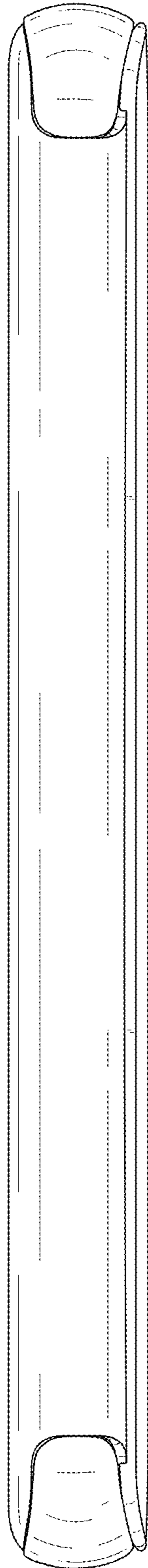

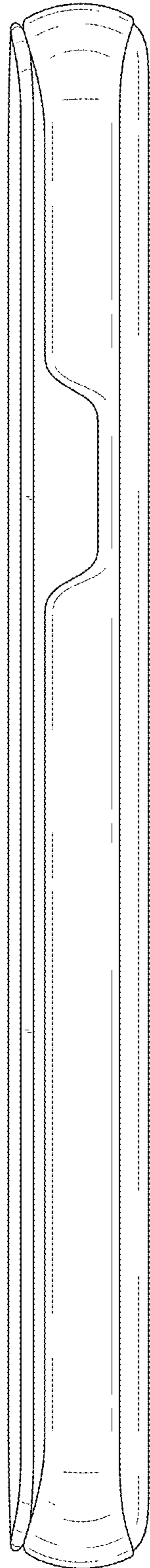

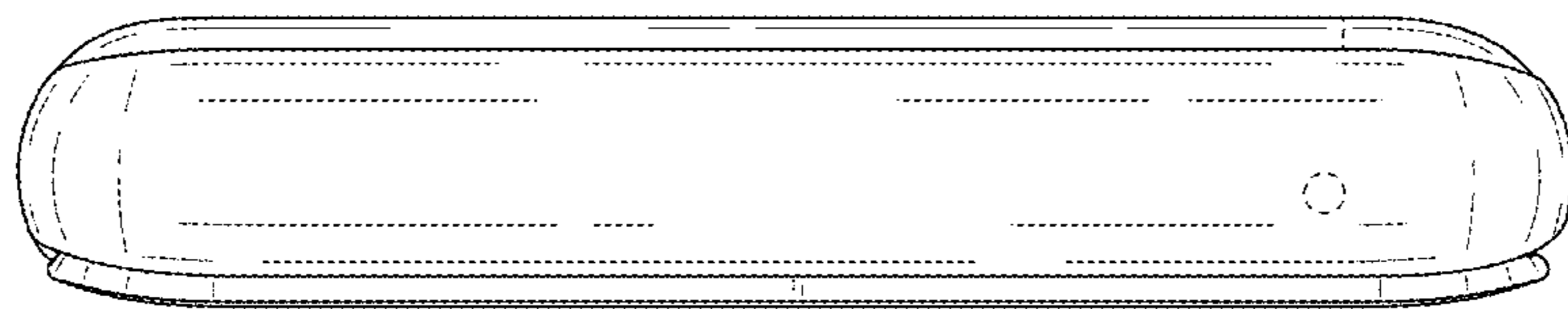

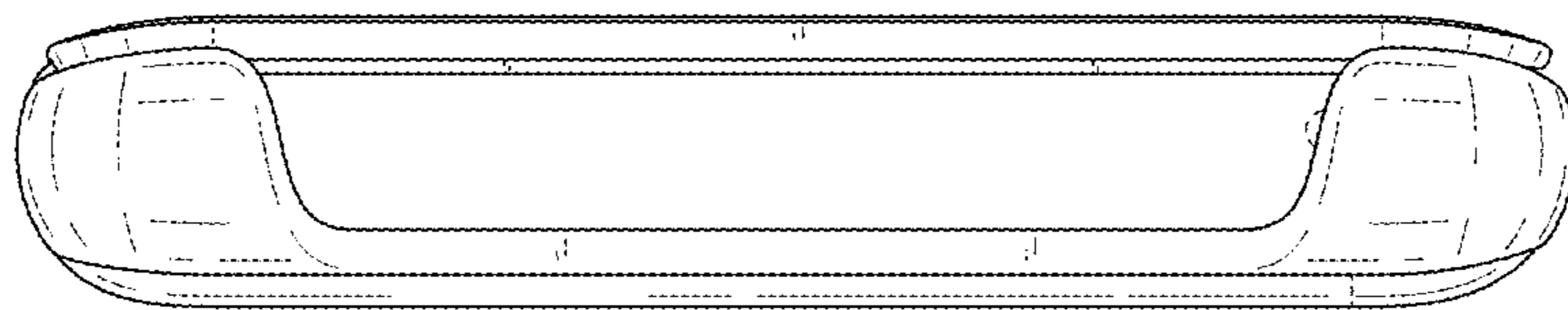

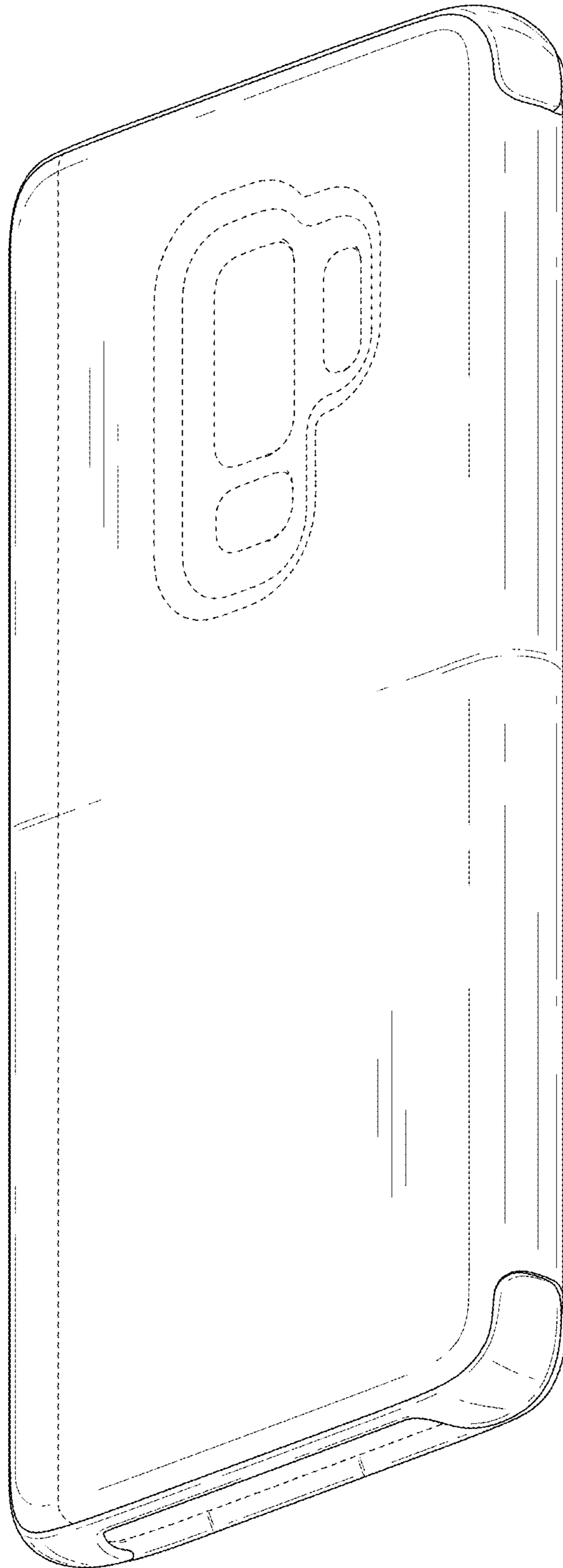

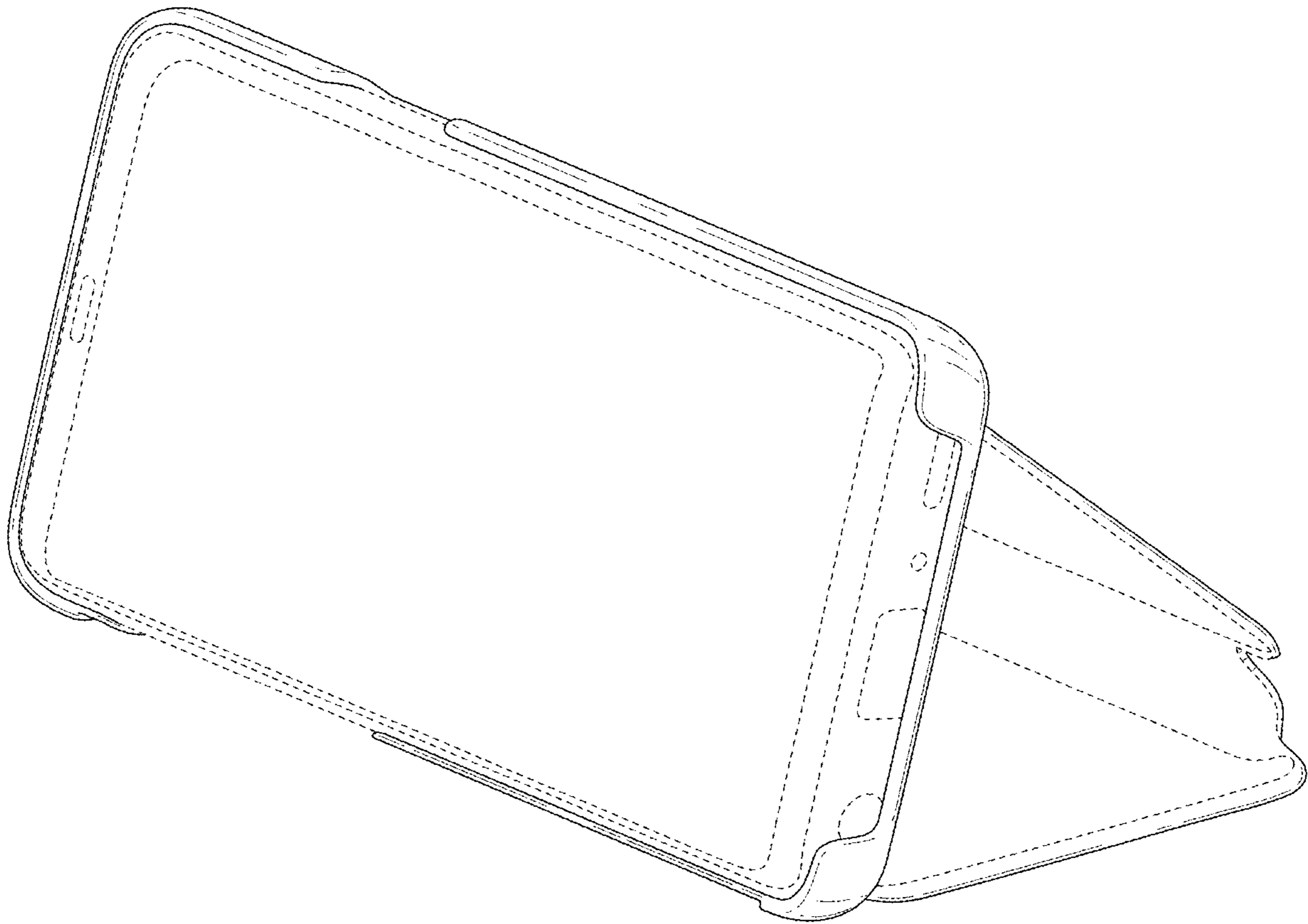

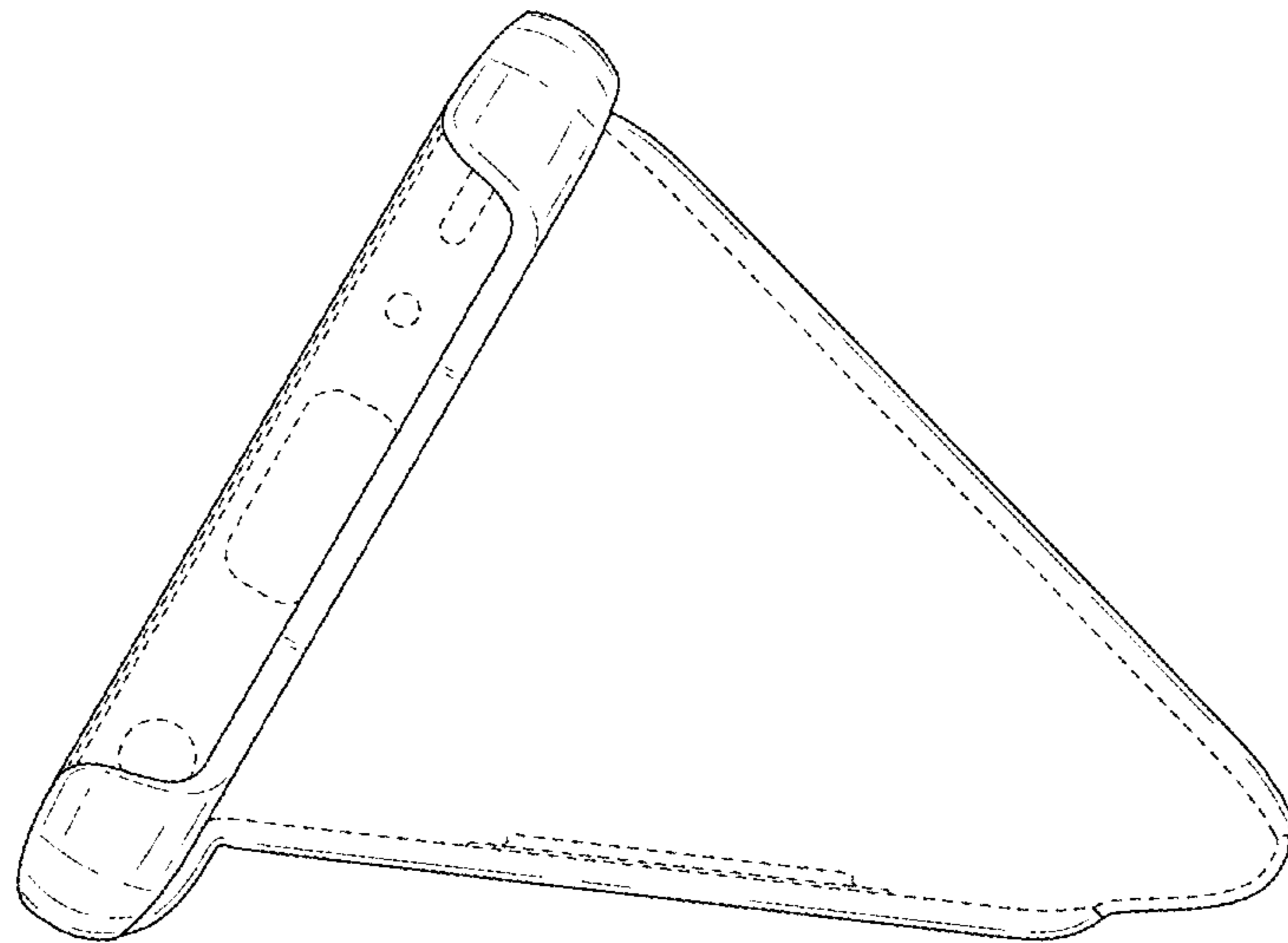

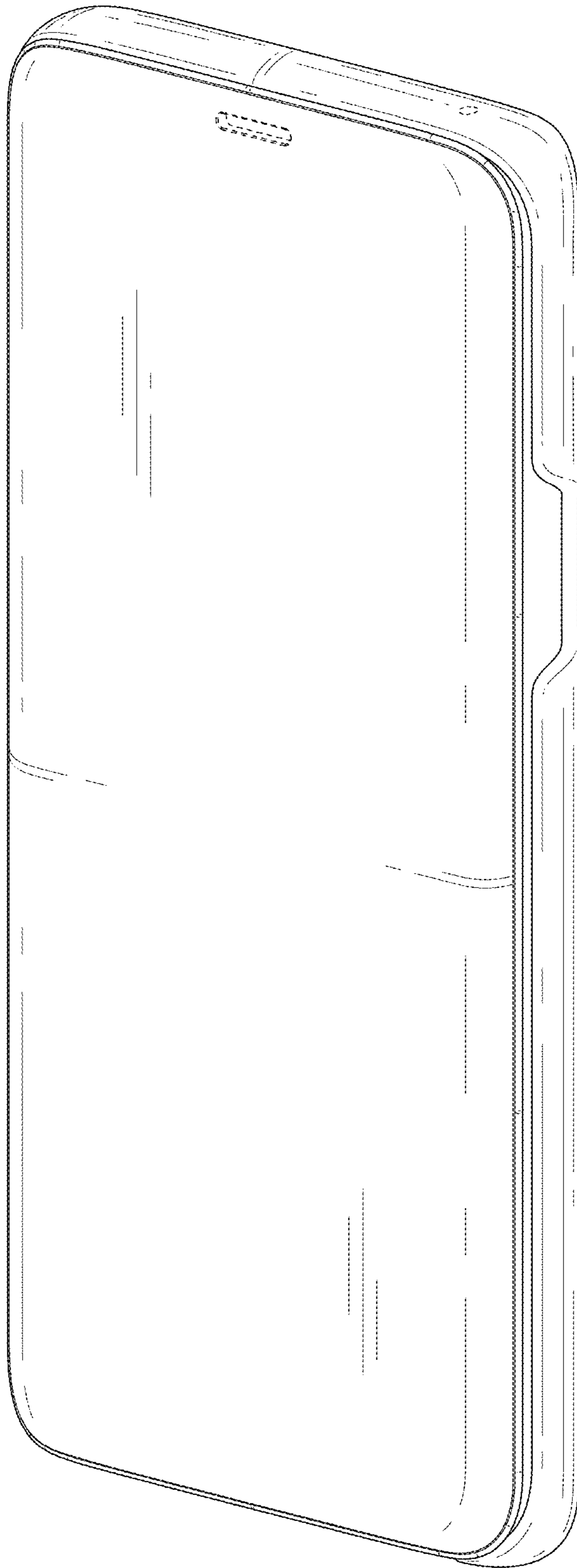

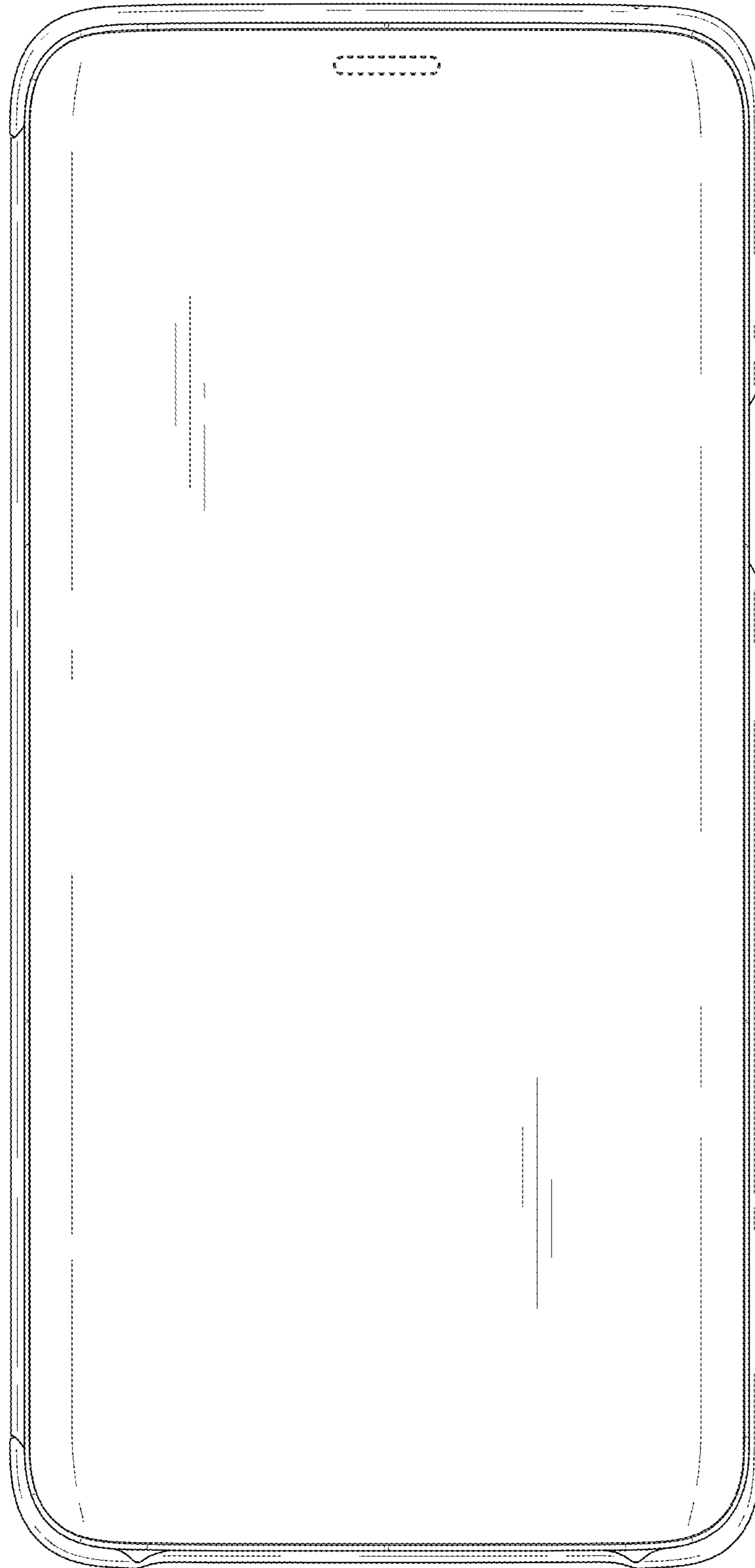

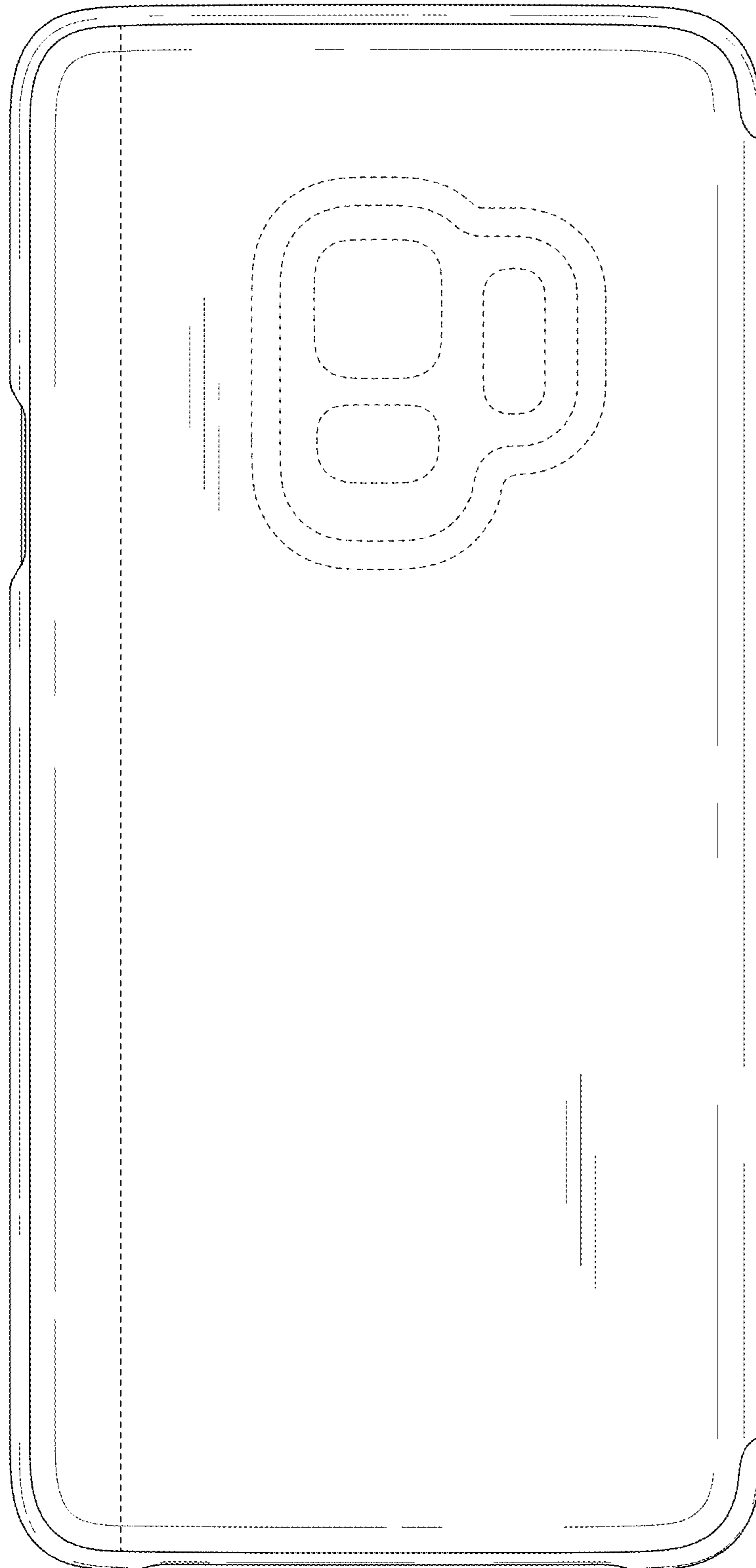

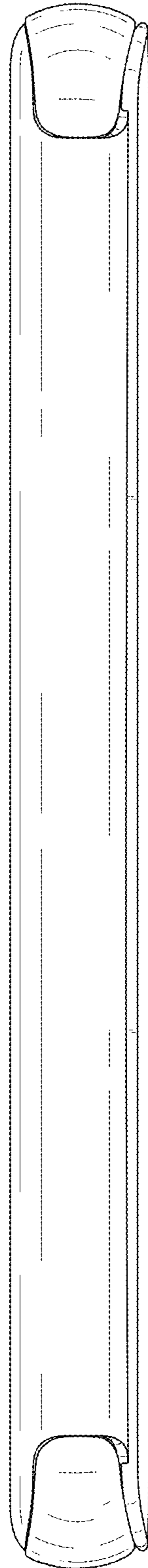

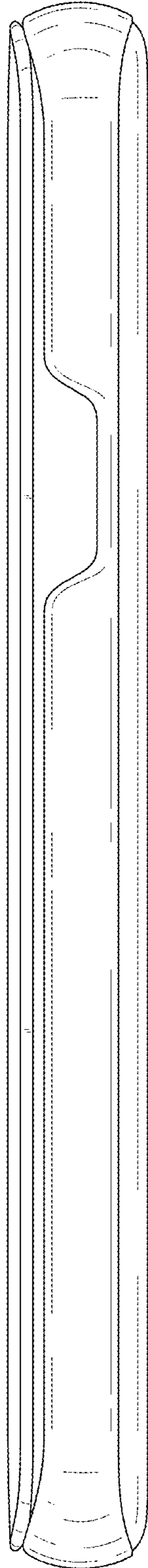

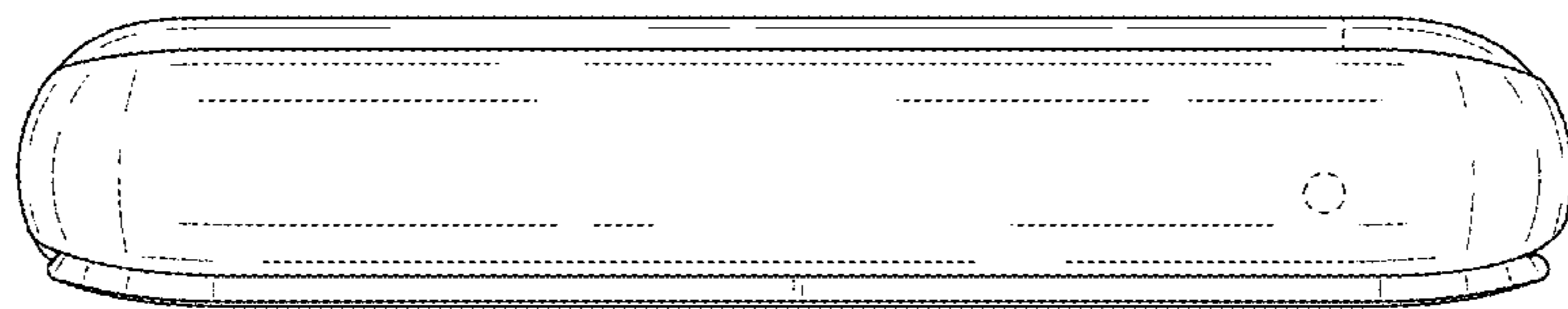

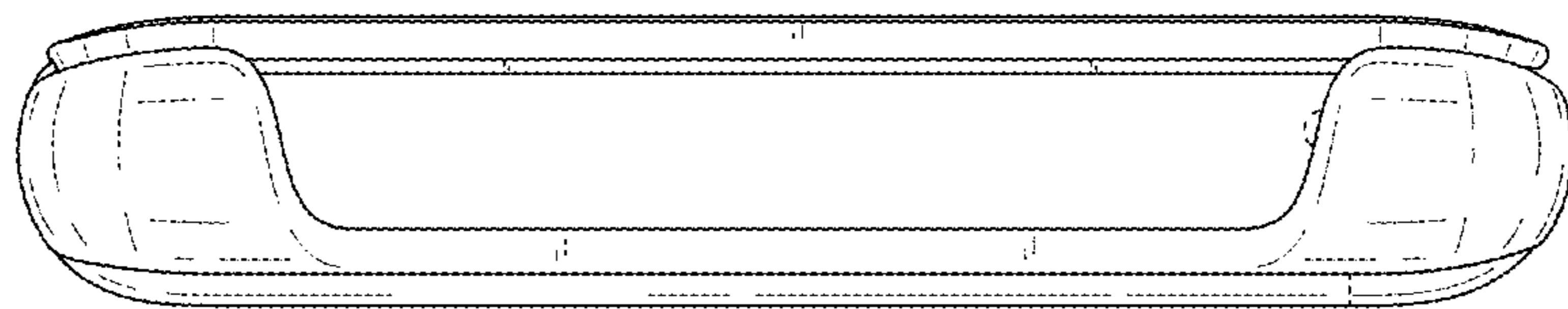
