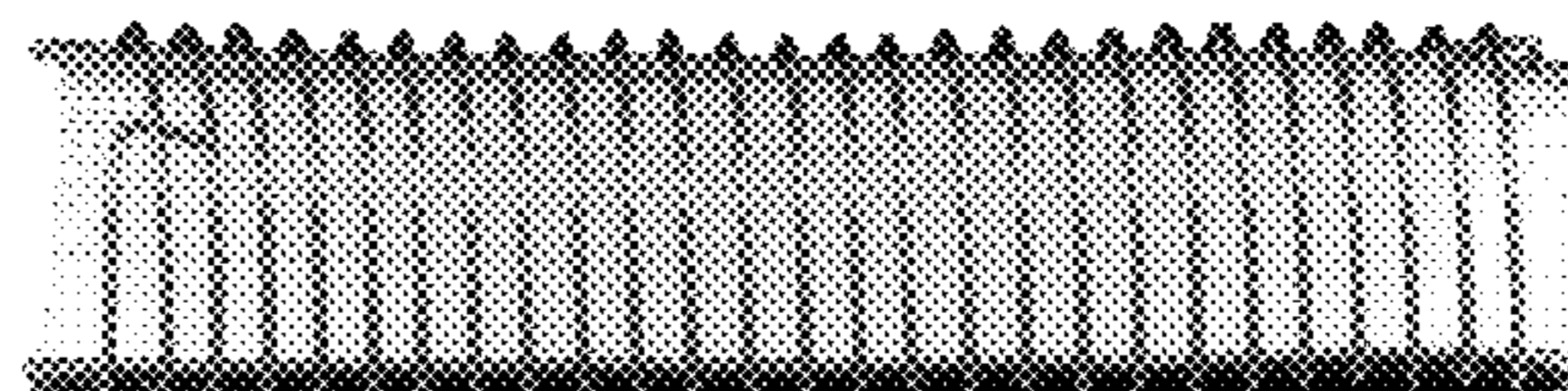
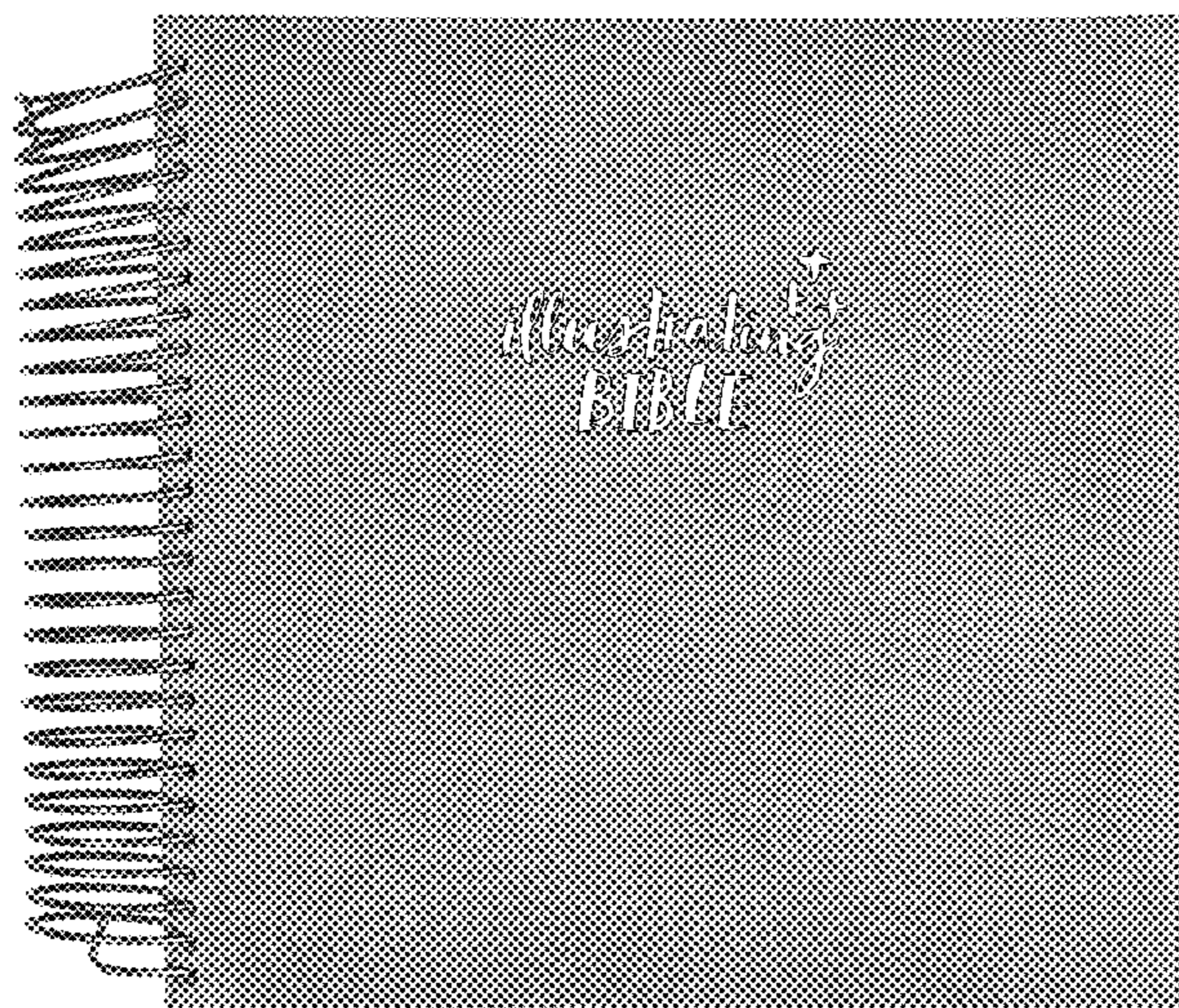
The ornamental design for a Bible, as shown and described.

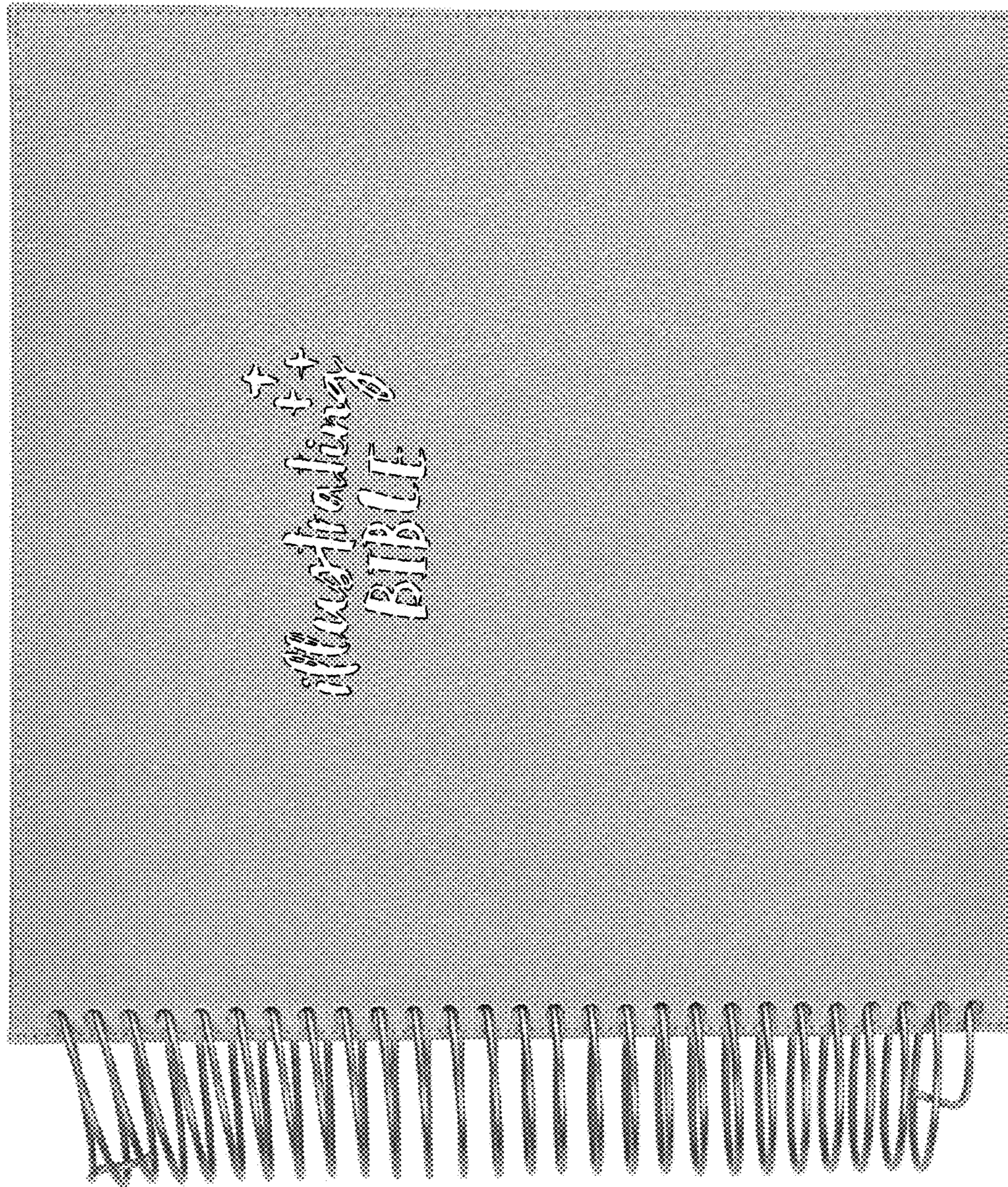

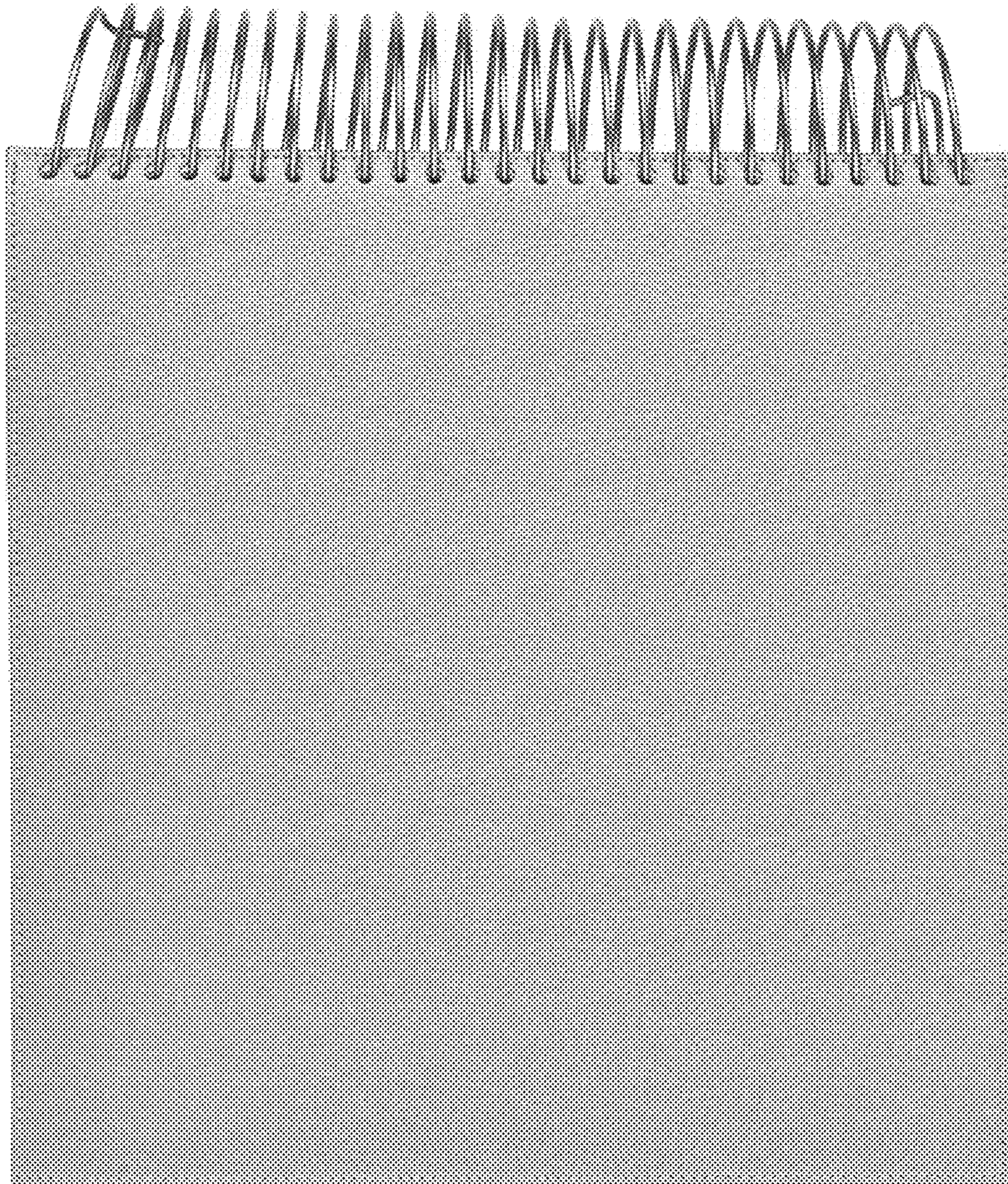

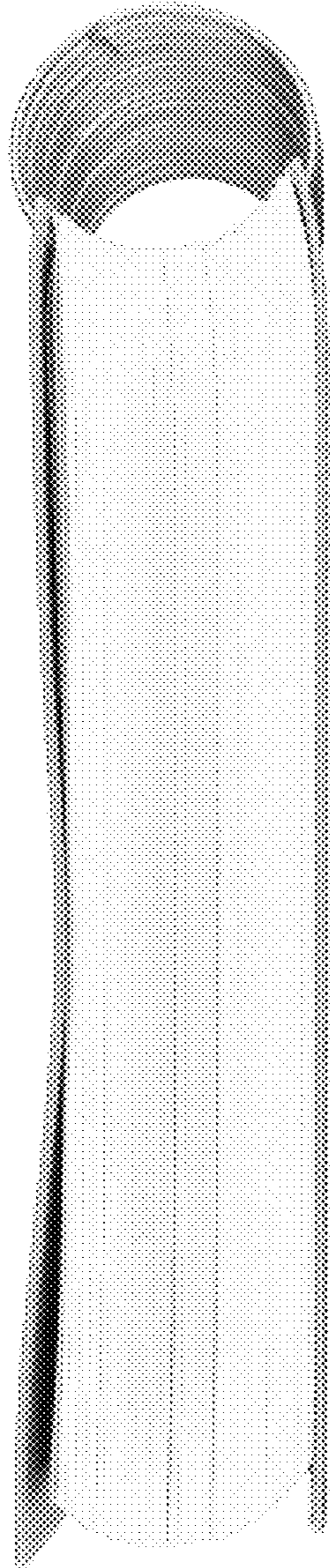

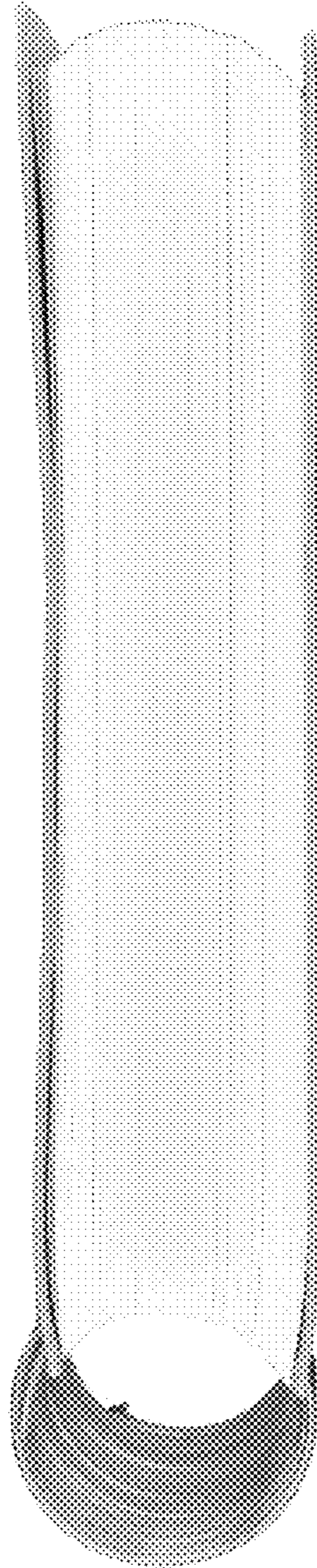

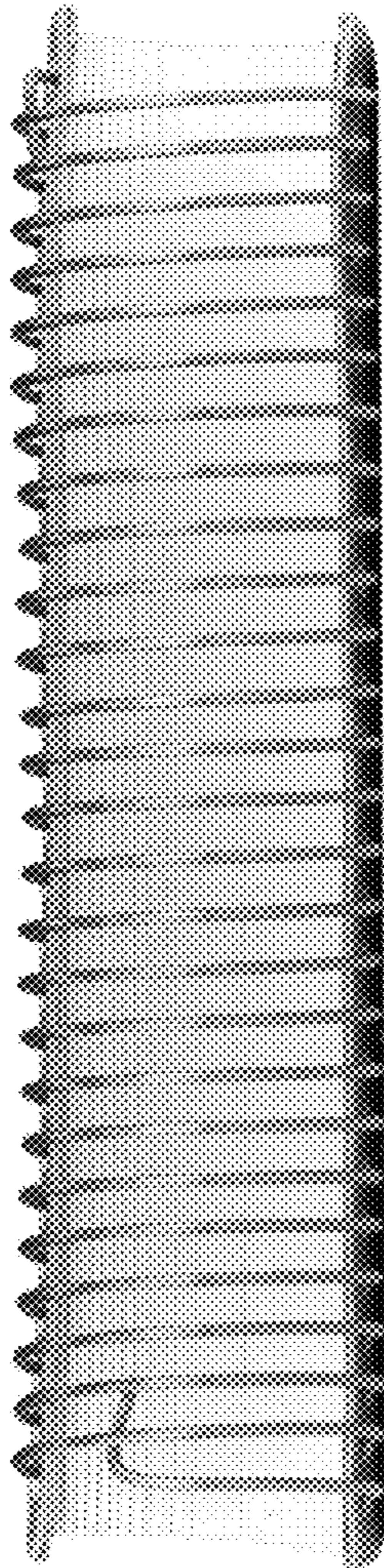

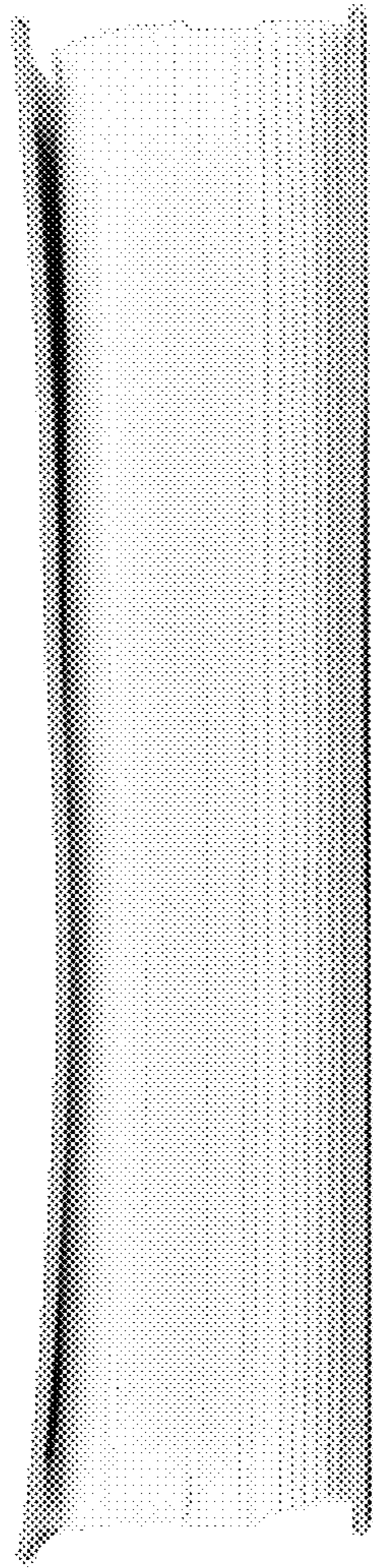

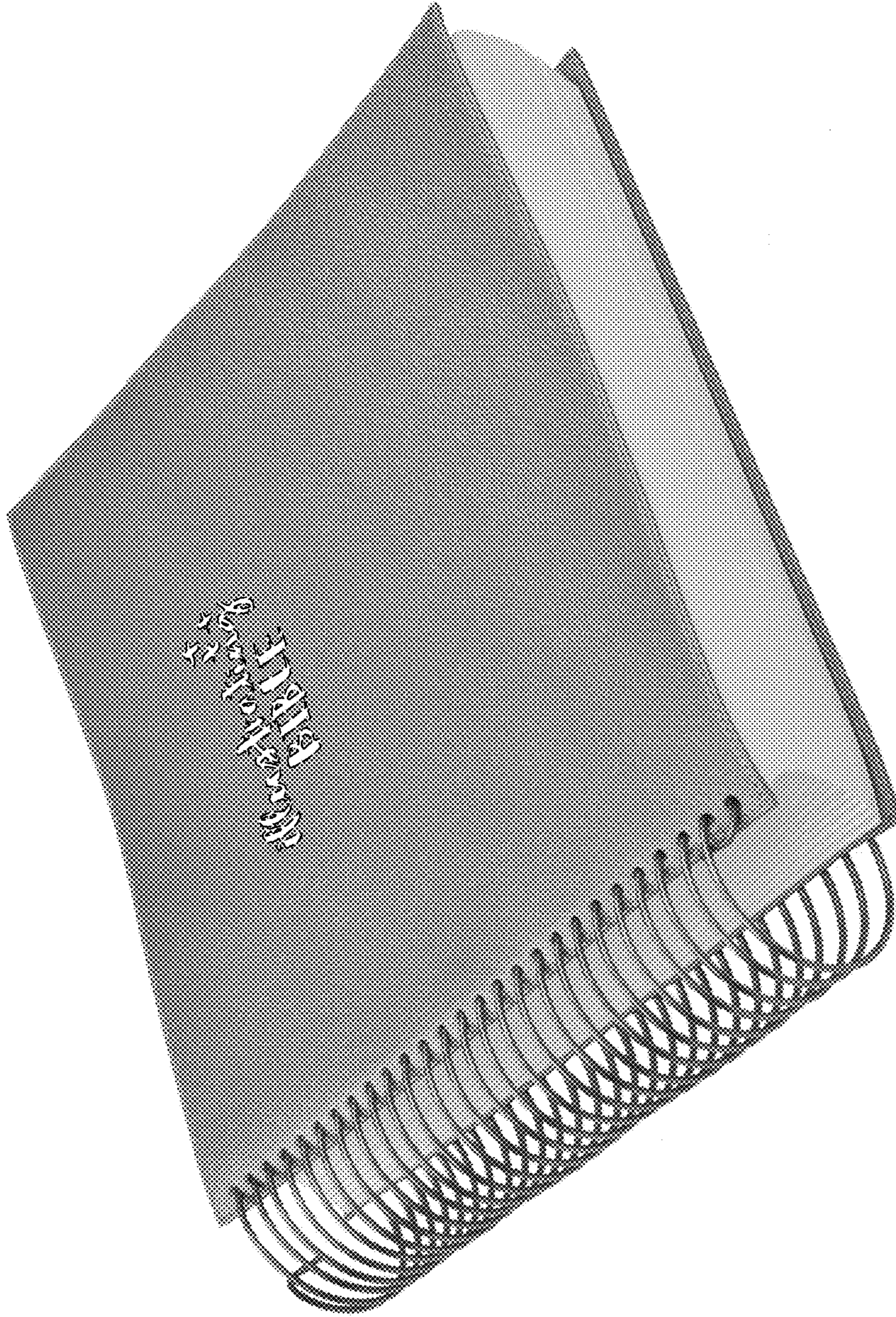

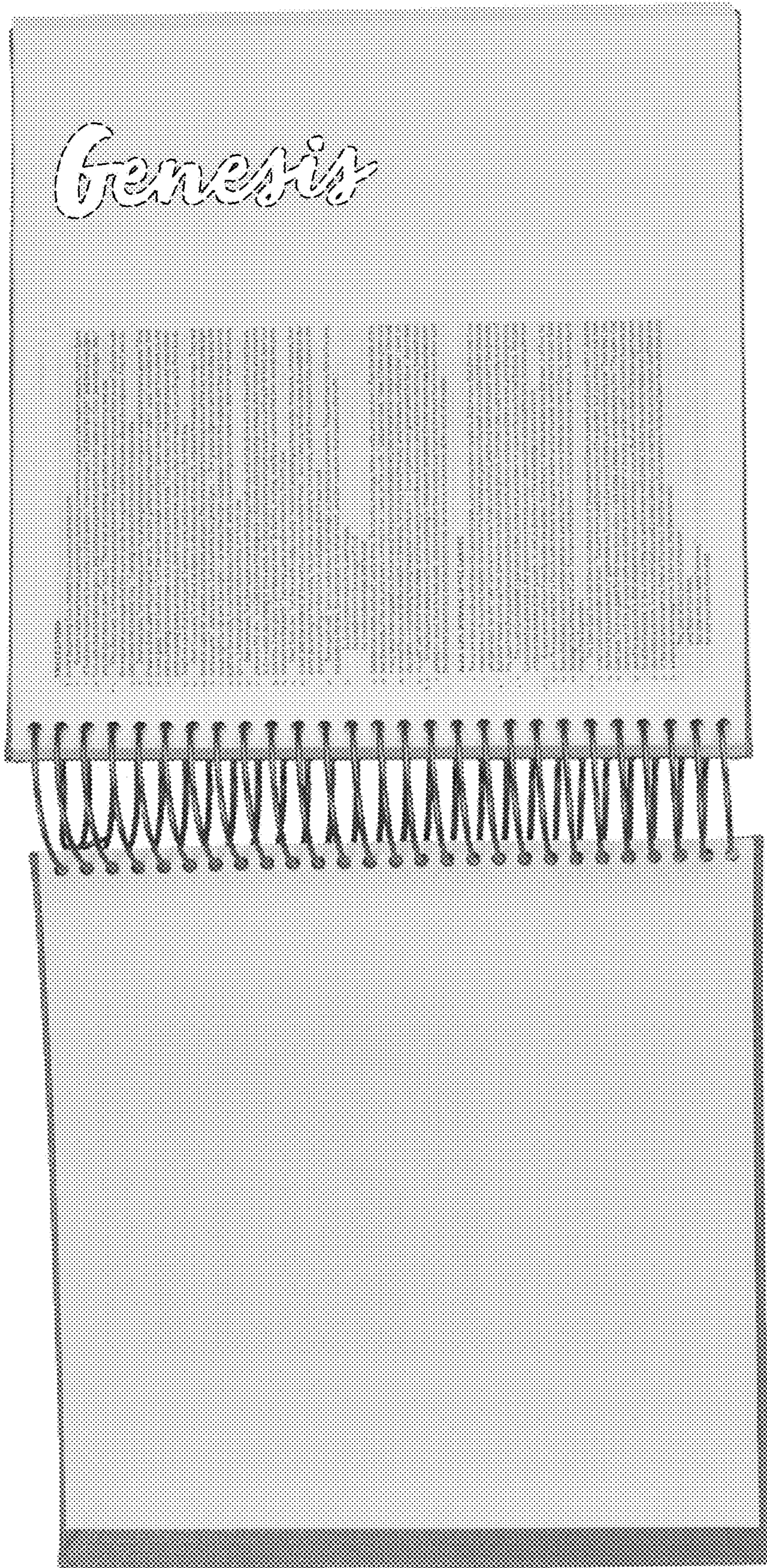

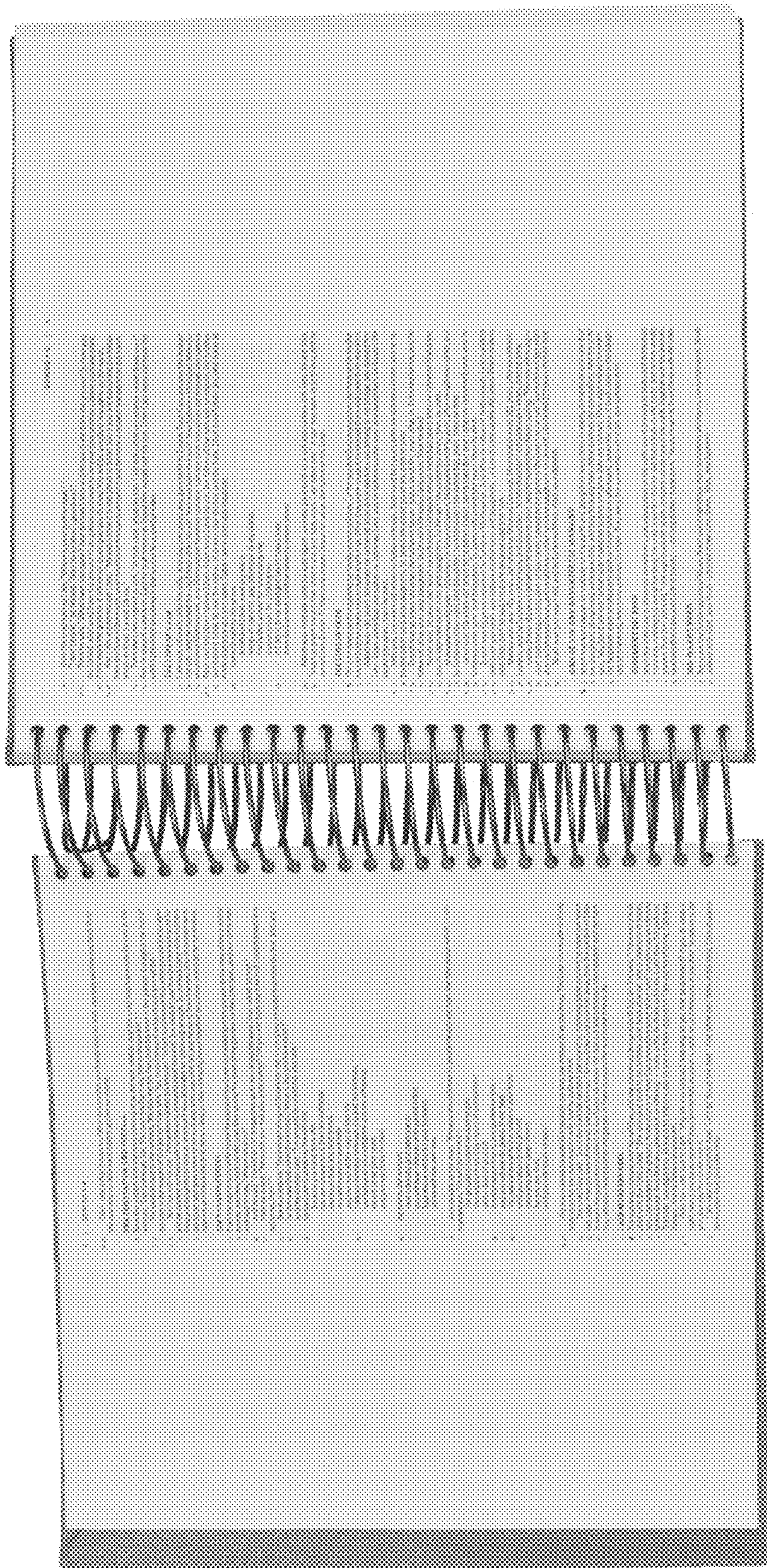
