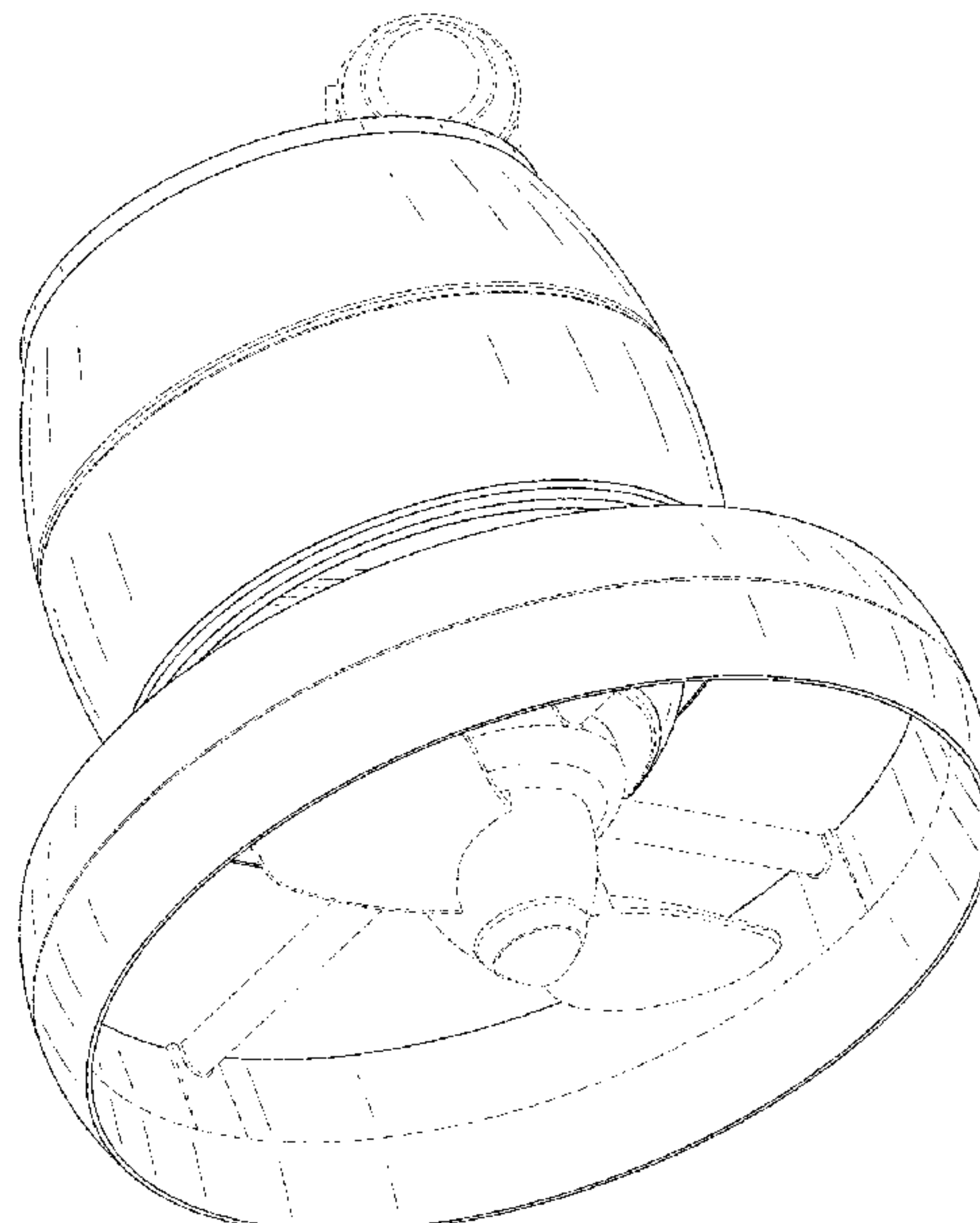
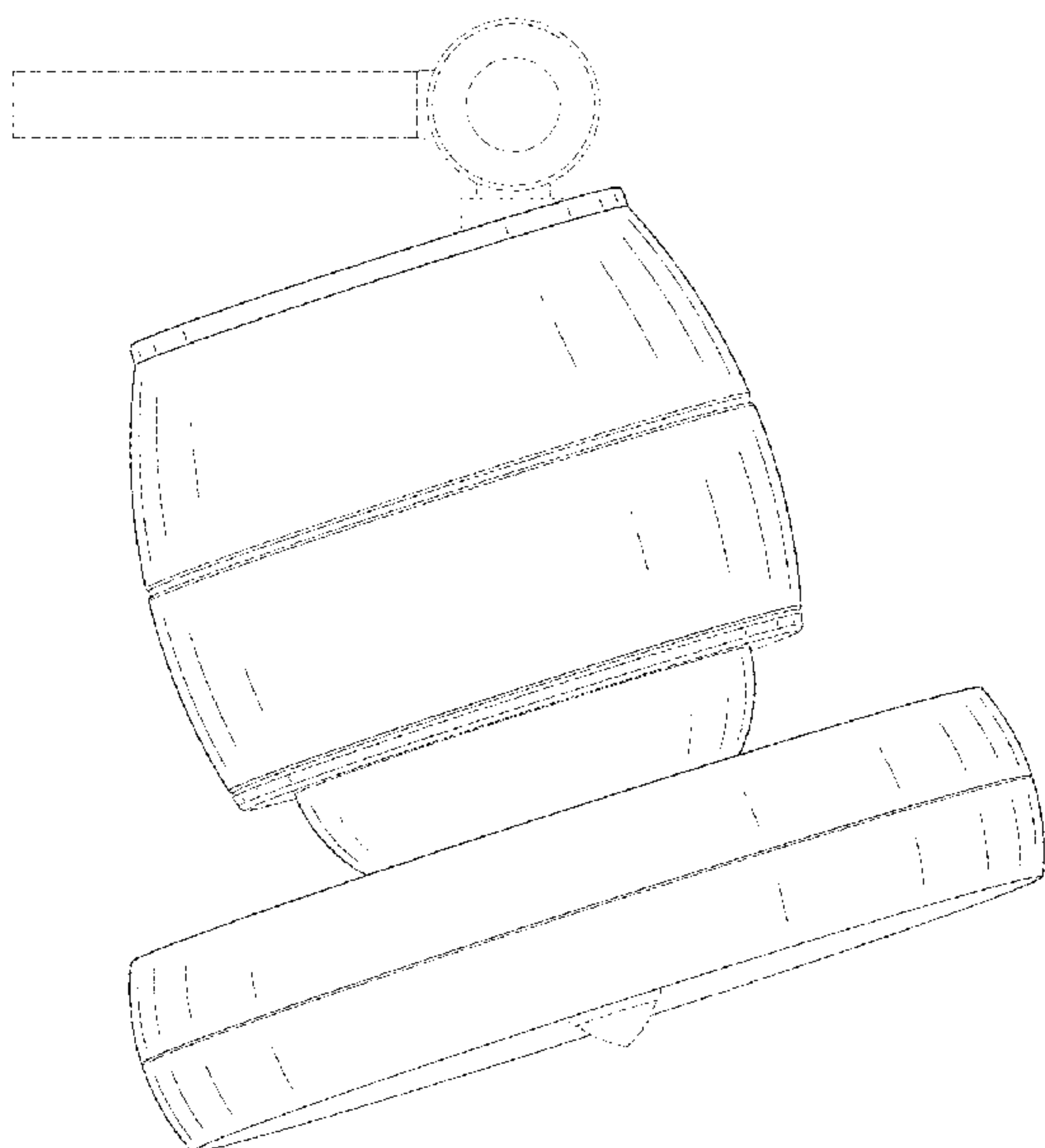
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front top perspective view of a ceiling fan
housing showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a front bottom perspective view thereof.
The broken lines depict portions of the ceiling fan housing

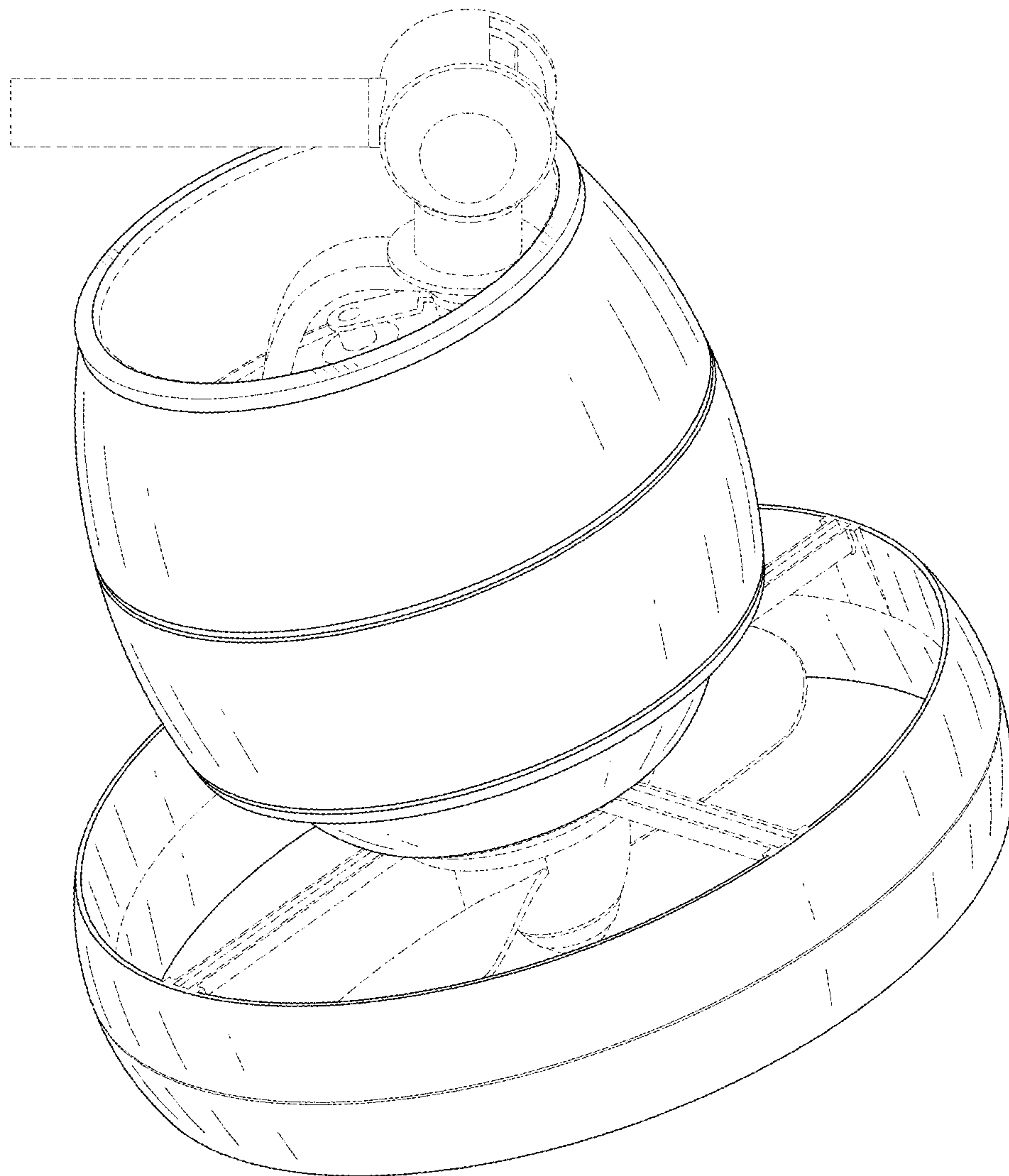

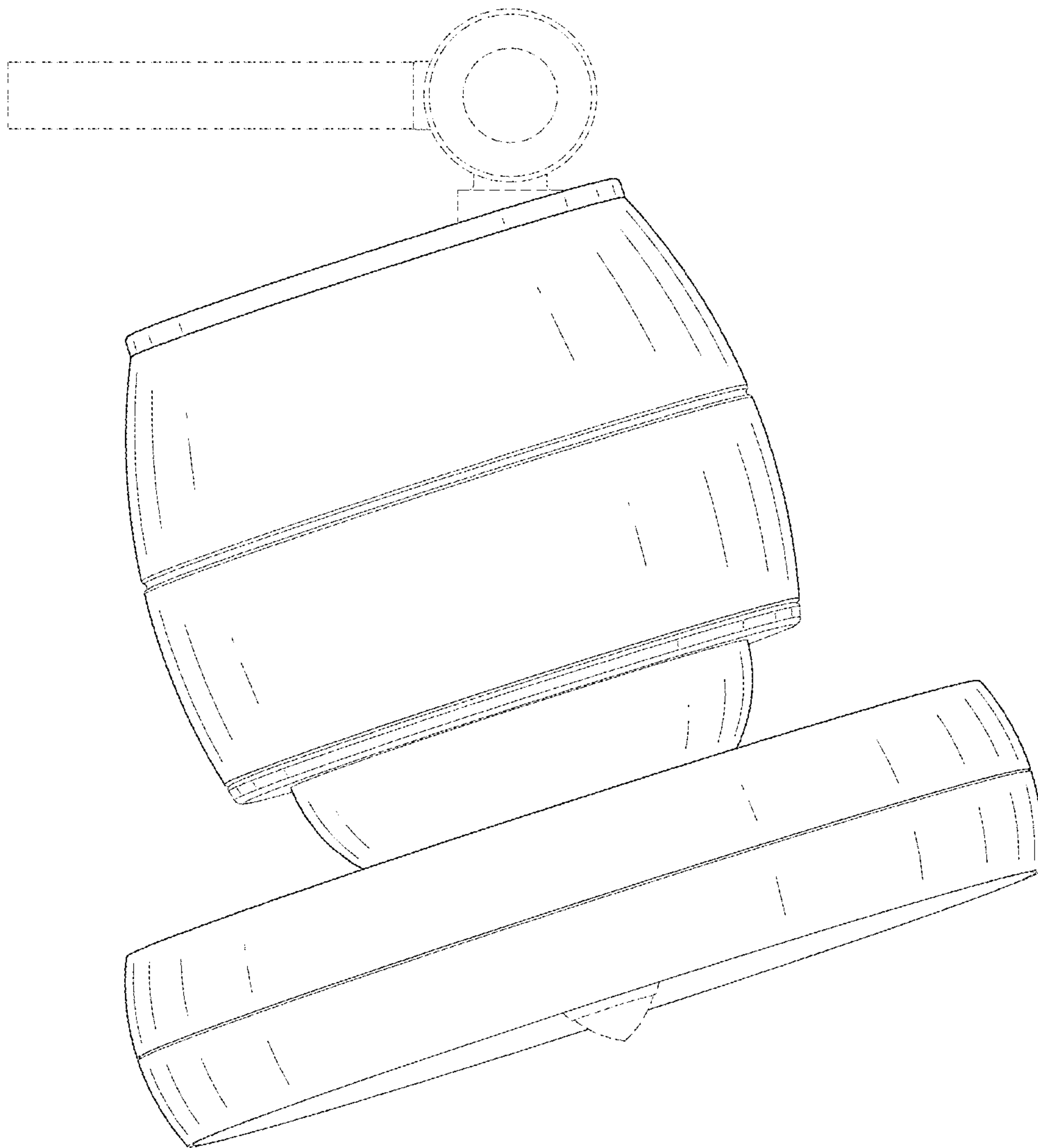

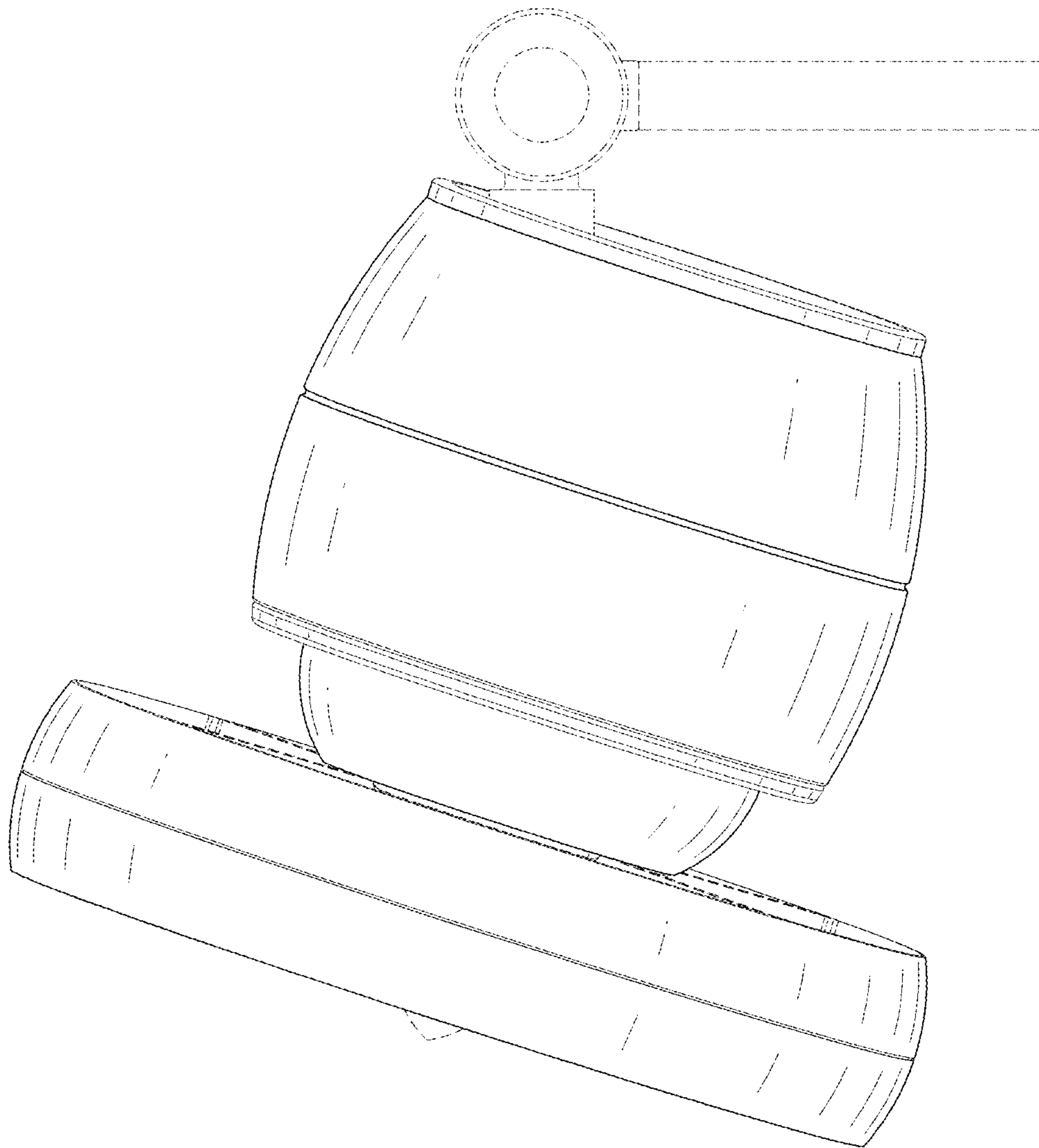

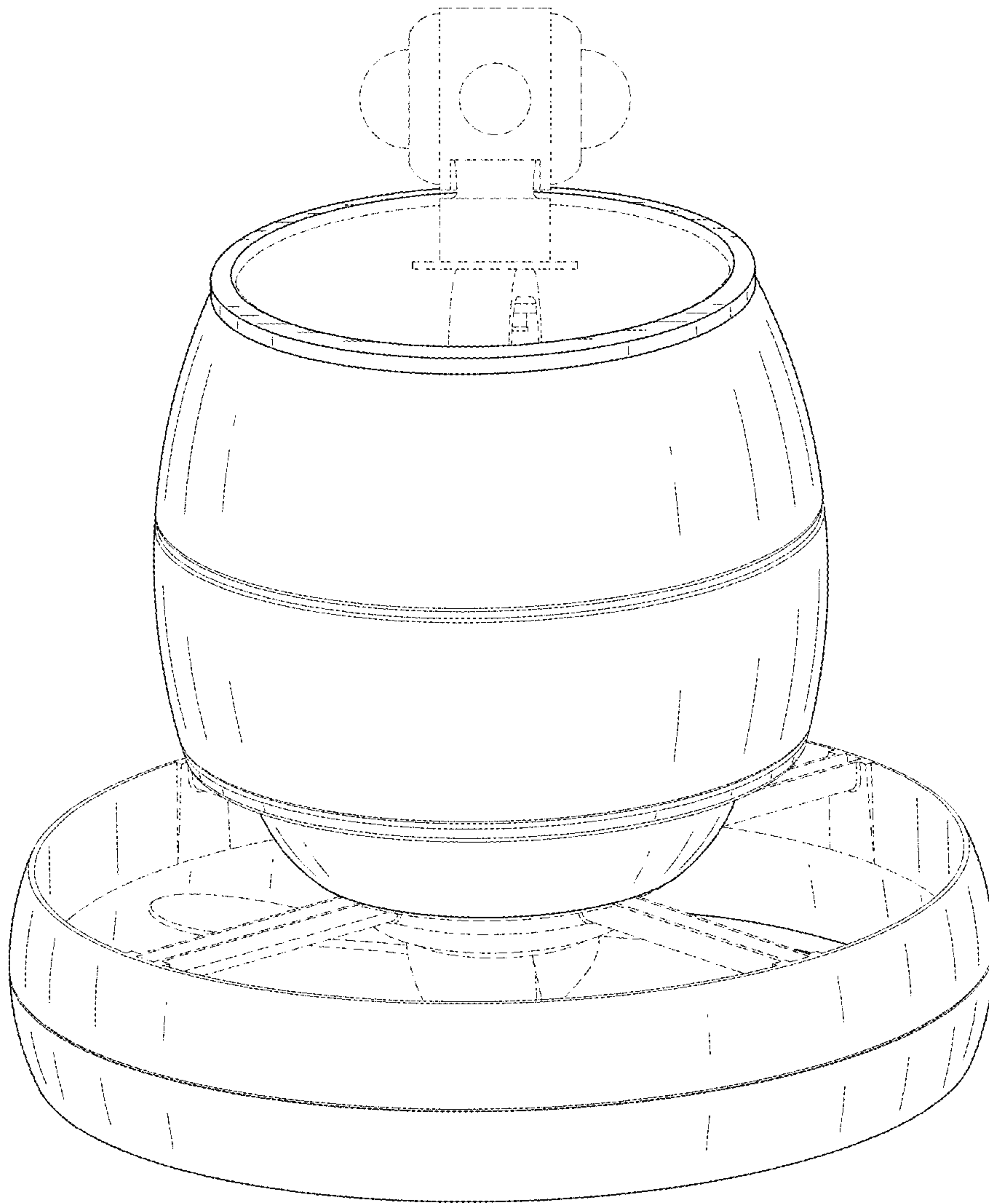

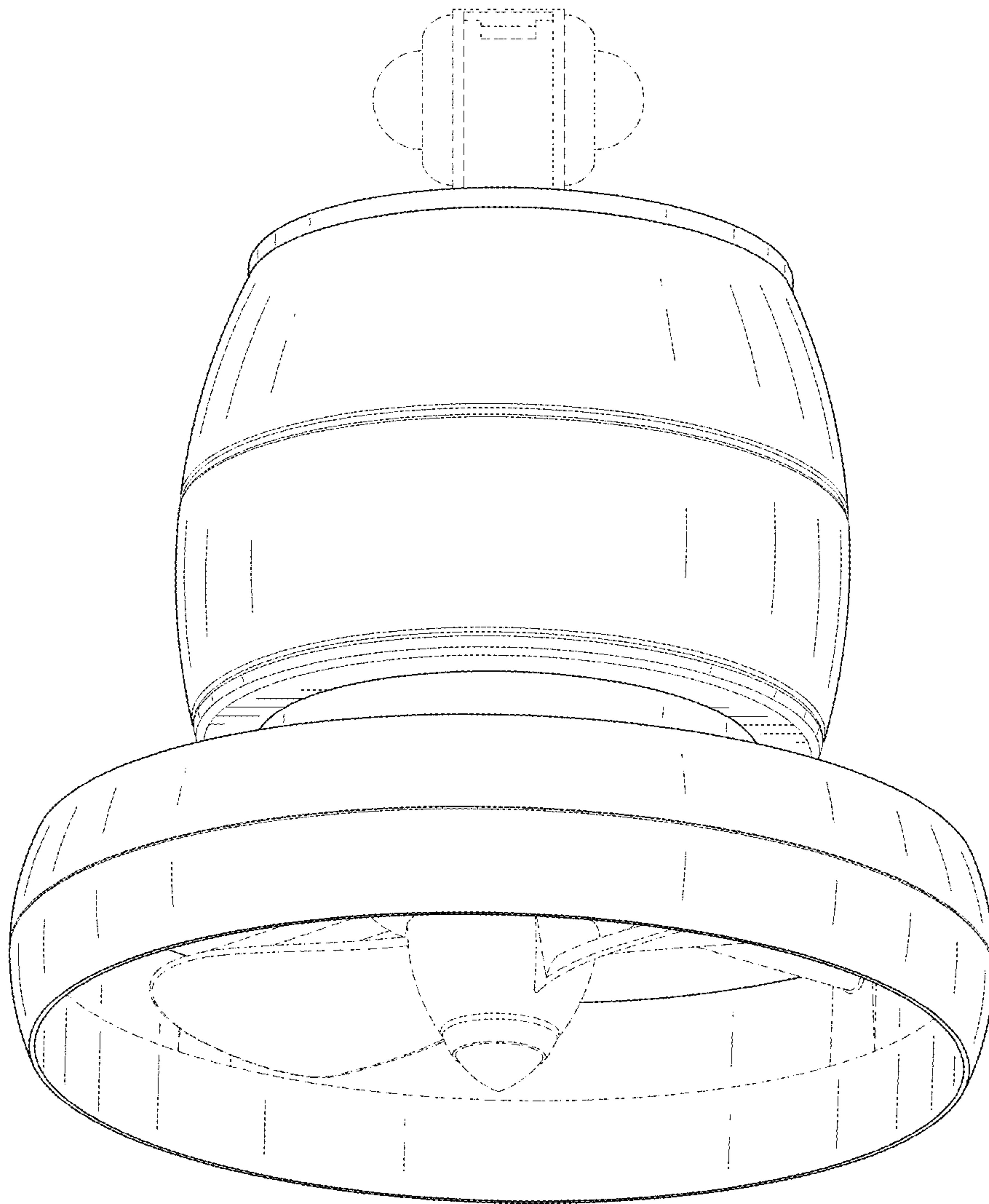

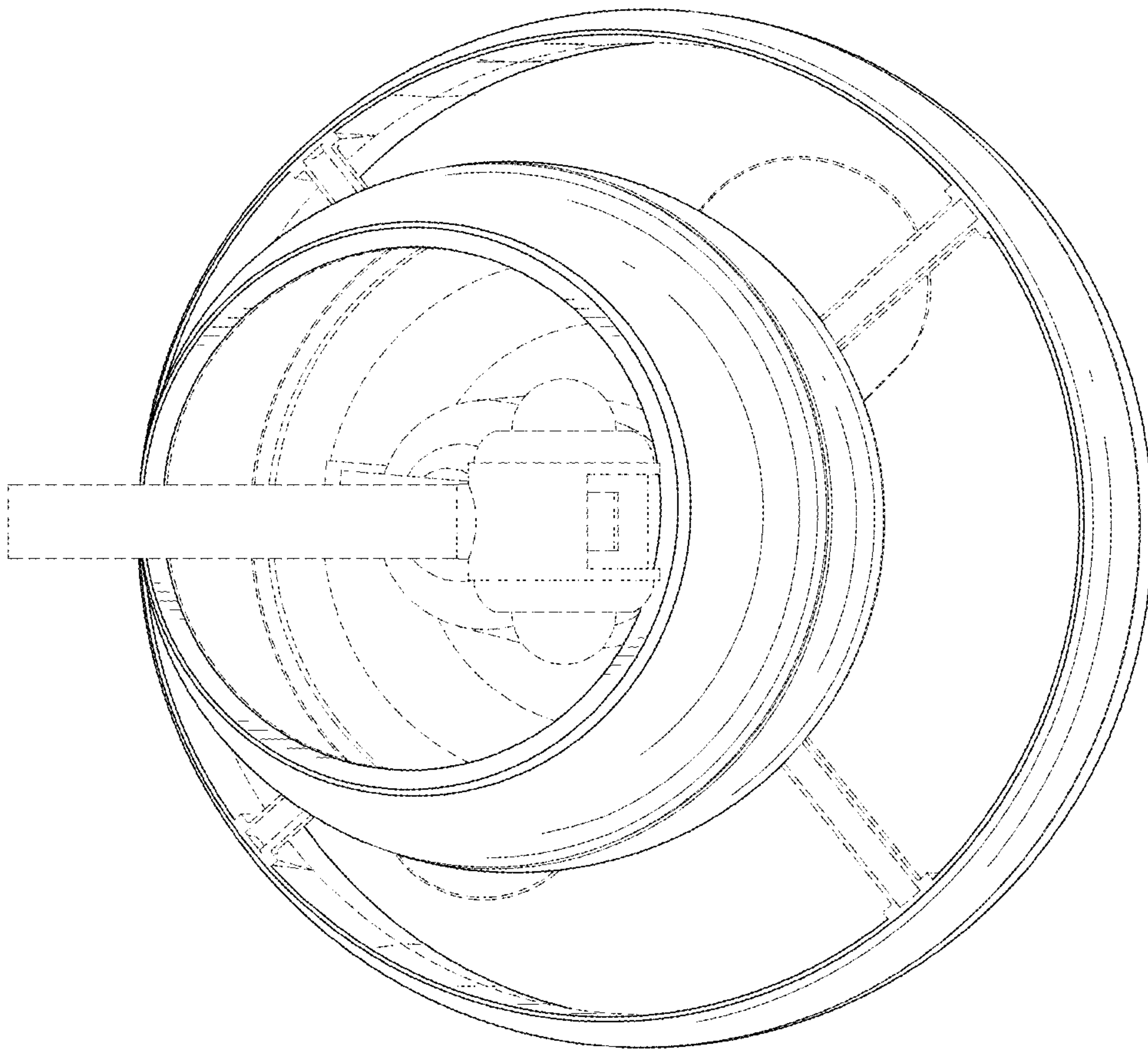

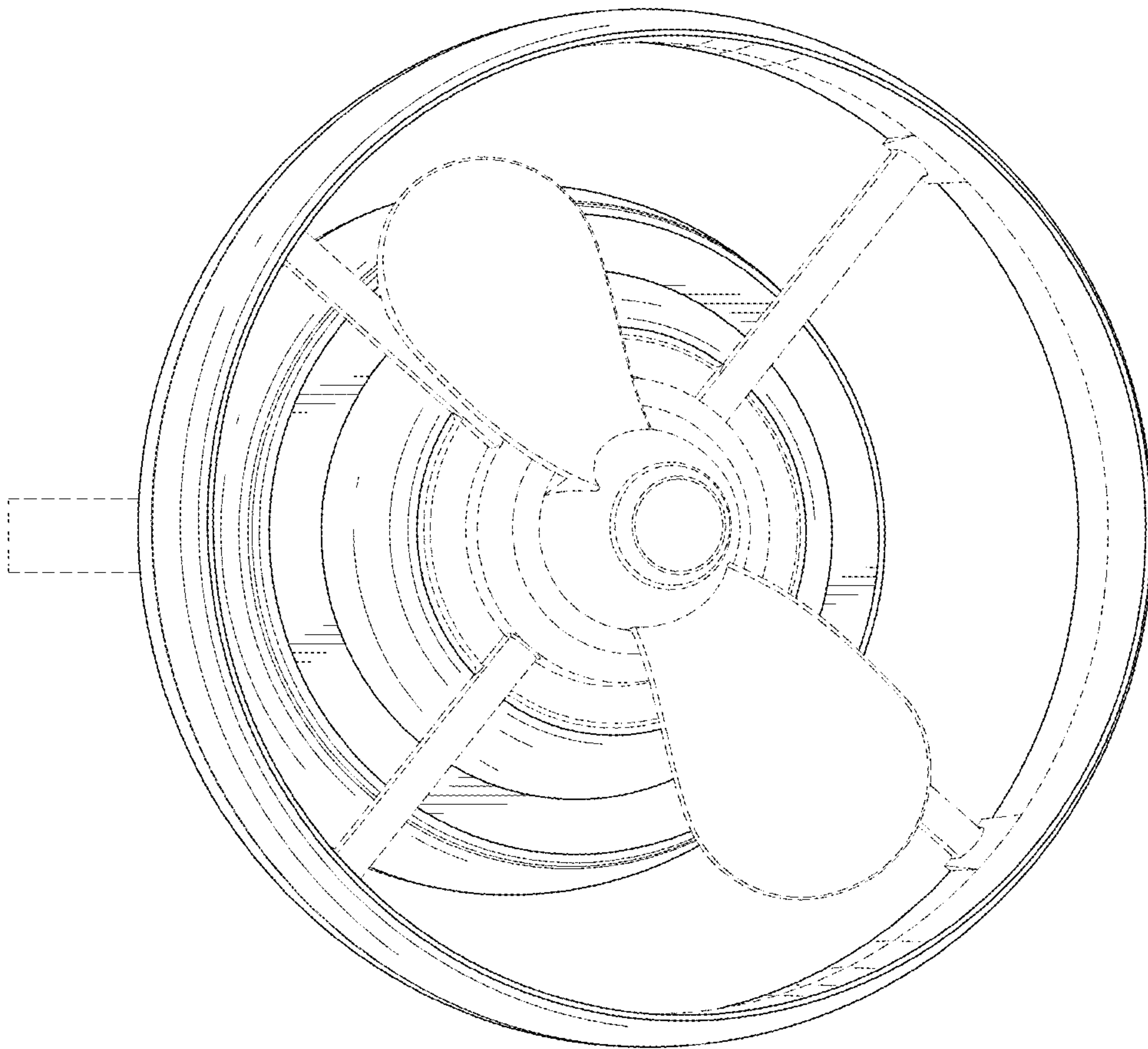

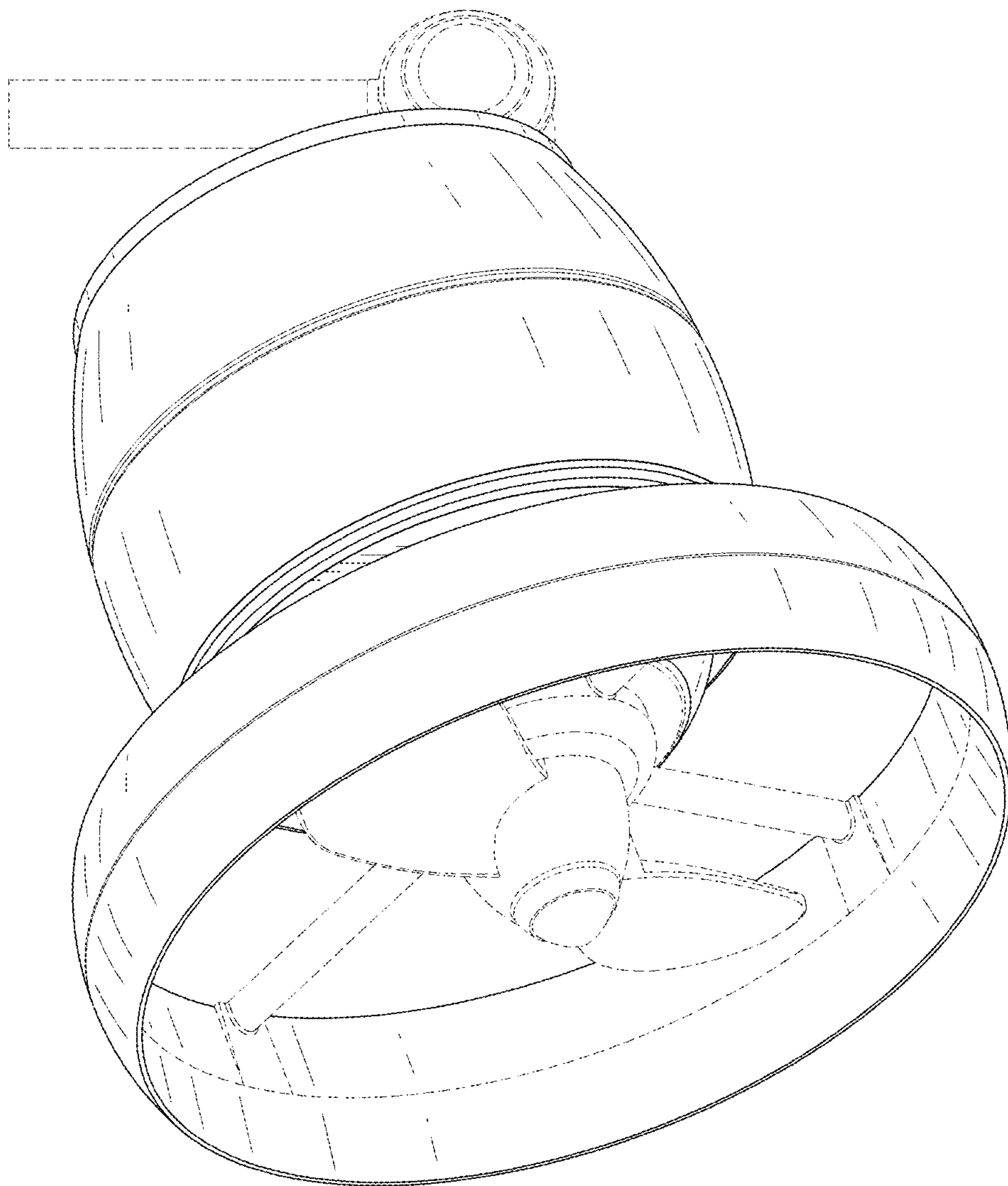
